FIG. 1.1 is a rear perspective view of a boat showing my new design;

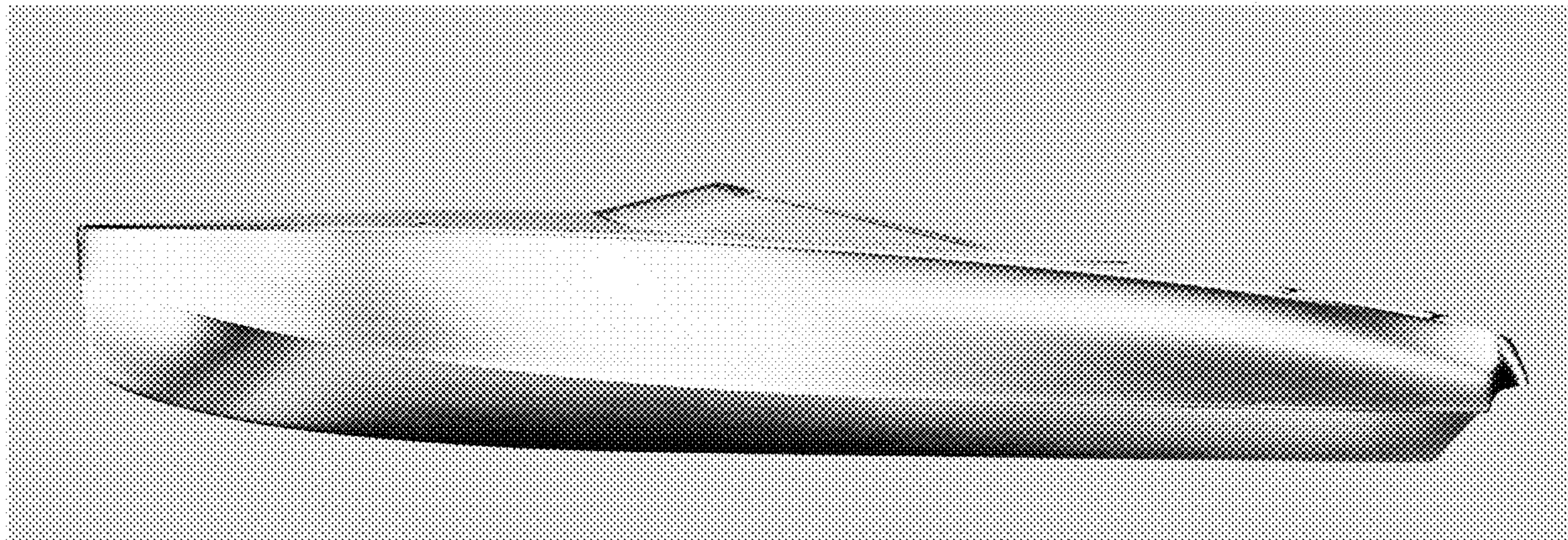
FIG. 1.2 is a front perspective view of the design shown in FIG. 1.1;

FIG. 1.3 is a bottom view of the design shown in FIG. 1.1;

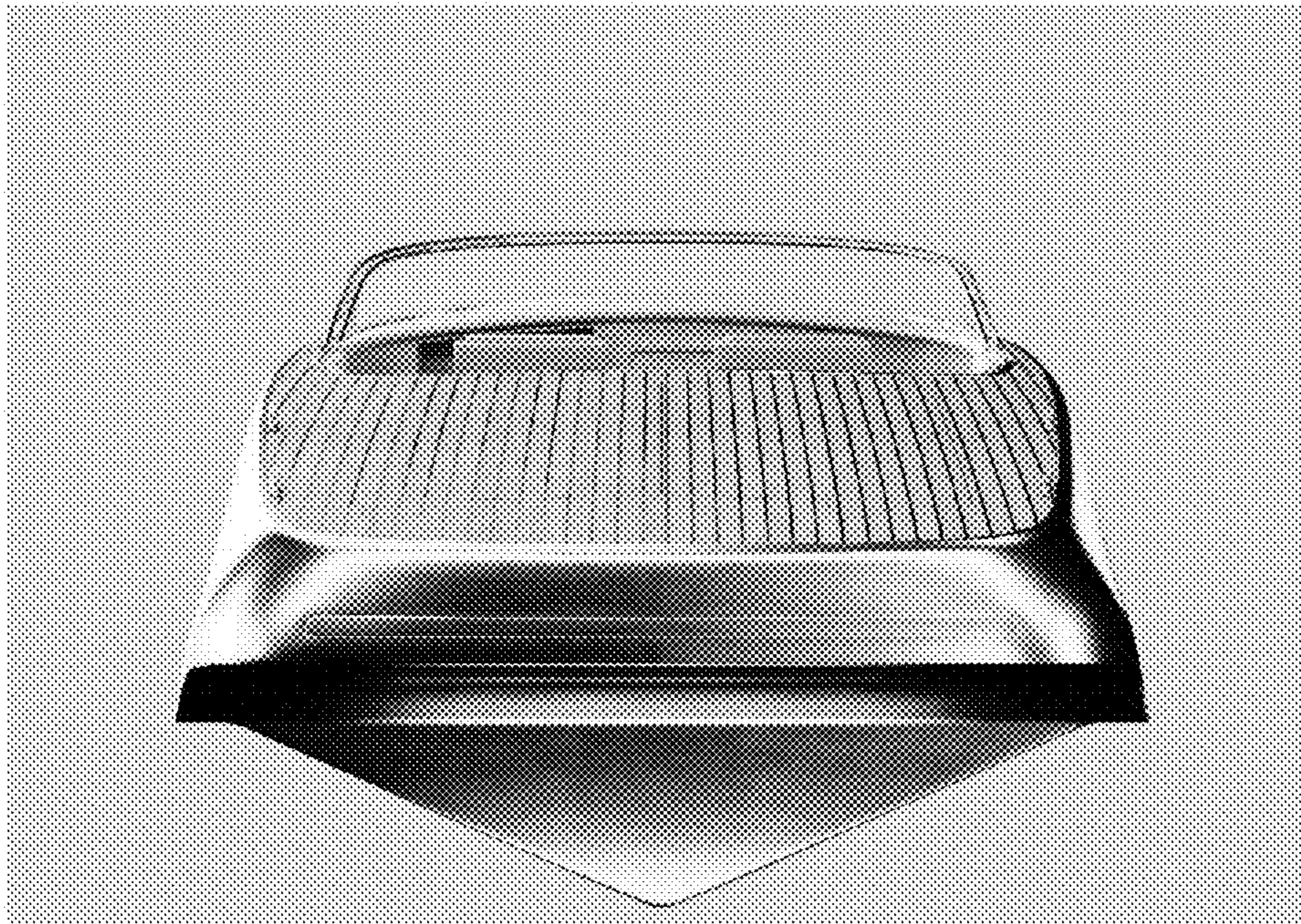
FIG. 1.5 is a top view of the design shown in FIG. 1.1; and

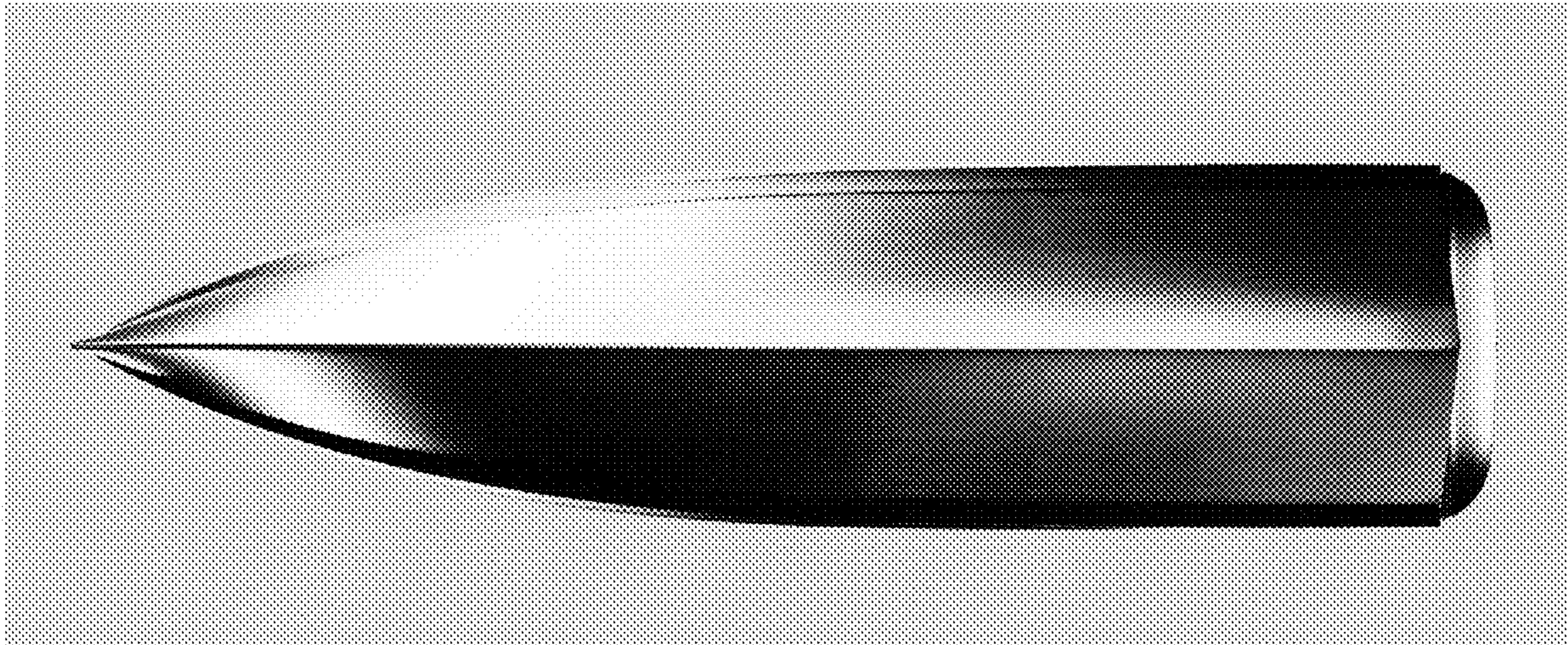

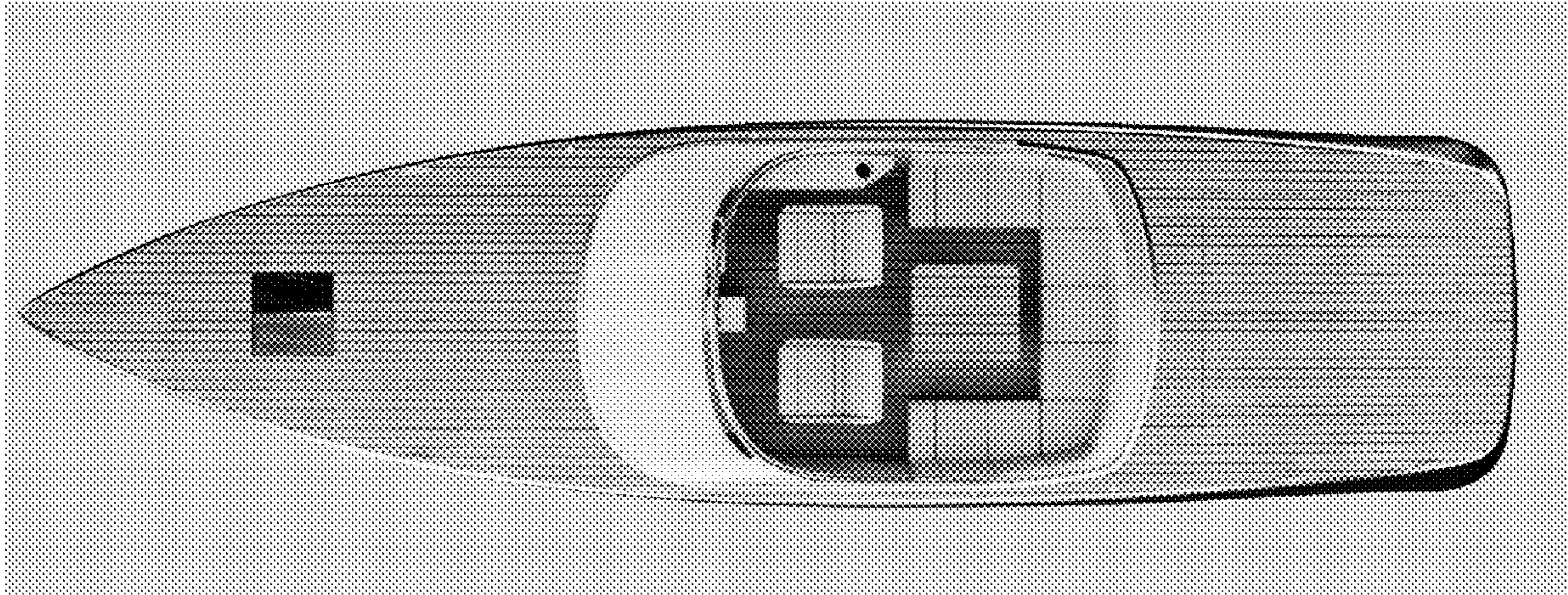
