DESCRIPTION

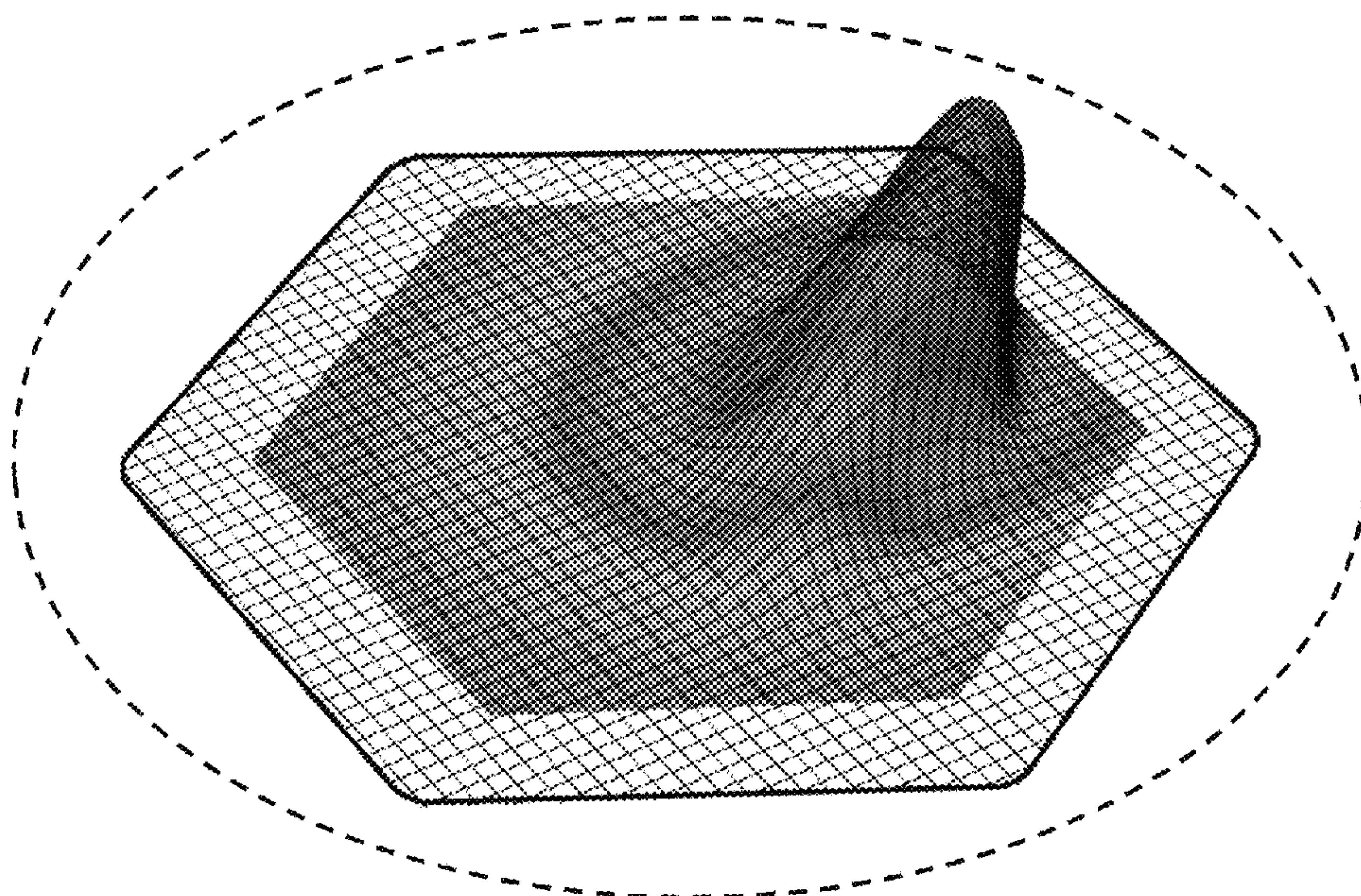

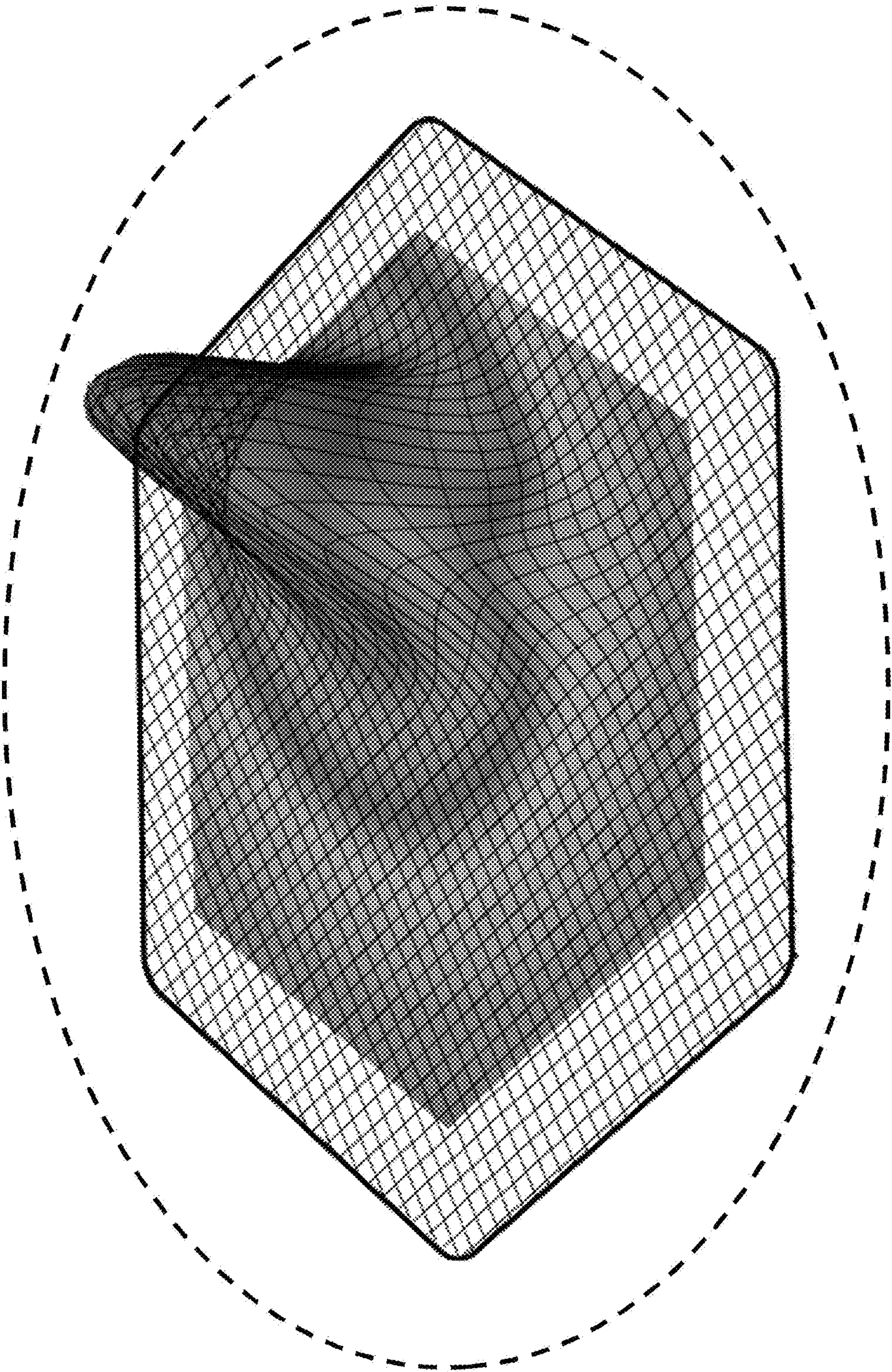
