(57) **CLAIM**

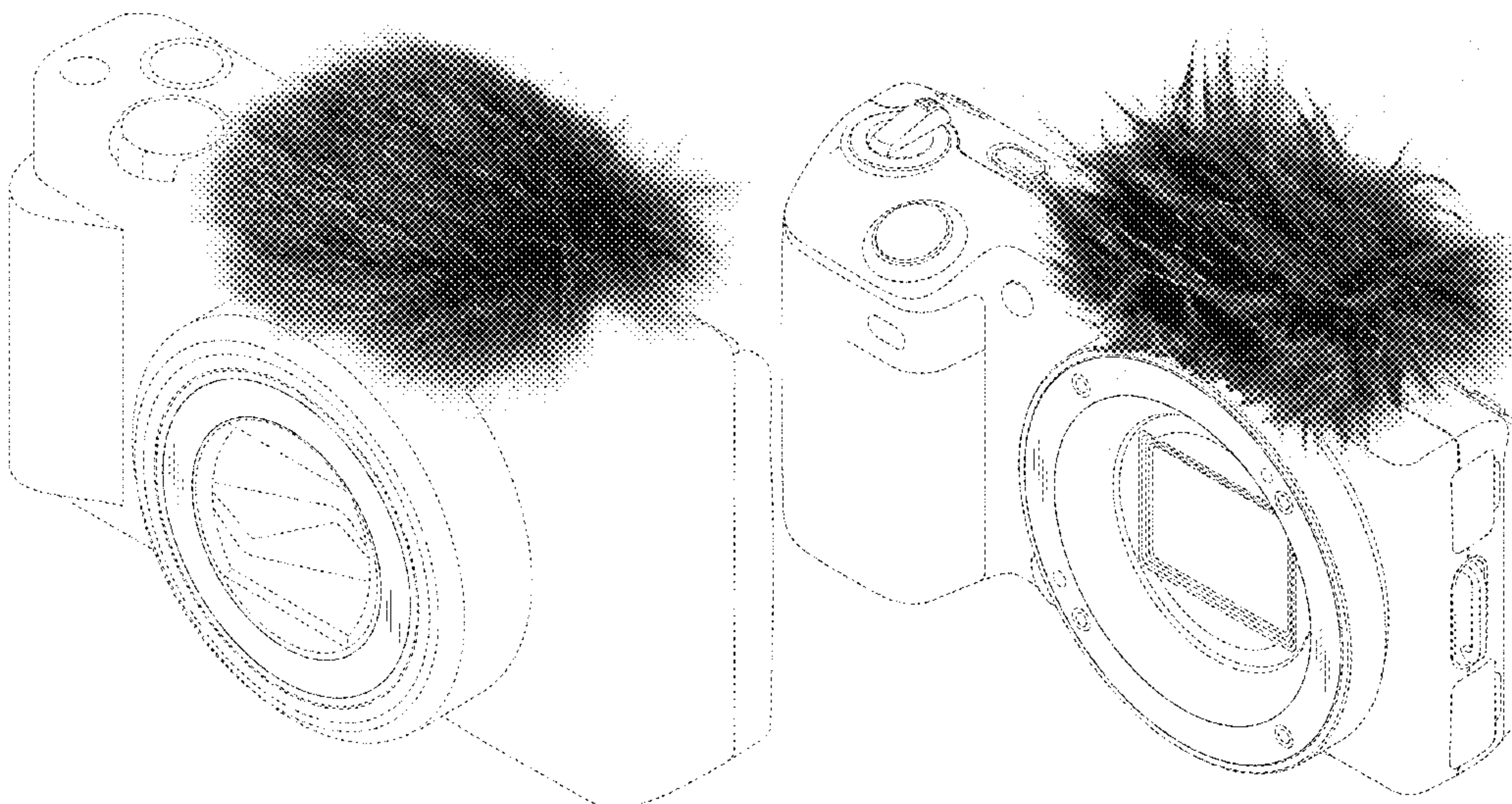
The ornamental design for a camera with a windjammer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a camera with a windjammer showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; and FIG. 7 is a bottom plan view thereof. FIG. 8 is a perspective view of a second embodiment of a camera with a windjammer showing our new design; FIG. 9 is a front elevational view thereof; FIG. 10 is a rear elevational view thereof; FIG. 11 is a right side elevational view thereof; FIG. 12 is a left side elevational view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof.

The broken lines showing the camera portions or the windjammer attaching member portions form no part of the claimed design.

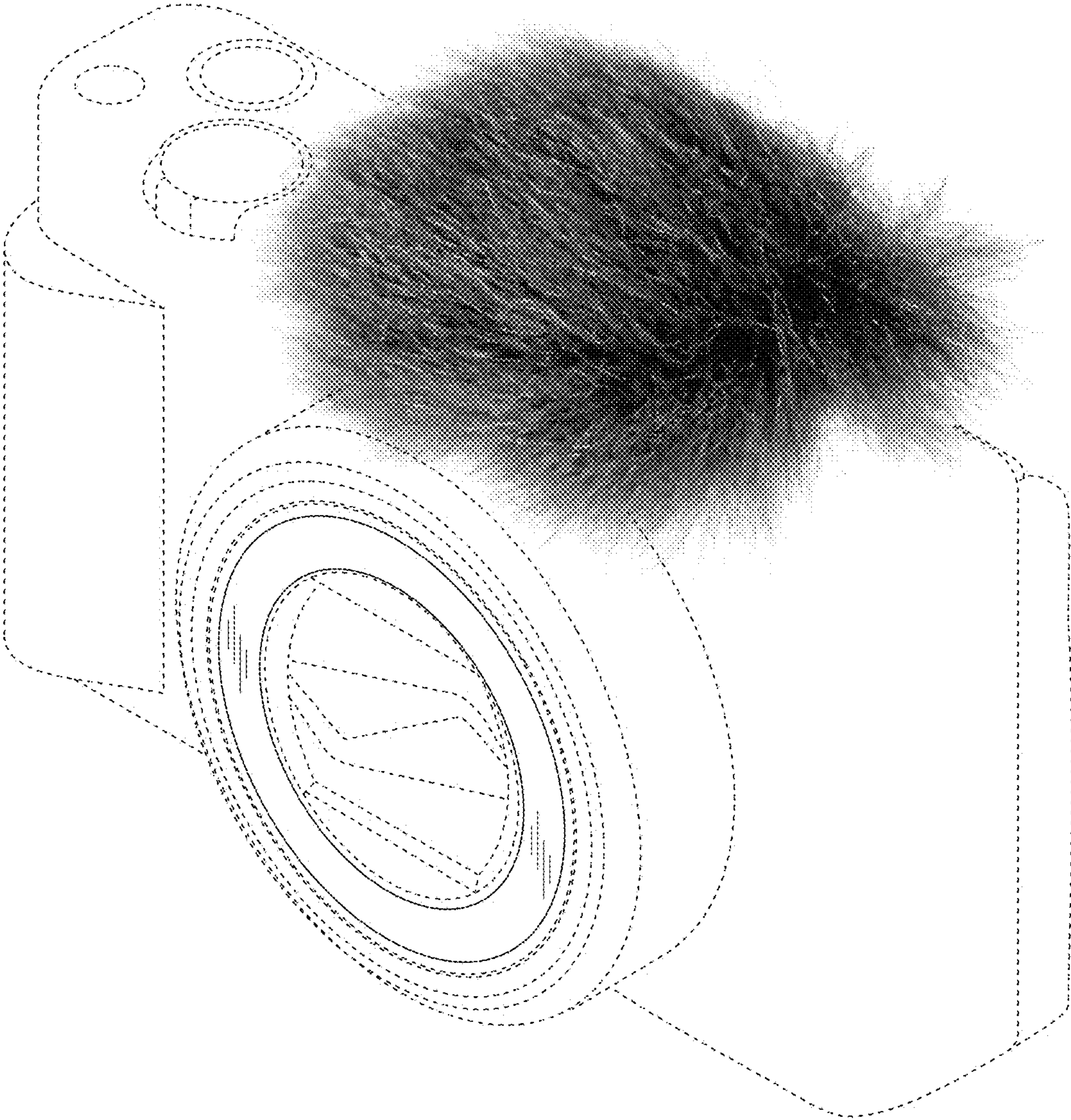

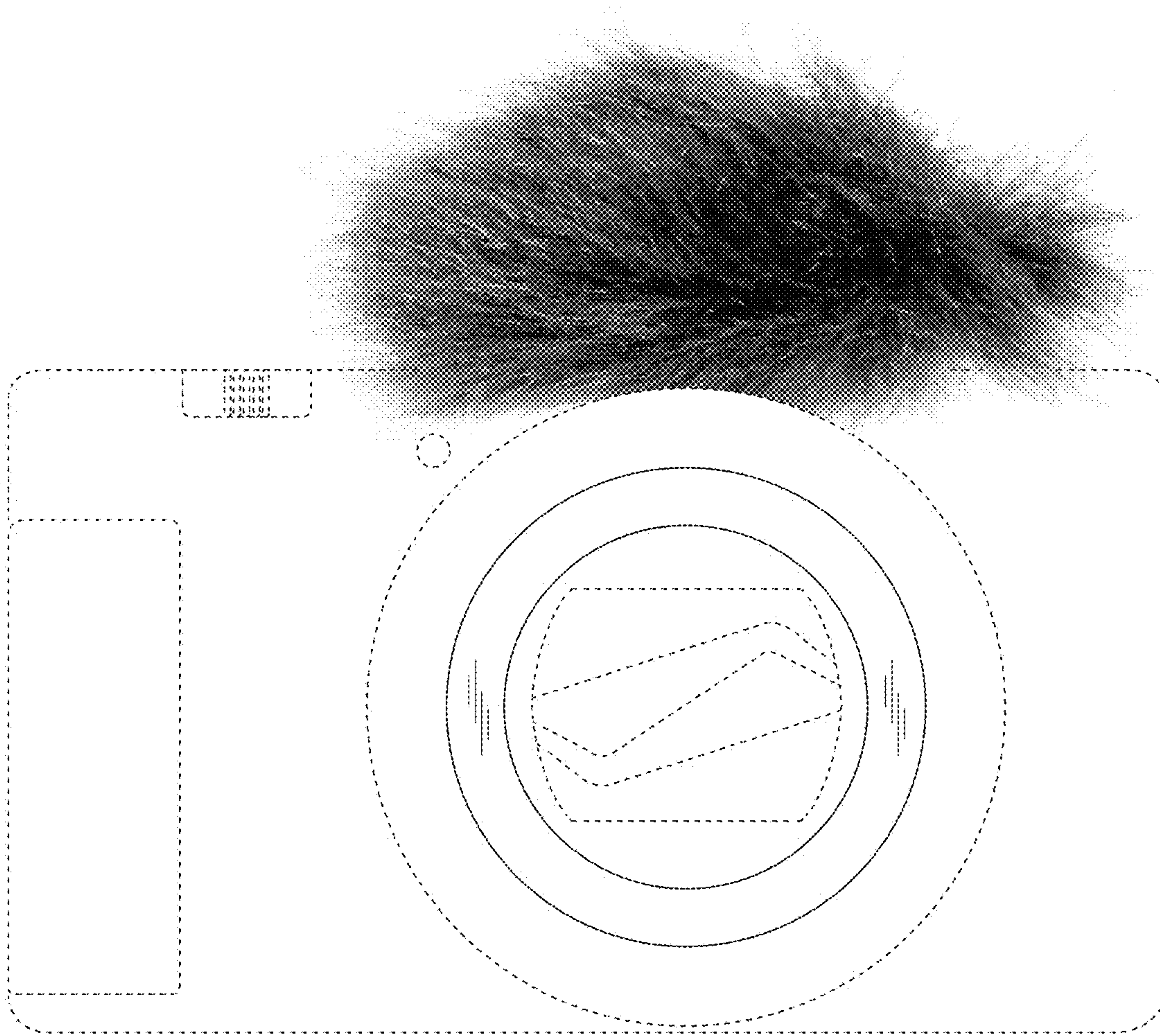

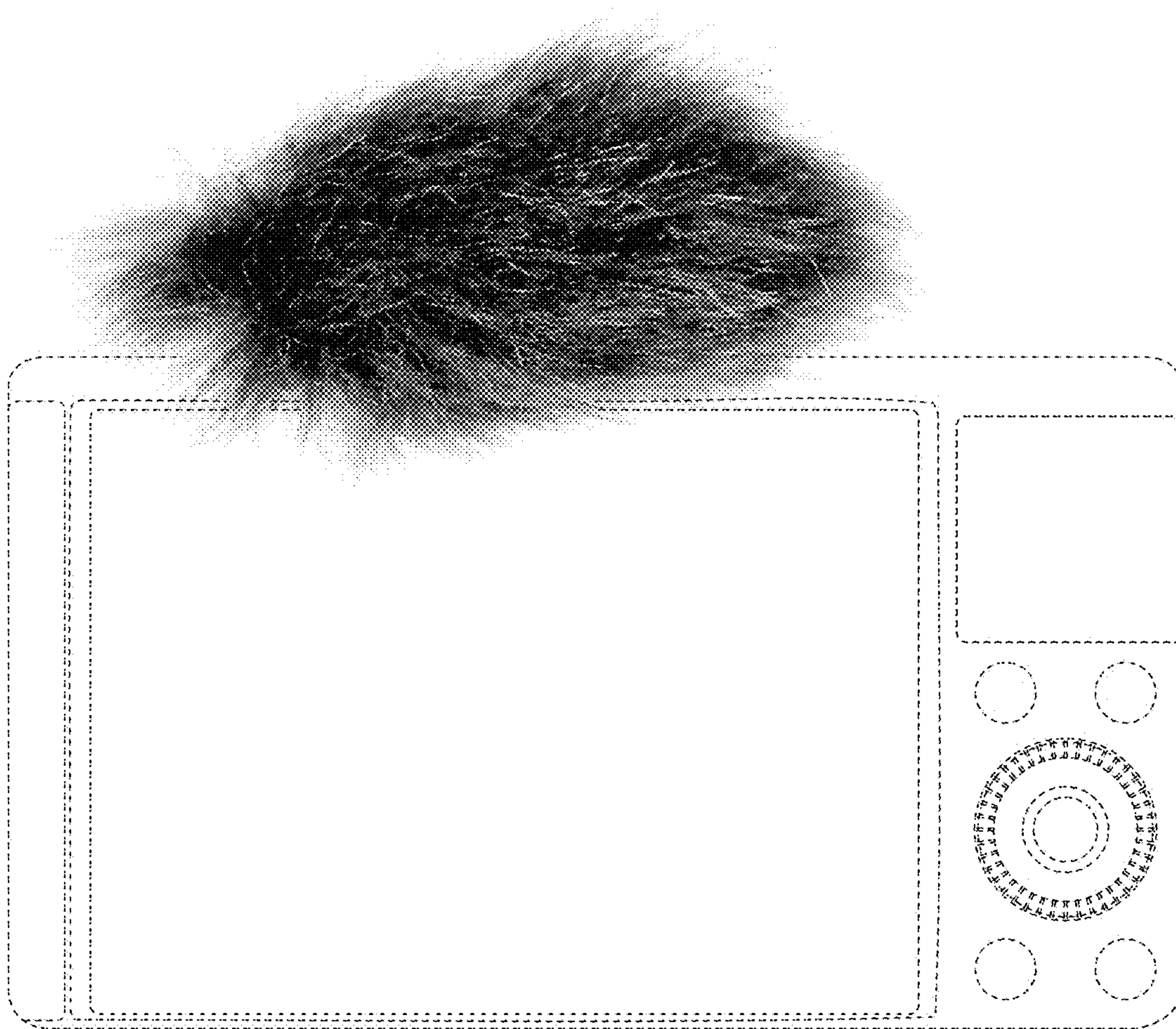

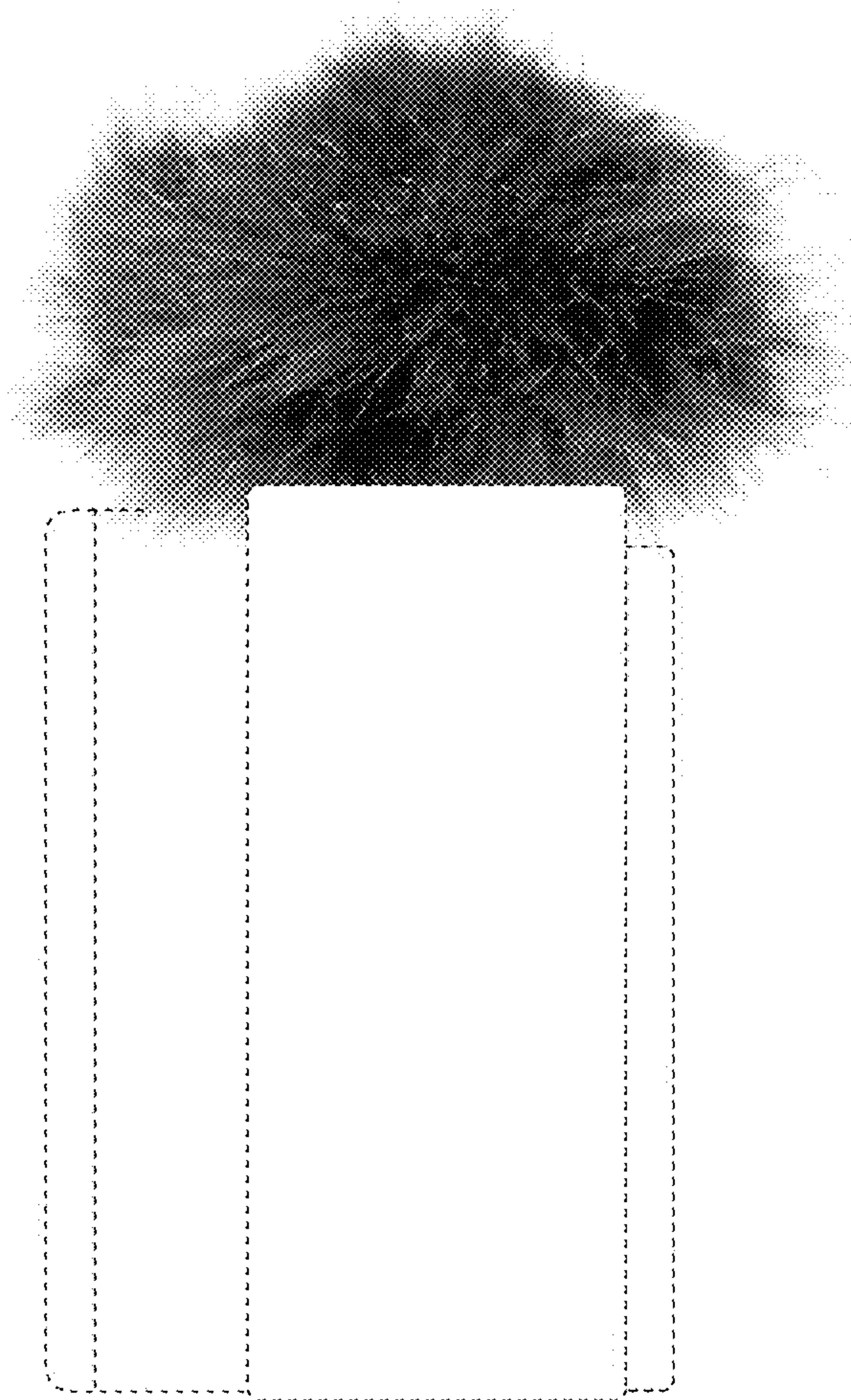

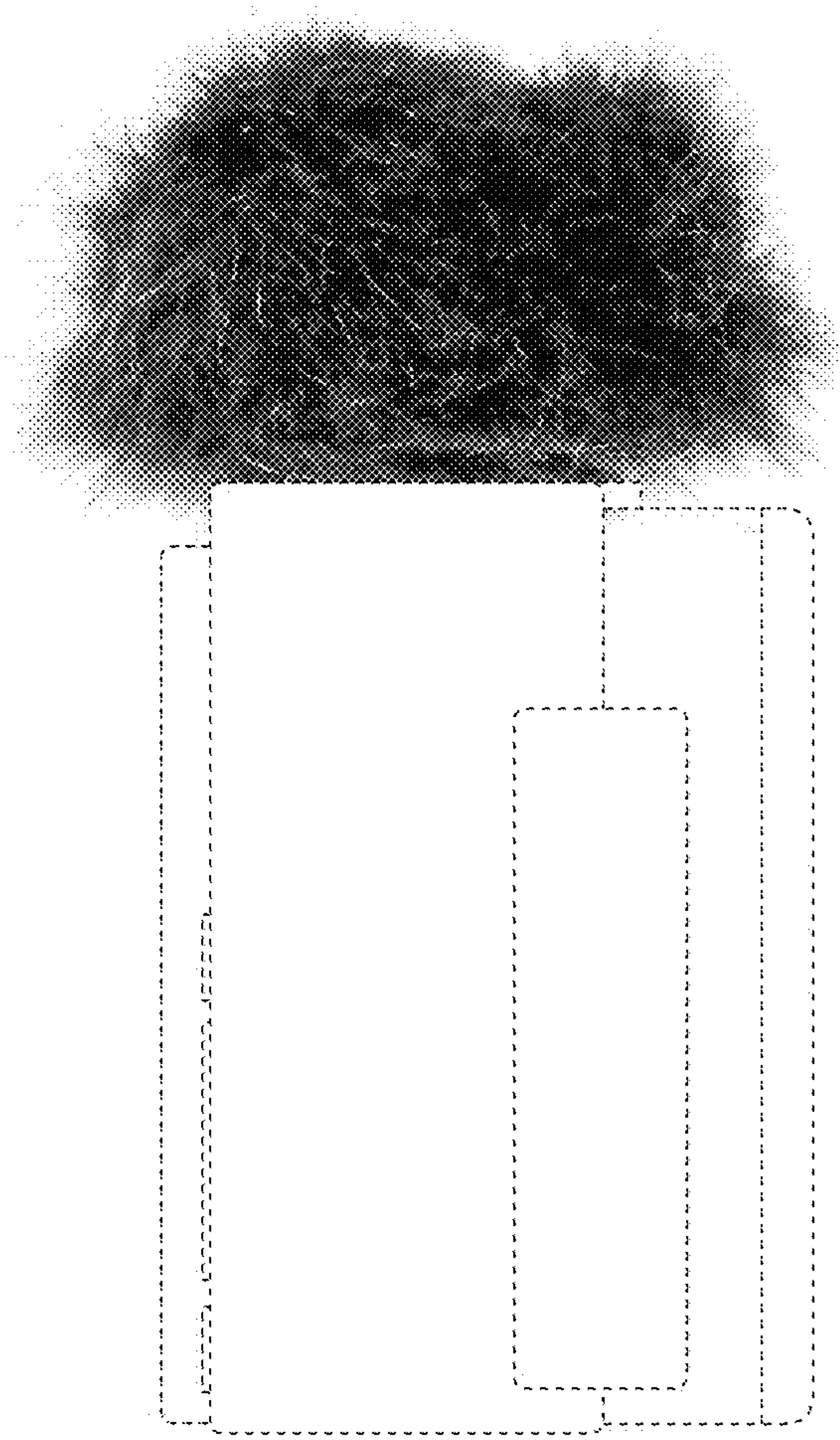

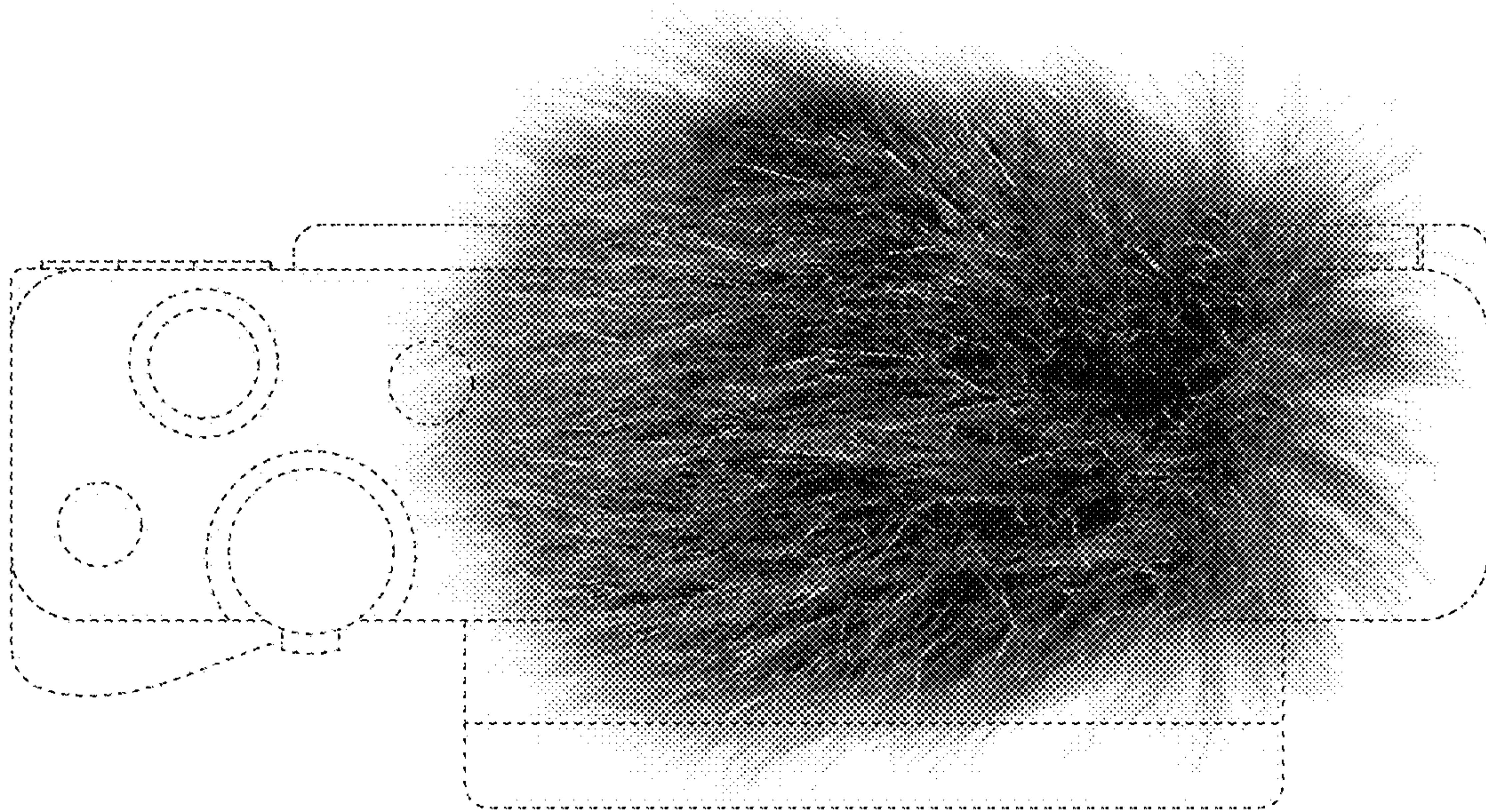

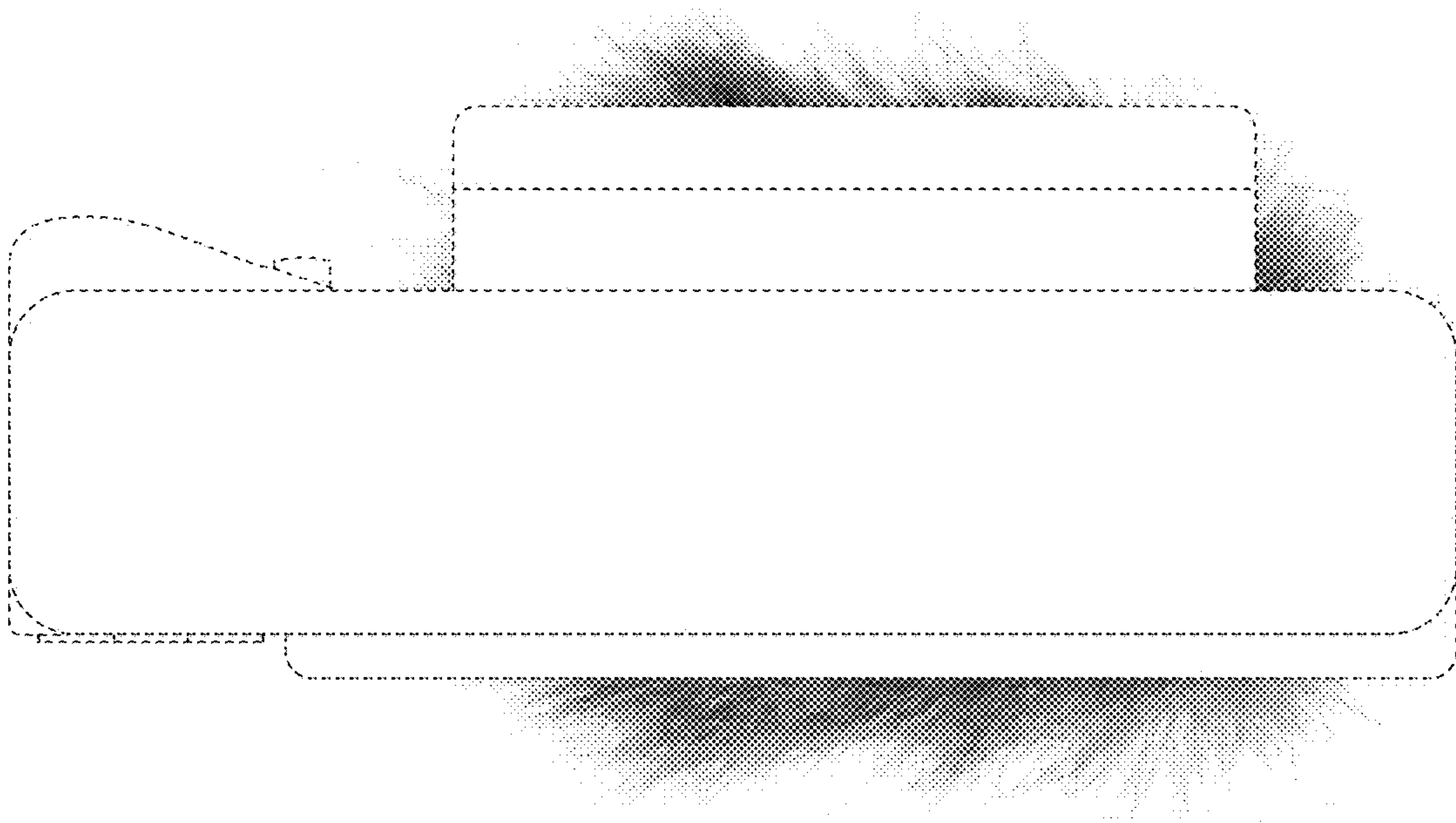

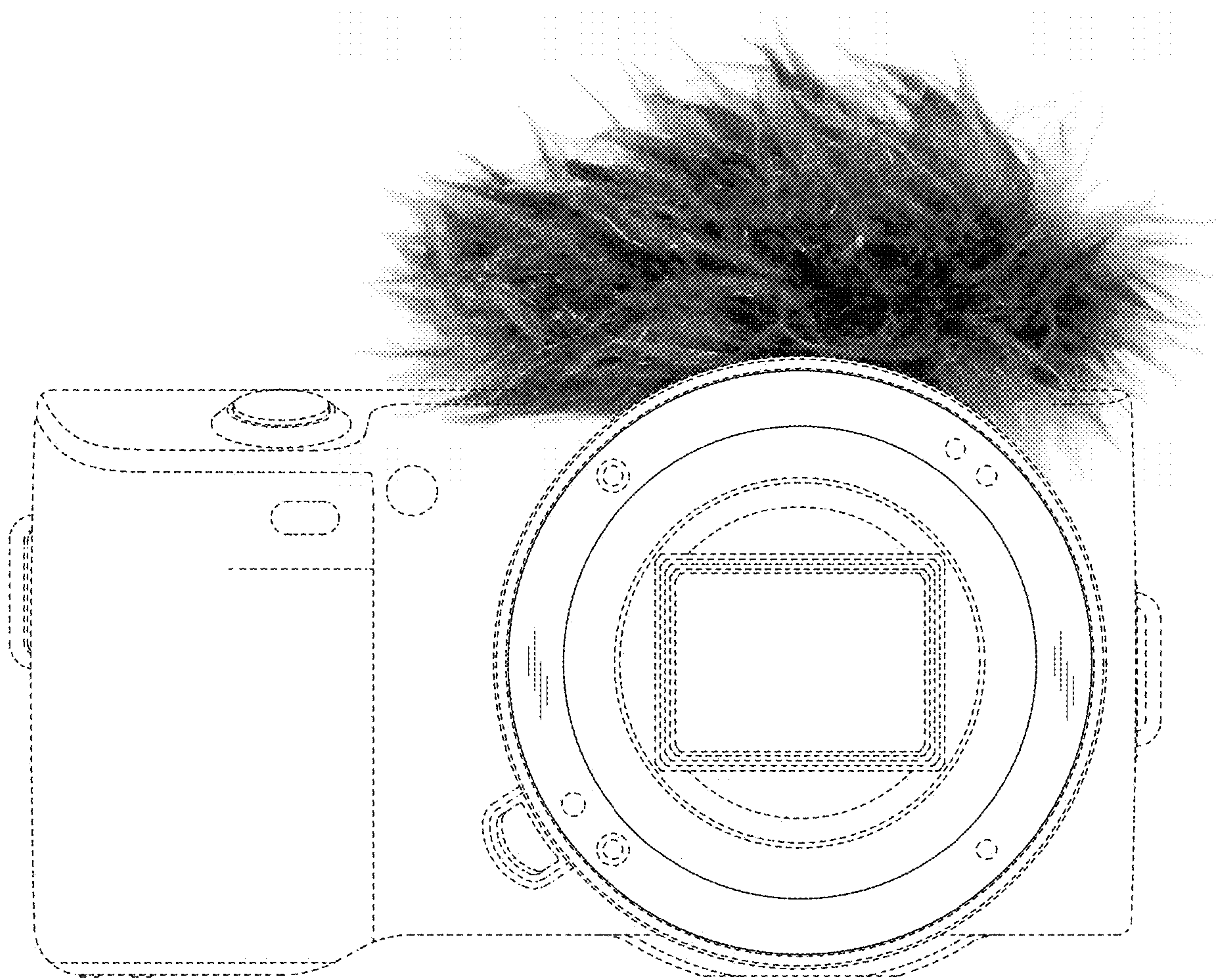

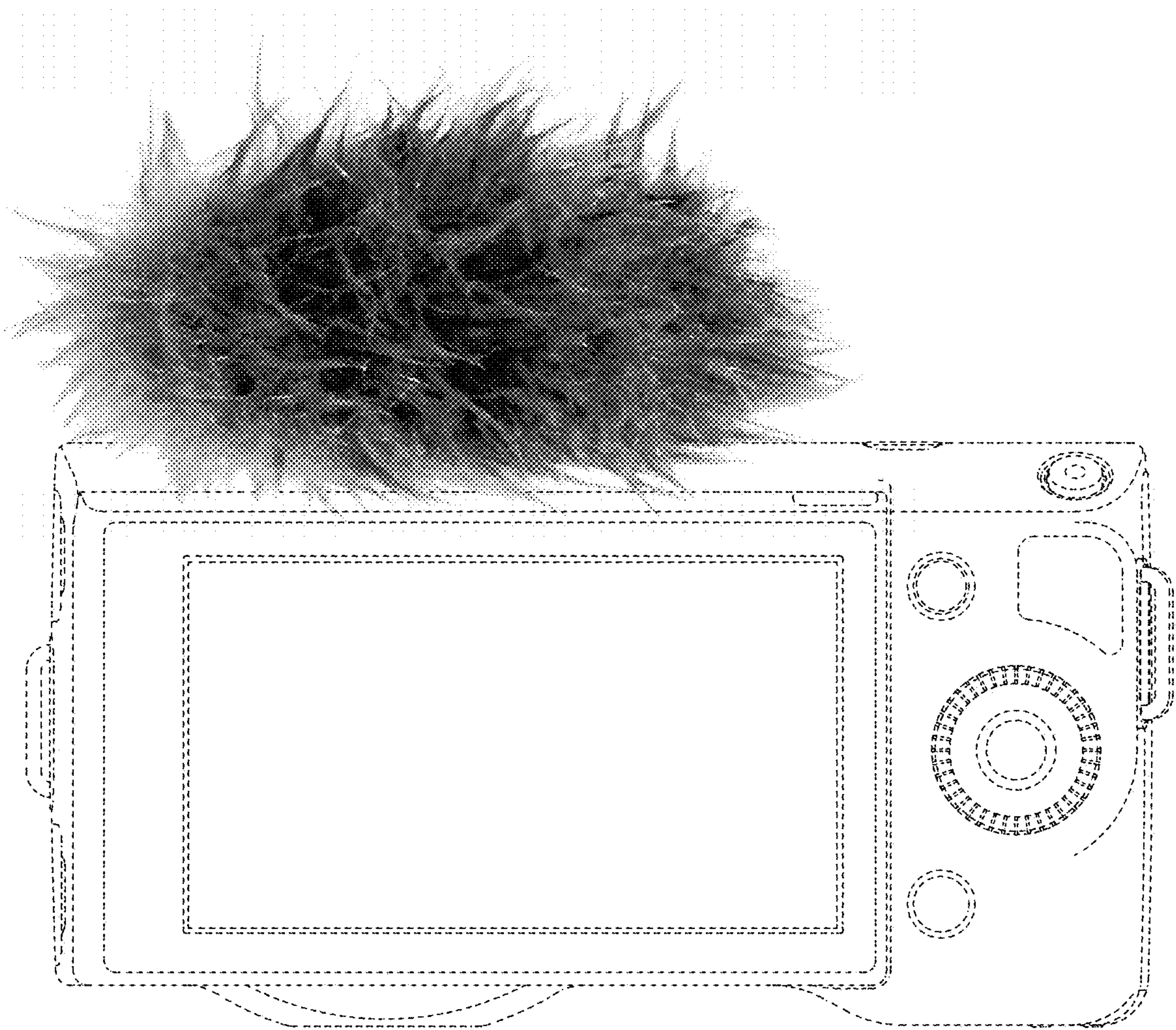

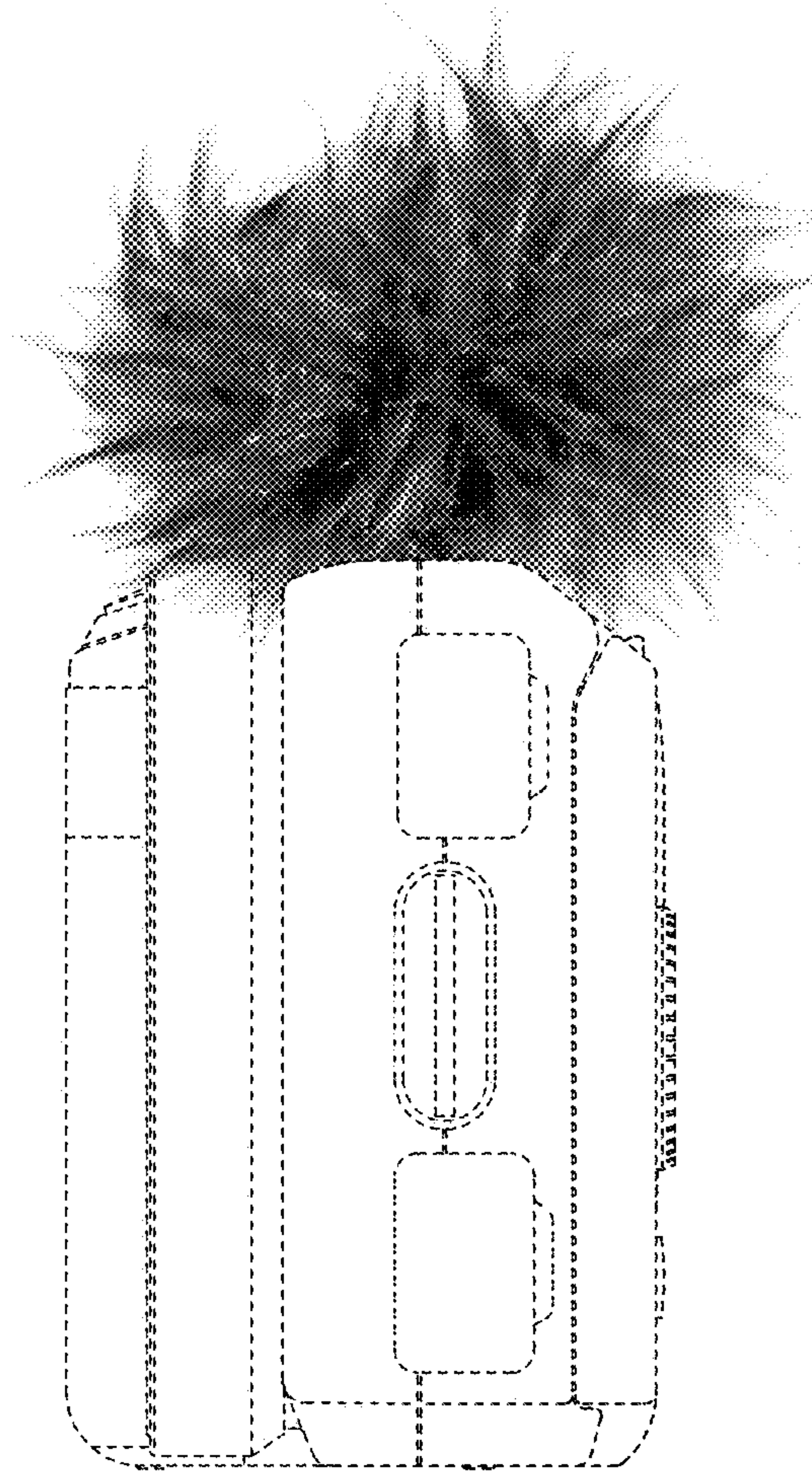

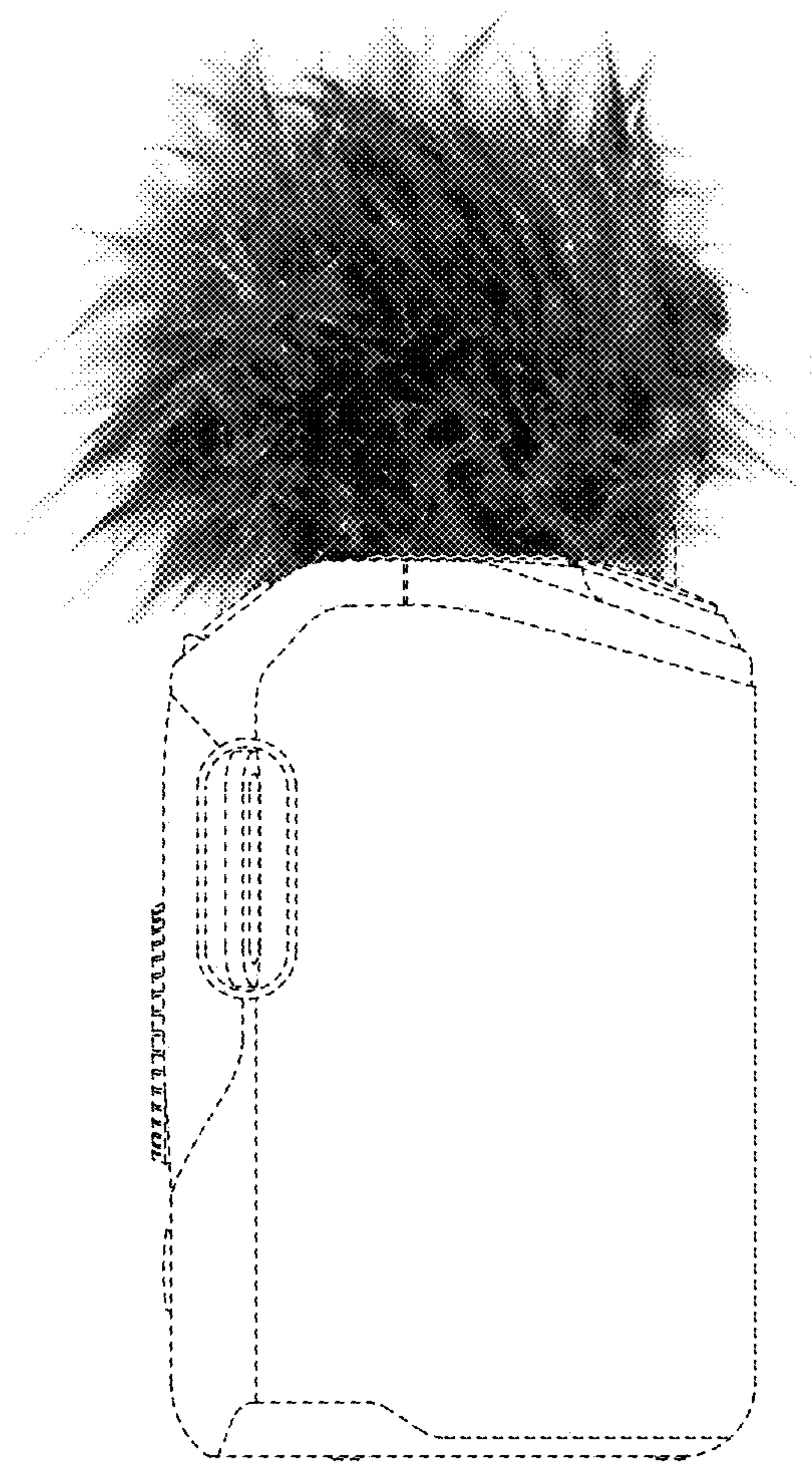

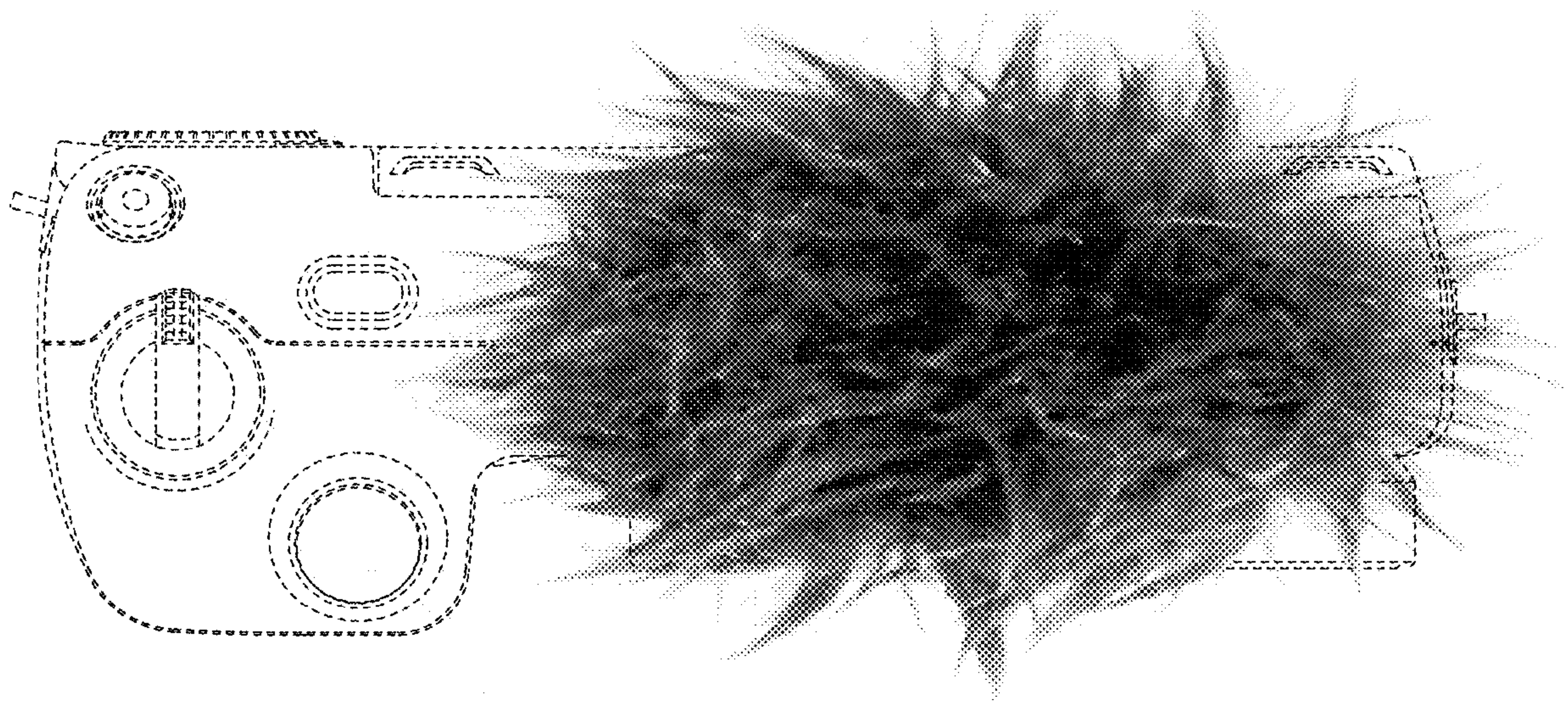
