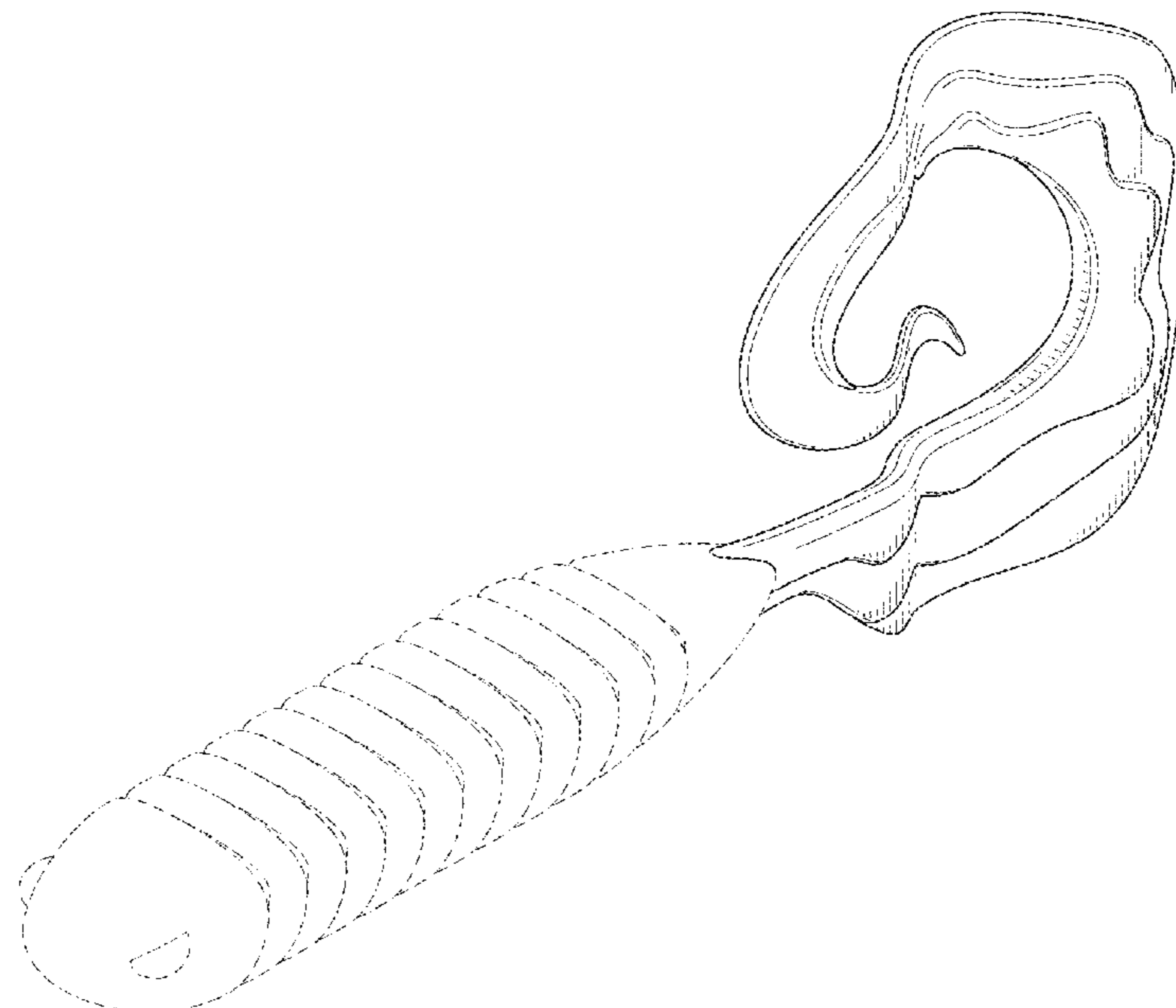
(57) **CLAIM**

The ornamental design for a three thickness layer wave-type tail for a soft lure, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a three-thickness layer wave-type tail for a soft lure showing our new design, with the tail in an exemplary wave form configuration; FIG. 2 is a bottom rear perspective view thereof. FIG. 3 is a left side elevational view thereof. FIG. 4 is a right side elevational view thereof. FIG. 5 is a top elevational view thereof. FIG. 6 is a bottom elevational view thereof. FIG. 7 is a front elevational view thereof; and, FIG. 8 is a rear elevational view thereof. The broken line showing of portions of the three-thickness layer wave-type tail for a soft lure is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

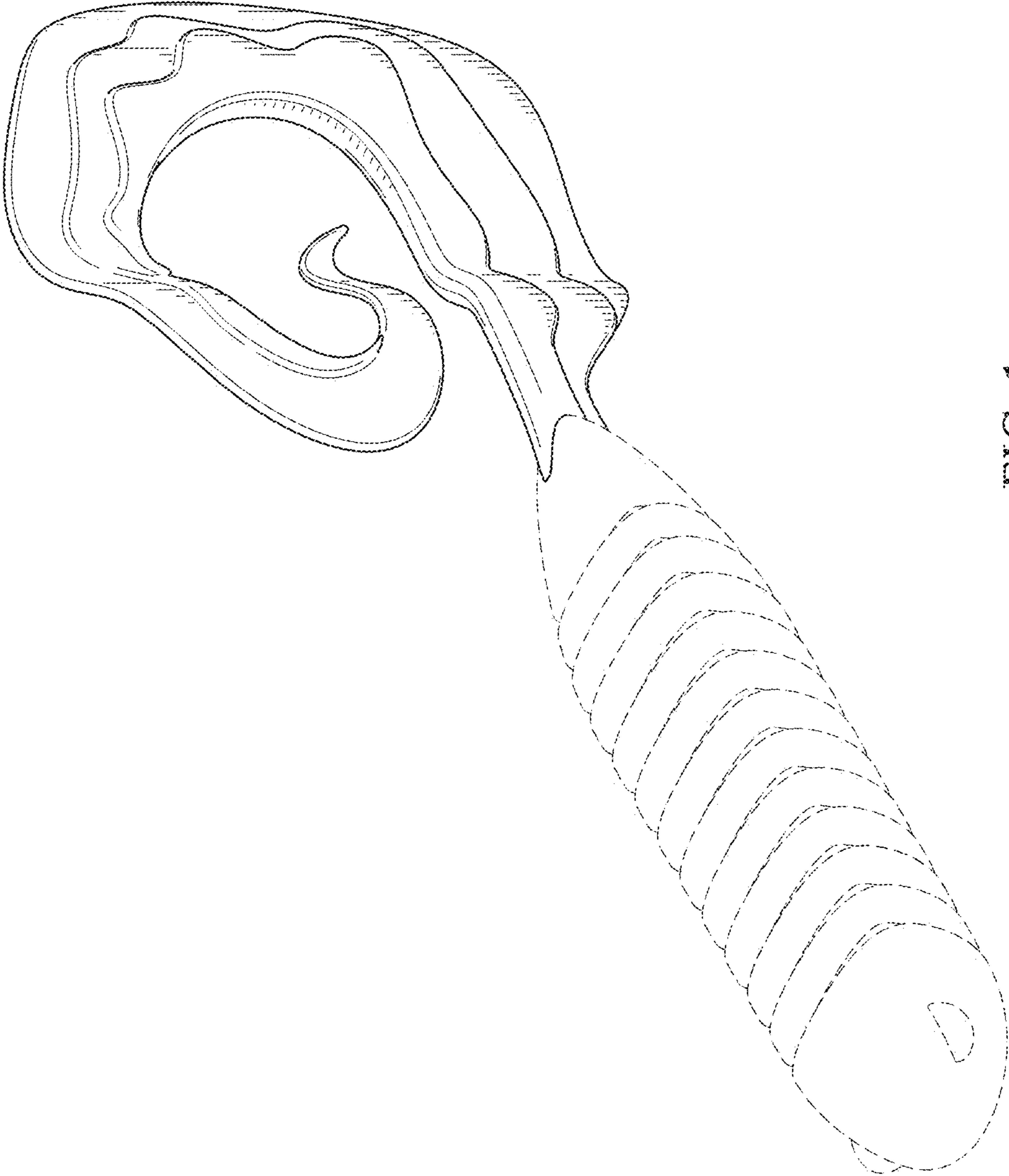

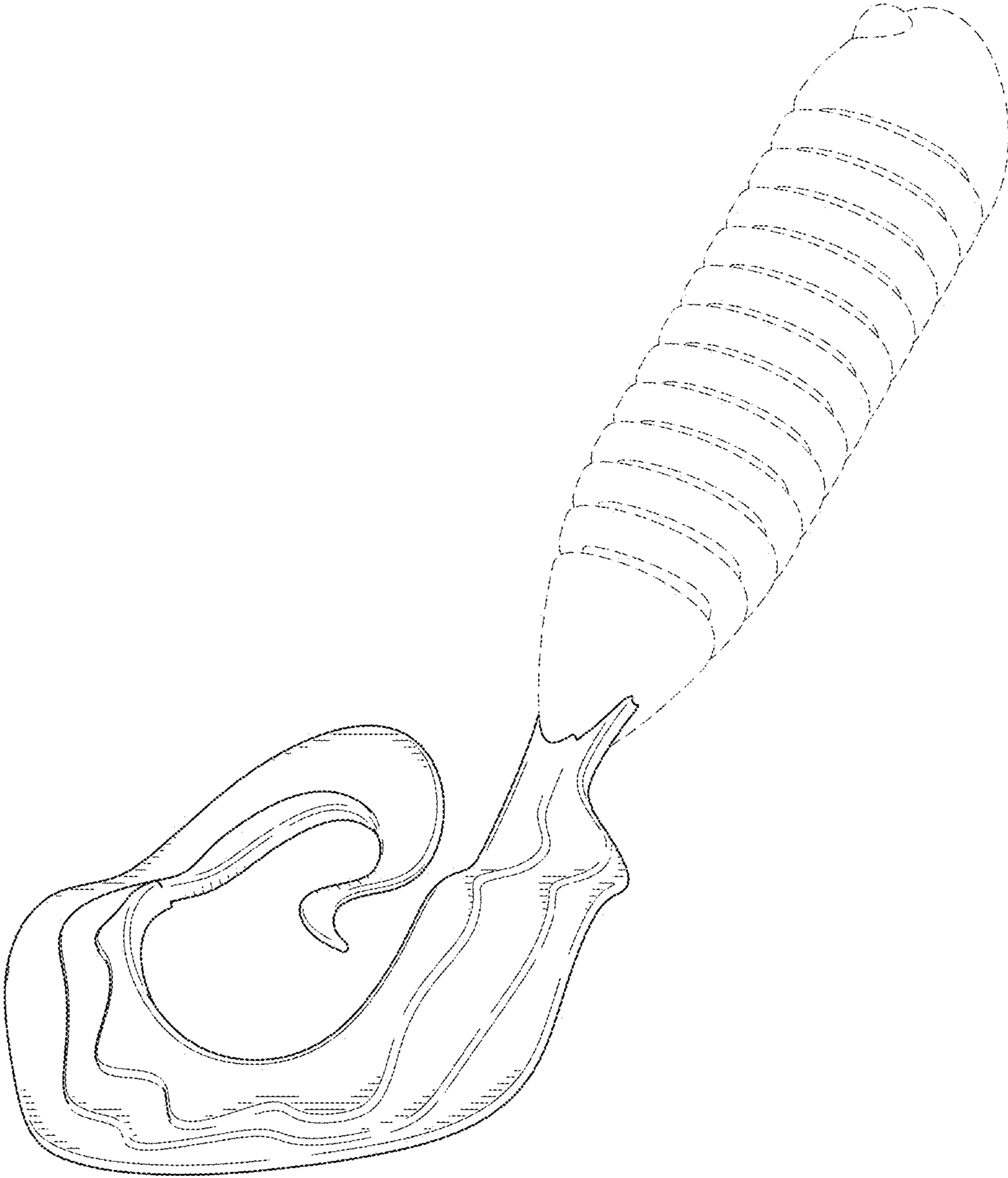

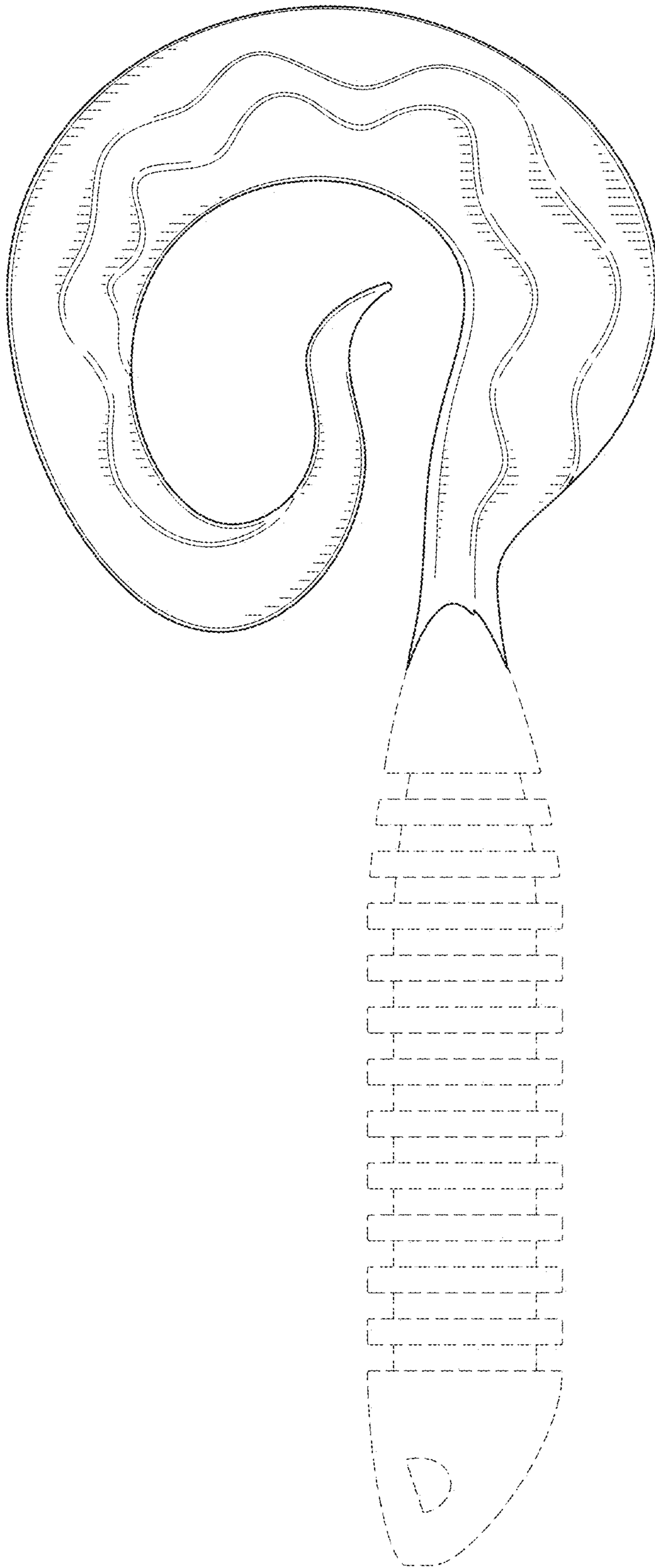

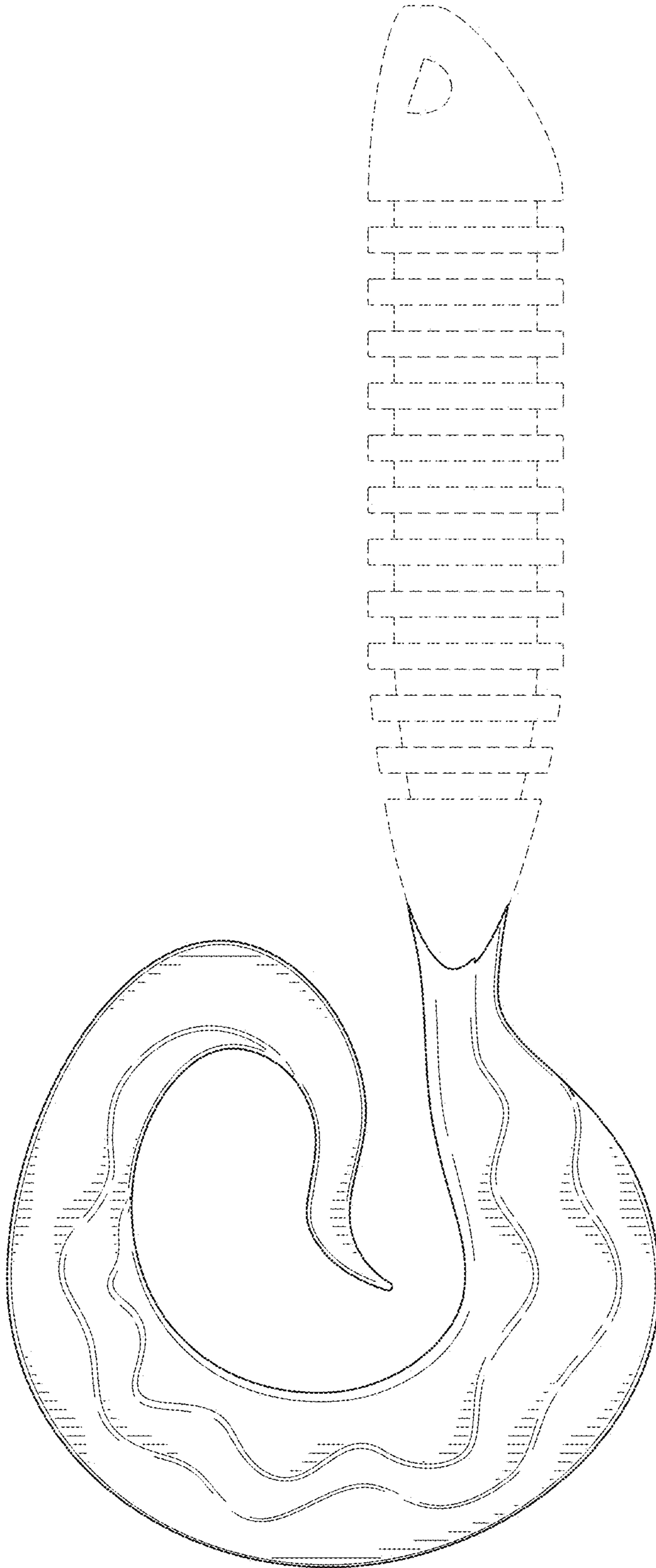

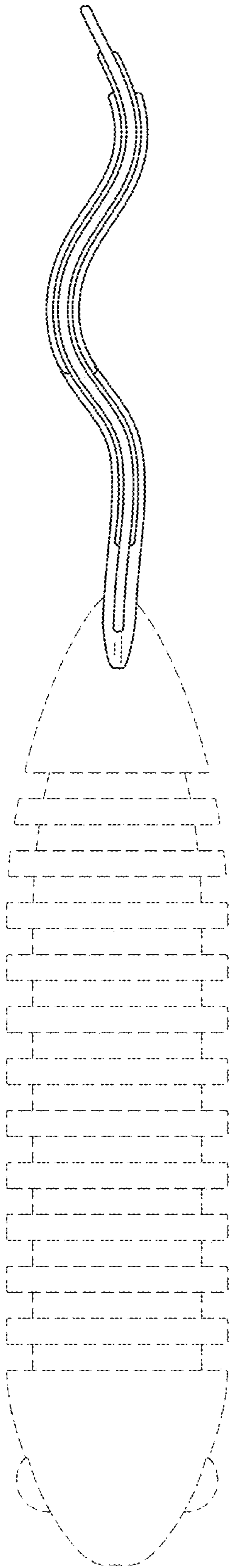

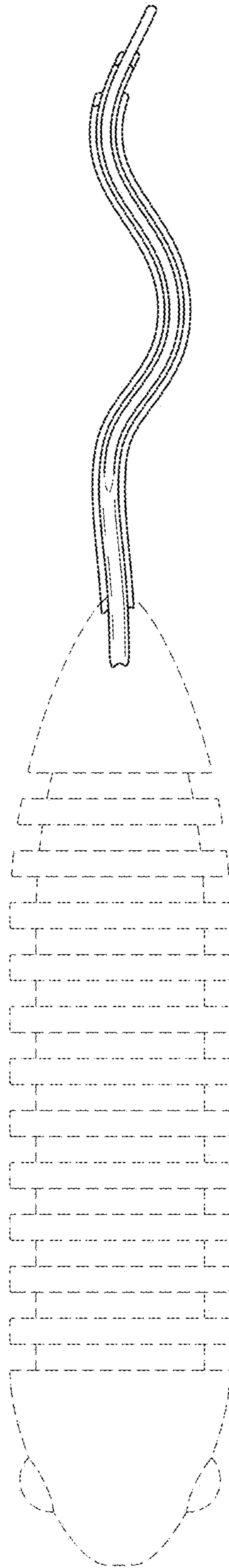

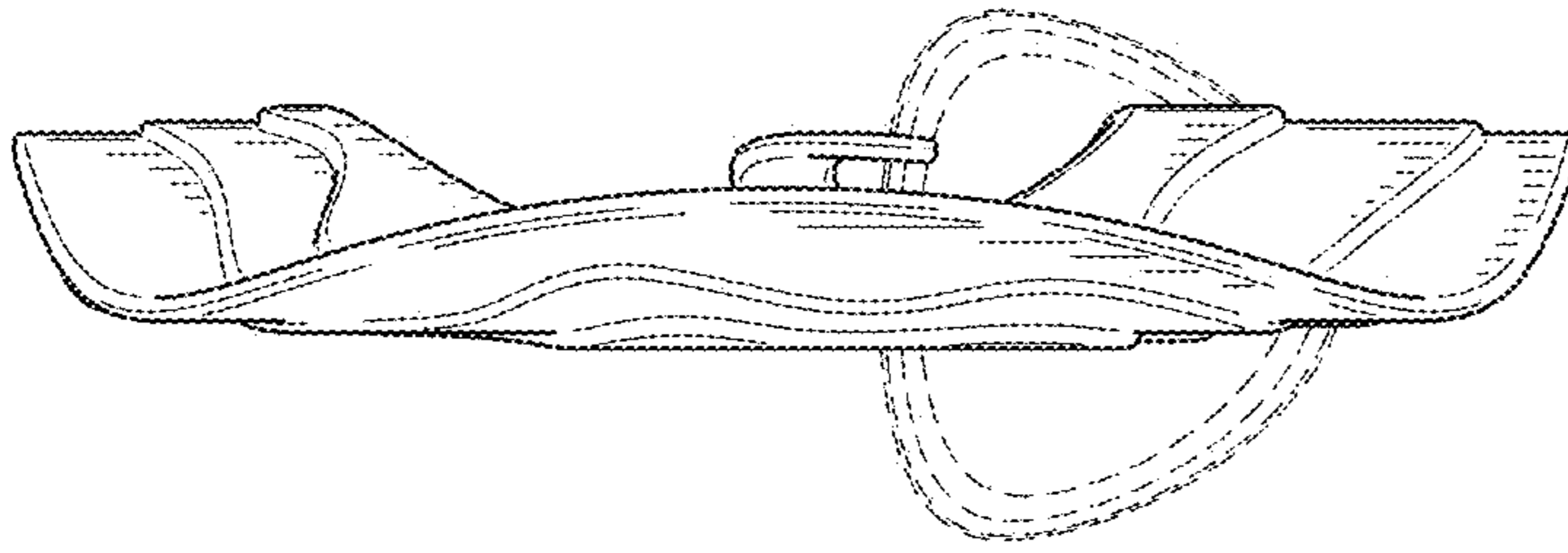

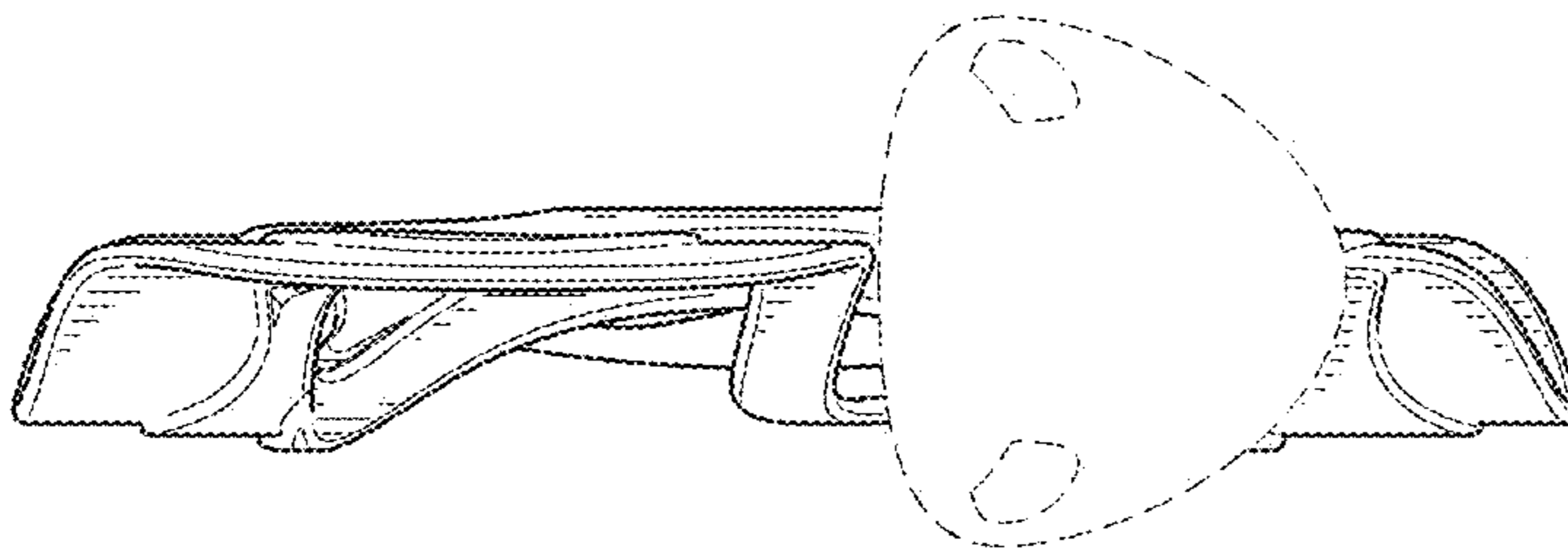
