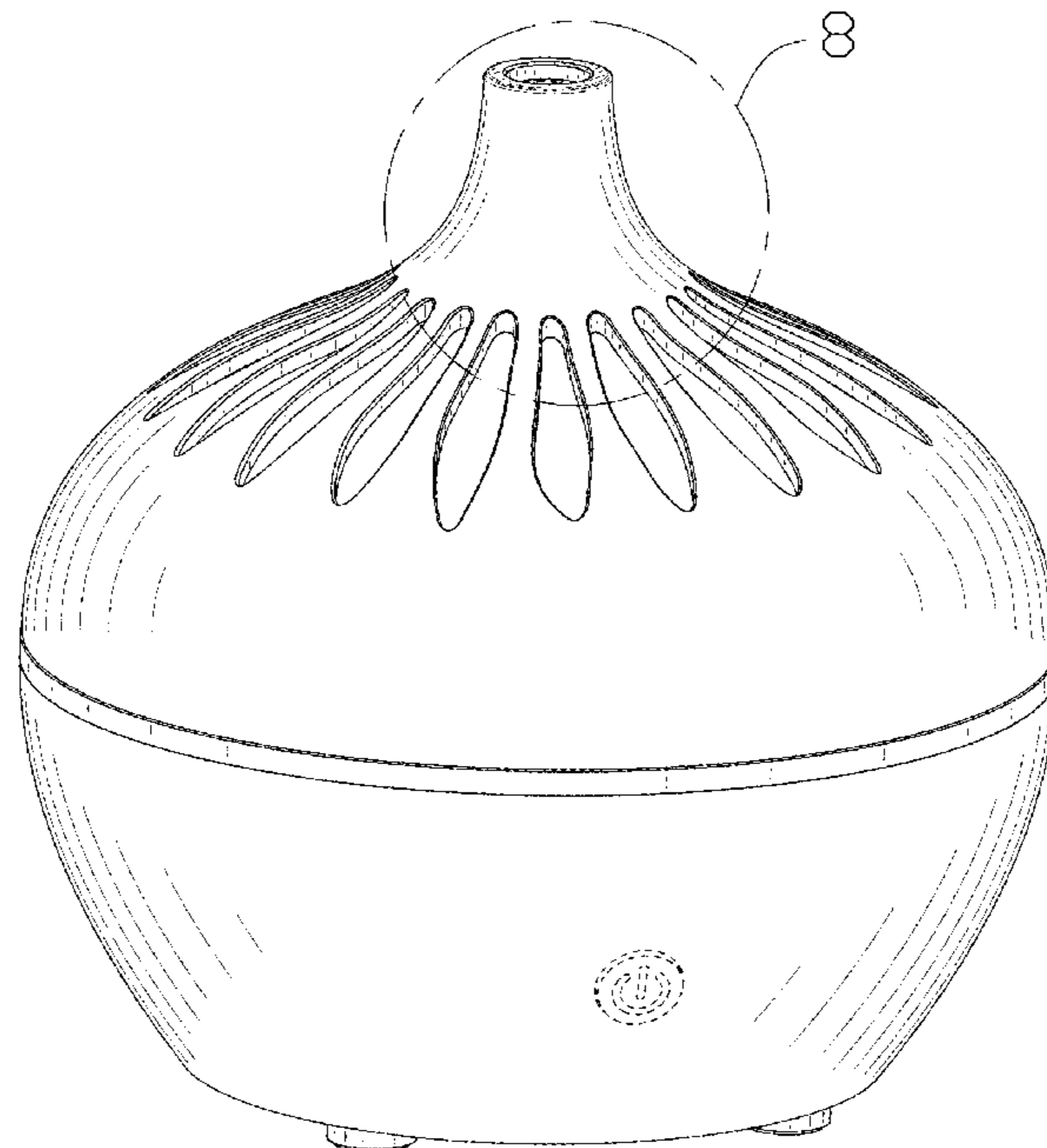
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top and front perspective view of a diffuser, showing my design.
FIG. 2 is a front elevation view thereof.

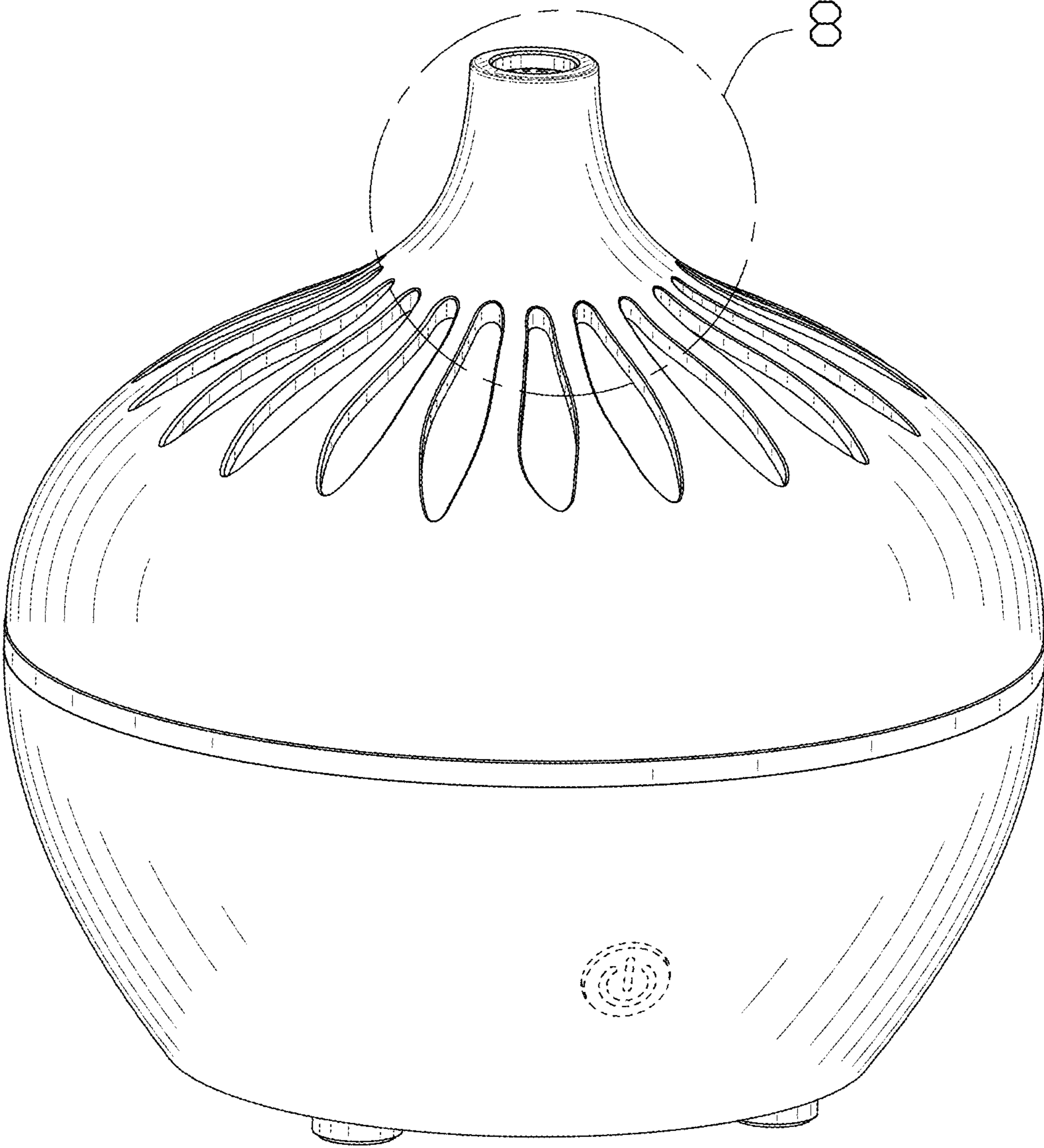

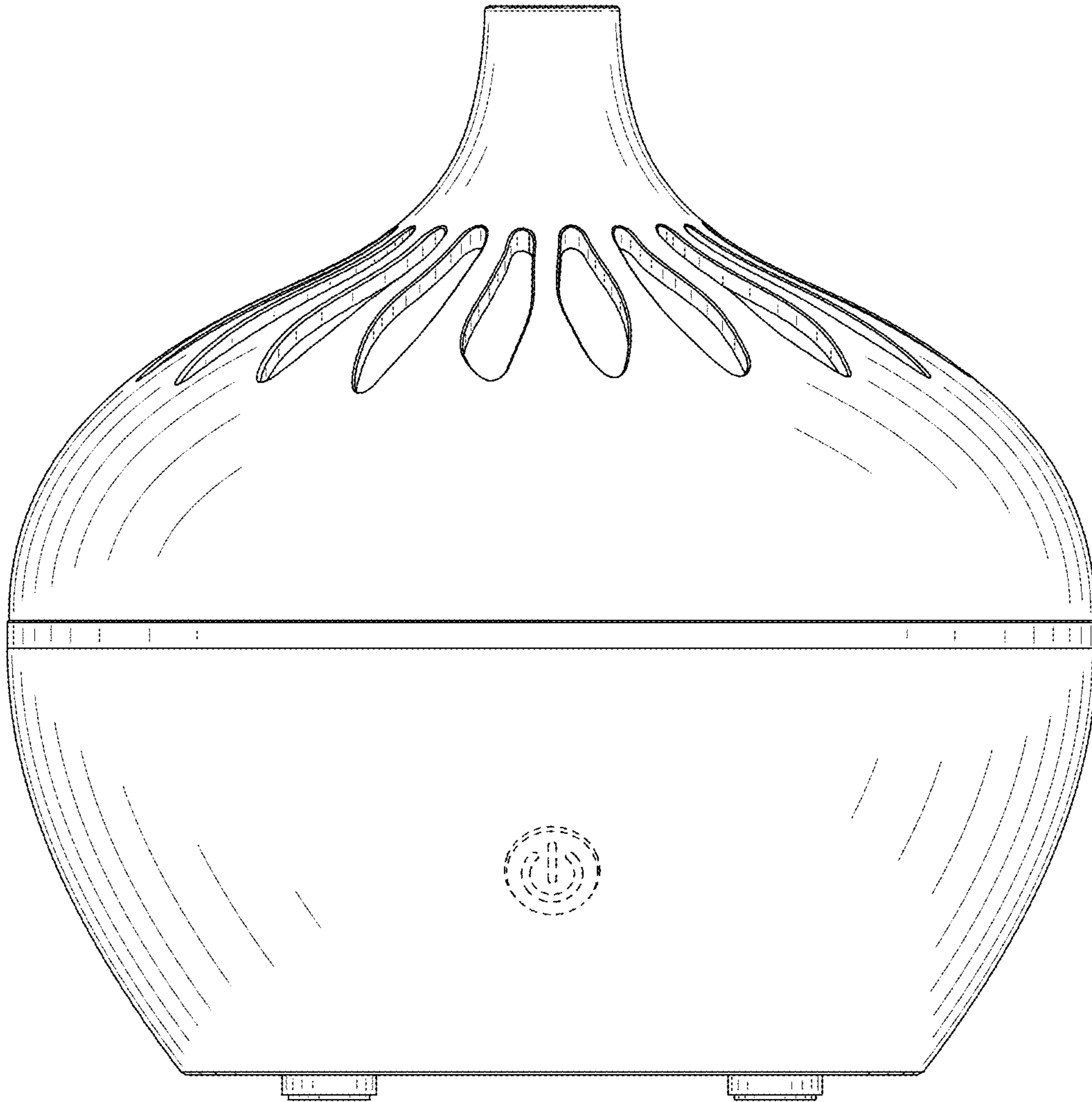

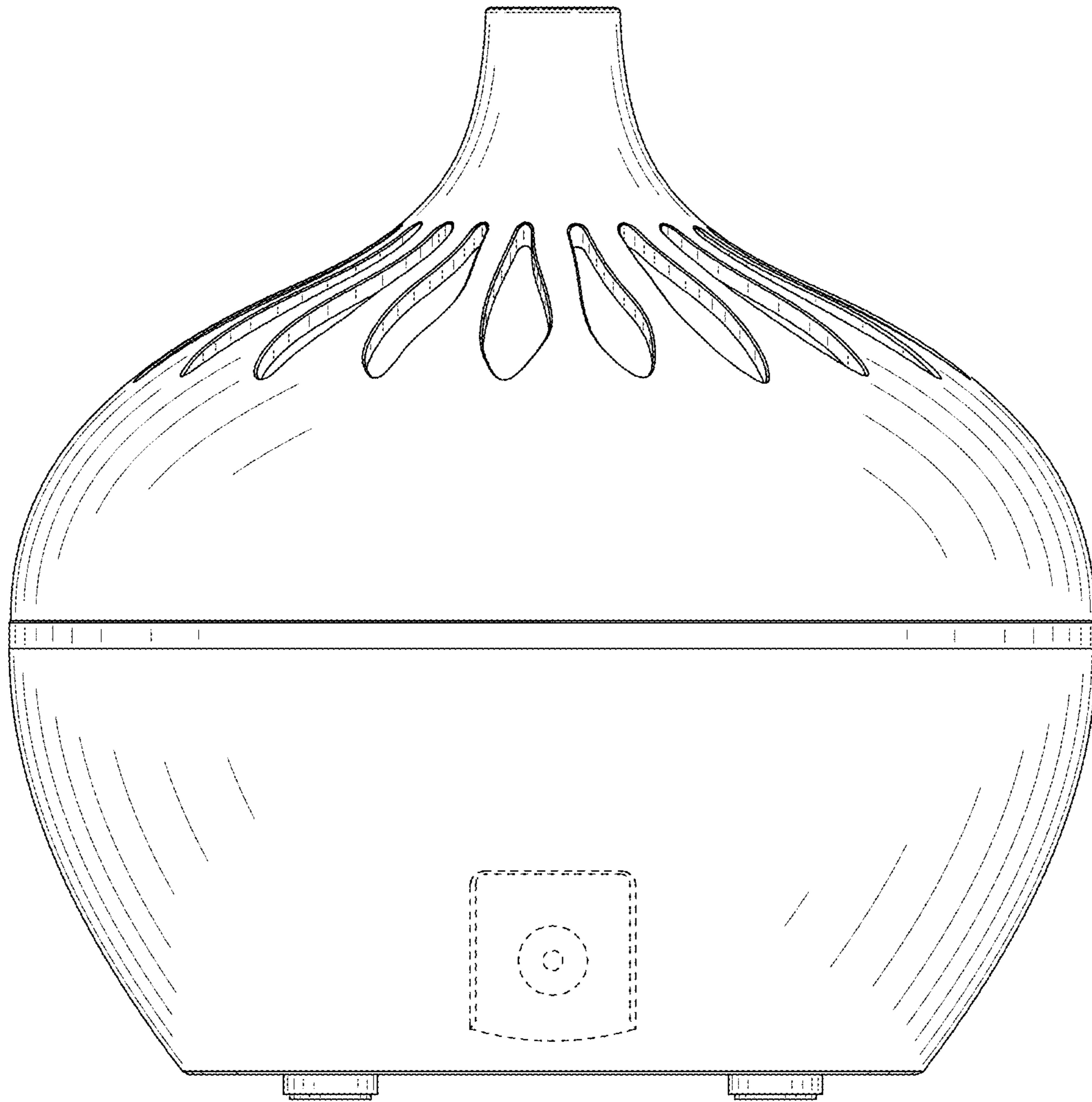

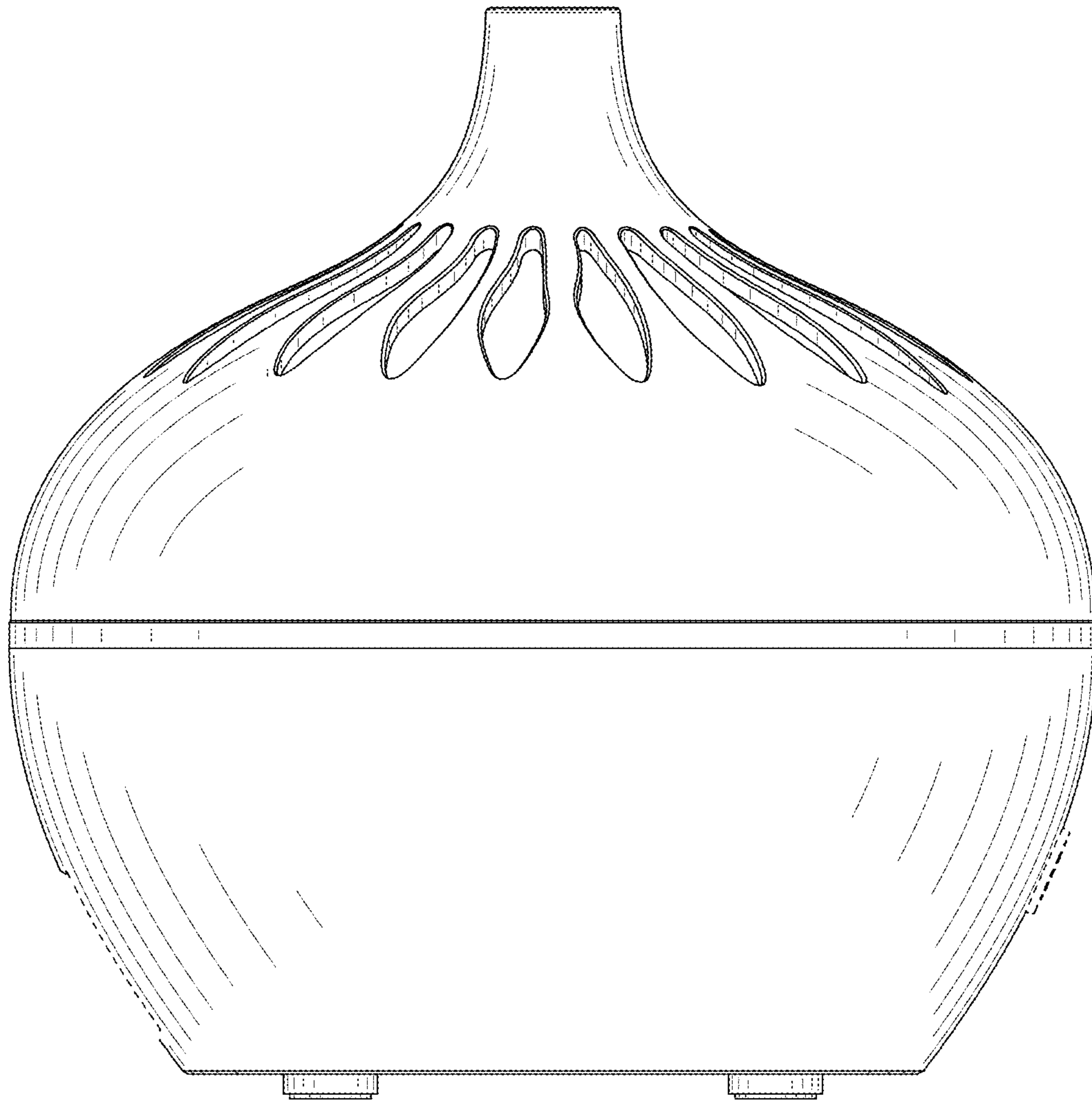

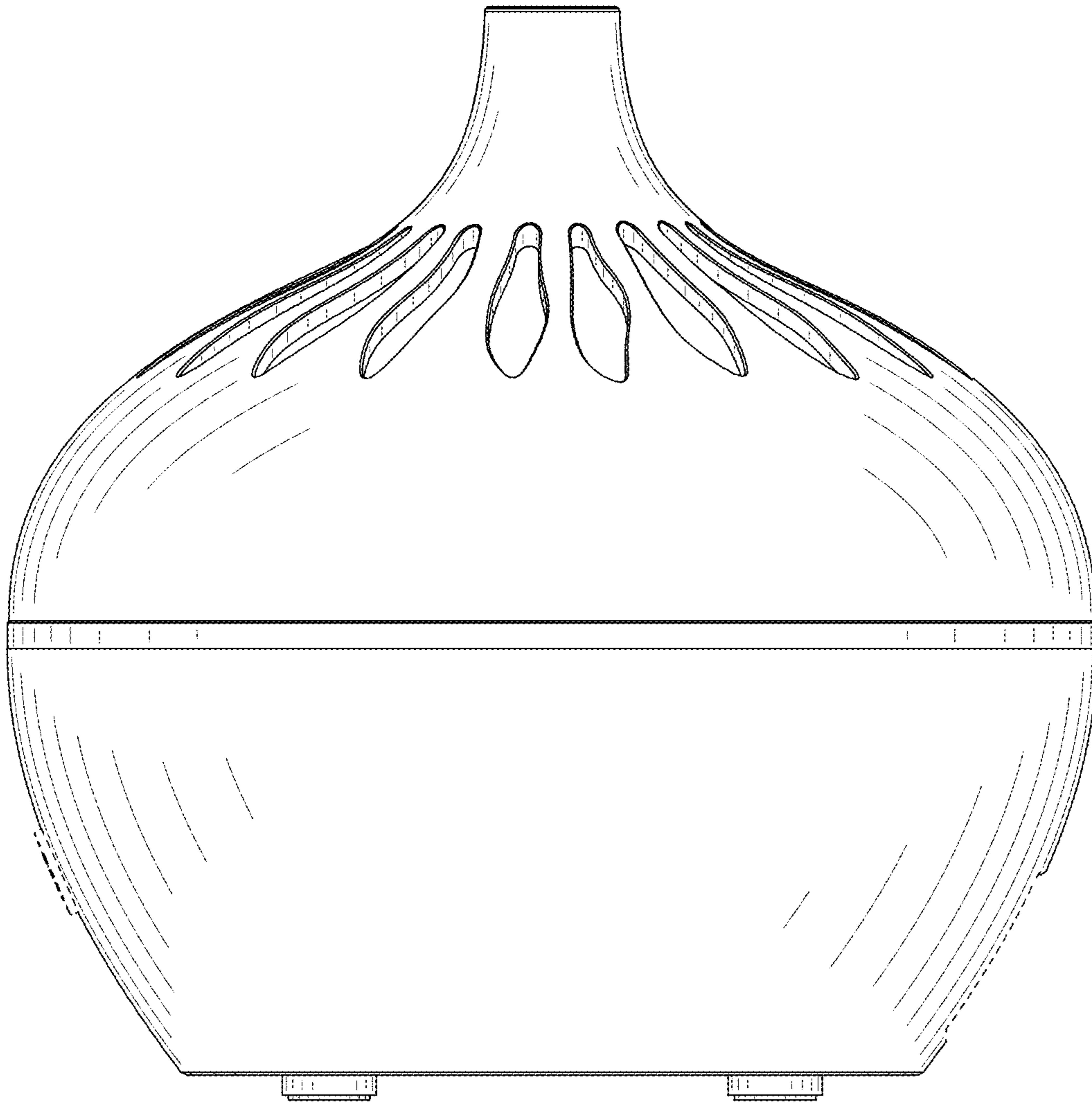

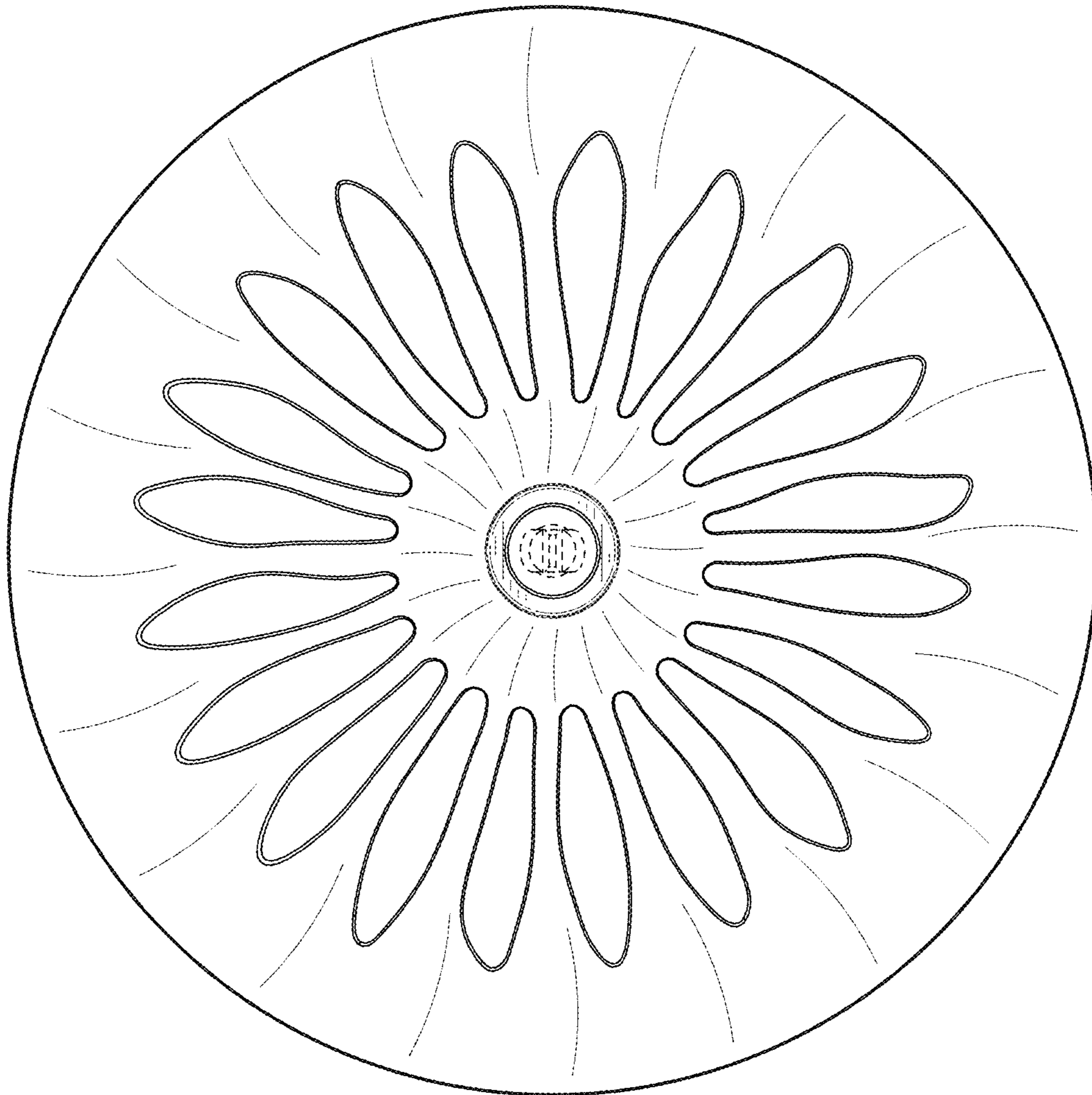

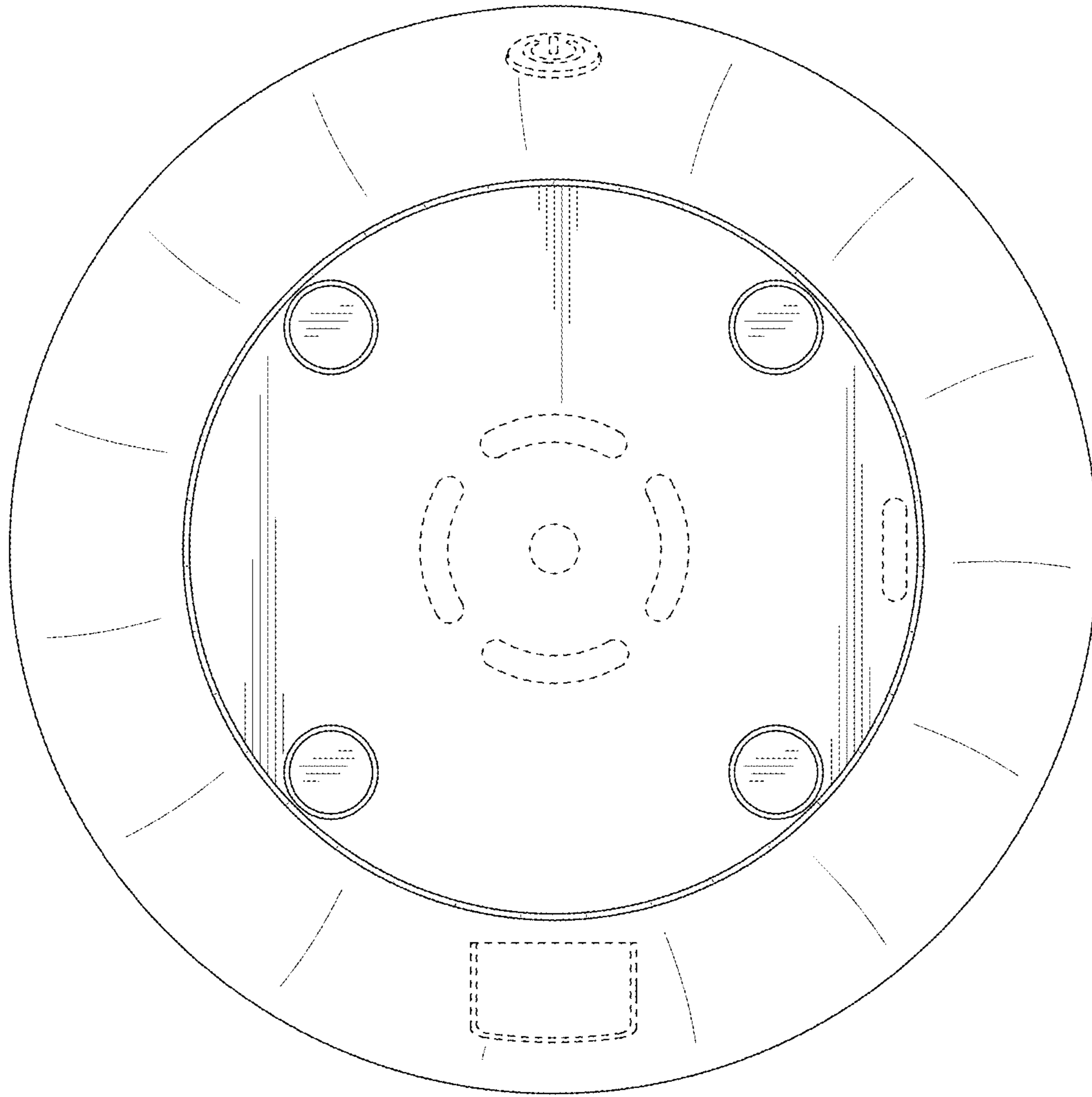

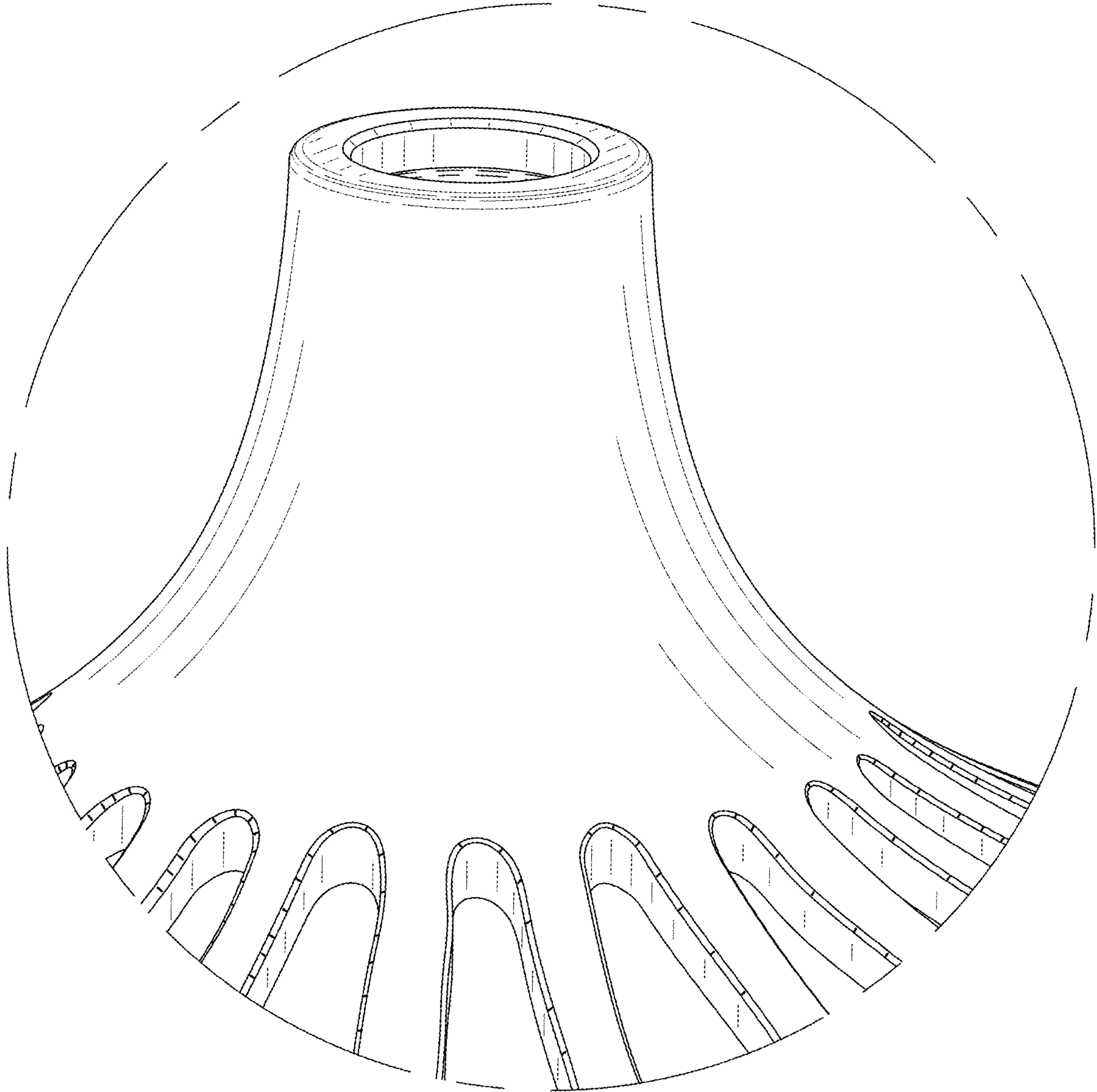
