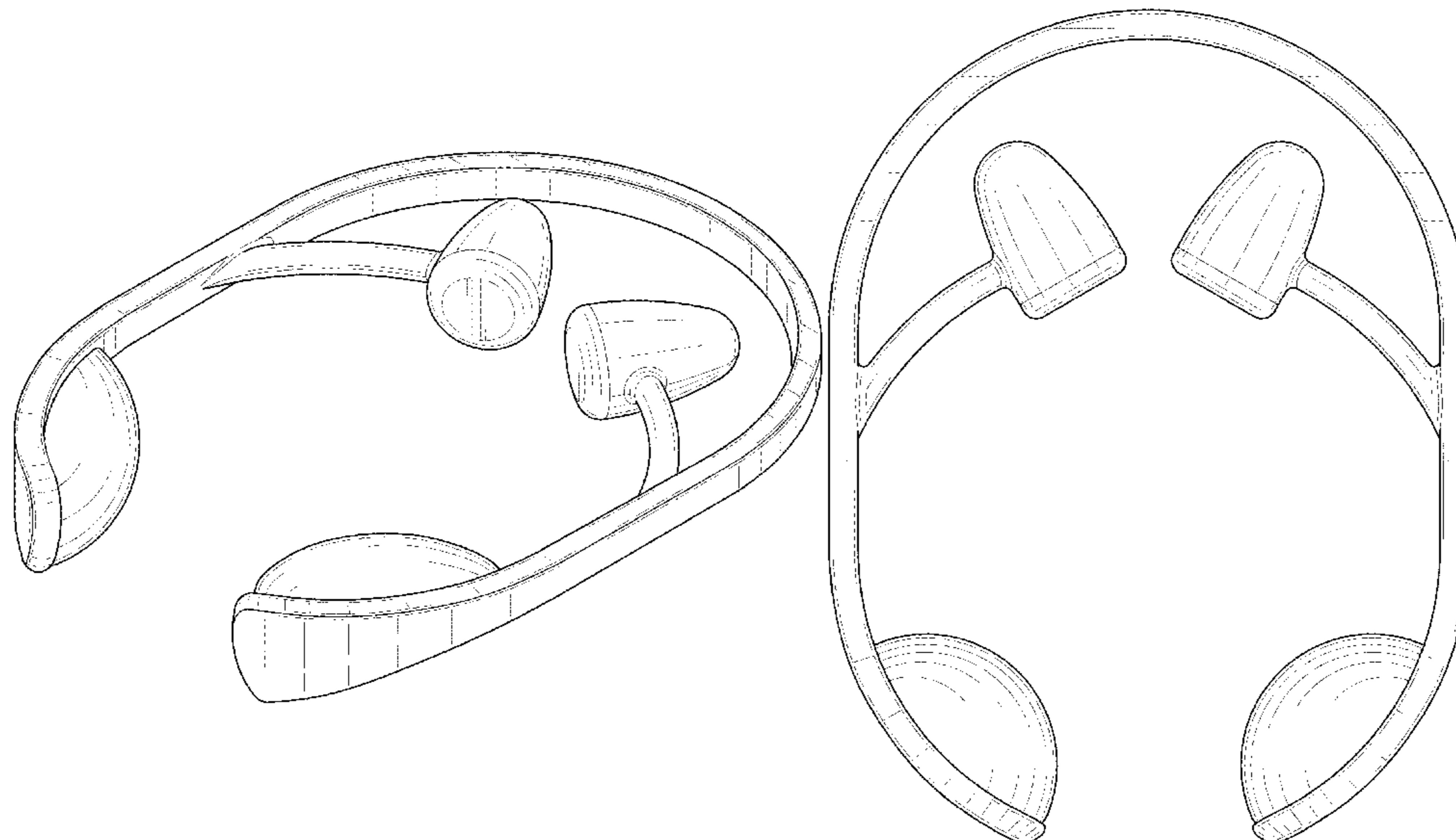
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, right-side, and top perspective view of the swallowing sensor, showing the new design;

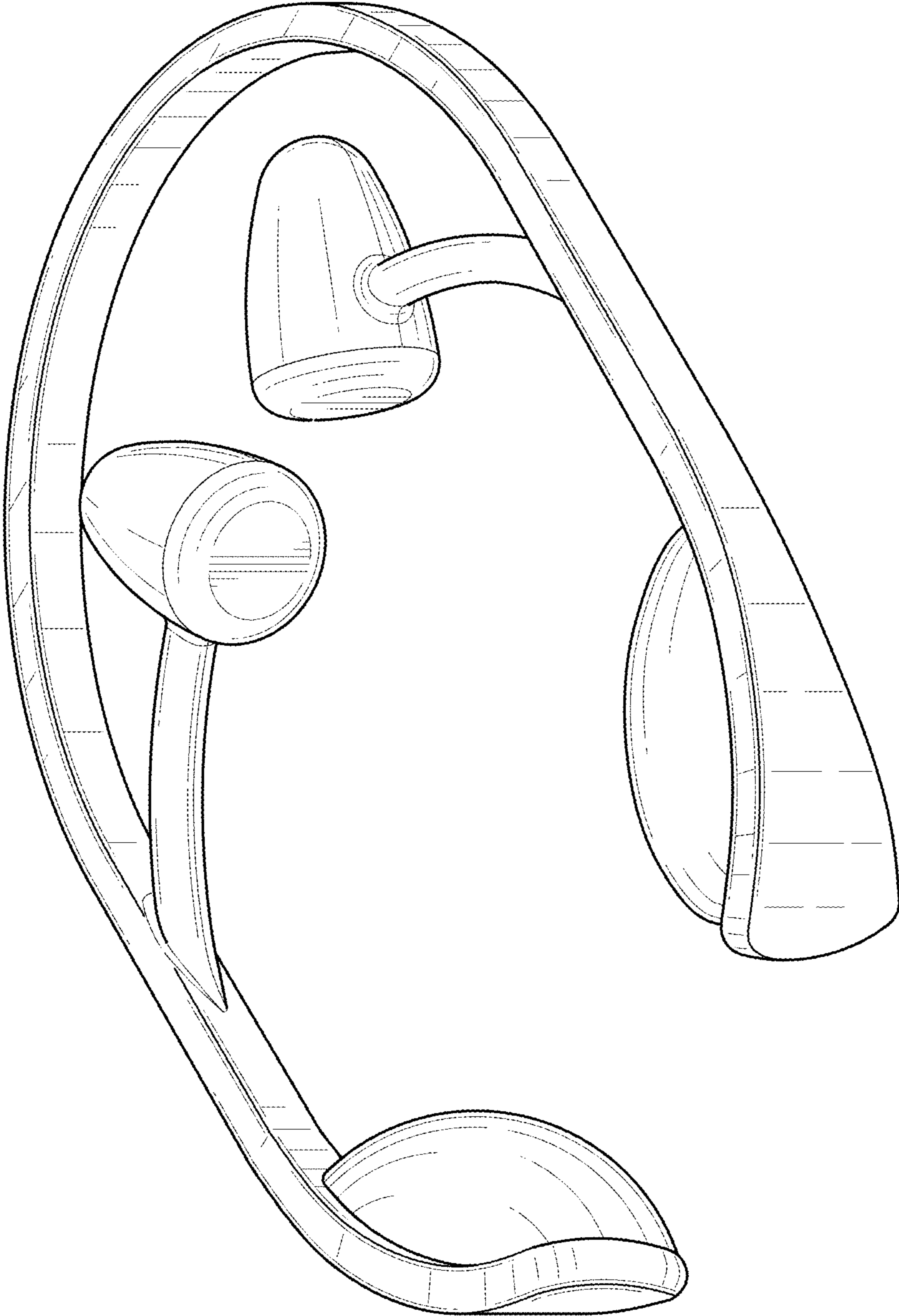

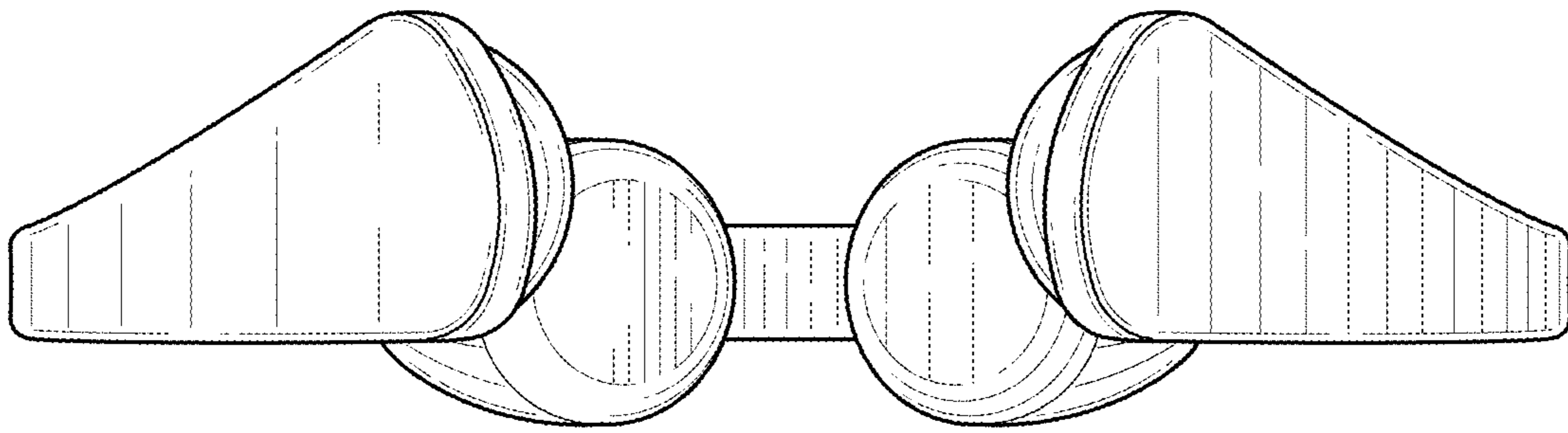

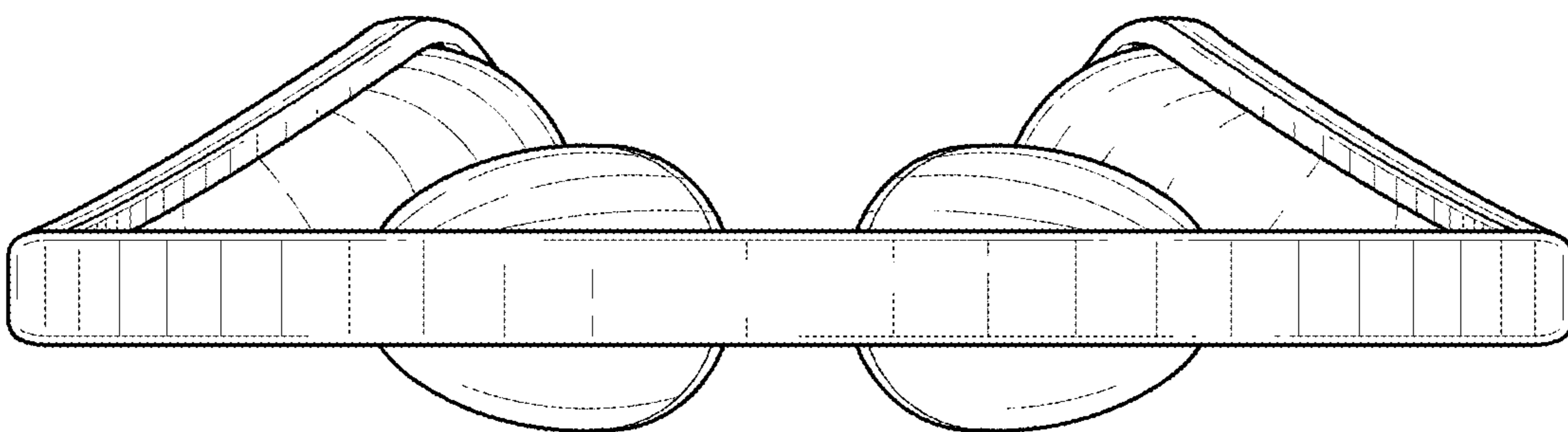

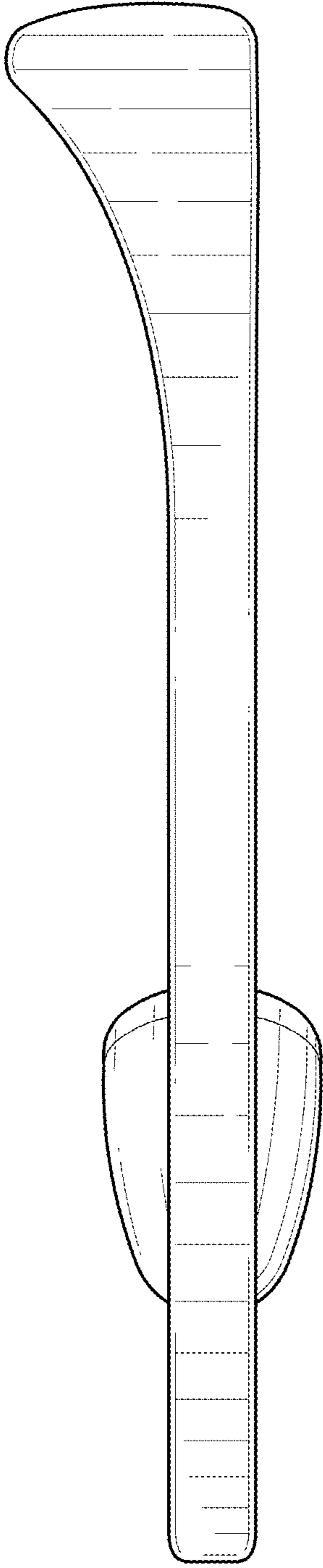

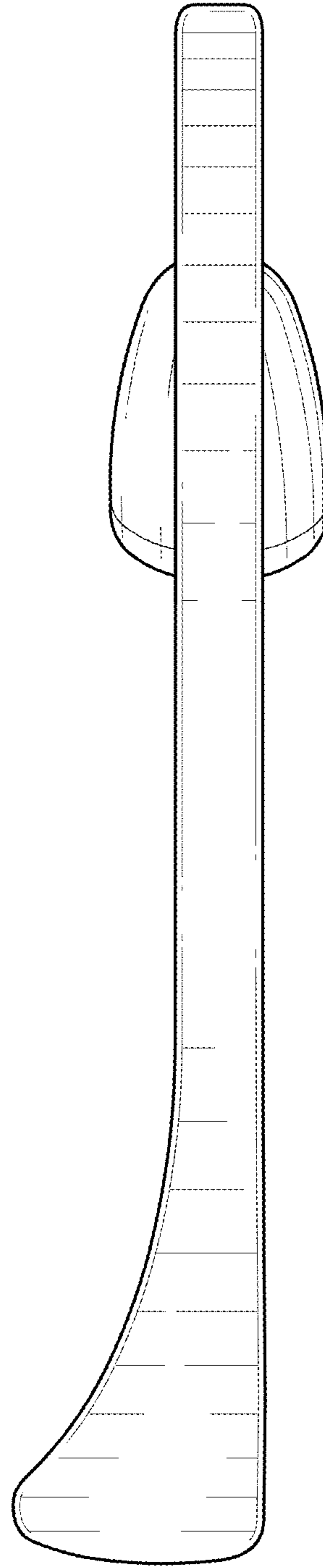

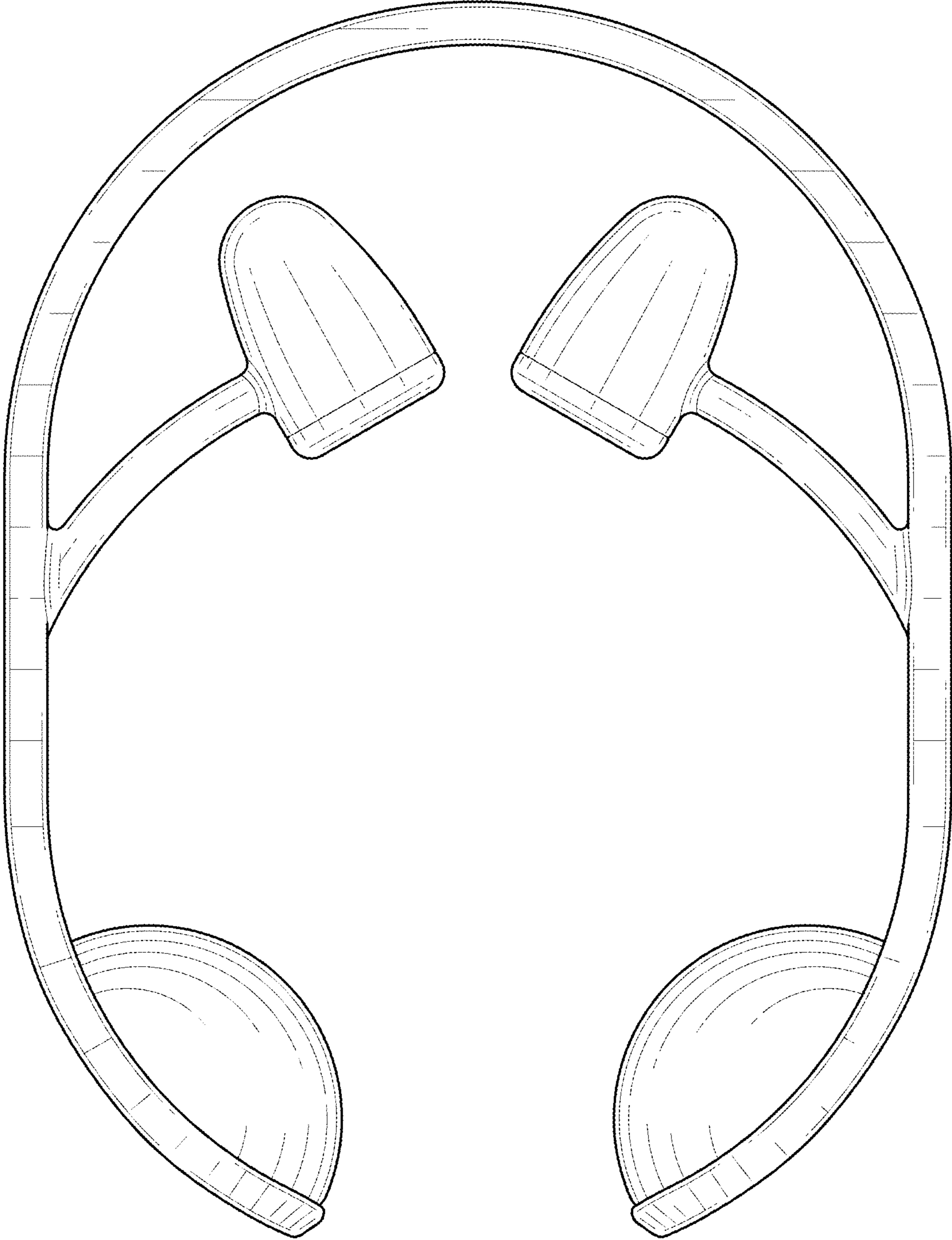

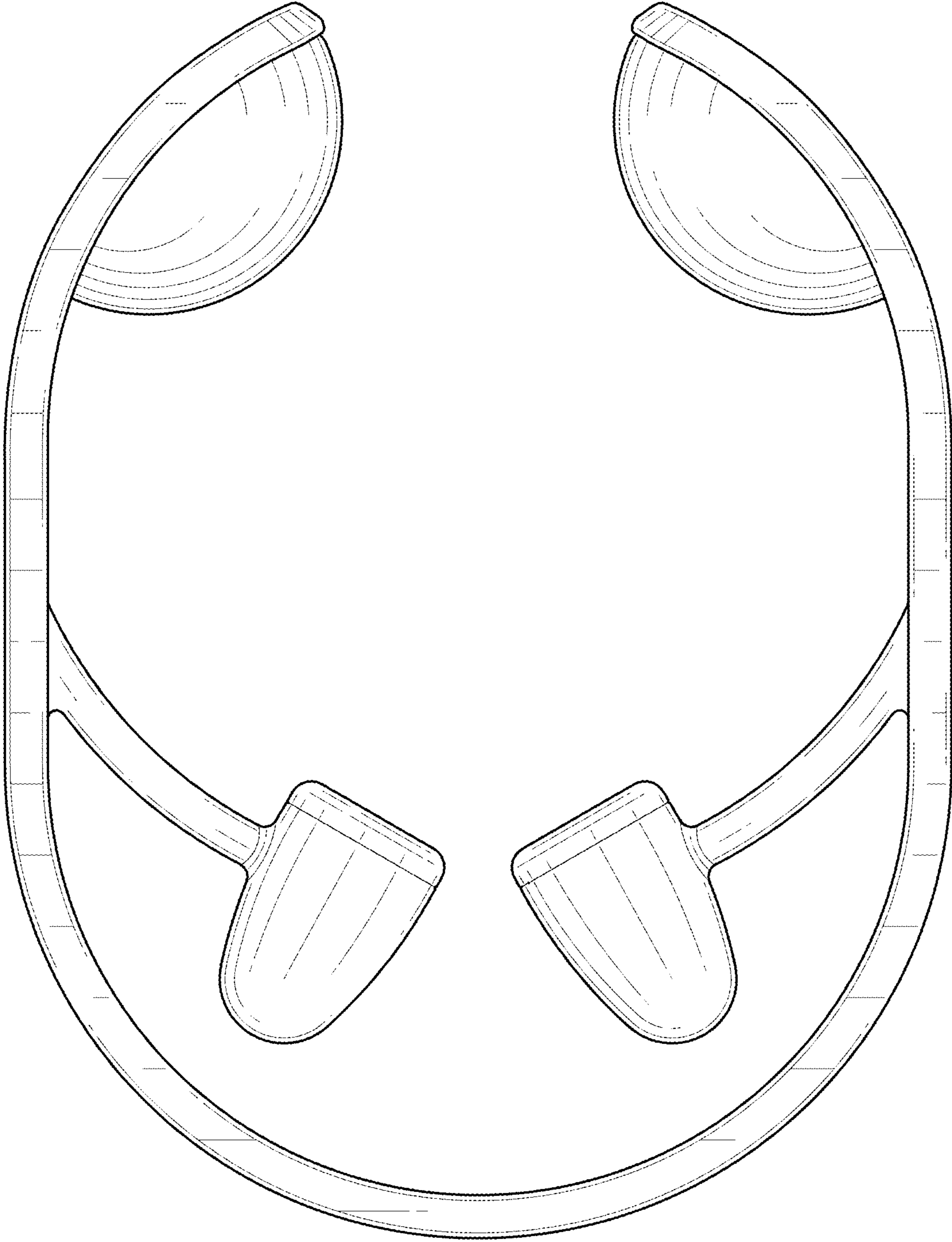
