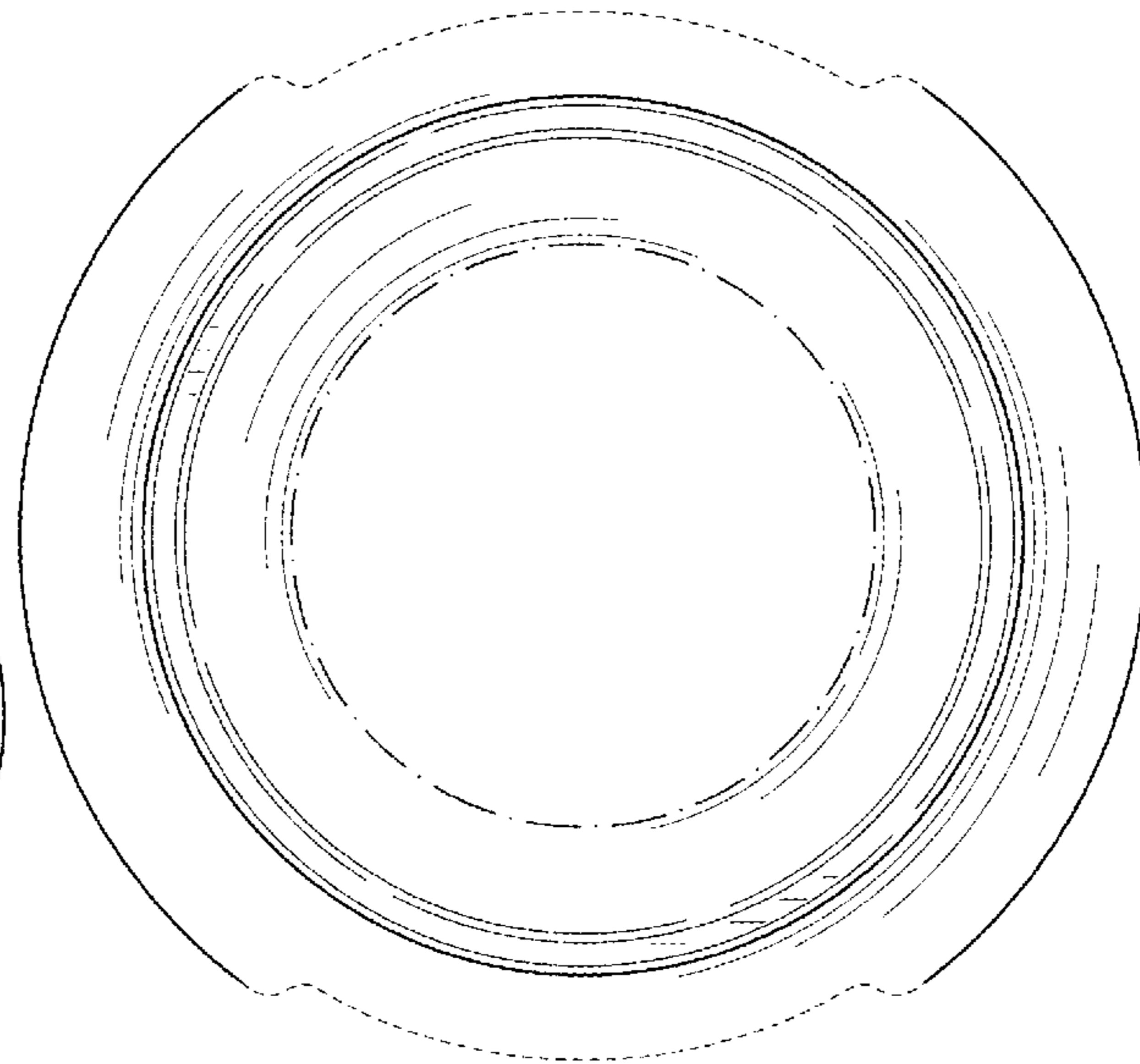
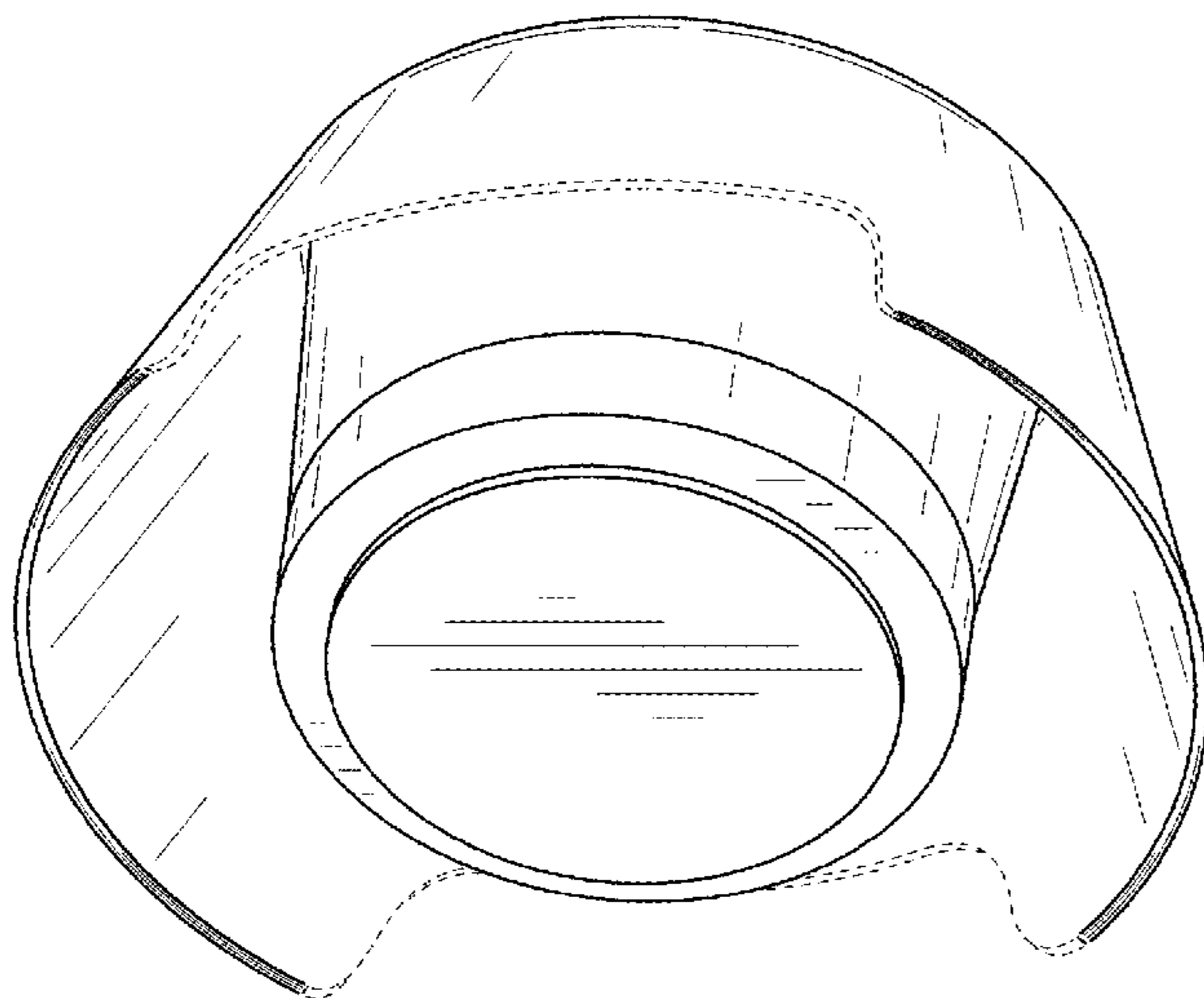
(57) **CLAIM**

The ornamental design for a non-slip dog bowl, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a design for a non-slip dog bowl;  
FIG. 2 is a side view thereof;  
FIG. 3 is another side view thereof;  
FIG. 4 is a front view thereof;  
FIG. 5 is a back view thereof;  
FIG. 6 is a top plan view thereof; and,

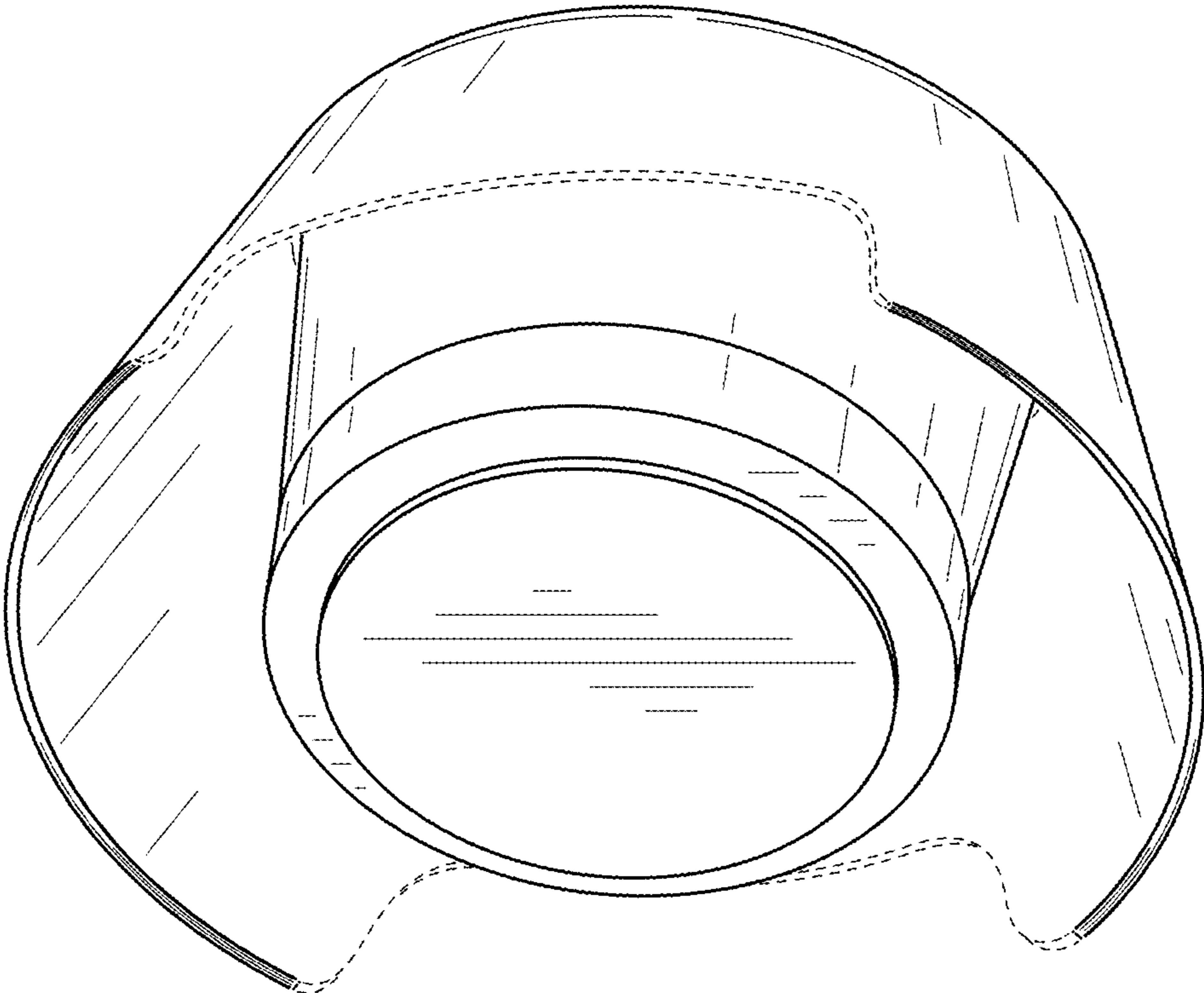

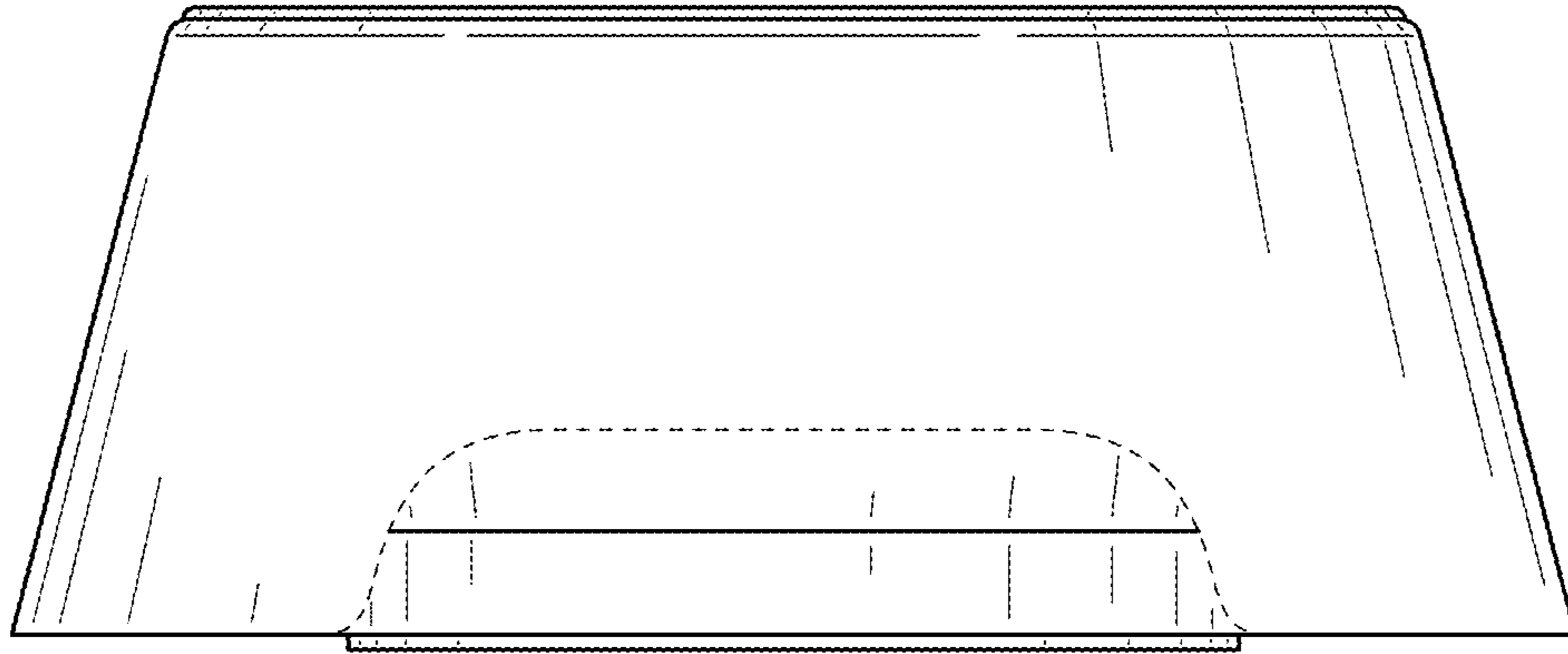

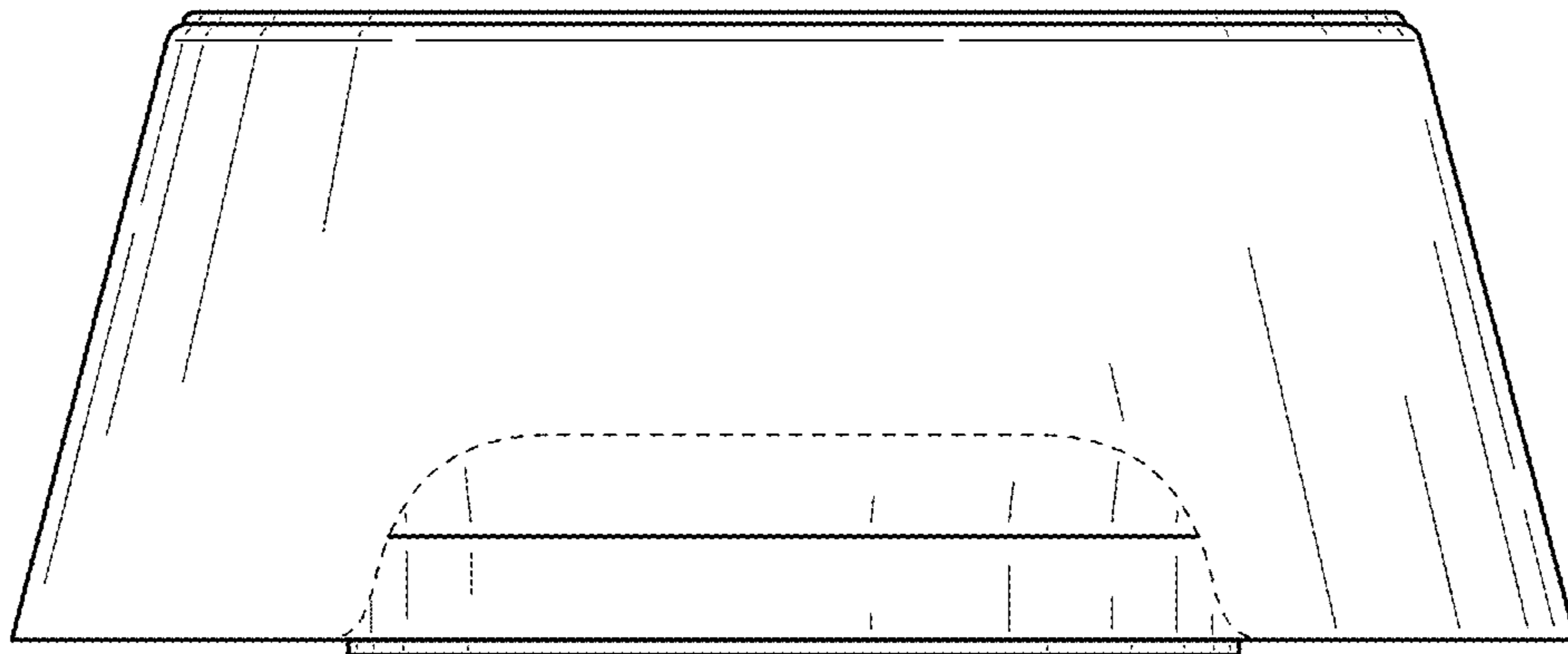

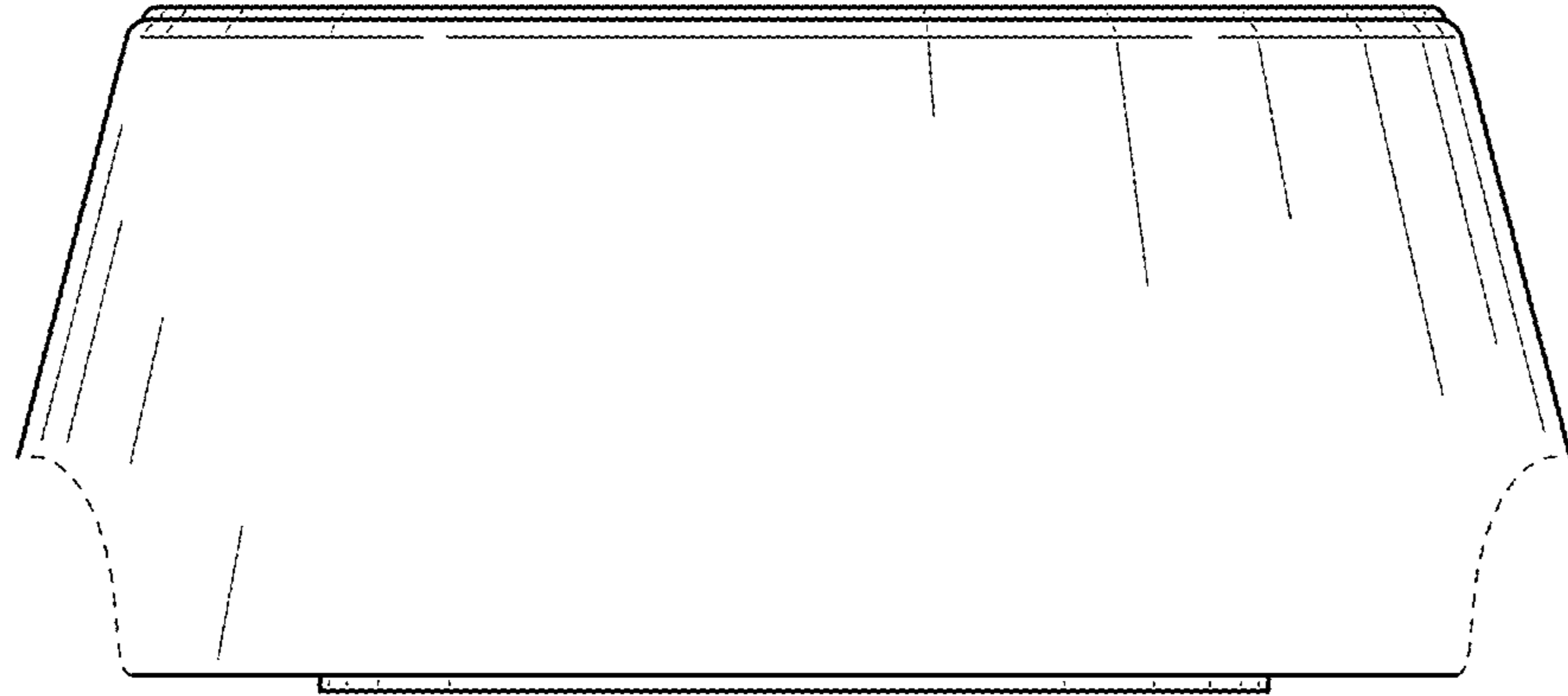

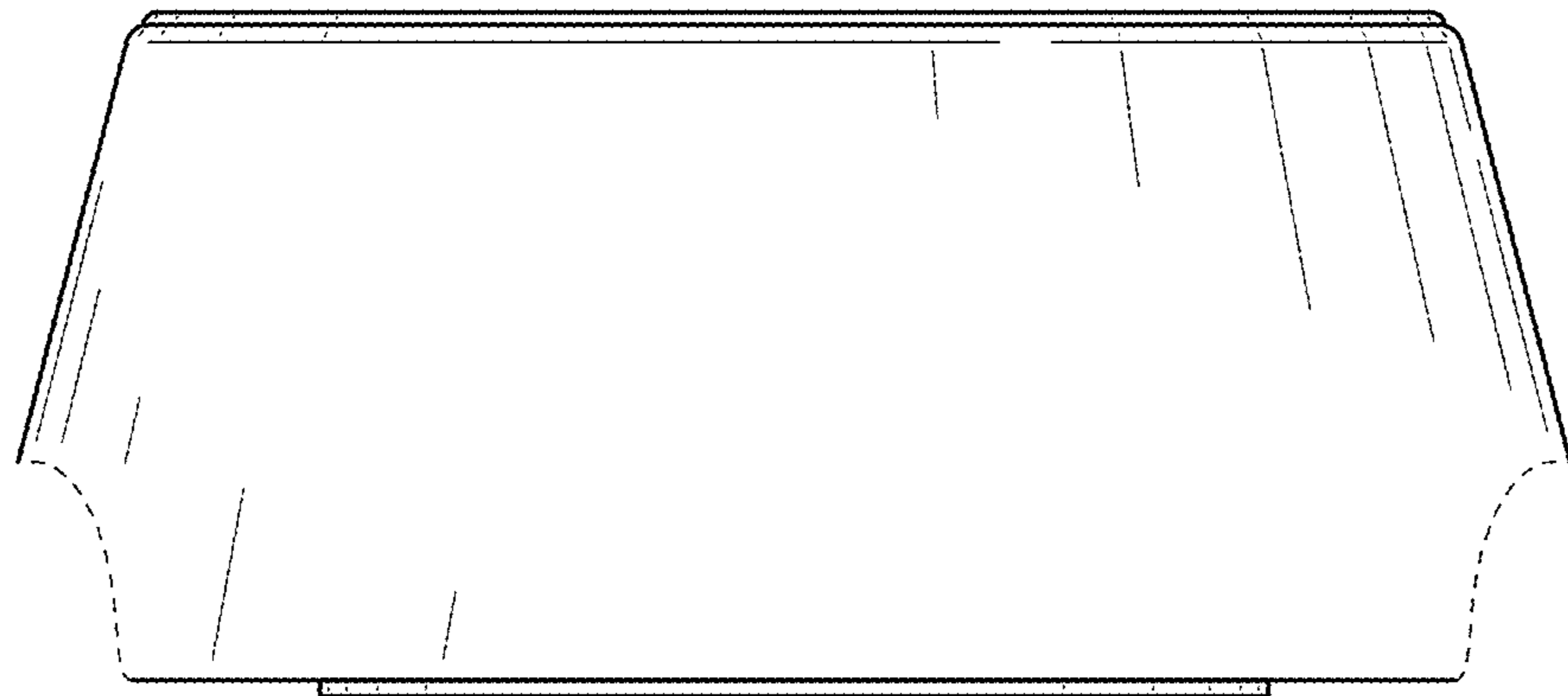

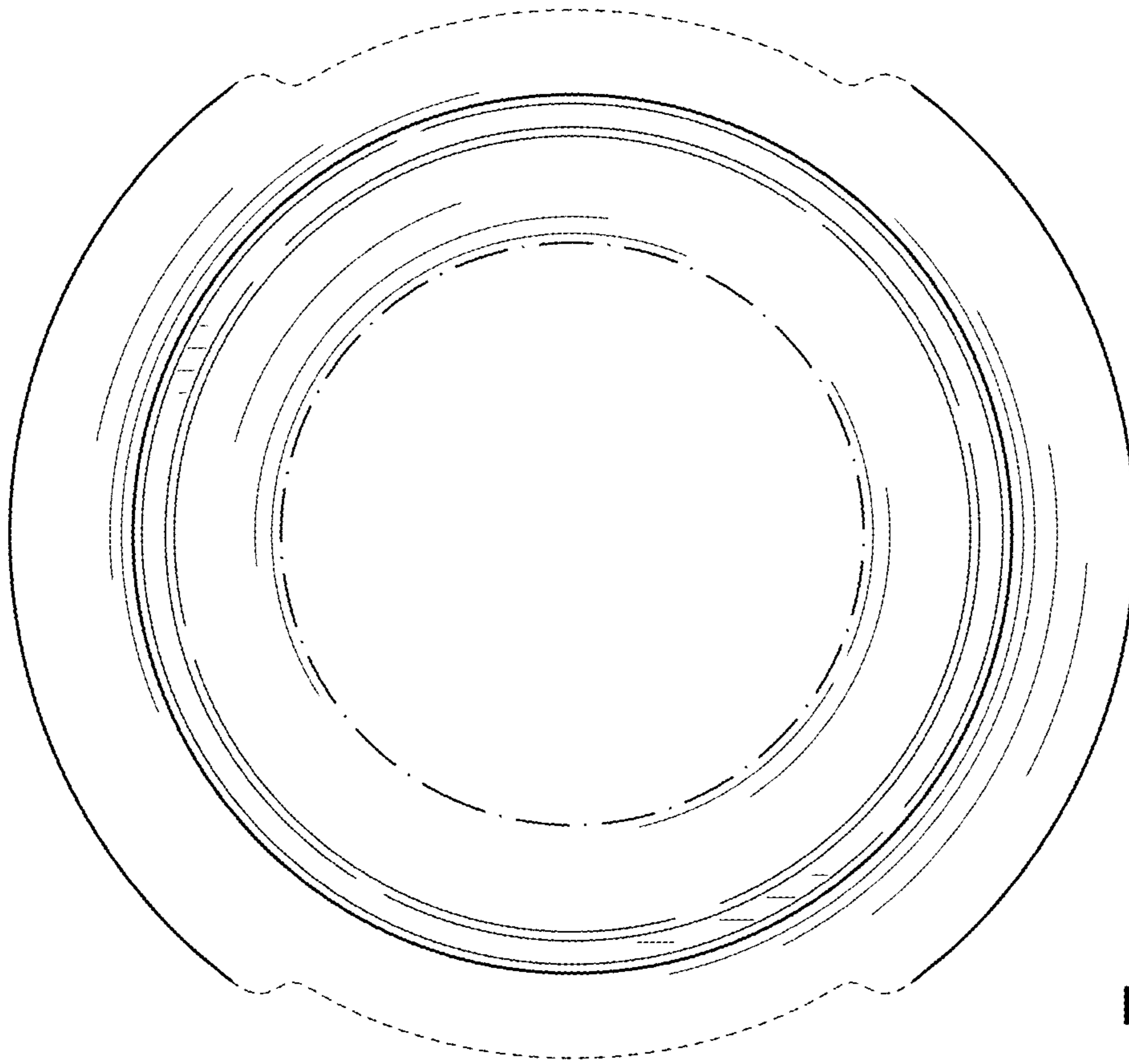

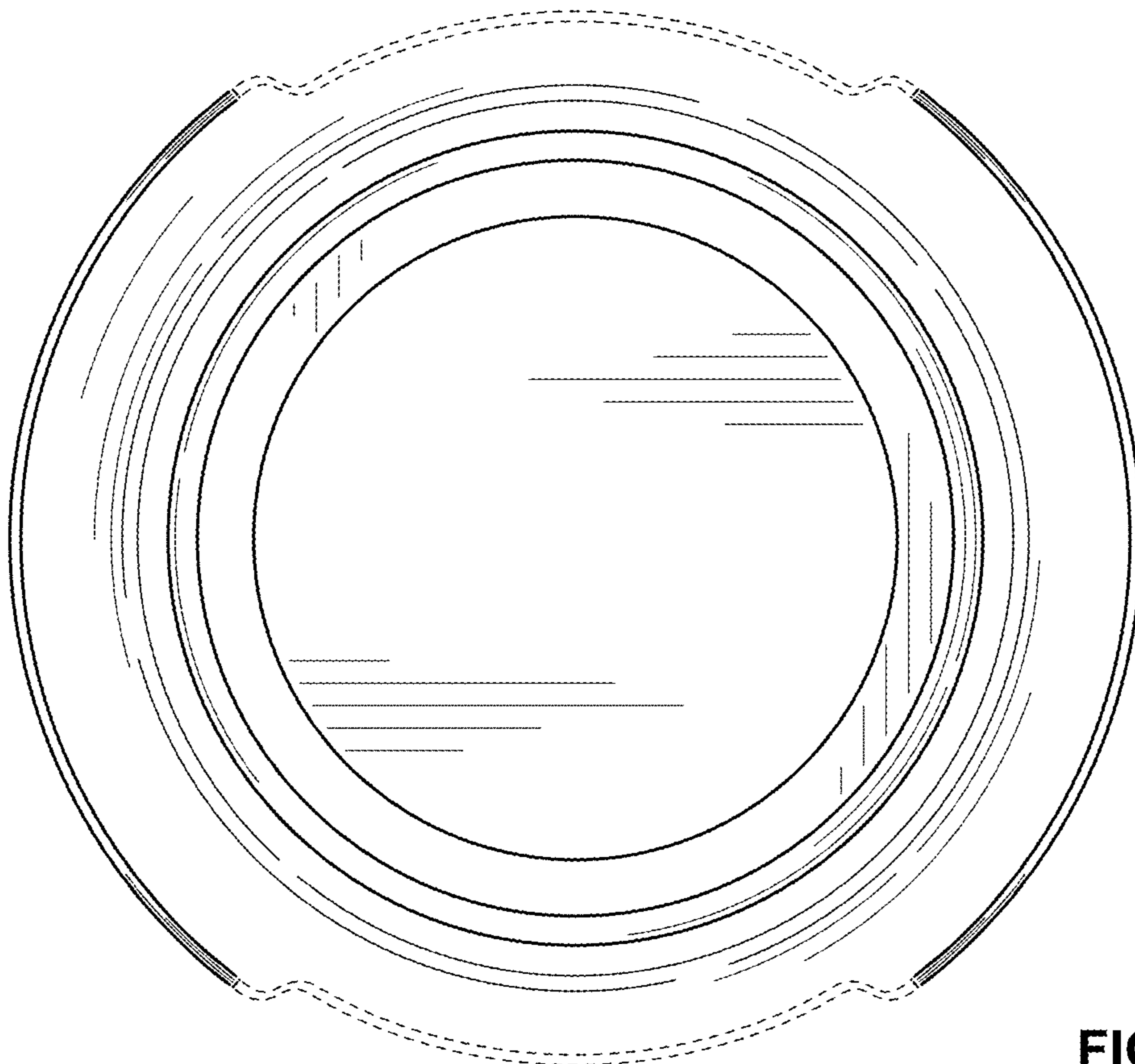
