(57) **CLAIM**

The ornamental design for a group of tamales with colored husks, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a group of tamales with colored husks showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a back elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

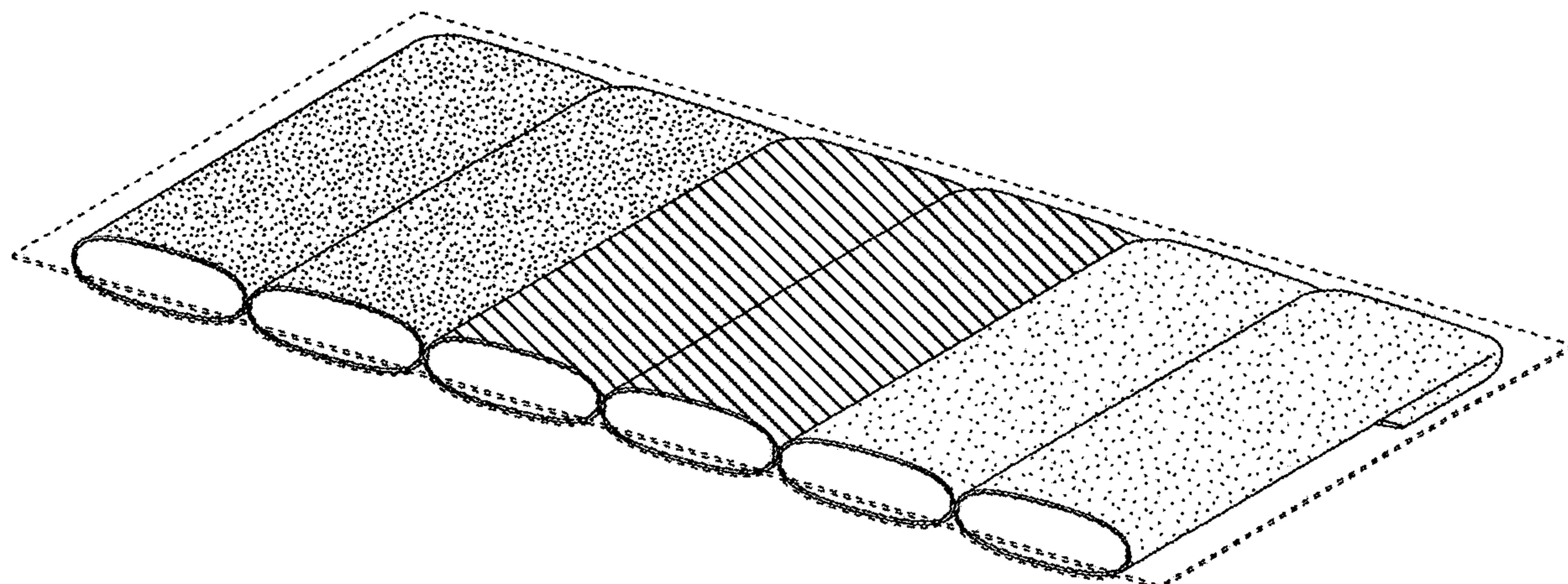
FIG. 6 is a left side elevation view thereof; and,

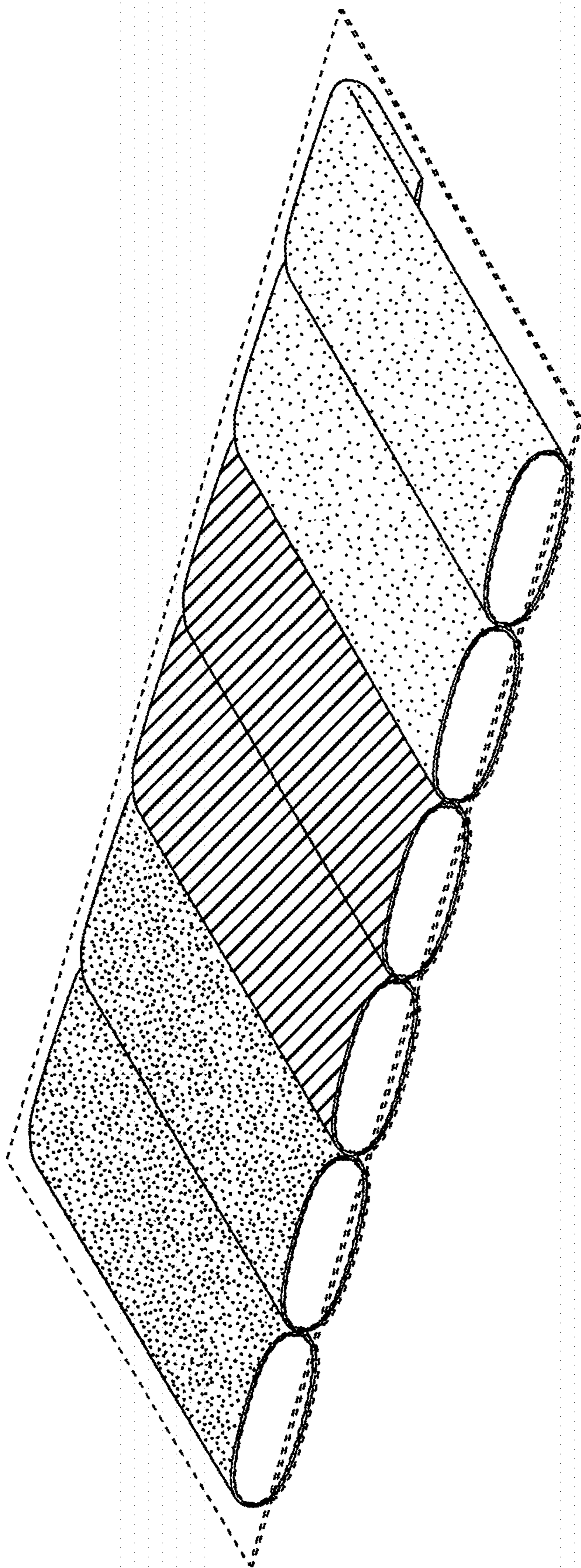

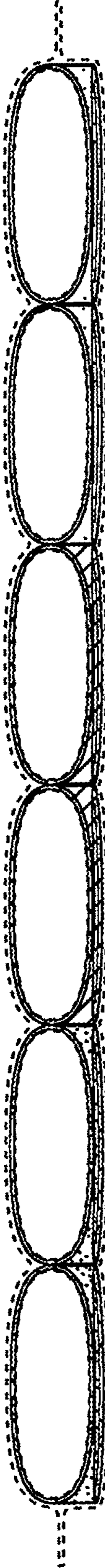

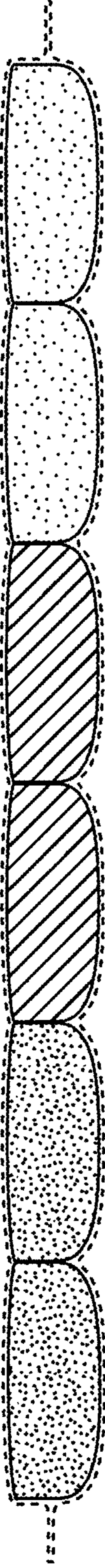

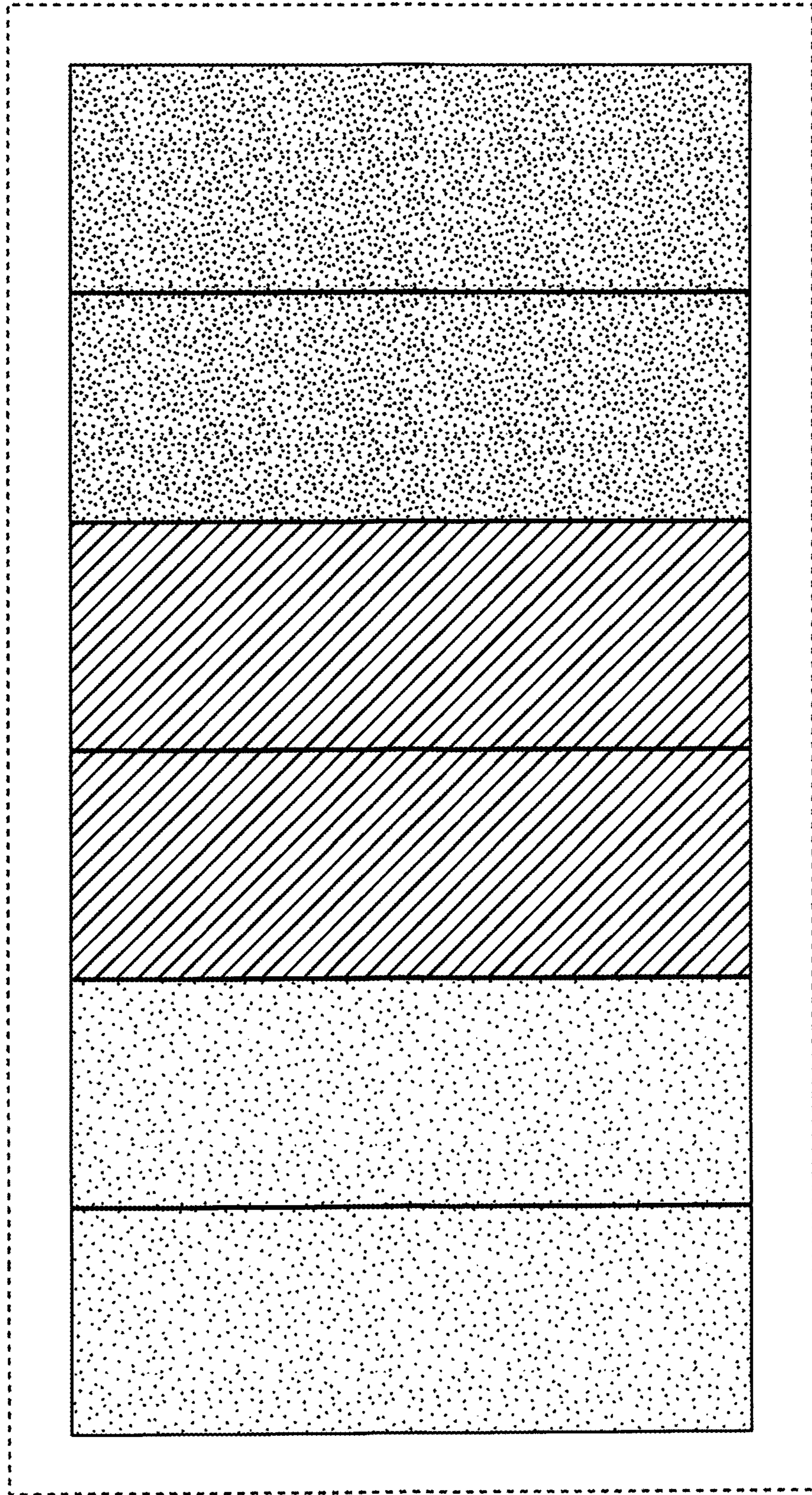

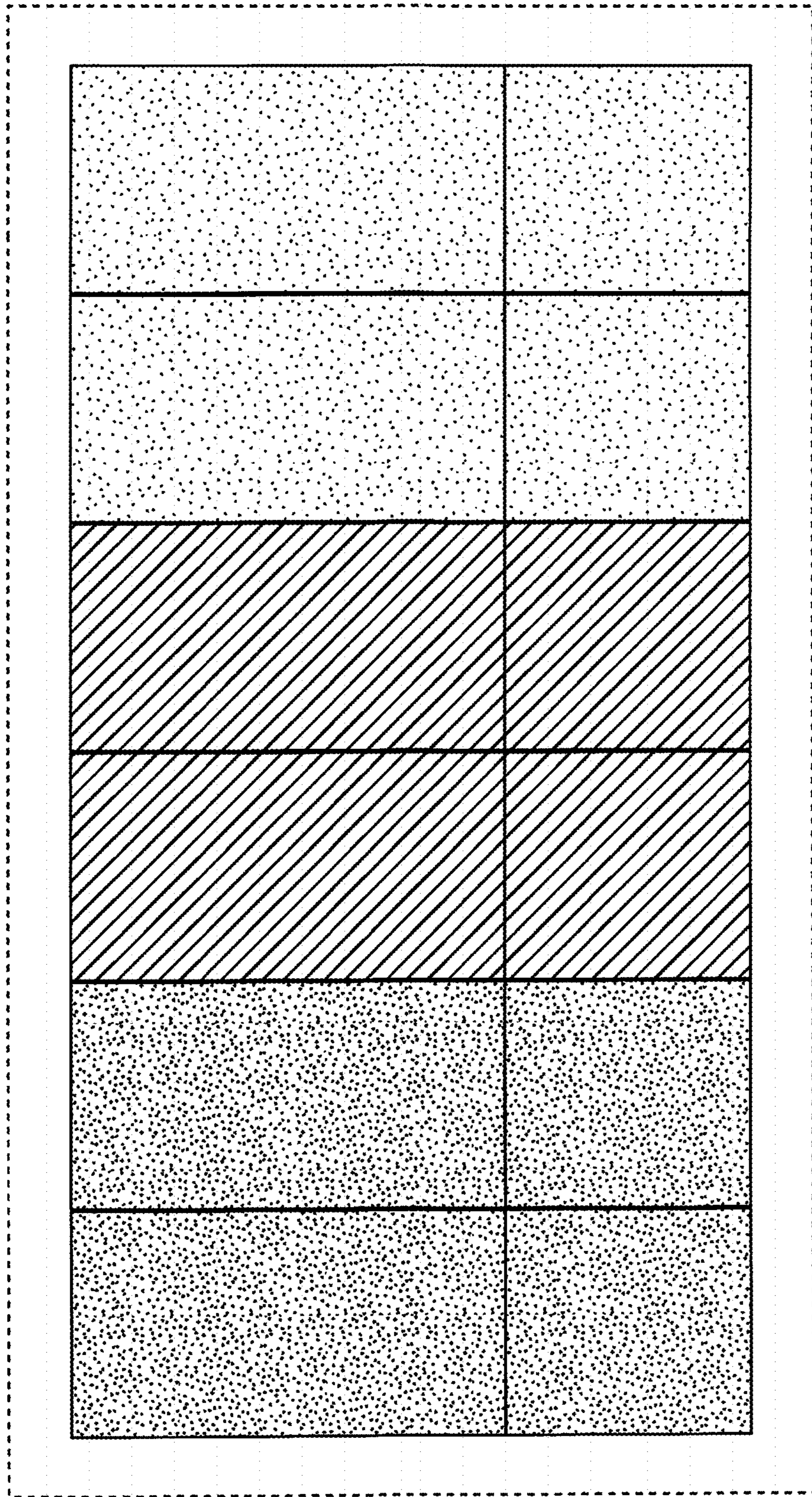

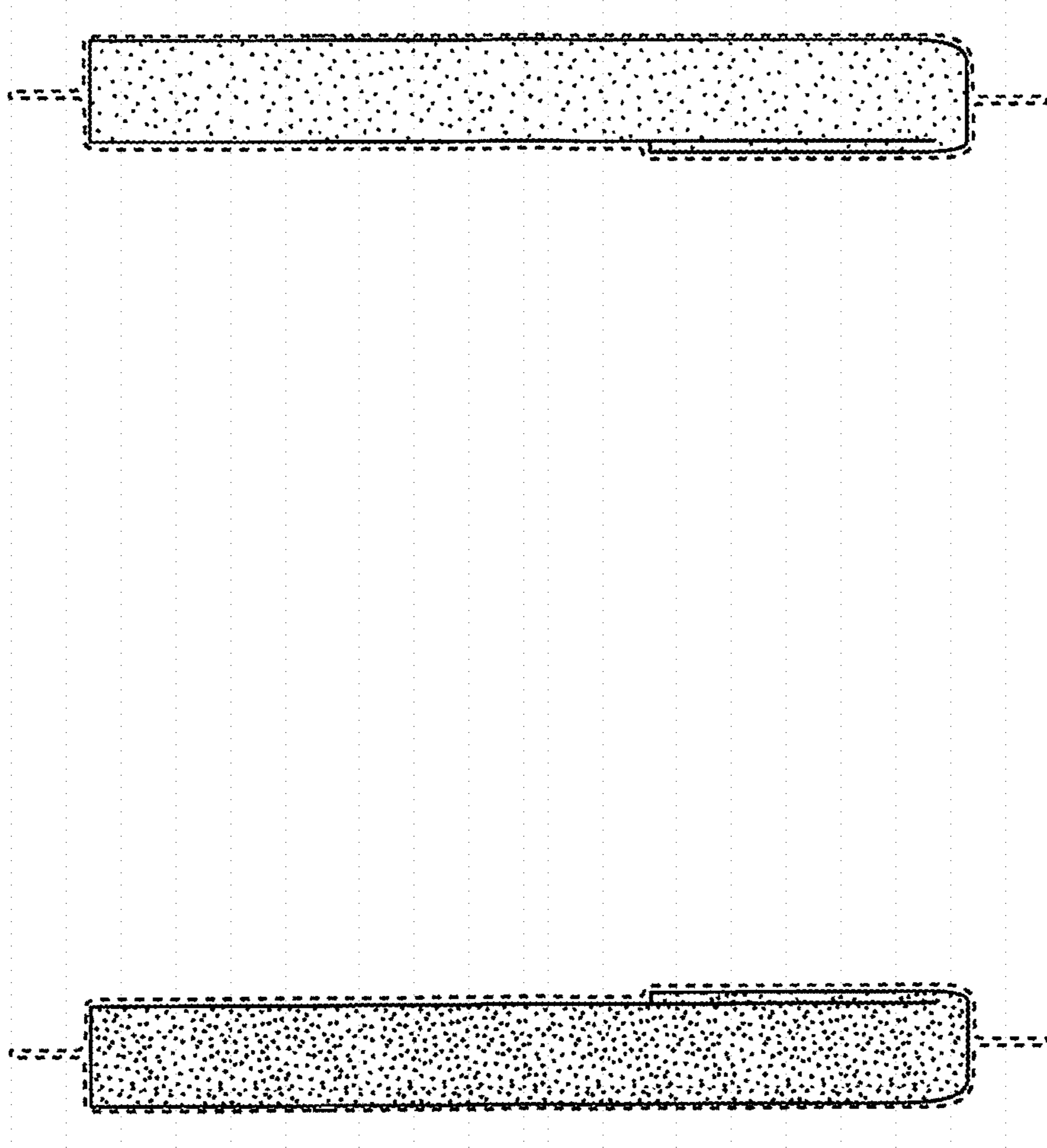
