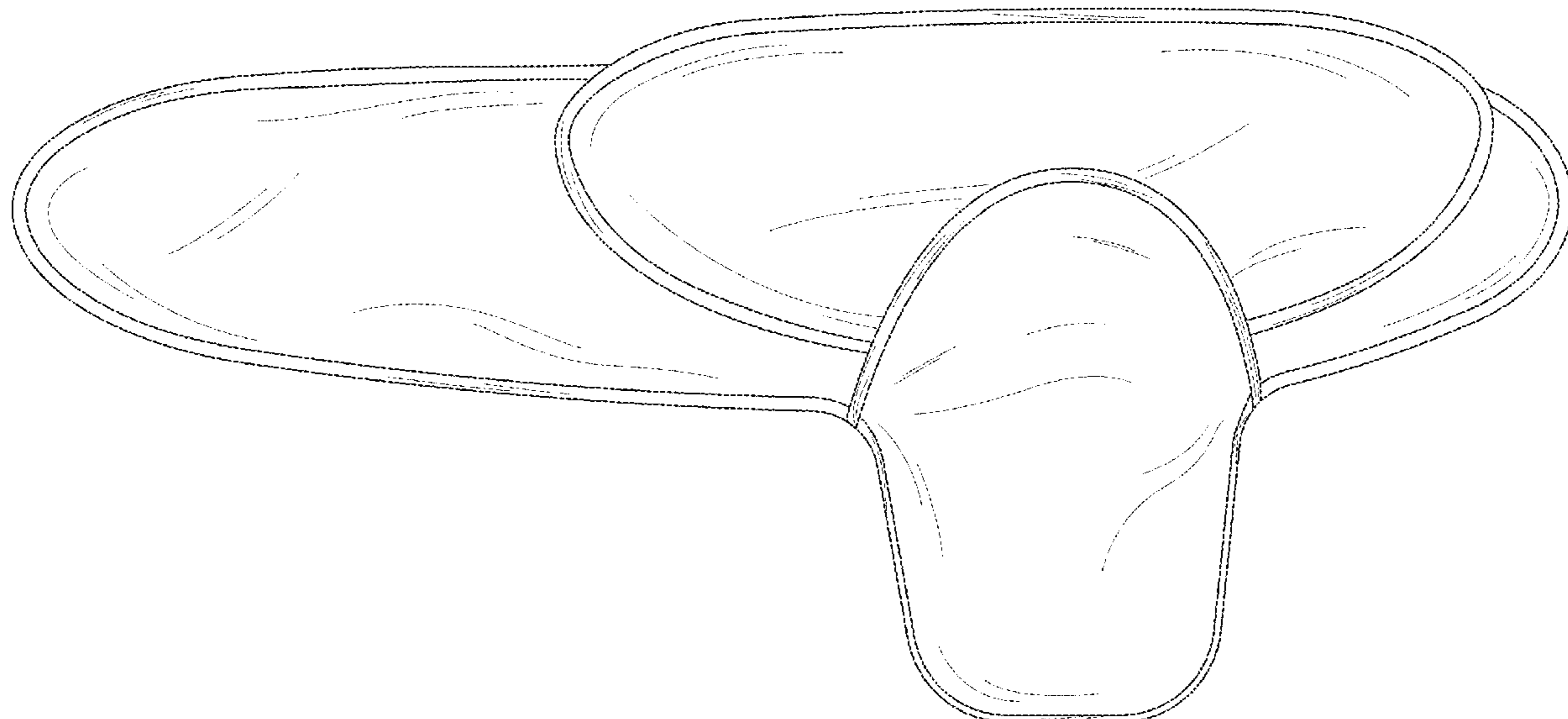
(57) **CLAIM**

The ornamental design for a baby swaddling blanket, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a baby swaddling blanket, showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left-side elevational view thereof;
FIG. 4 is a right-side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a top perspective view thereof, illustrated with a first wrap of the blanket tucked over a baby's shoulders and arms and tucked under the baby's torso;
FIG. 8 is a top perspective view thereof, illustrated with a lower portion of the baby tucked into a lower pocket of the blanket;
FIG. 9 is a top perspective view thereof, illustrated with a short side of a second wrap wrapped around the baby's torso; and,
FIG. 10 is a top perspective view thereof, illustrated with a long side of the second wrap wrapped the baby's torso.
The broken lines showing a baby in the figures depict environmental matter and form no part of the claimed design.

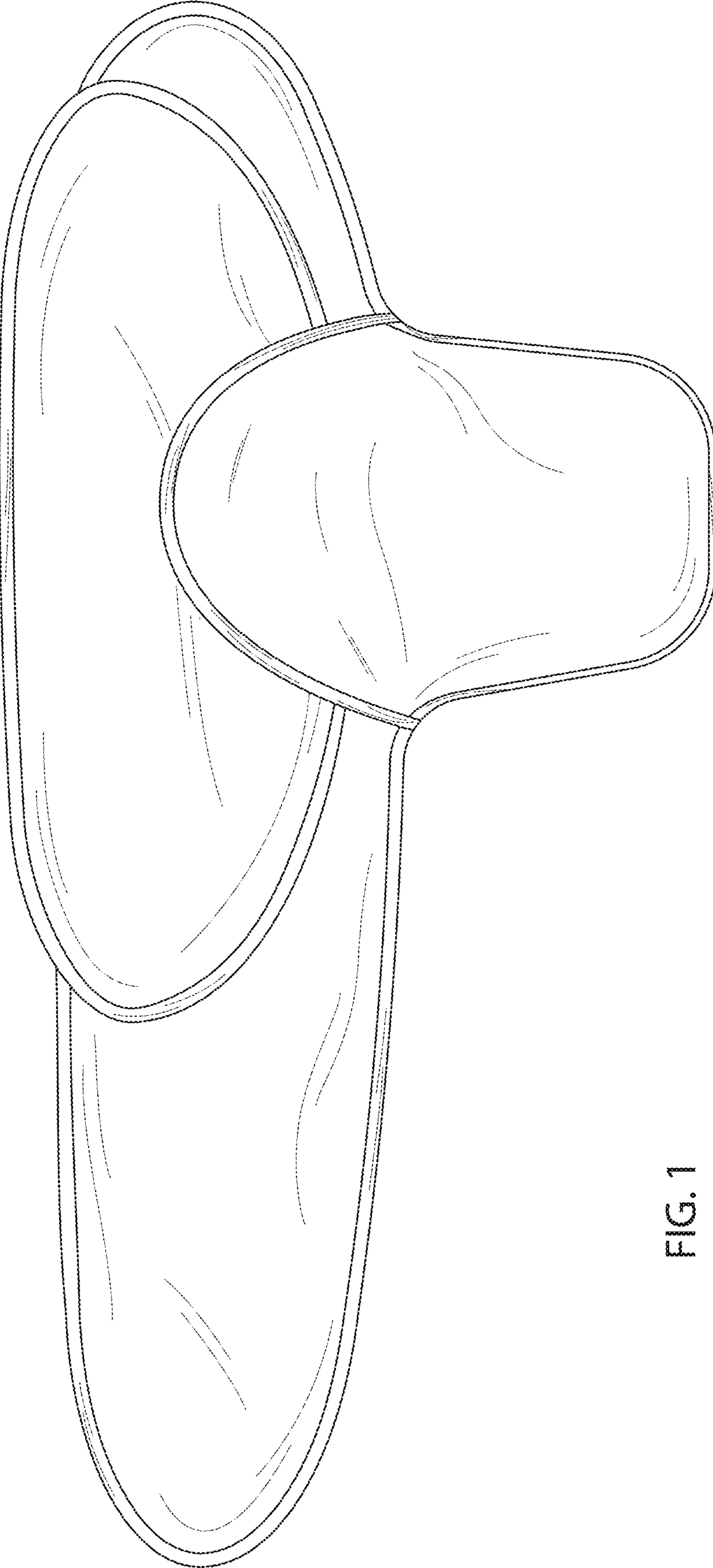

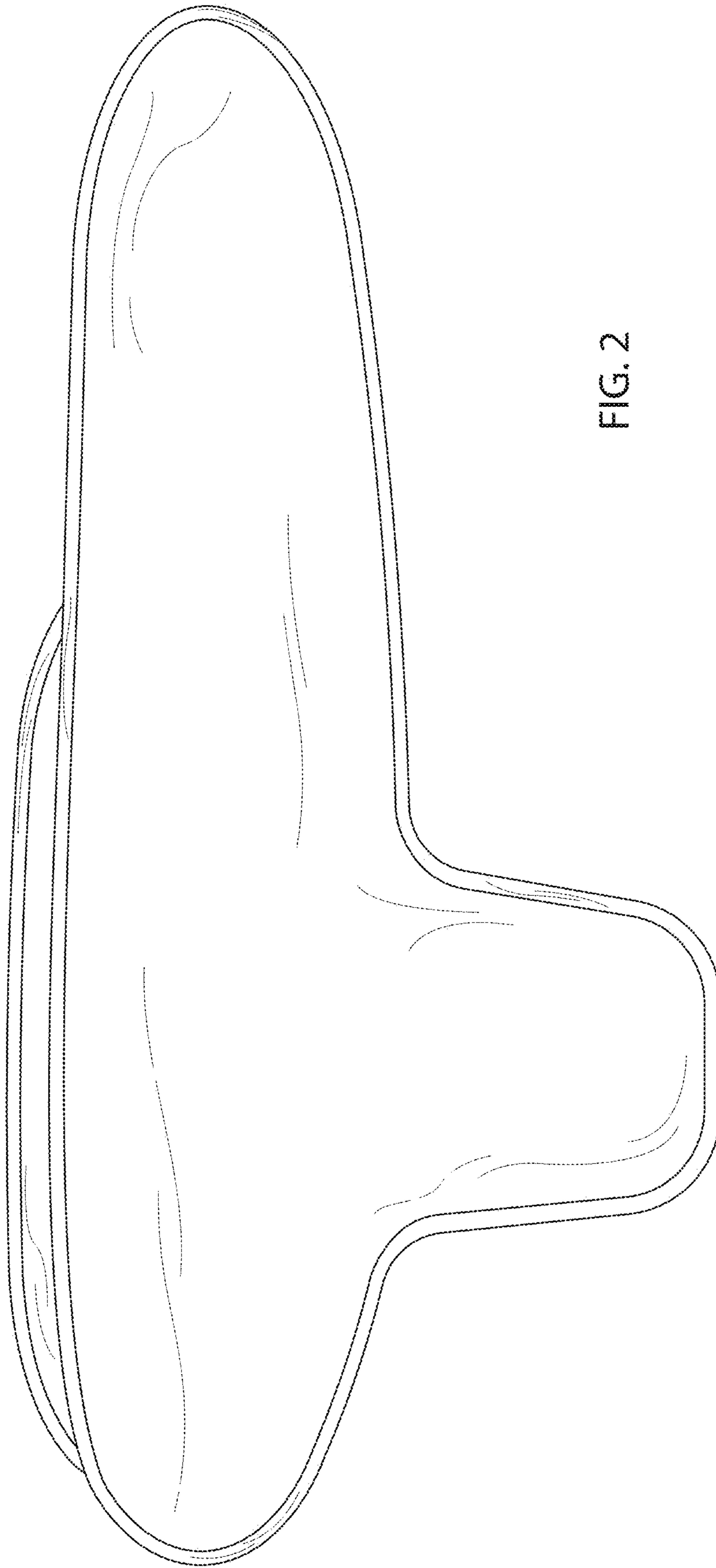

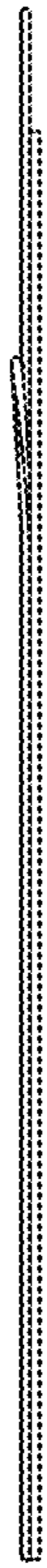

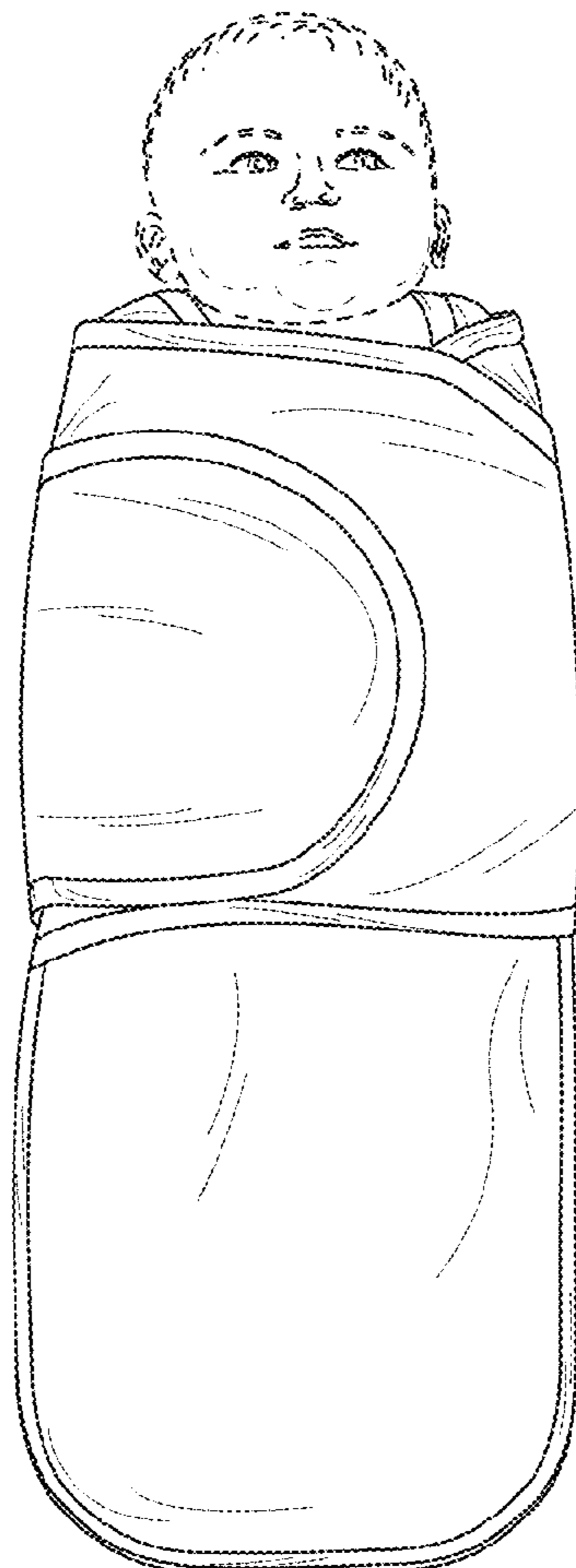

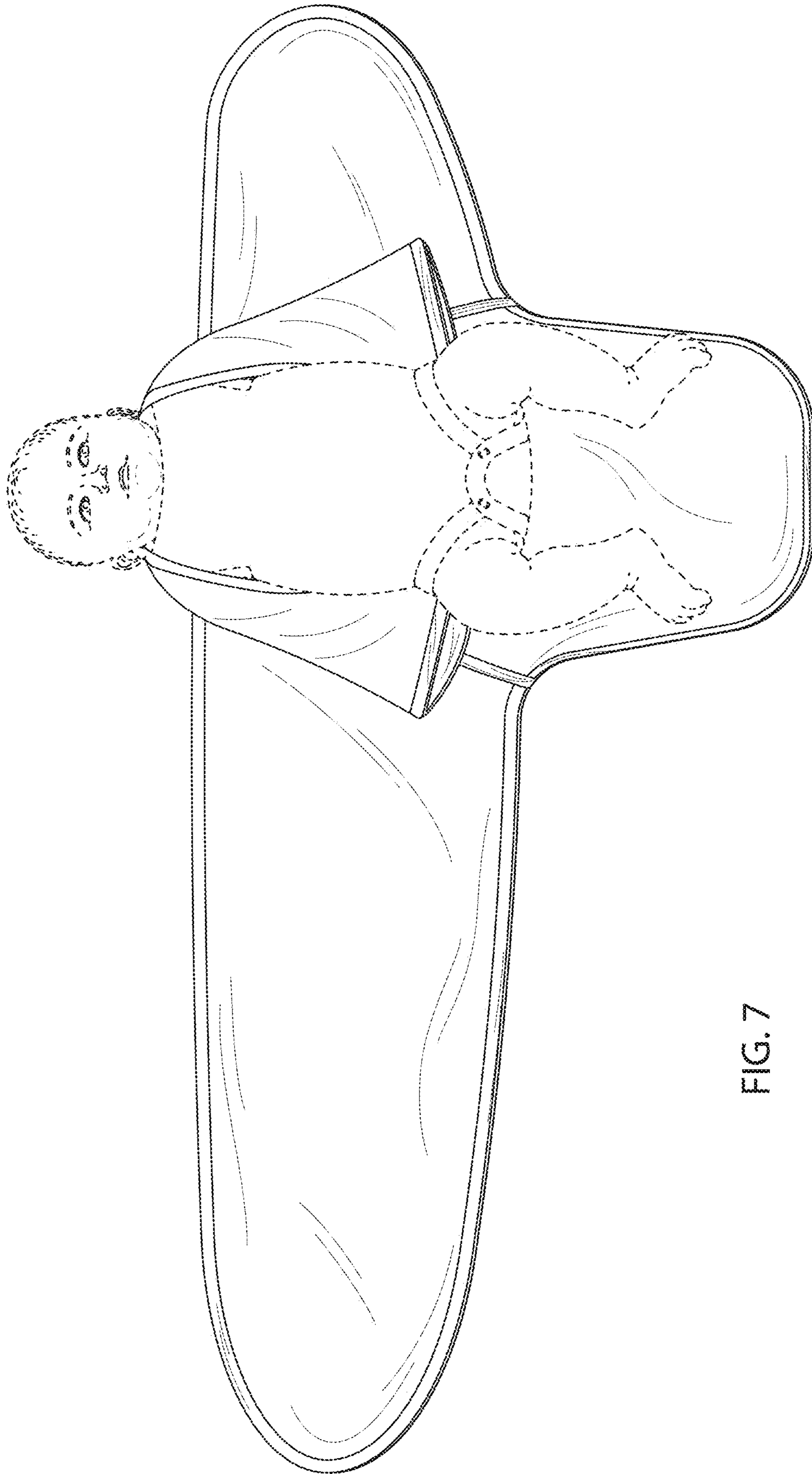

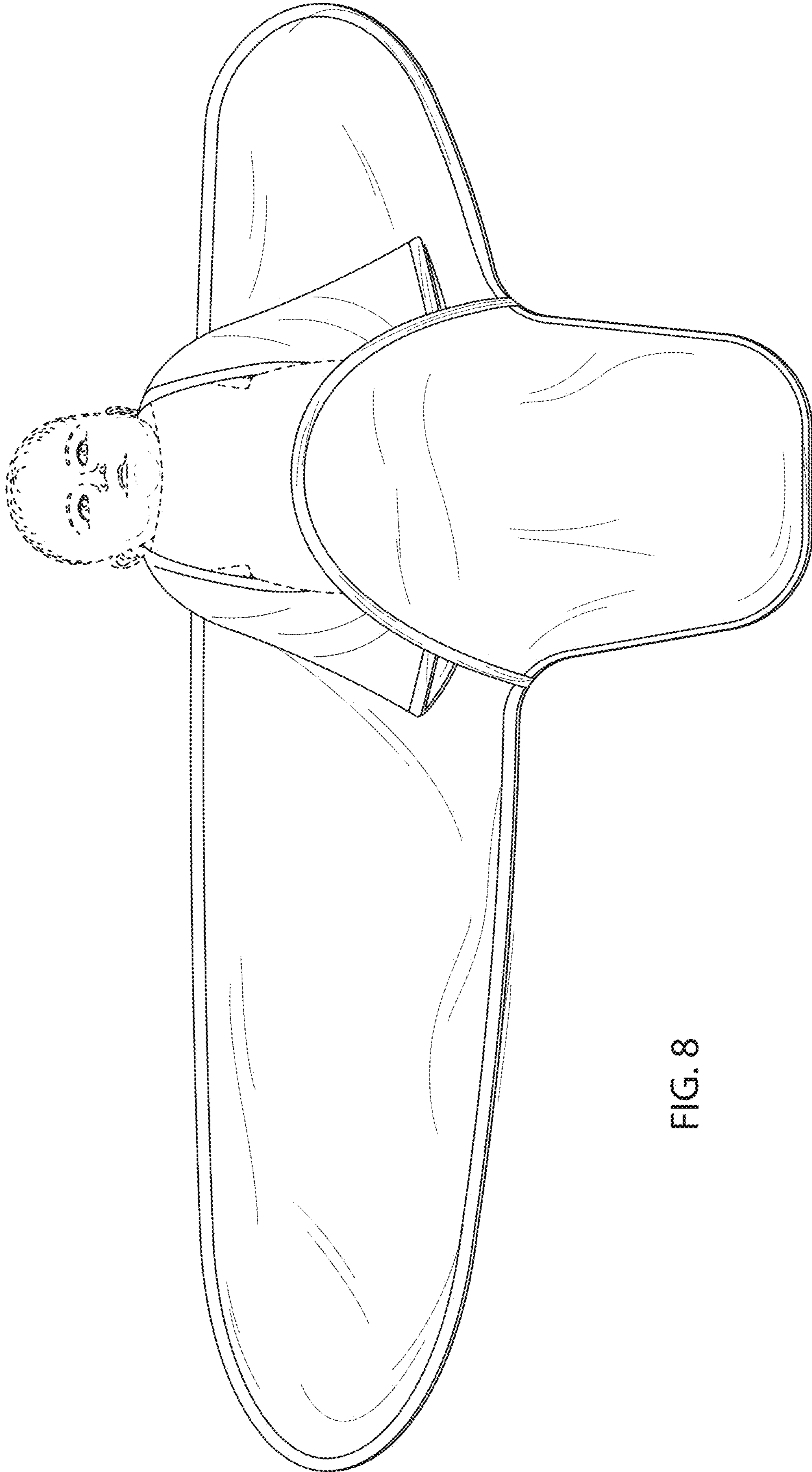

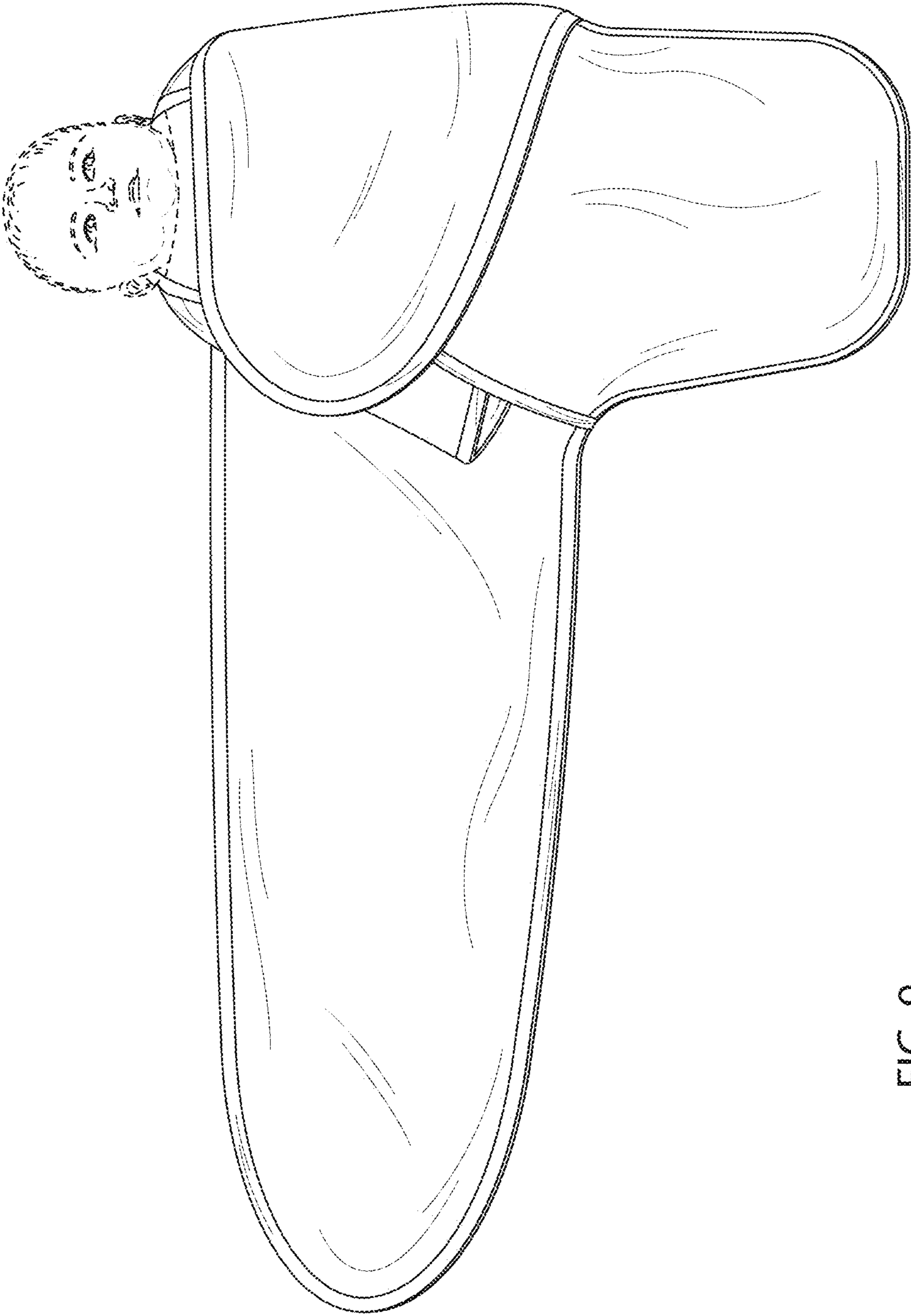
