DESCRIPTION

FIG. 1 is a front, left side, top perspective view of a flip flop showing my new design;

FIG. 8 is a rear elevational view thereof.

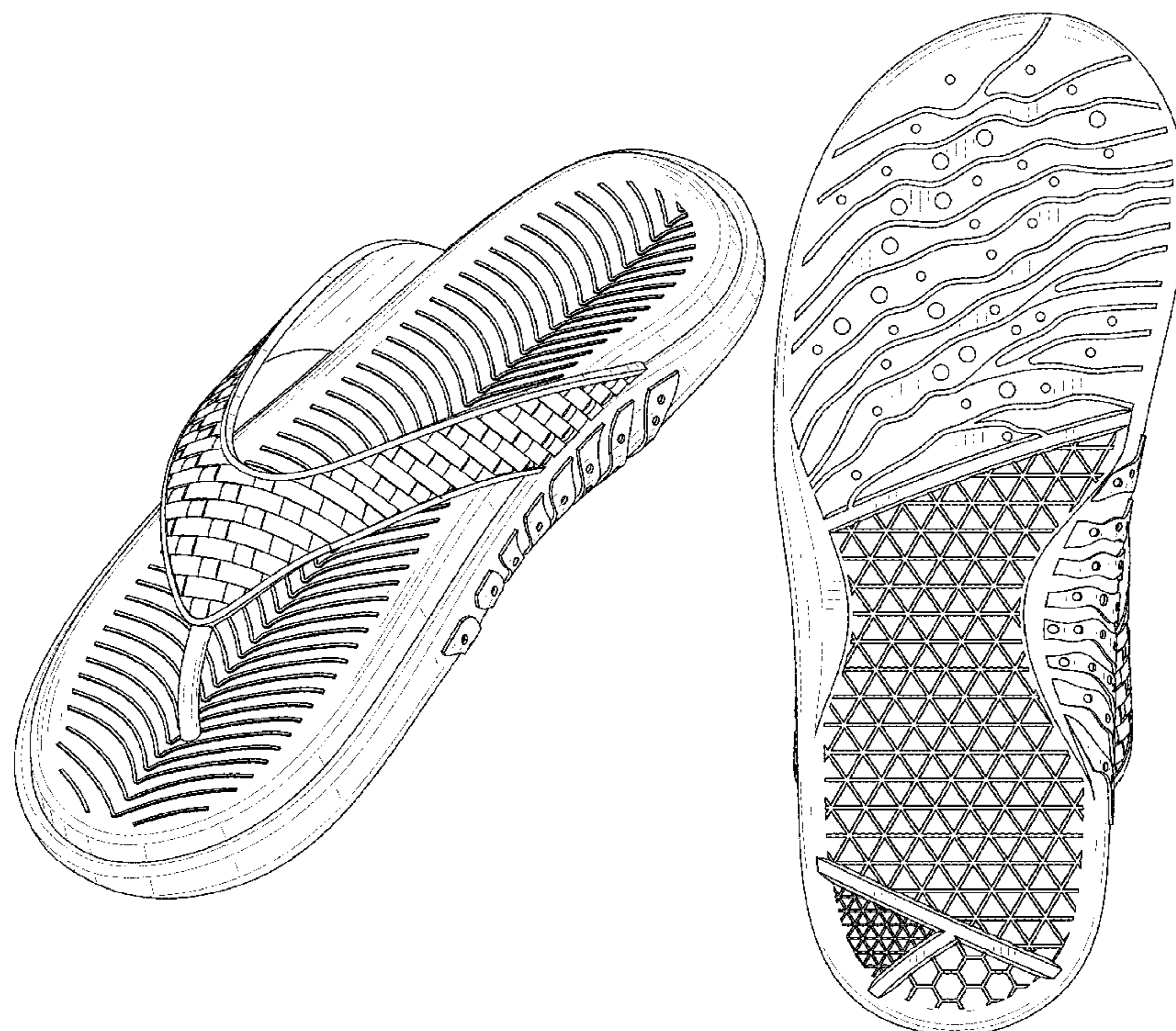
The broken lines depict portions of the flip flop that form no part of the claimed design.

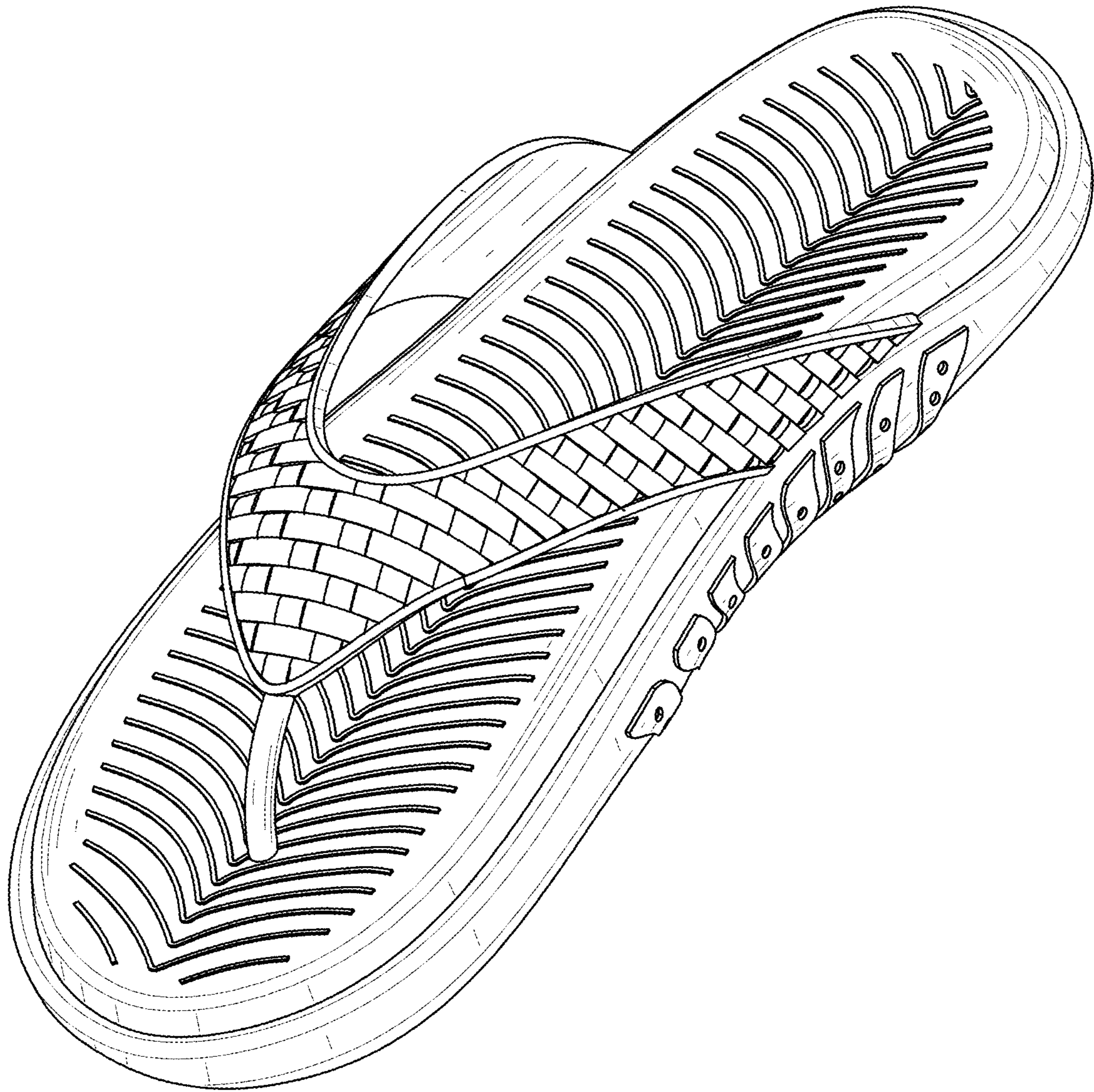

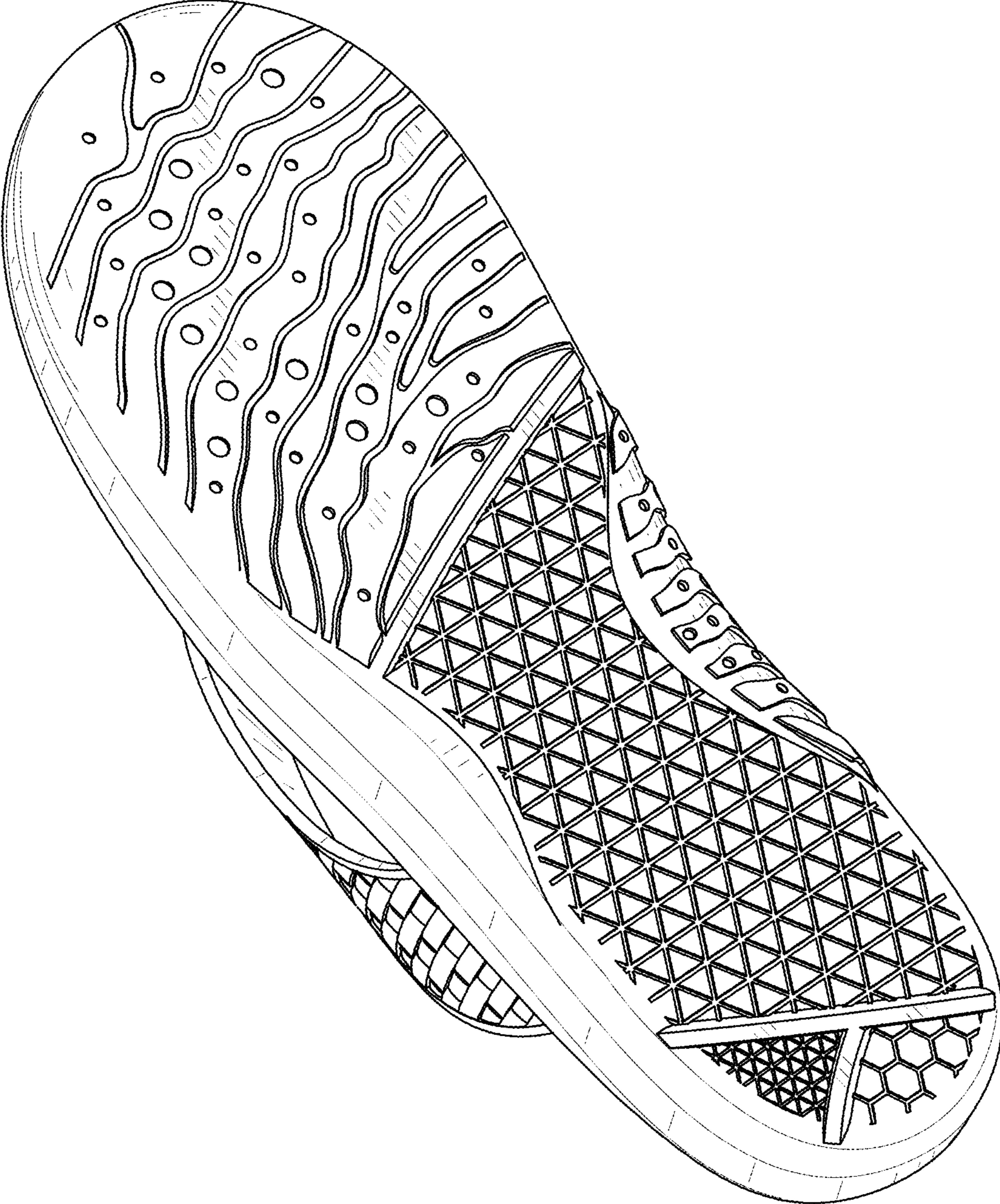

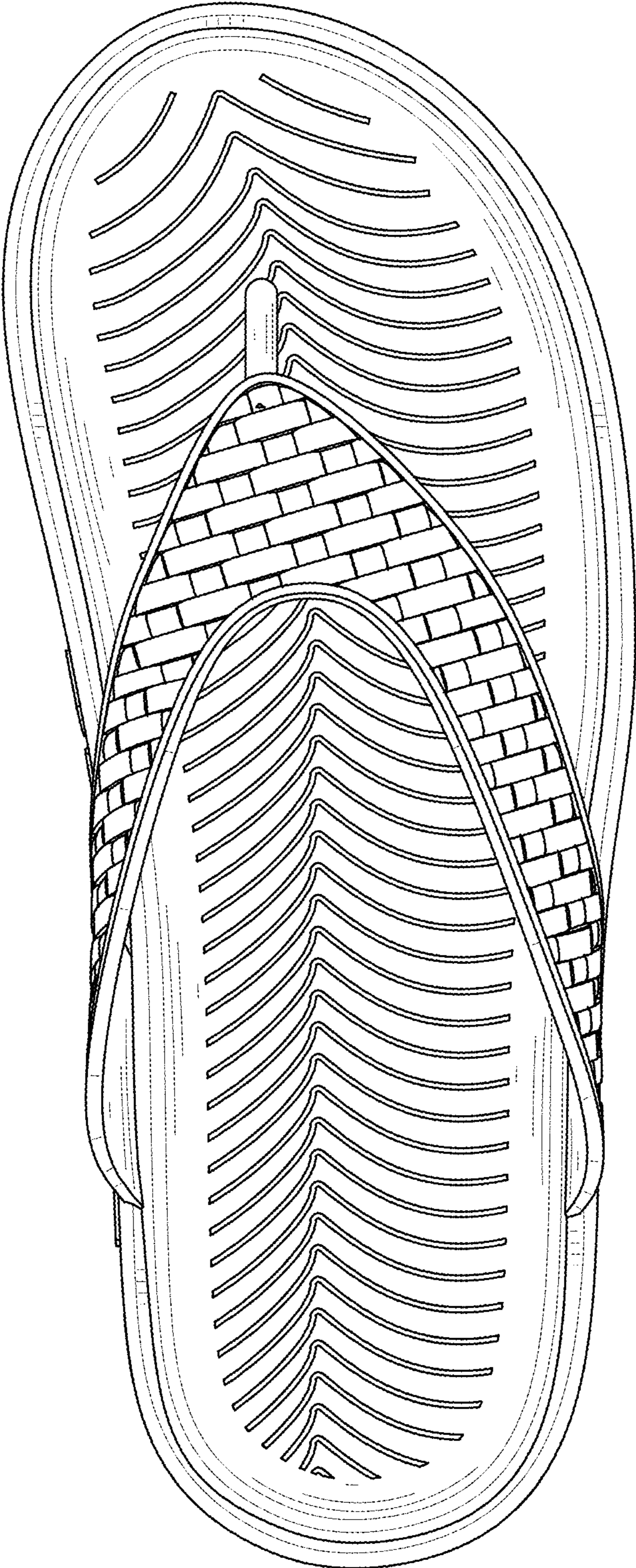

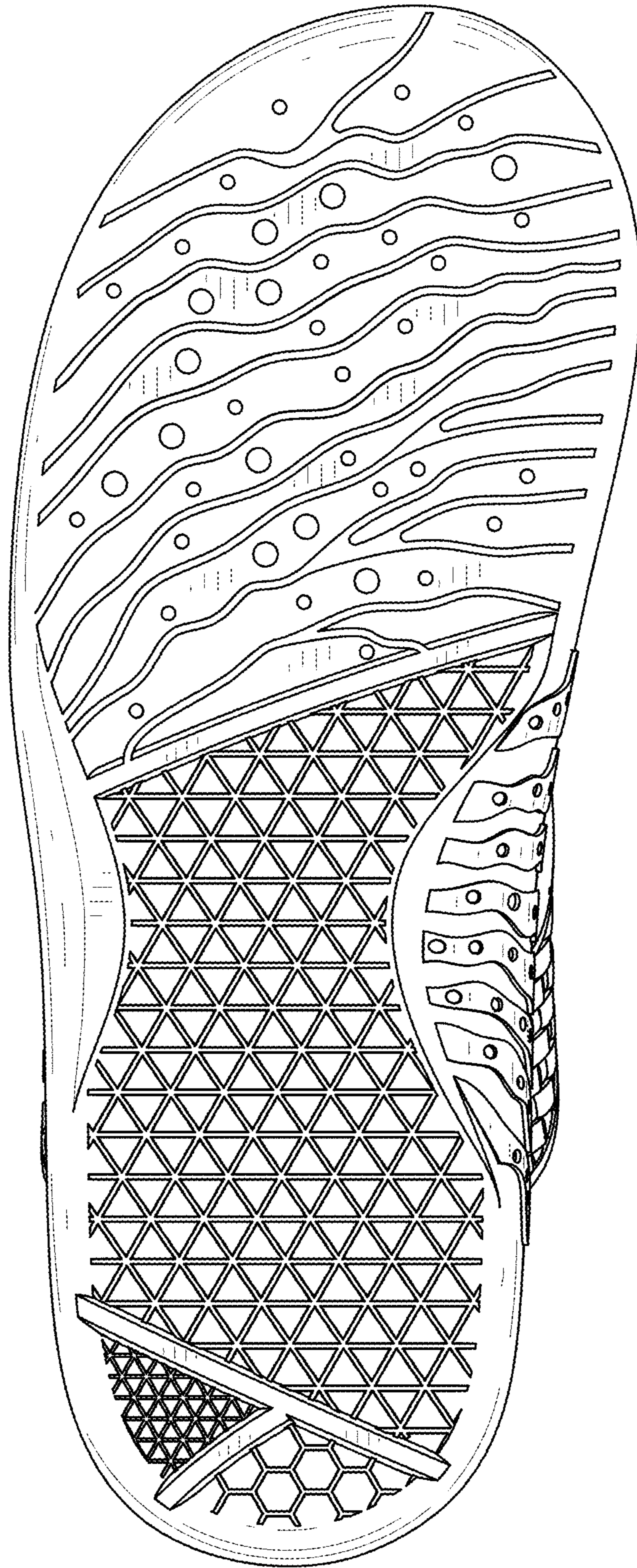

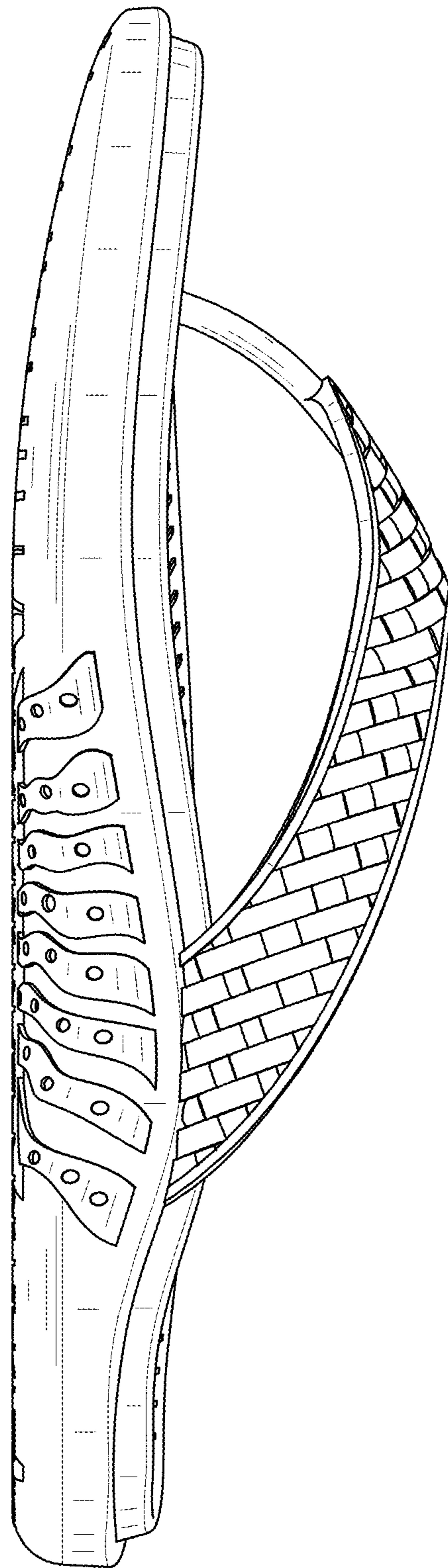

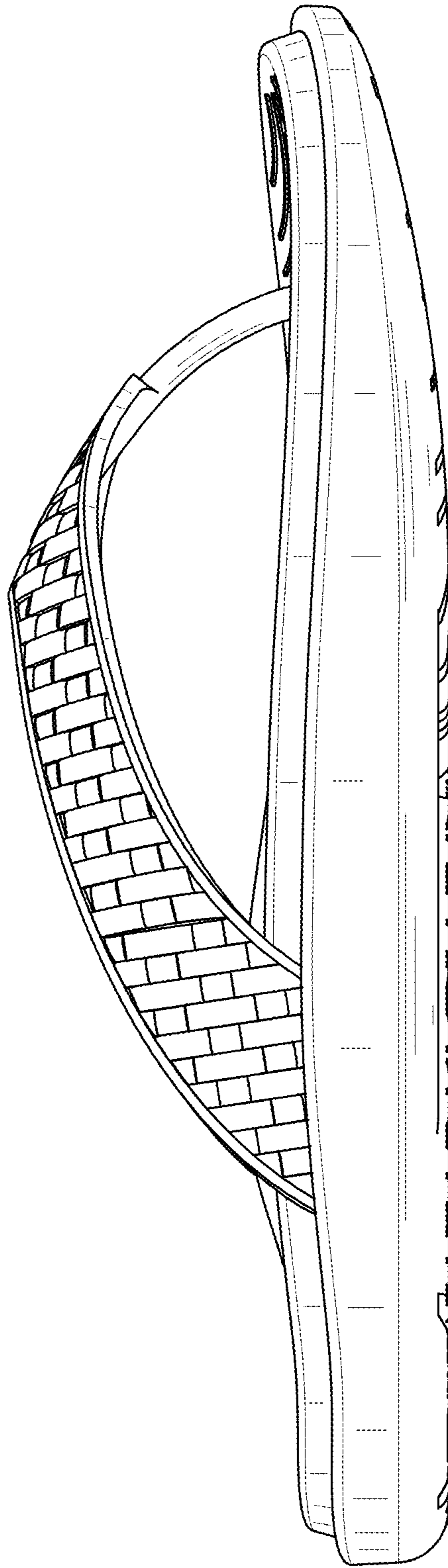

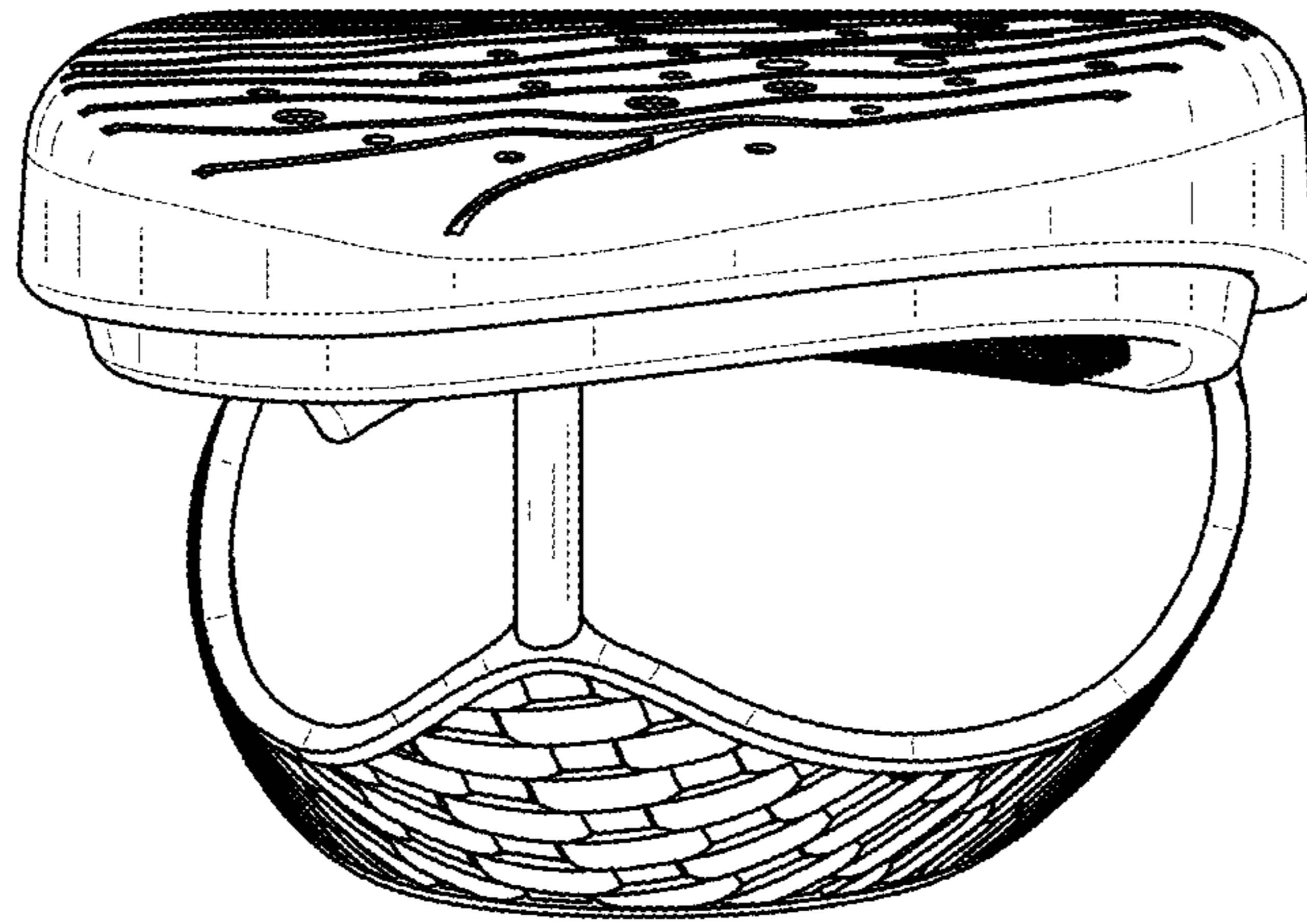

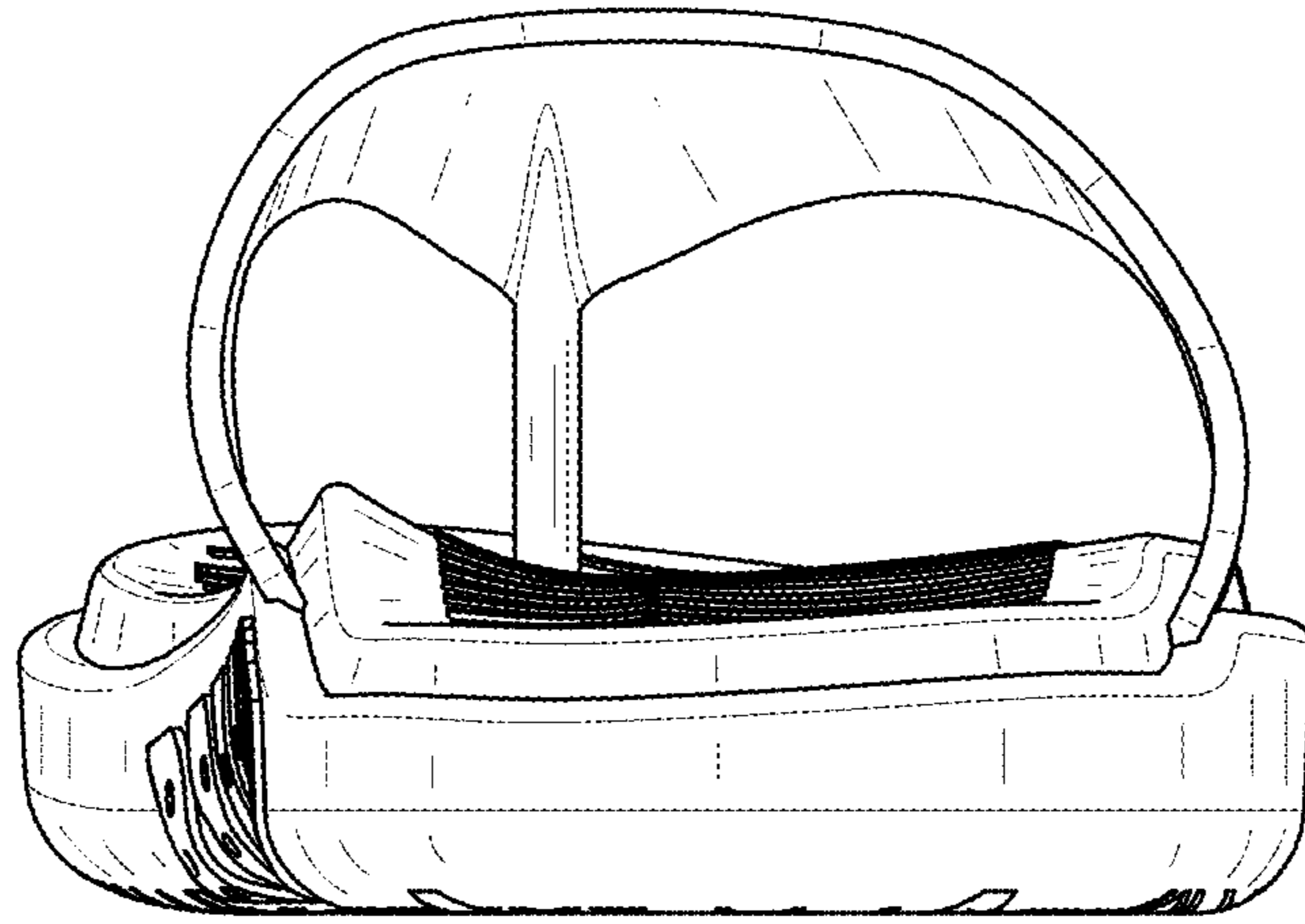
