(57) **CLAIM**

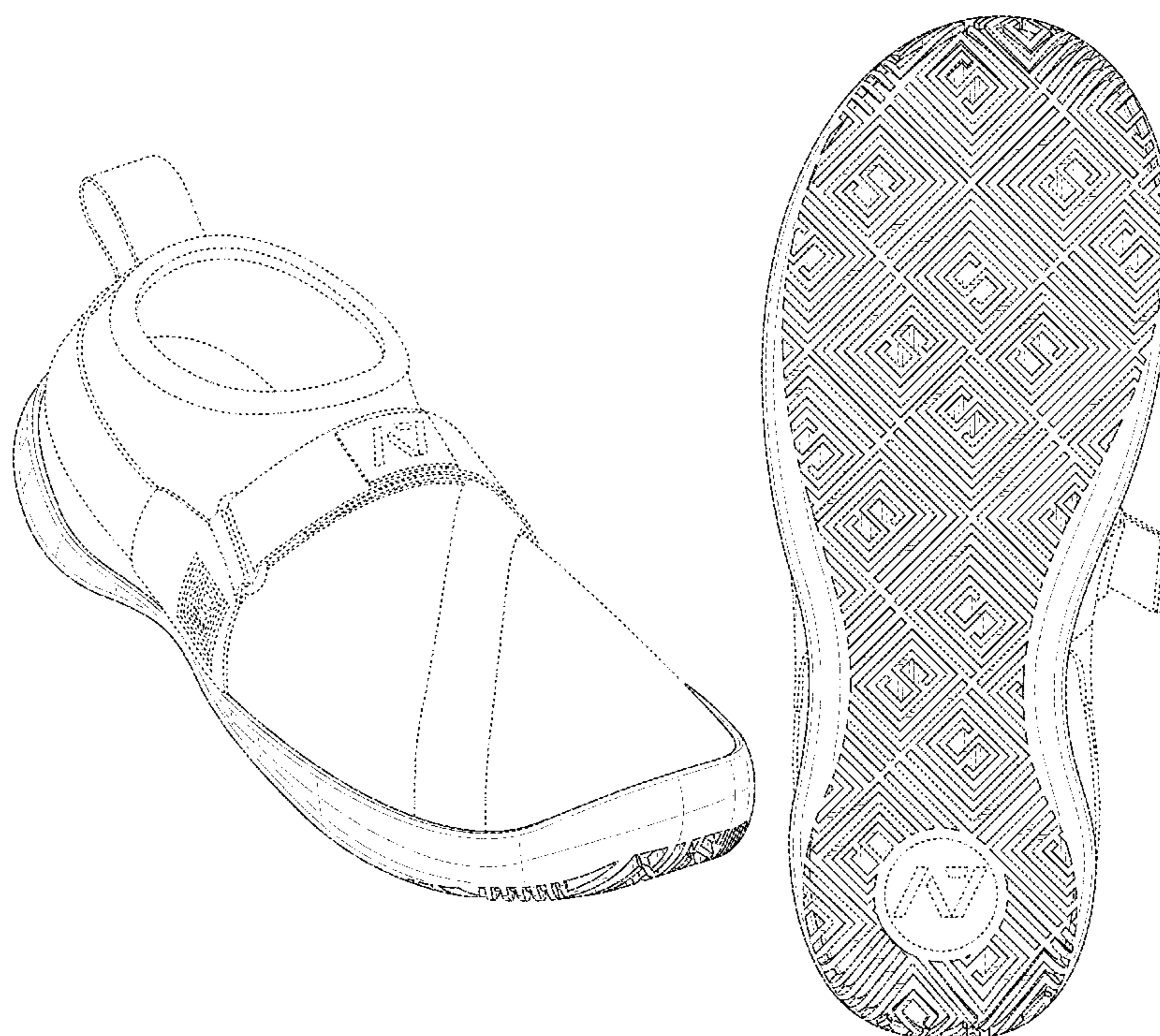
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left-side perspective view of a shoe. A mirror image shoe is evident from the shoe shown; FIG. 2 is bottom, back, right-side perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a back view thereof; FIG. 5 is a left-side view thereof; FIG. 6 is a right-side view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.

The dashed broken lines depict portions of the shoe that form no part of the claimed design.

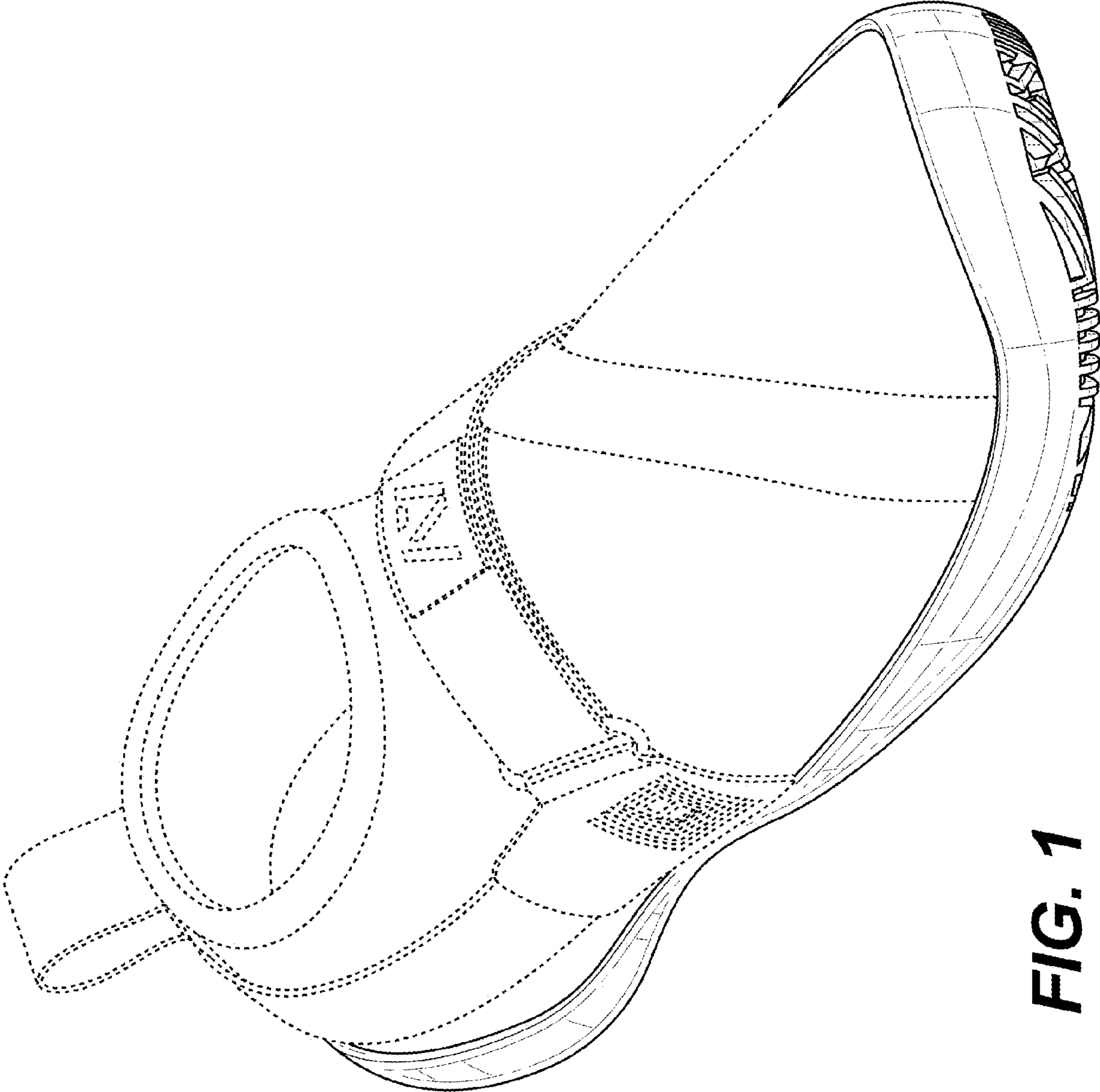

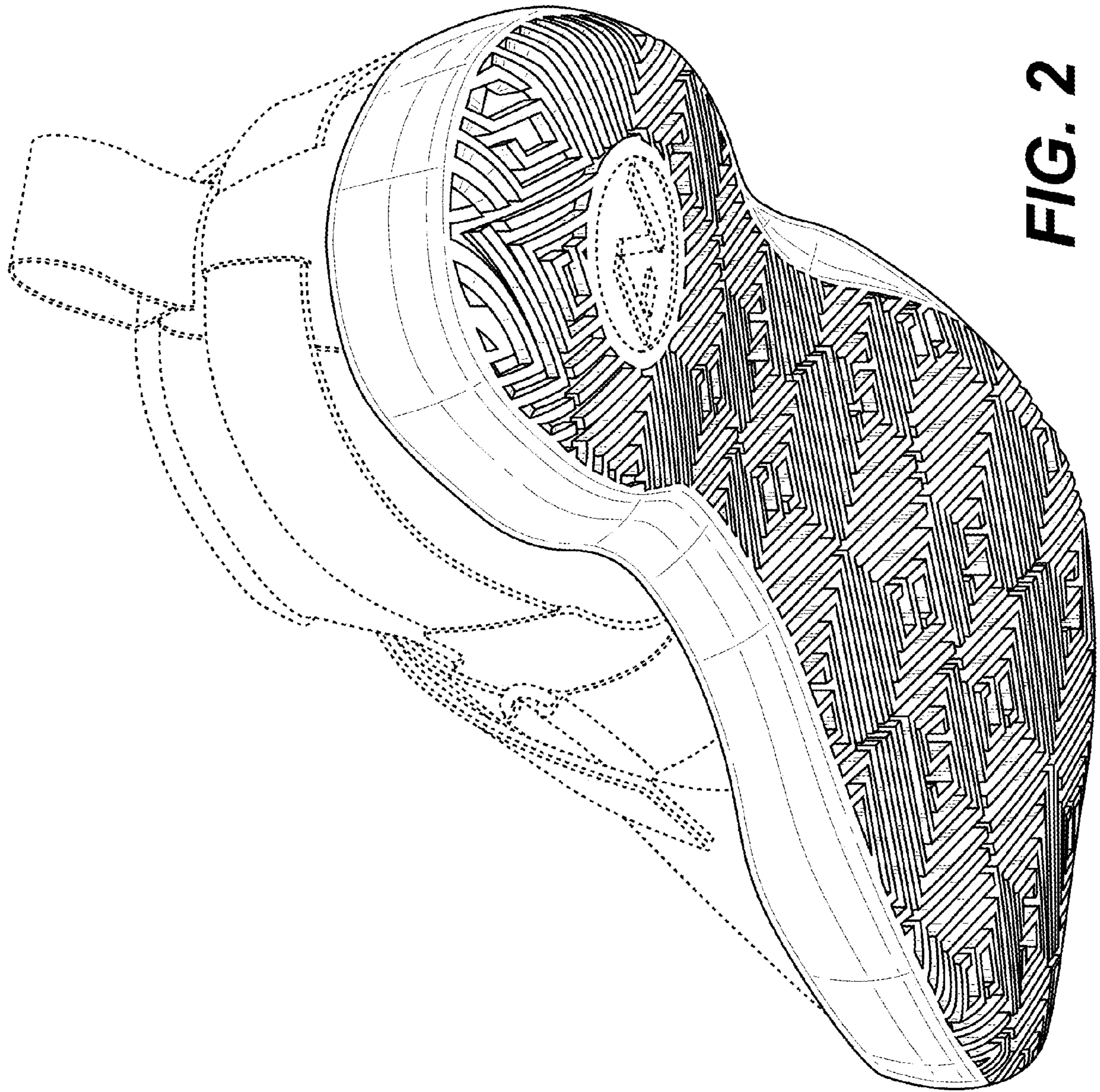

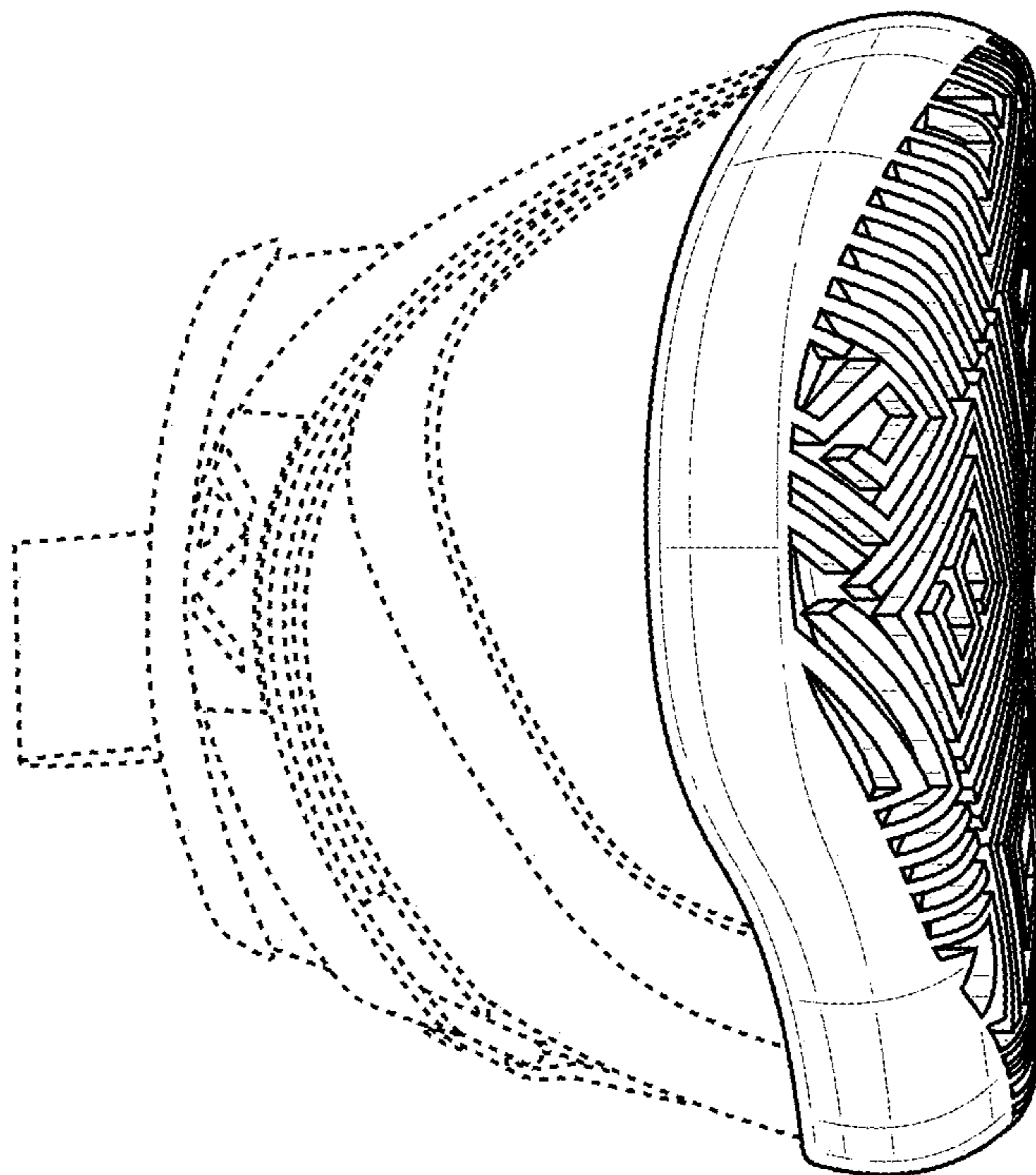

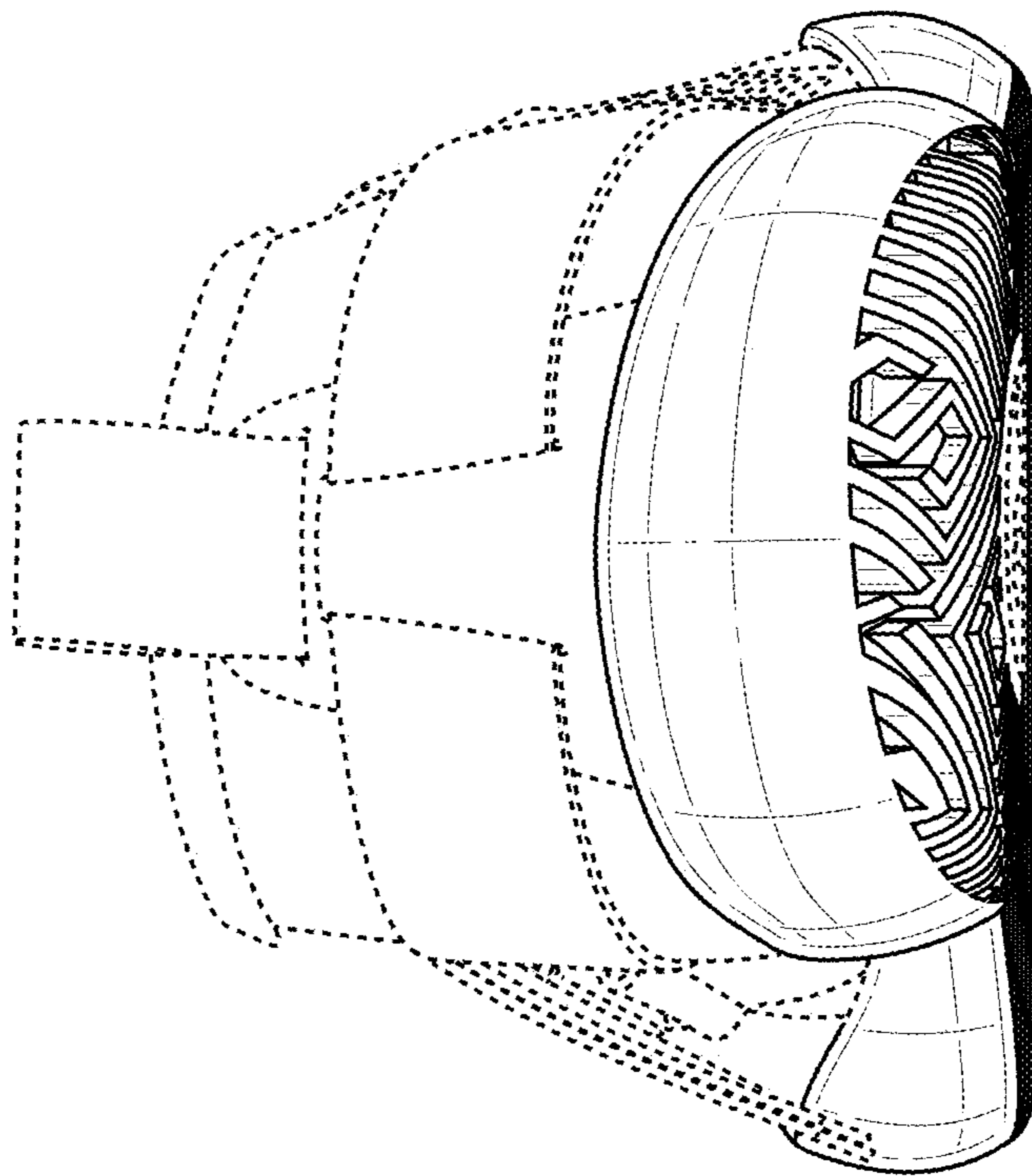

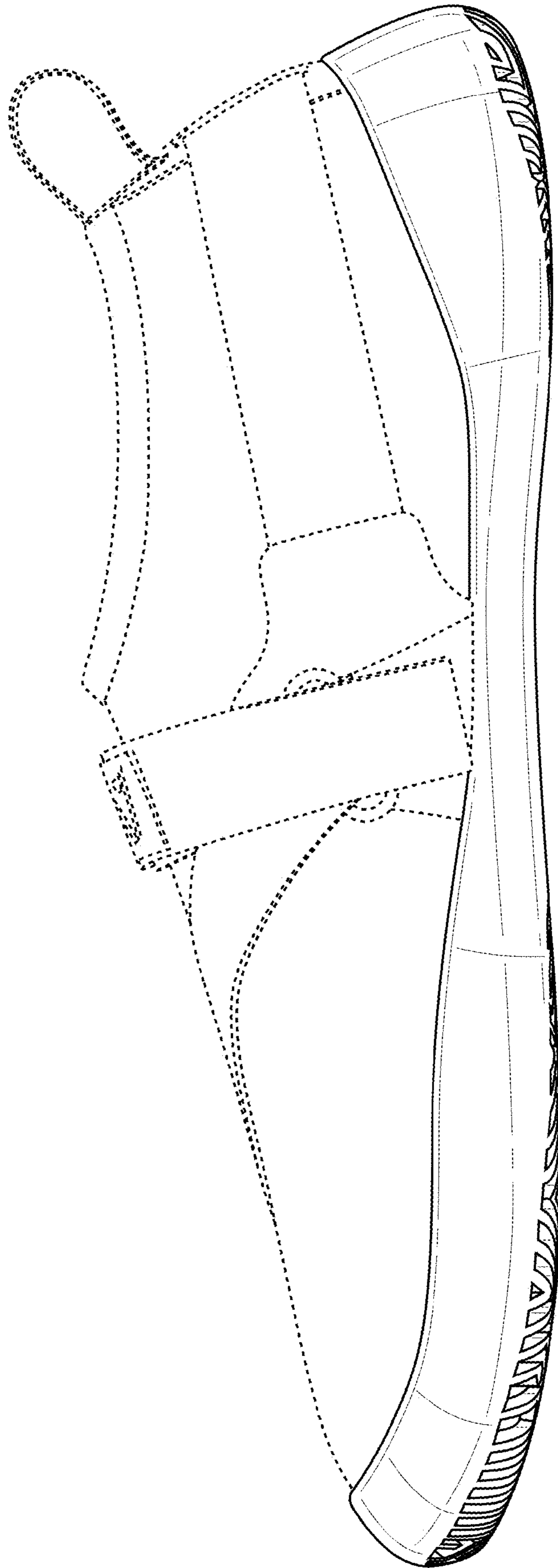

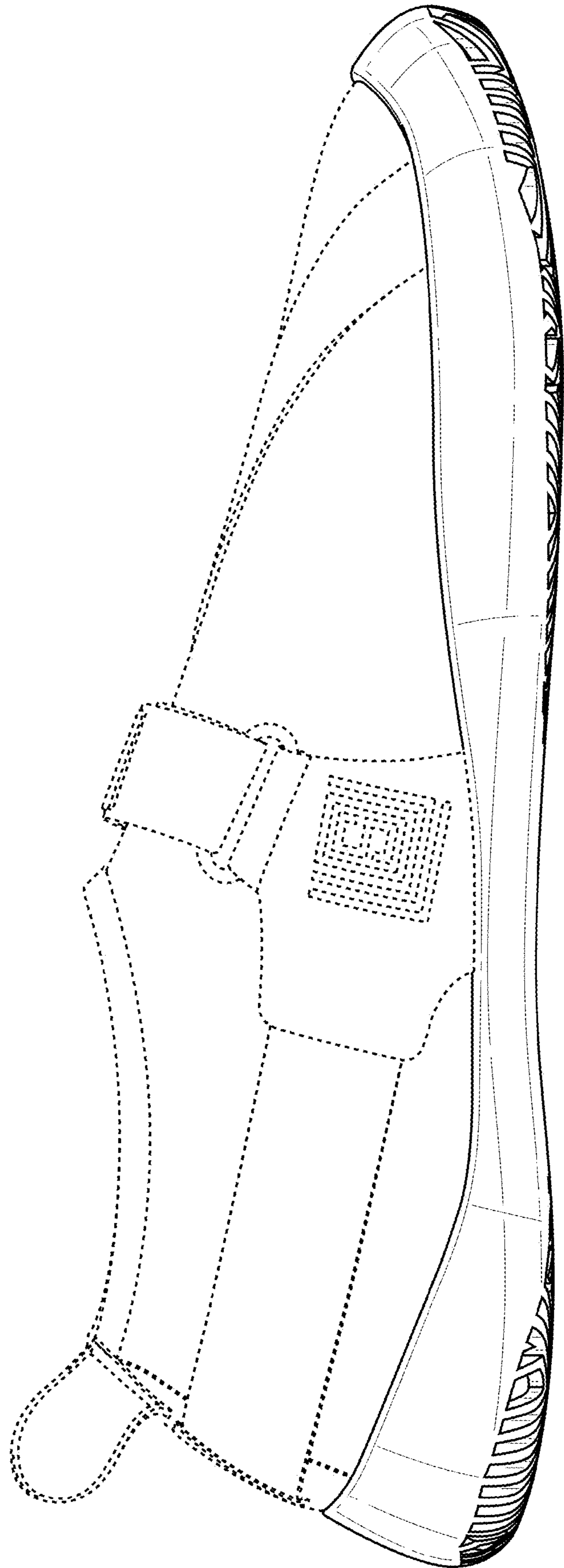

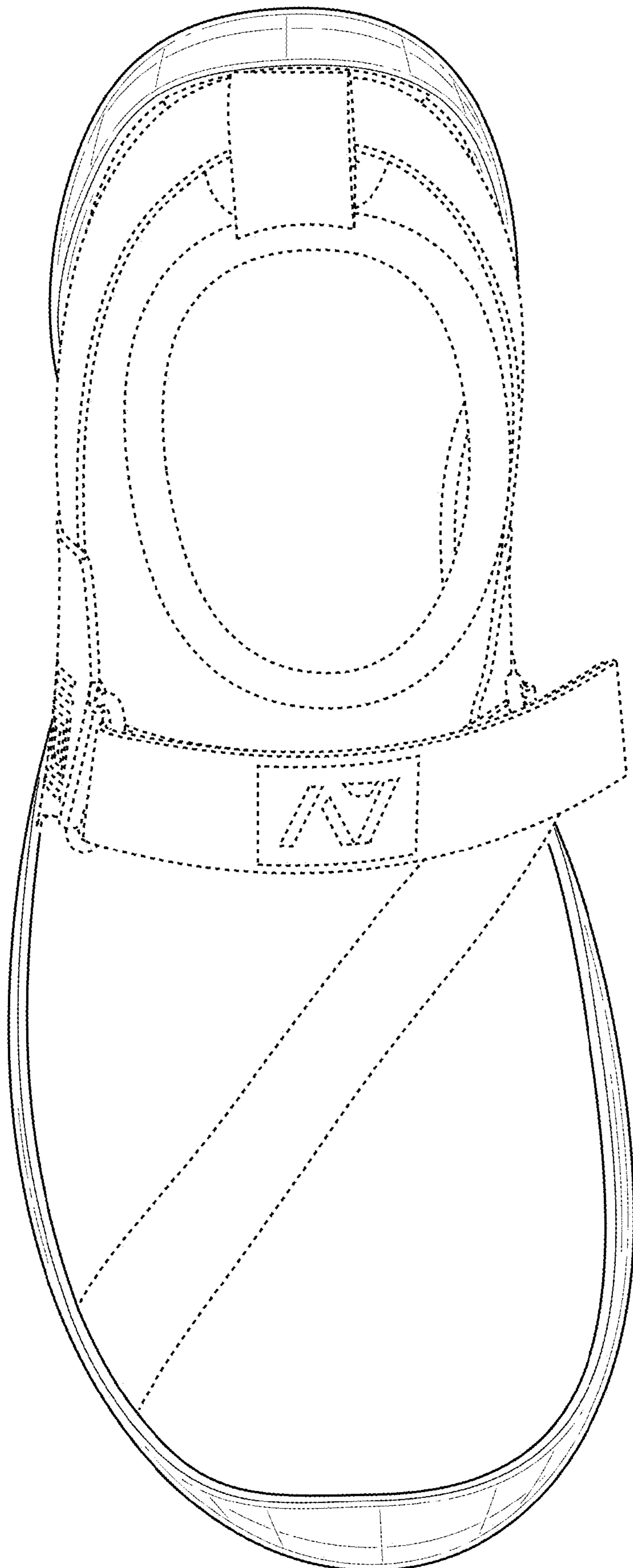

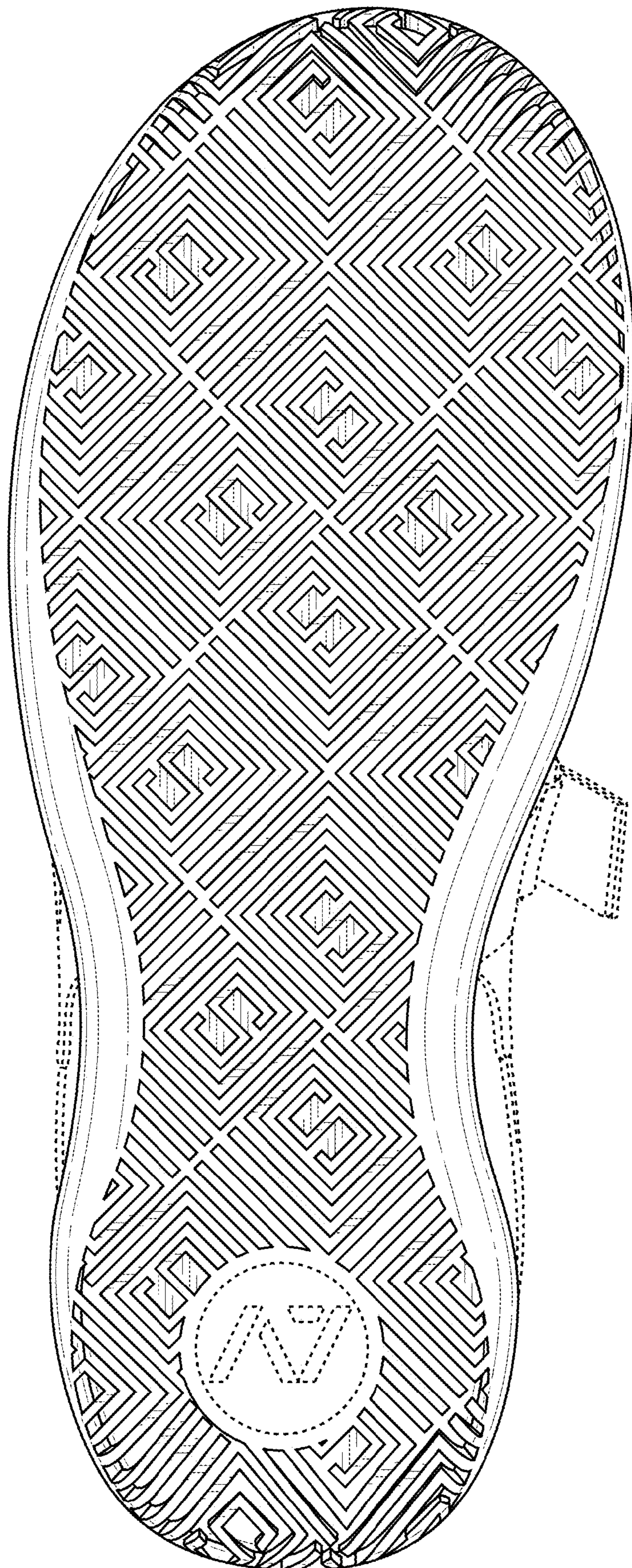
