(57) **CLAIM**

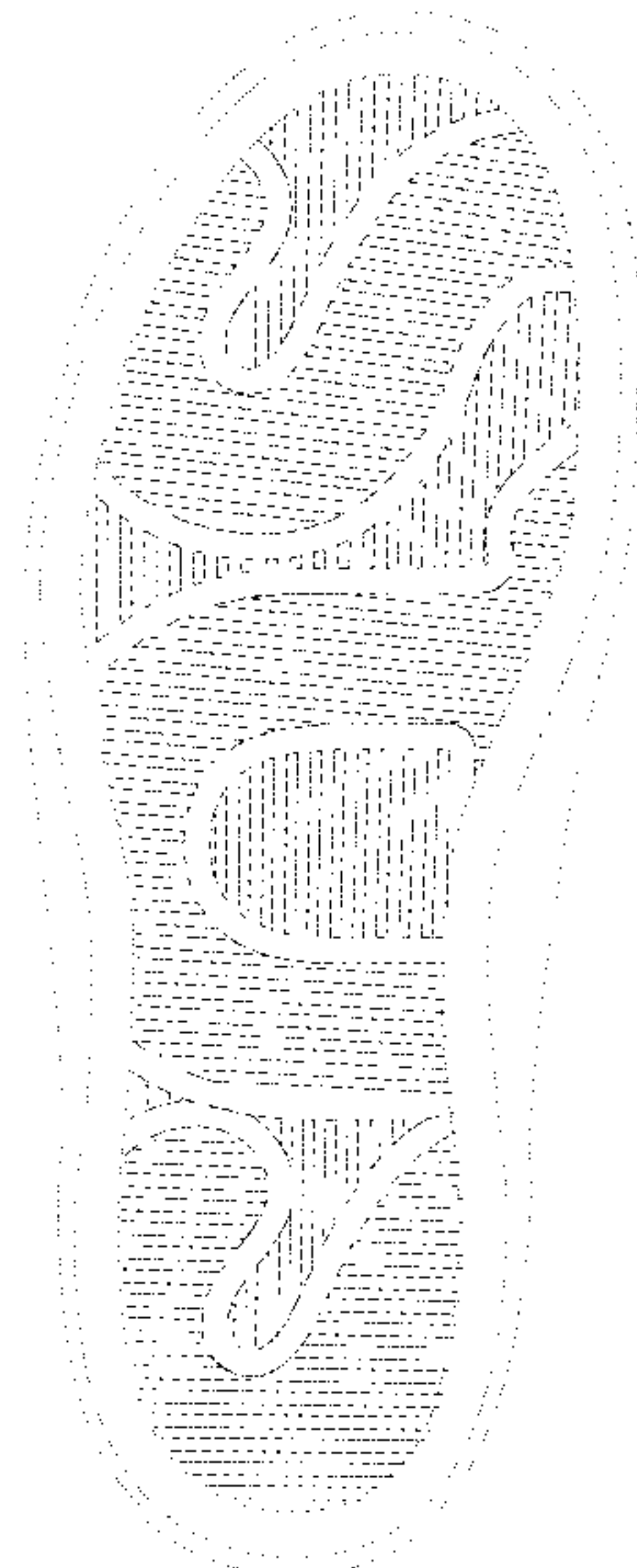
The ornamental design for a shoe bottom, as shown and described.

**DESCRIPTION**

This application is related to U.S. application Ser. No. 29/740,594, filed Jul. 6, 2020, the entire disclosure of which is hereby incorporated herein by reference.  
The sole FIGURE is a plan view of a shoe bottom showing my new design.  
The broken lines in the FIGURE illustrate unclaimed portions of the shoe bottom and form no part of the claimed design.  
The relative depths and three dimensionality between the surfaces of the shoe bottom form no part of the claimed design.
