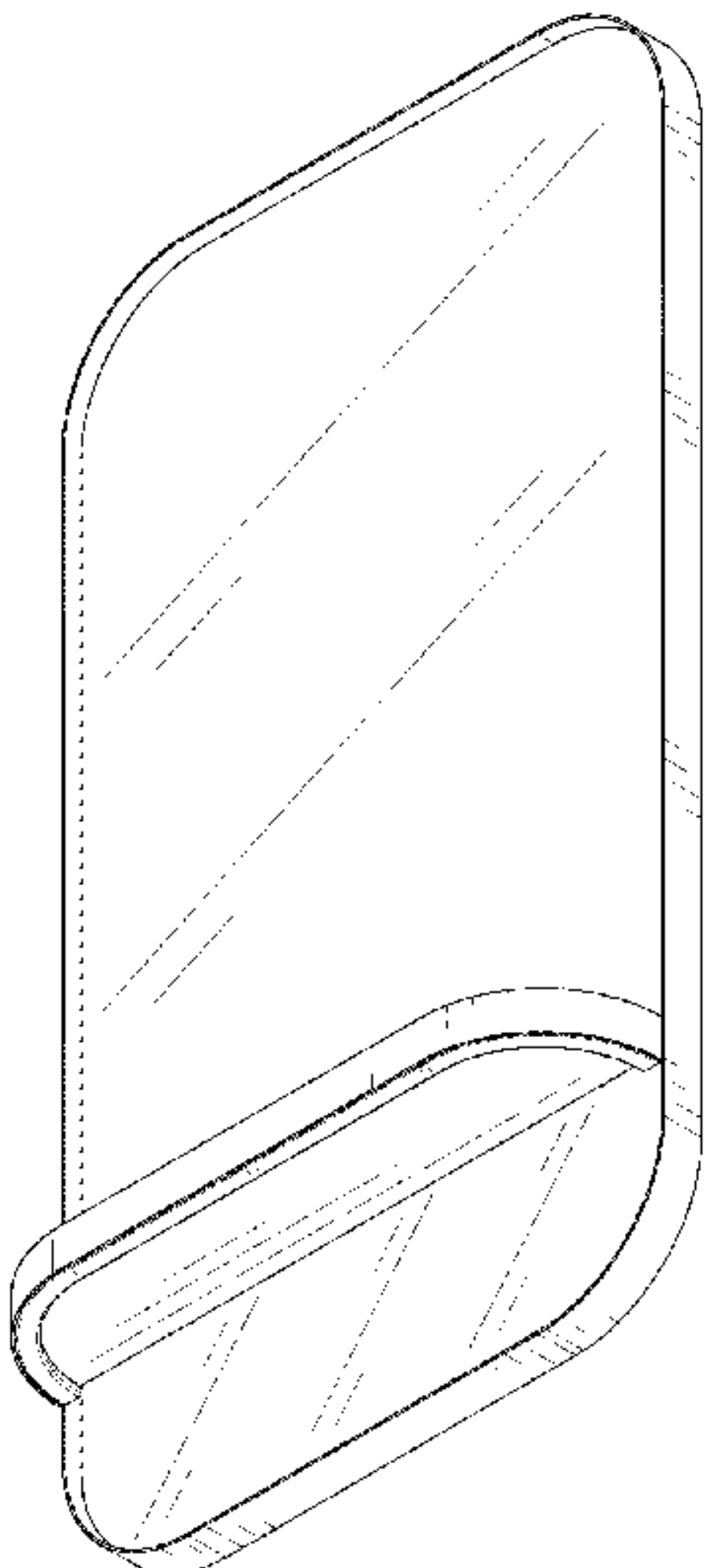
CLAIM

DESCRIPTION

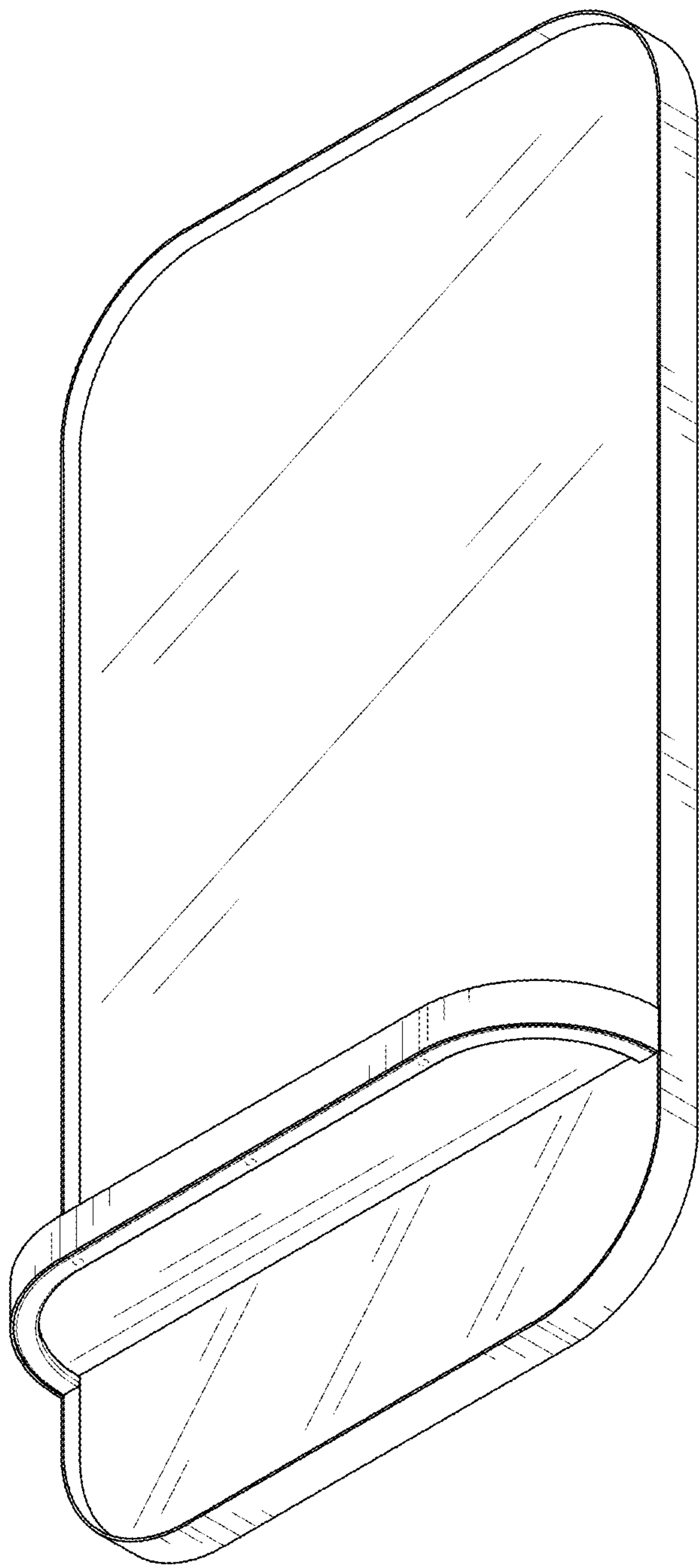

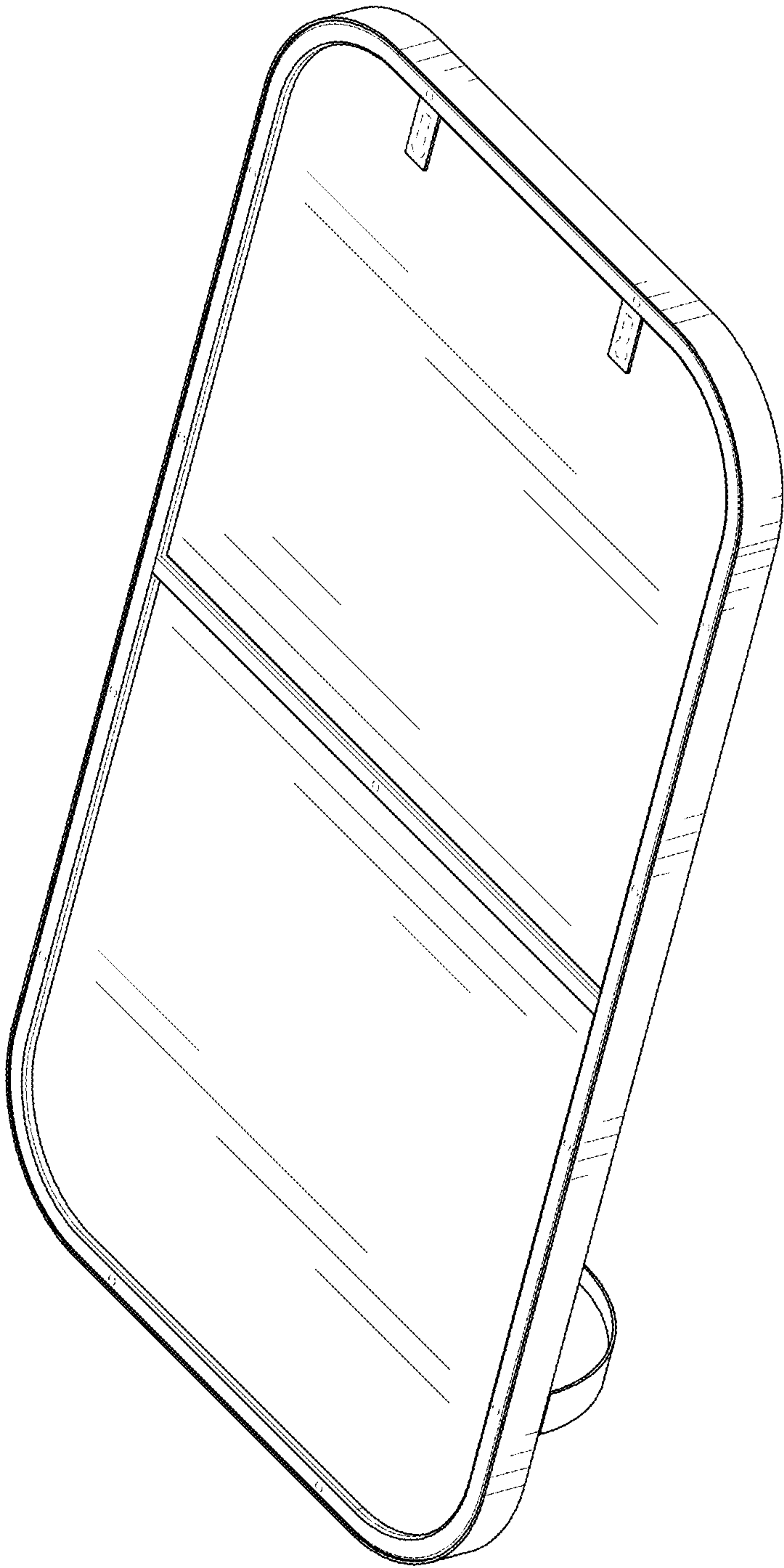

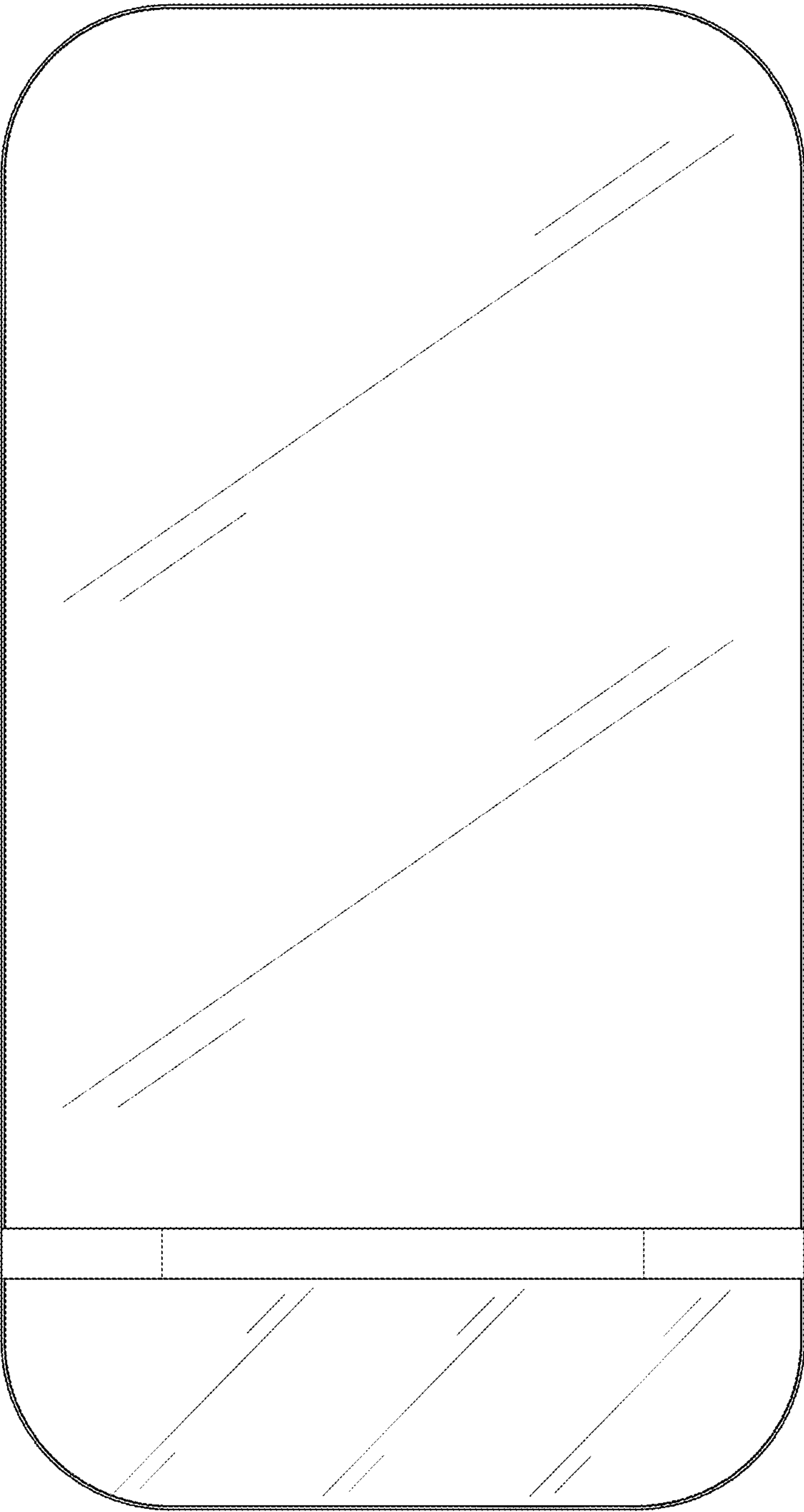

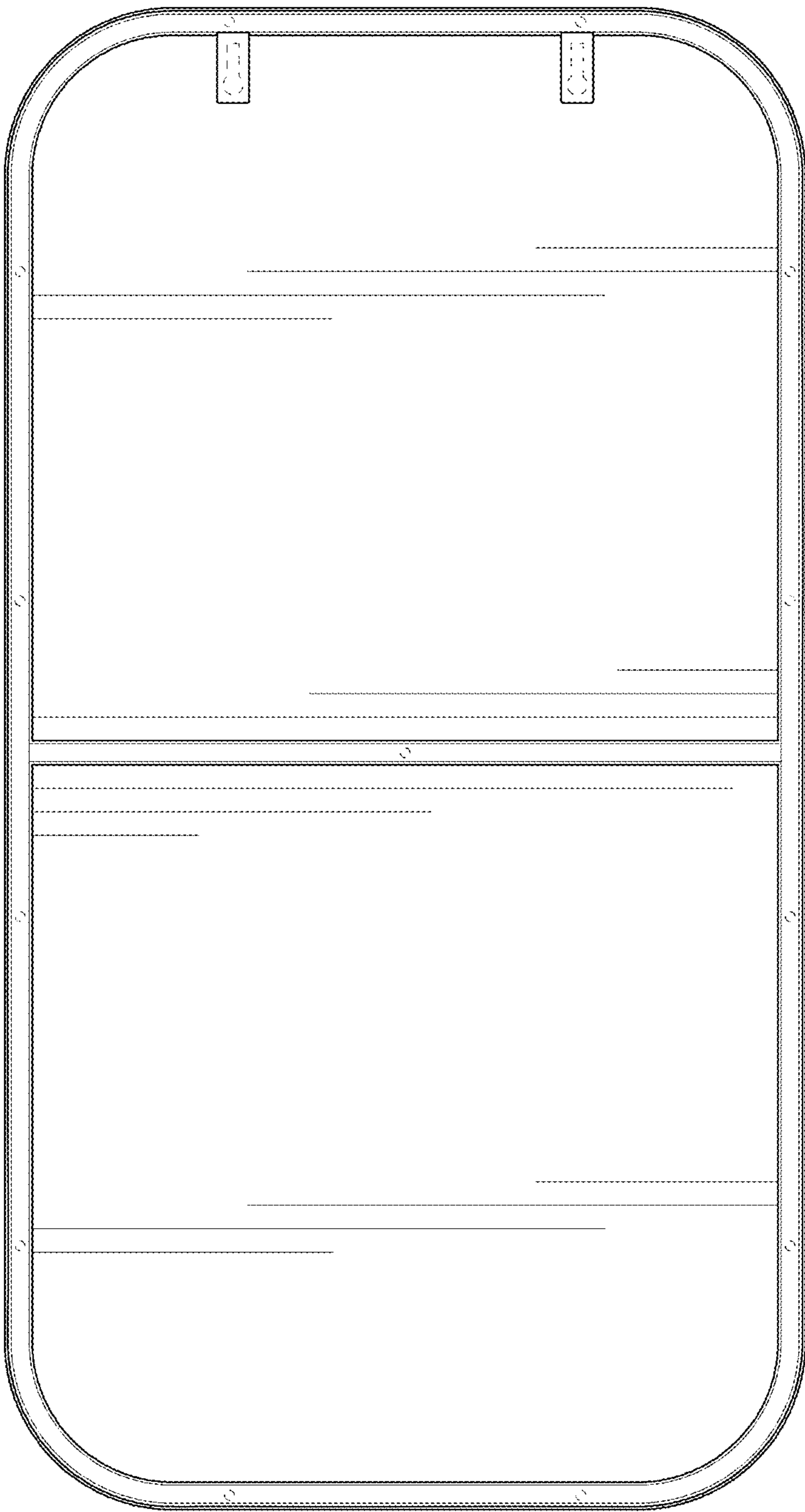

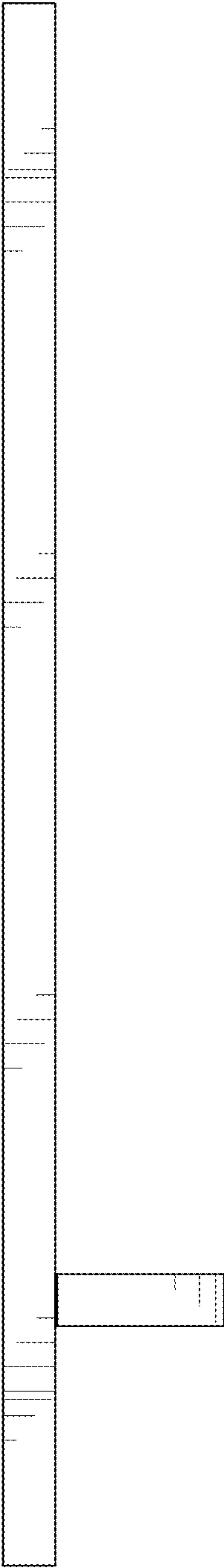

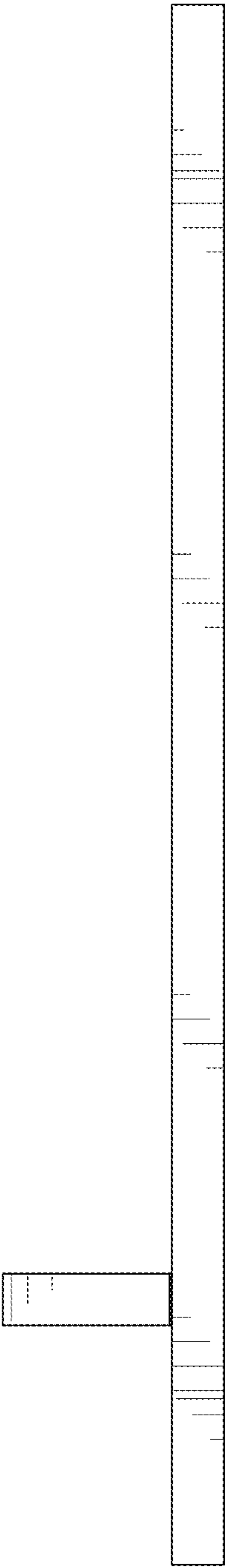

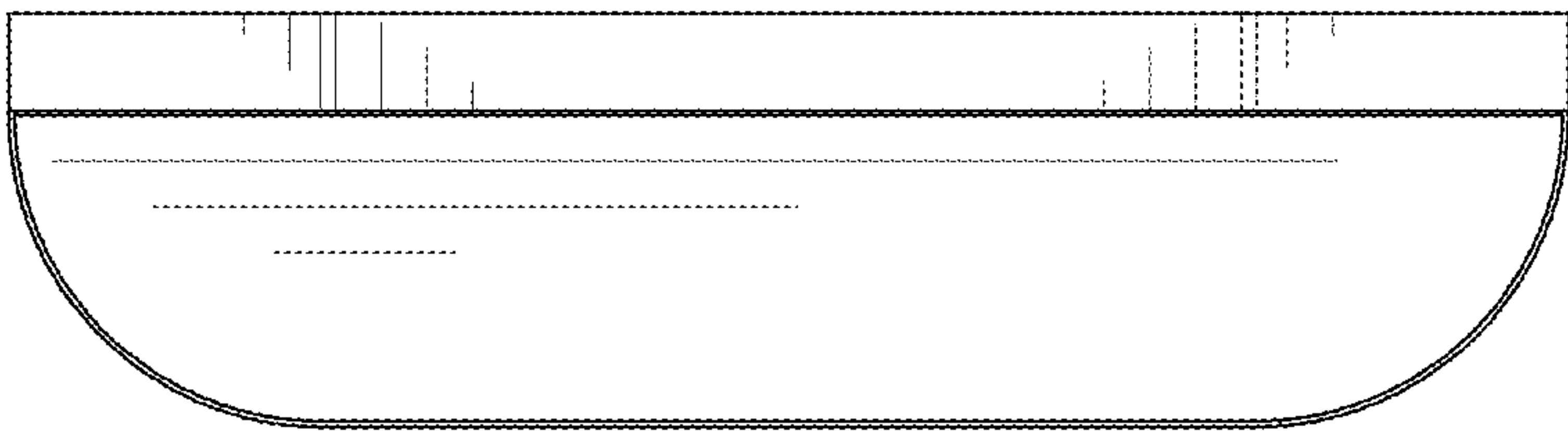

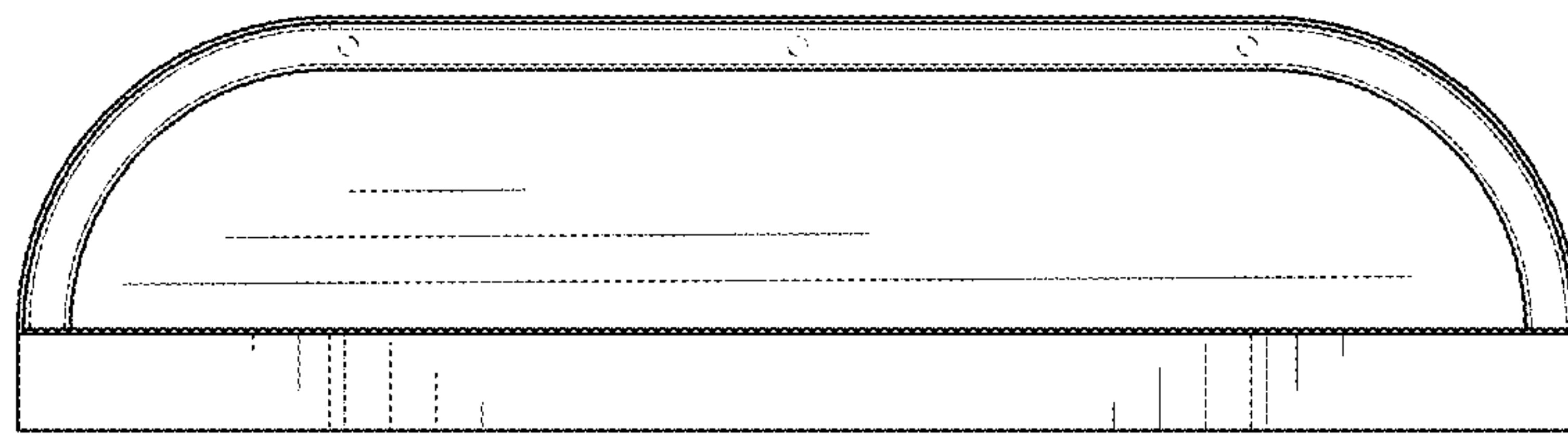
