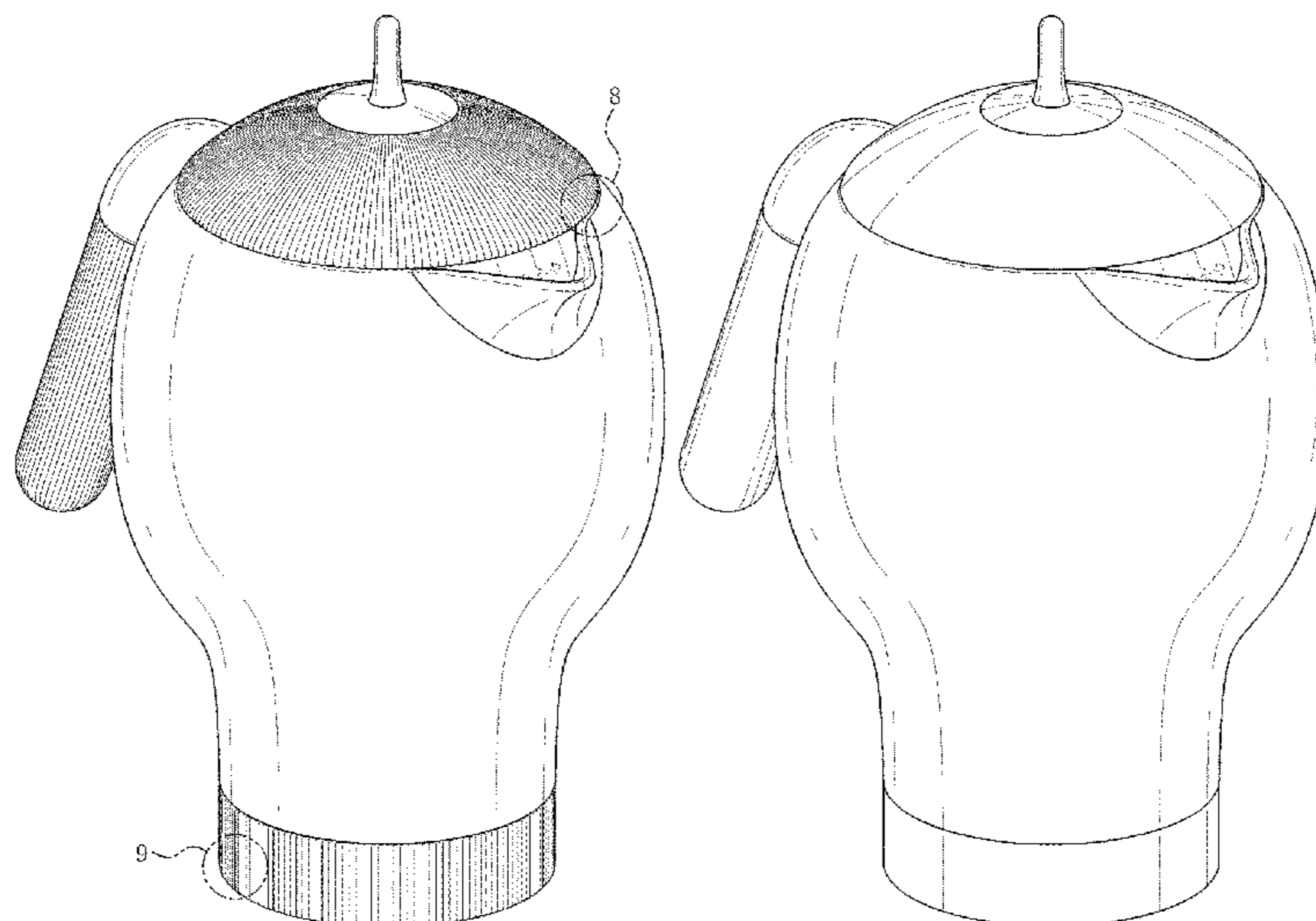
The ornamental design for an electric kettle, as shown and described.

**DESCRIPTION**

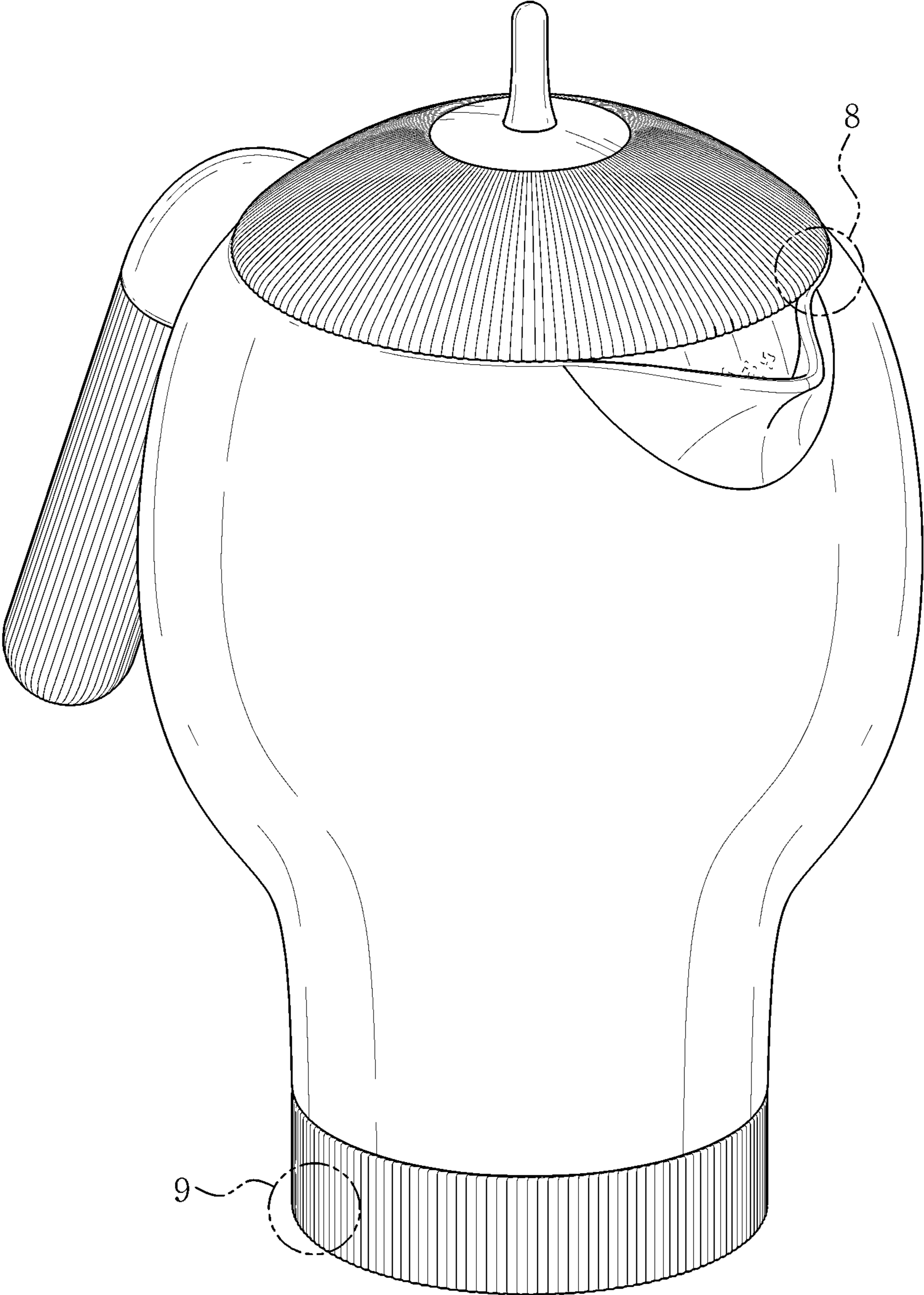

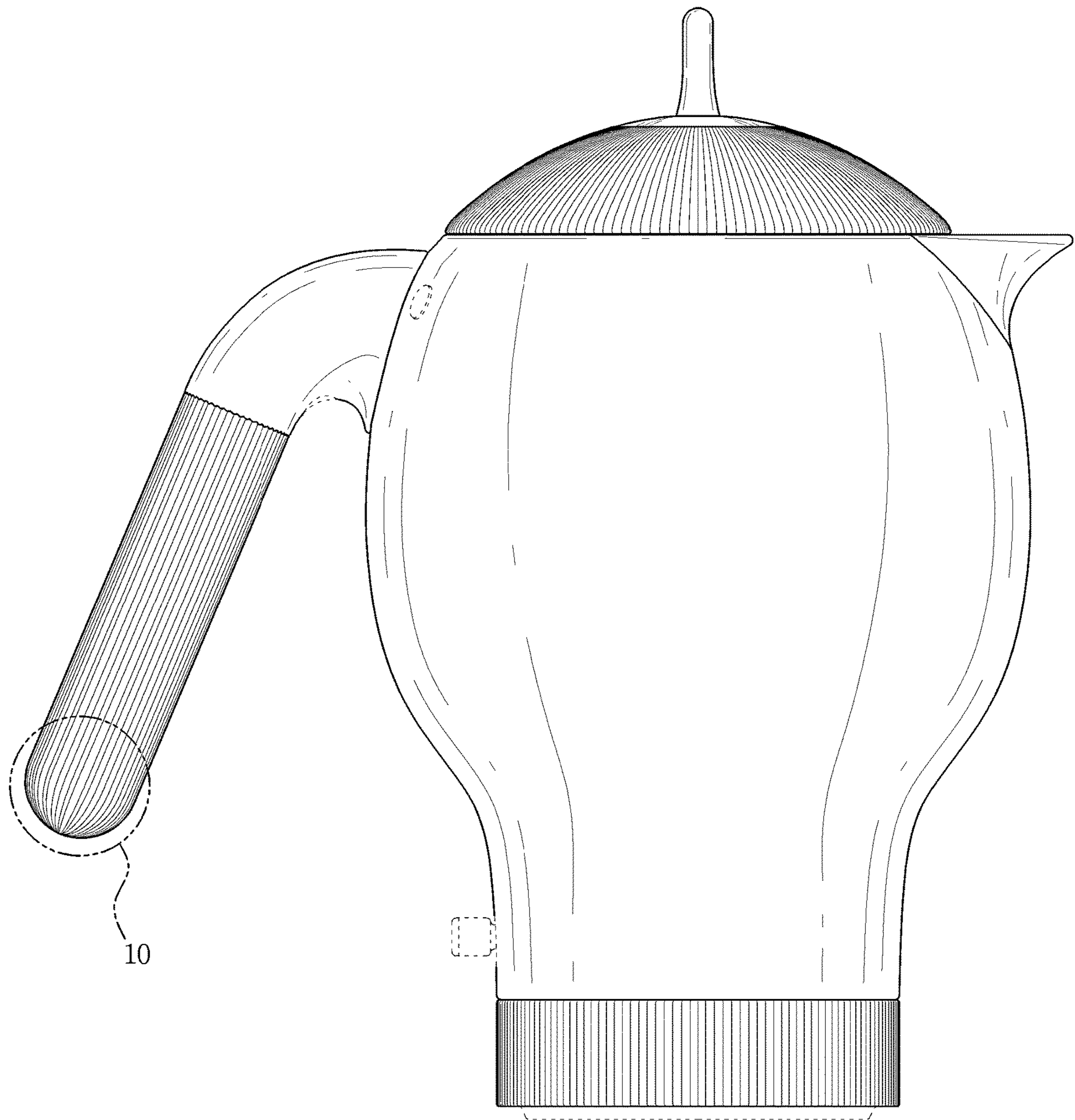

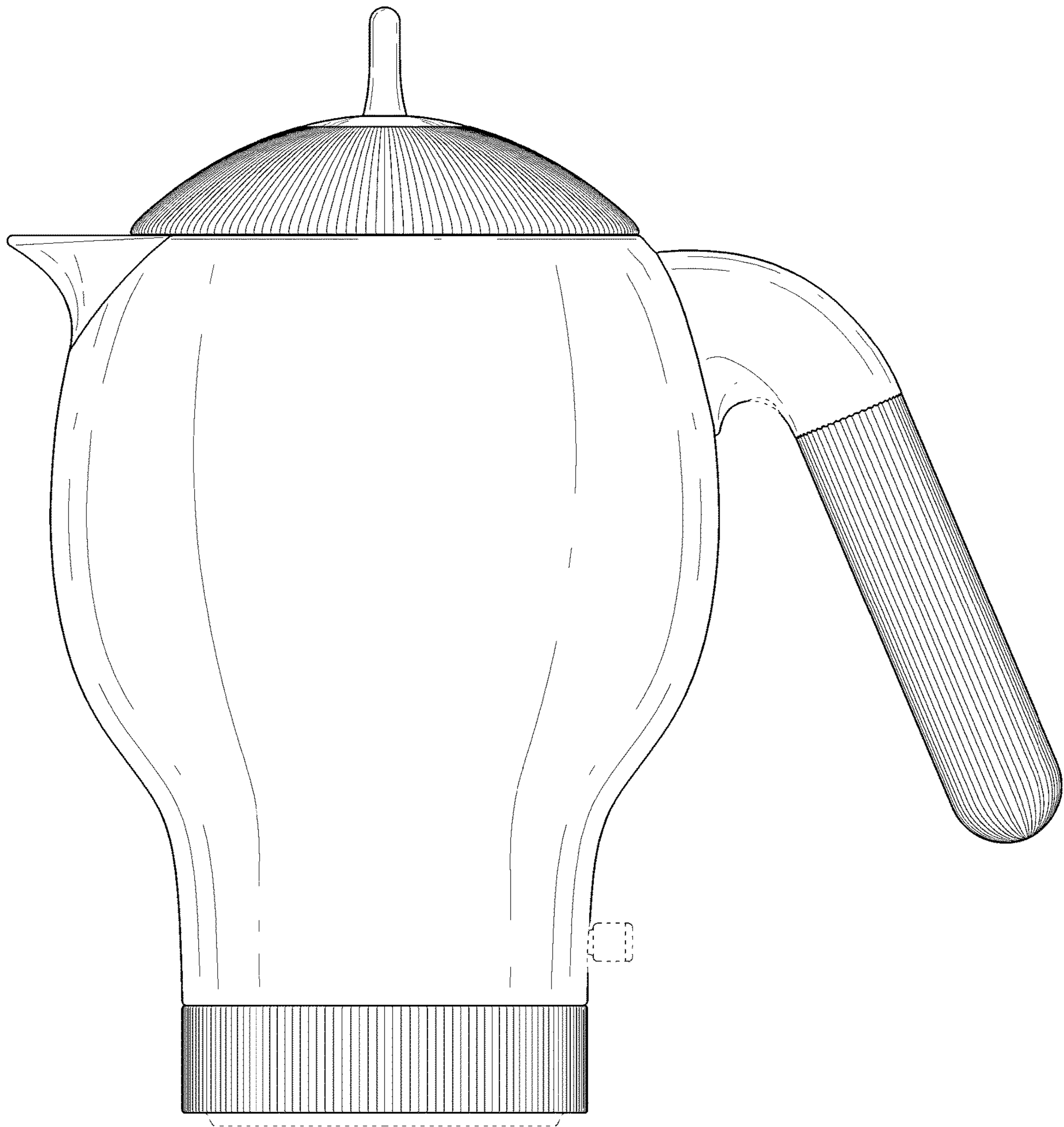

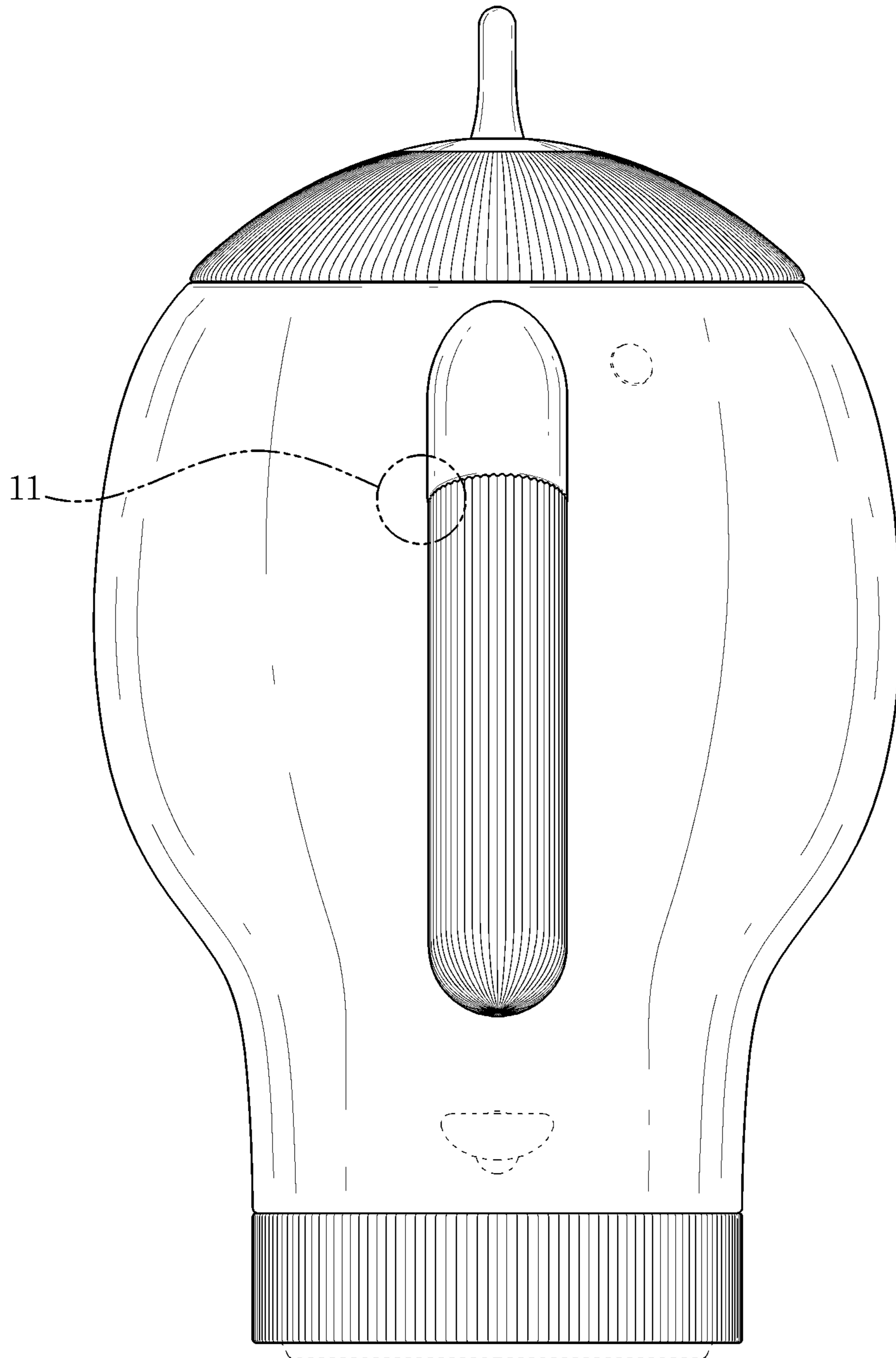

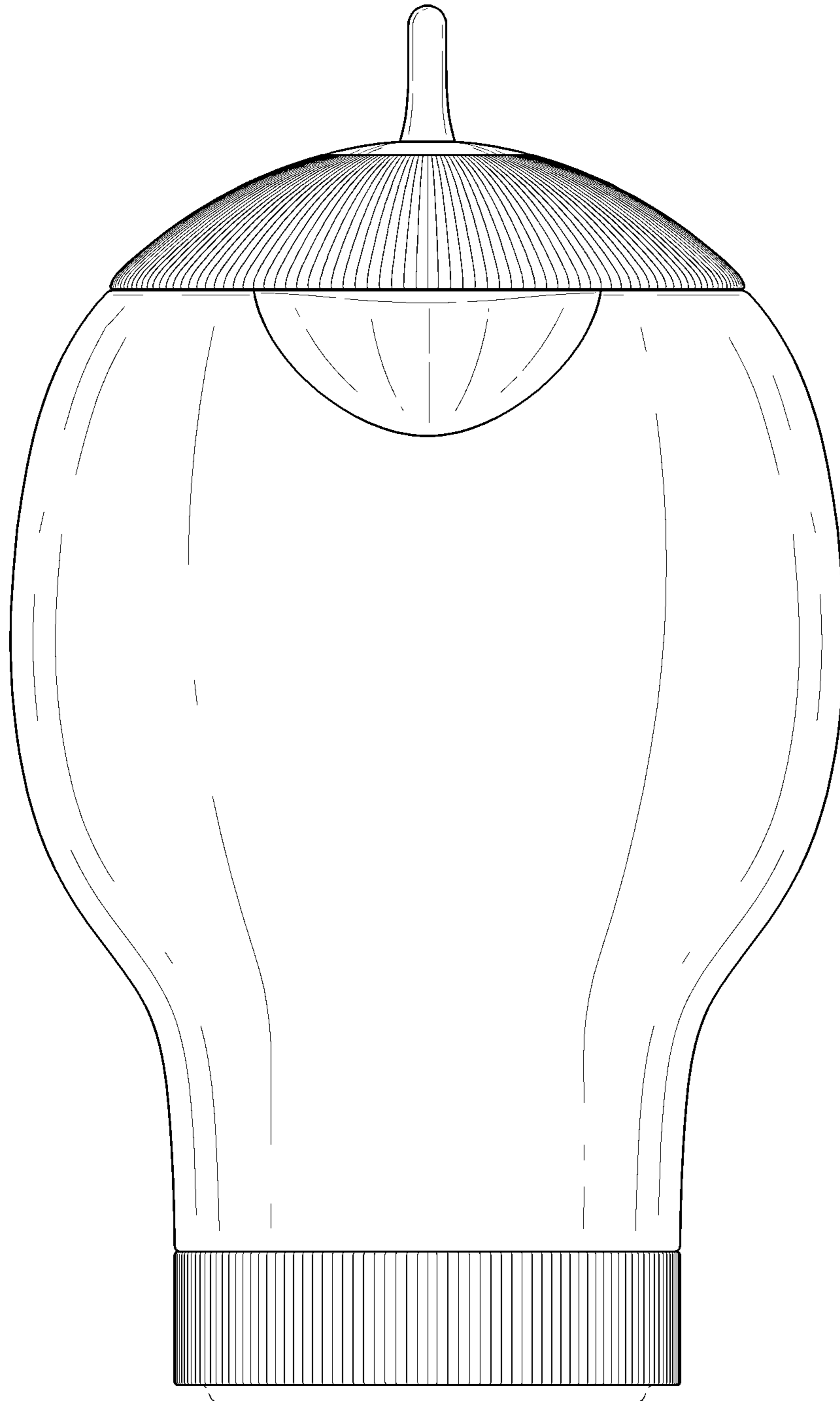

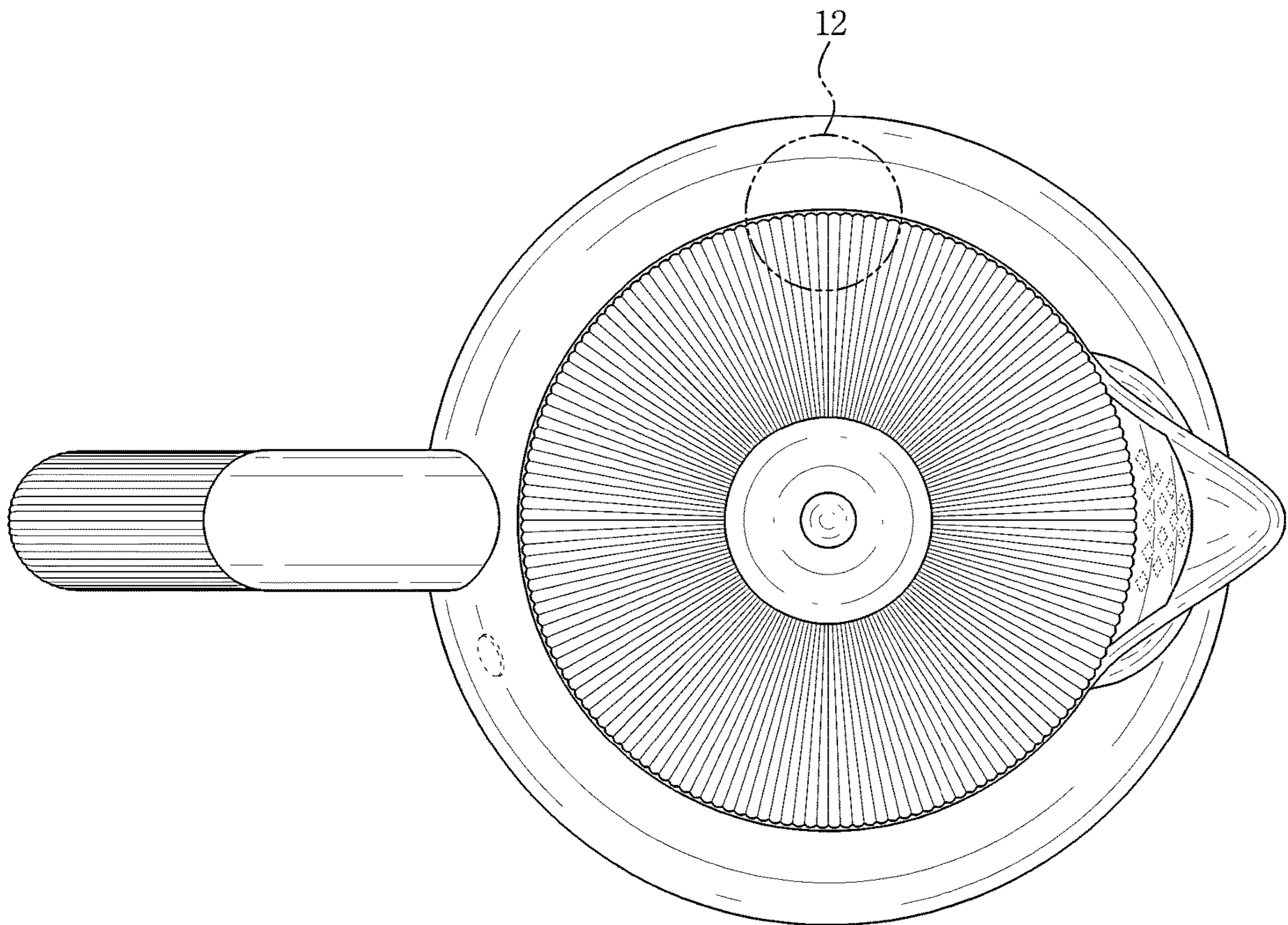

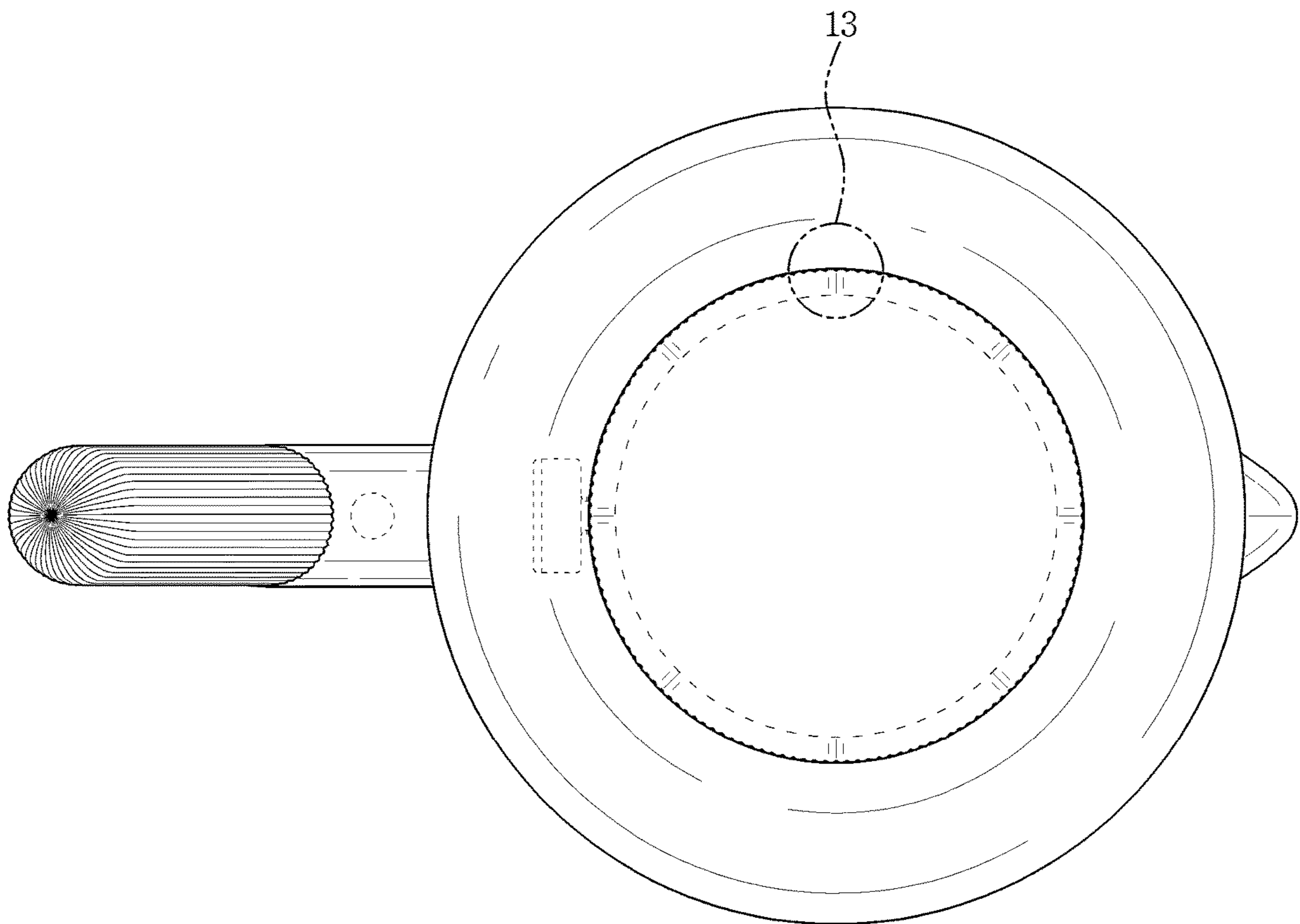

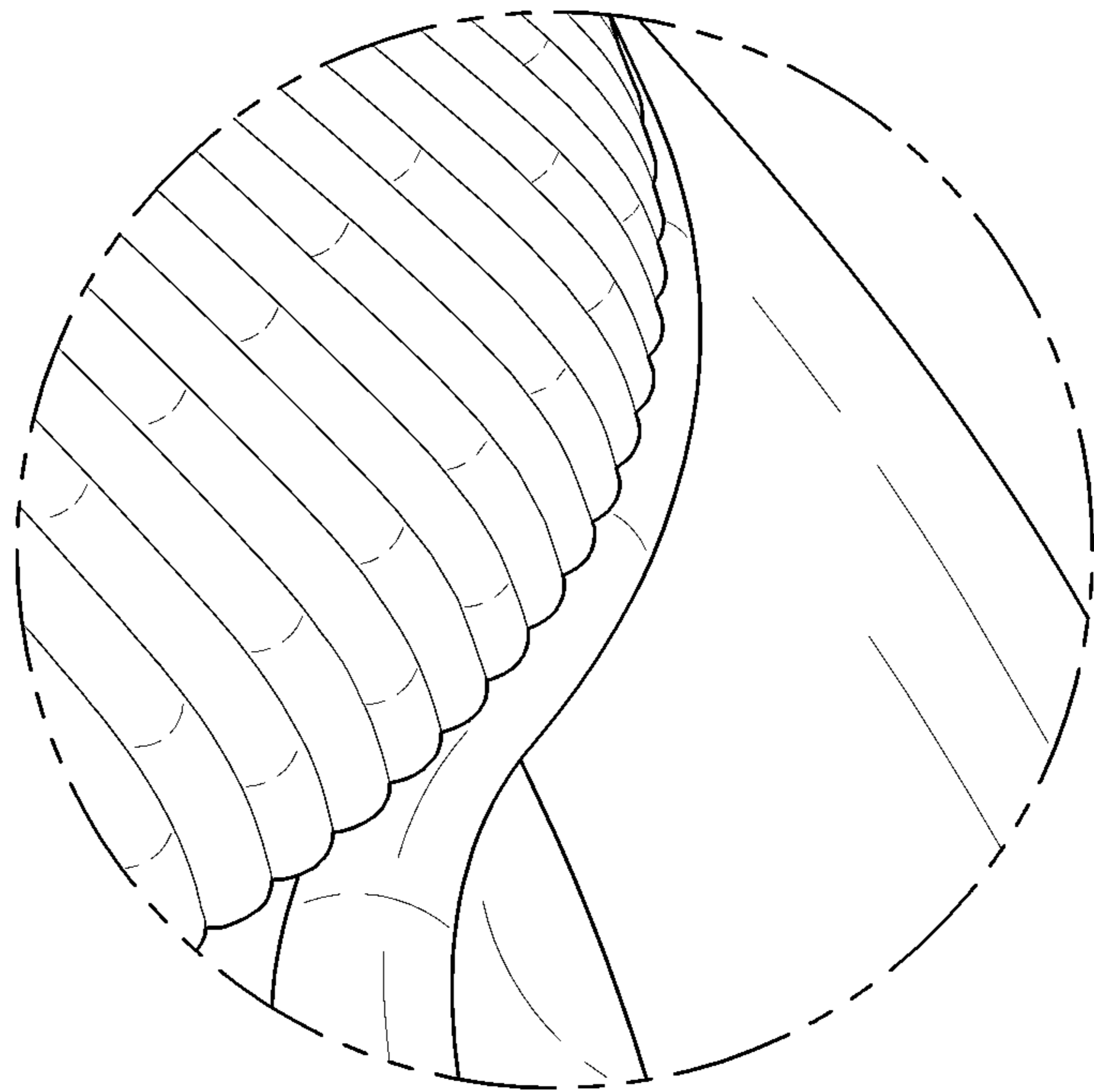

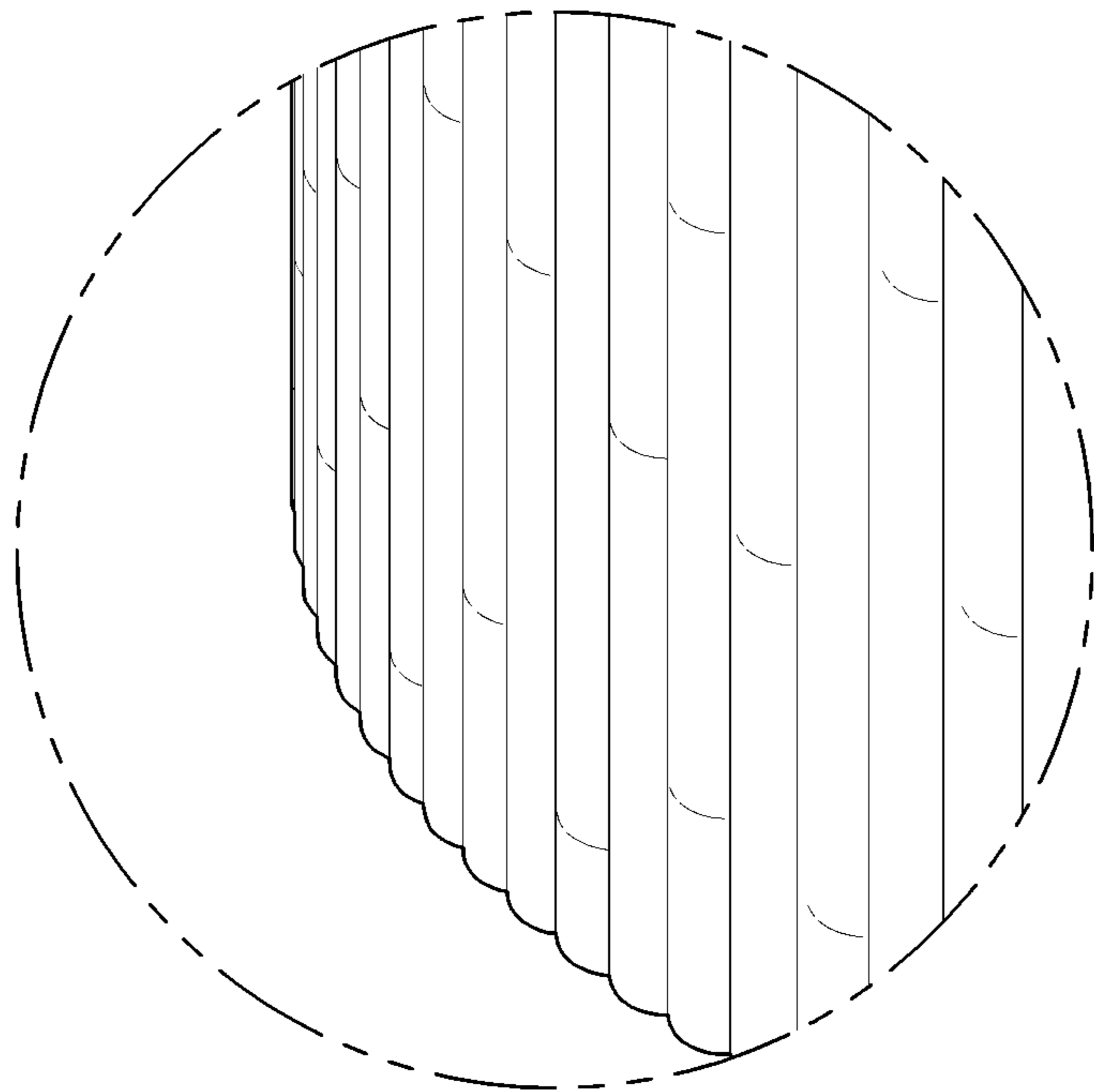

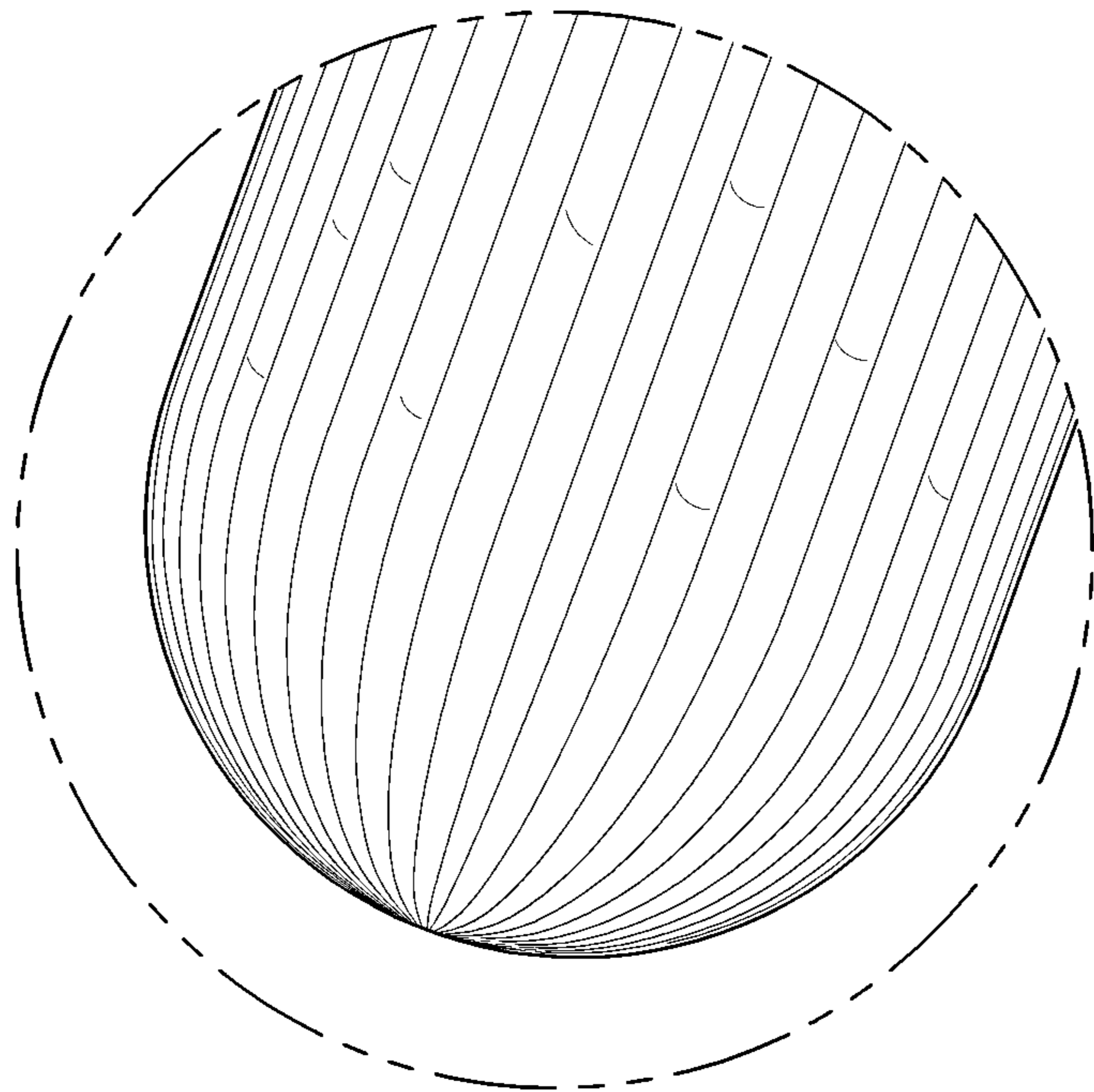

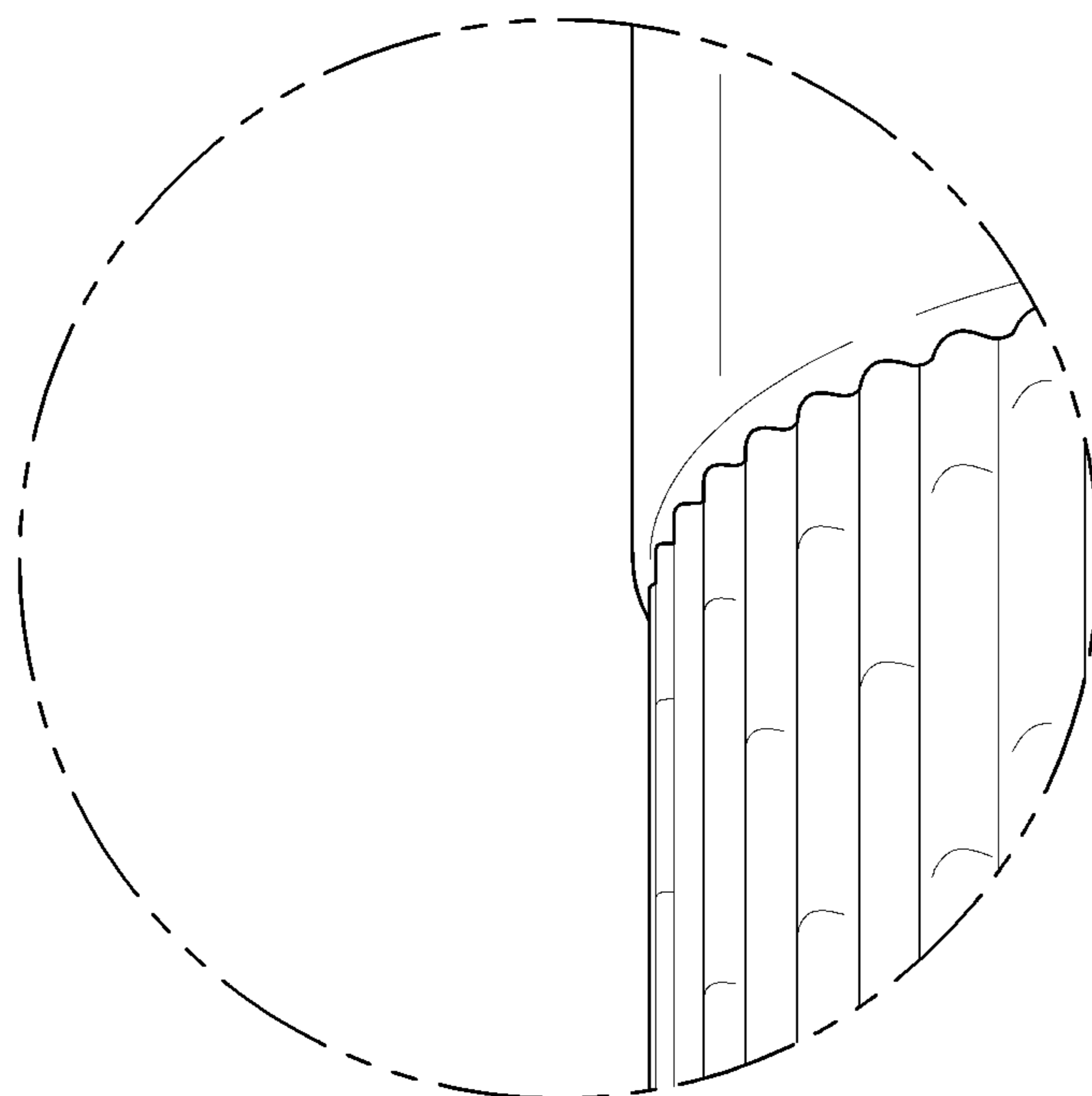

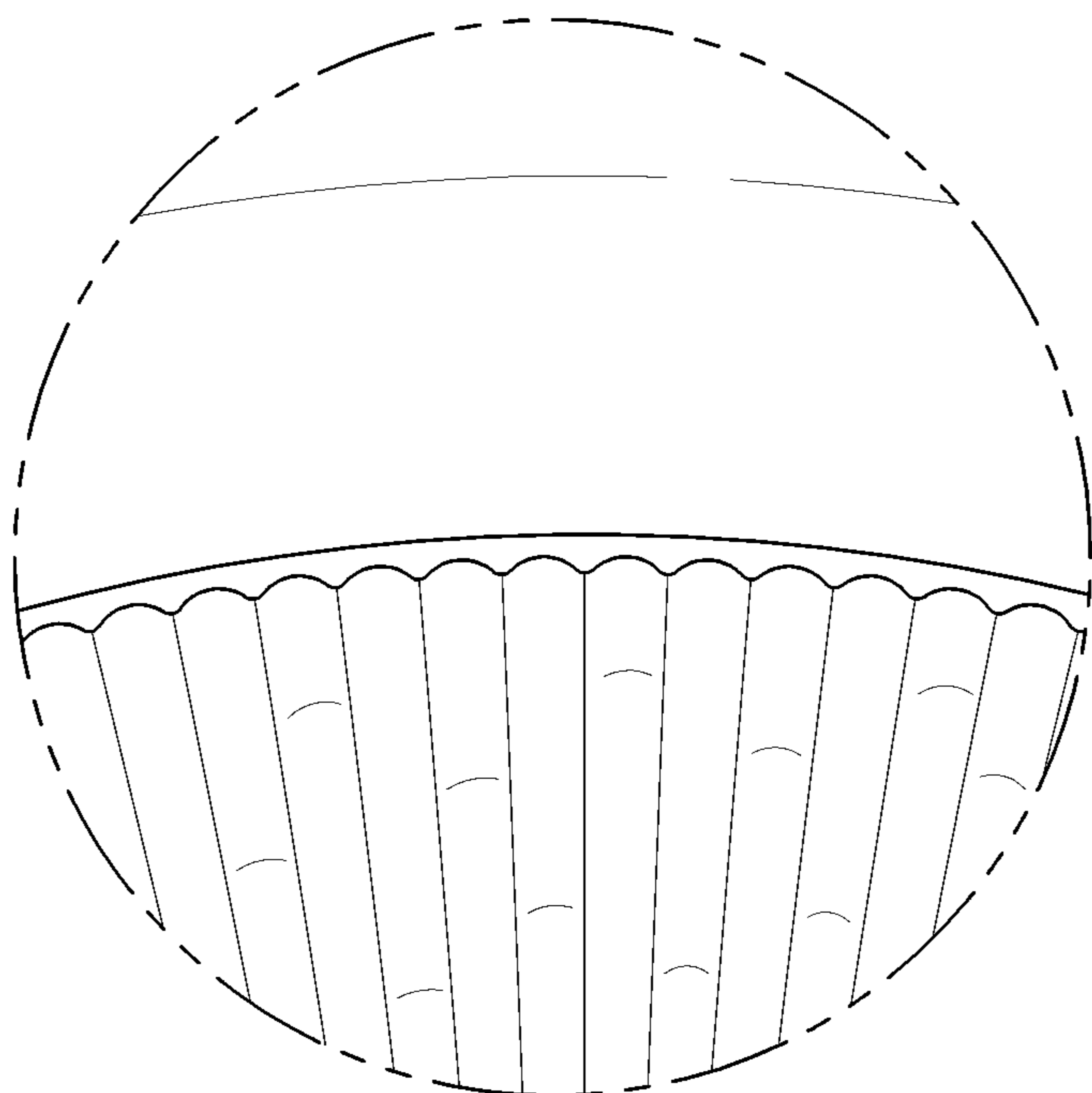

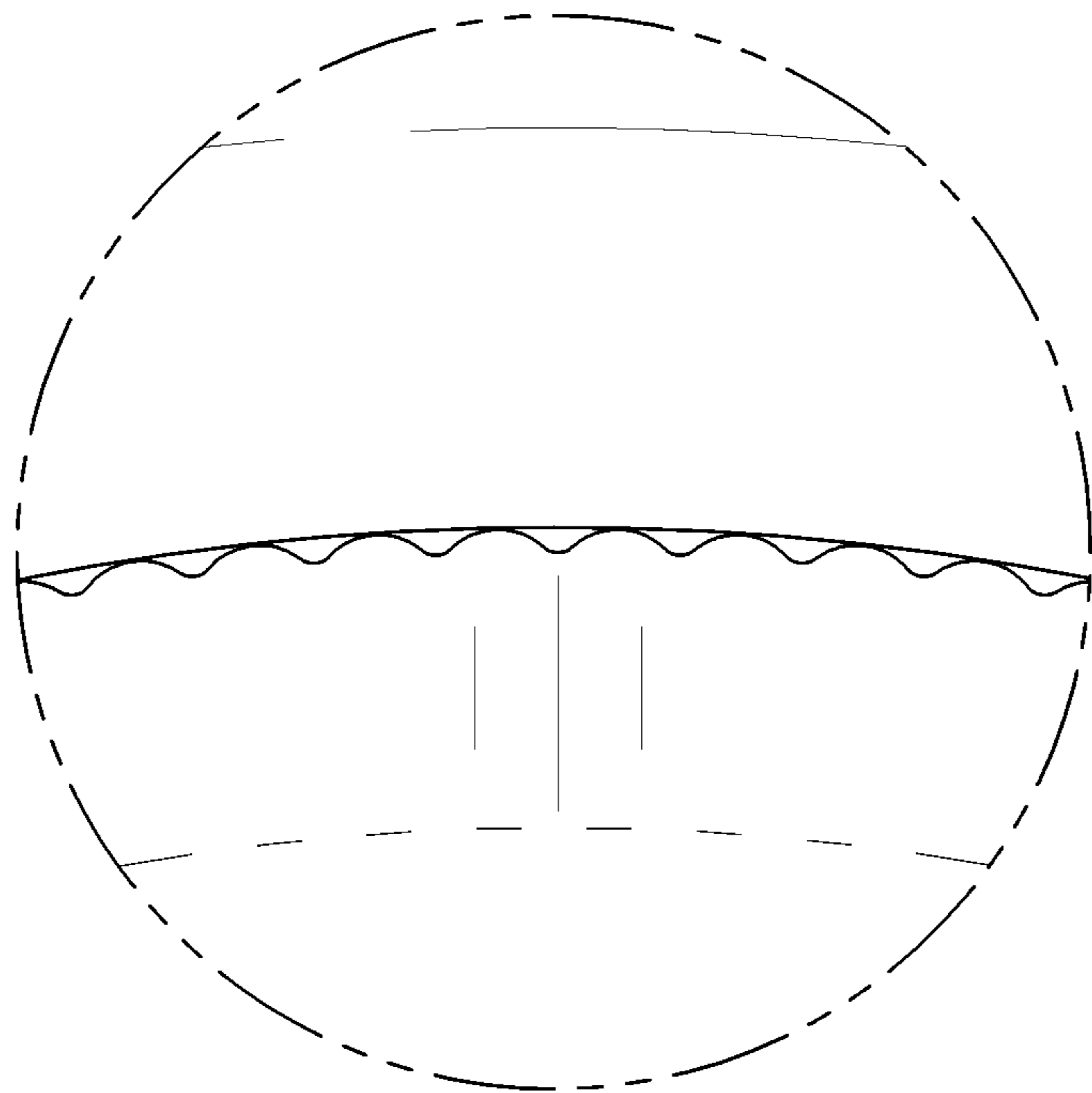

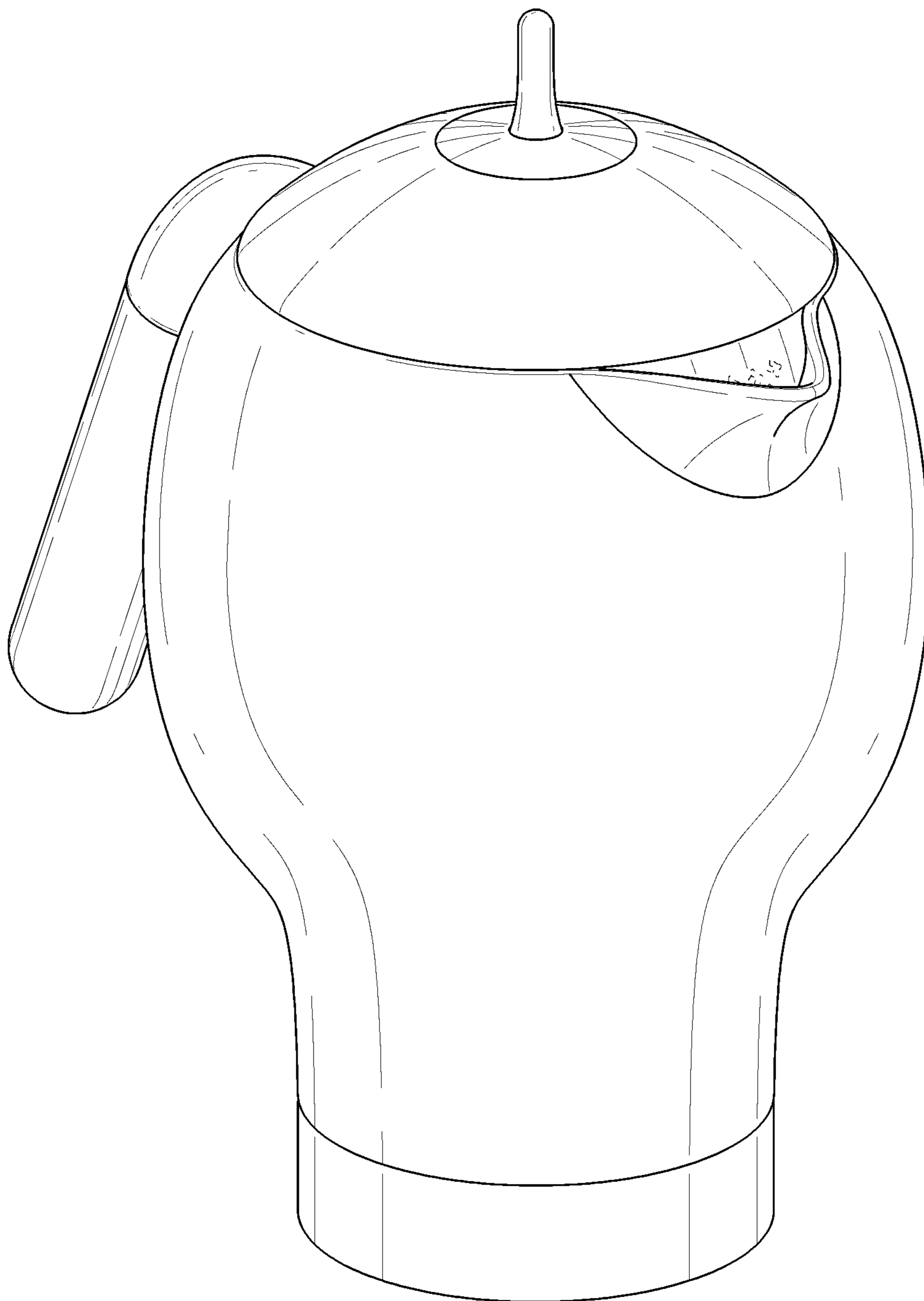

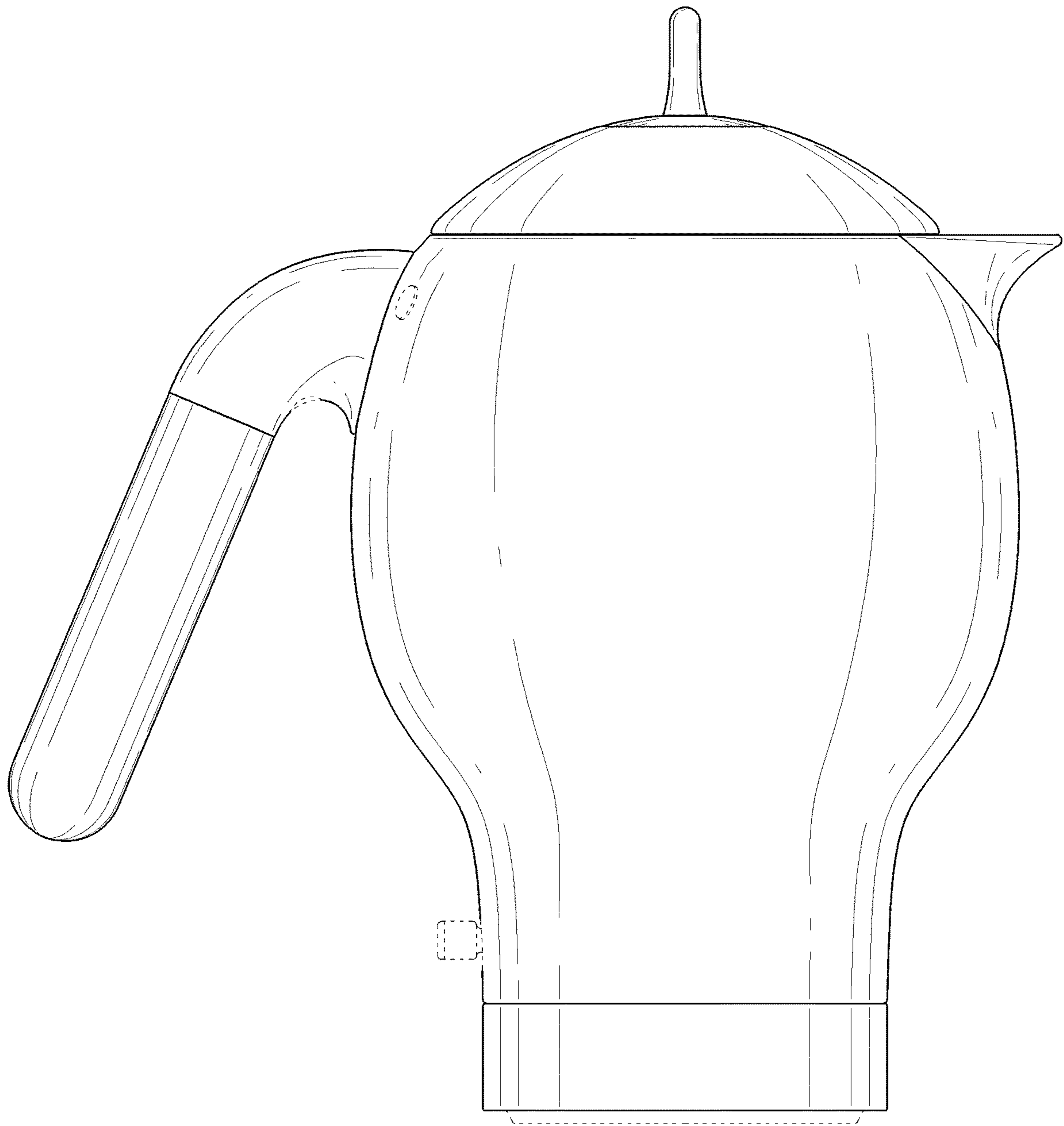

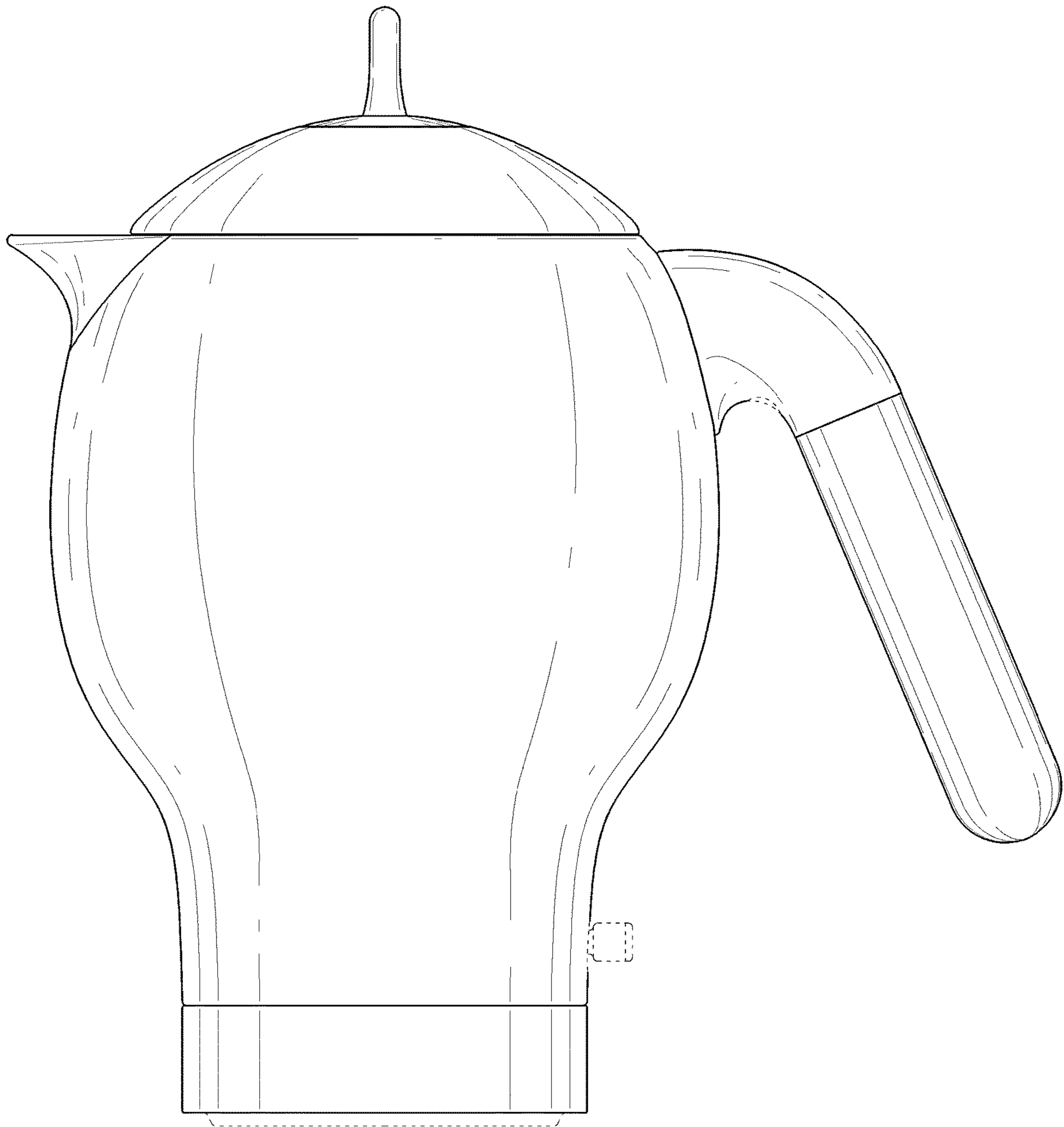

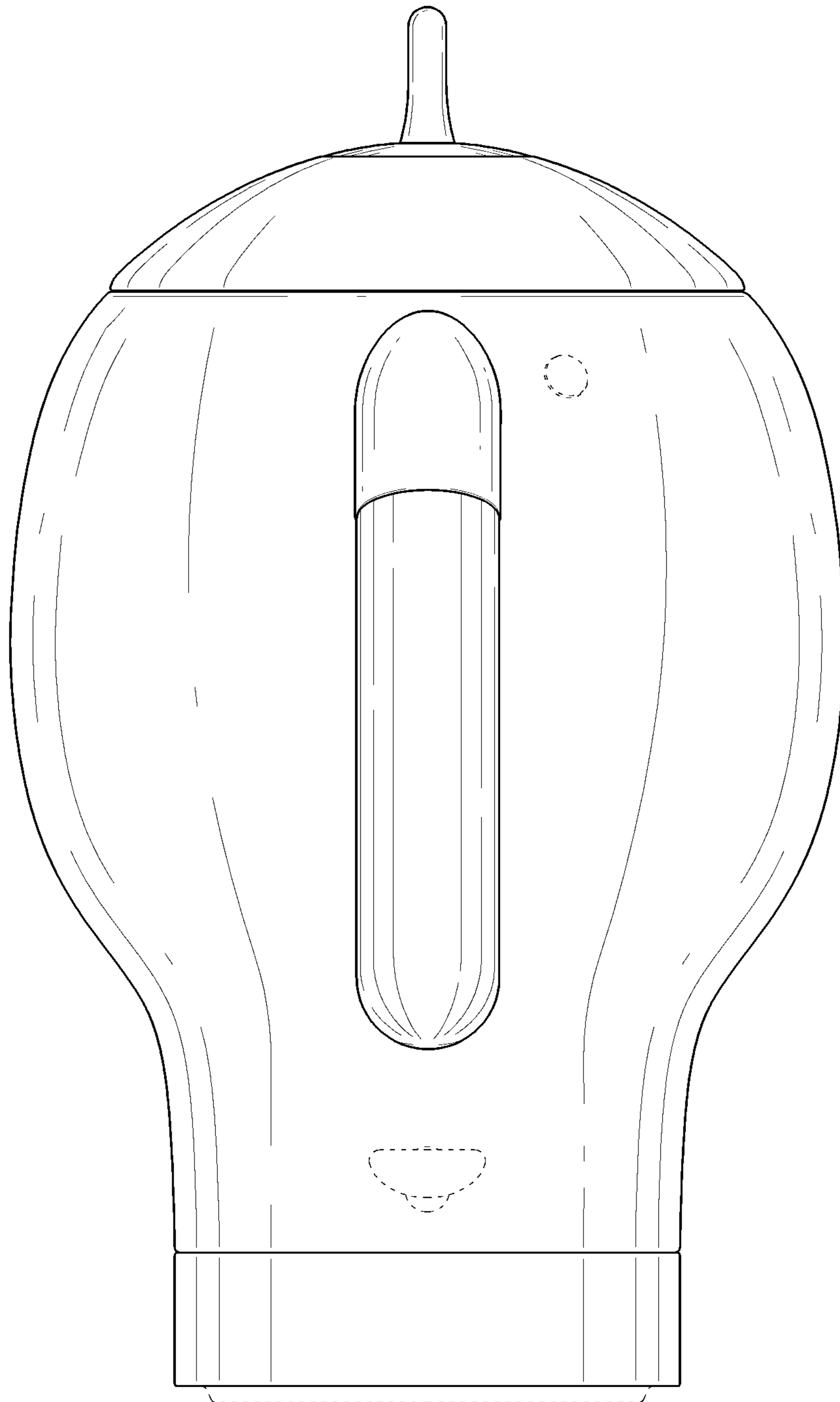

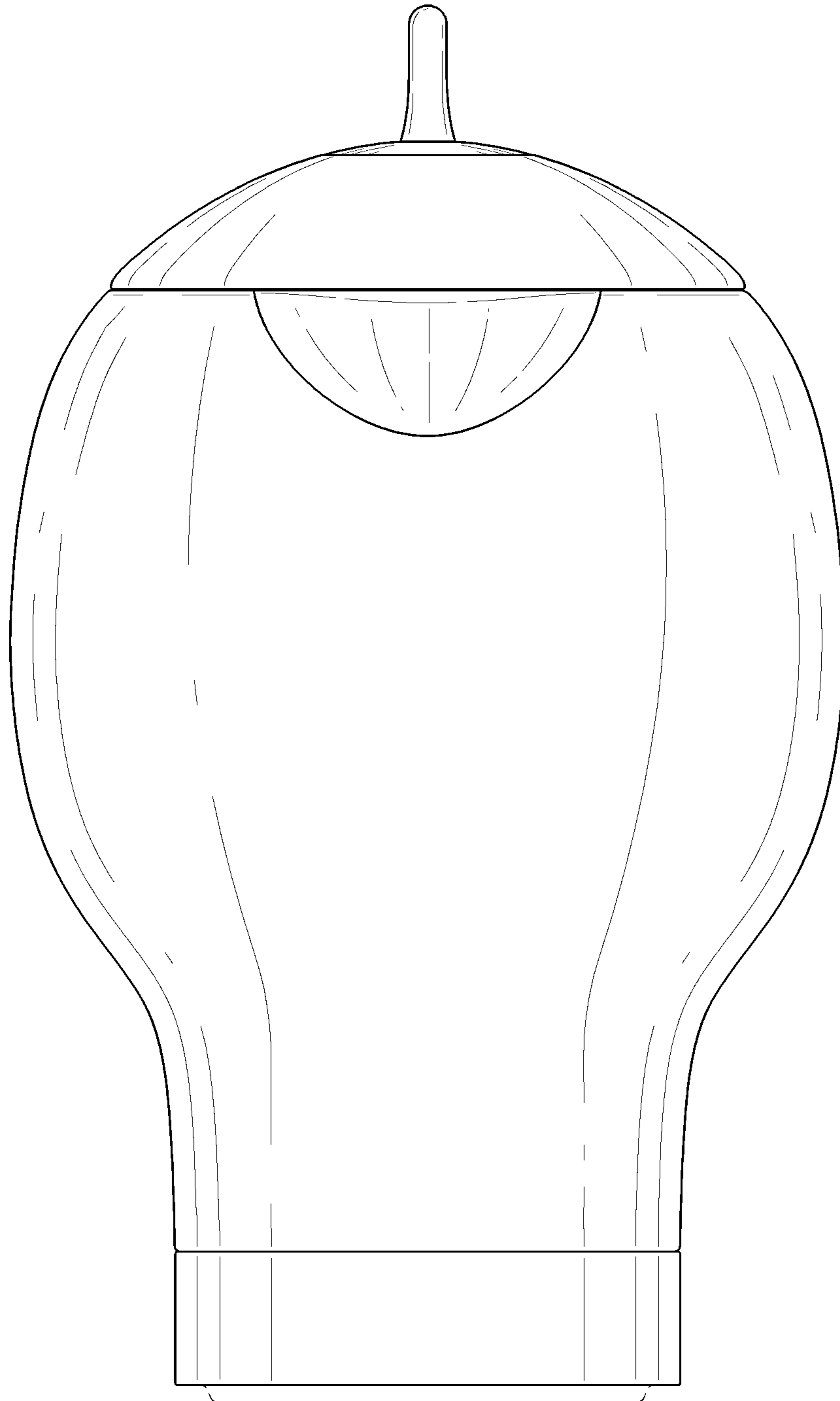

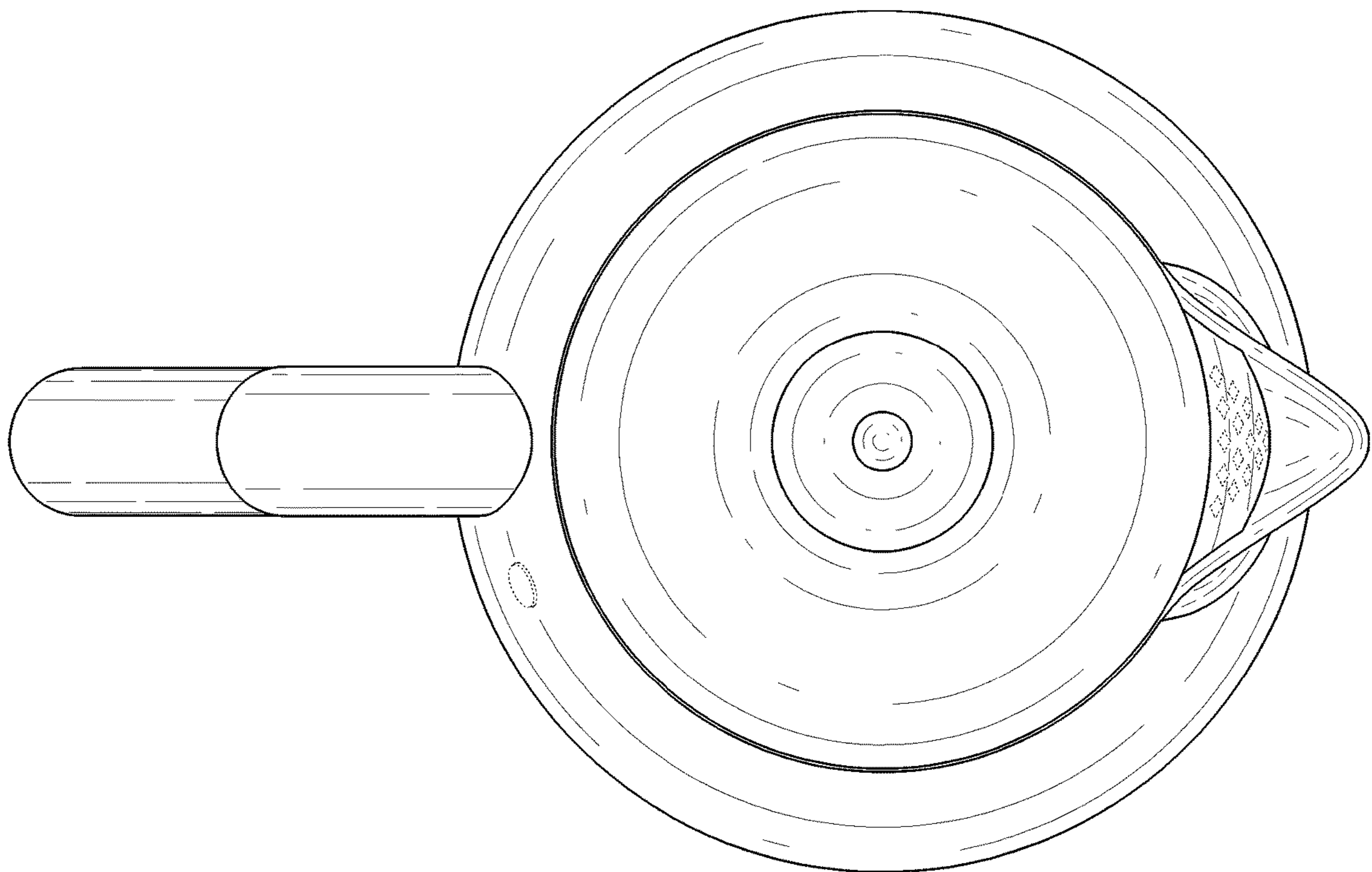
