FIG. 8 is a rear elevational view of the kitchen knife of FIG. 1.

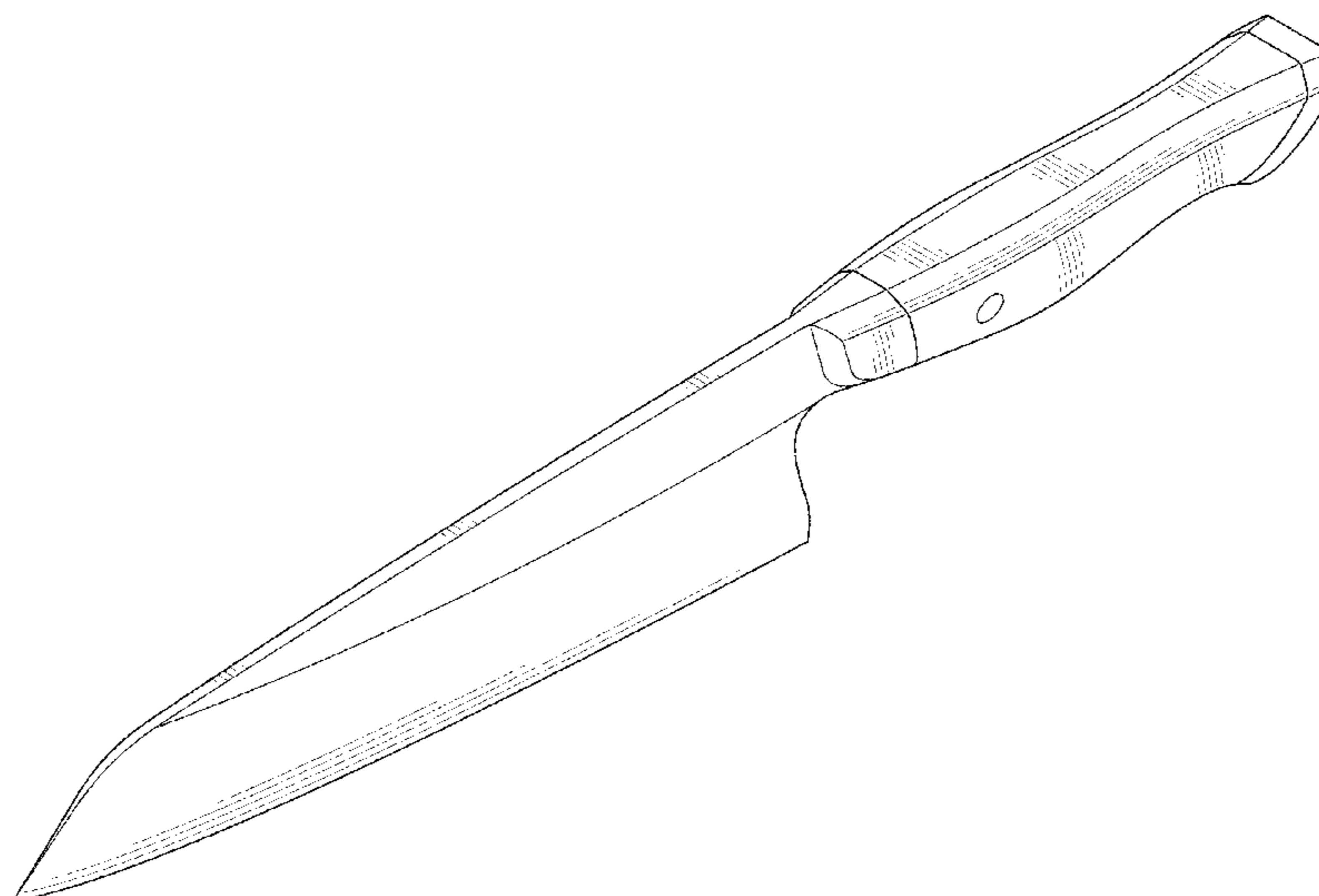

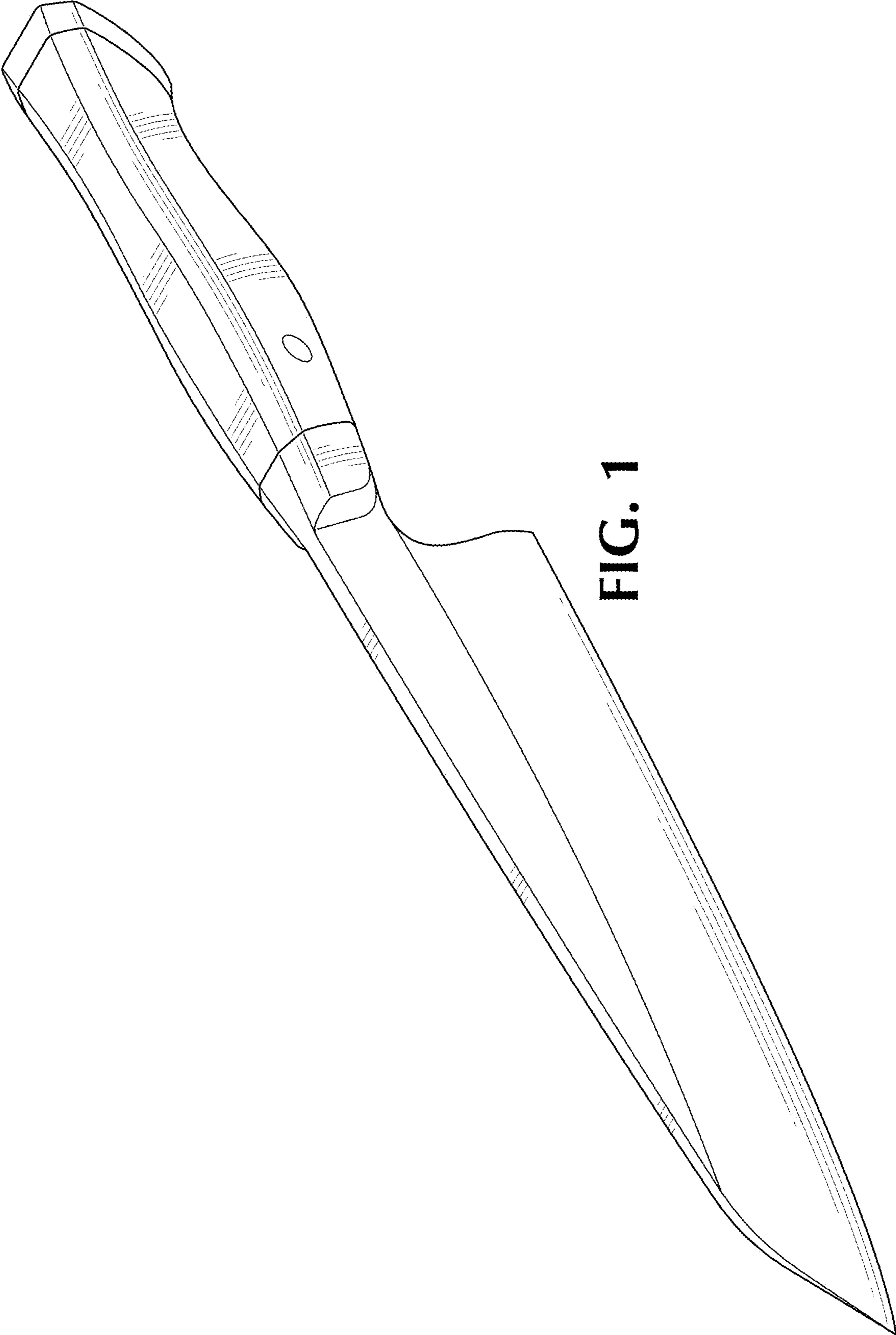

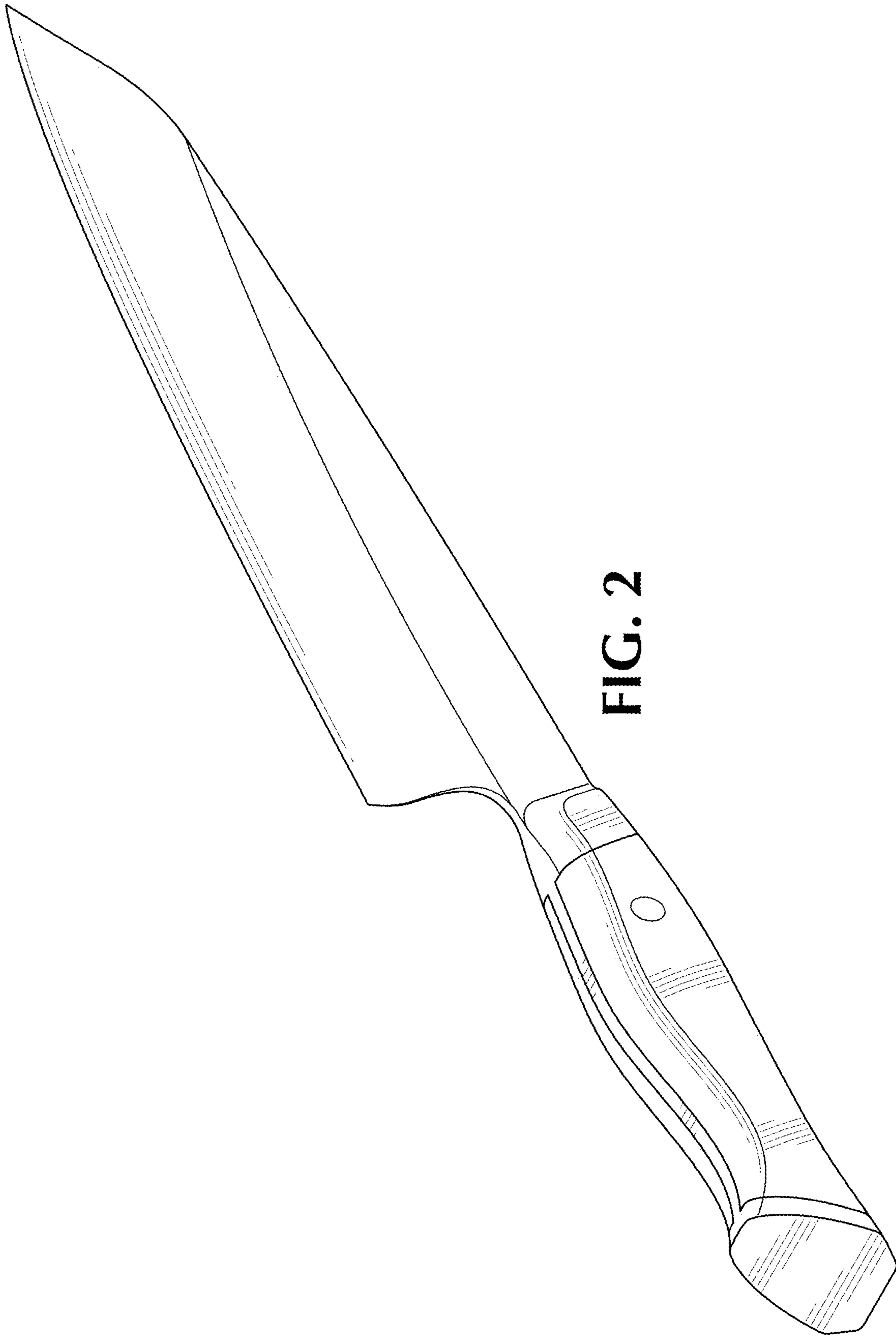

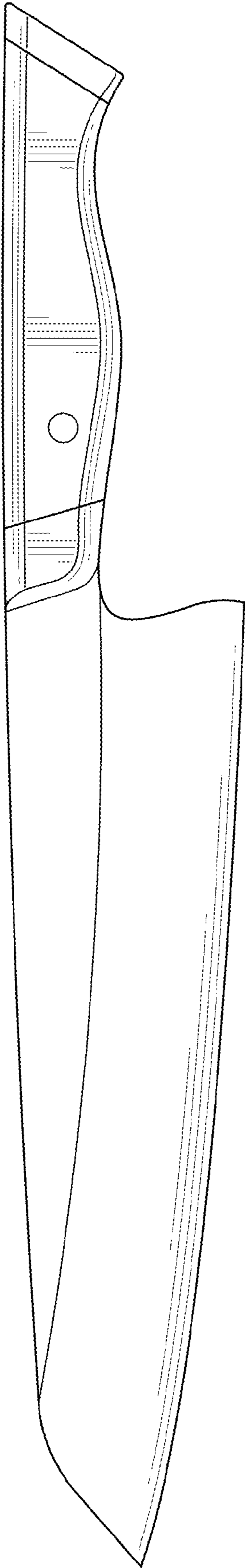

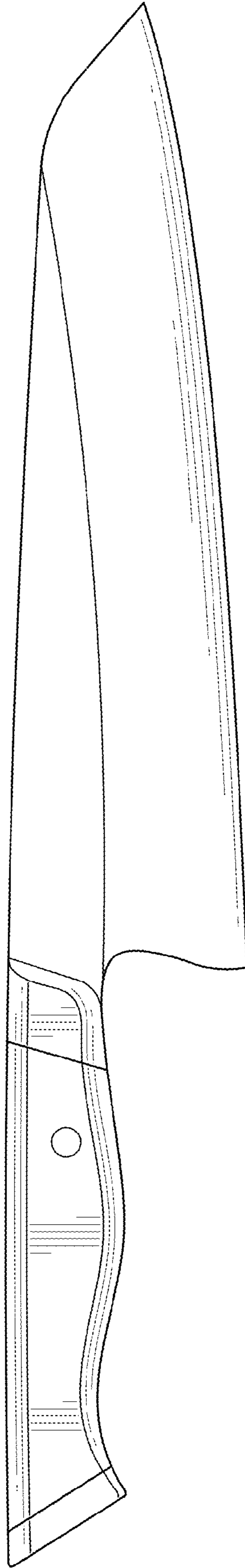

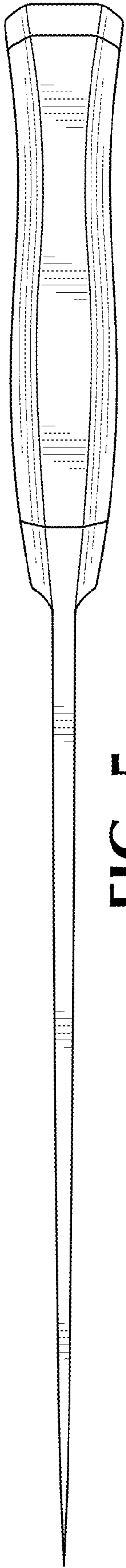

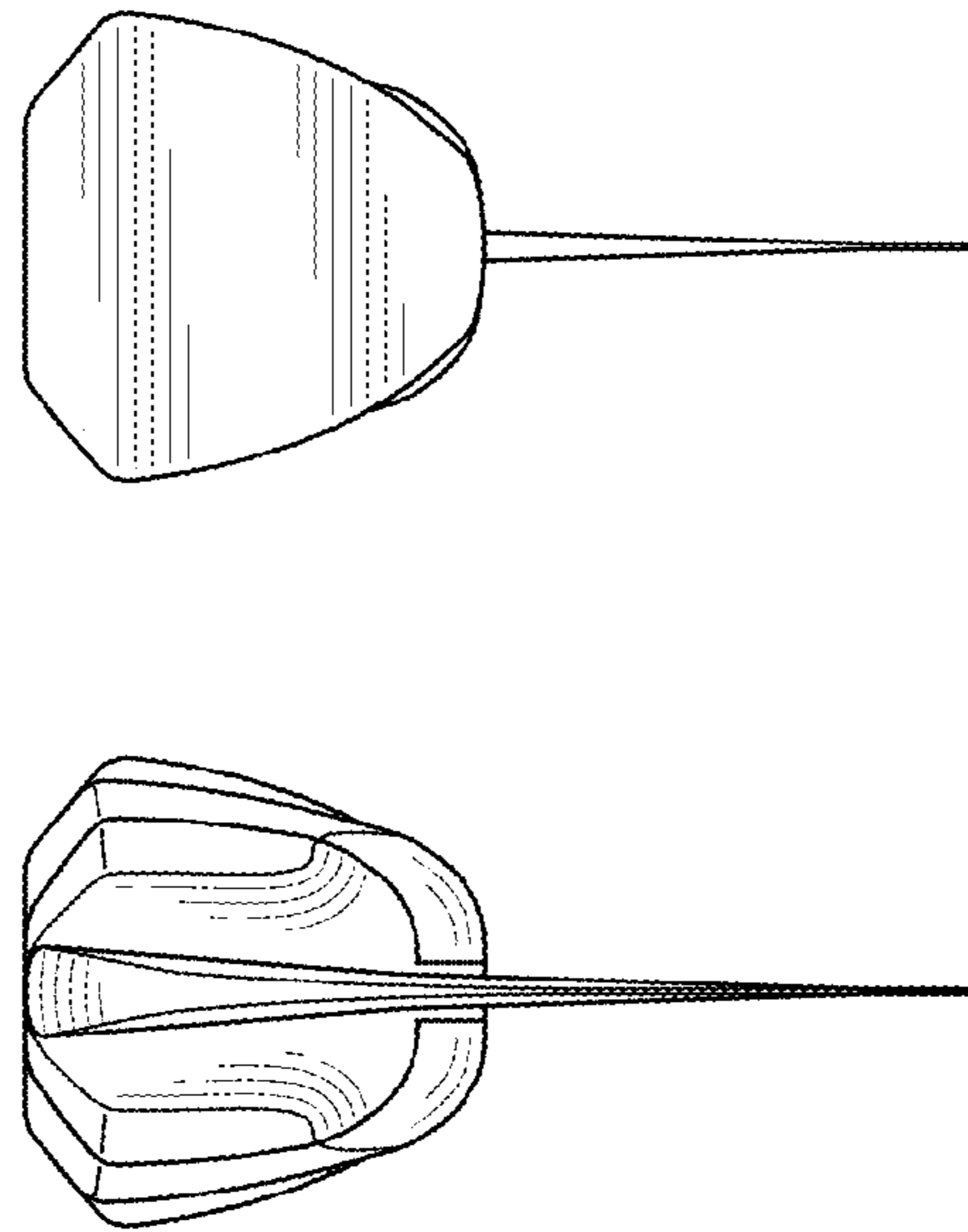
