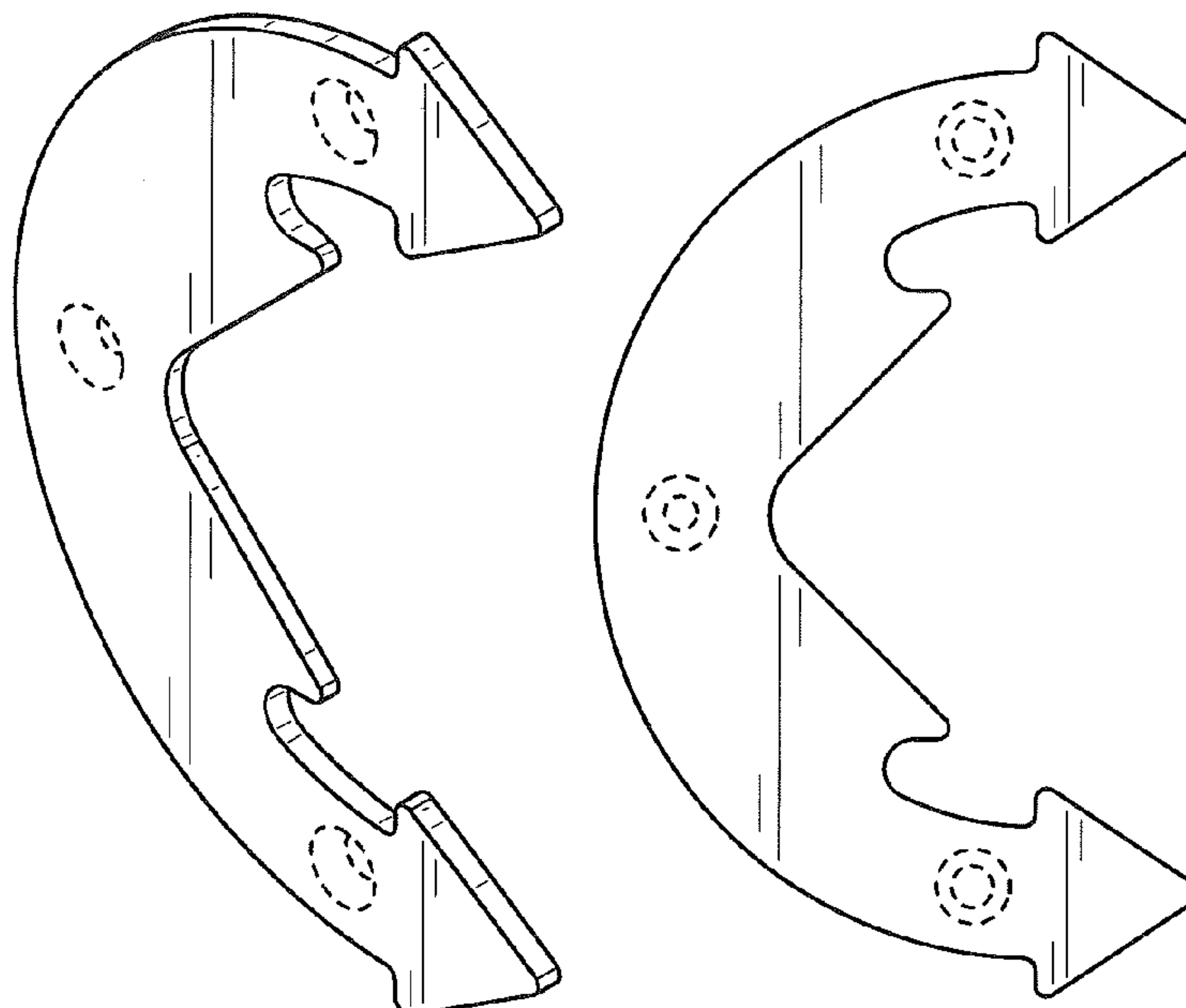
(57) **CLAIM**

The ornamental design for a release plate, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a release plate showing our new design.
FIG. 2 is a front view thereof.
FIG. 3 is a right side view thereof.
FIG. 4 is a left side view thereof.
FIG. 5 is a top view thereof, the bottom view being the same; and,
FIG. 6 is a rear view thereof.
The broken lines depict portions of the release plate that form no part of the claimed design.

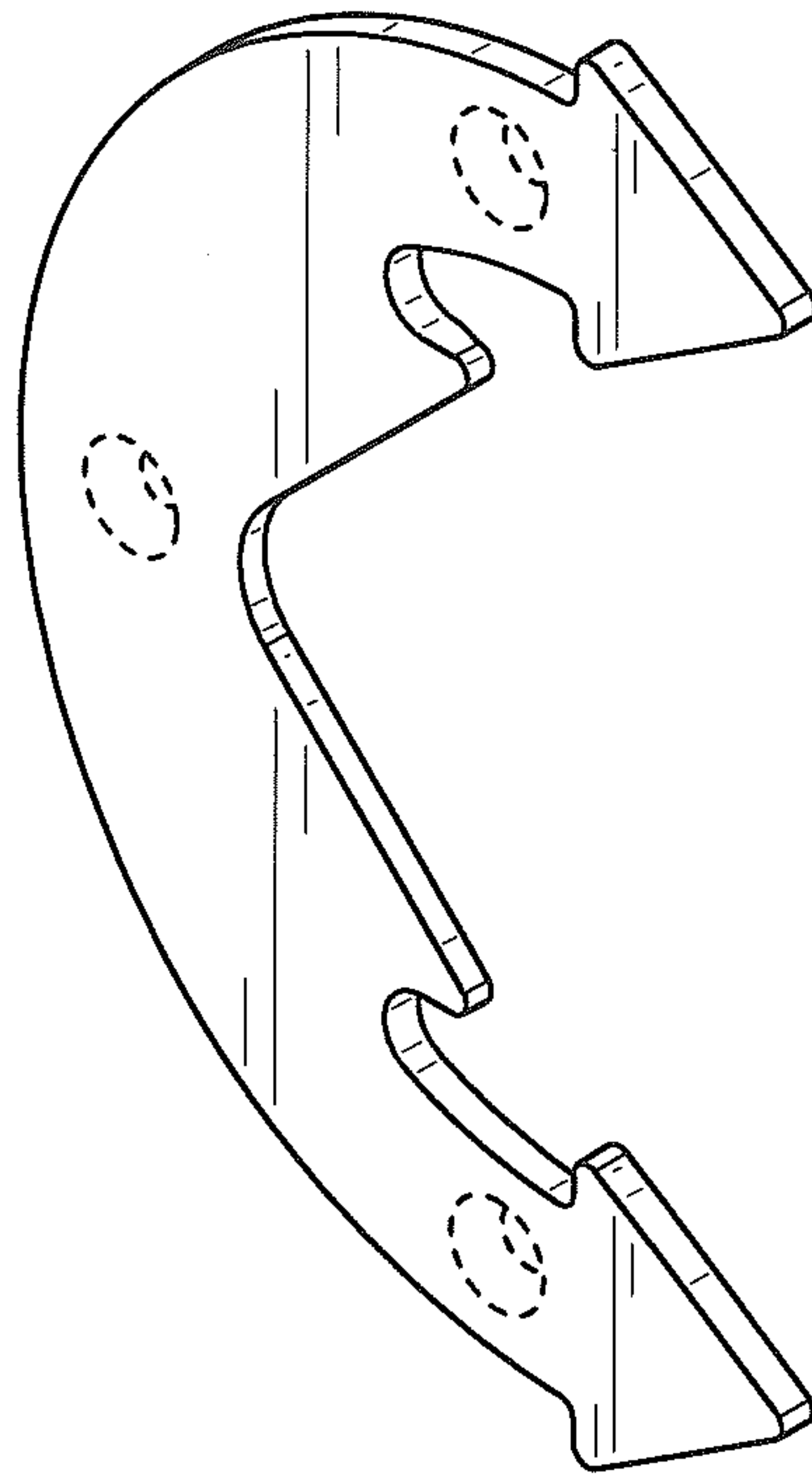

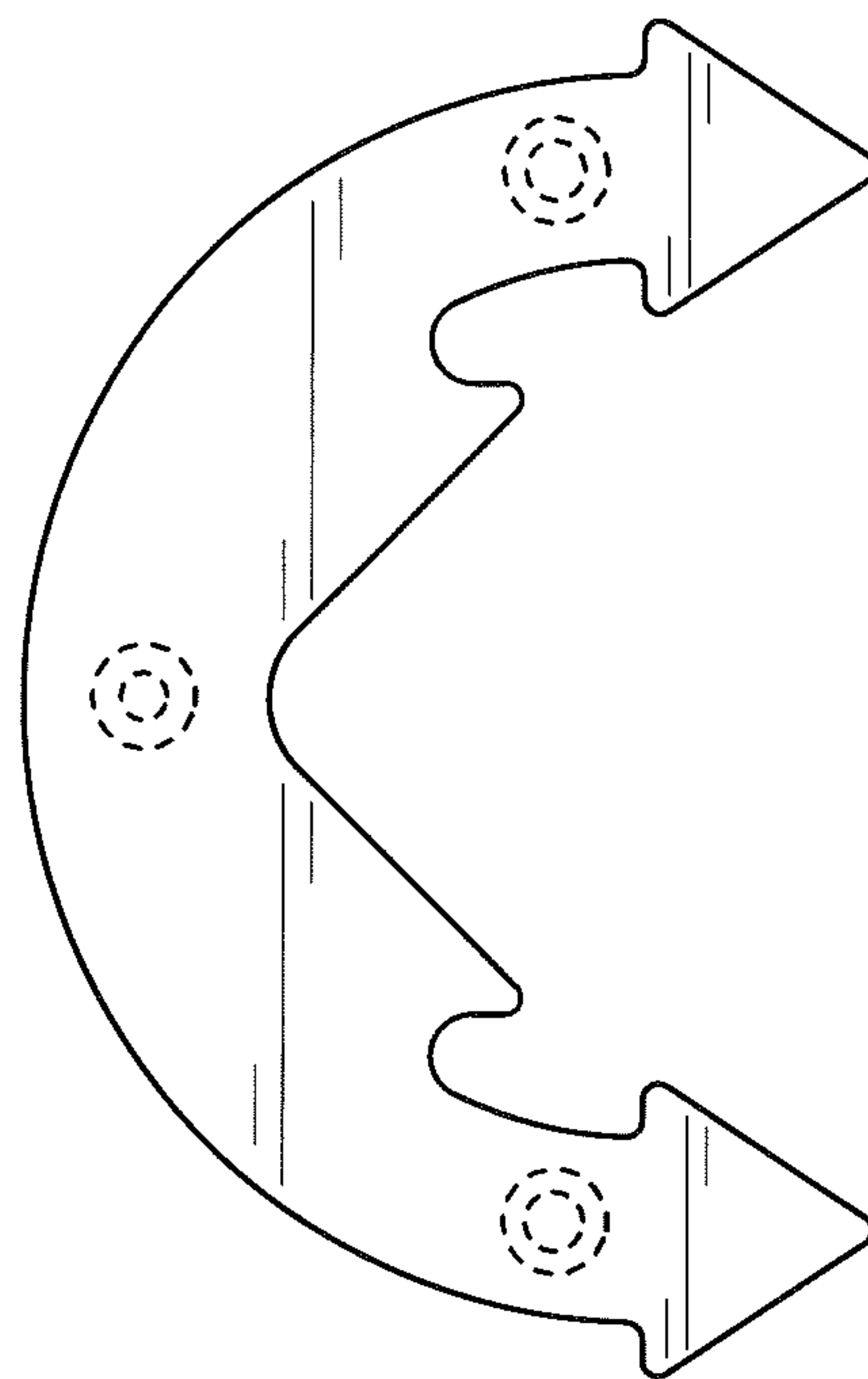

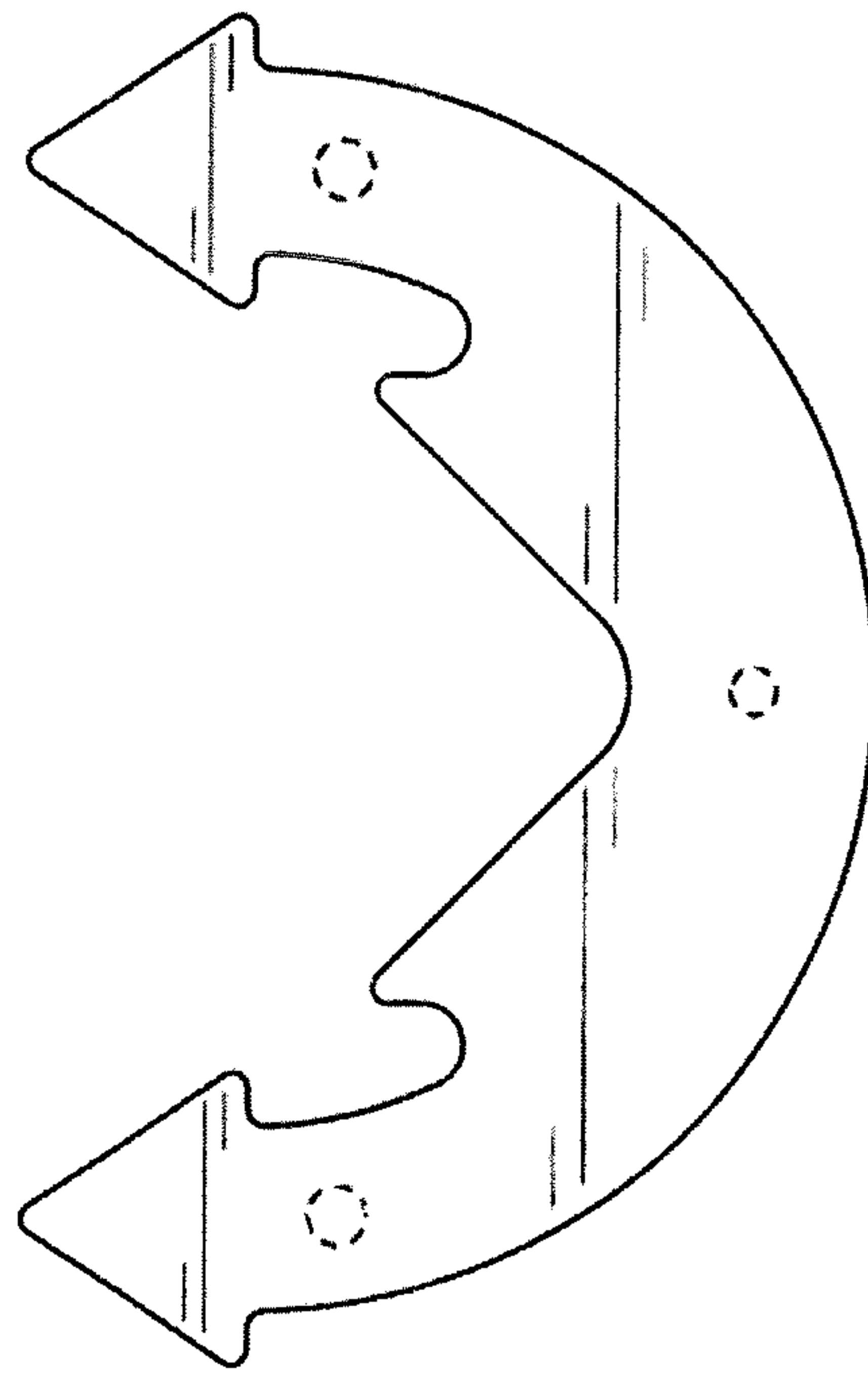
