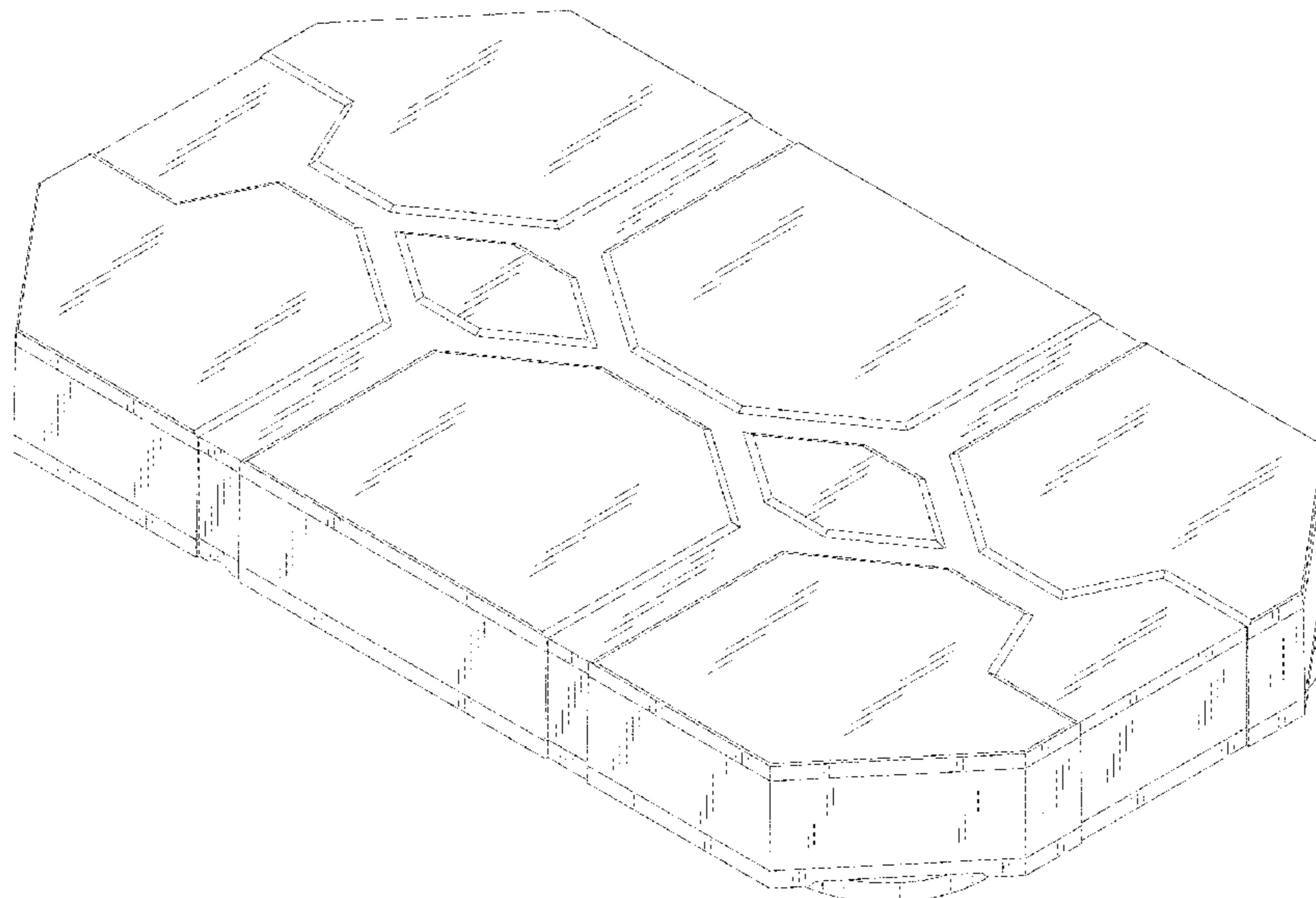
(57) **CLAIM**

I claim the ornamental design for a flash lamp, as shown and described.

DESCRIPTION

FIG. 1 is a Perspective view of a flash lamp showing my new design;
FIG. 2 is a Front view thereof;
FIG. 3 is a Back view thereof;
FIG. 4 is a Left-side view thereof;
FIG. 5 is a Right-side view thereof;
FIG. 6 is a Top view thereof; and,

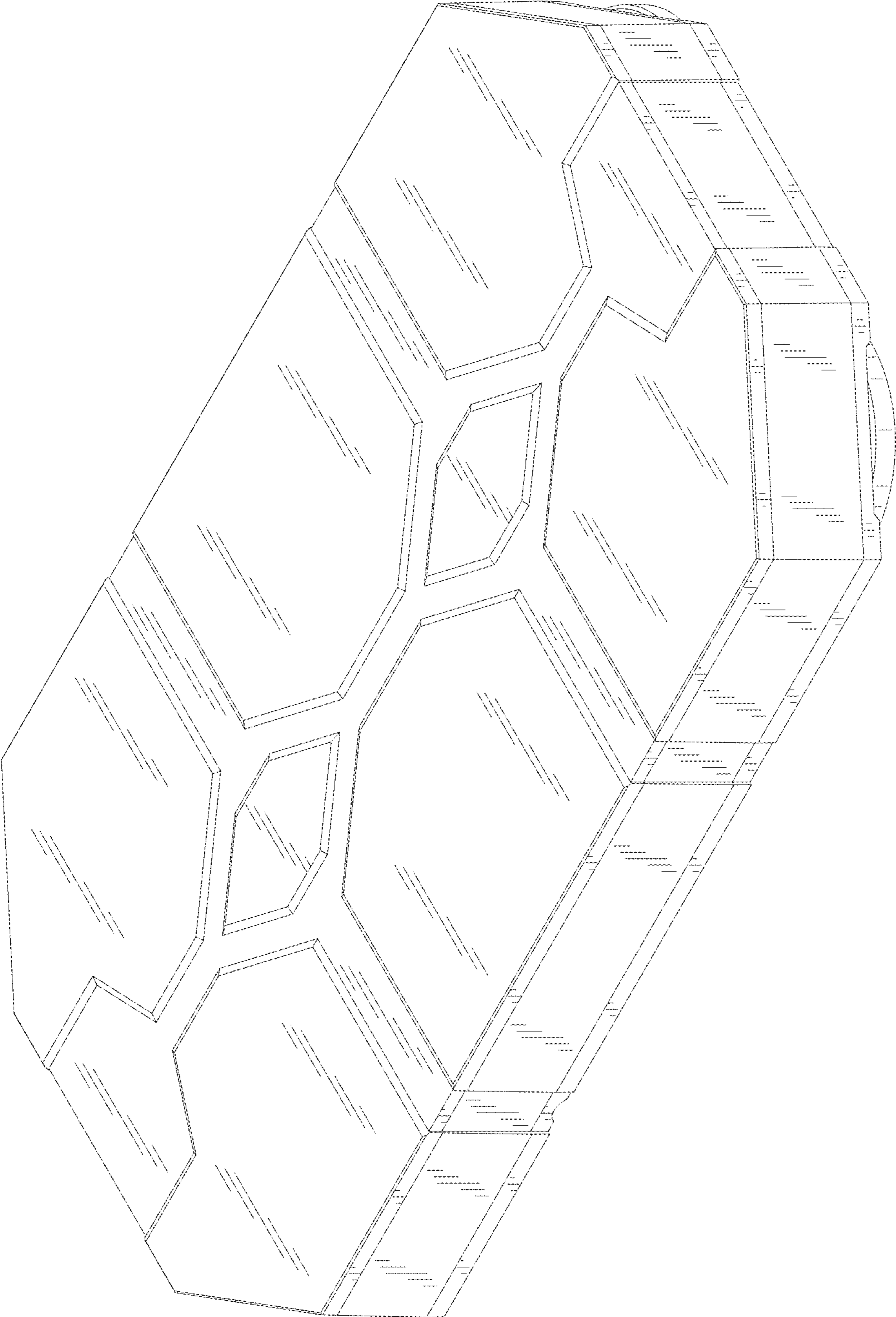

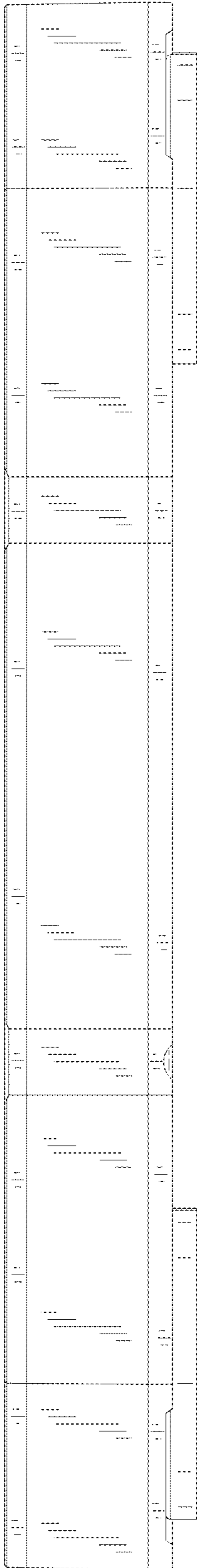

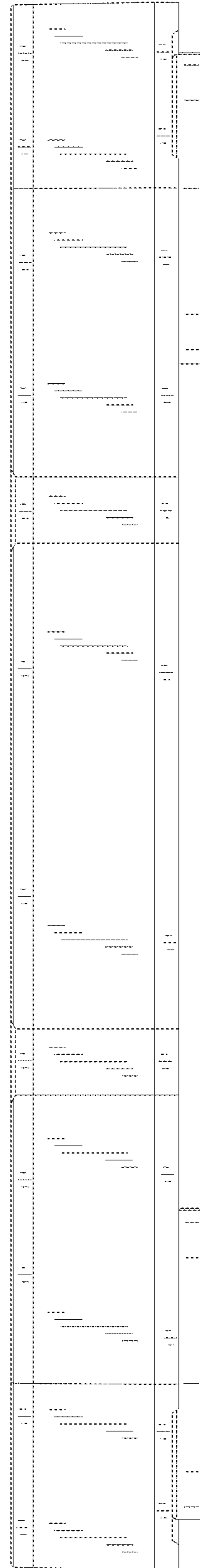

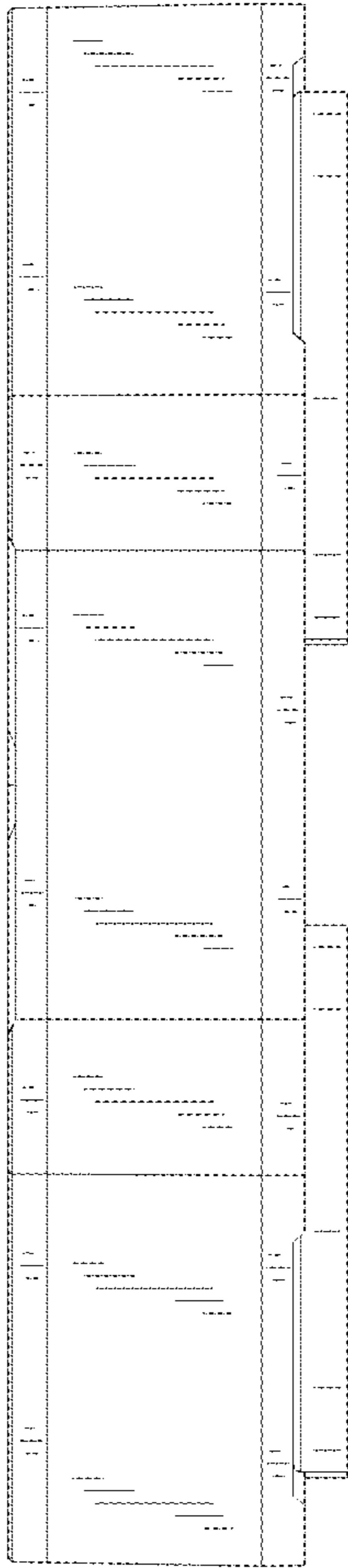

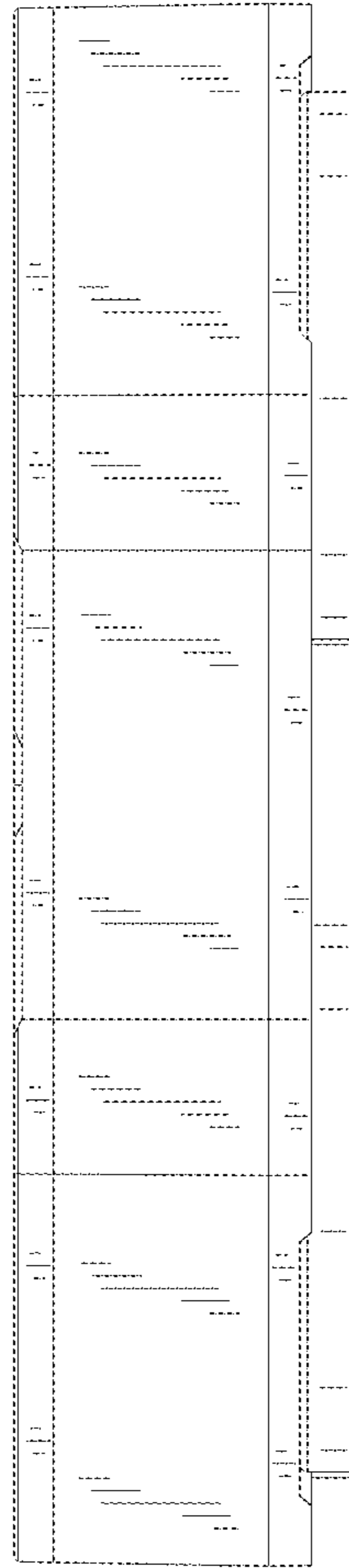

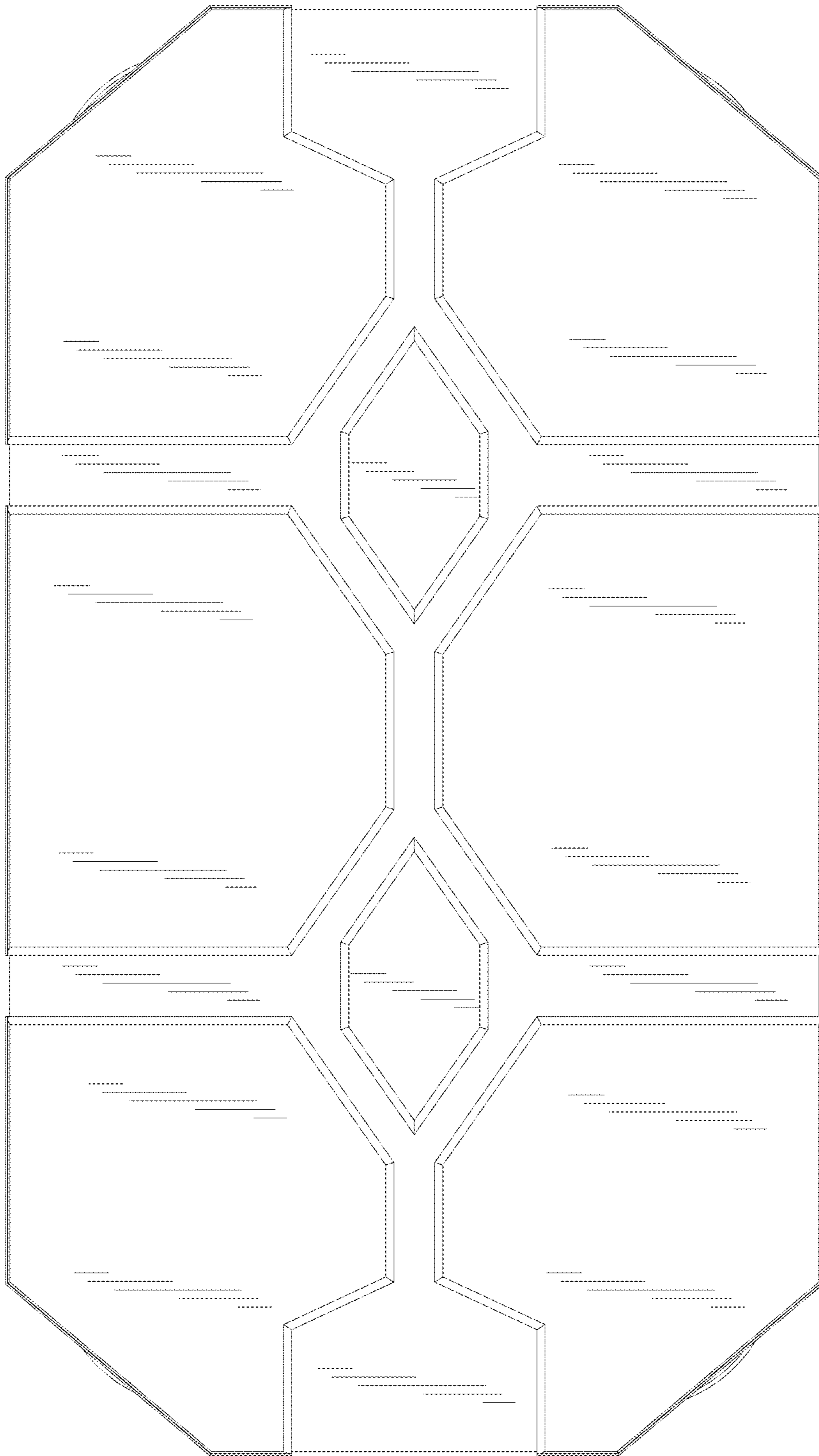

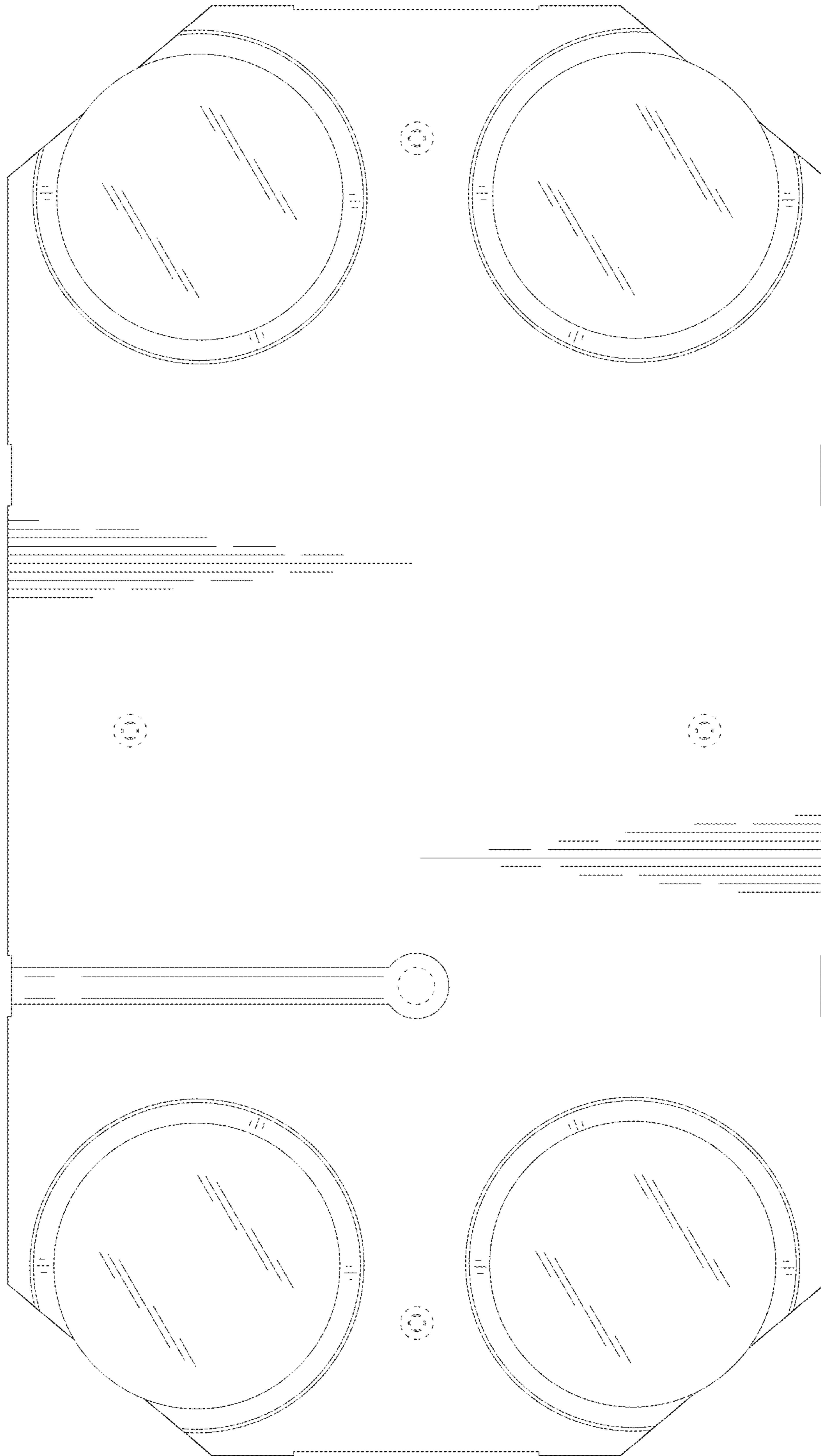
