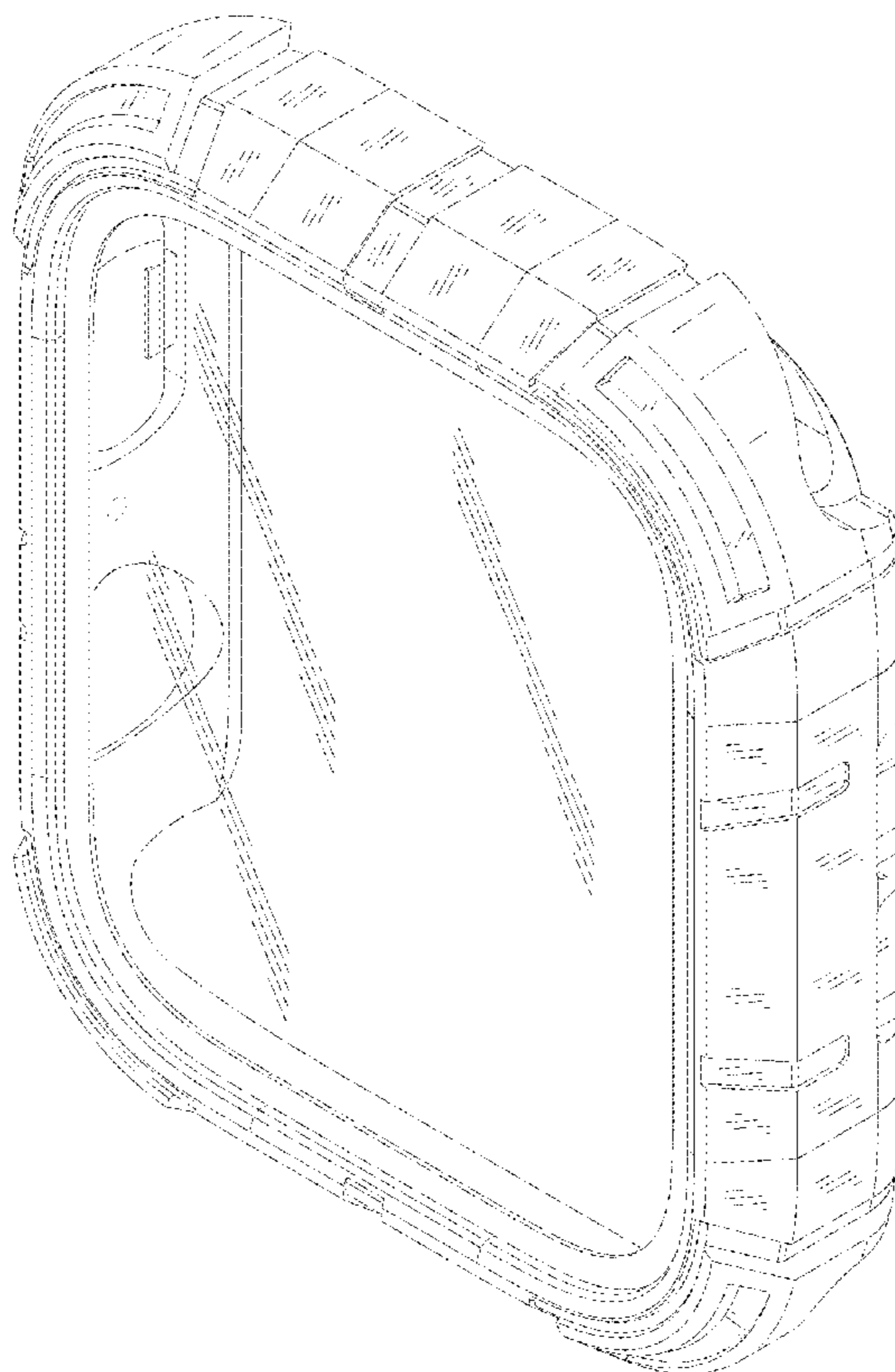
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a Perspective view of a watch case showing my new design;
FIG. 2 is a Front view thereof;

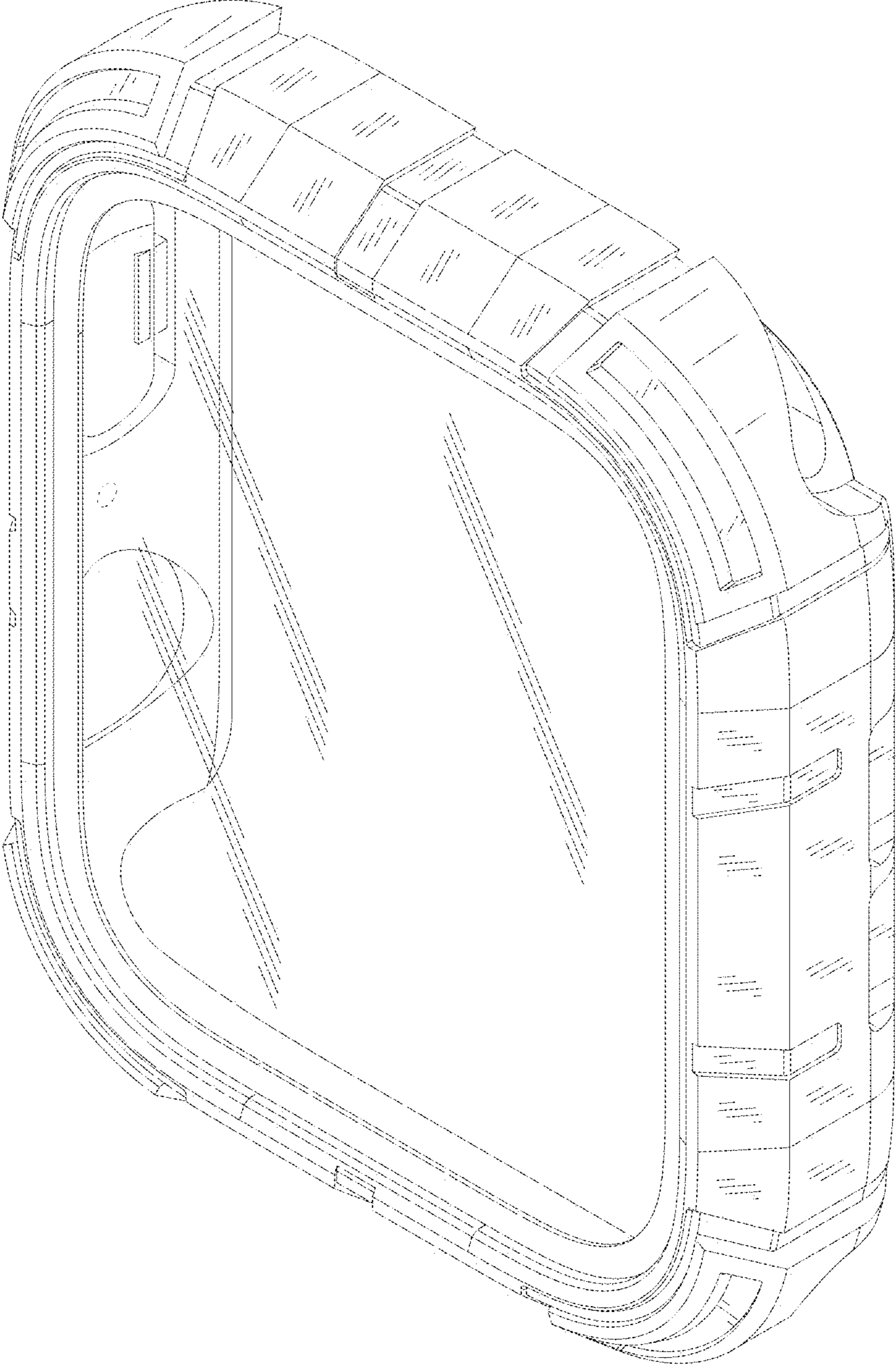

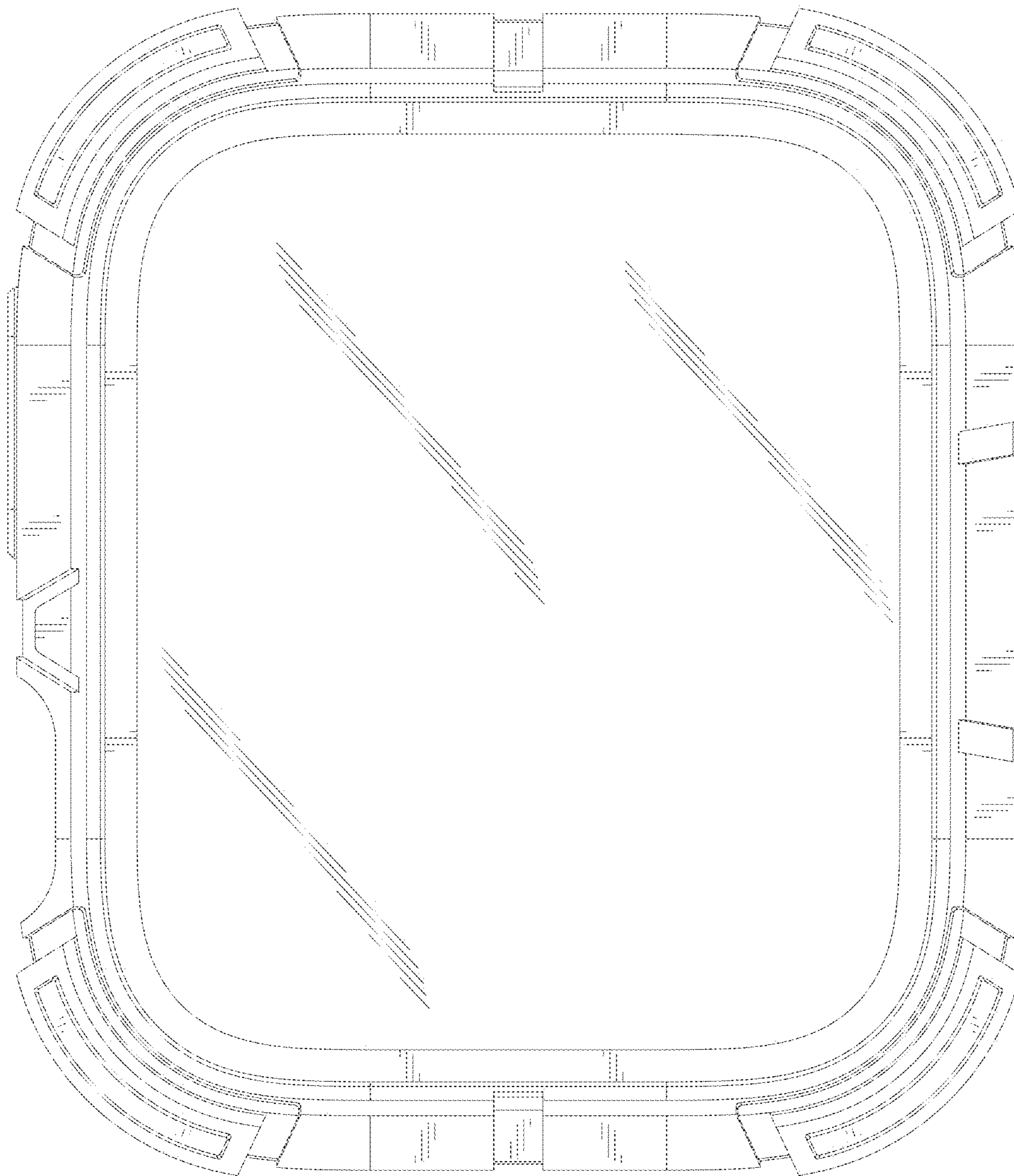

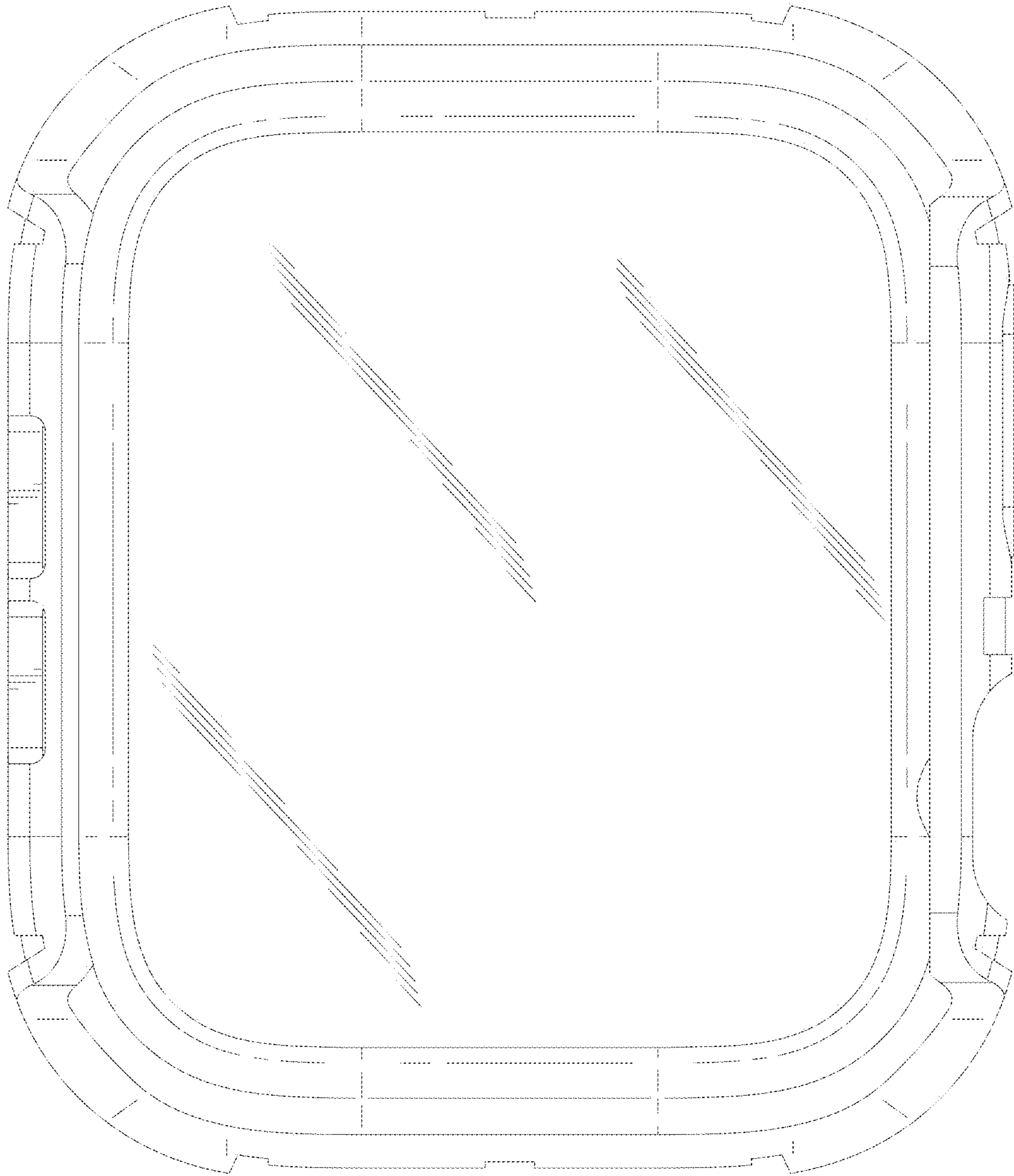

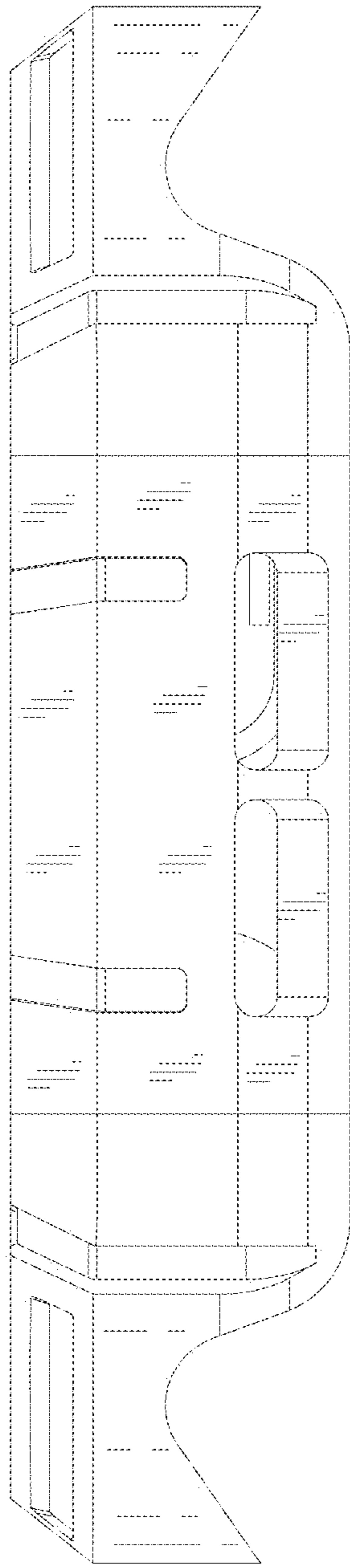

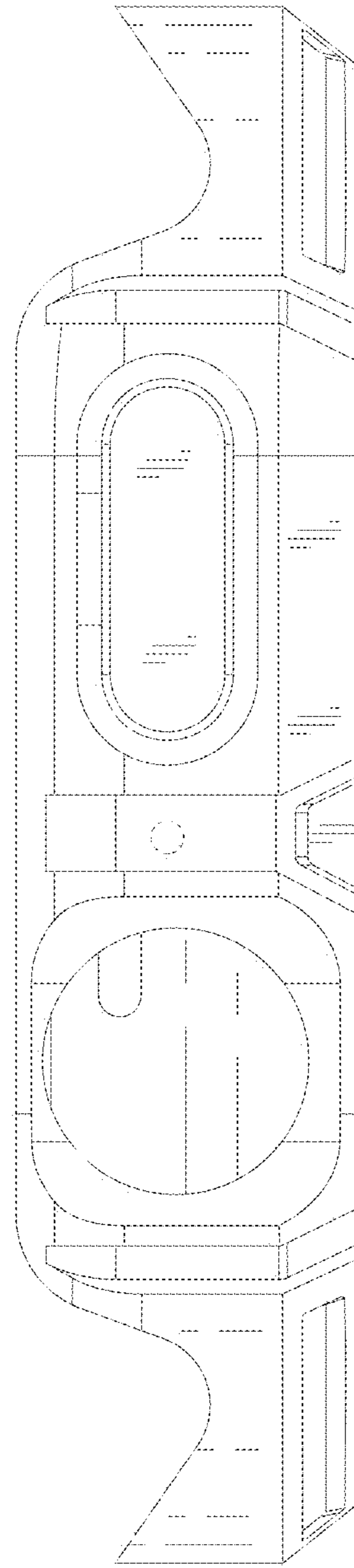

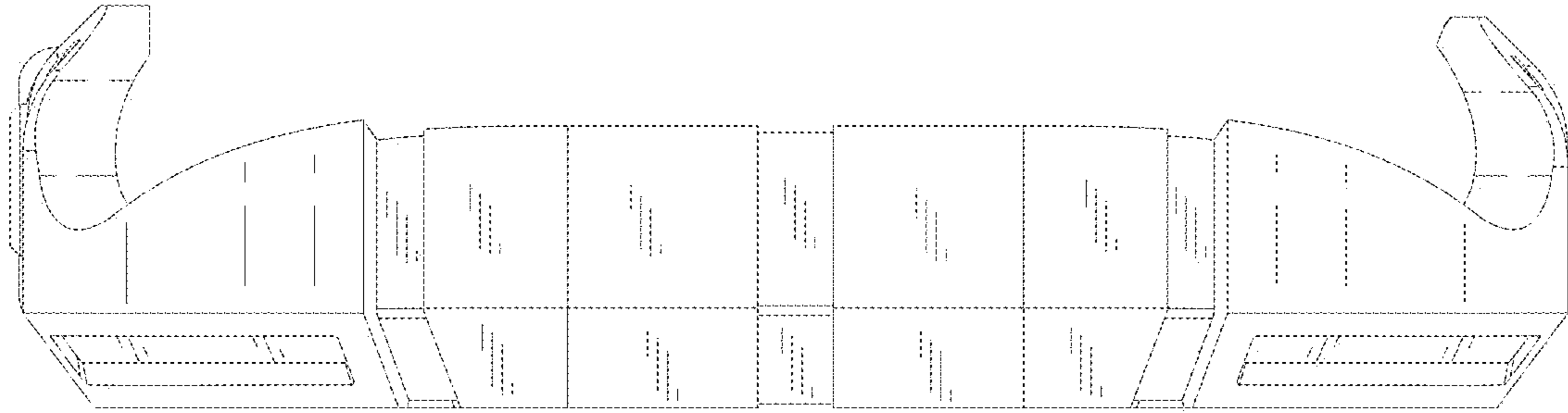

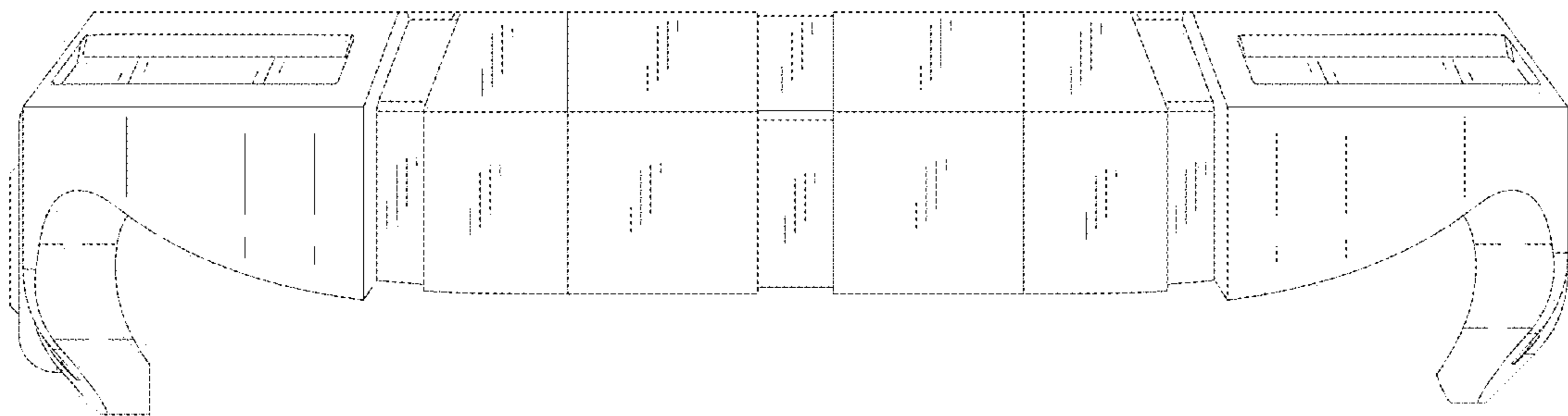
