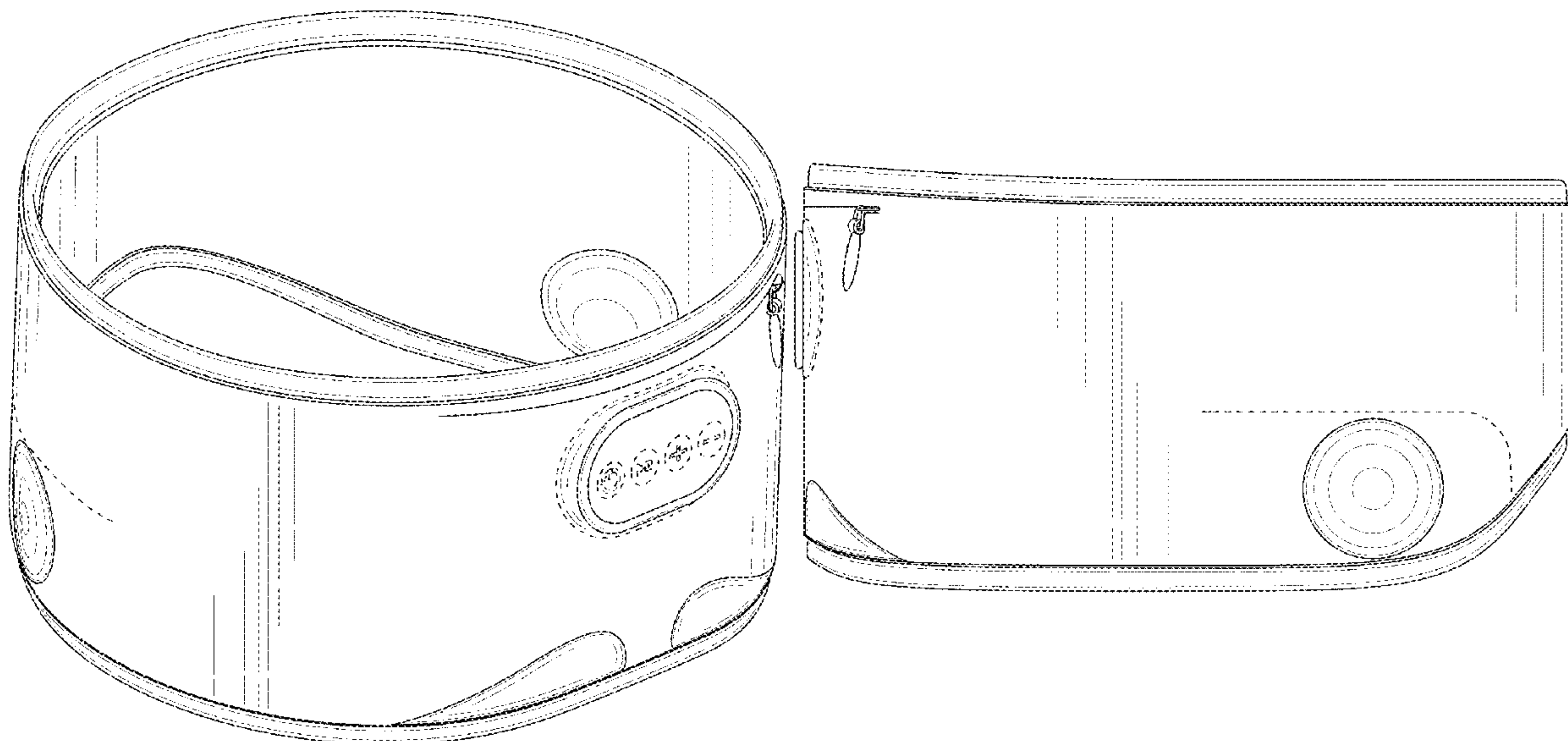
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a wireless music headband showing my new design according to a first embodiment; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a top plan view thereof. The broken lines depict portions of the wireless music headband and form no part of the claimed design.

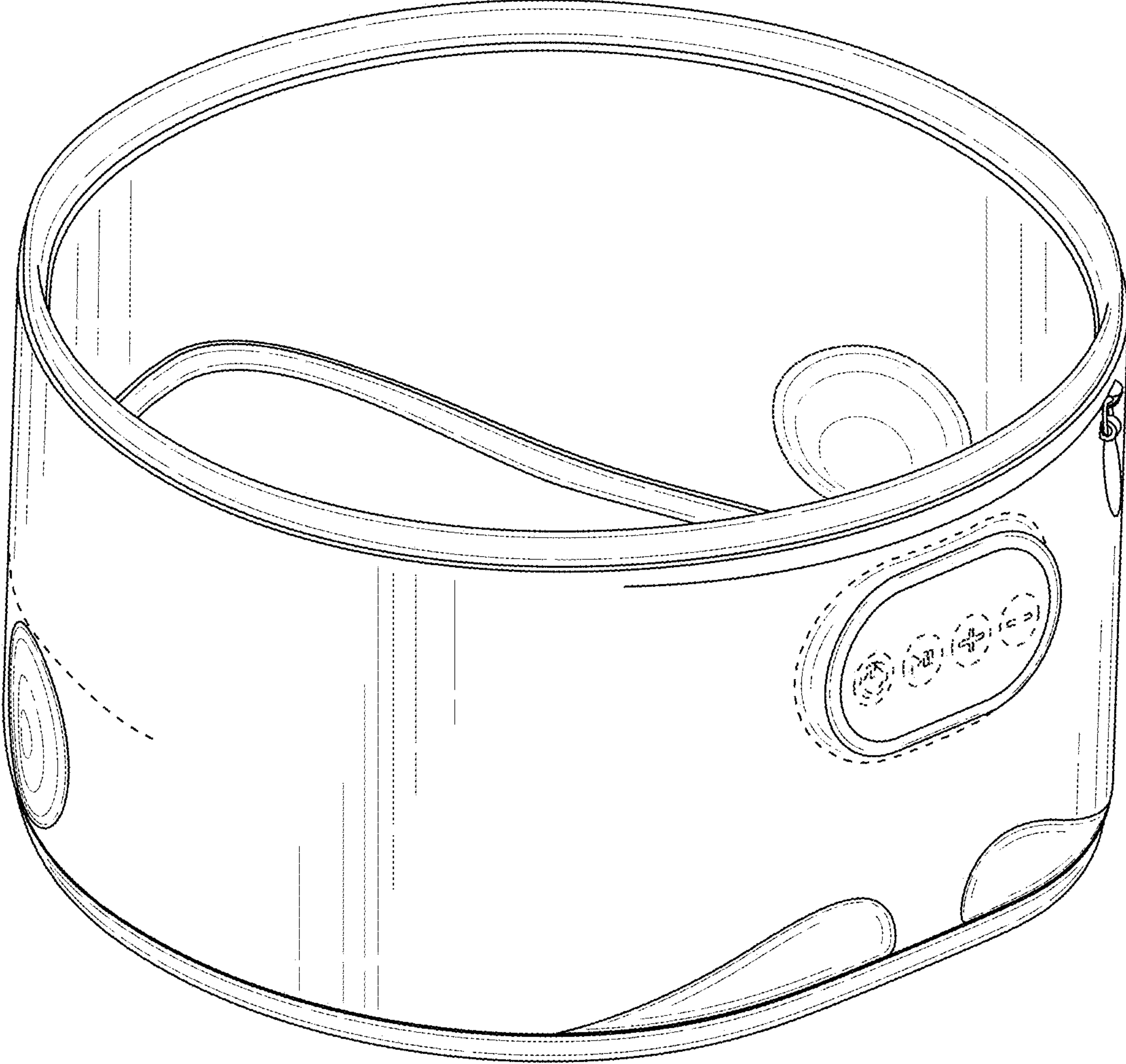

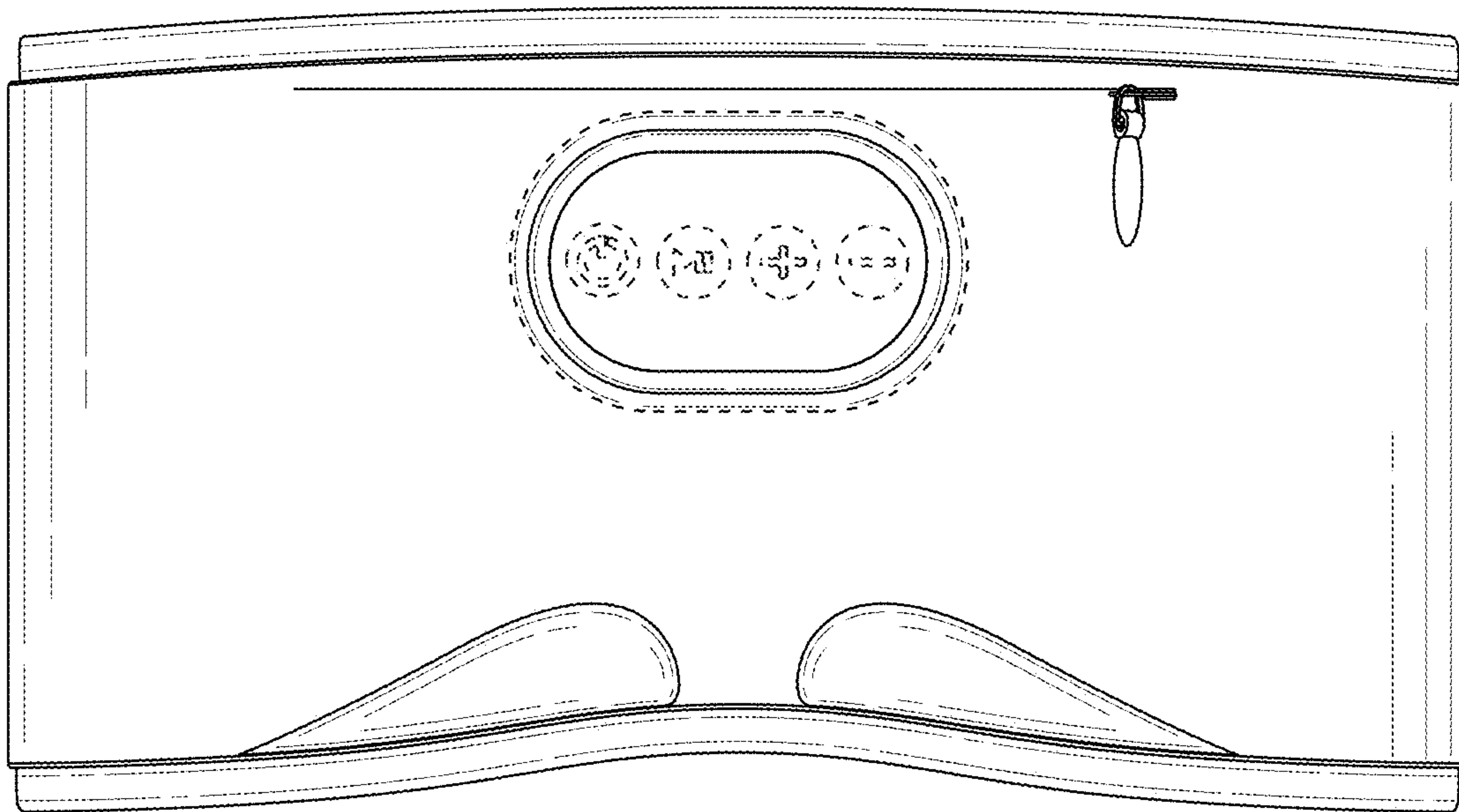

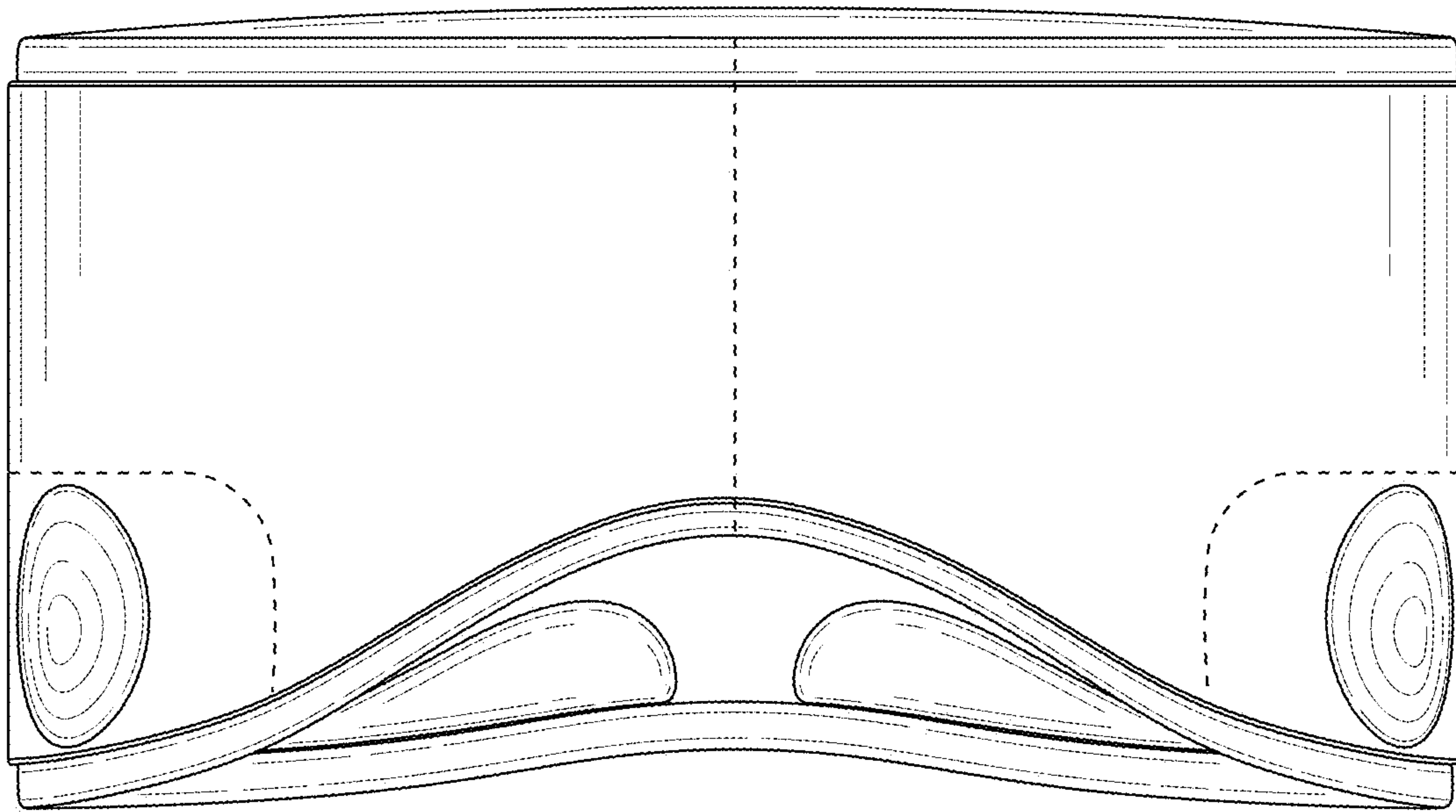

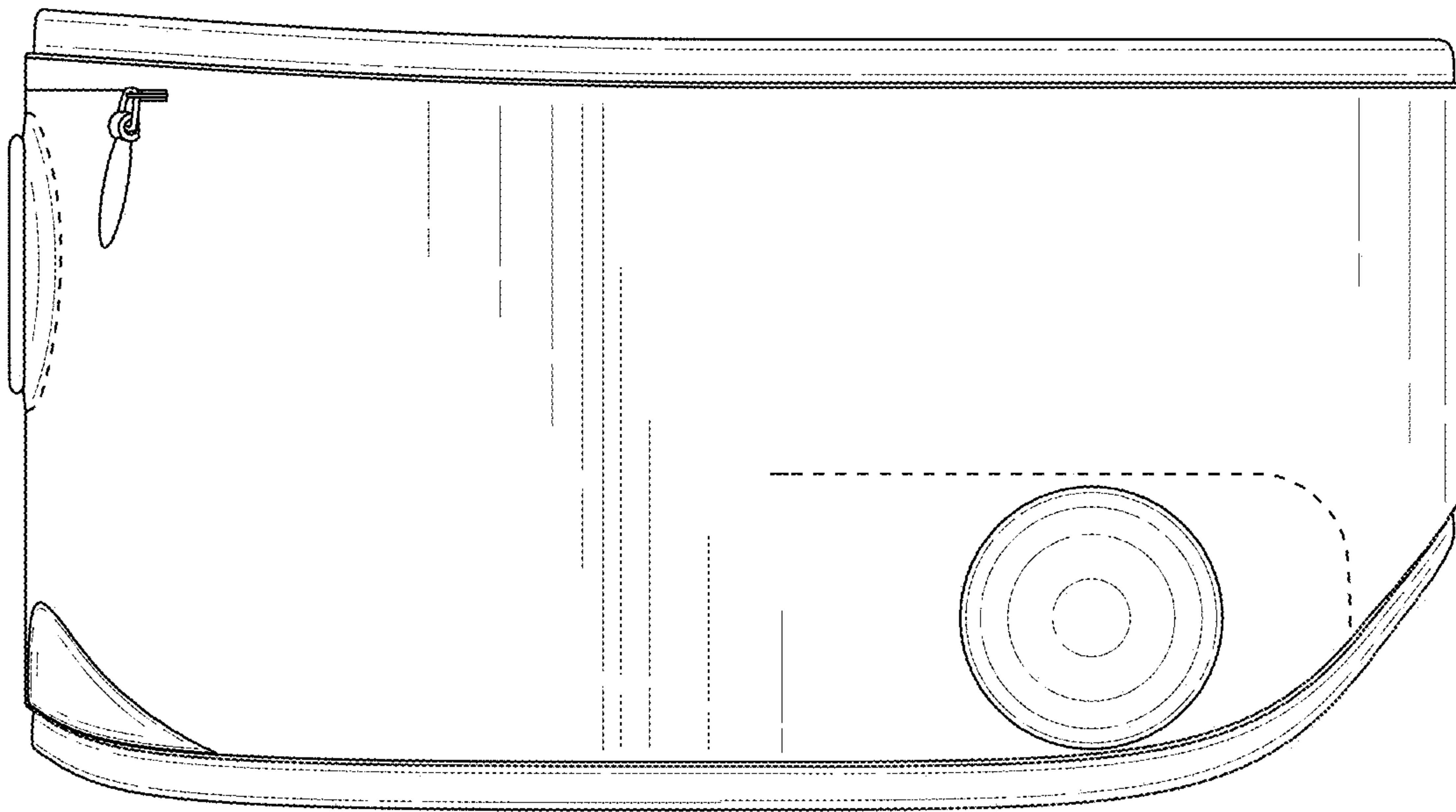

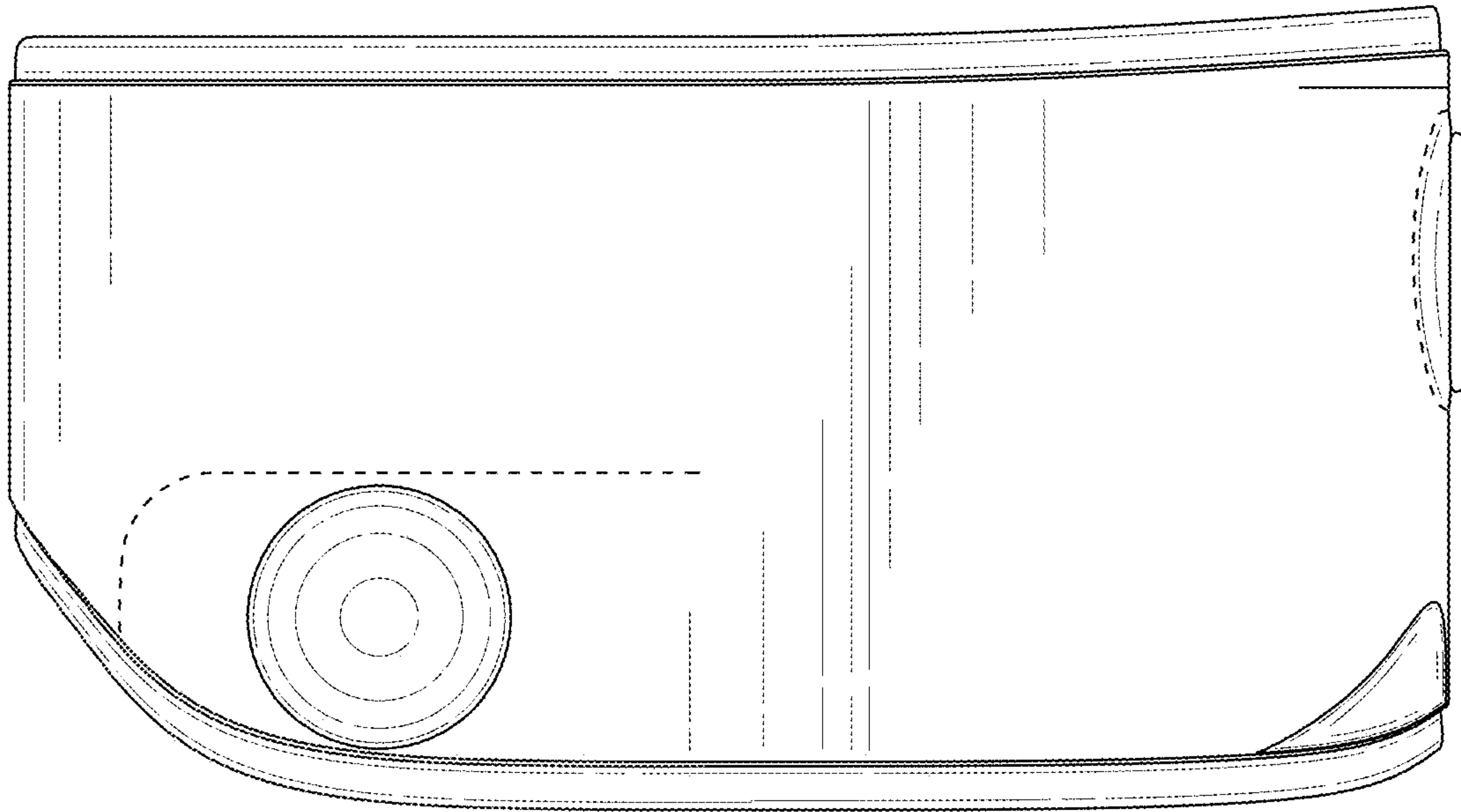

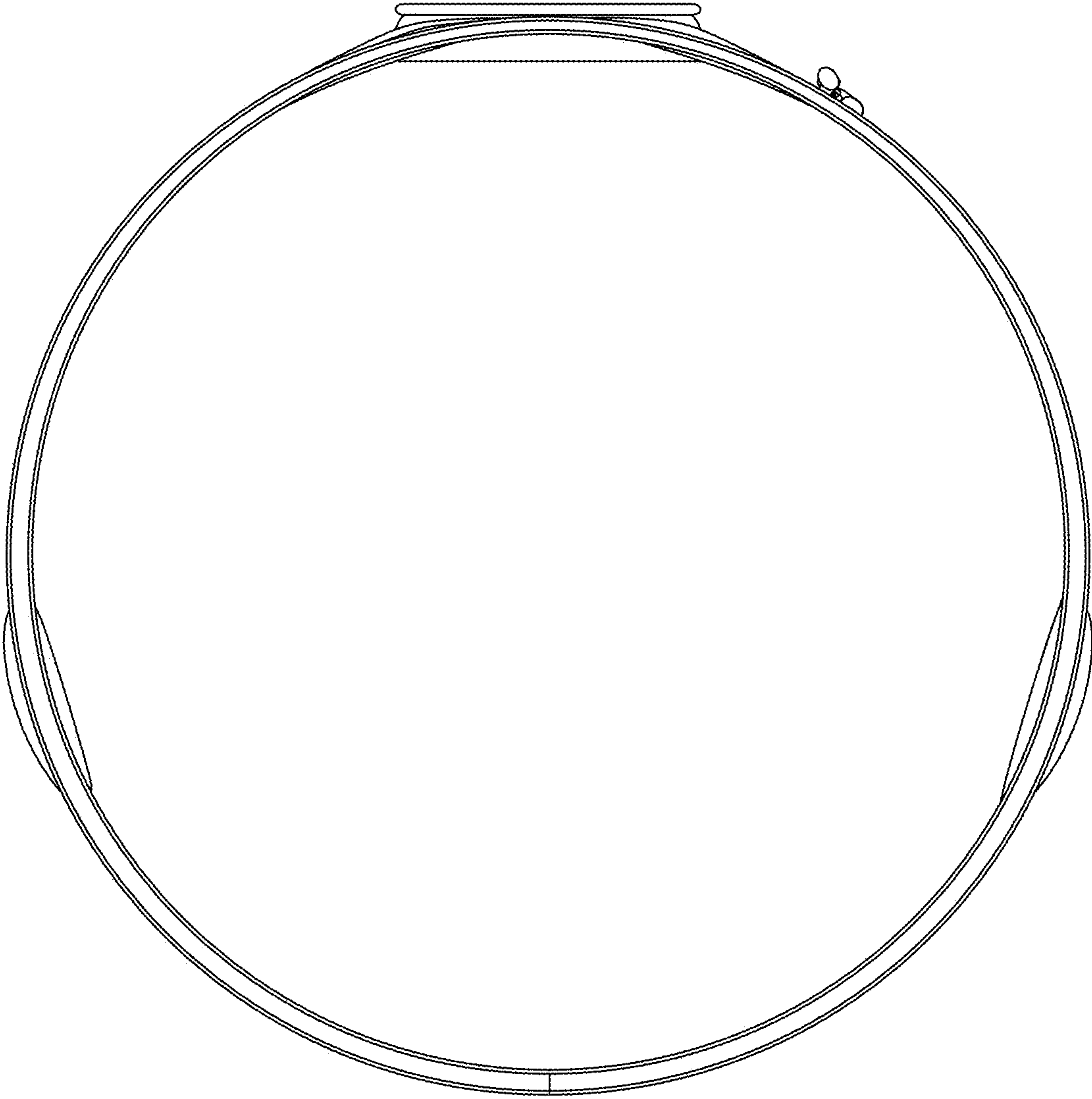

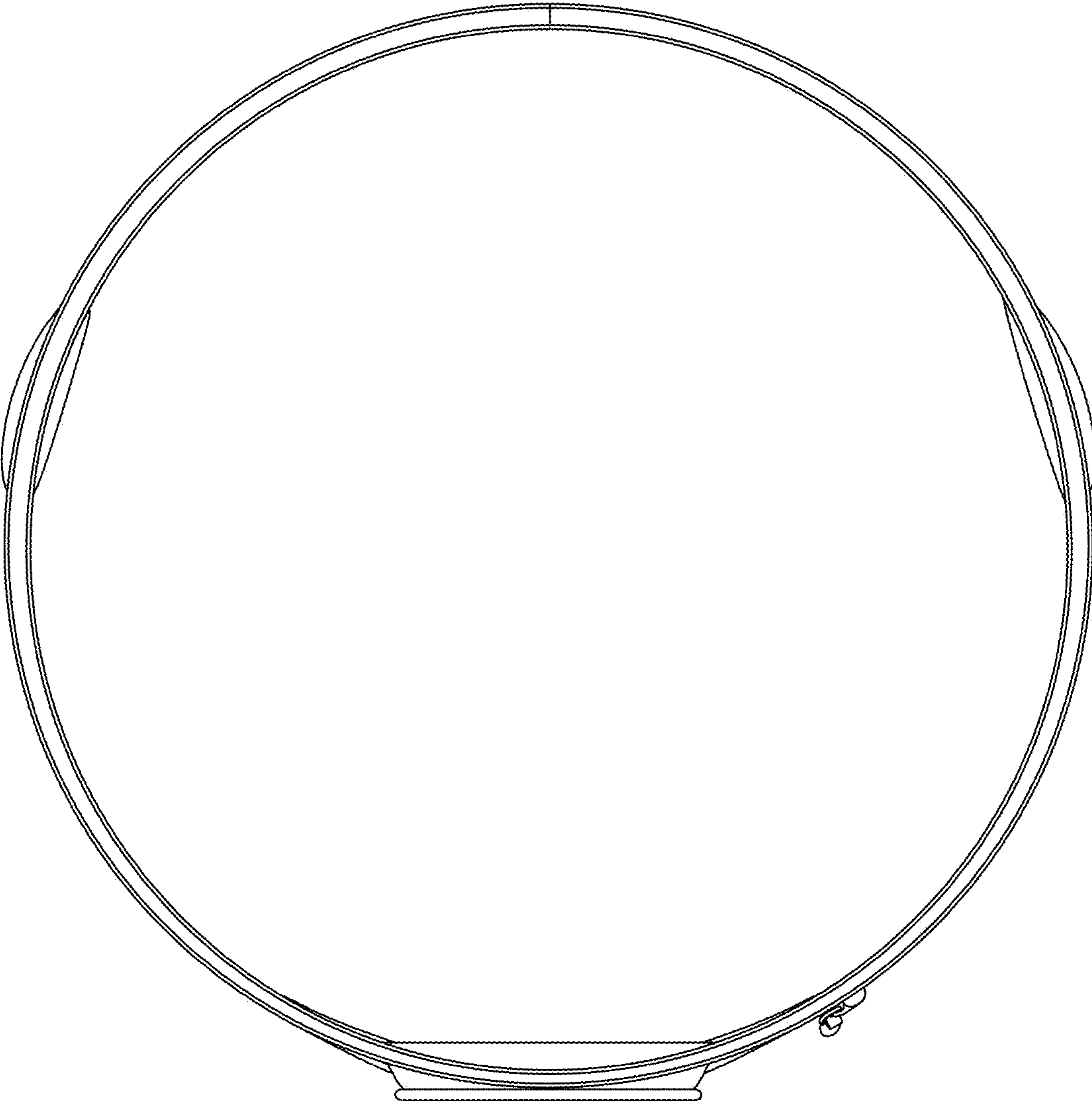
