(57) **CLAIM**

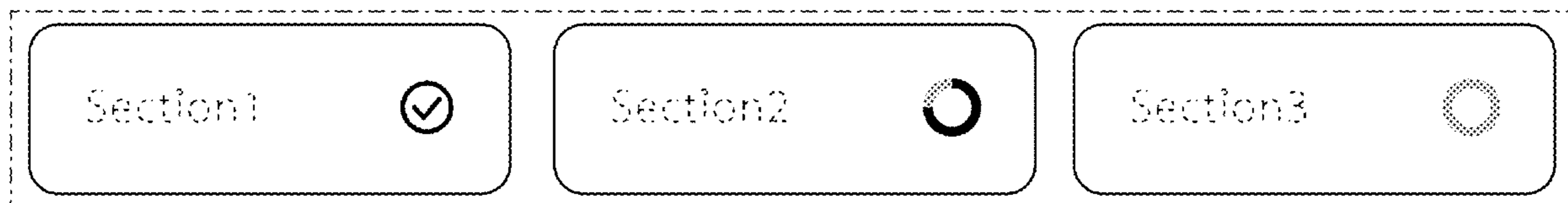
The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image for a display screen with graphical user interface showing my new design; and, FIG. 2 is an enlarged view of a portion thereof.

The peripheral dash-dot-dash broken lines illustrate a display screen or portion thereof and form no part of the claimed design. The dash-dot-dash broken lines in FIG. 1 within the peripheral dash-dot-dash broken lines illustrate the perimeter of a portion of the display screen with graphical user interface that is shown enlarged and form no part of the claimed design. The dashed broken lines within the peripheral dash-dot-dash broken lines illustrate portions of the display screen with graphical user interface, which form no part of the claimed design.

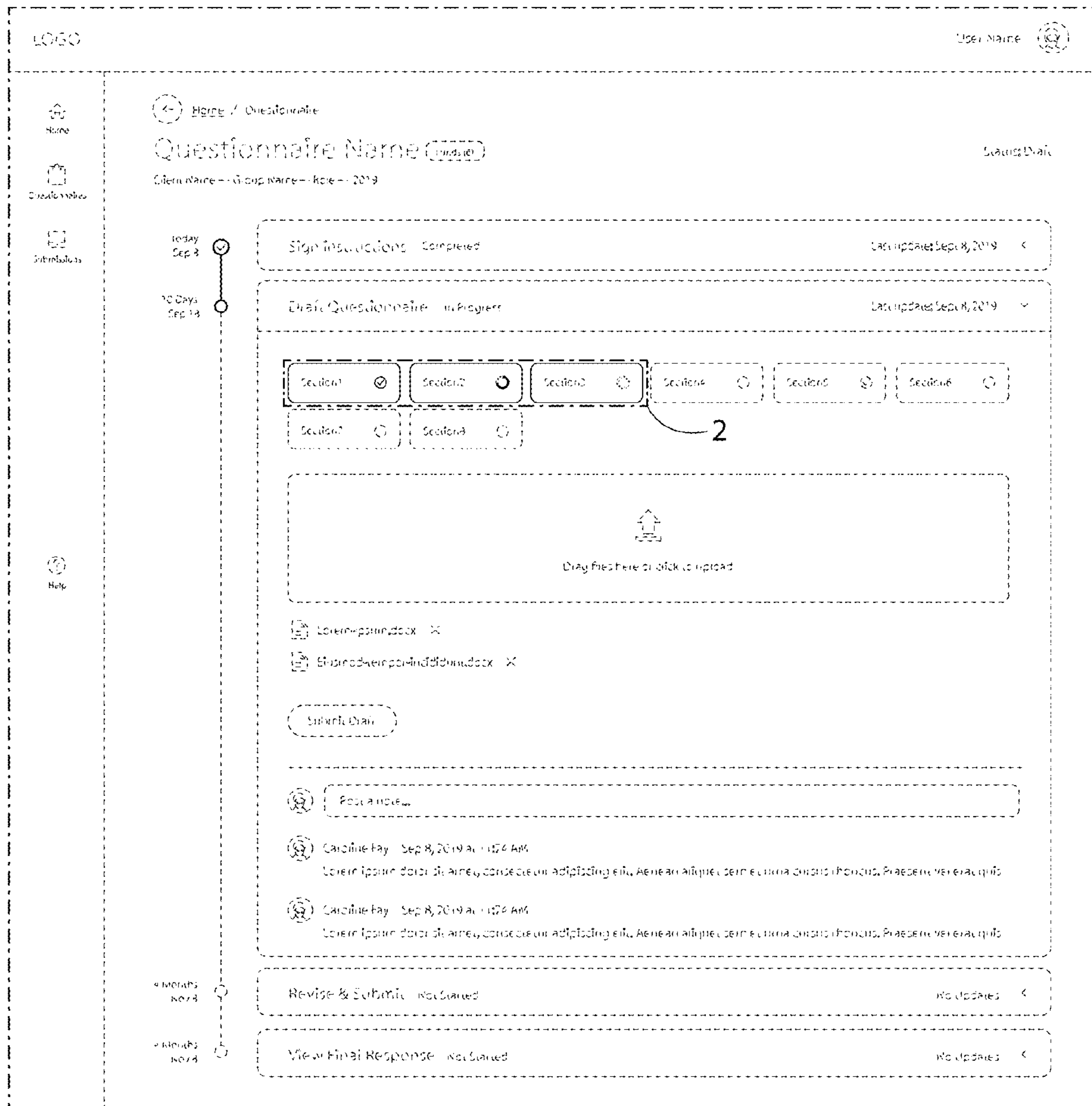

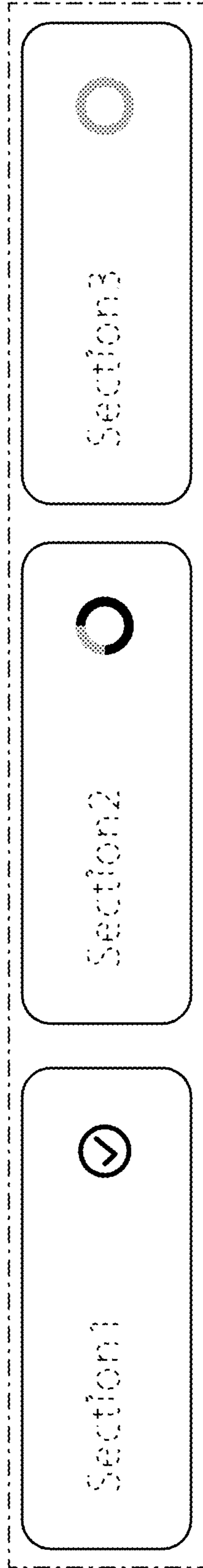
