DESCRIPTION

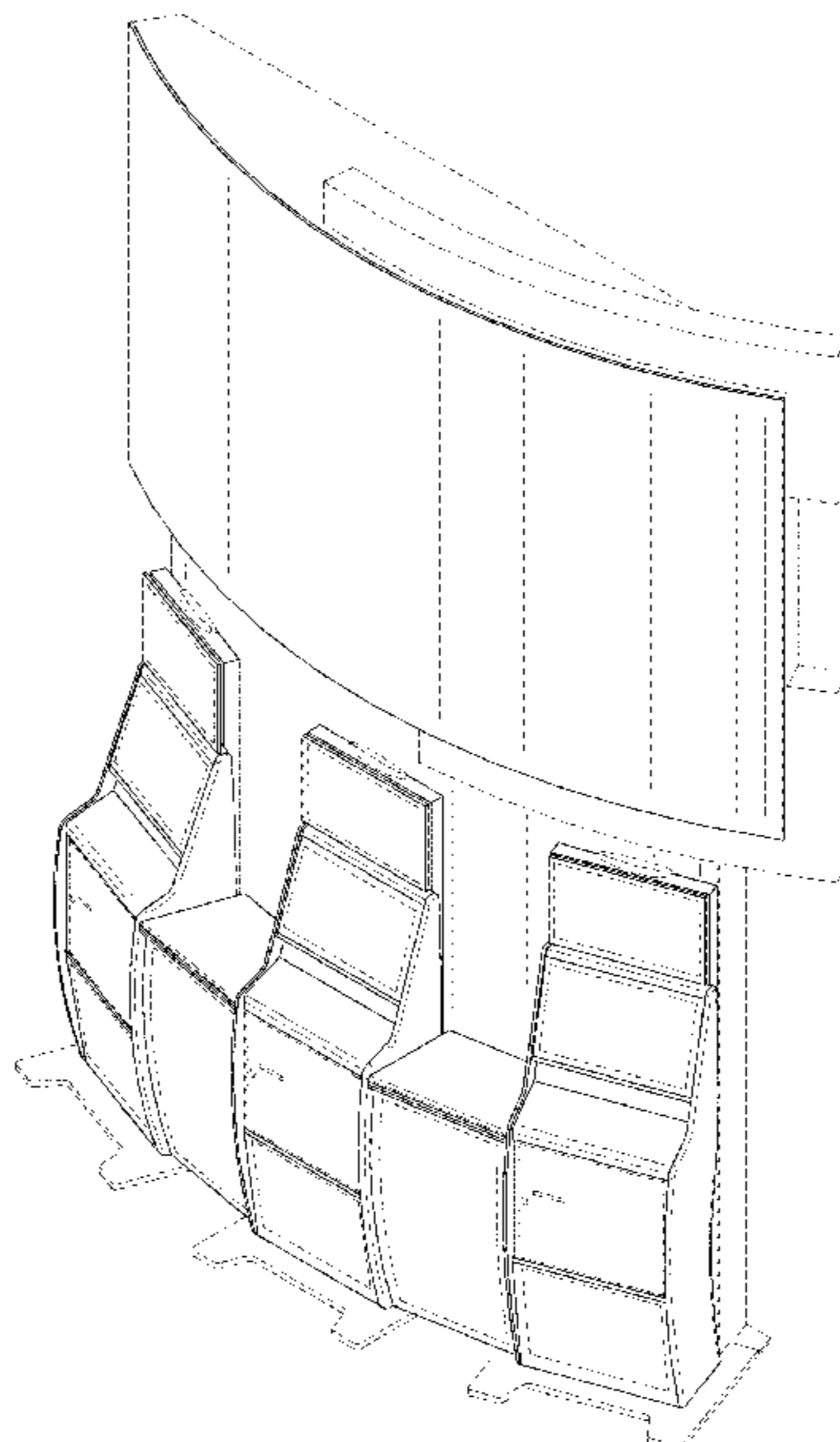
FIG. 1 is at front perspective view of a gaming system showing our new design.

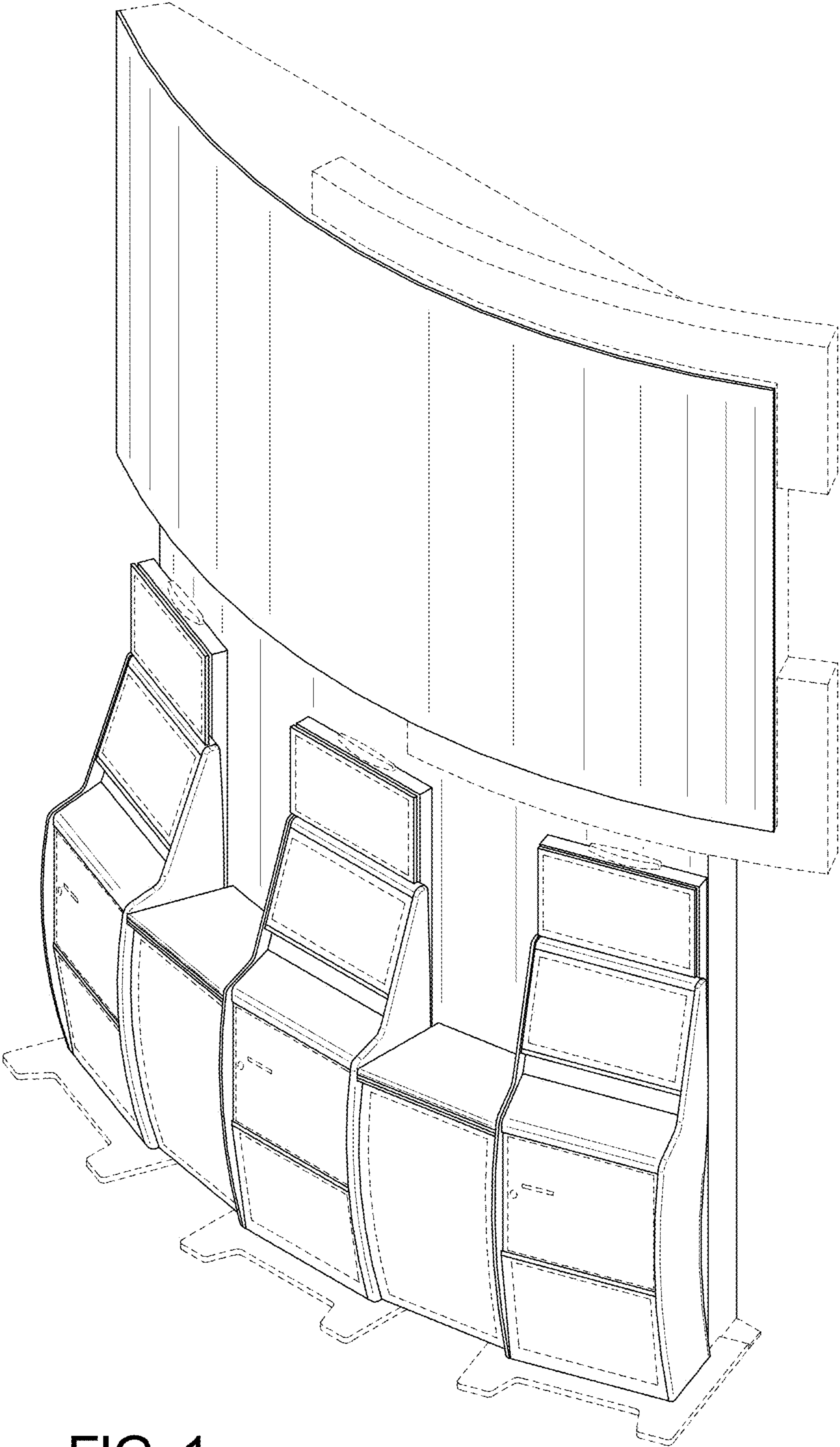

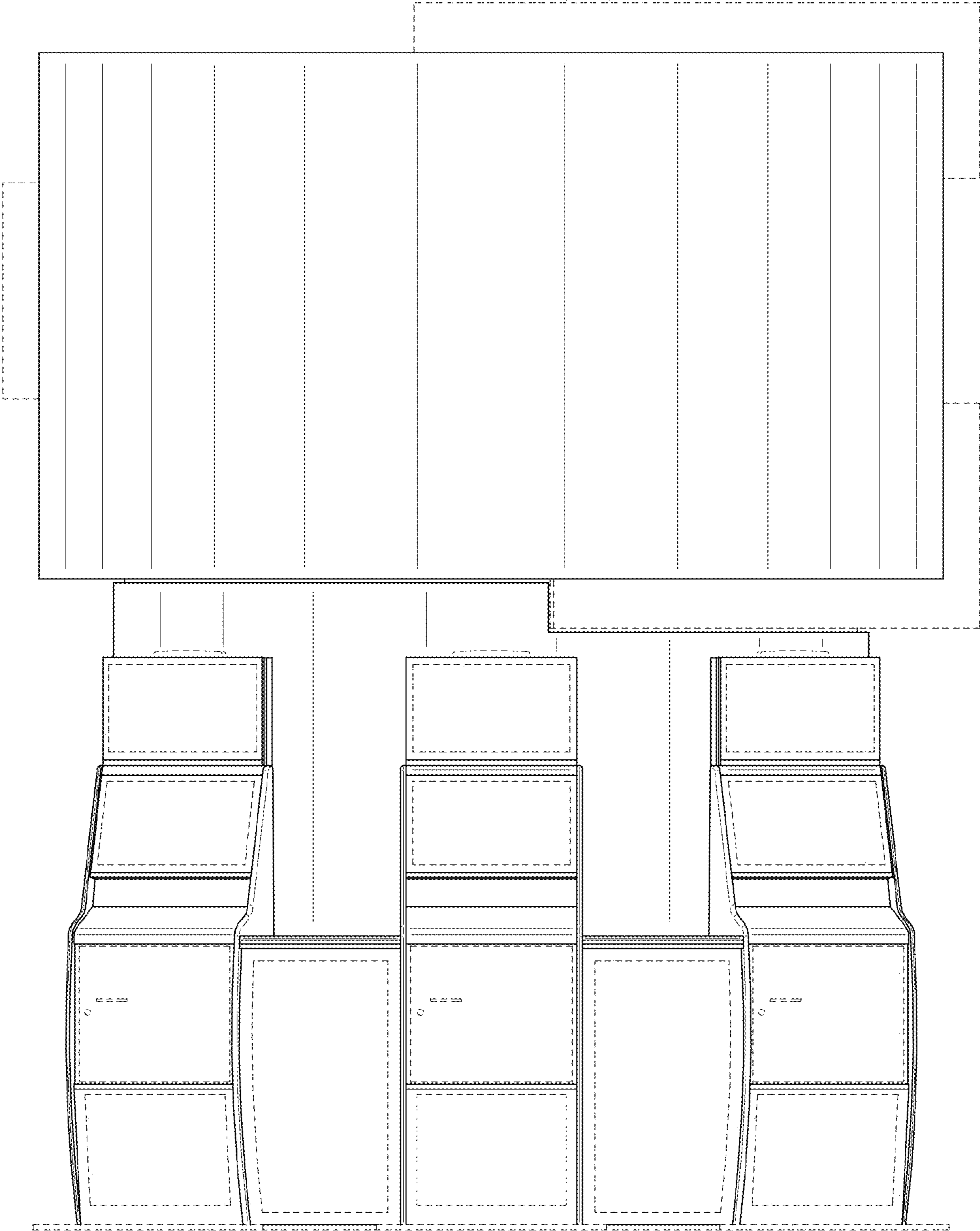

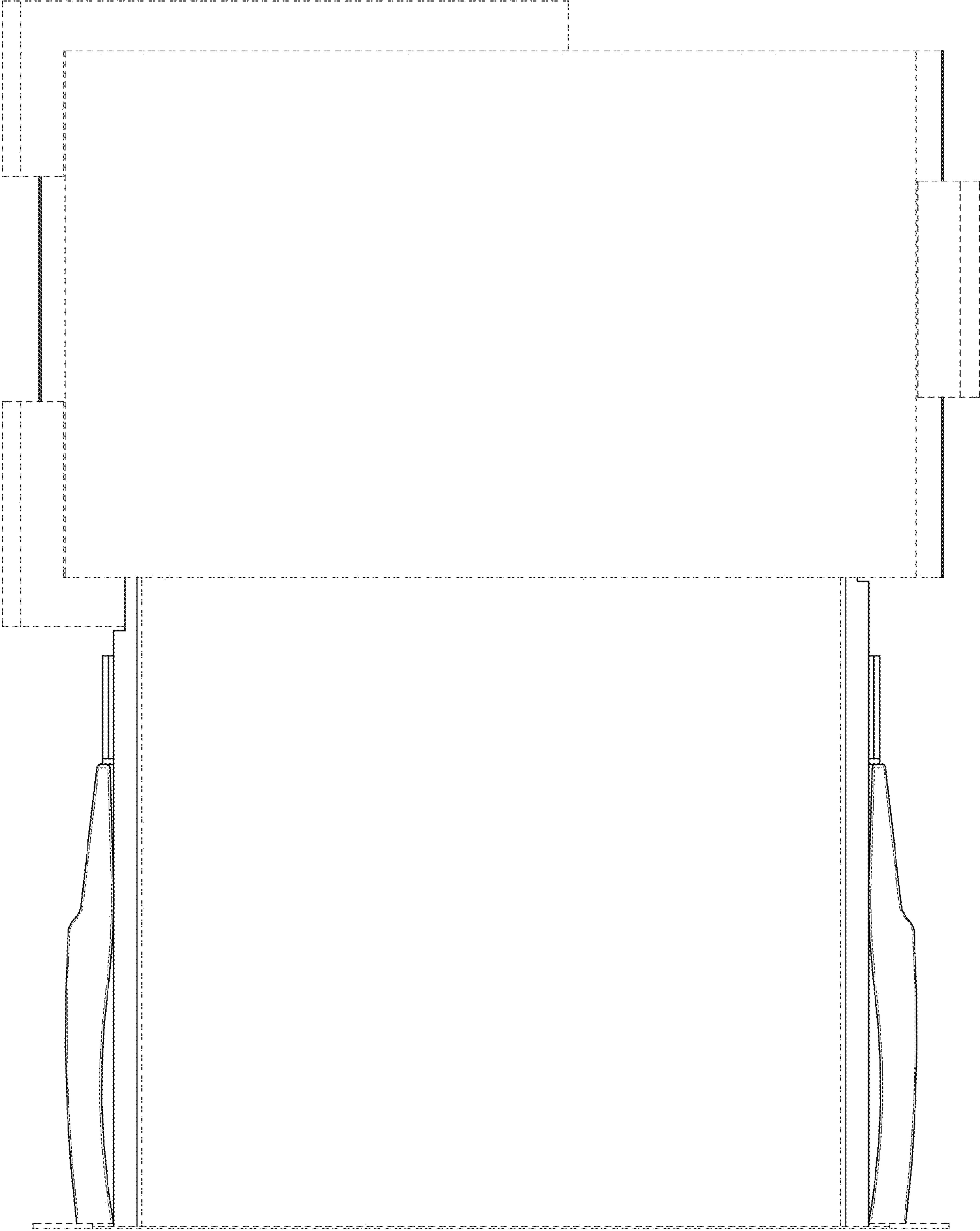

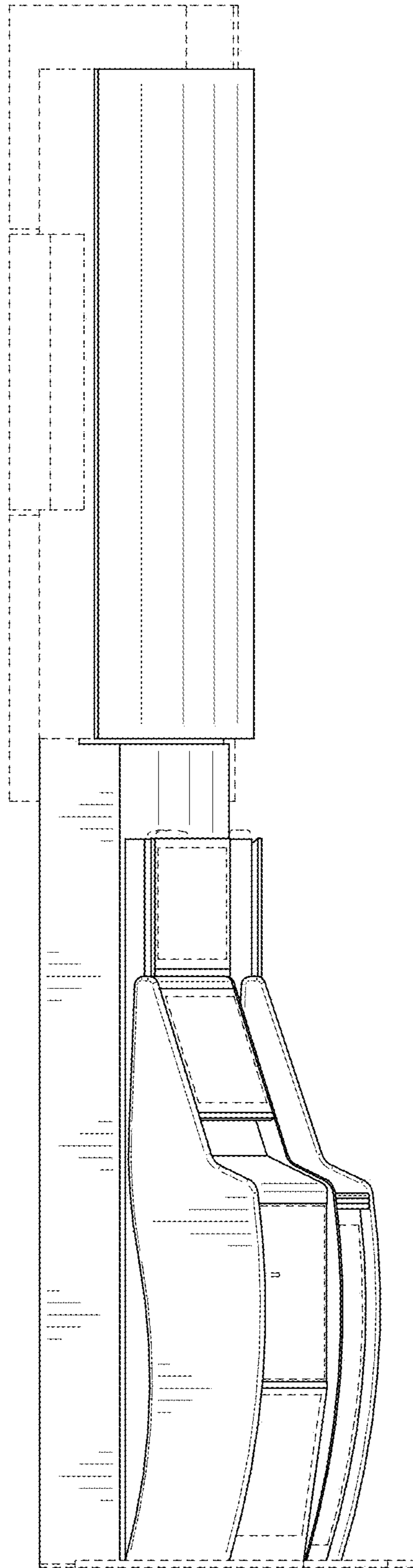

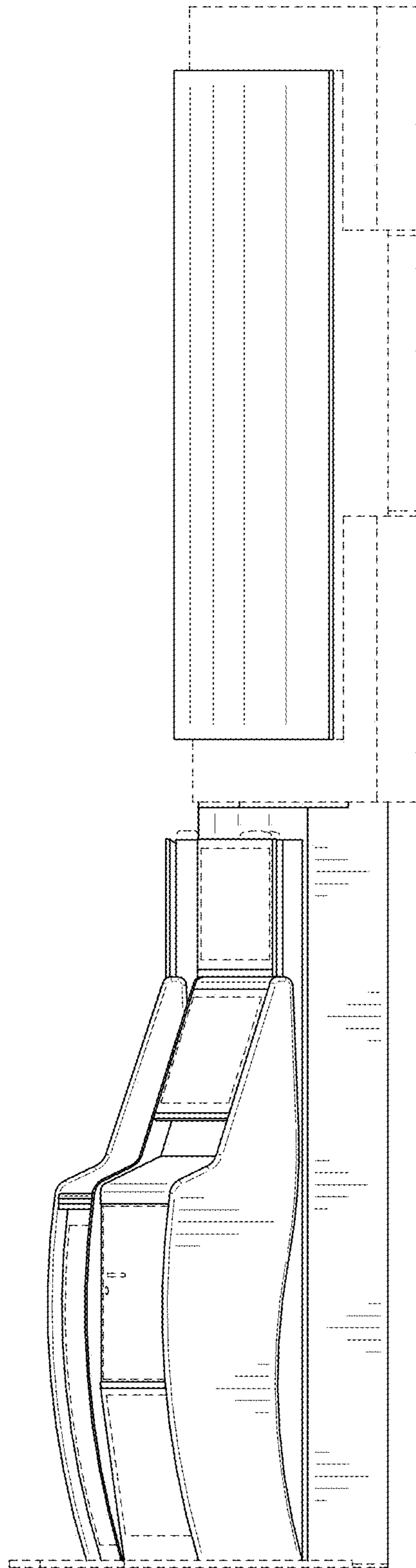

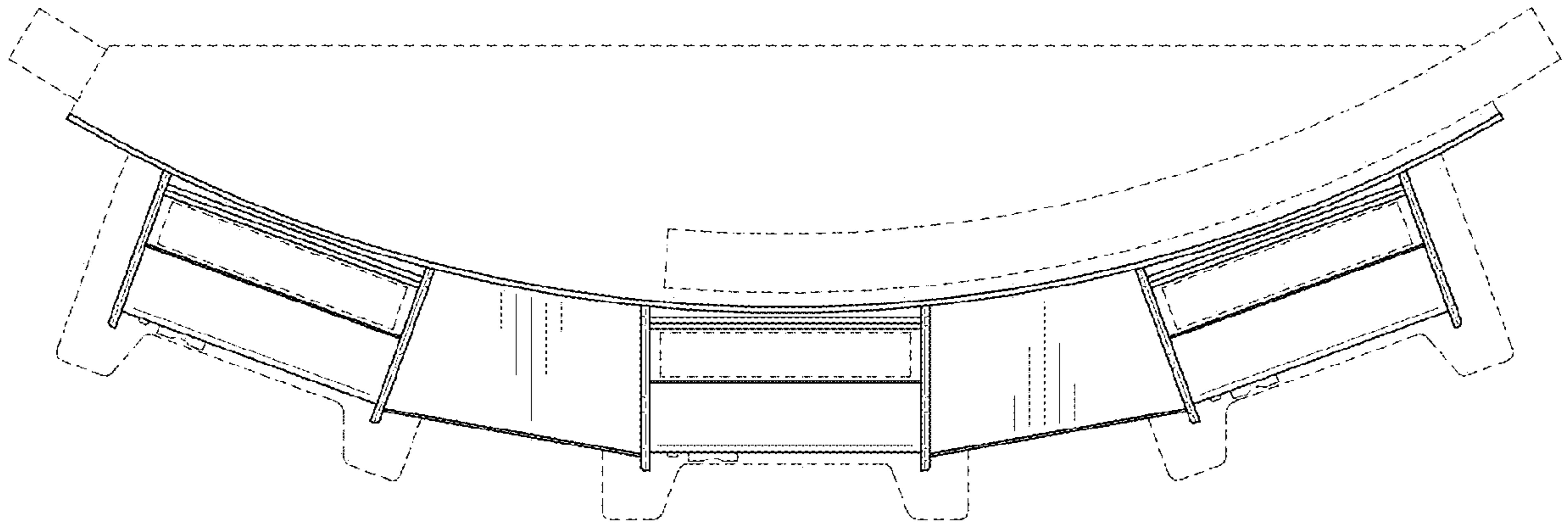

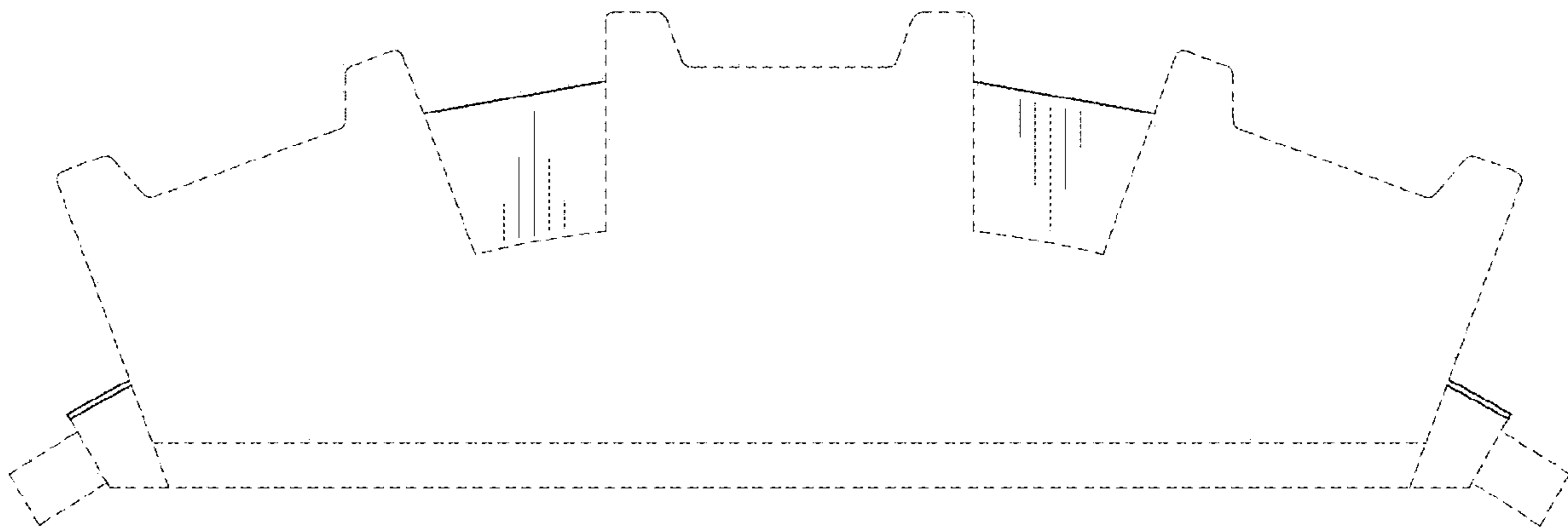
