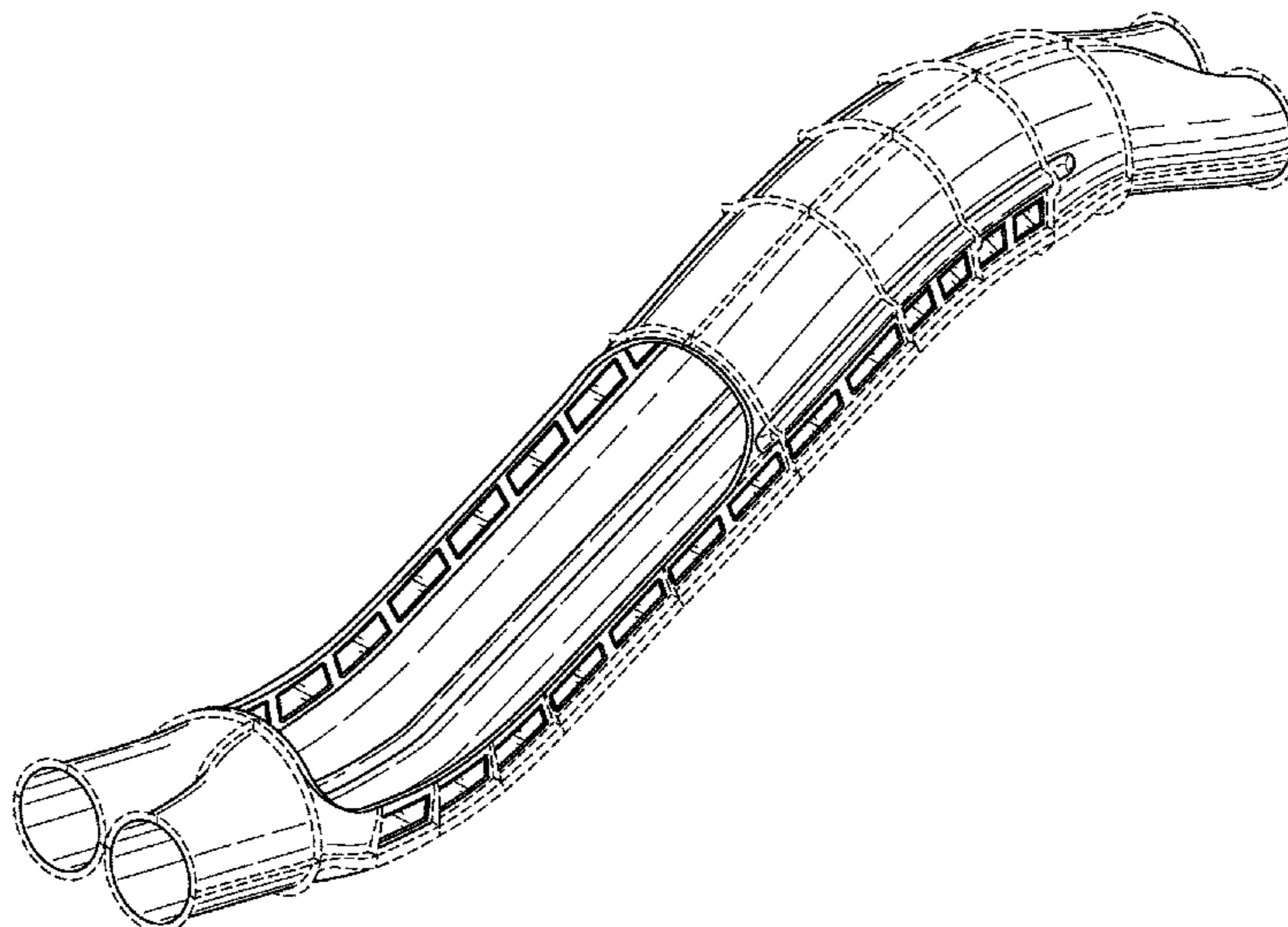
The ornamental design of a water ride, as shown and described.

**DESCRIPTION**

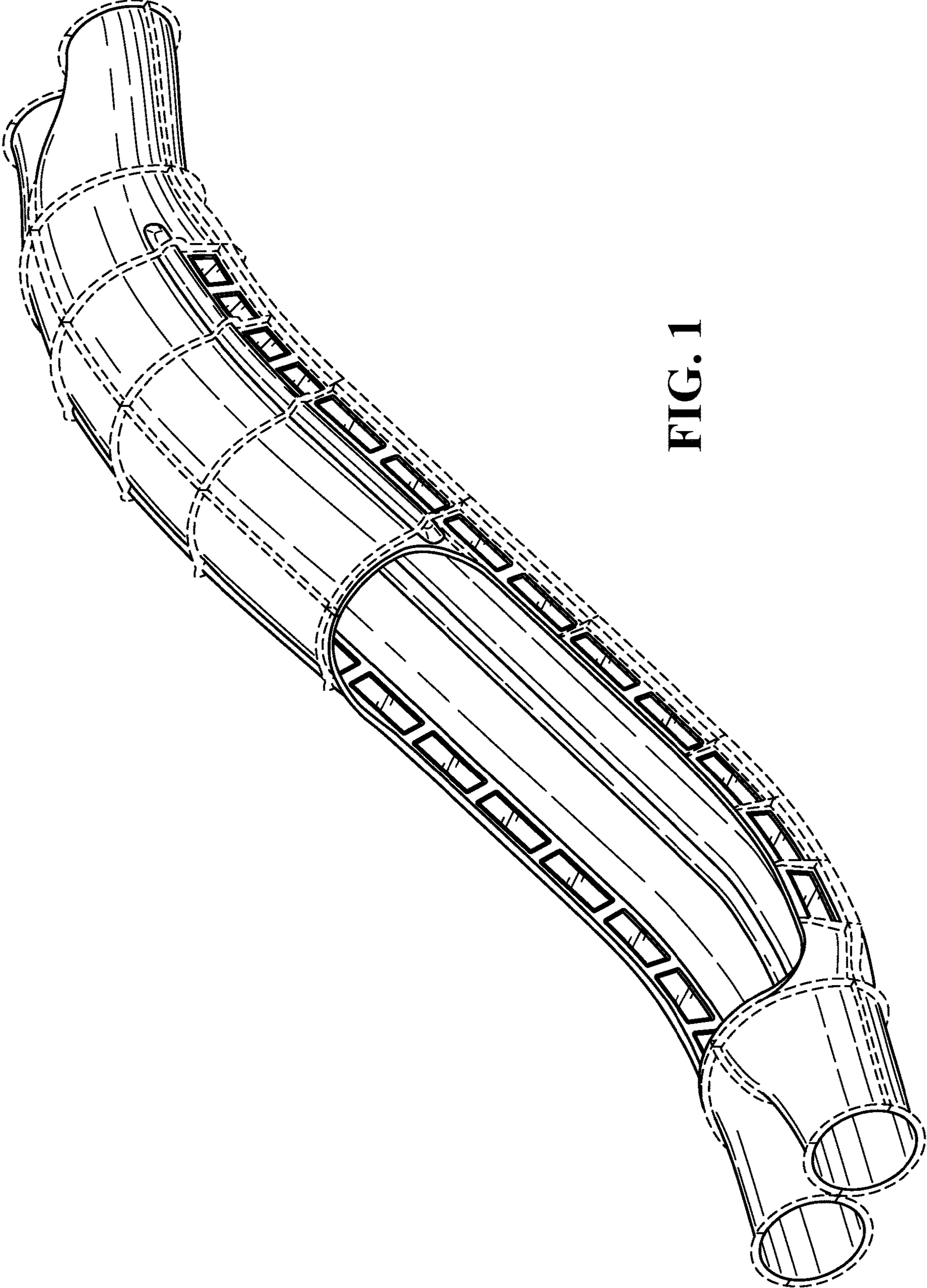

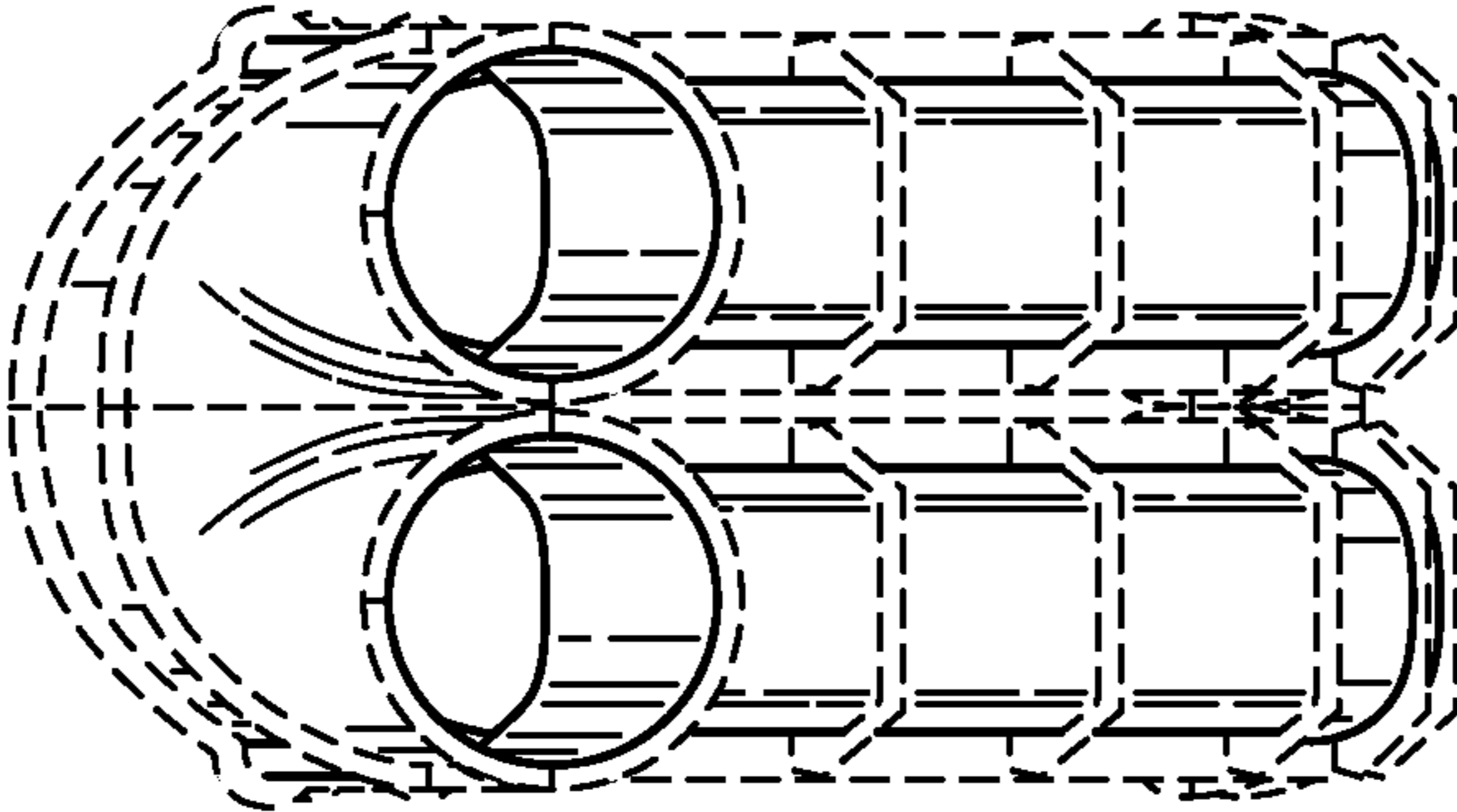

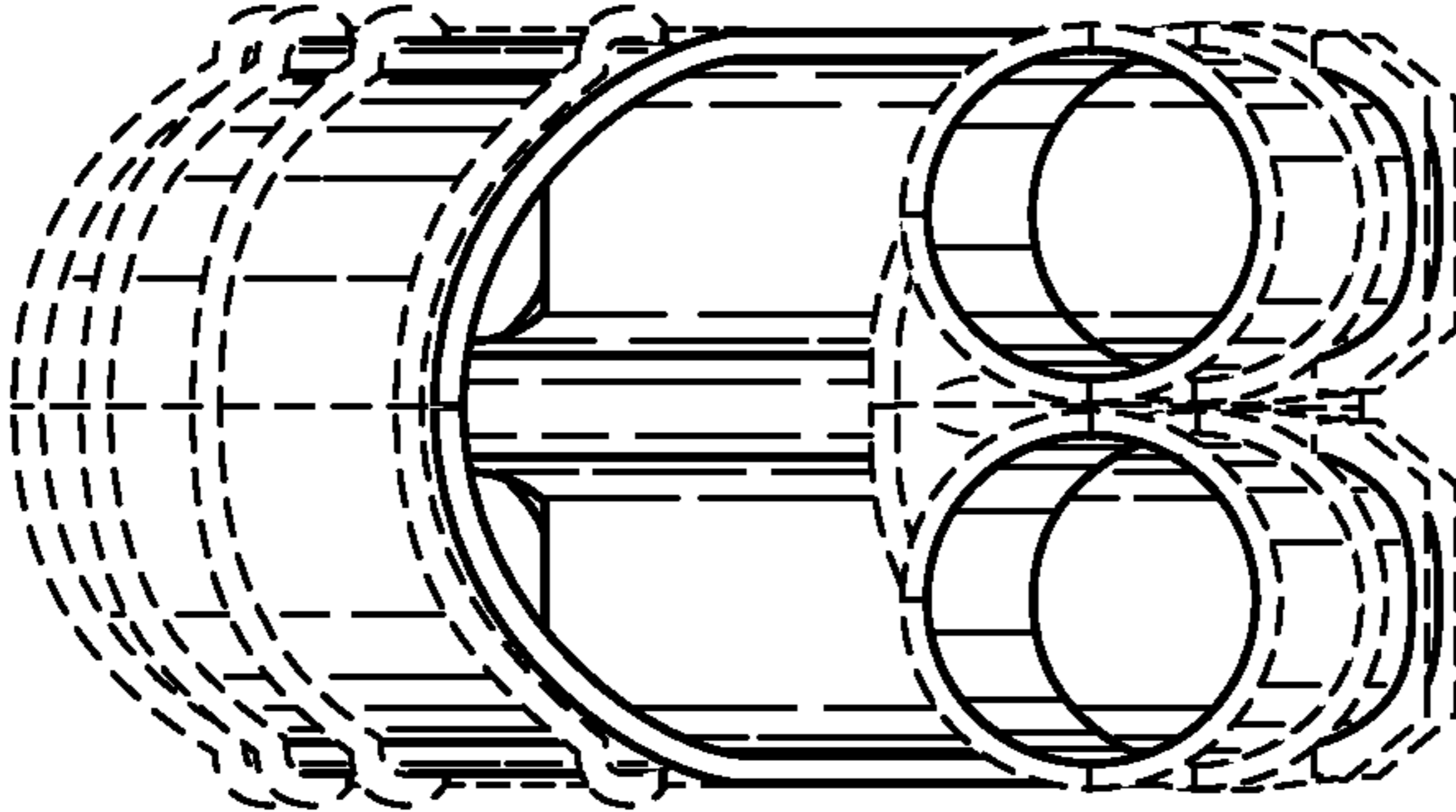

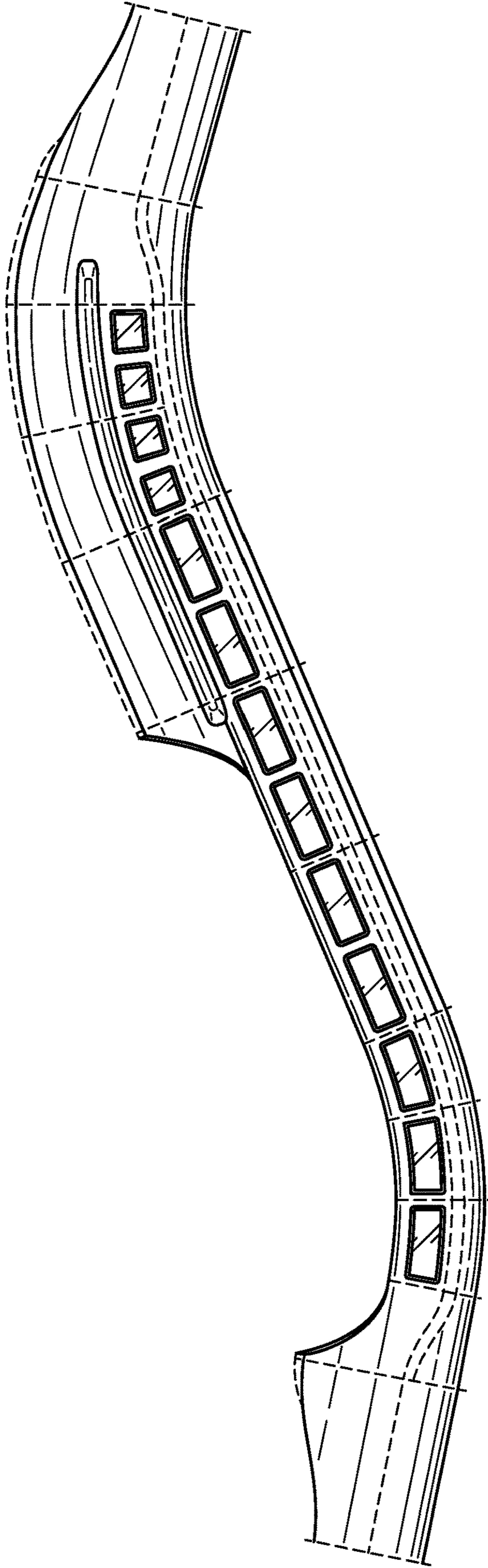

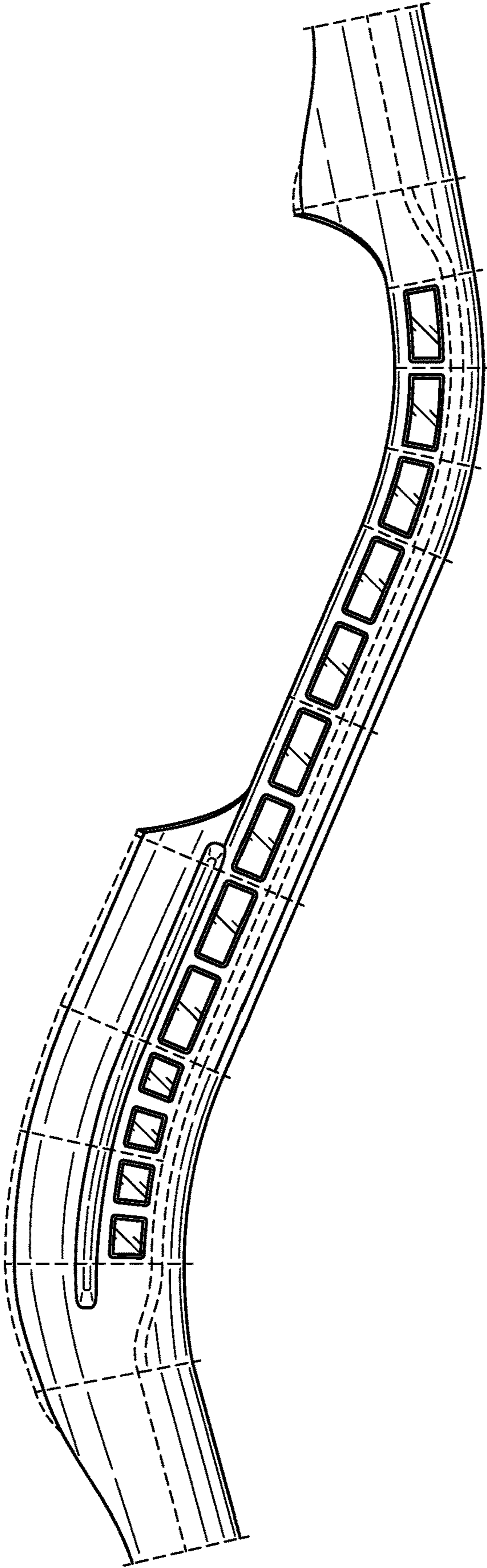

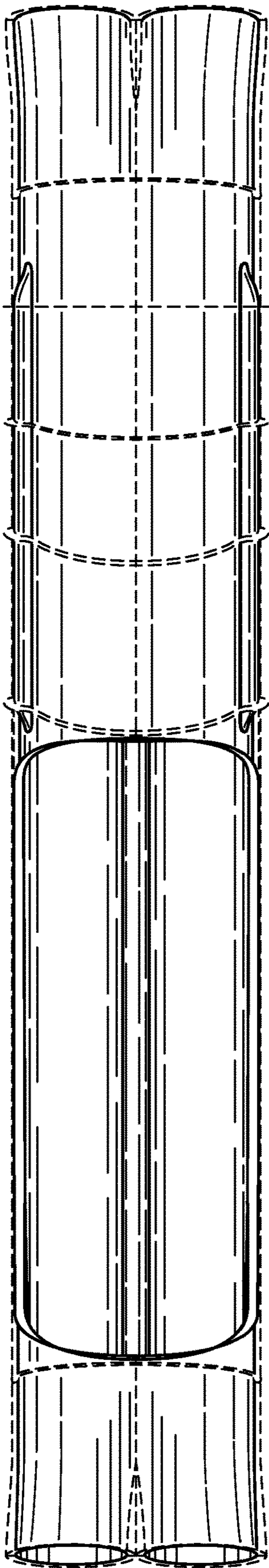

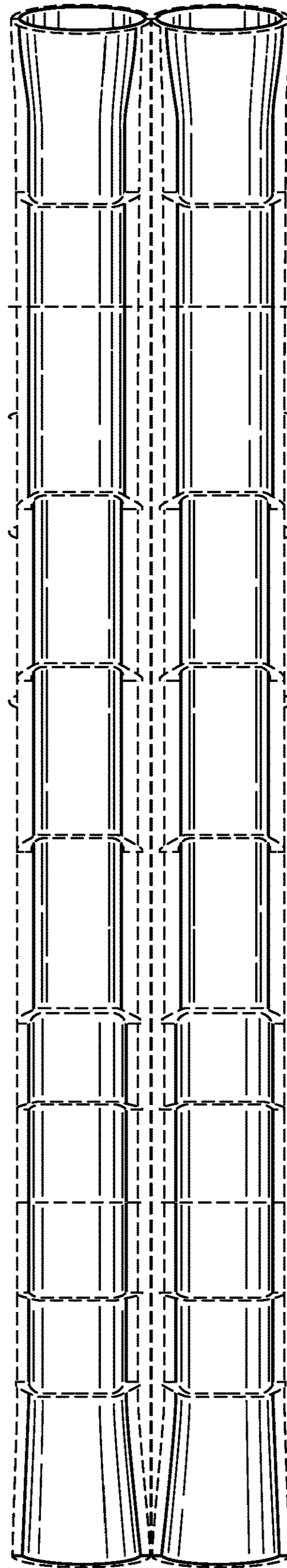

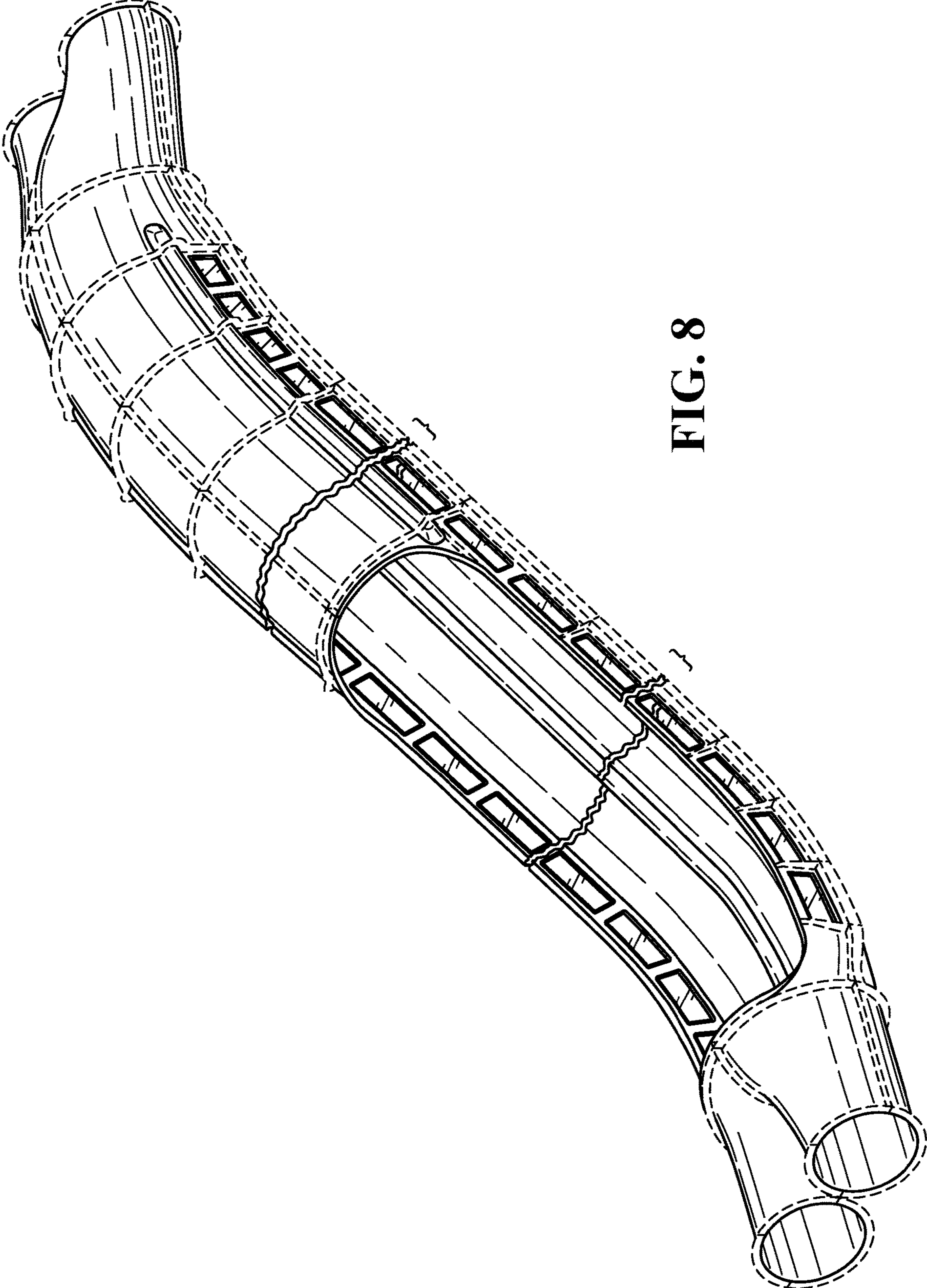

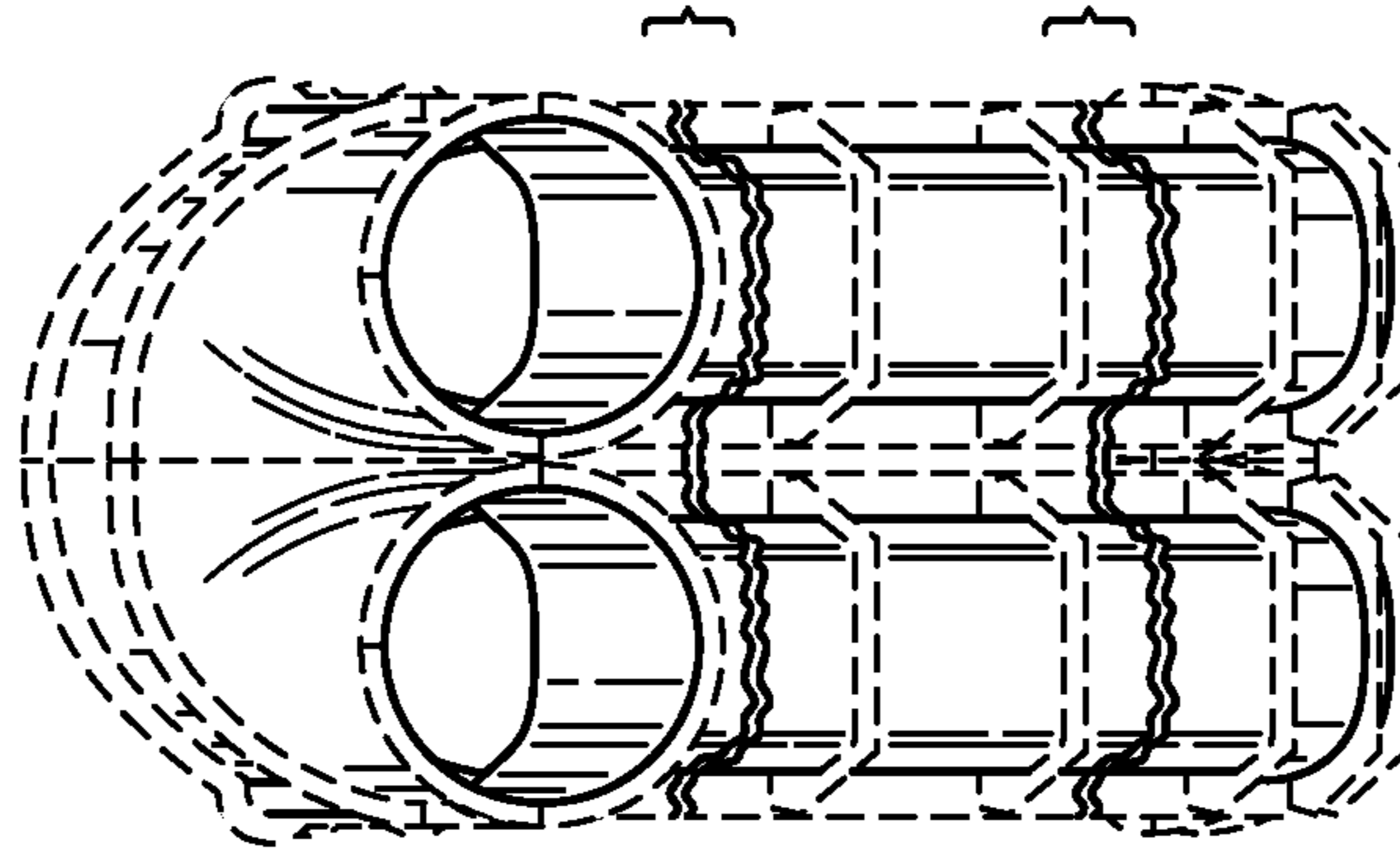

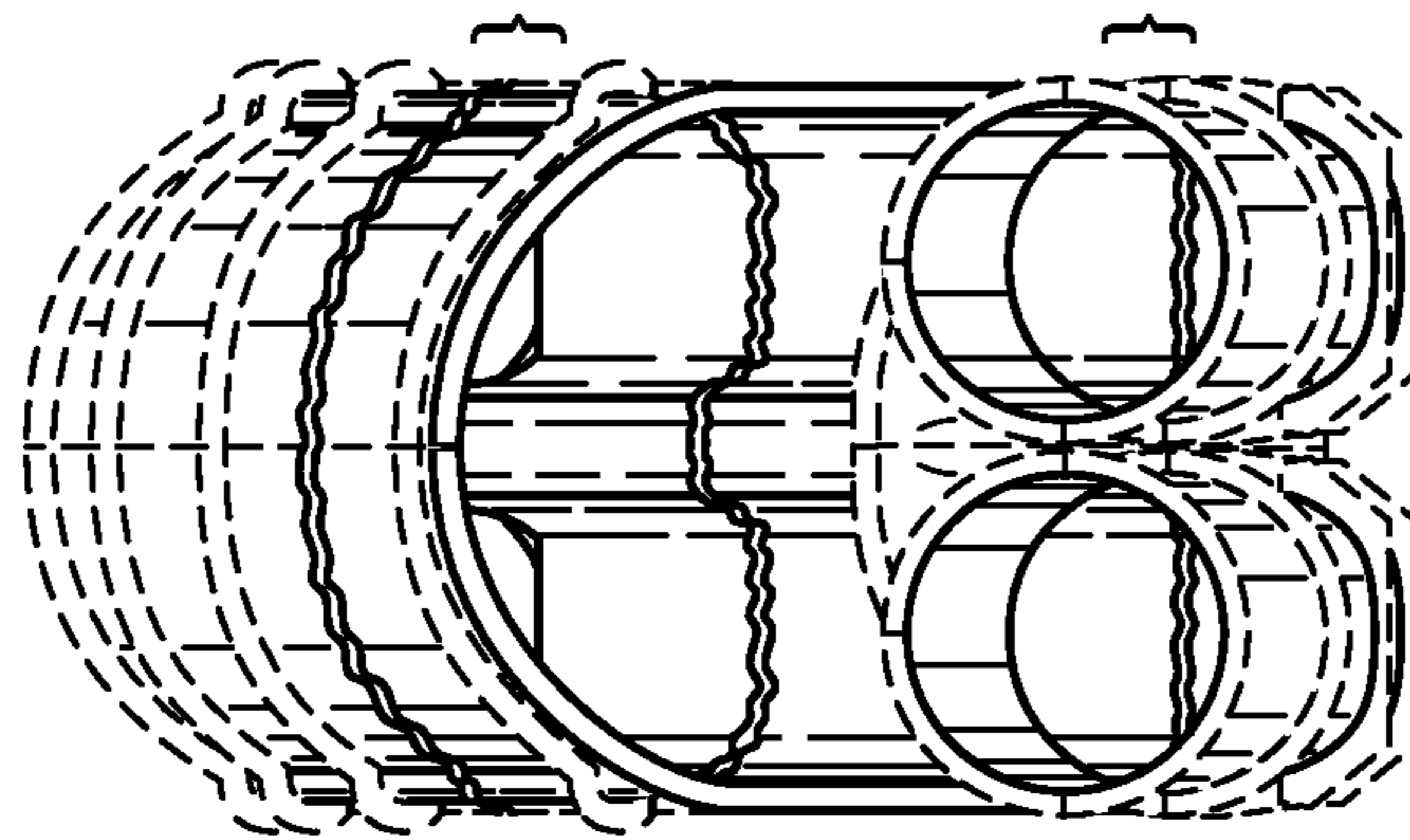

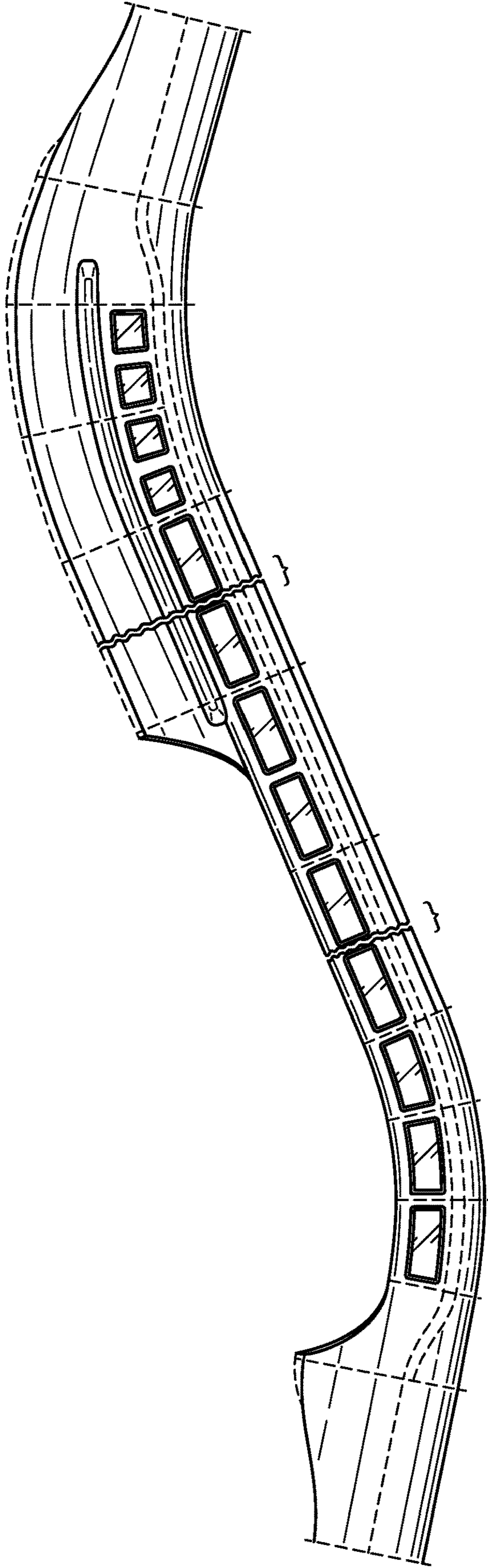

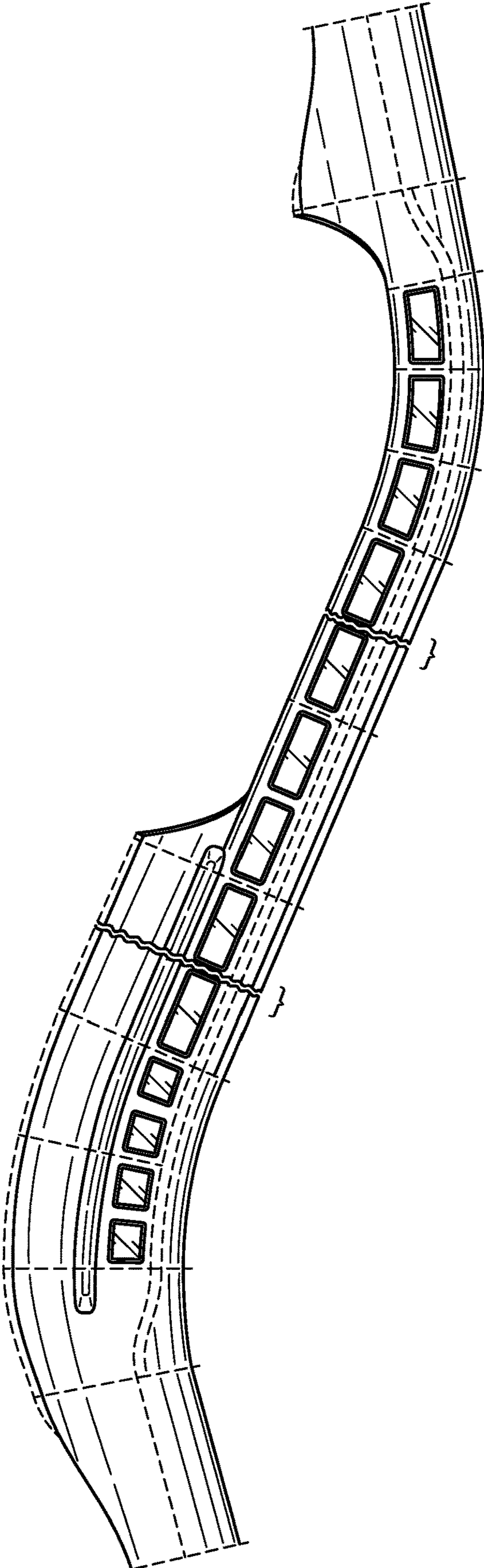

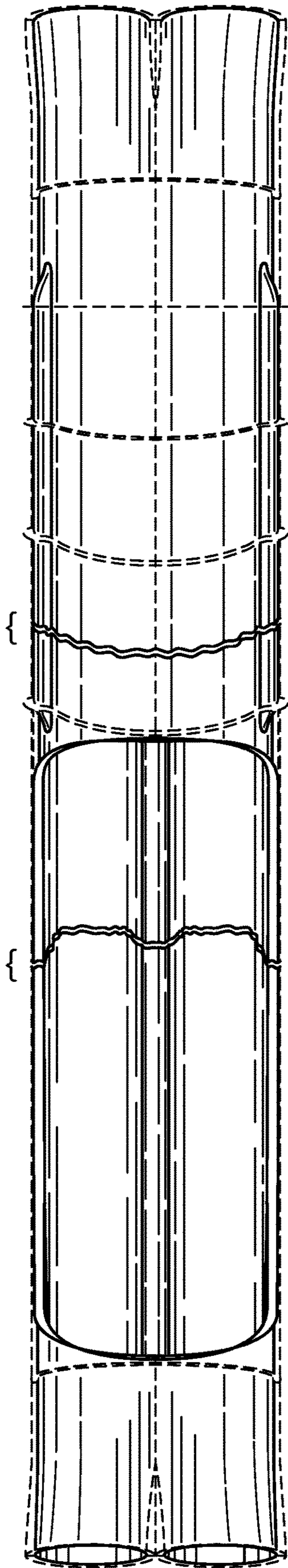

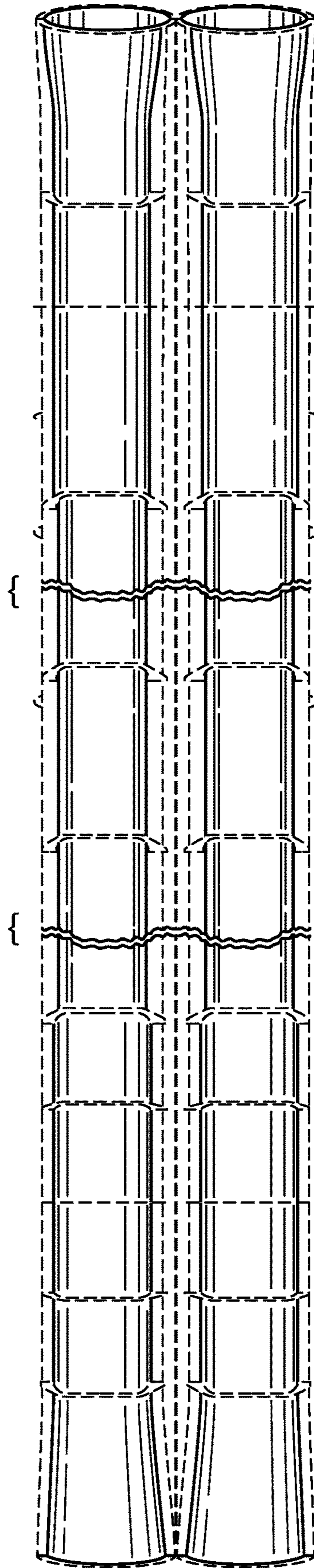
