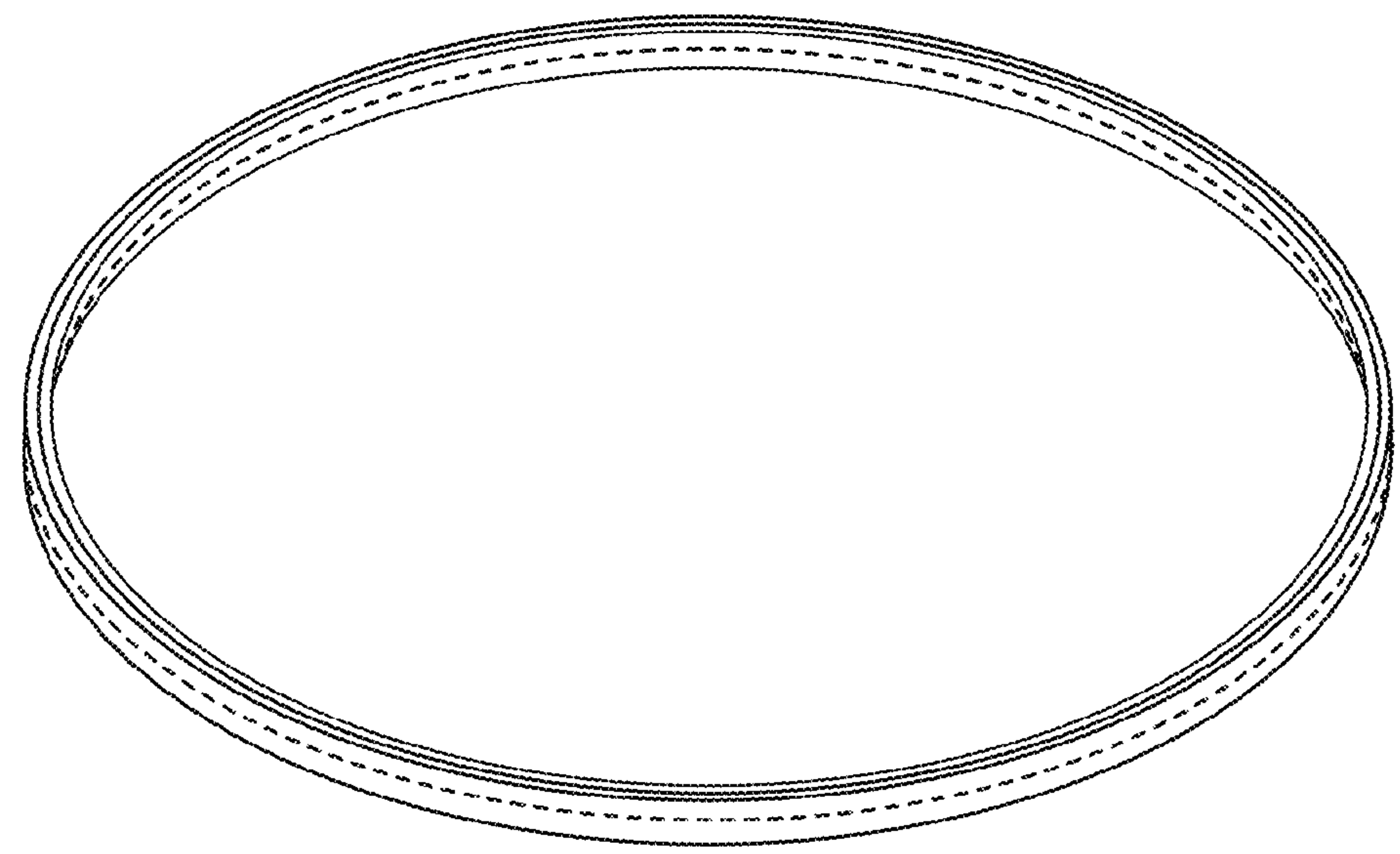

(57) **CLAIM**
The ornamental design for a thin headband with a single row of stitching, as shown and described.

DESCRIPTION
FIG. 1 is a first perspective view of a design for a thin headband with a single row of stitching in an example environment.
FIG. 2 is a second perspective view of the design for a thin headband with a single row of stitching.
FIG. 3 is a left side view of the design for a thin headband with a single row of stitching.
FIG. 4 is a right side view of the design for a thin headband with a single row of stitching.
FIG. 5 is a front view of the design for a thin headband with a single row of stitching.
FIG. 6 is a rear view of the design for a thin headband with a single row of stitching.
FIG. 7 is a top view of the design for a thin headband with a single row of stitching; and,
FIG. 8 is a bottom view of the design for a thin headband with a single row of stitching.
The thin headband with a single row of stitching as shown in FIGS. 1-8 has a width of between 0.6 cm and 0.9 cm. Features shown in broken lines depict environment and form no part of the claimed design.

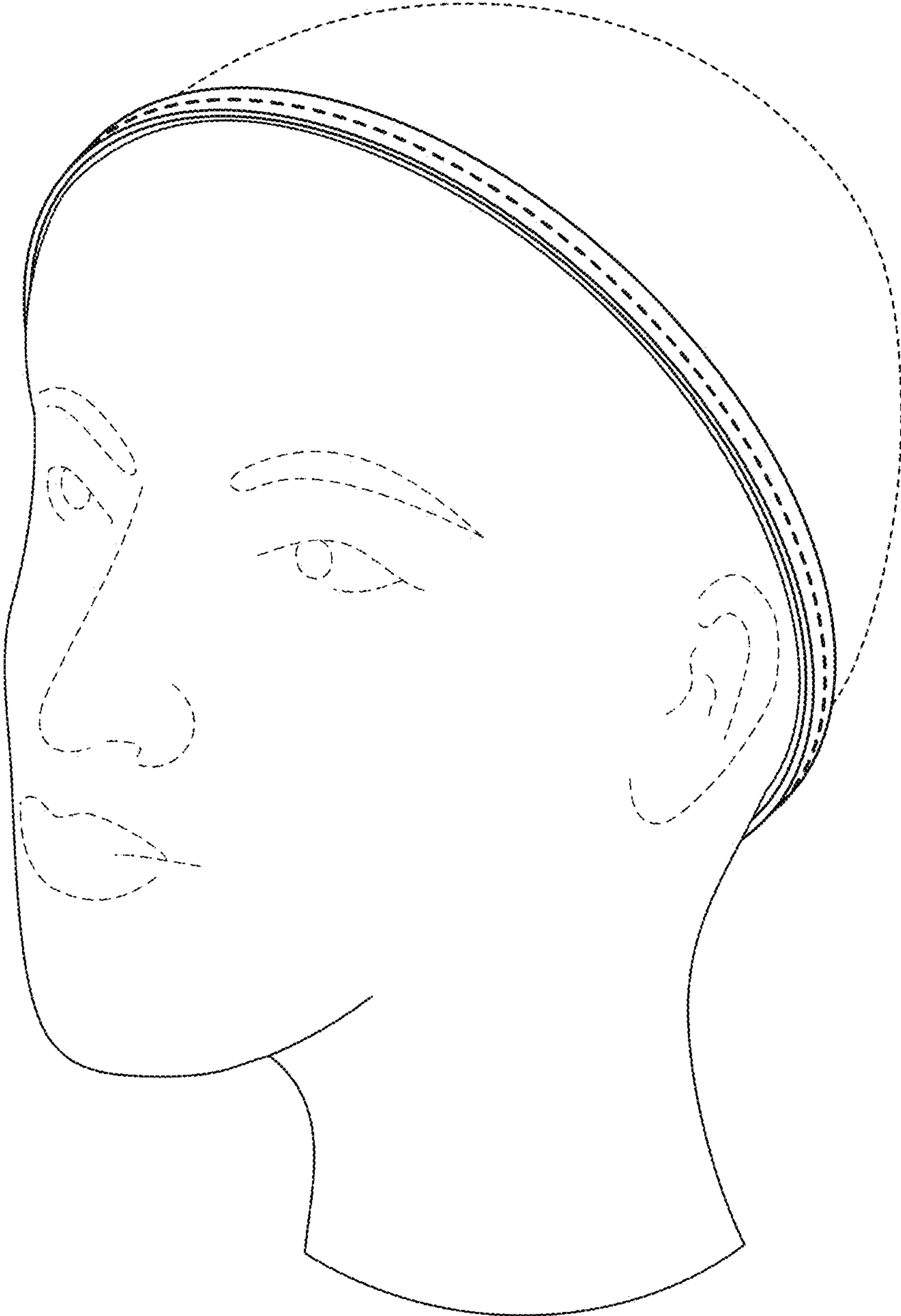

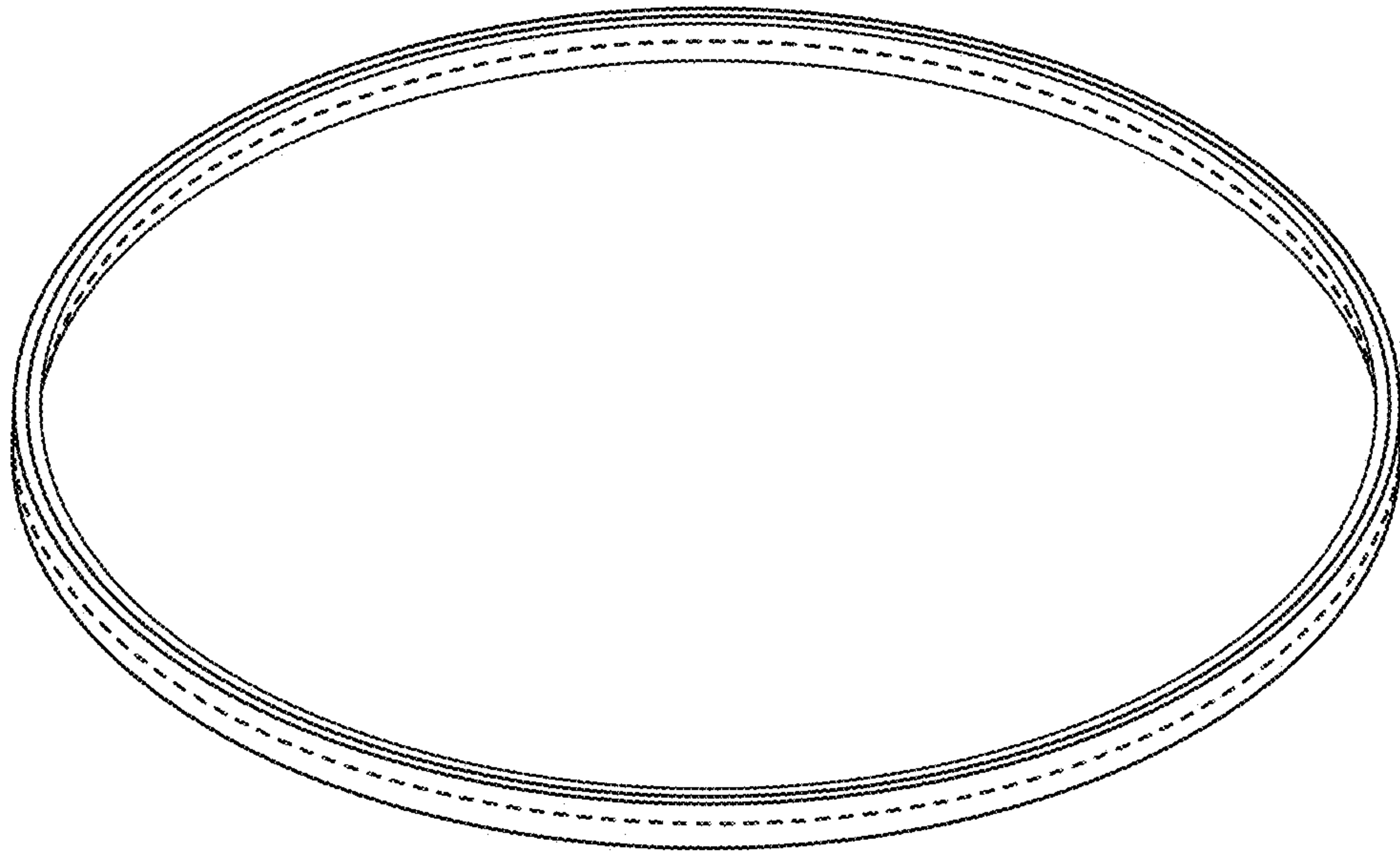

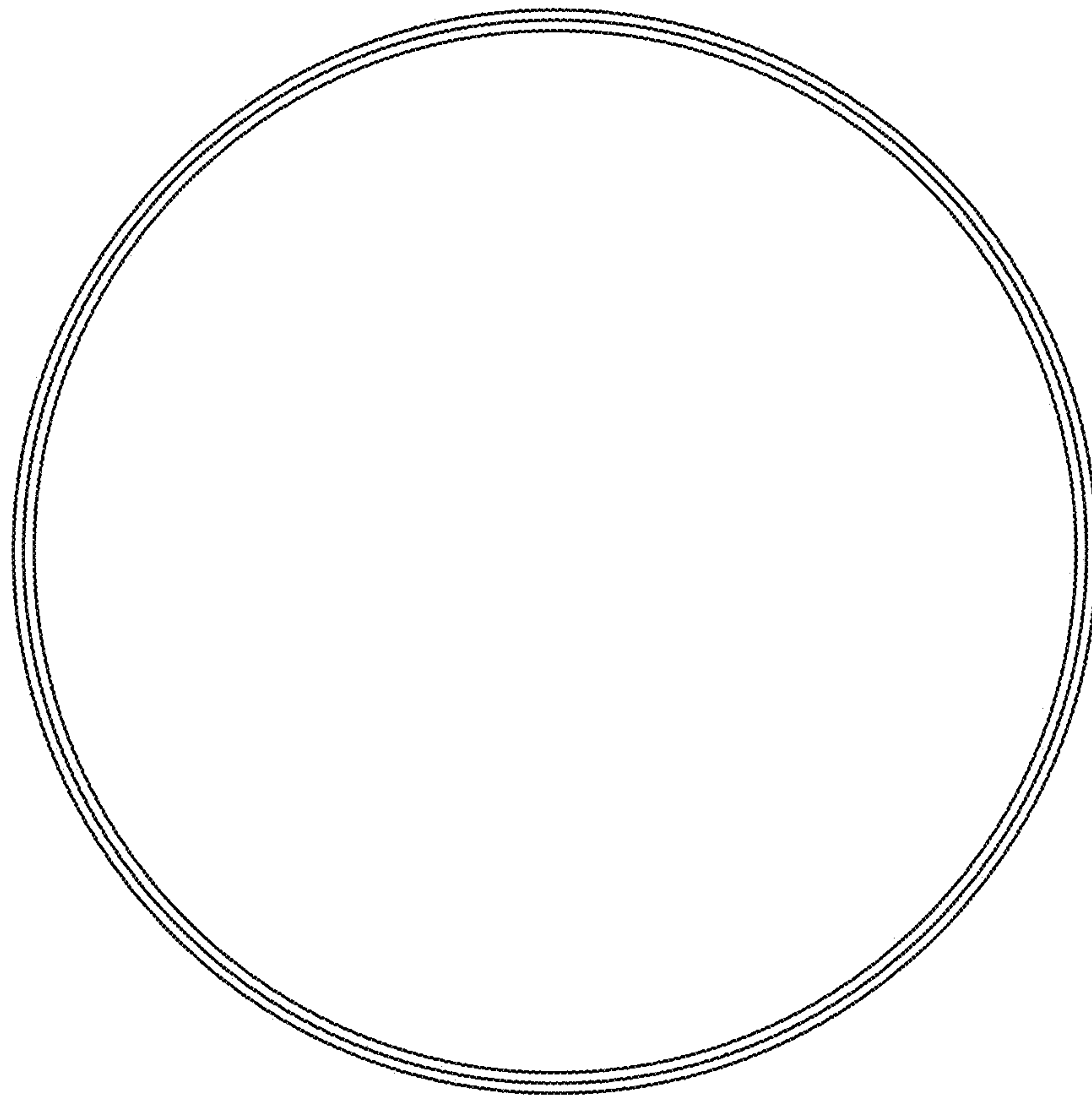

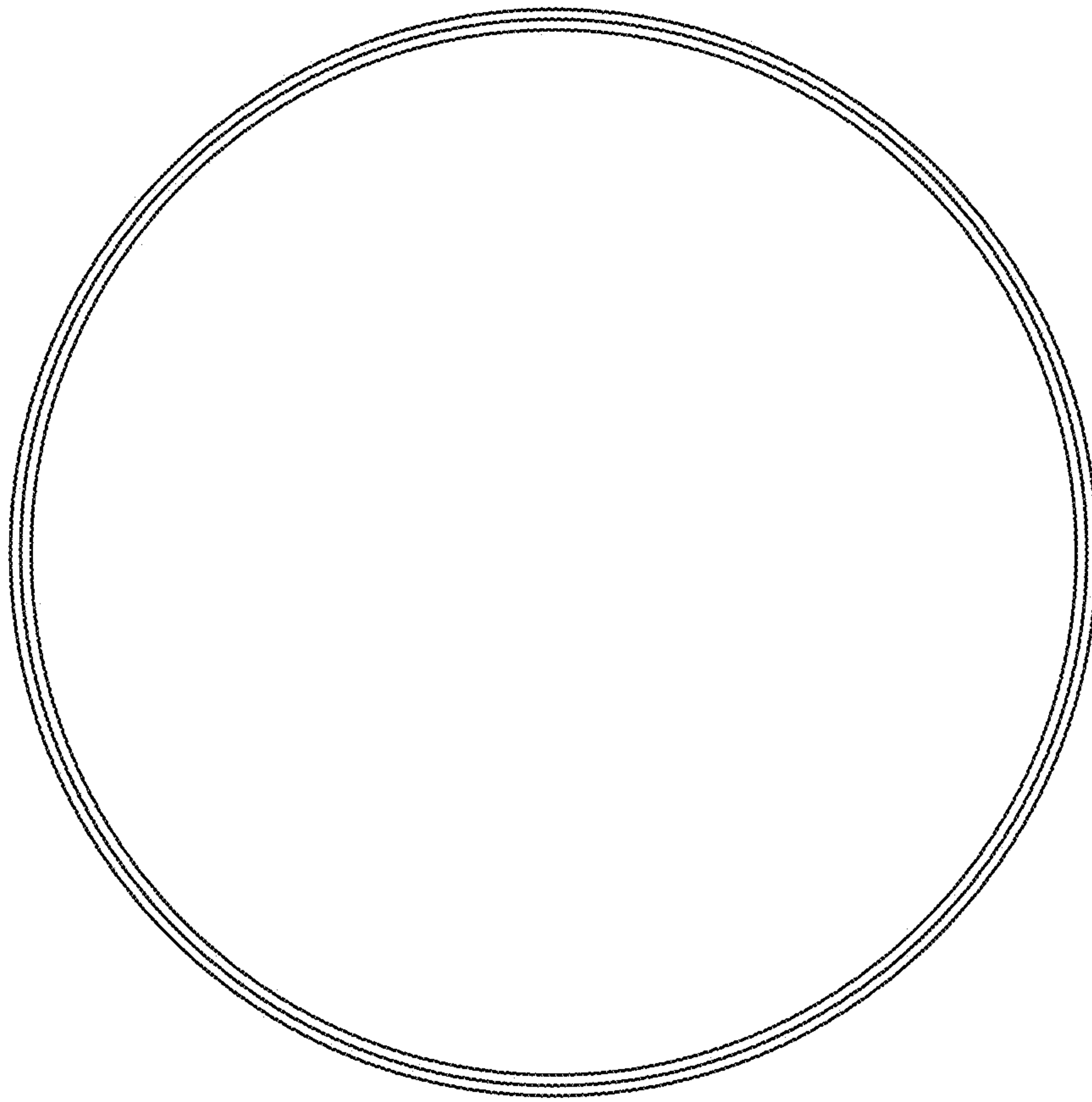
