I claim the ornamental design for a helmet, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front left isometric view of a design for a helmet;

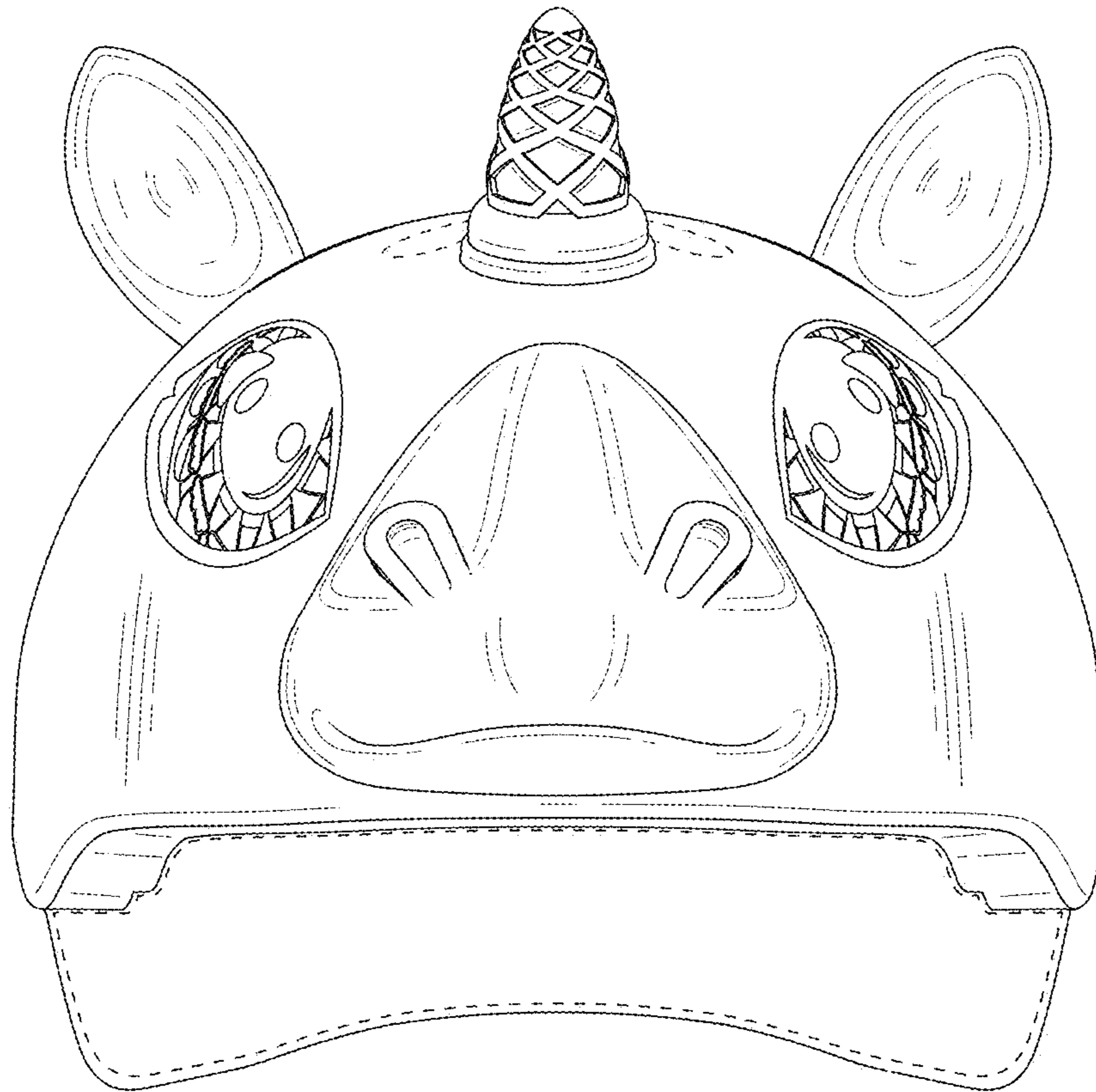

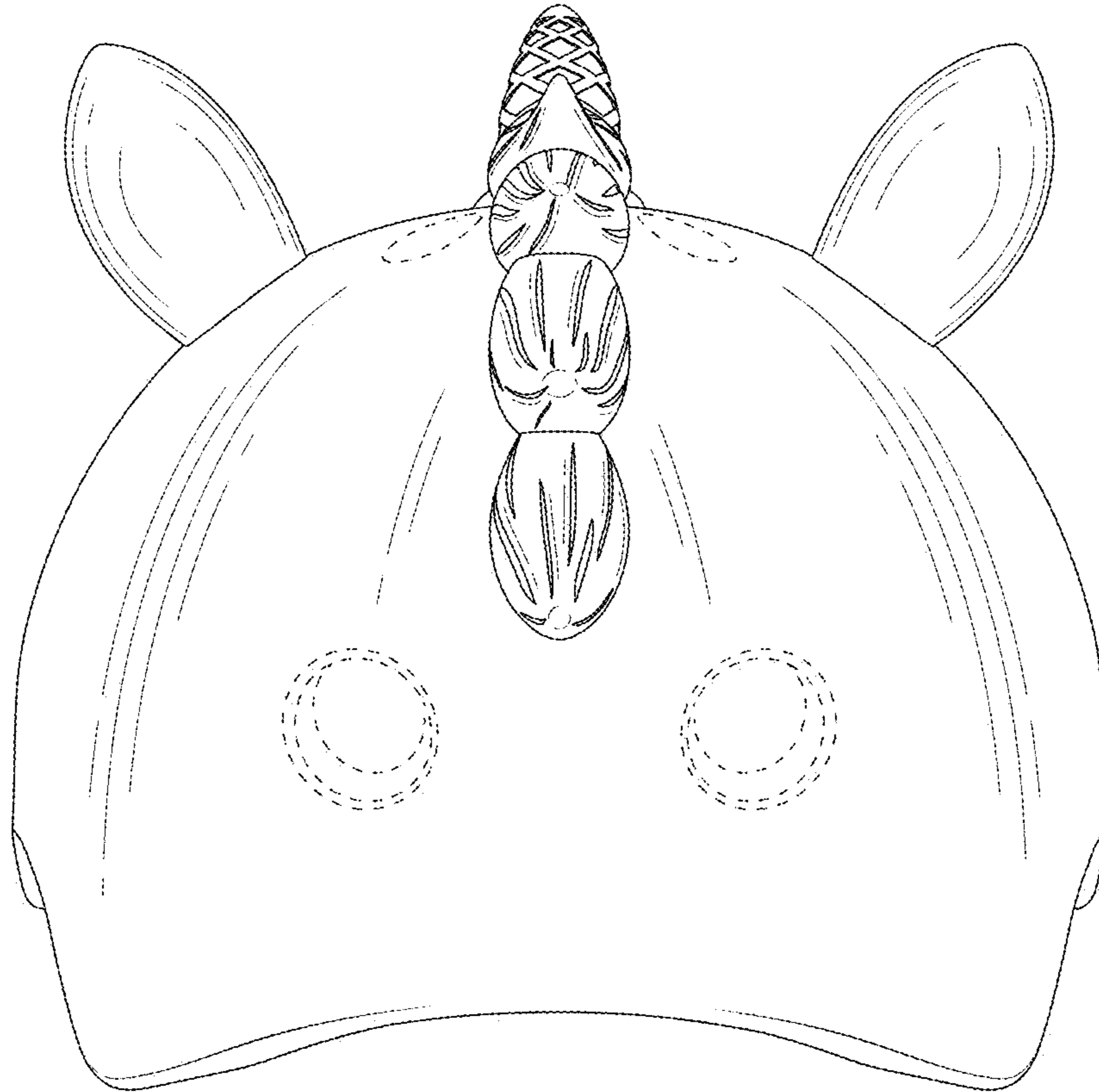

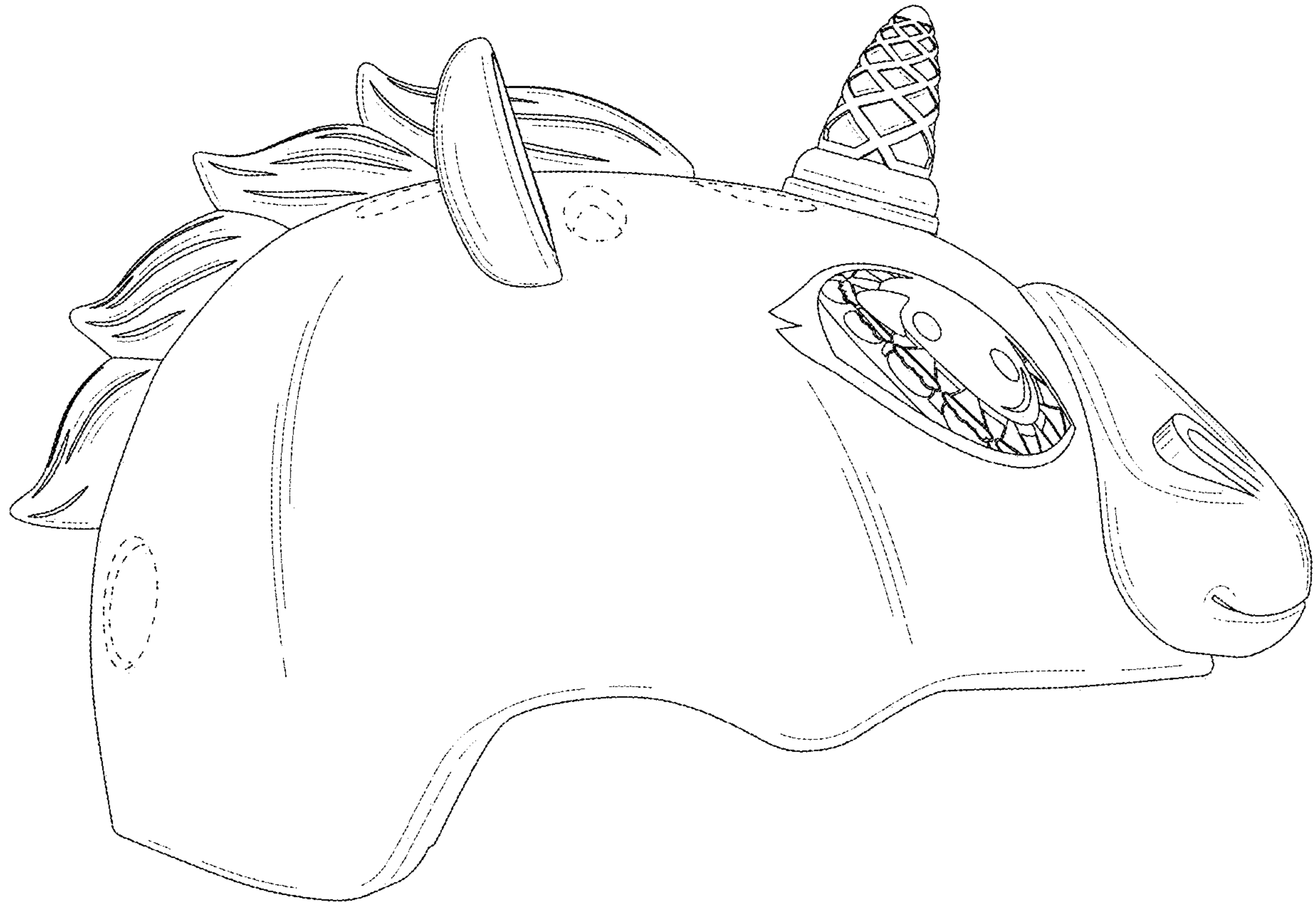

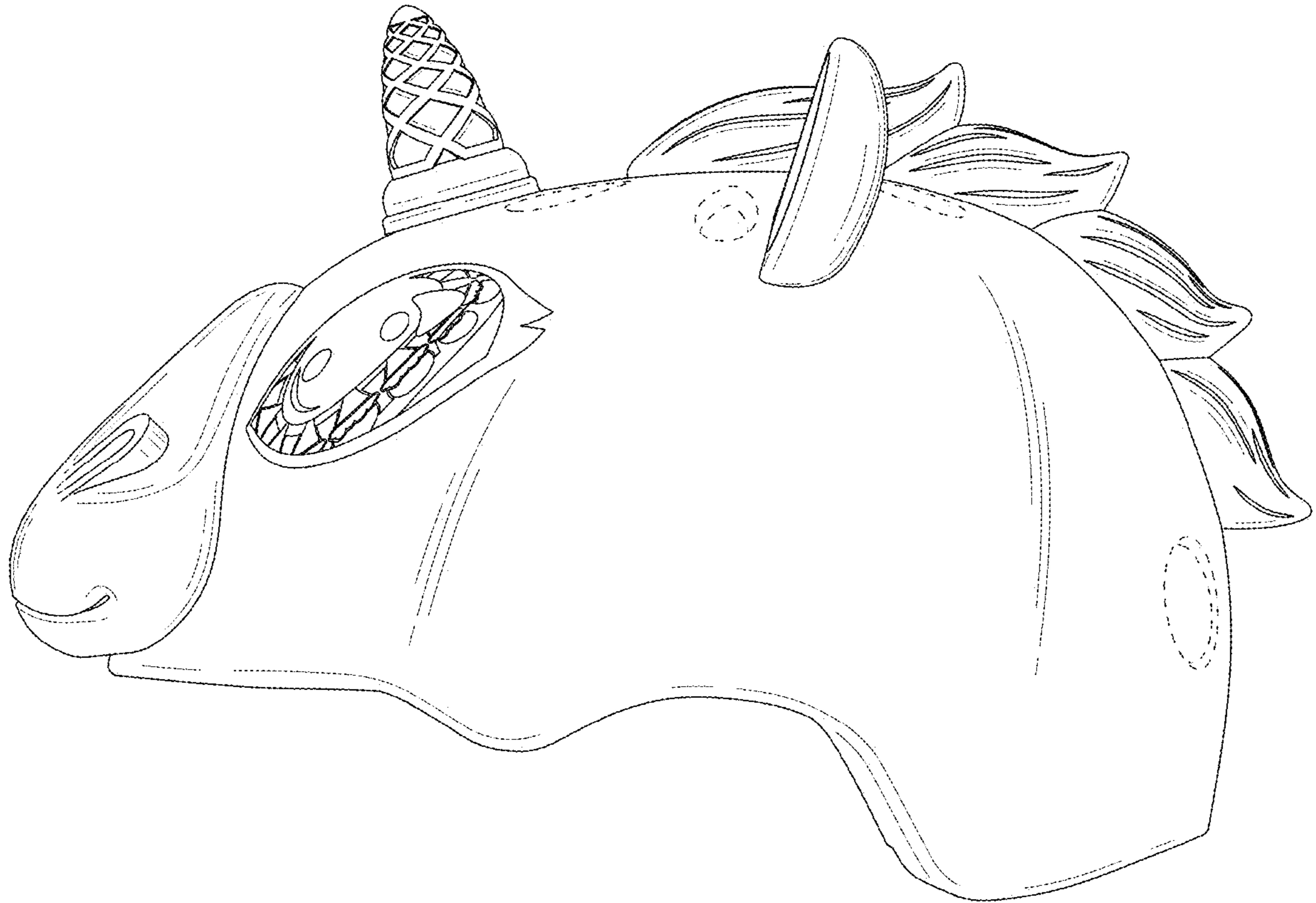

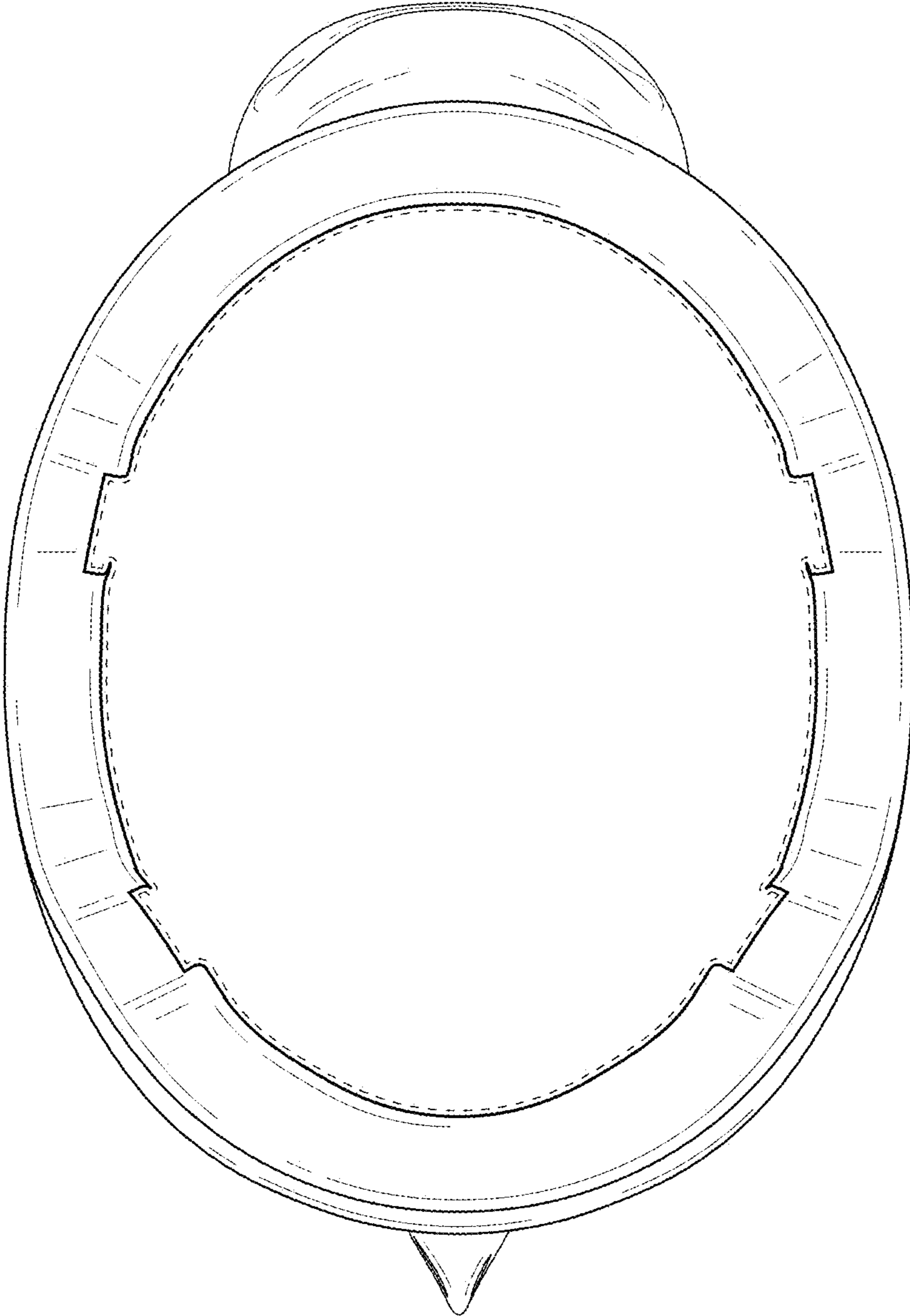
