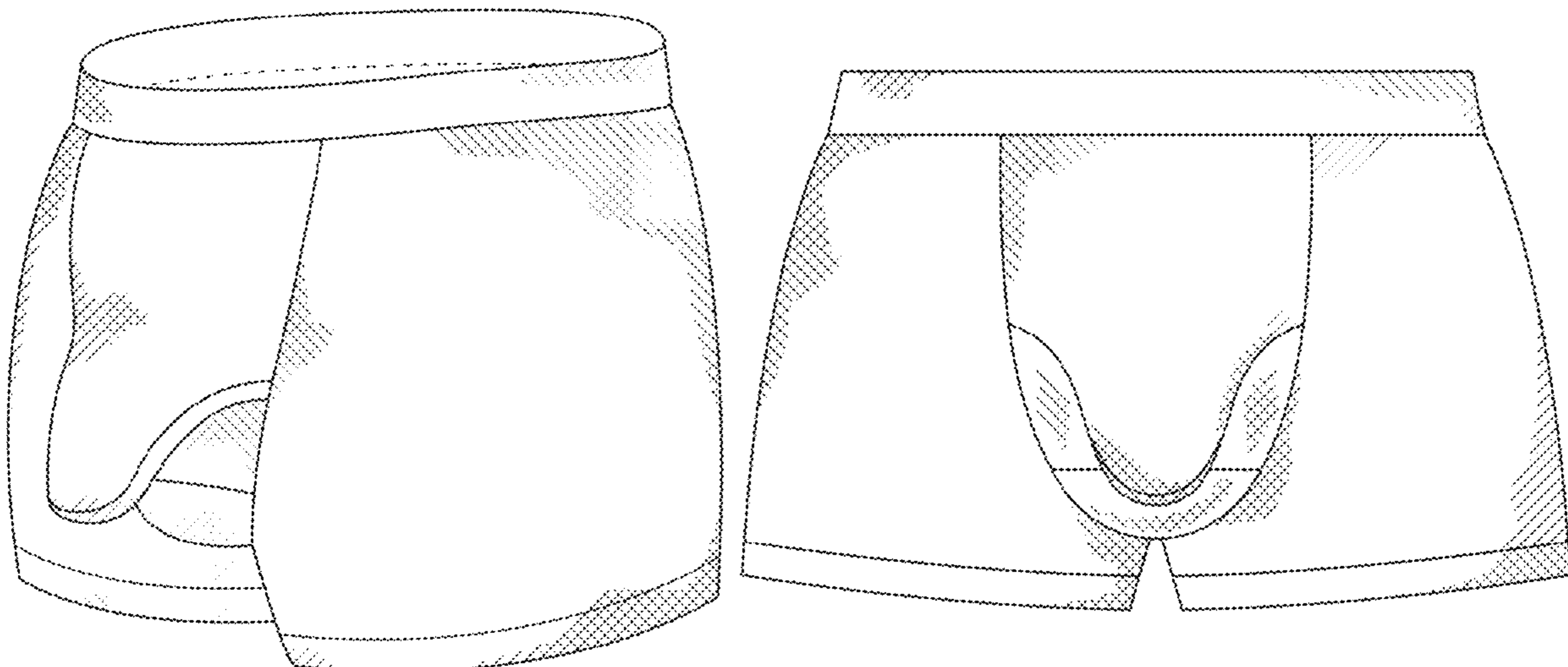
(57) **CLAIM**

The ornamental design for an underwear garment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an underwear garment; FIG. 2 is a front side view thereof; FIG. 3 is a back side view thereof; FIG. 4 is a left side view thereof; and, FIG. 5 is a right side view thereof. The broken lines in the drawings depict portions of the underwear garment that form no part of the claimed design.

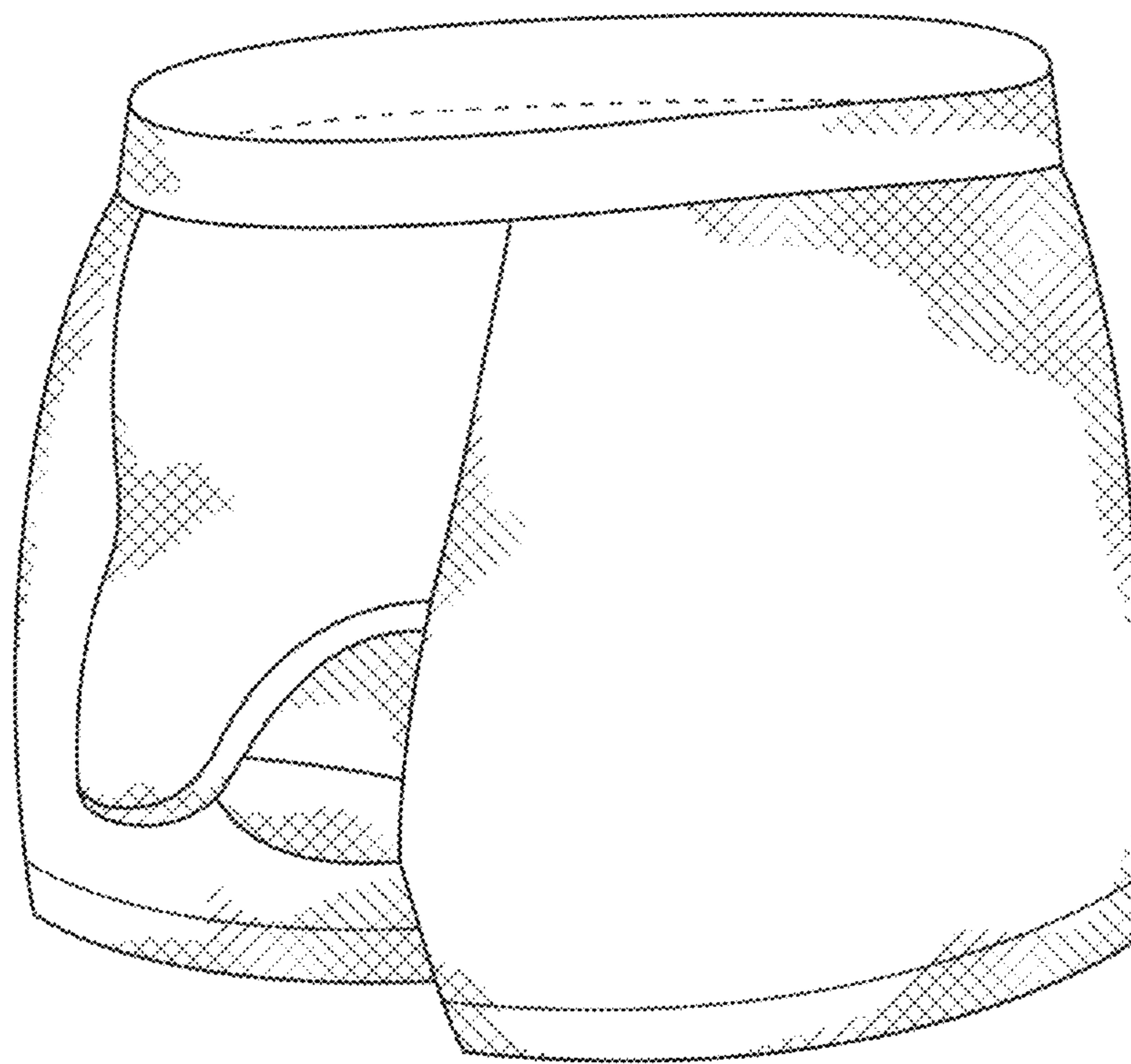

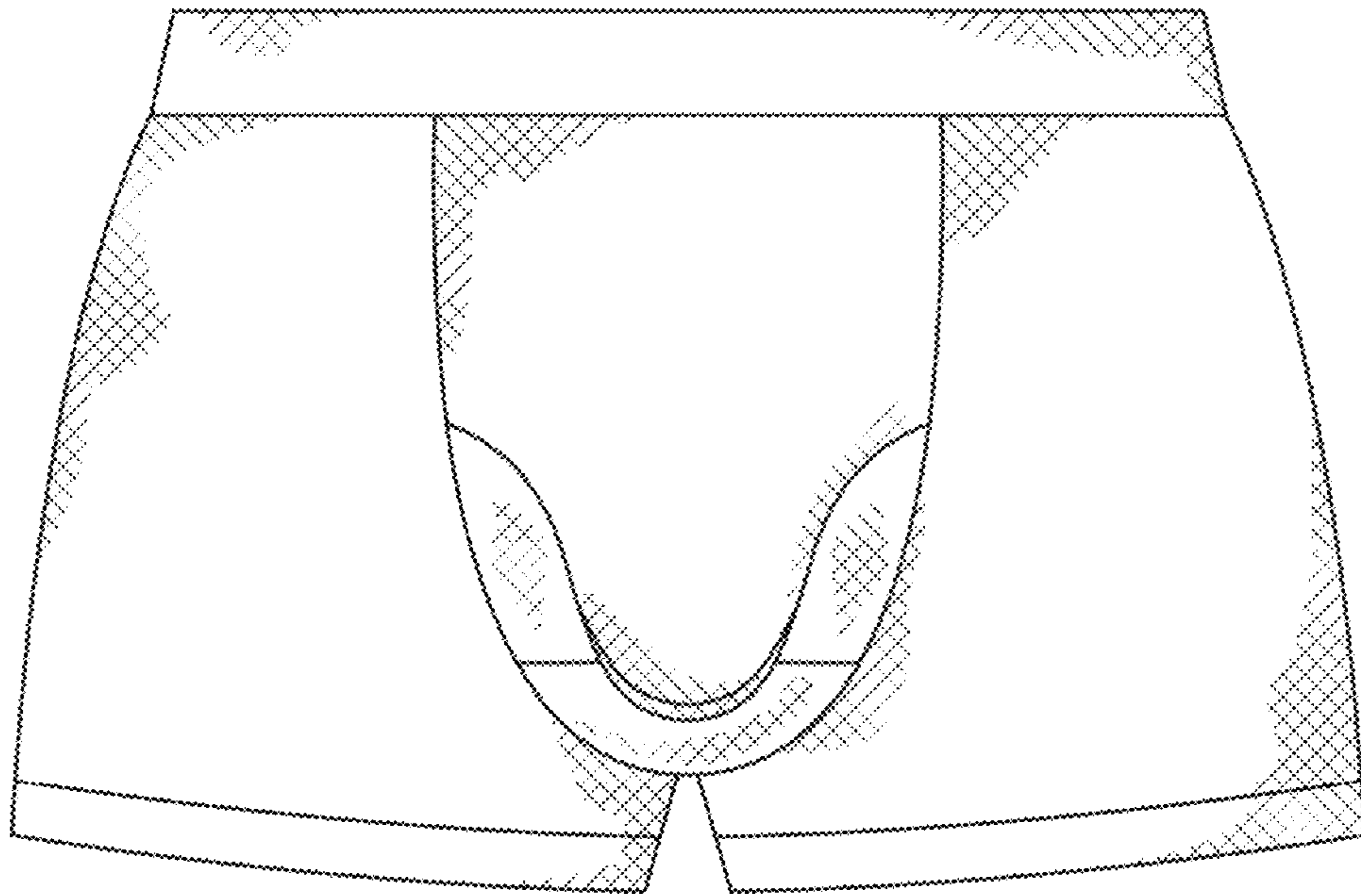

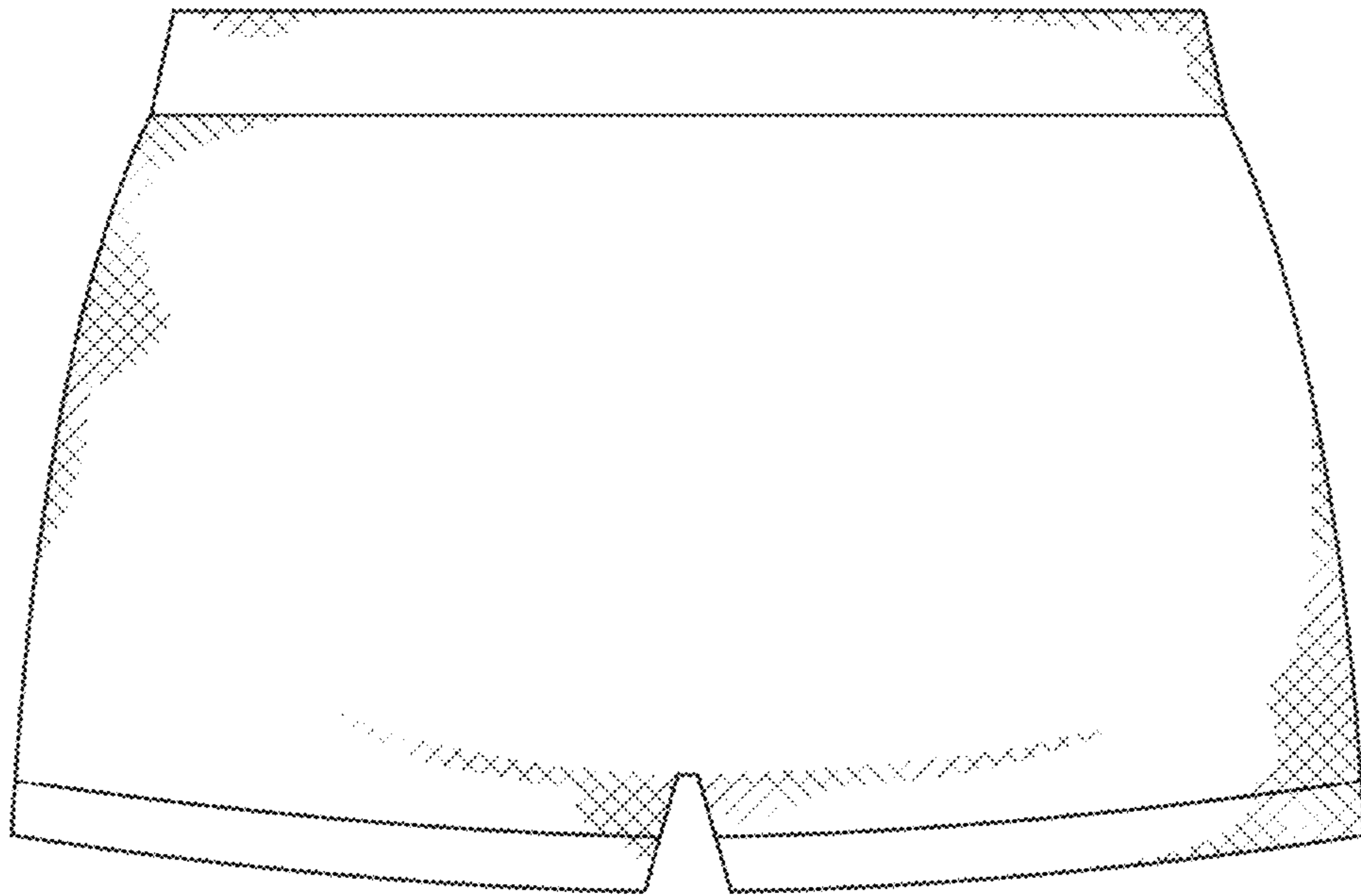

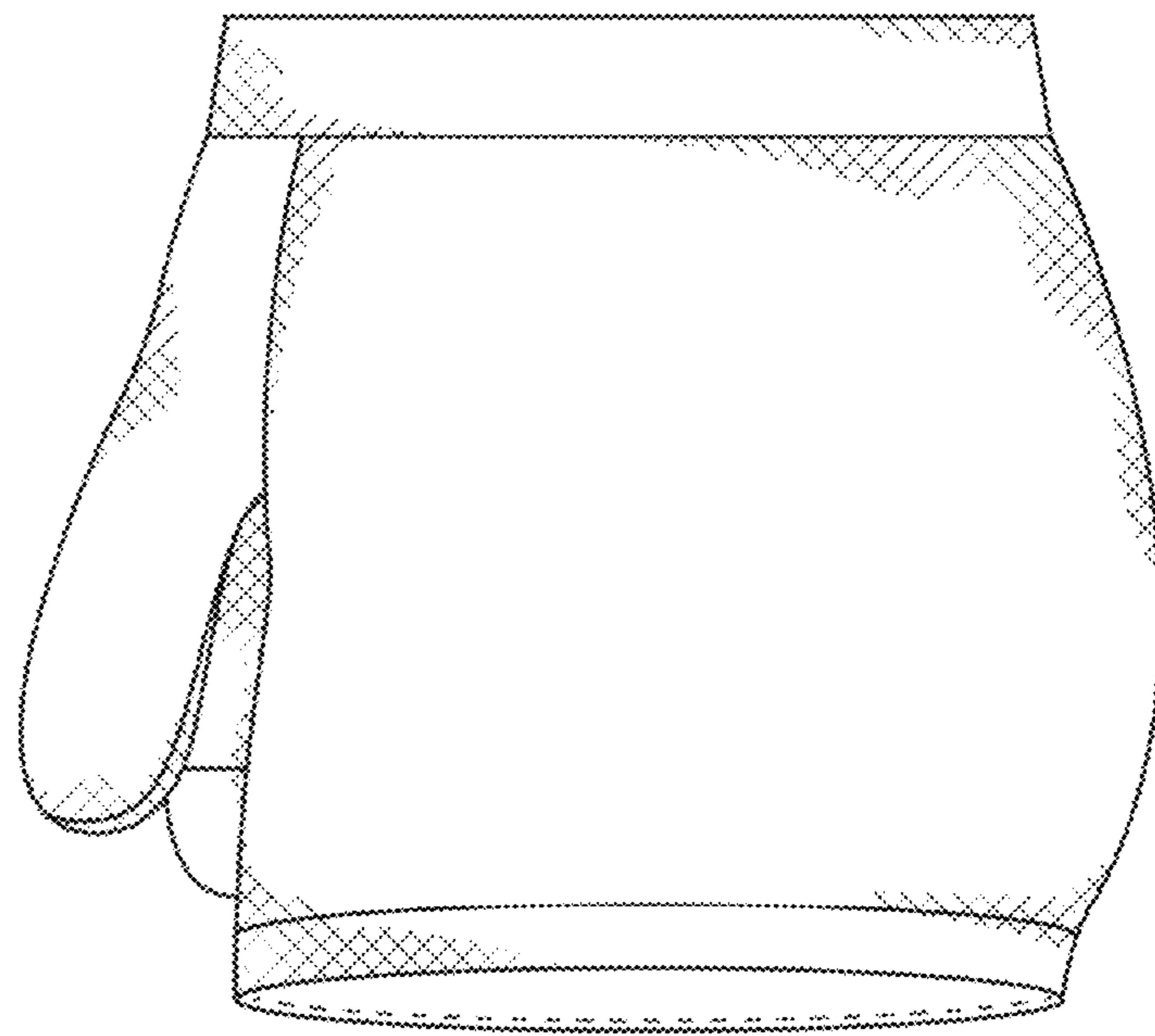

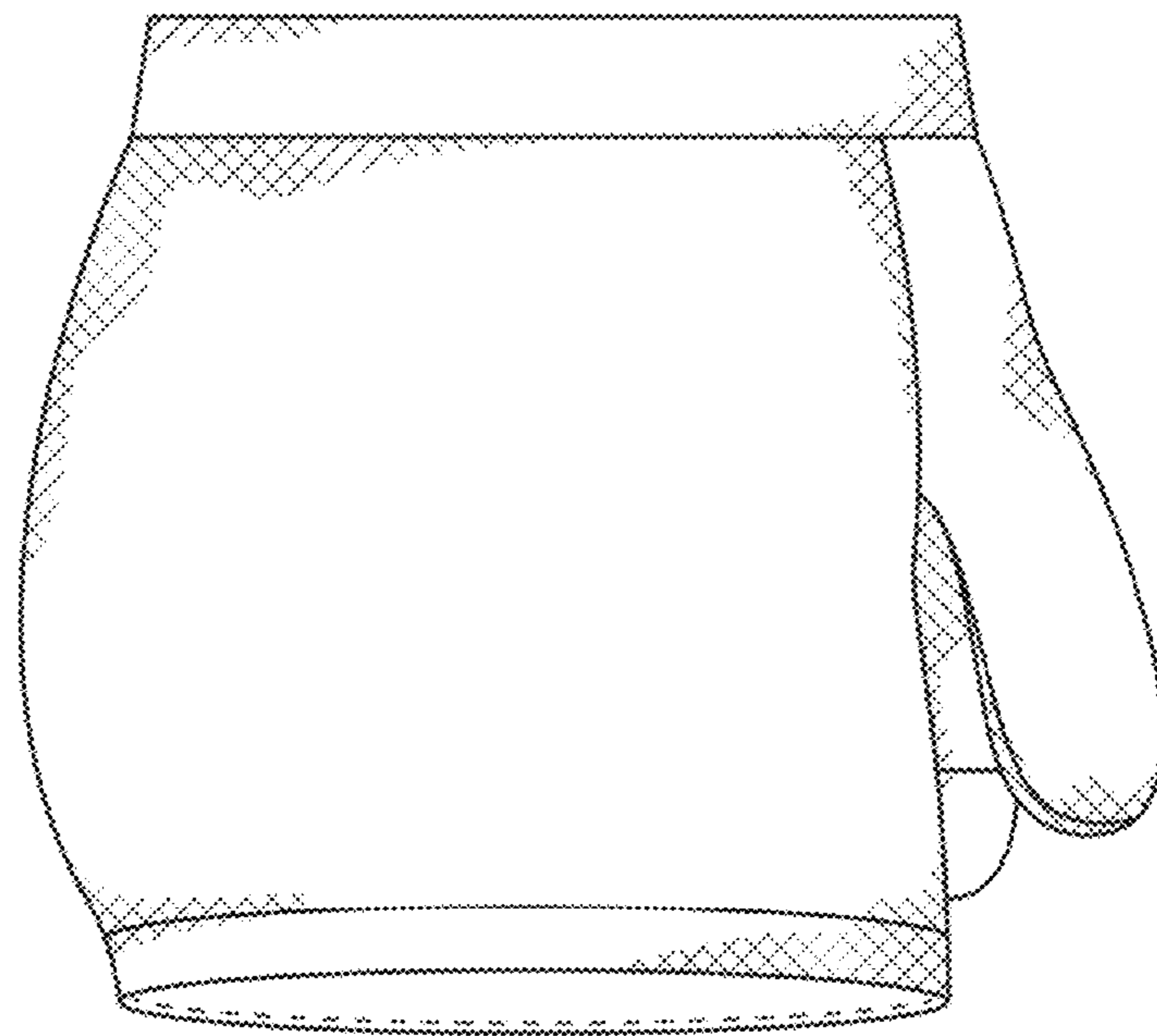
