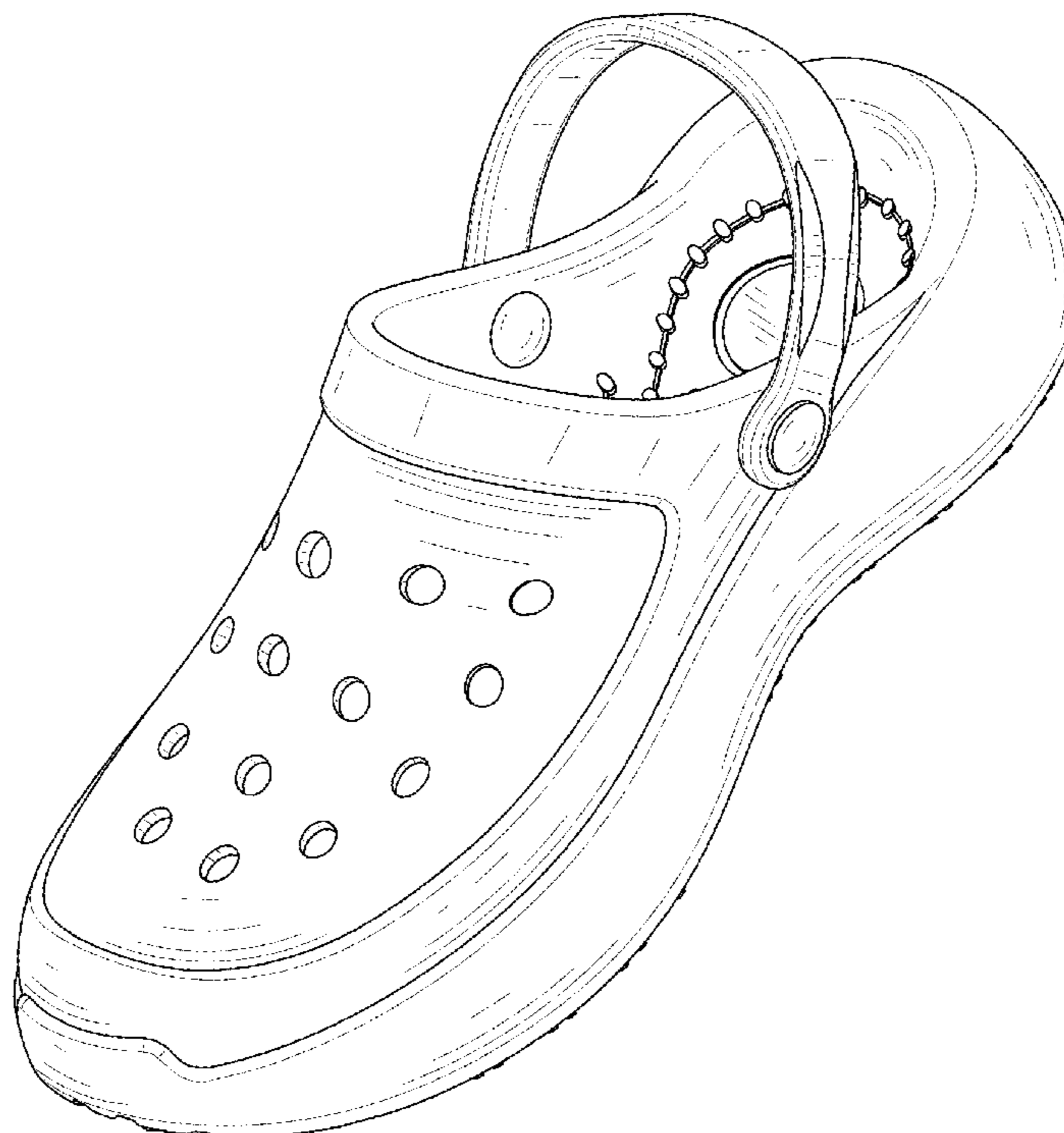
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, left side, top perspective view of footwear showing my new design;

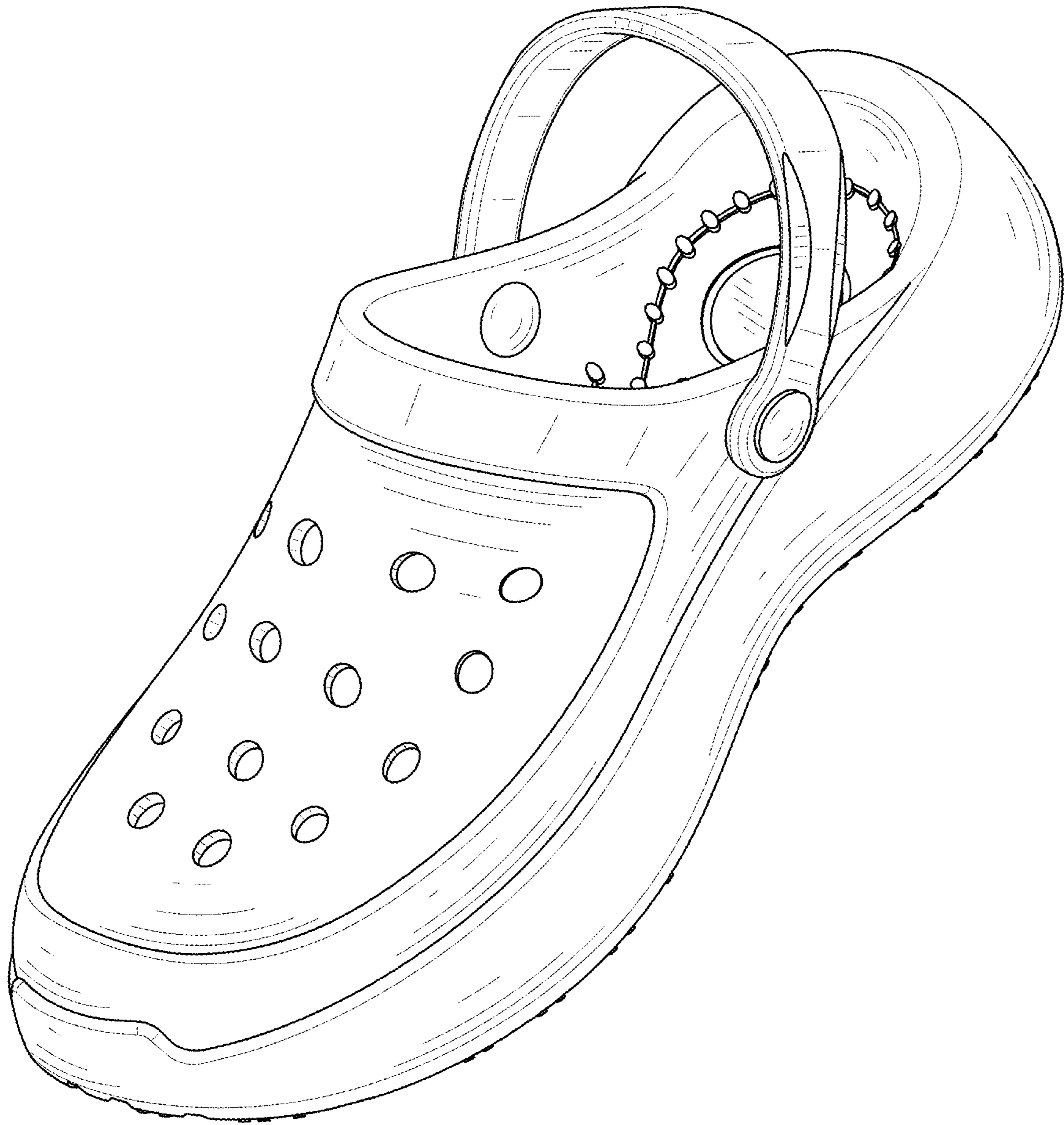

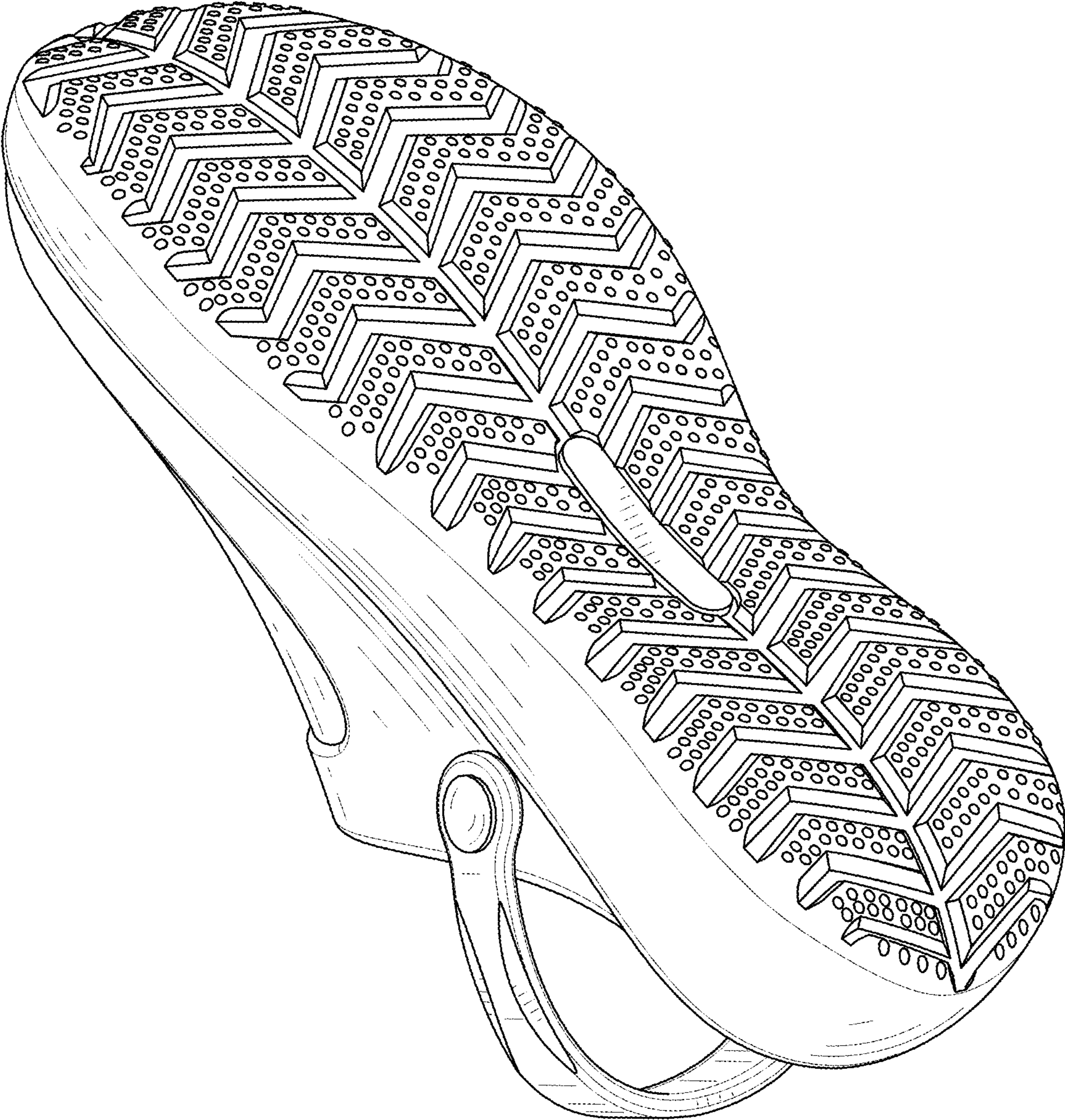

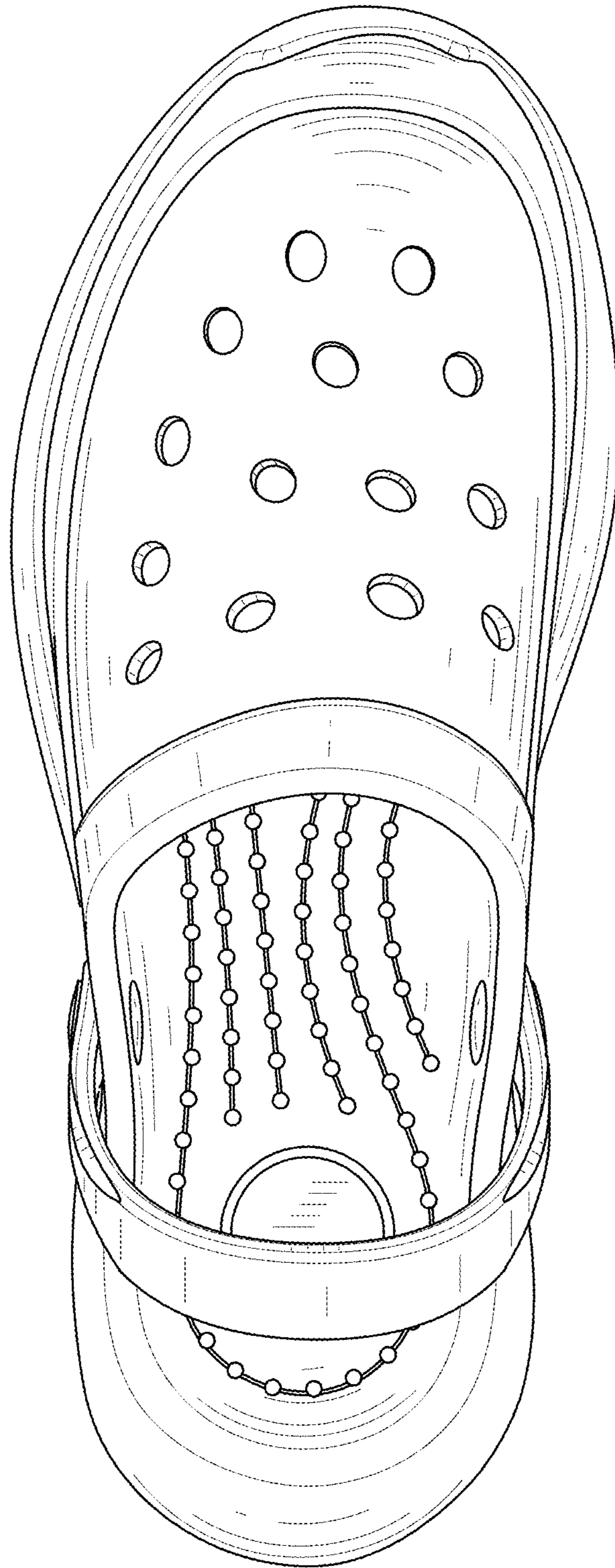

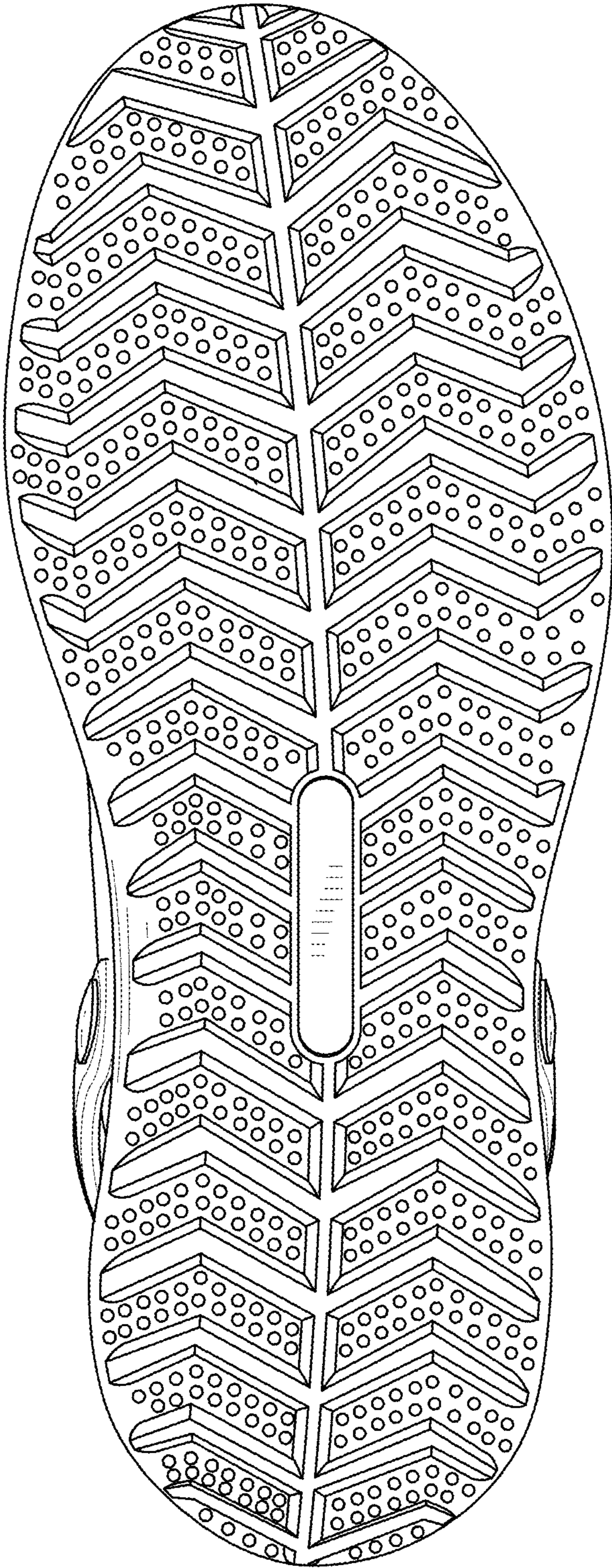

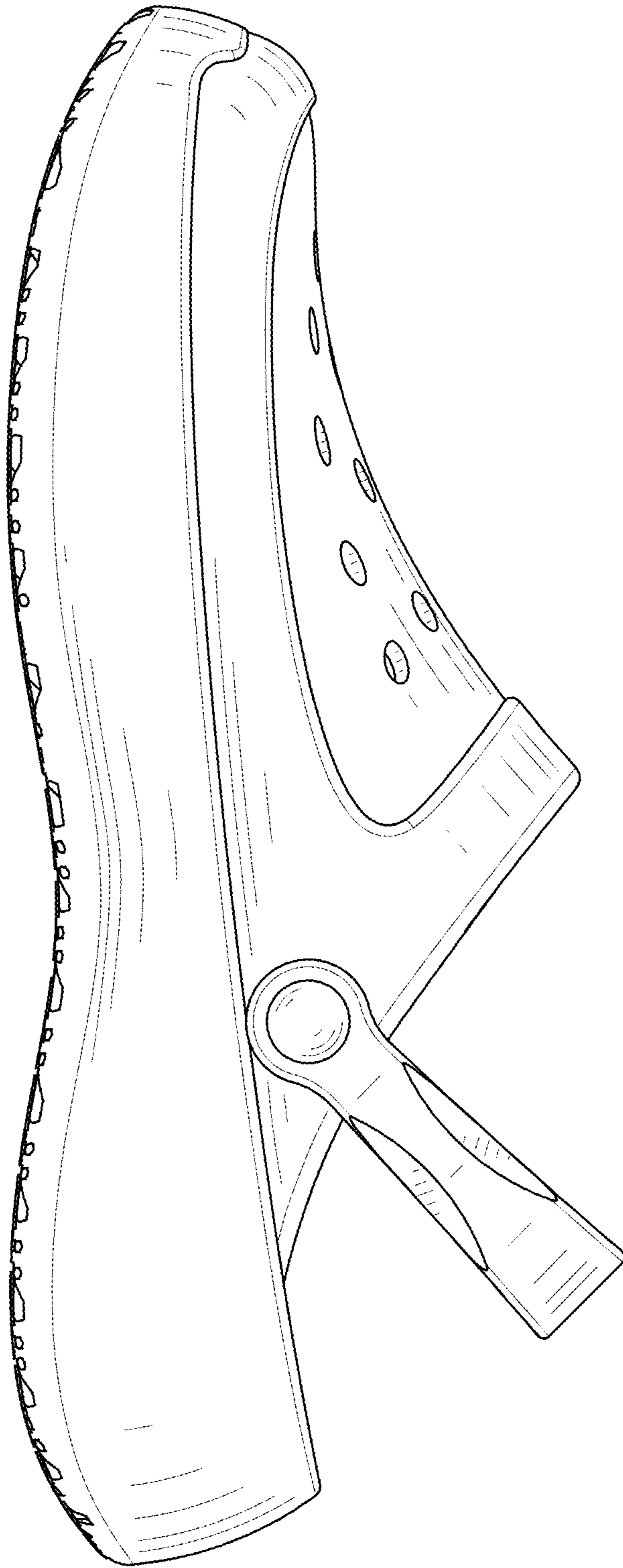

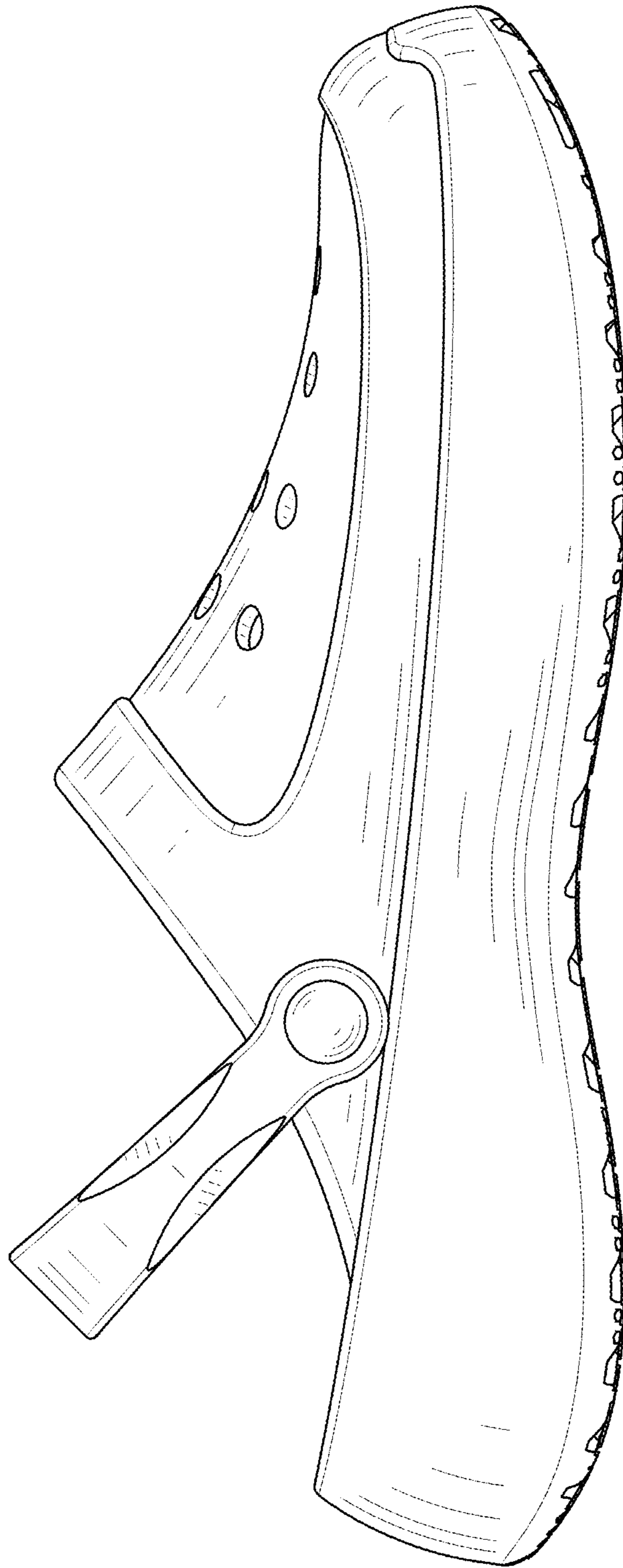

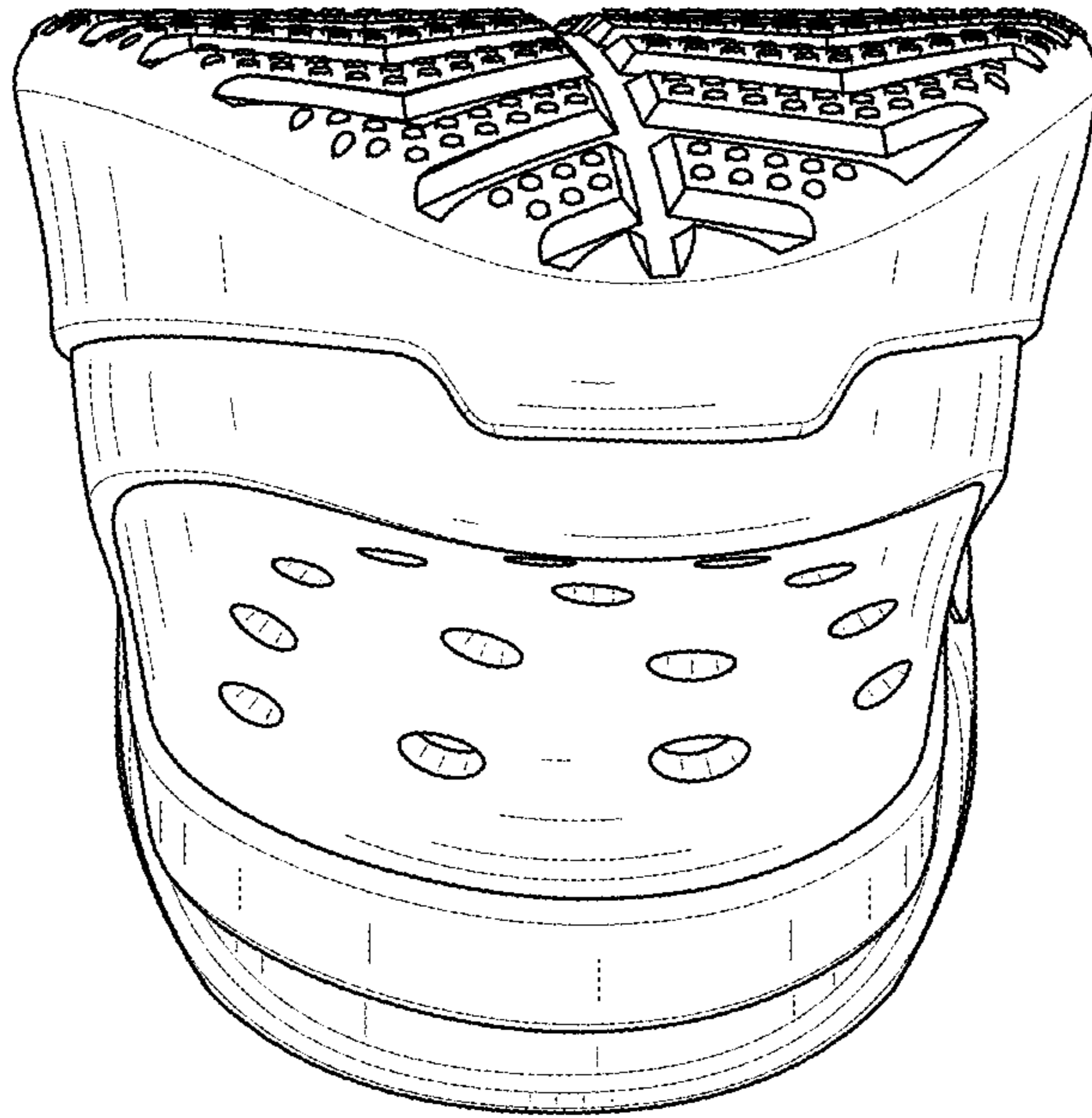

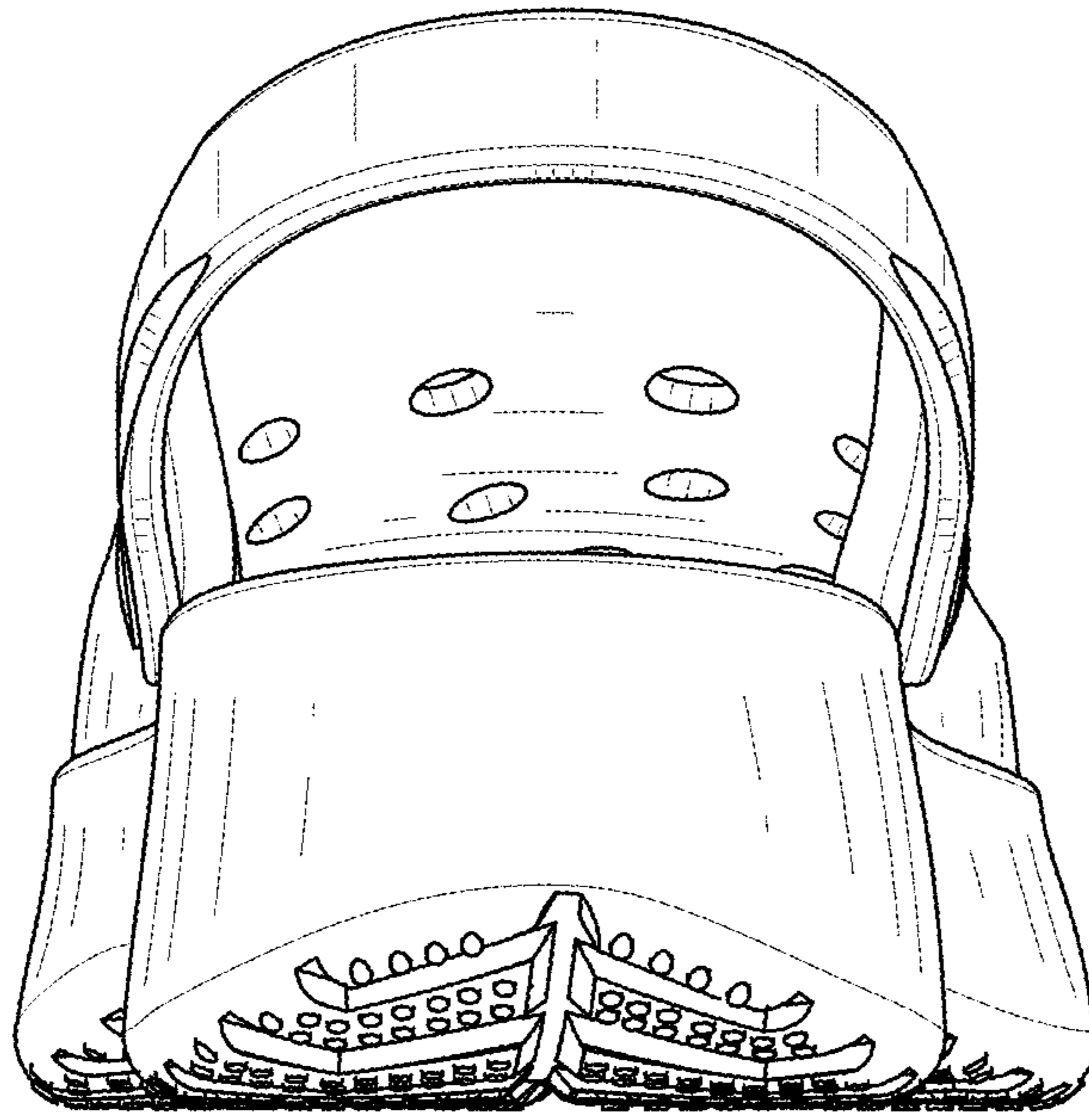
