(57) CLAIM

The ornamental design for a handle for hot air comb, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a handle for hot air comb showing my design;

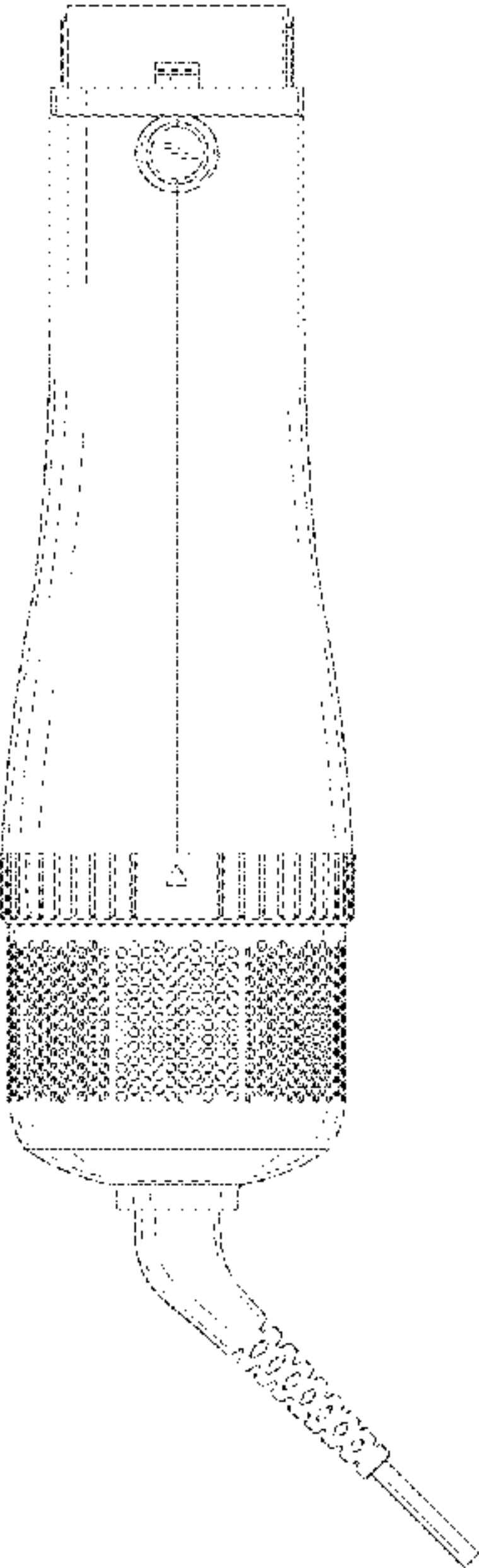

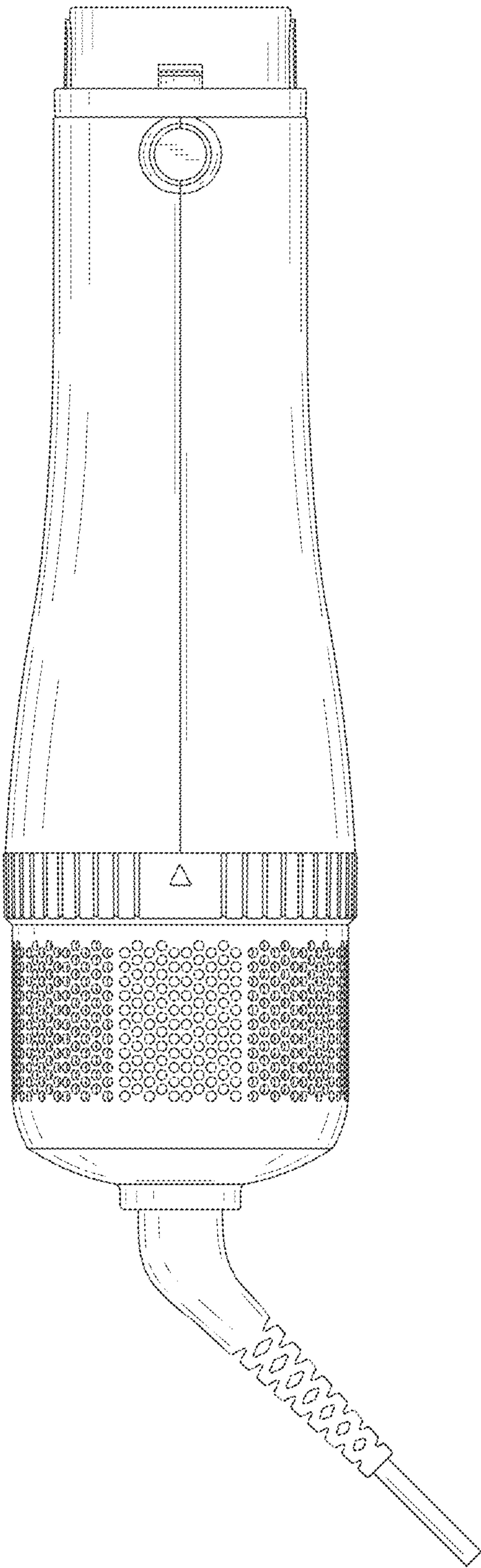

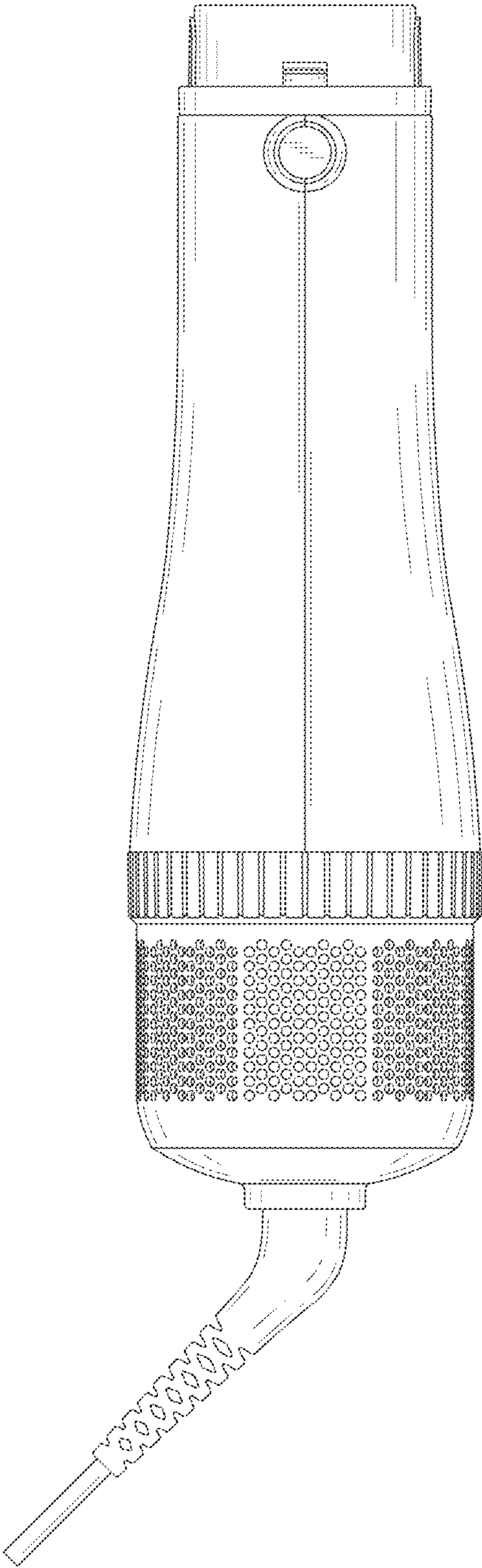

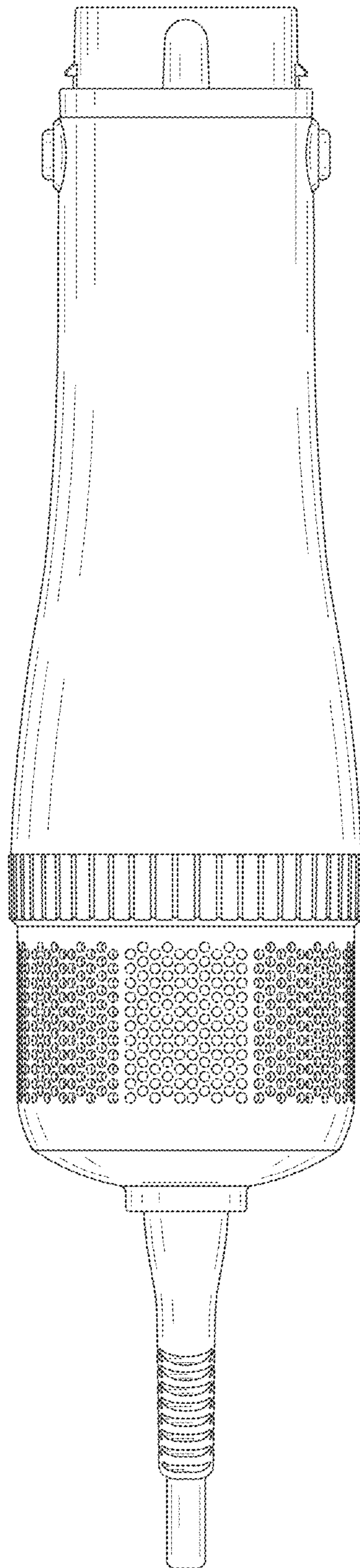

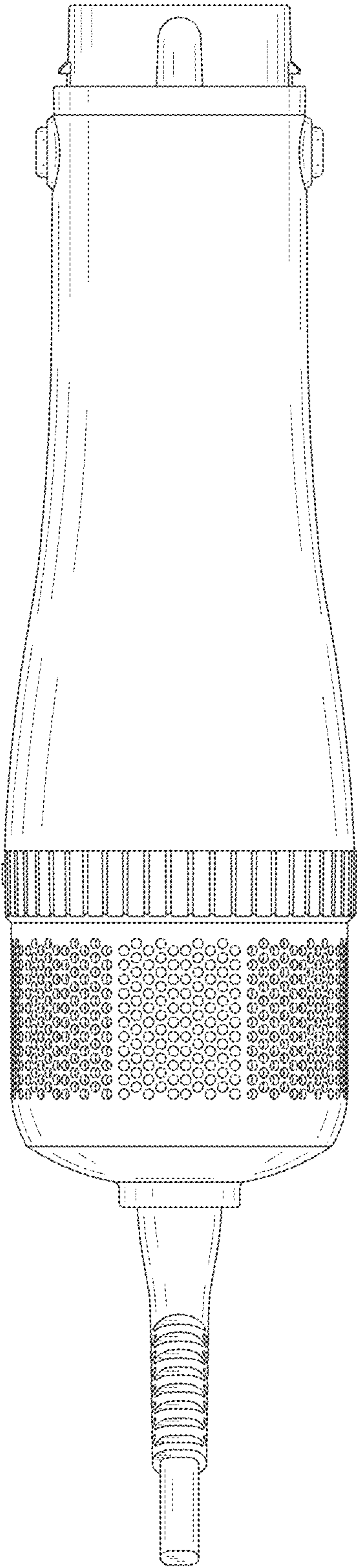

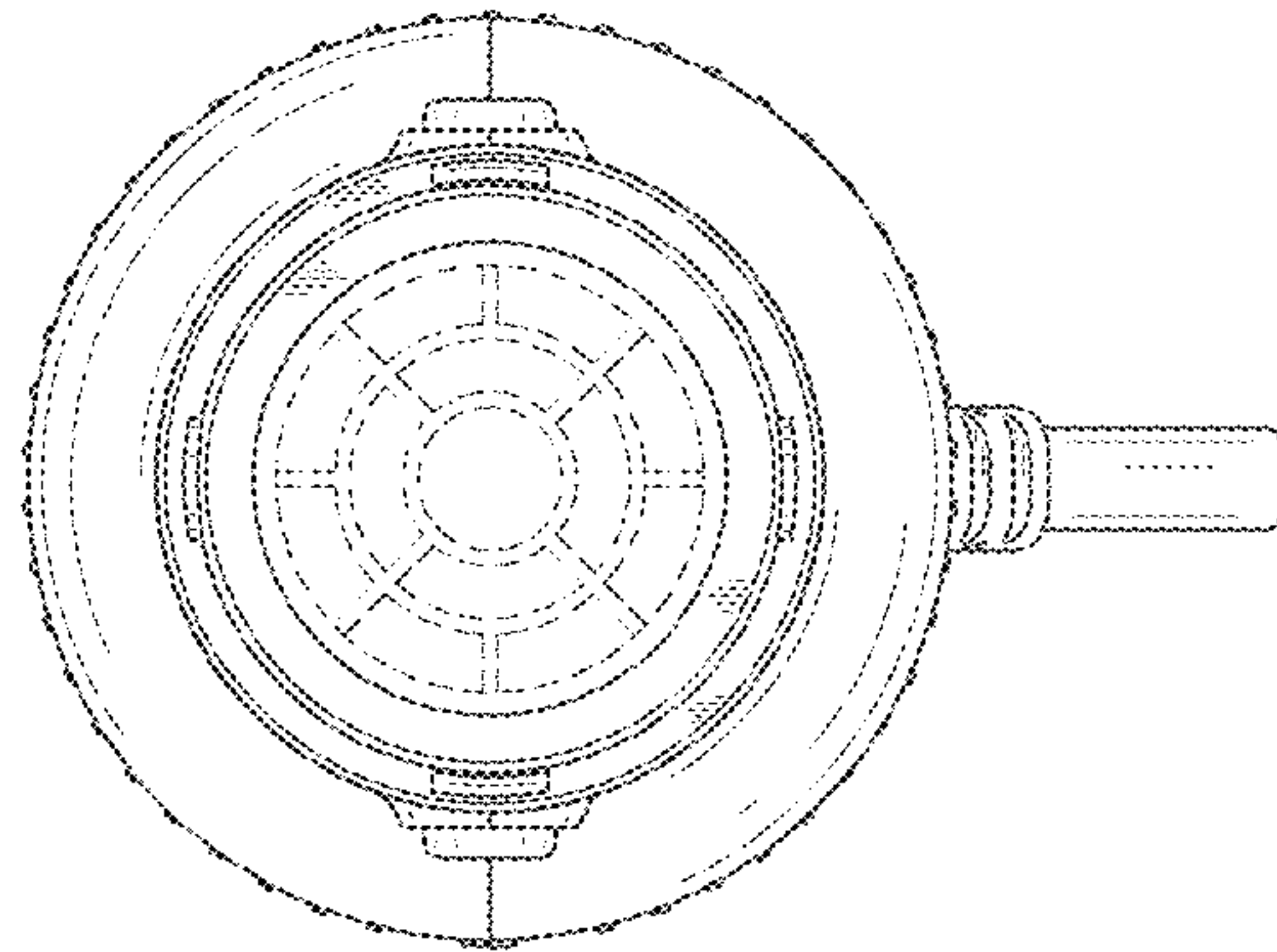

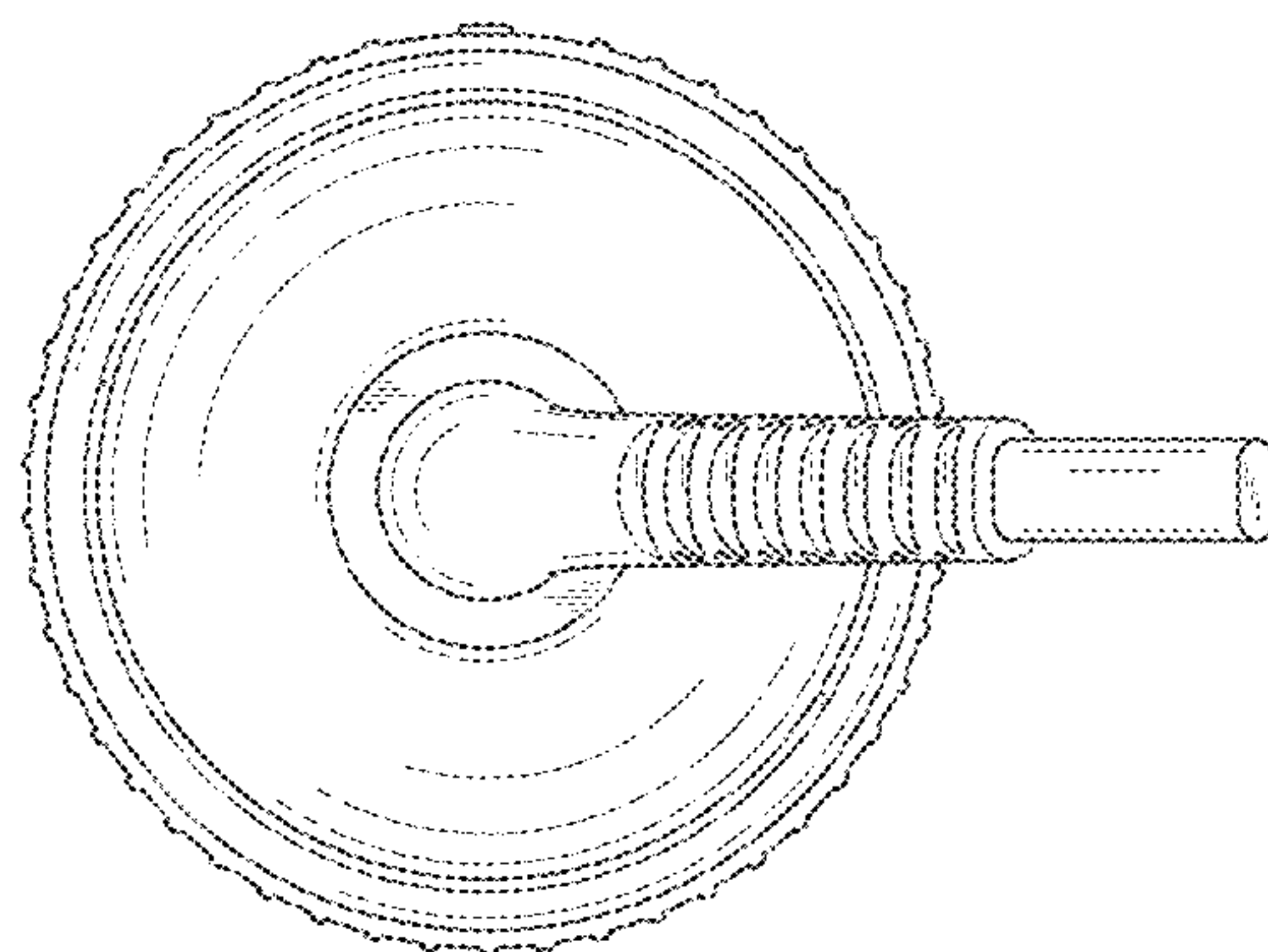

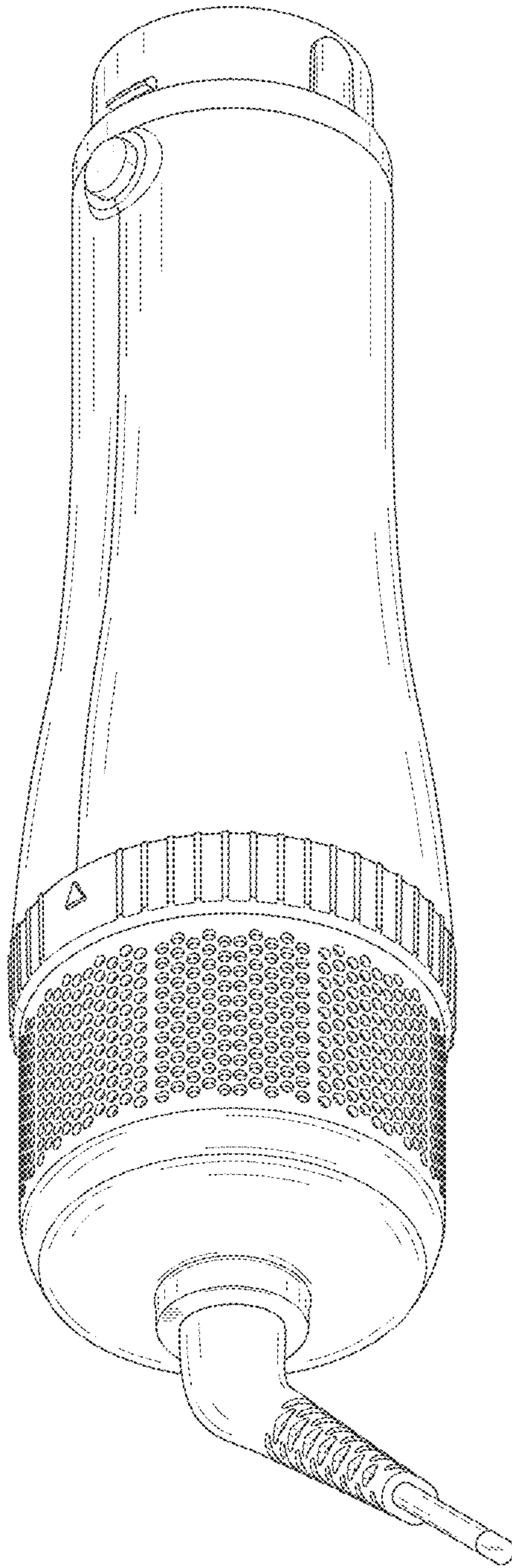

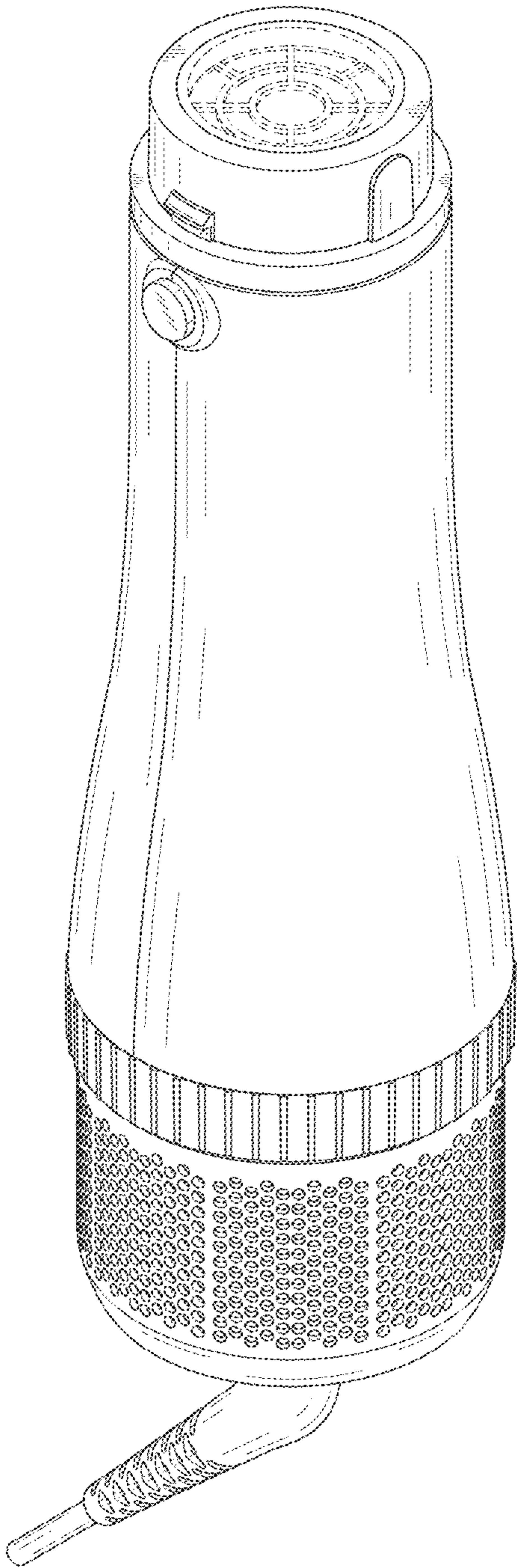
