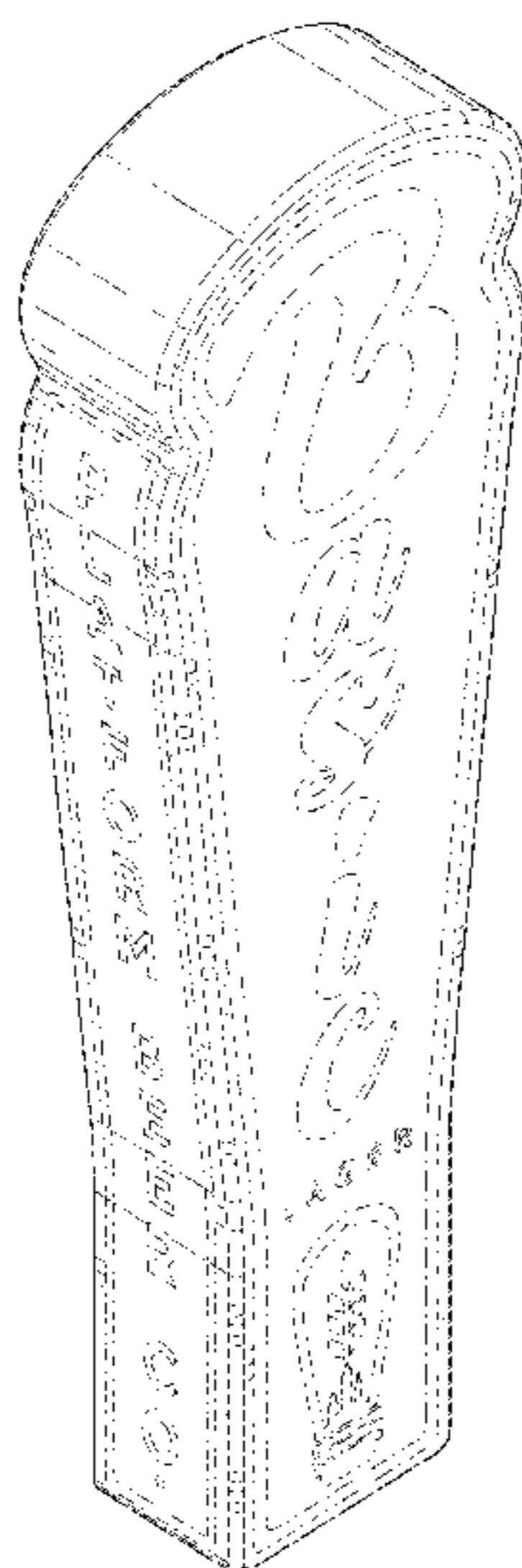
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a tap handle showing our new design;
FIG. 2 is a left side view of the tap handle illustrated in FIG. 1;
FIG. 3 is a front view of the tap handle illustrated in FIG. 1;
FIG. 4 is a right side view of the tap handle illustrated in FIG. 1;

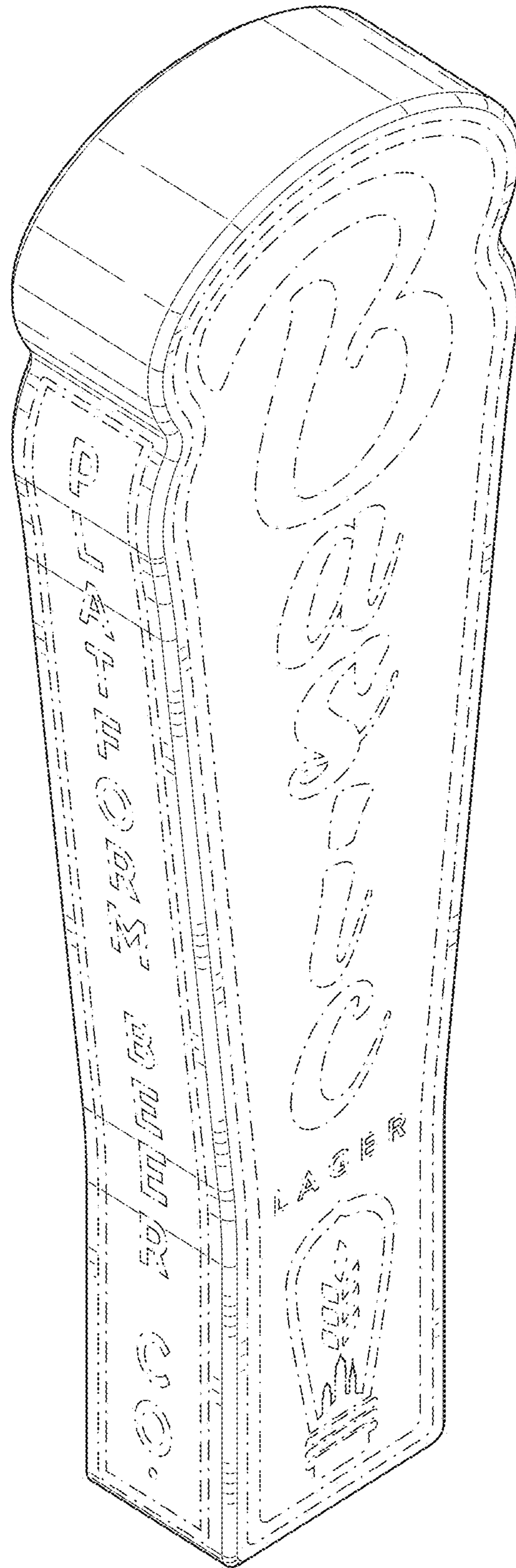

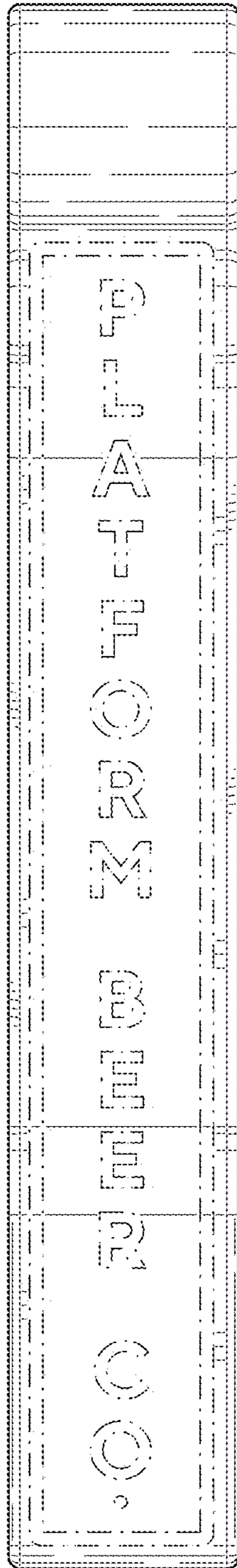

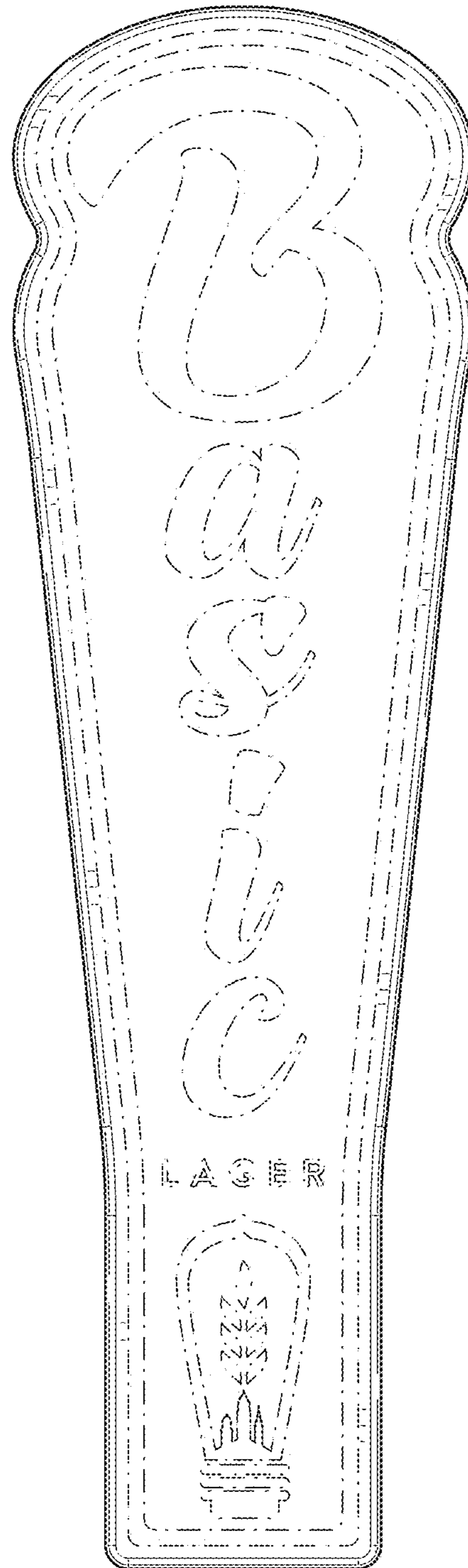

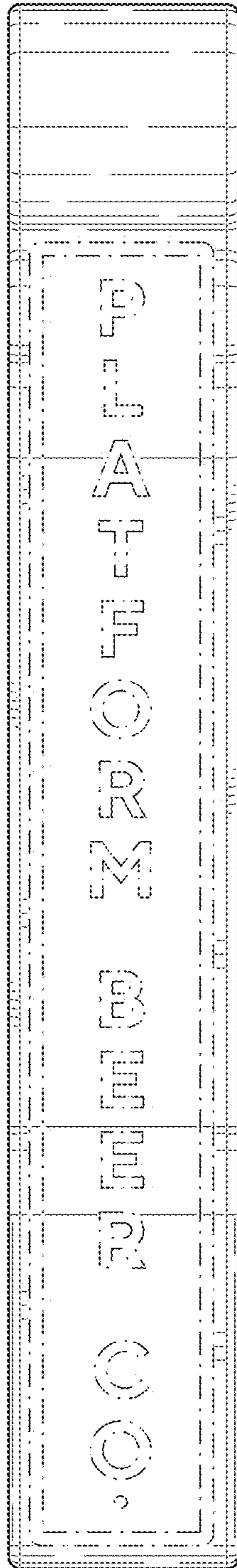

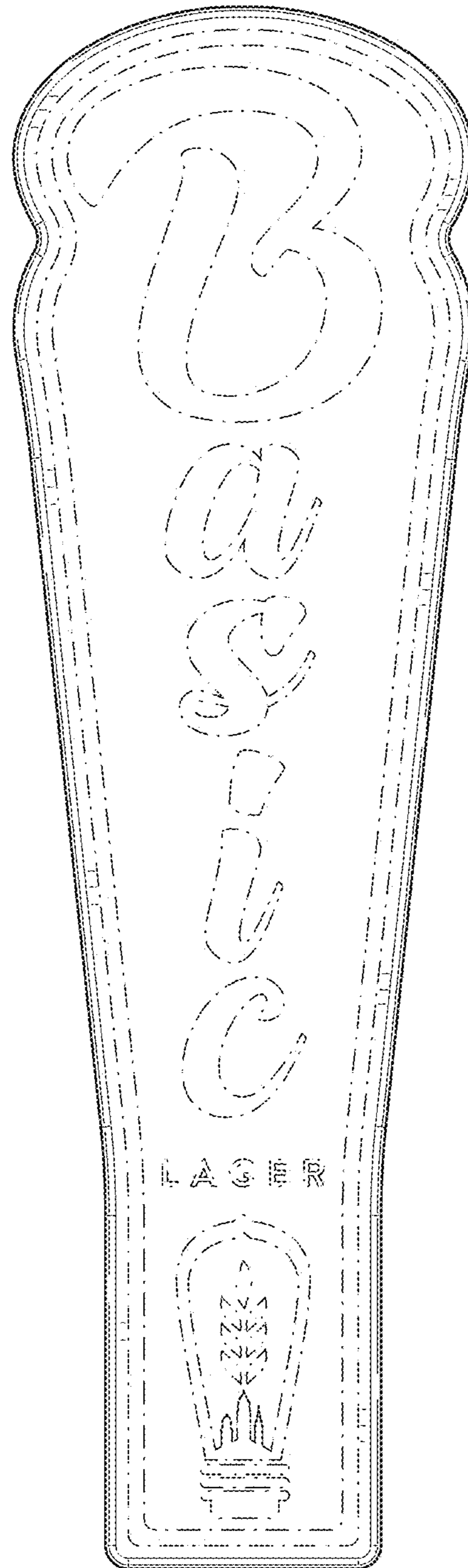

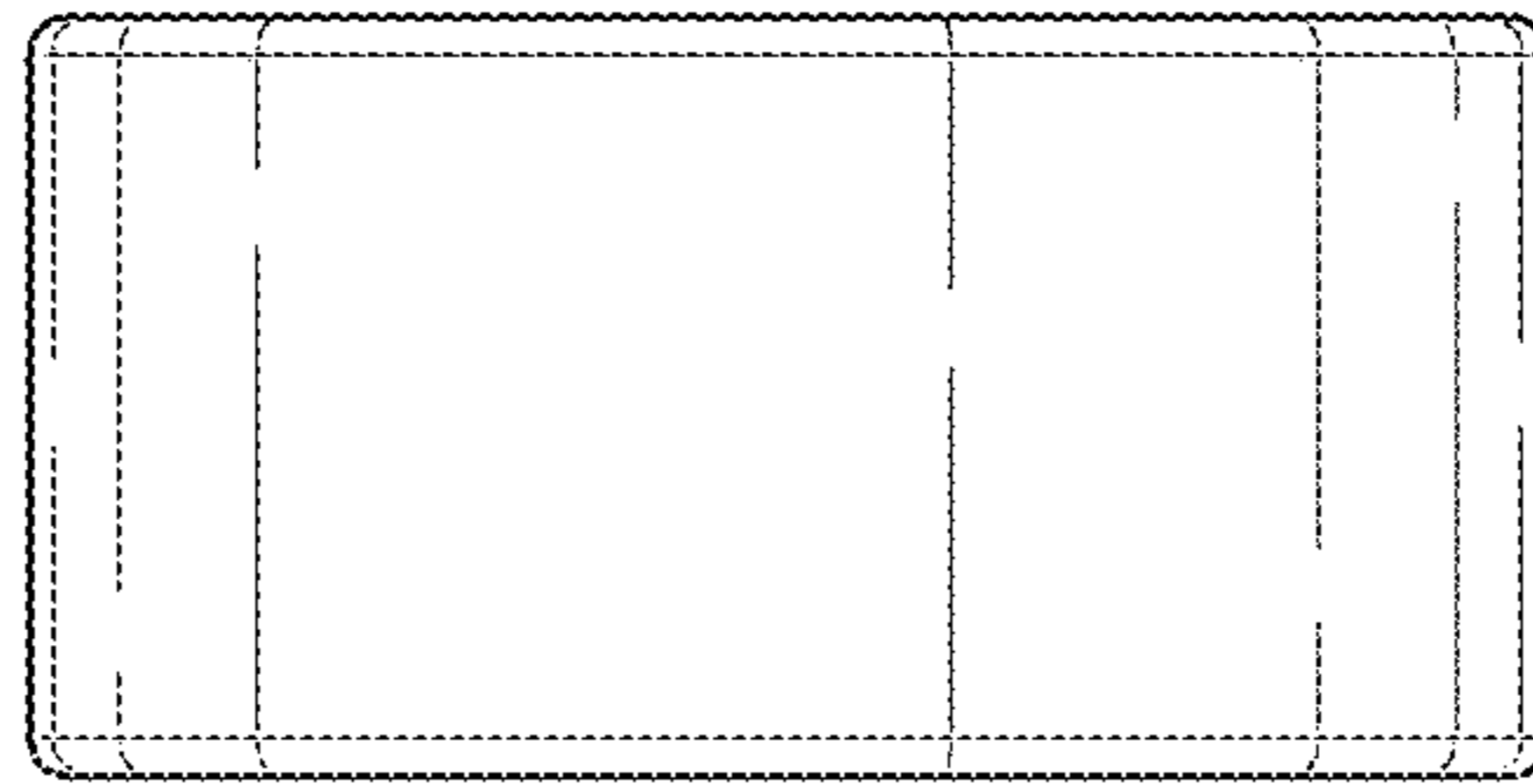

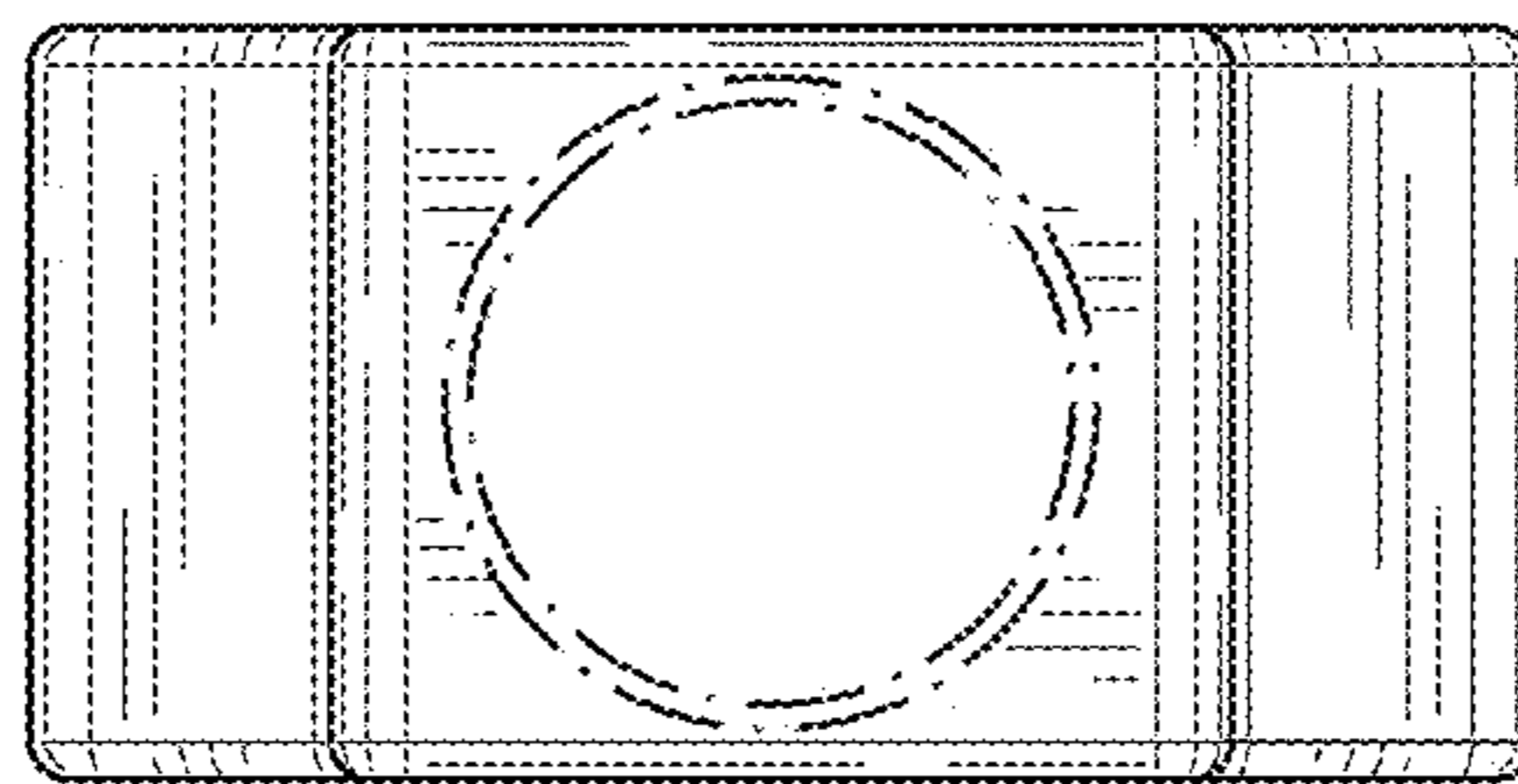
