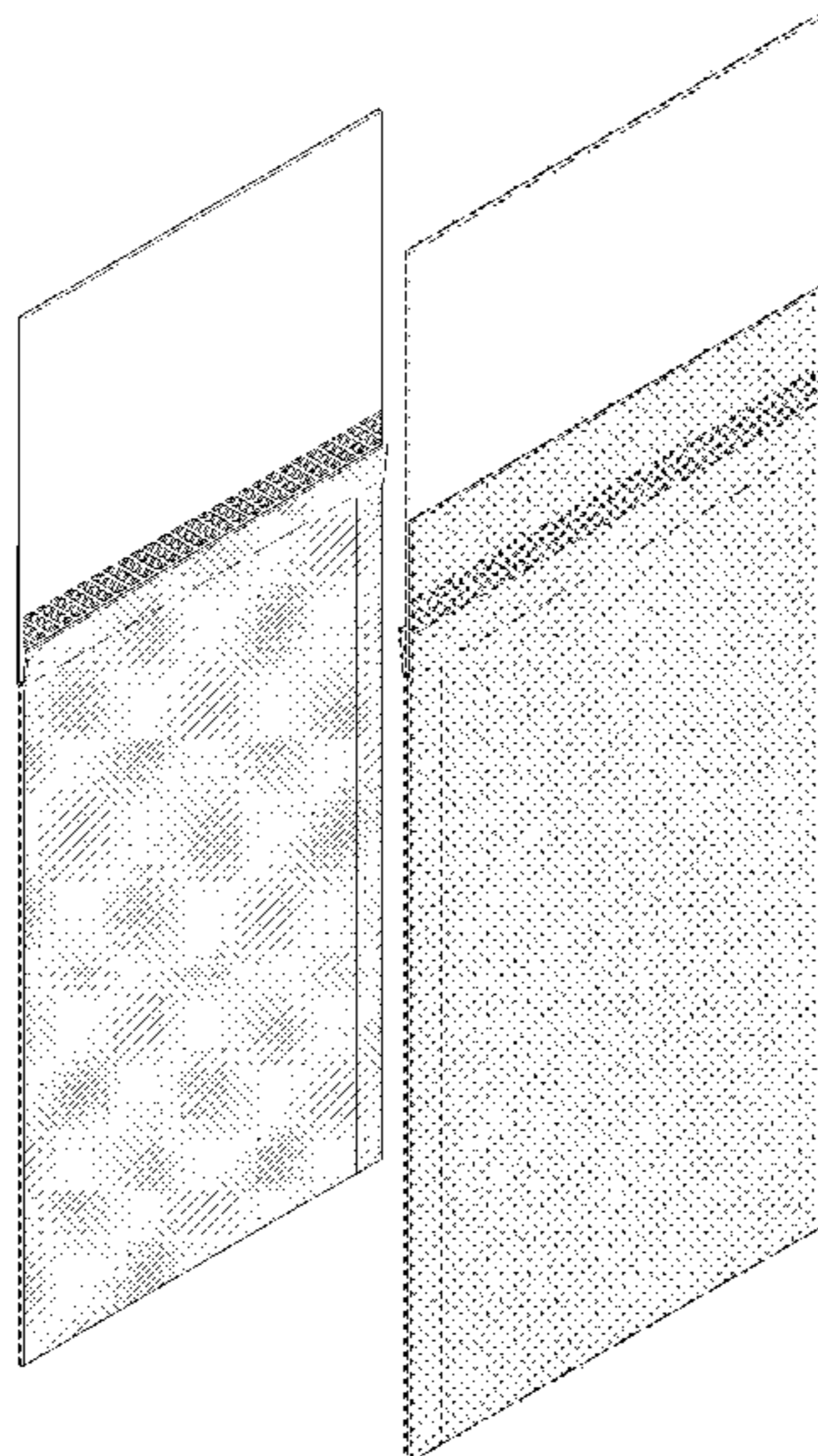
(57) **CLAIM**

The ornamental design for a tea filter, as shown and described.

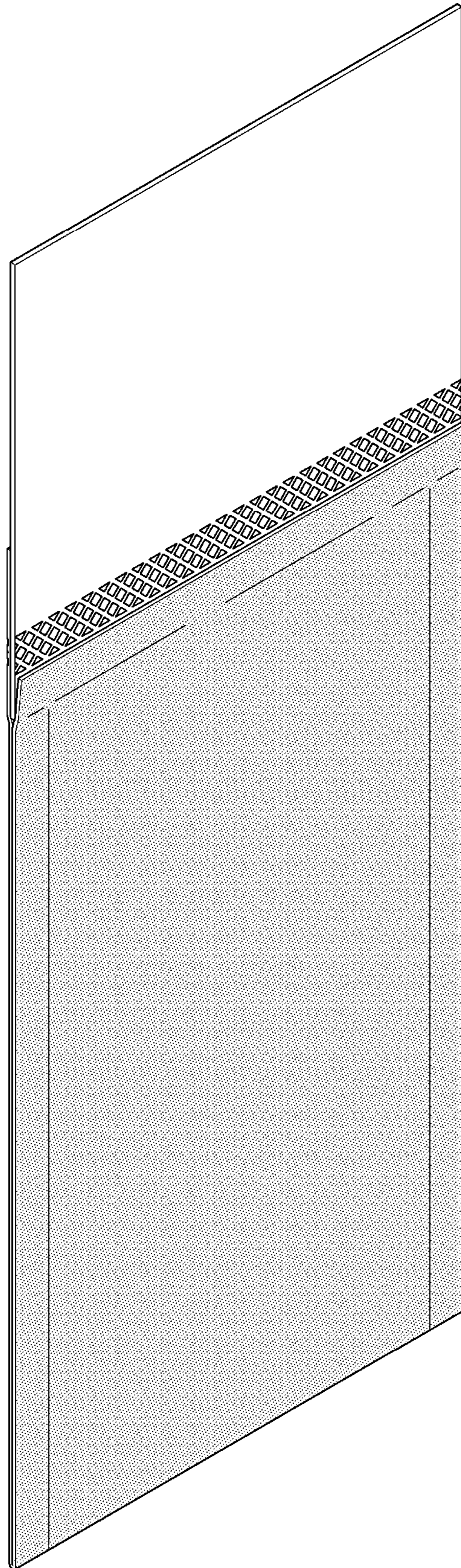
DESCRIPTION

- 1.8 is a right elevation view thereof.

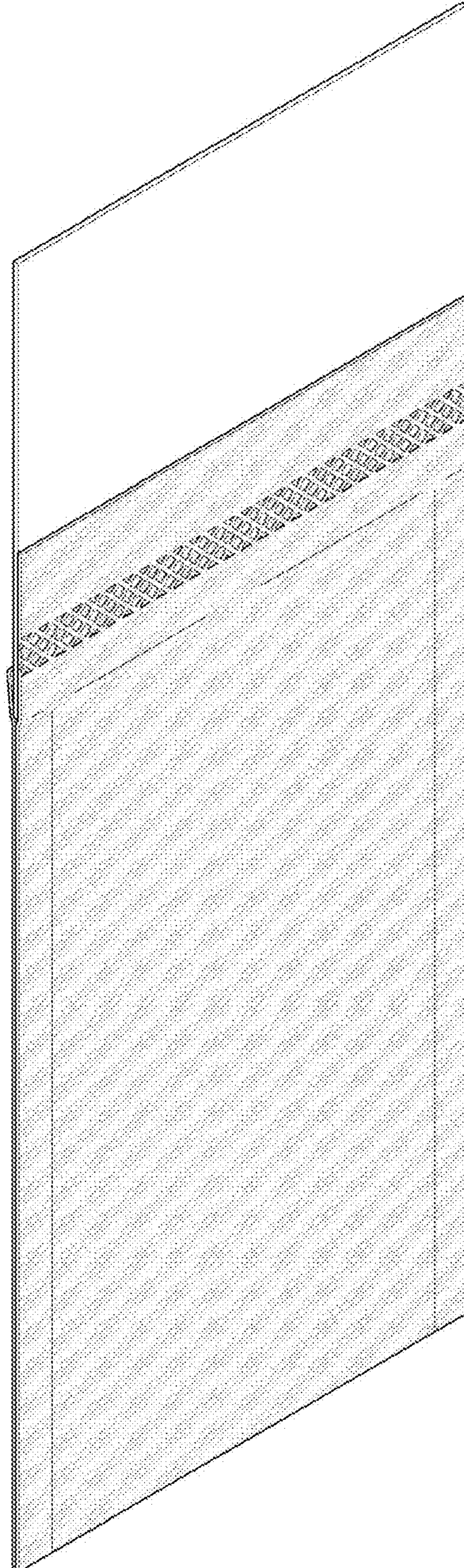

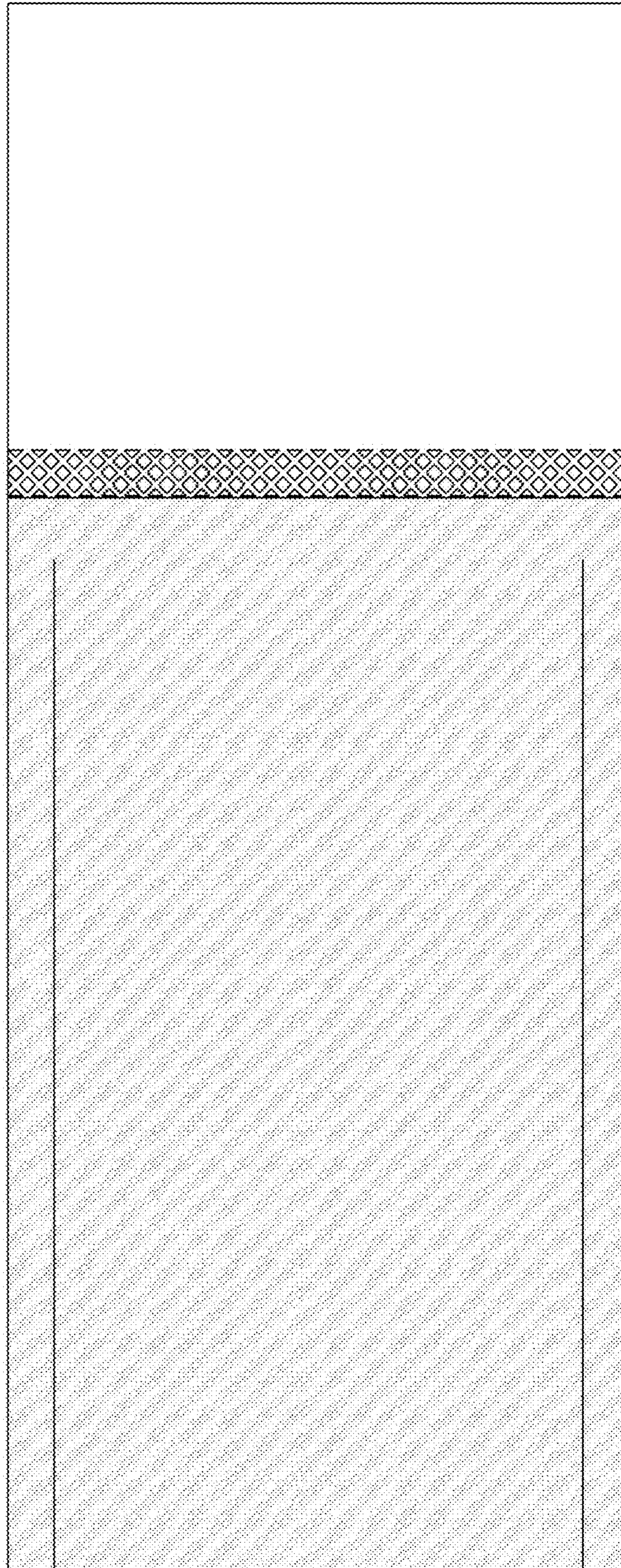

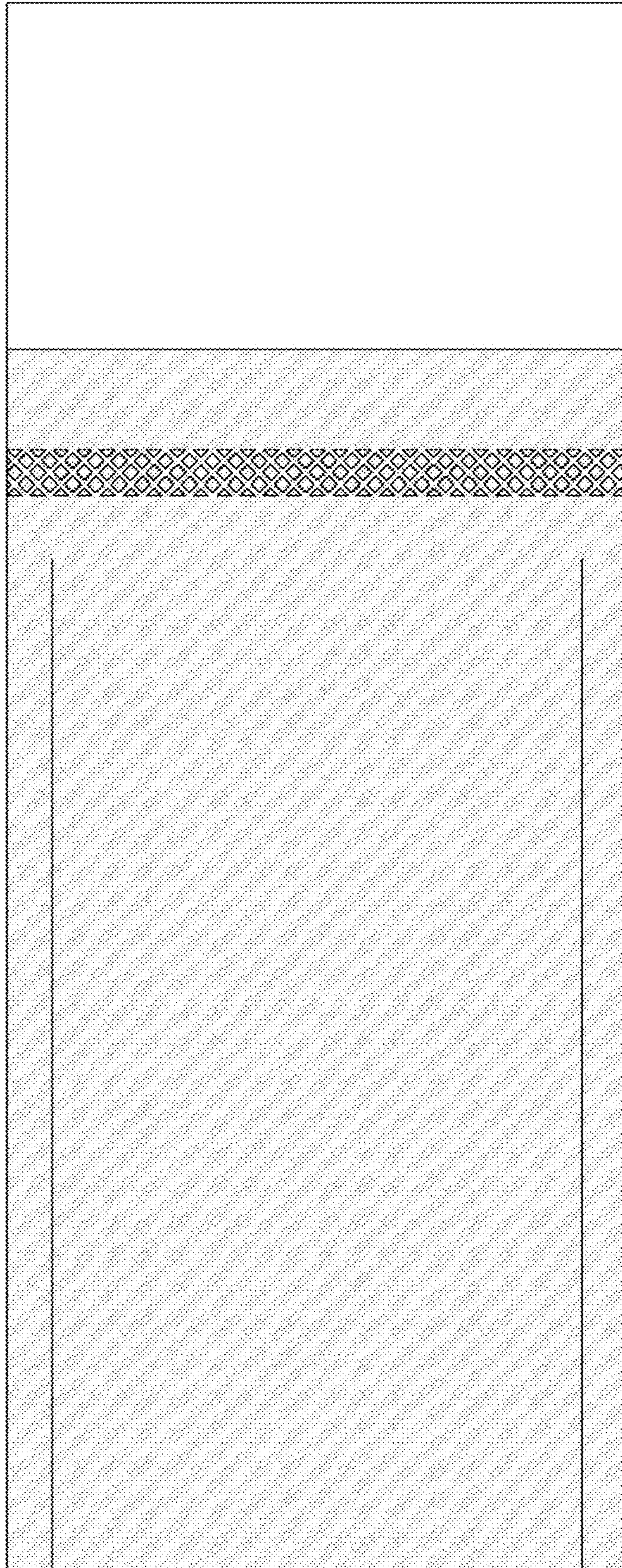

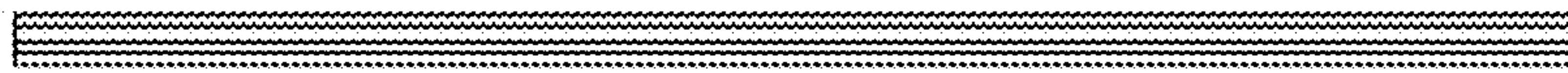

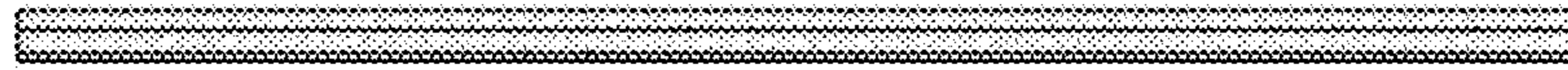

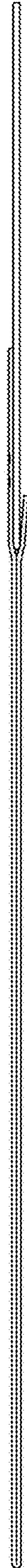
