The ornamental design for a cooler, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a cooler showing my new design;

FIG. 12 is a top view thereof.

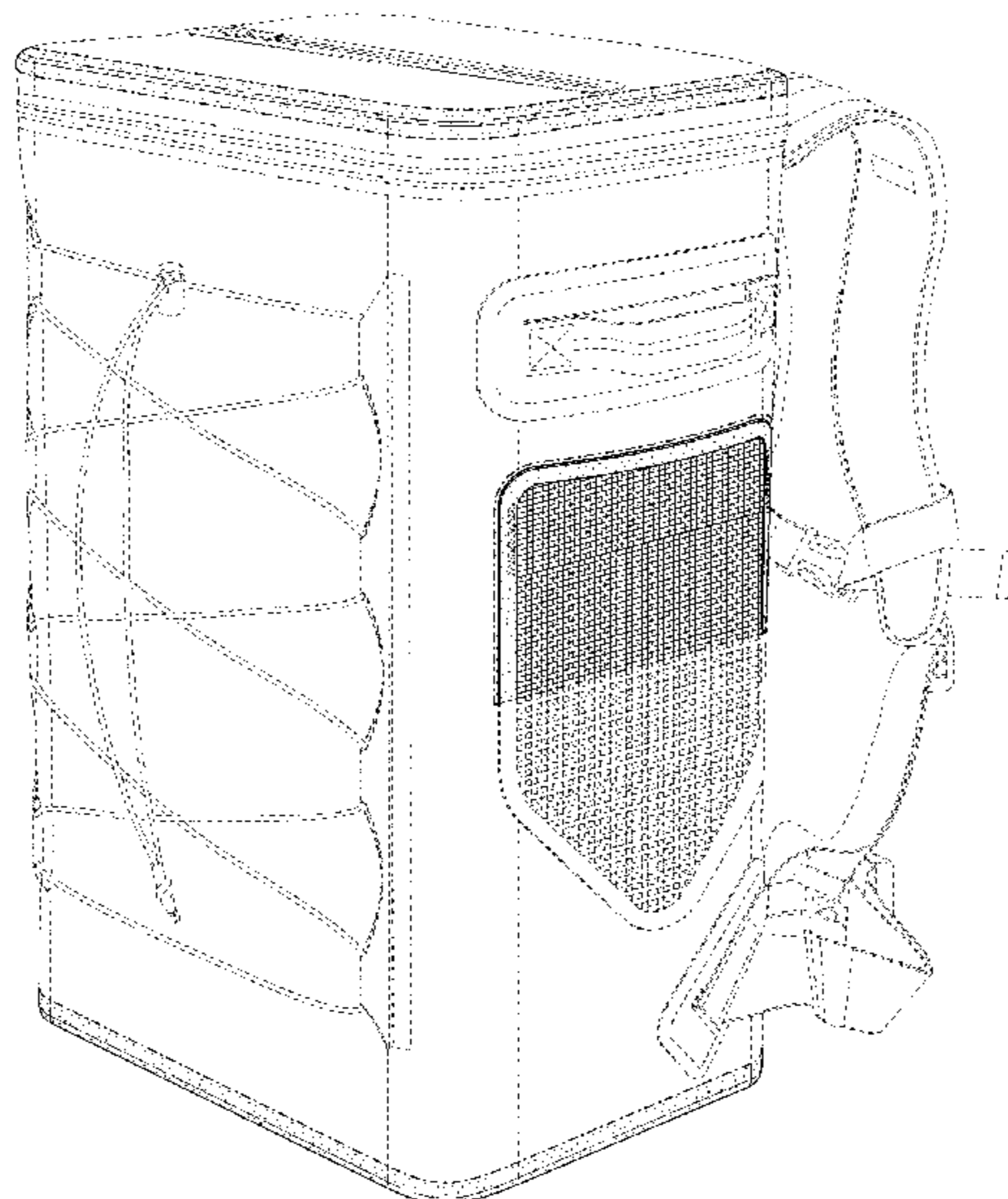
The dash-dash-dash broken lines in the Figures are for the purpose of illustrating unclaimed portions of the cooler and form no part of the claimed design.

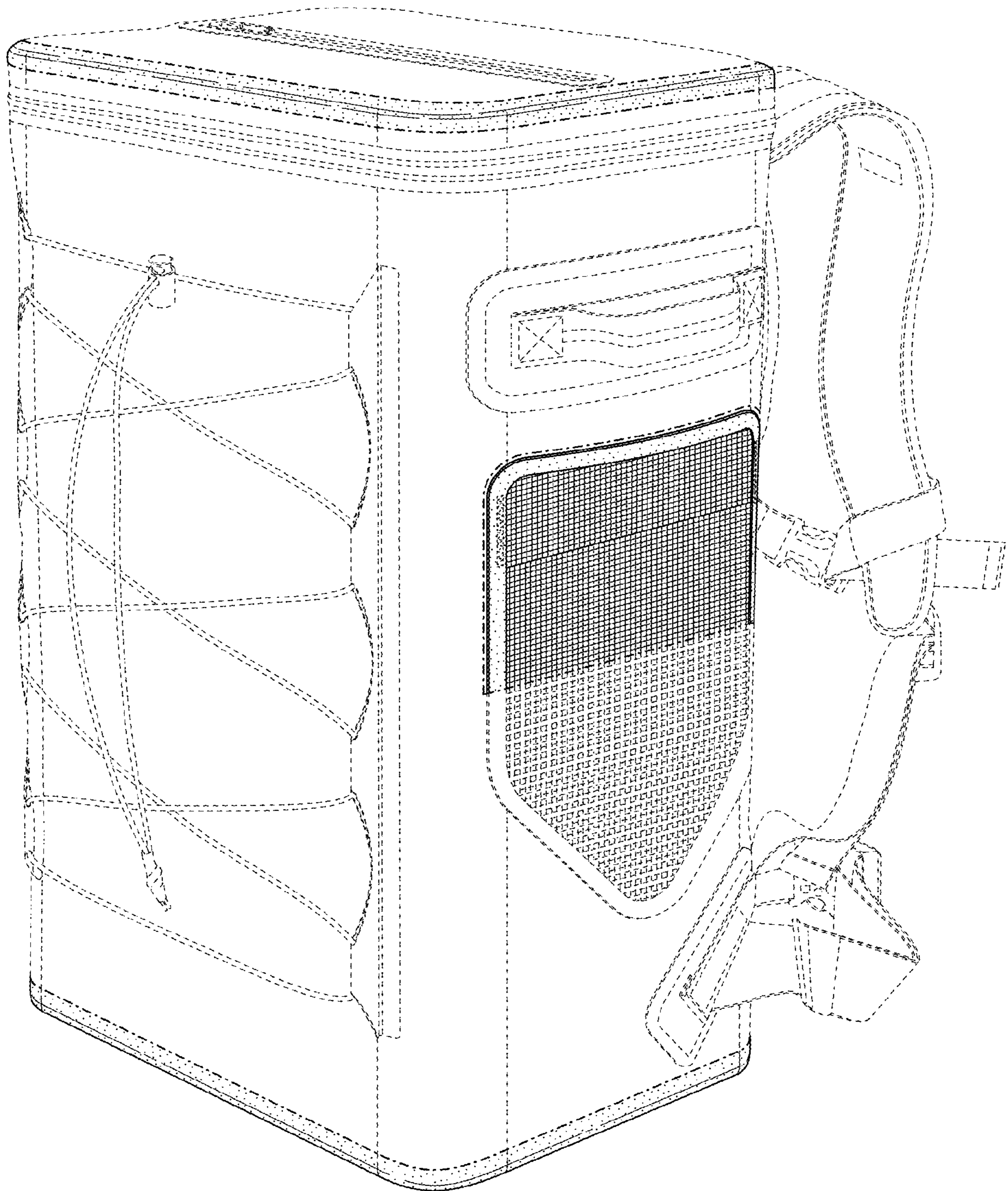

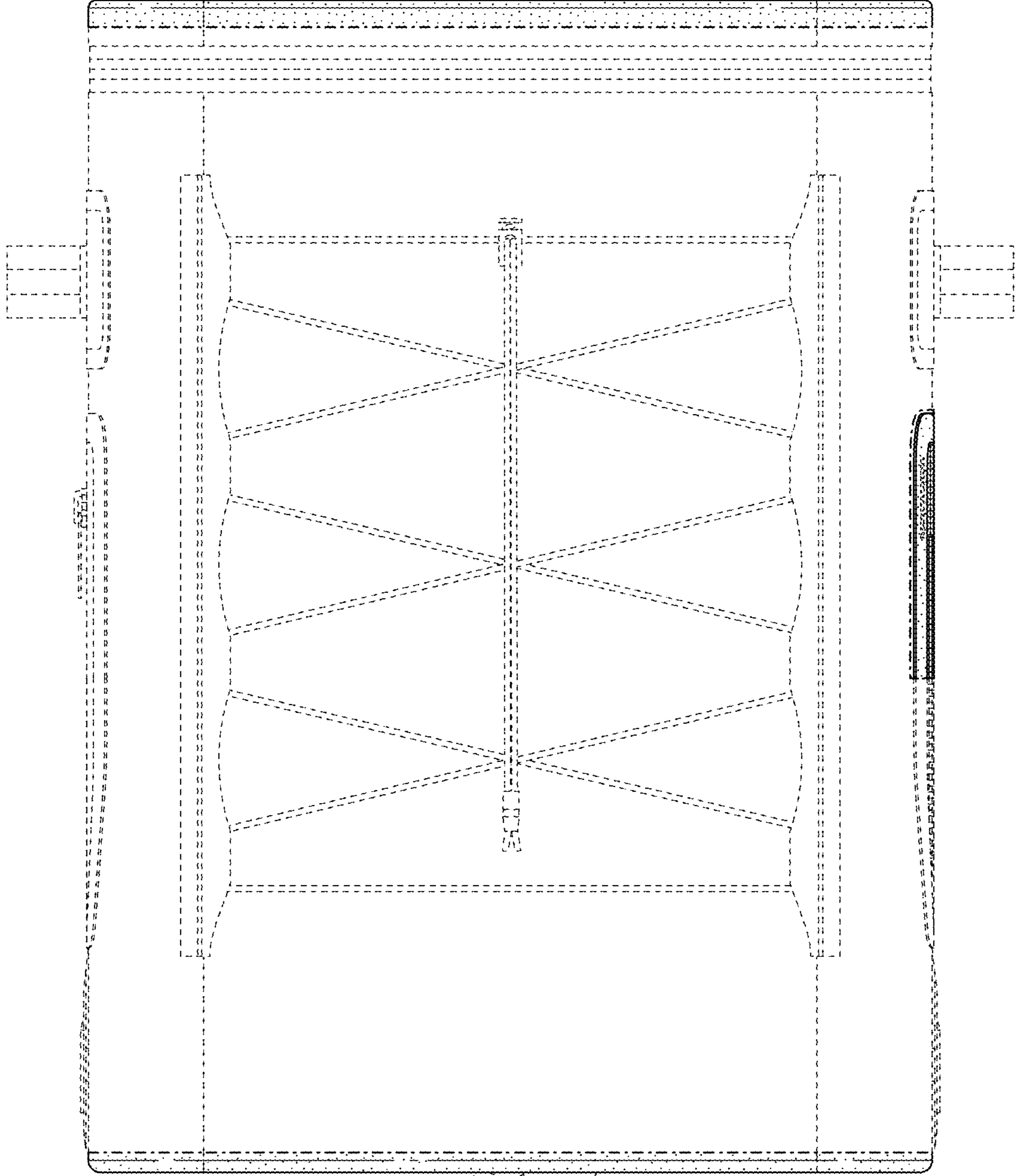

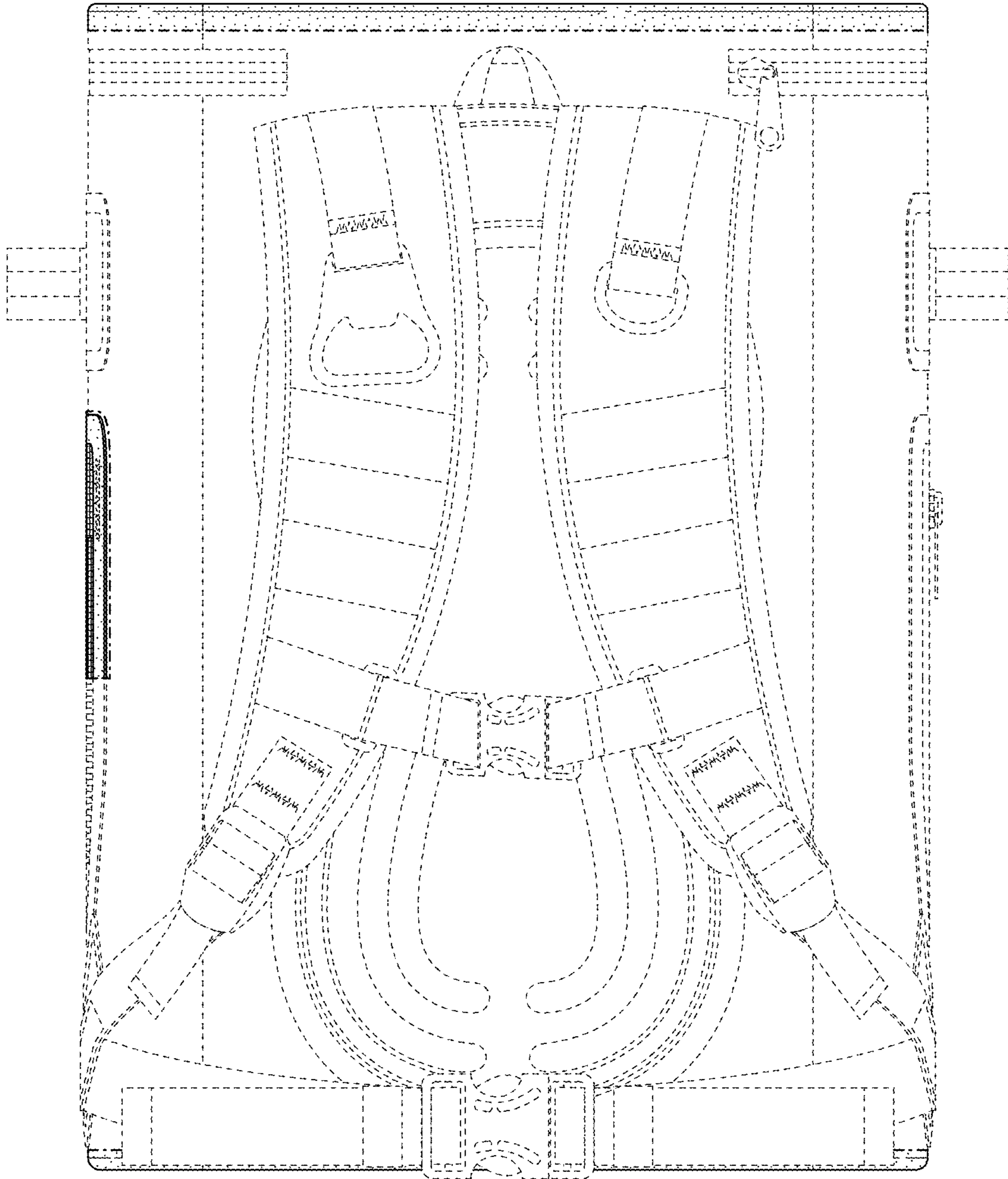

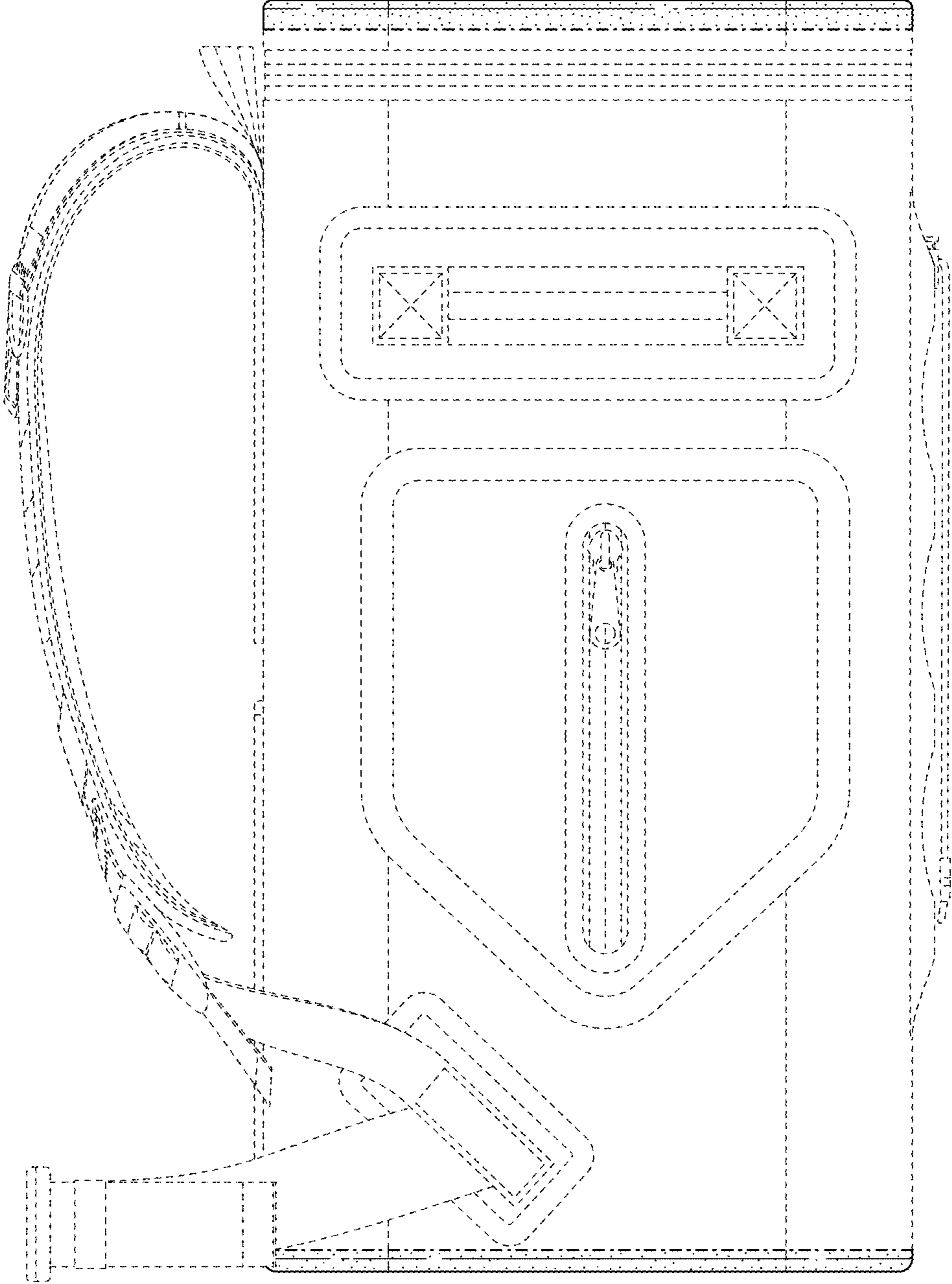

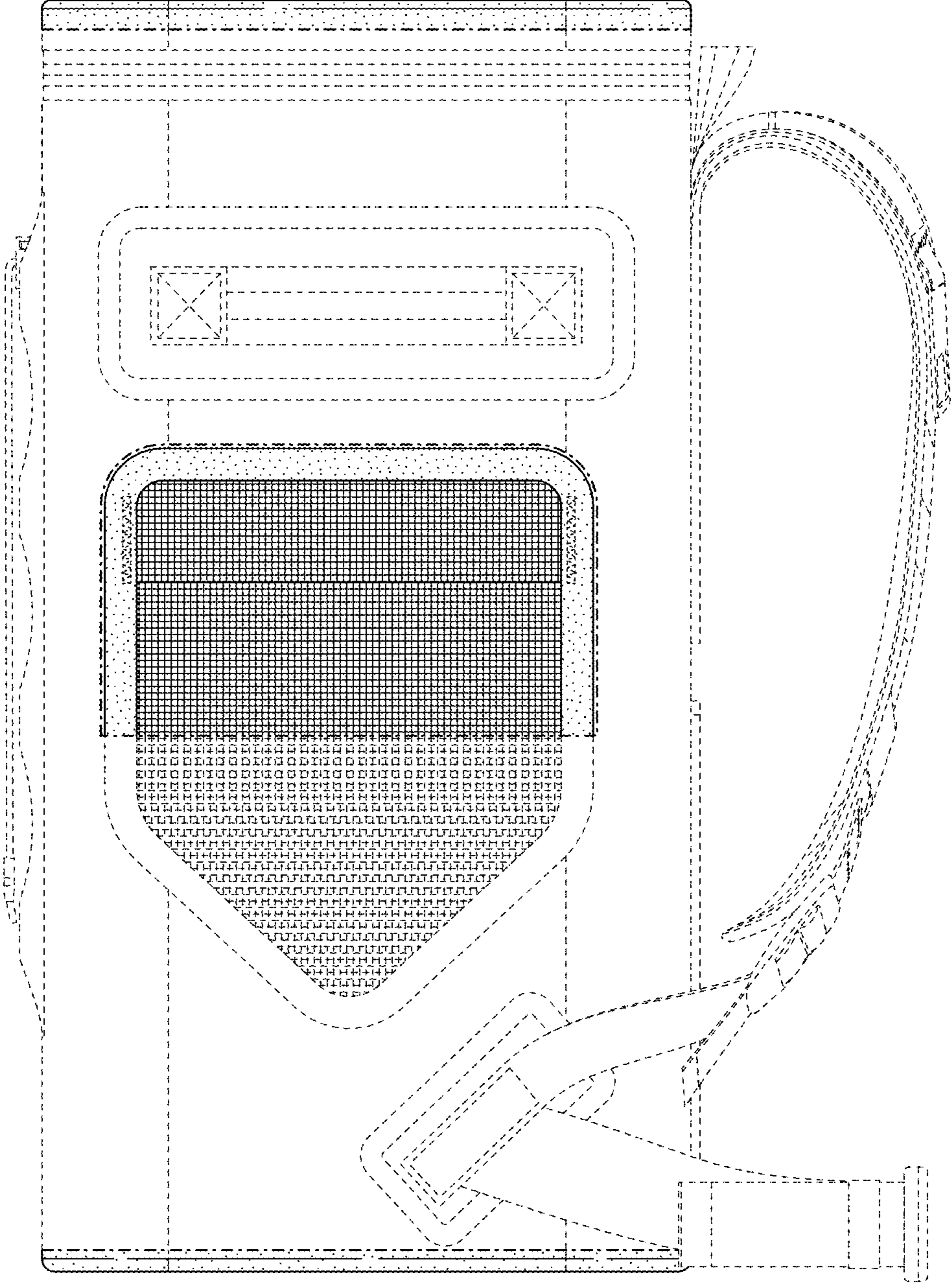

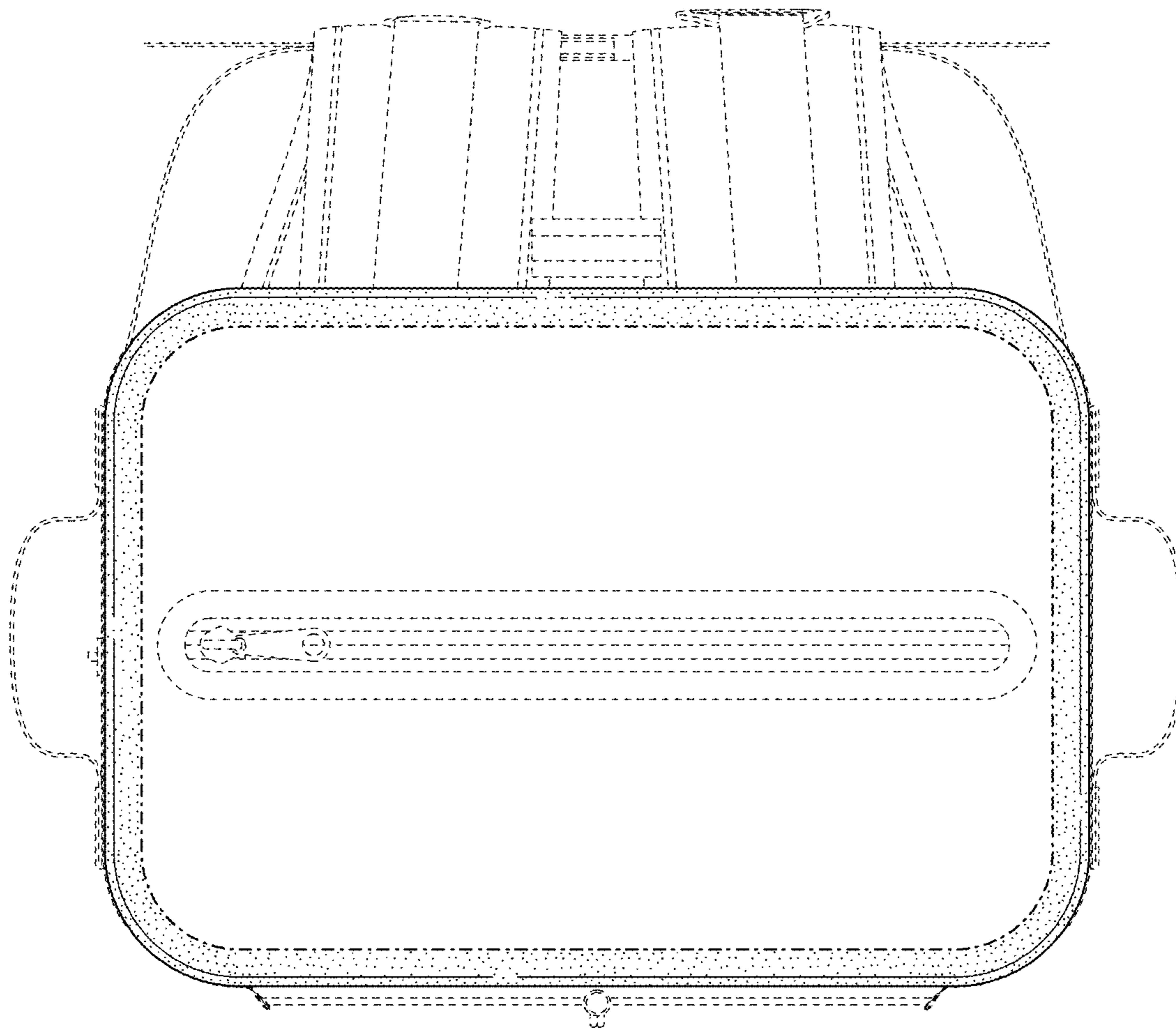

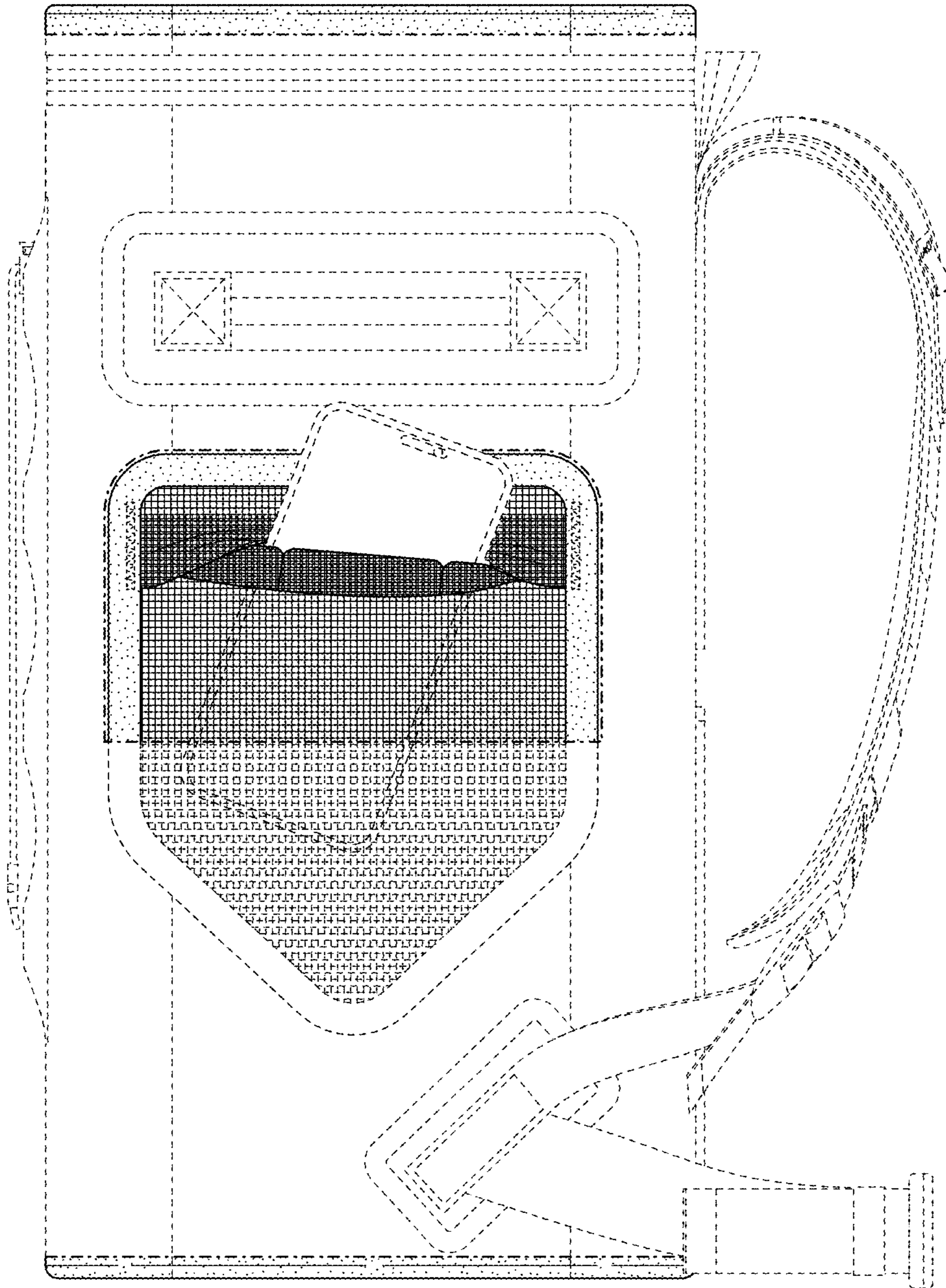

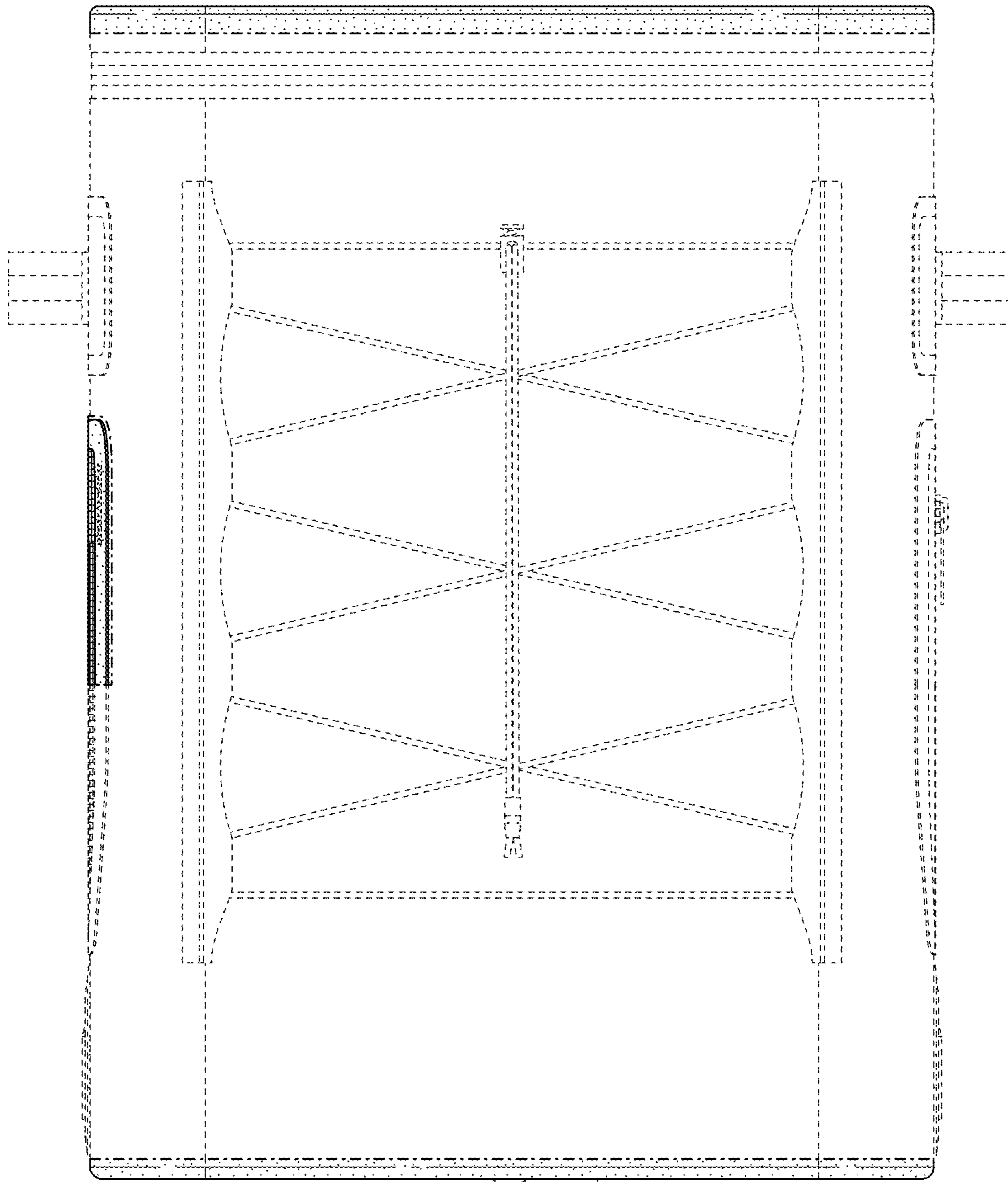

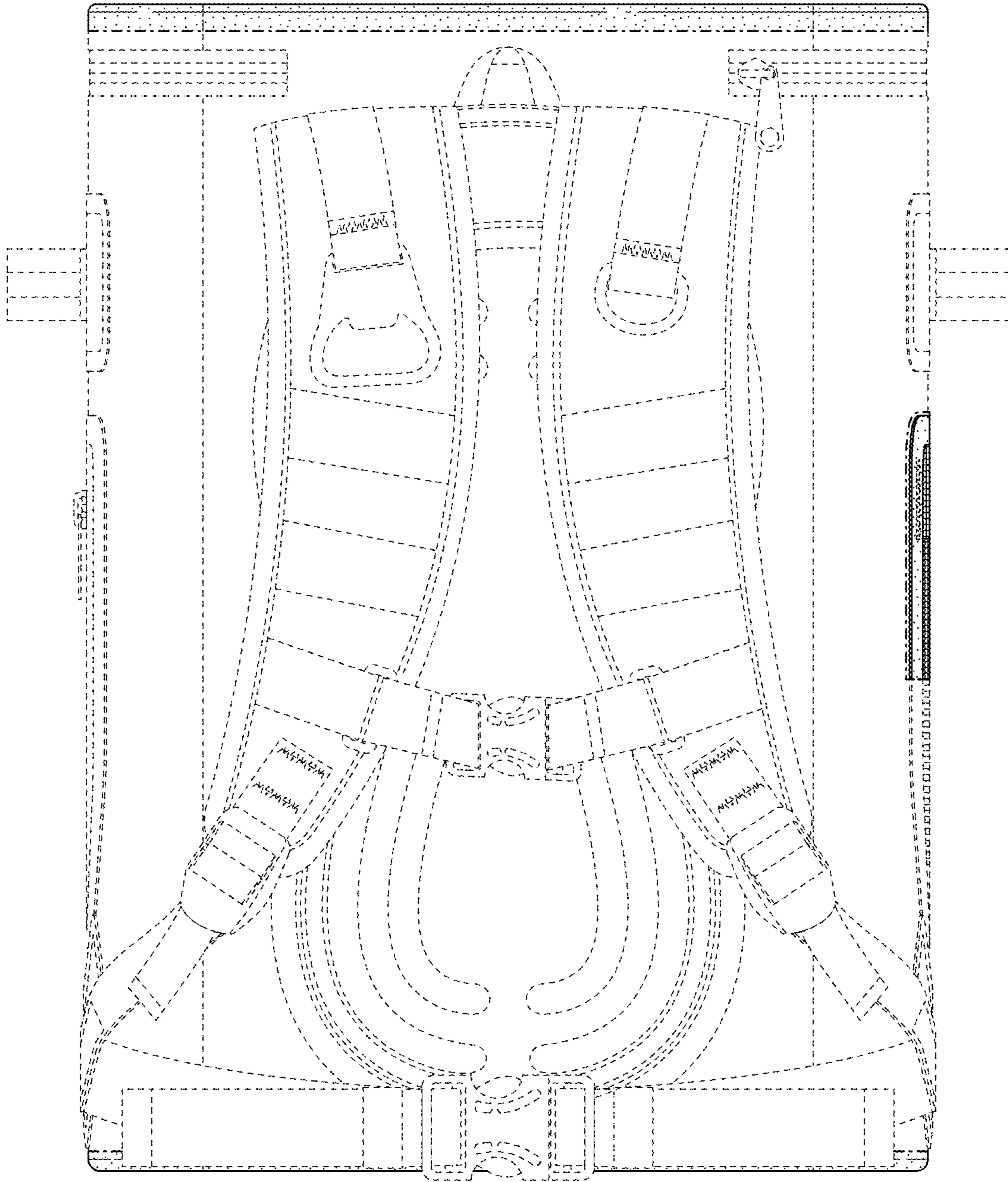

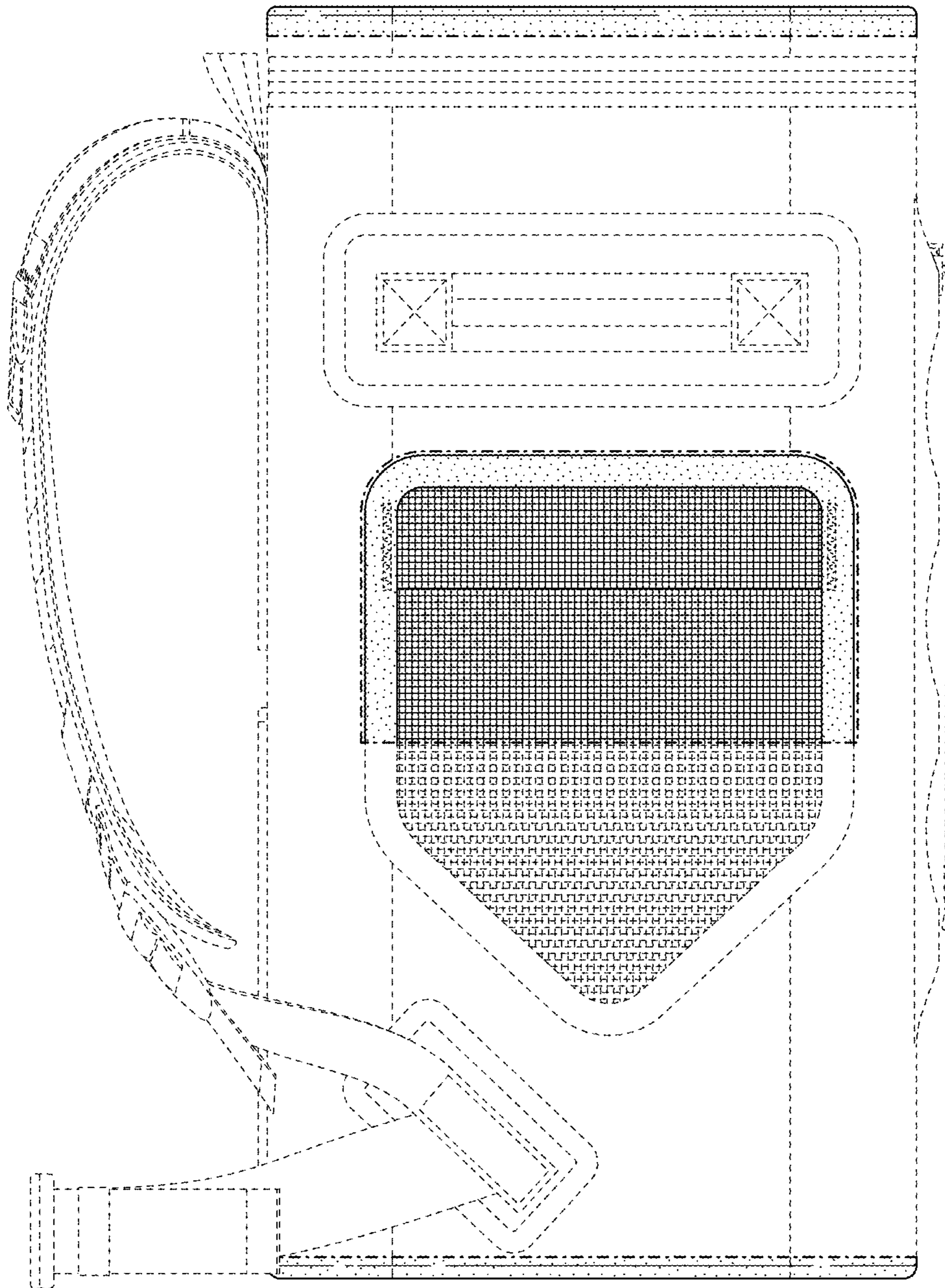

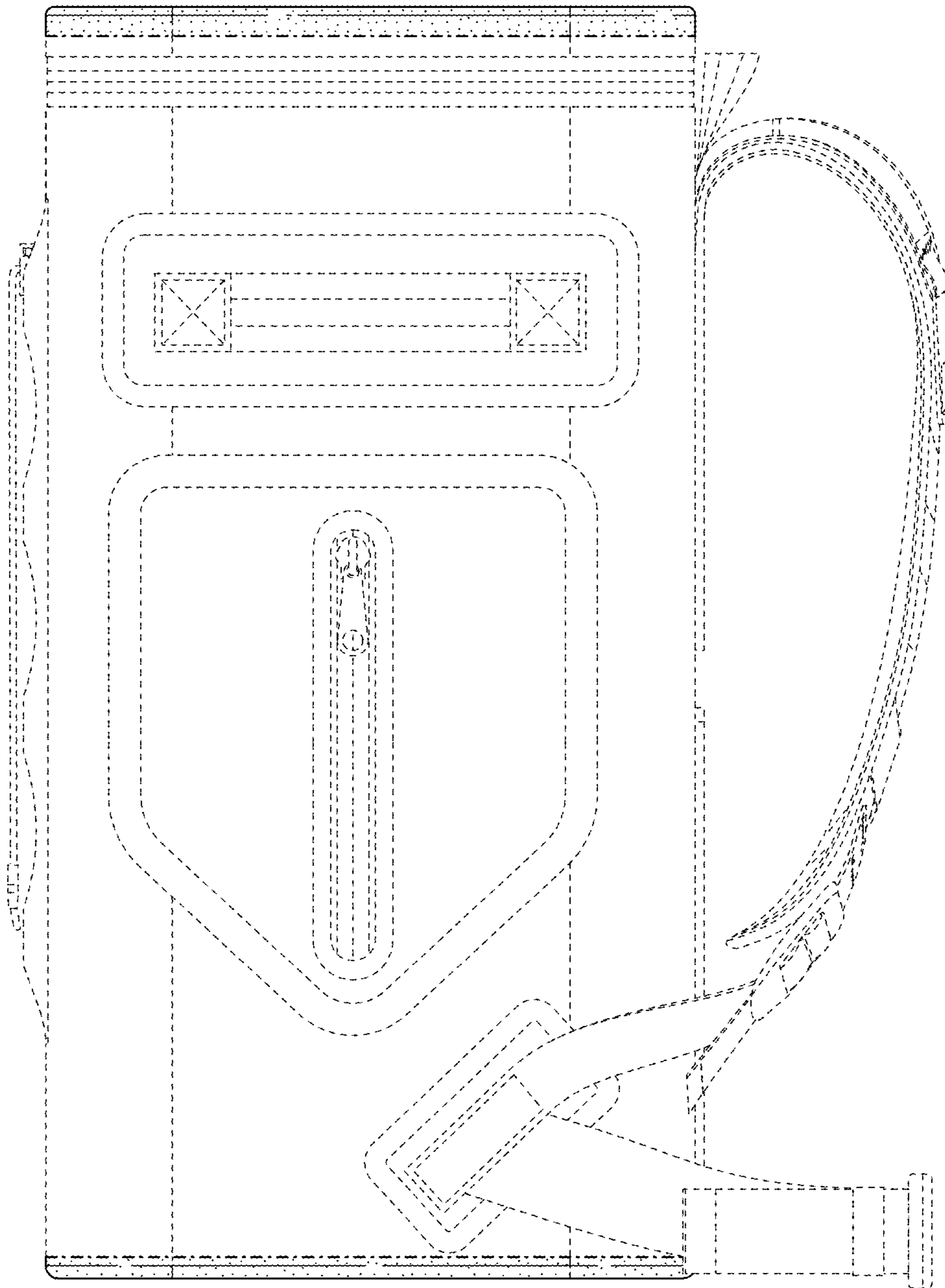

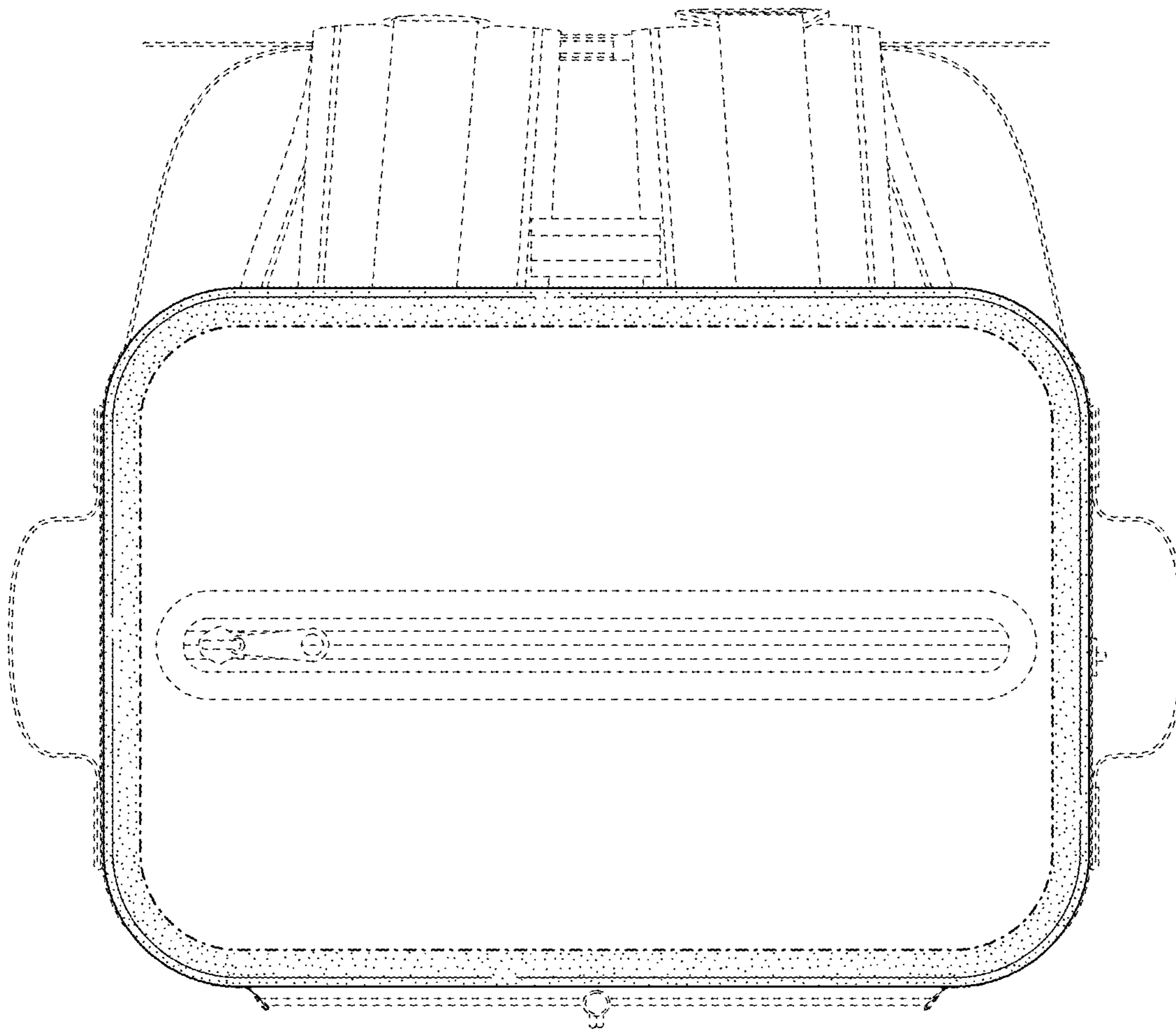
