FIG. 3.

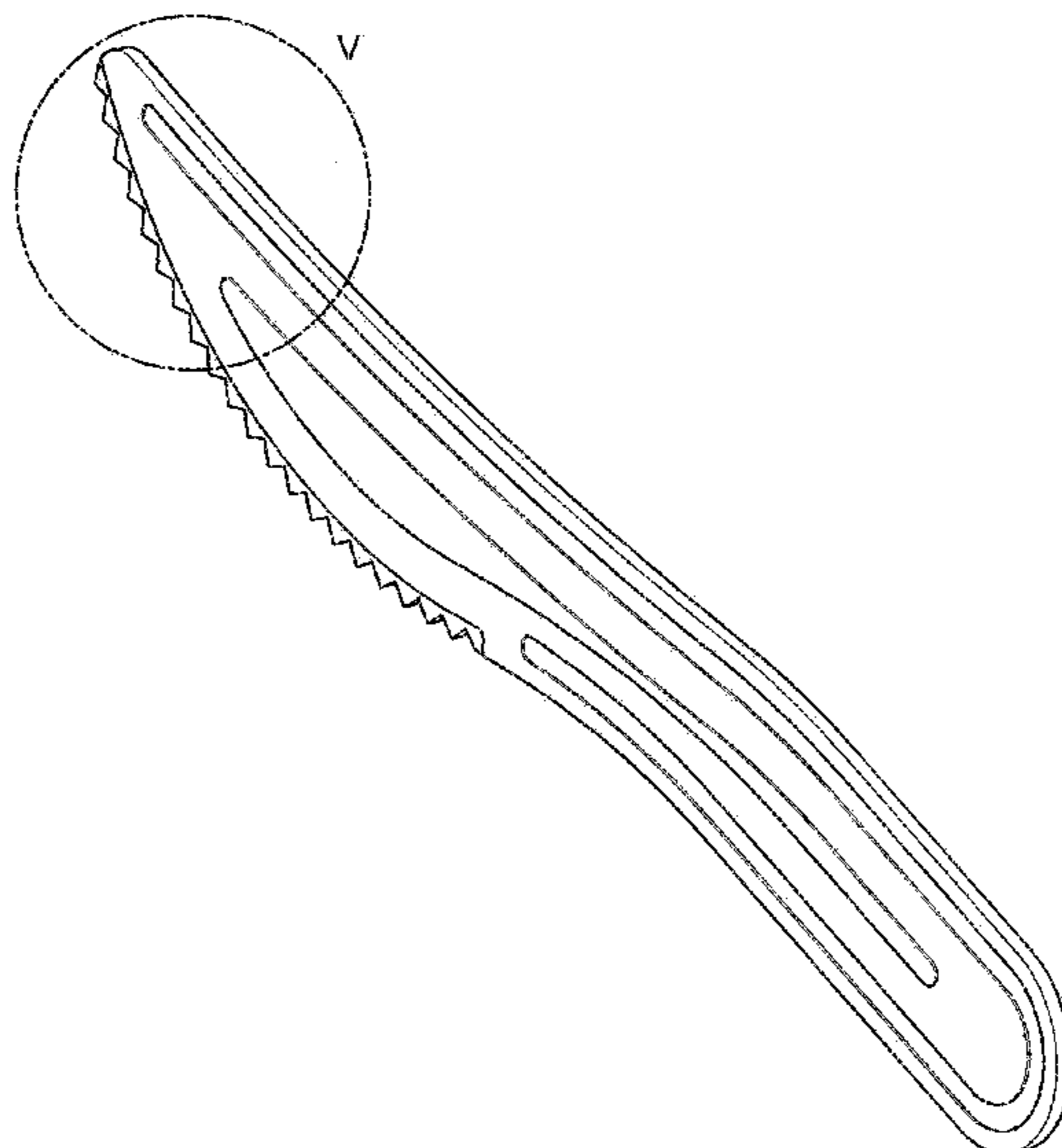
The short dash-long dash broken lines in FIGS. 1 and 5,

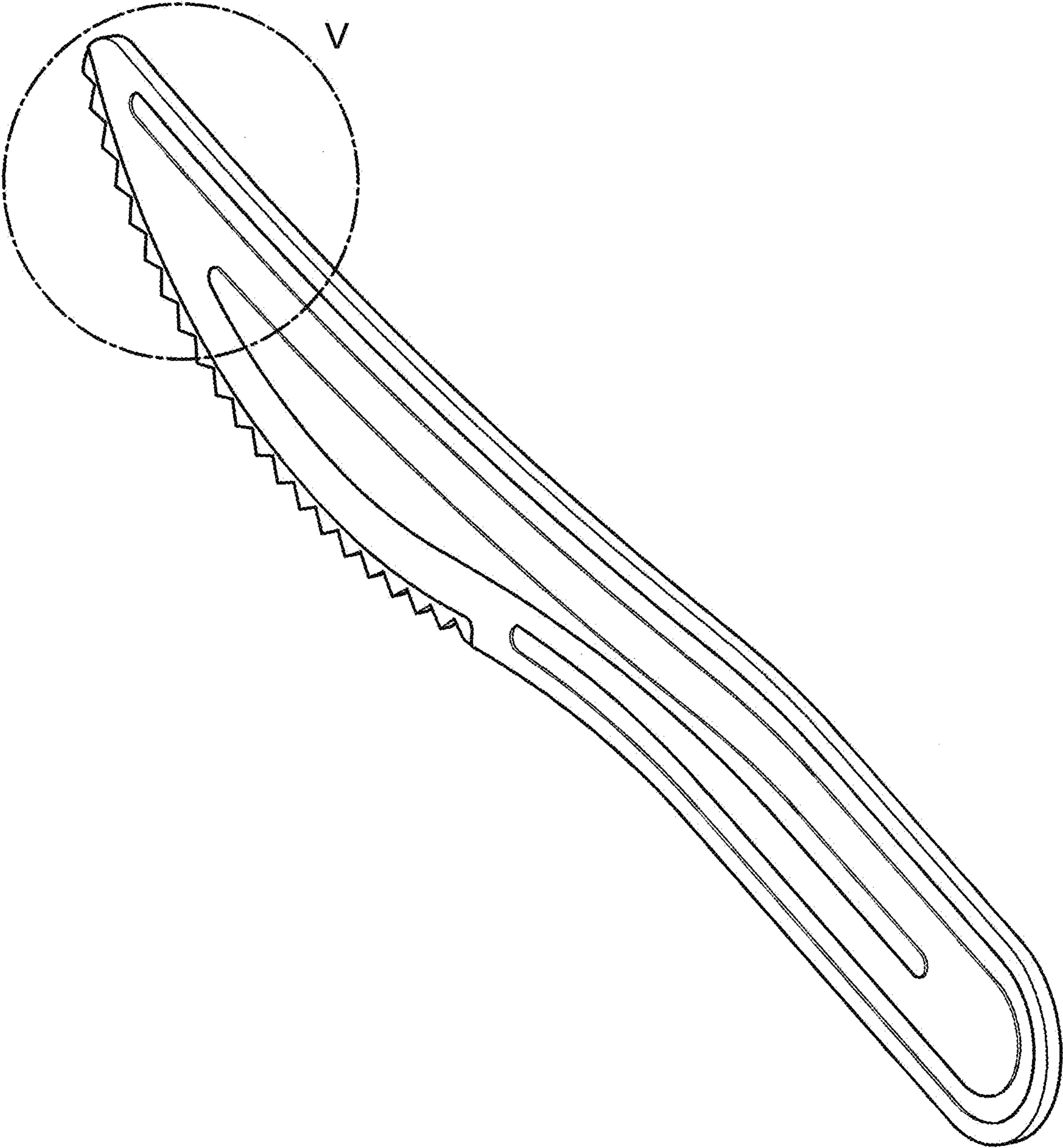

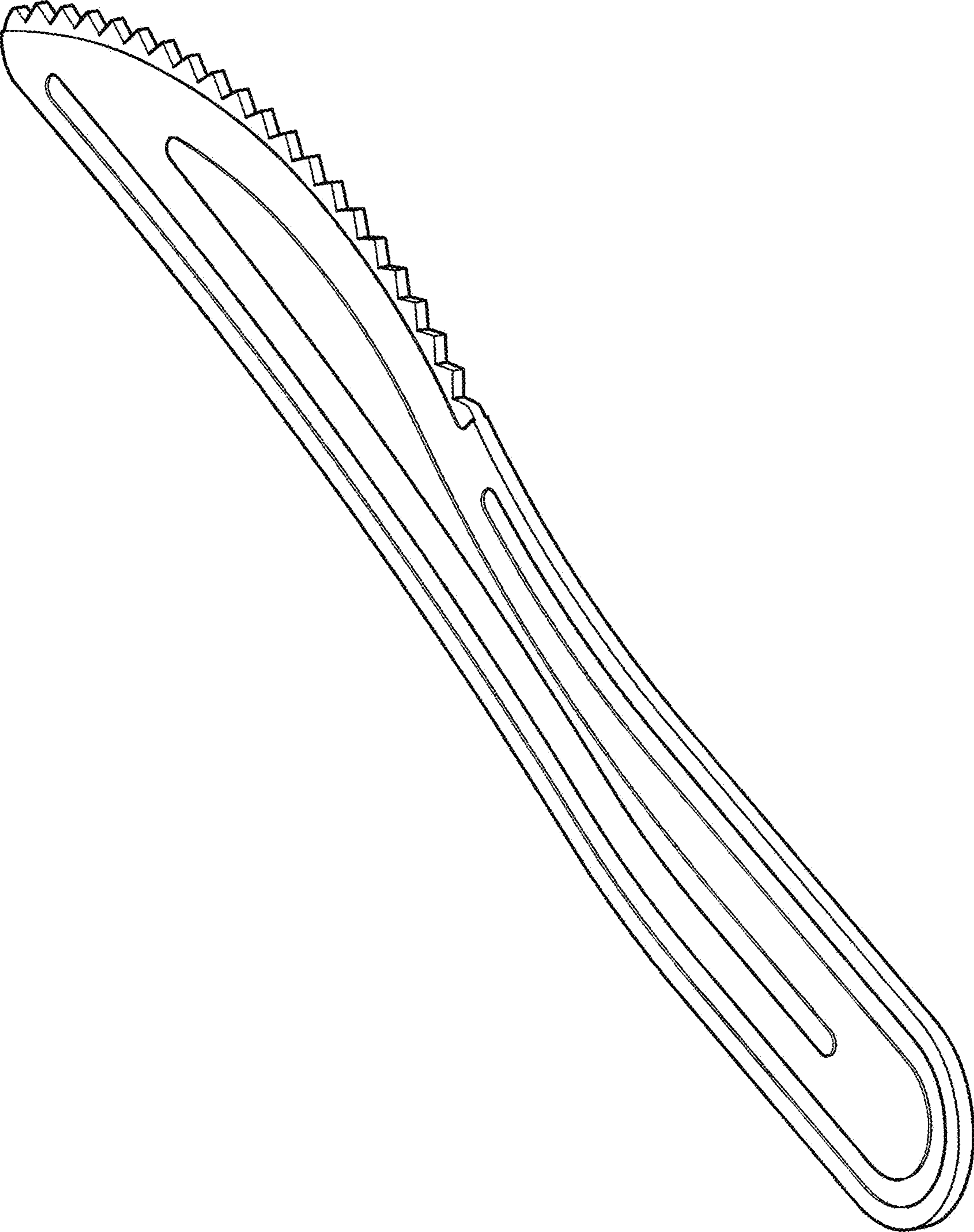

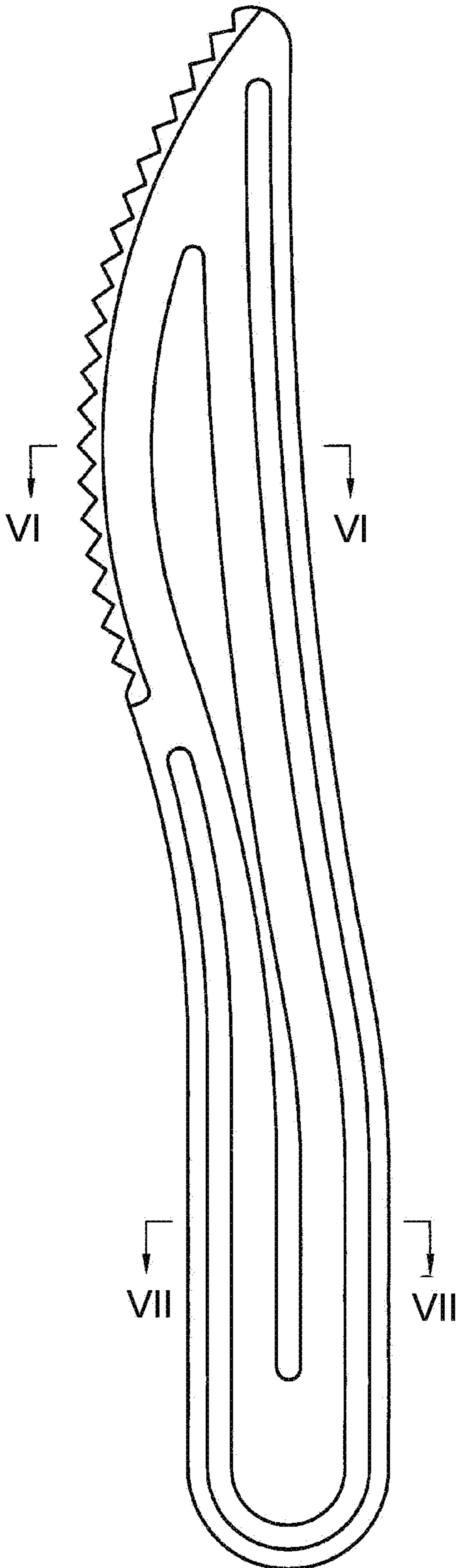

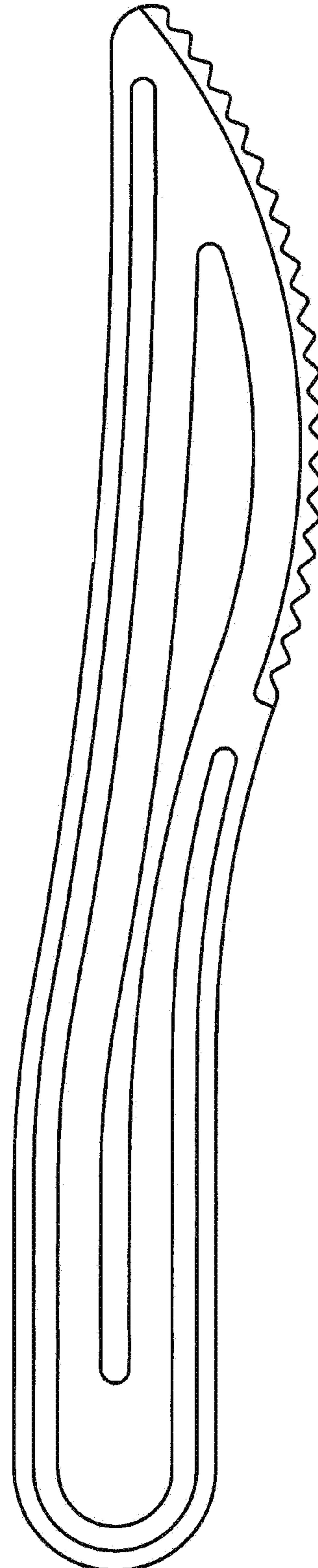

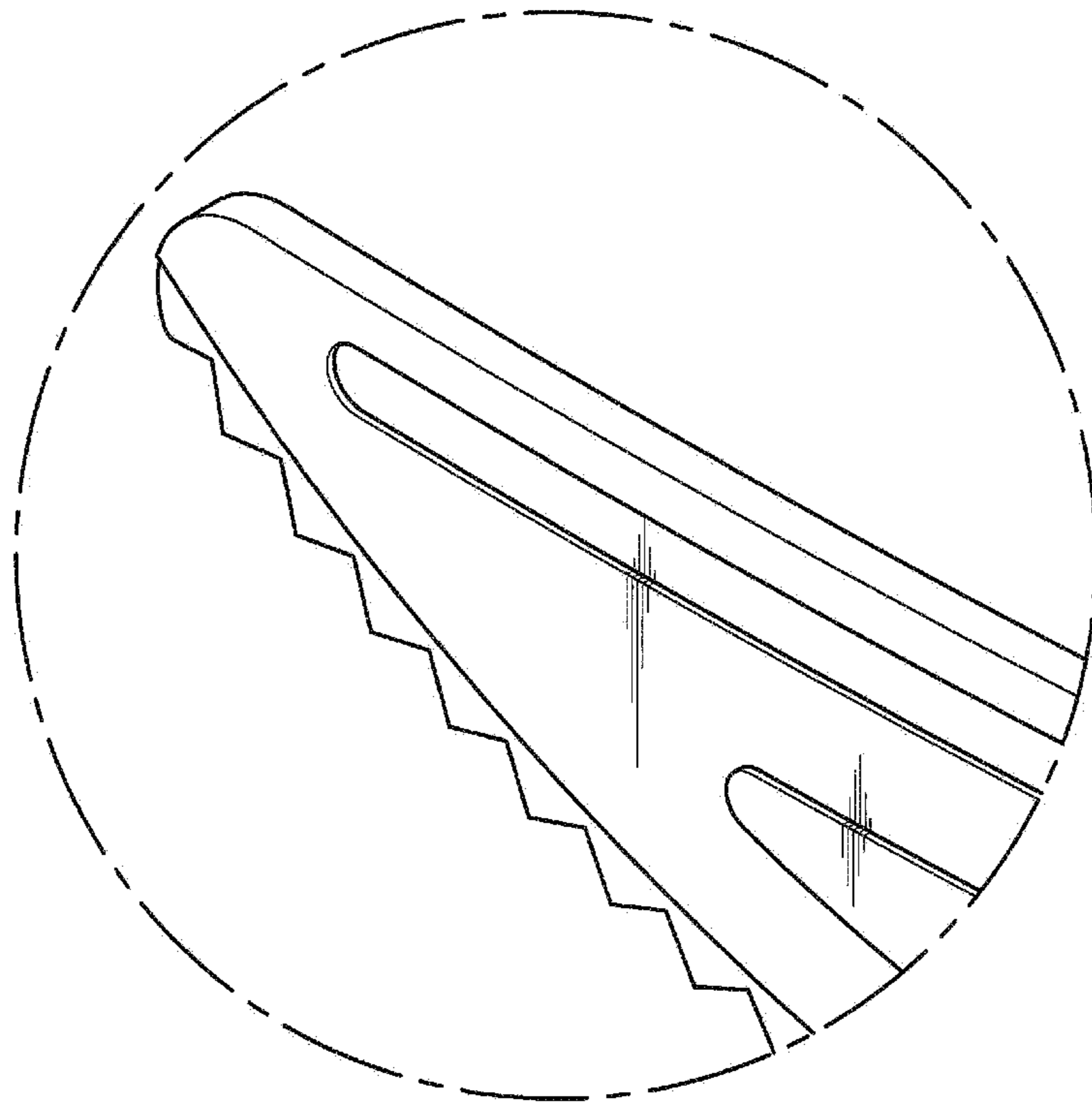

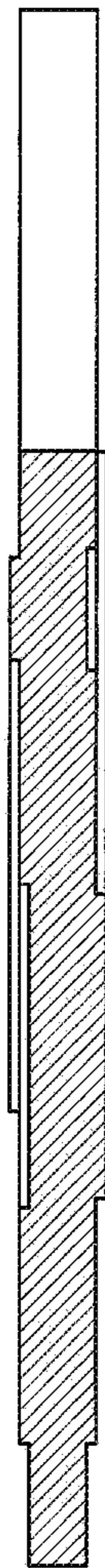
