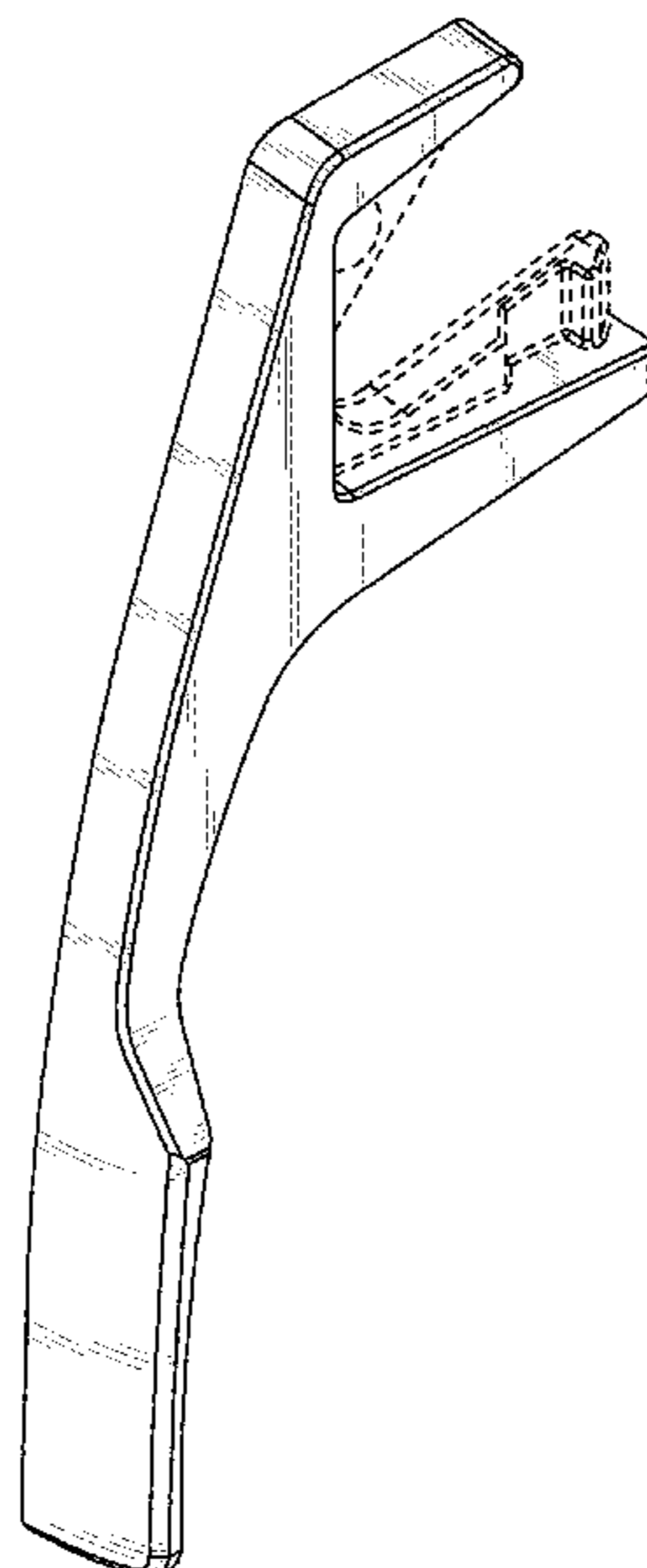
(57) **CLAIM**

The ornamental design for a lock lever, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a first embodiment of a lock lever, embodying our new design; FIG. 2 is a front and bottom perspective view of the first embodiment; FIG. 3 is a left side elevational view of the first embodiment; FIG. 4 is a right side elevational view of the first embodiment; FIG. 5 is a back elevational view of the first embodiment; FIG. 6 is a front elevational view of the first embodiment; FIG. 7 is a top plan view of the first embodiment; FIG. 8 is a bottom plan view of the first embodiment; FIG. 9 is a front and top perspective view of a second embodiment of a lock lever, embodying our new design; FIG. 10 is a front and bottom perspective view of the second embodiment; FIG. 11 is a left side elevational view of the second embodiment; FIG. 12 is a right side elevational view of the second embodiment; FIG. 13 is a back elevational view of the second embodiment; FIG. 14 is a front elevational view of the second embodiment; FIG. 15 is a top plan view of the second embodiment; and, FIG. 16 is a bottom plan view of the second embodiment. The broken lines shown represent portions of the lock lever that form no part of the claimed design.

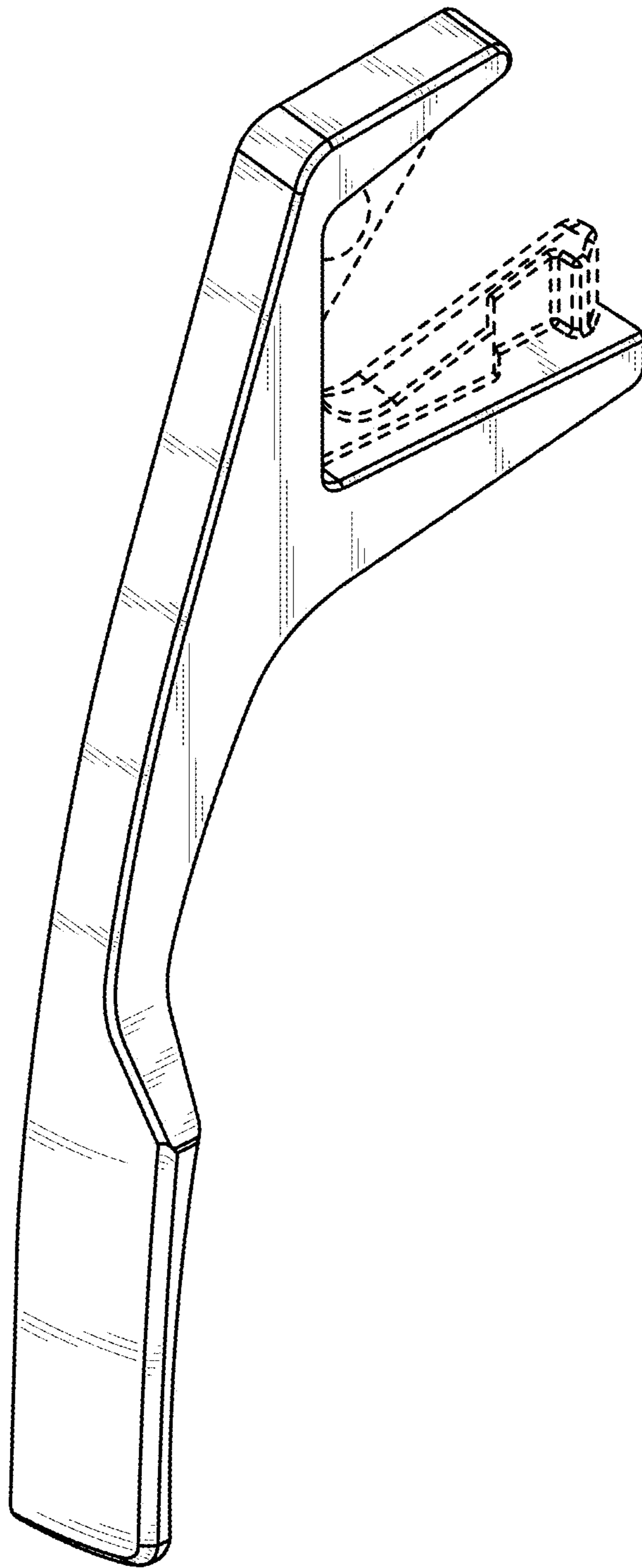

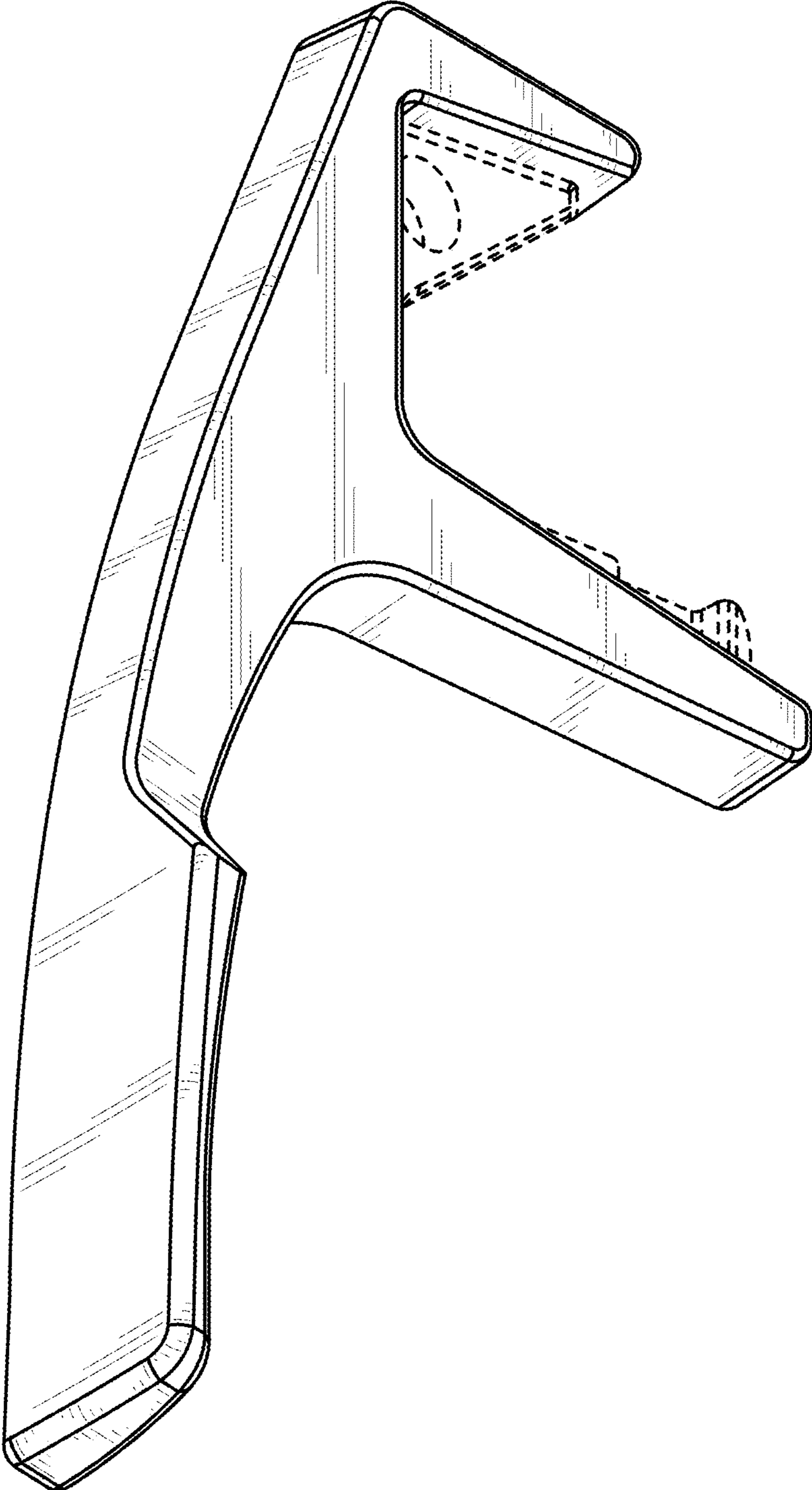

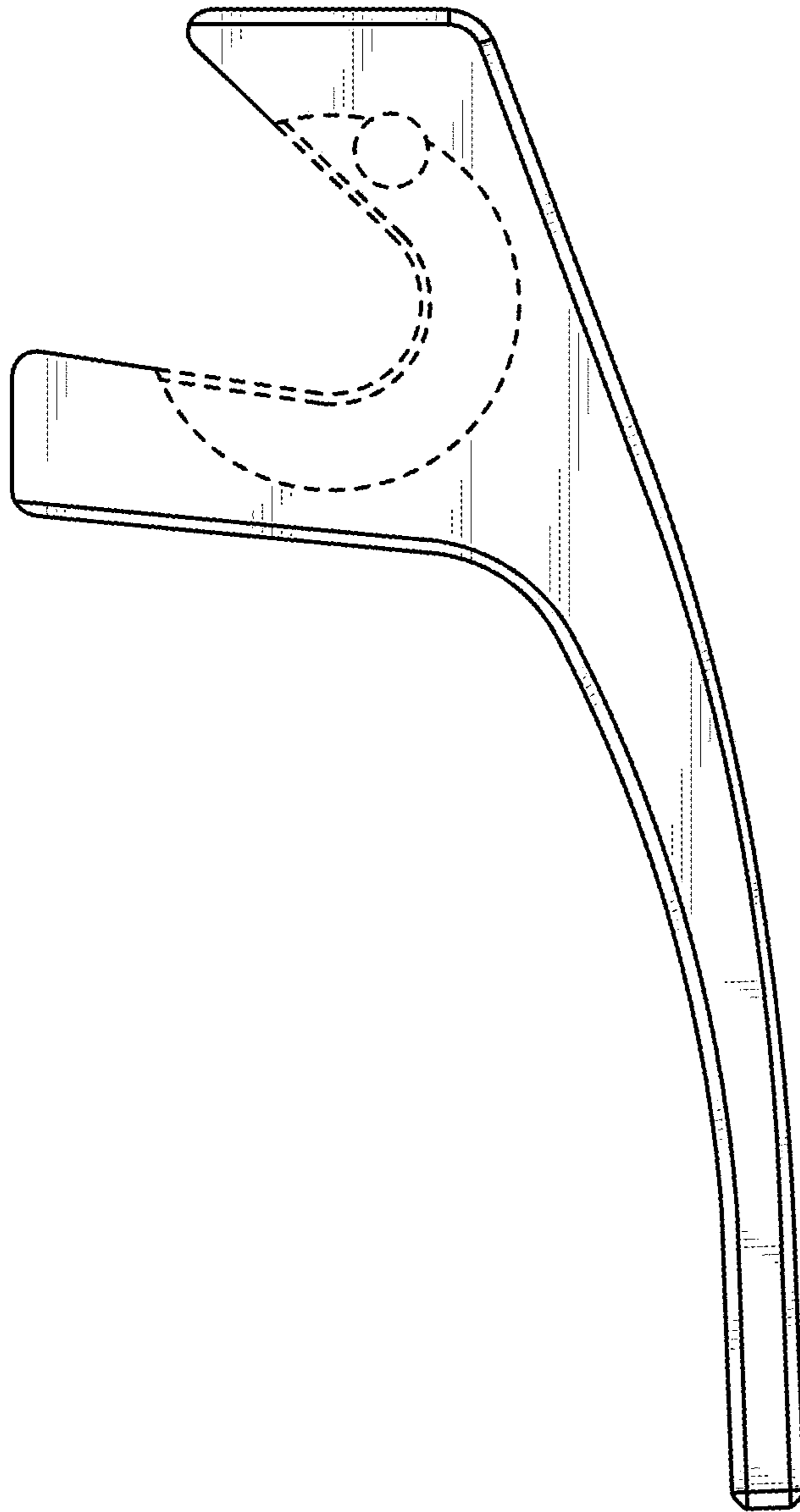

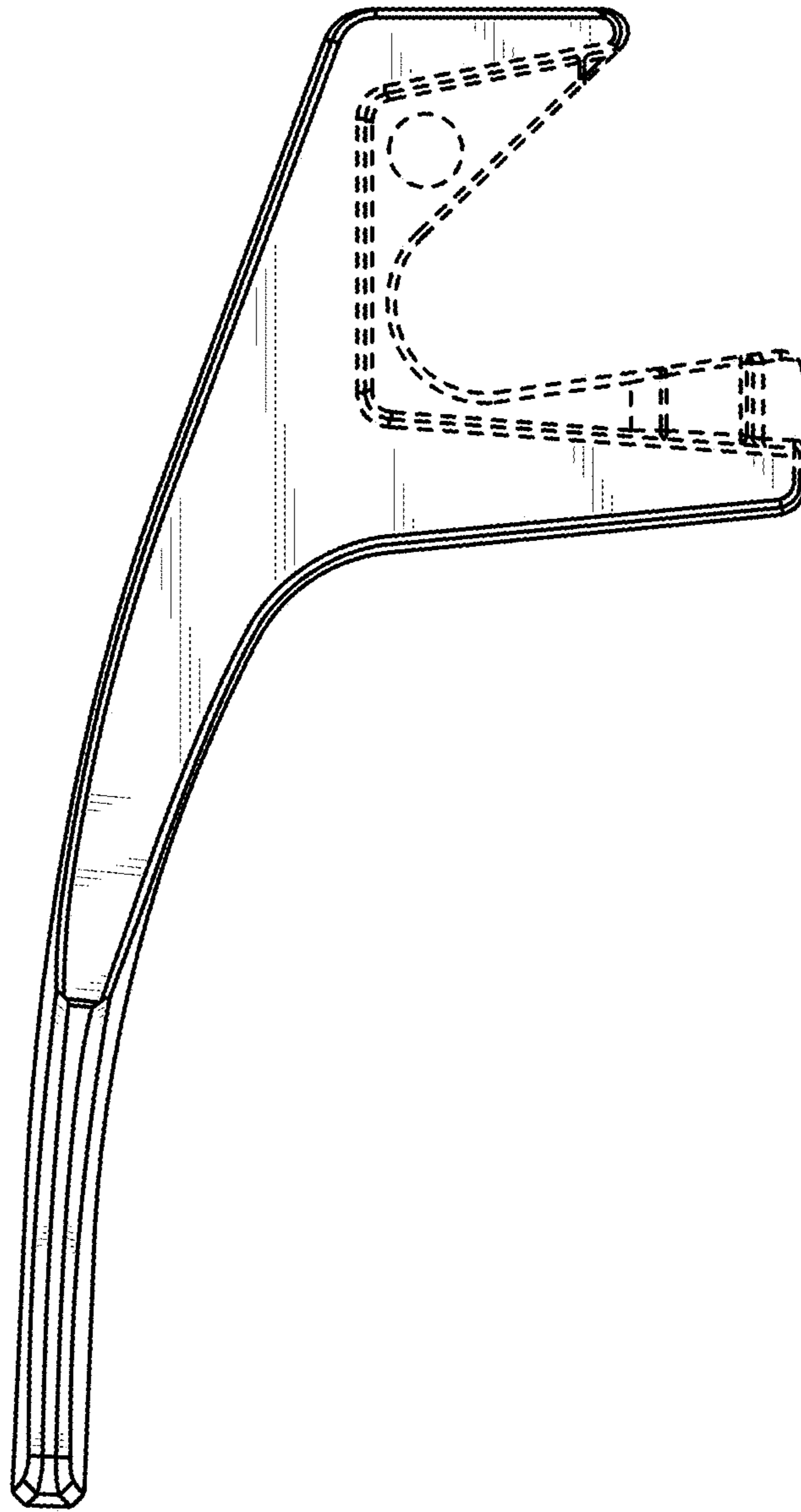

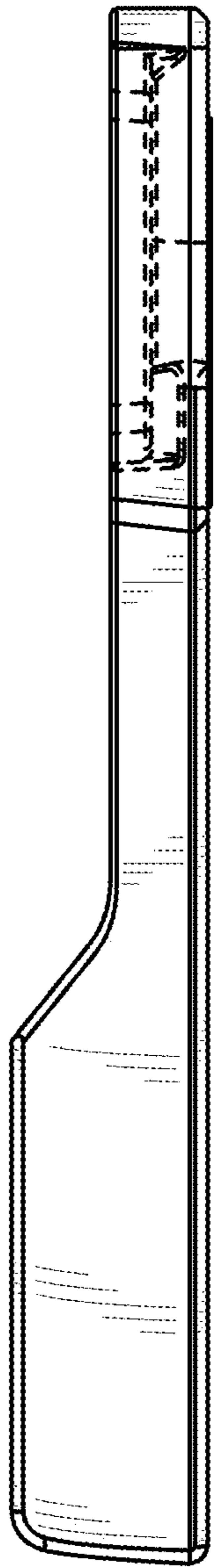

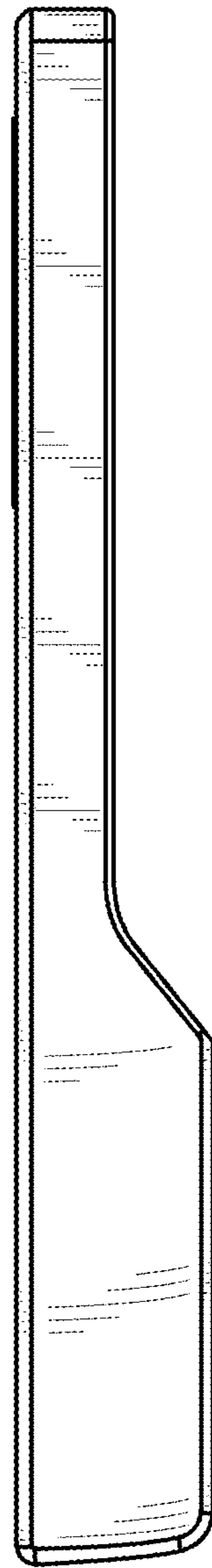

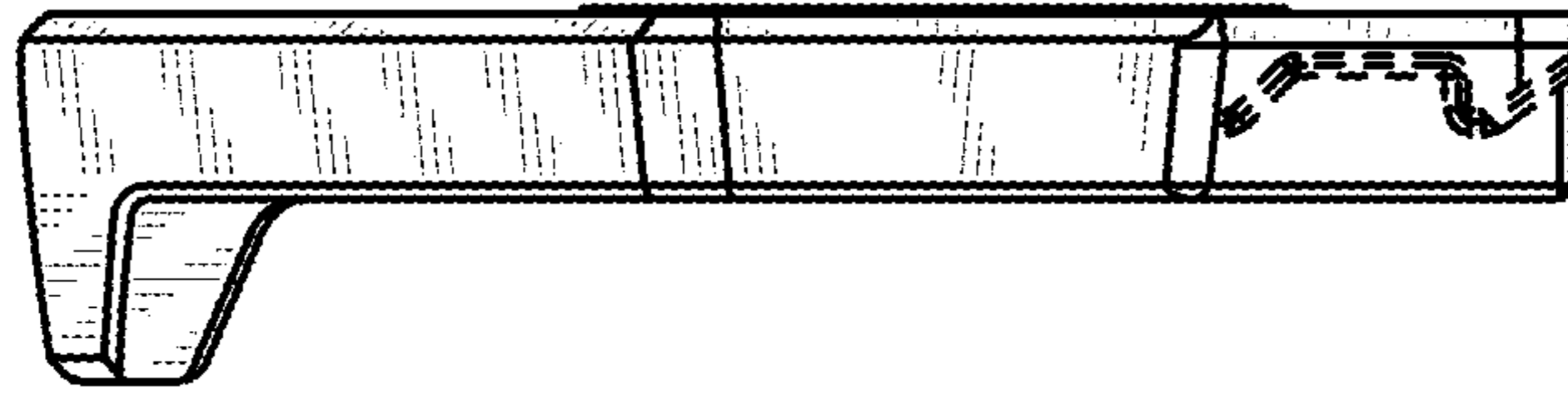

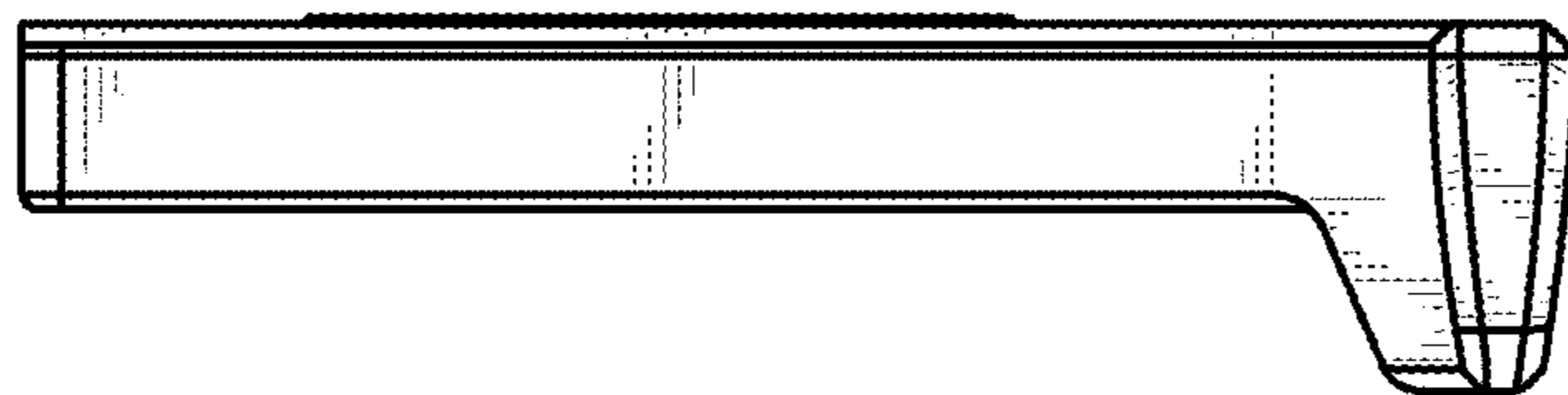

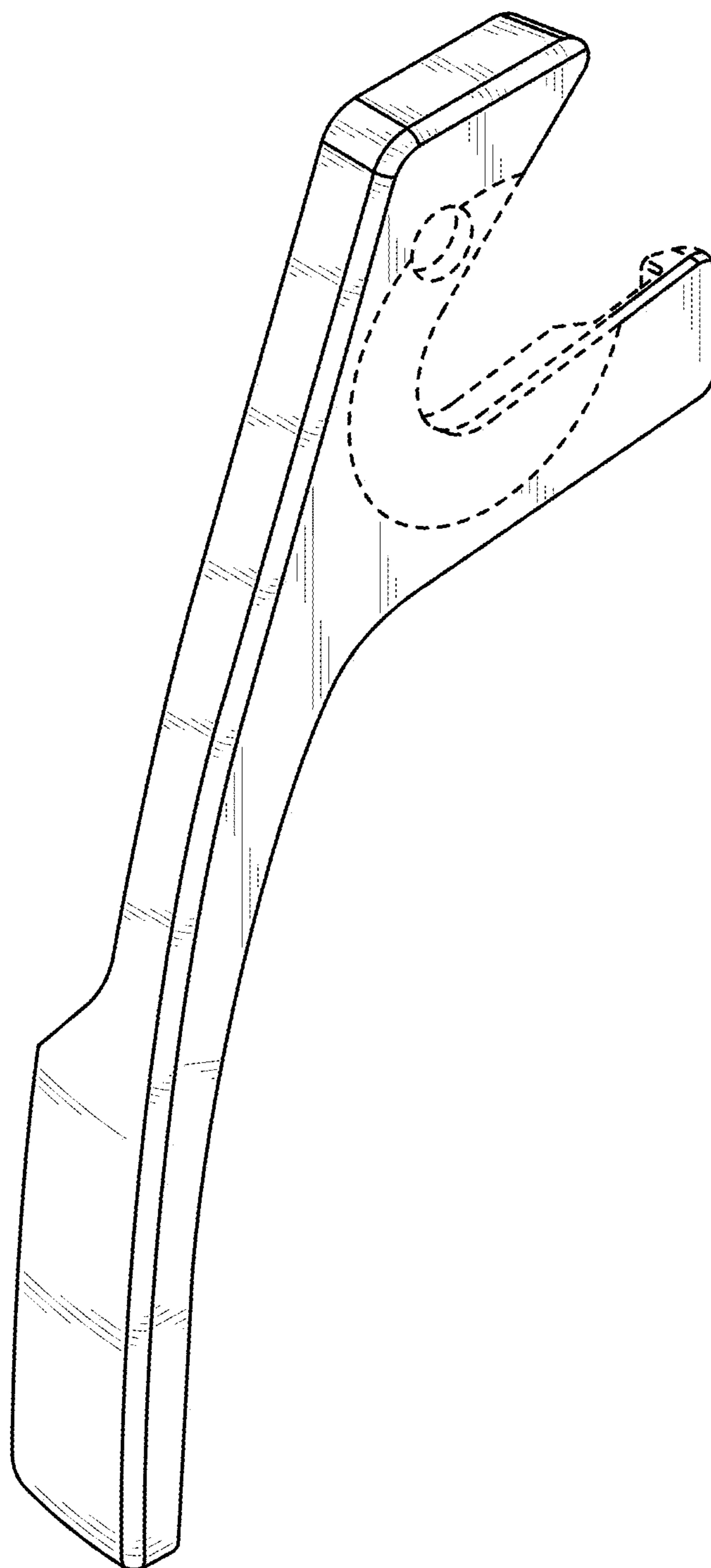

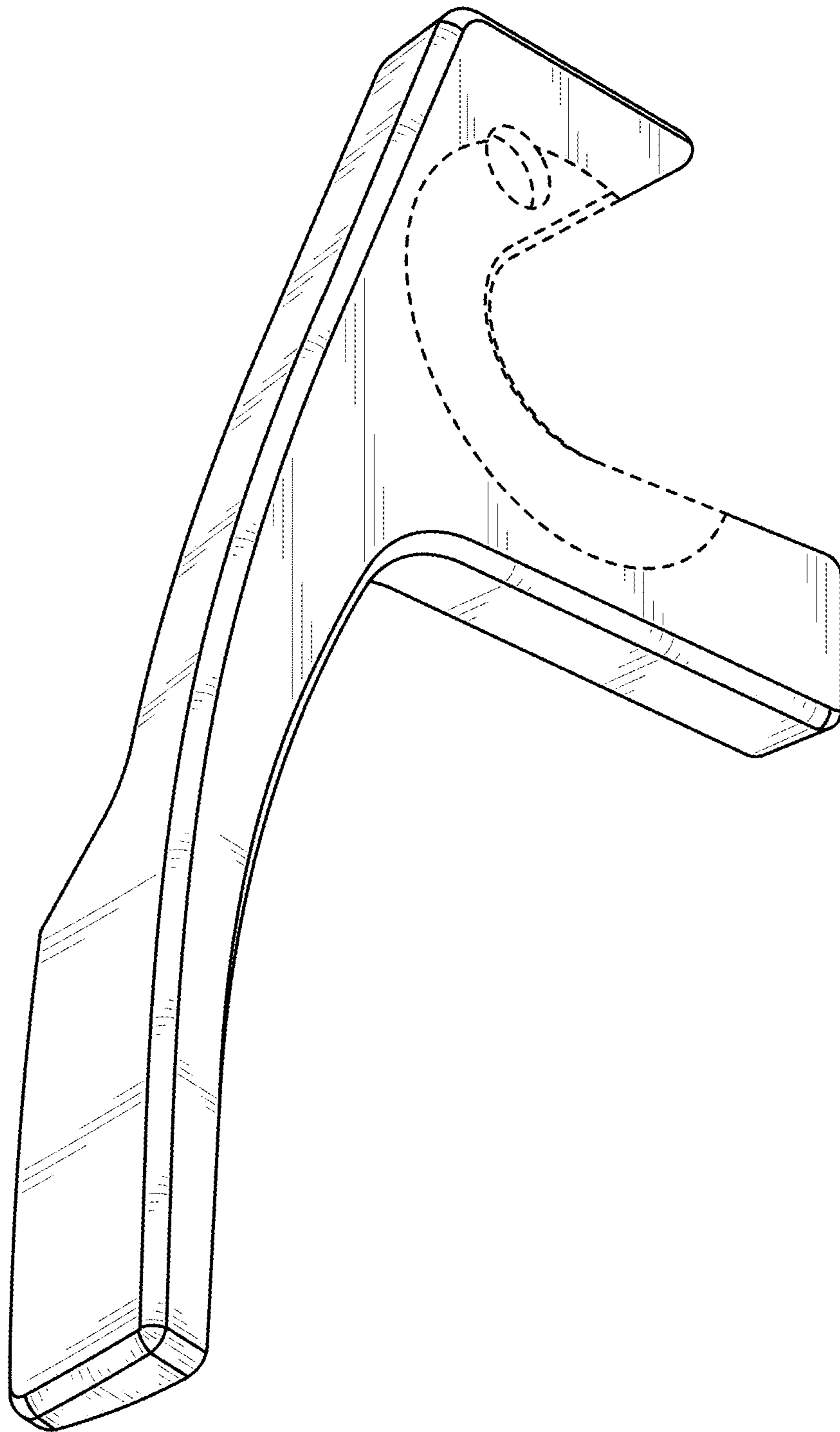

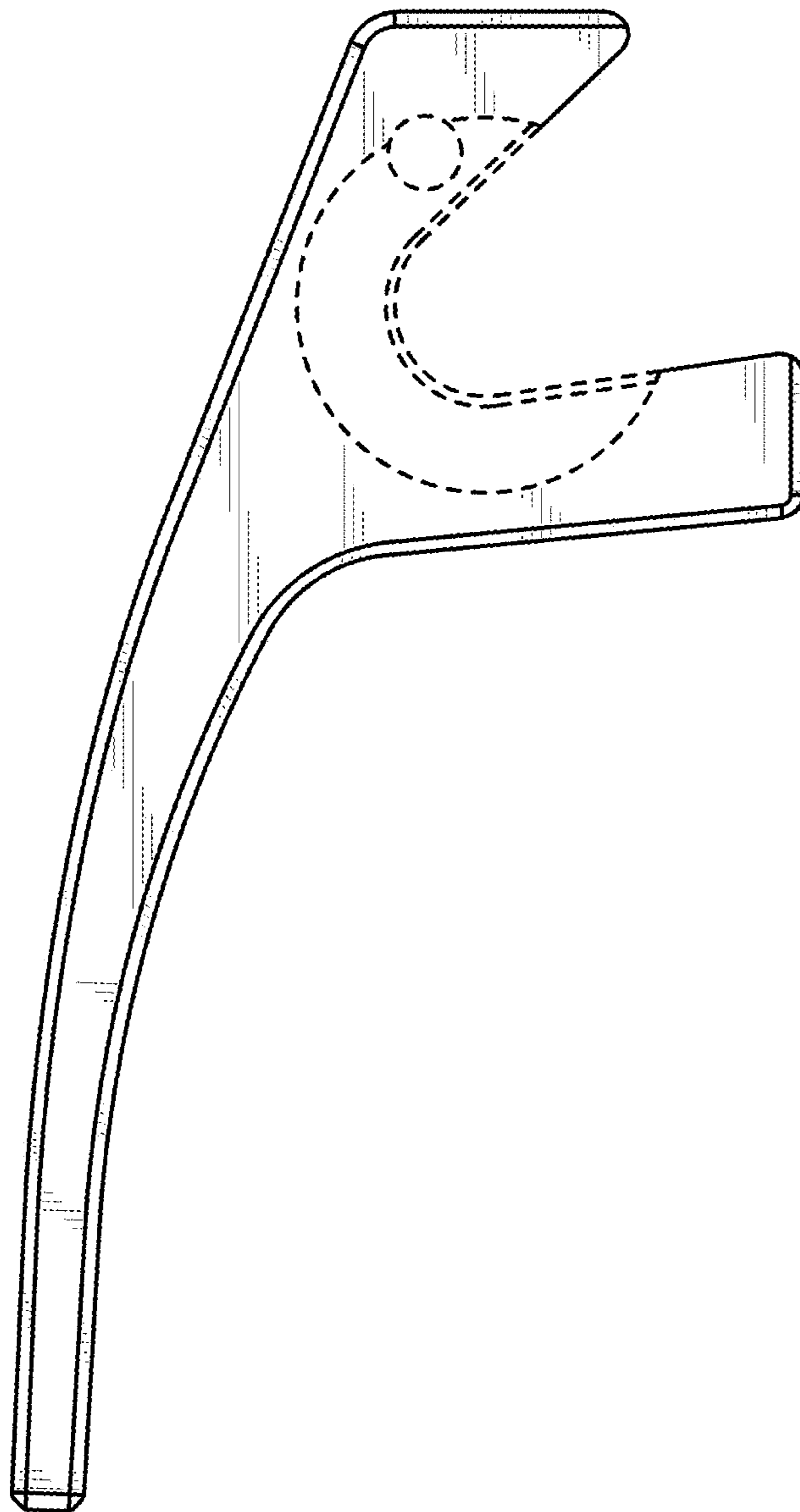

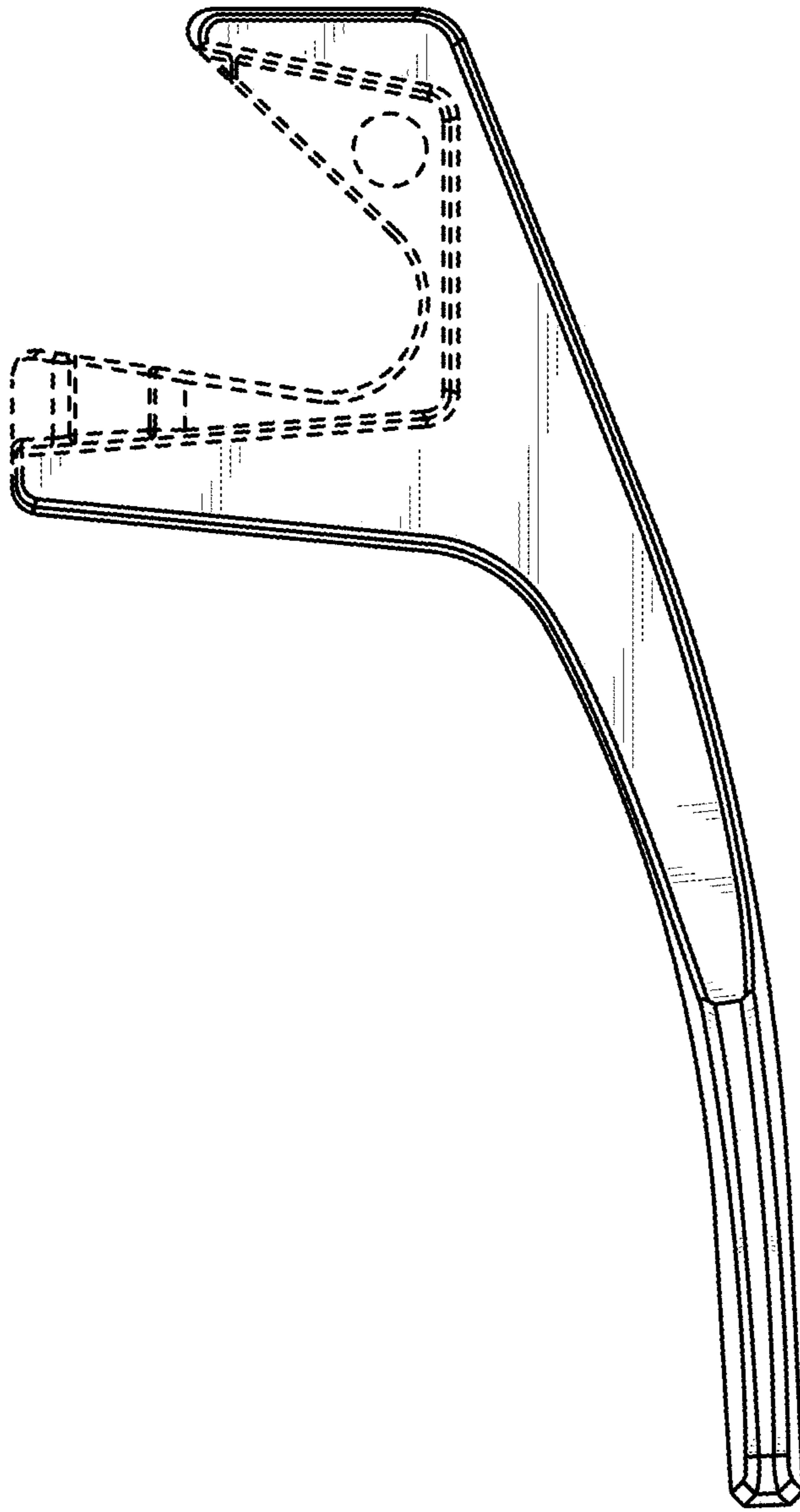

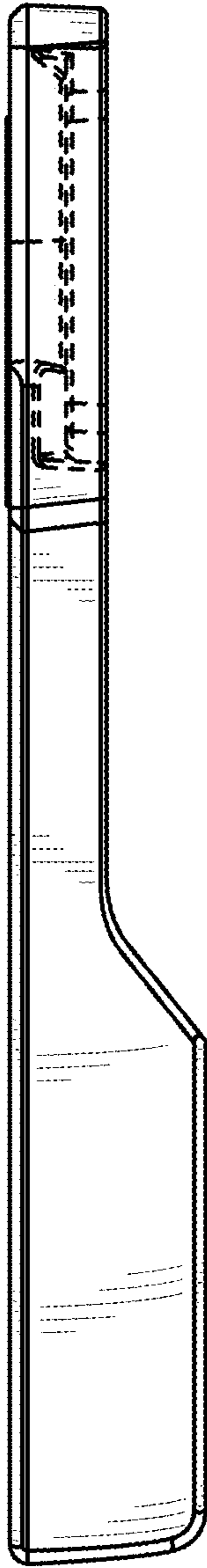

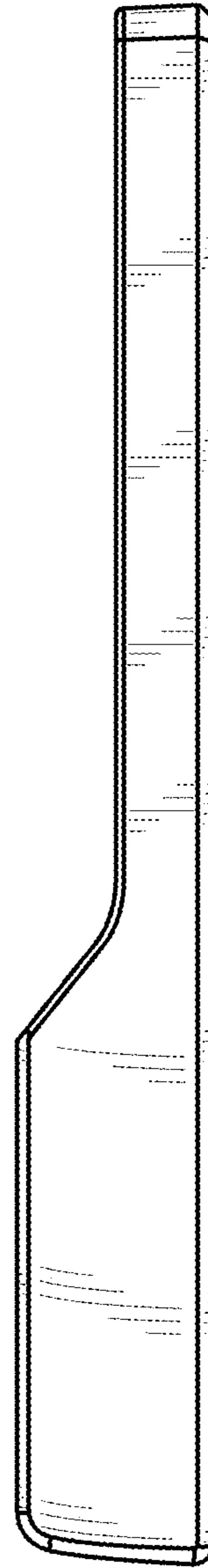

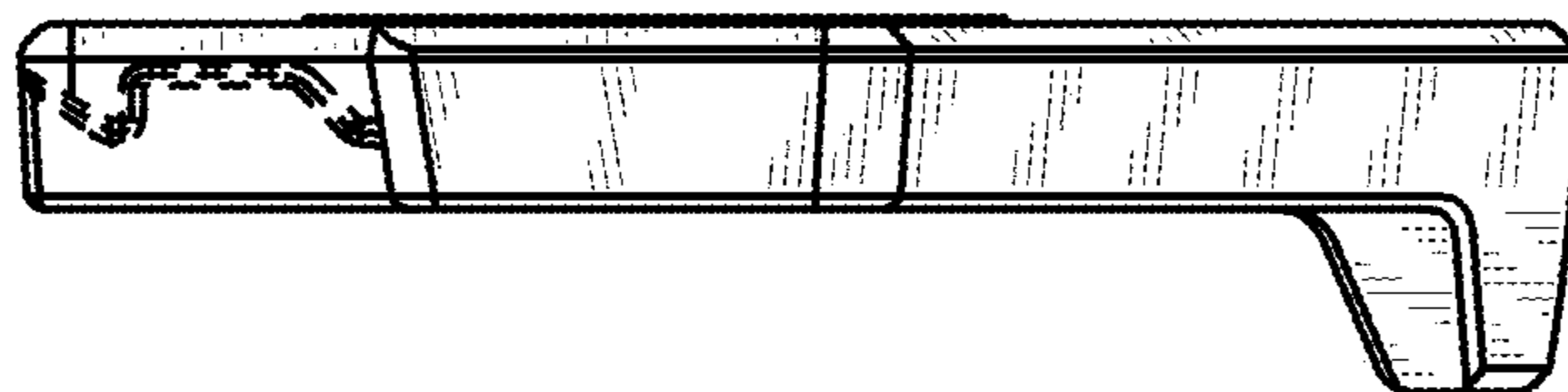

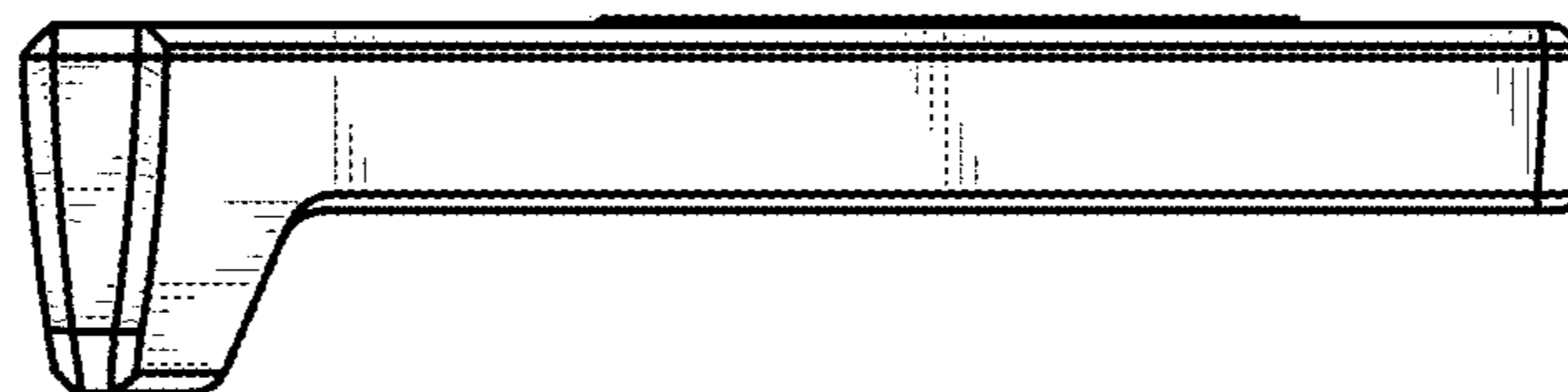
