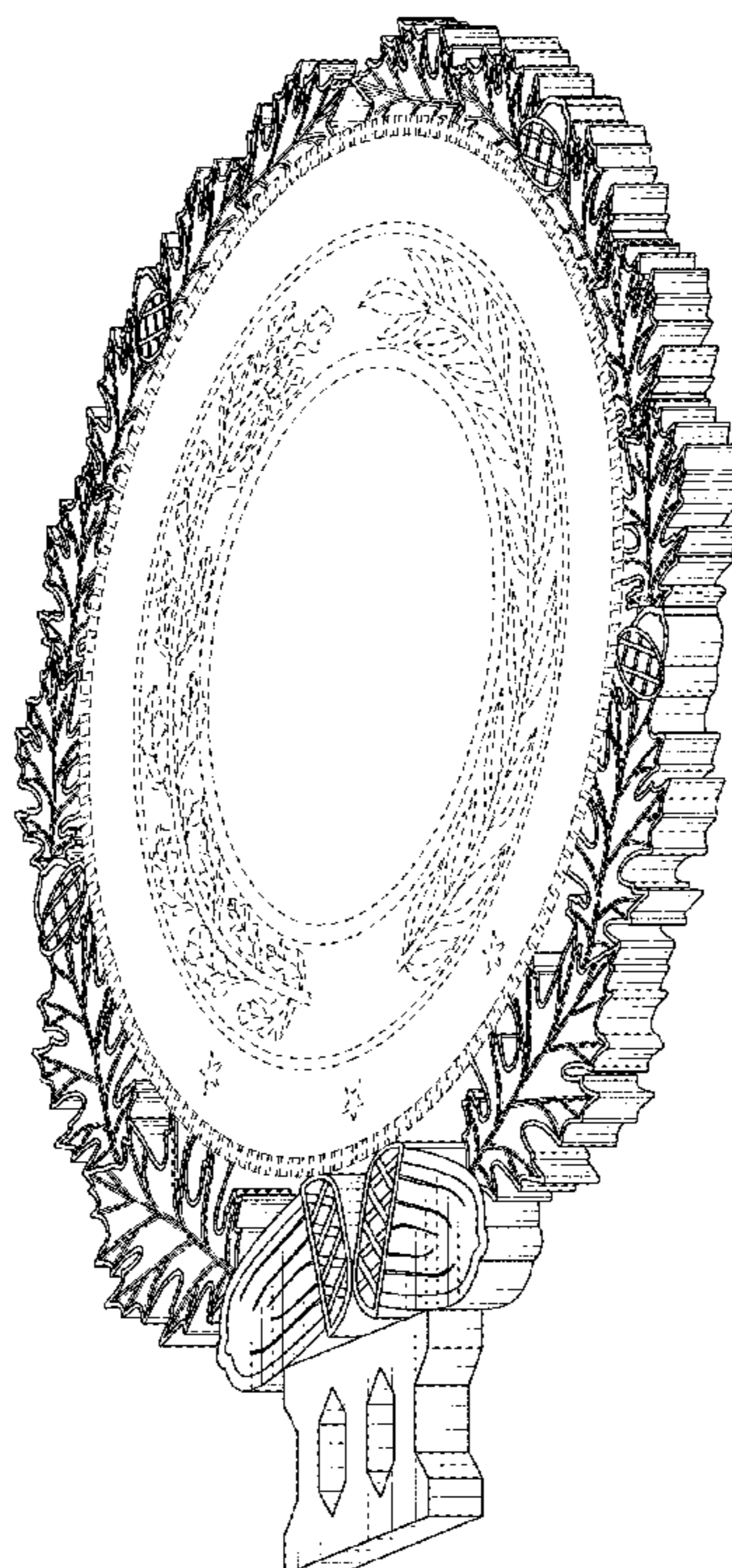
FIG. 1 is a front perspective view of a design for an emblem with legacy number;

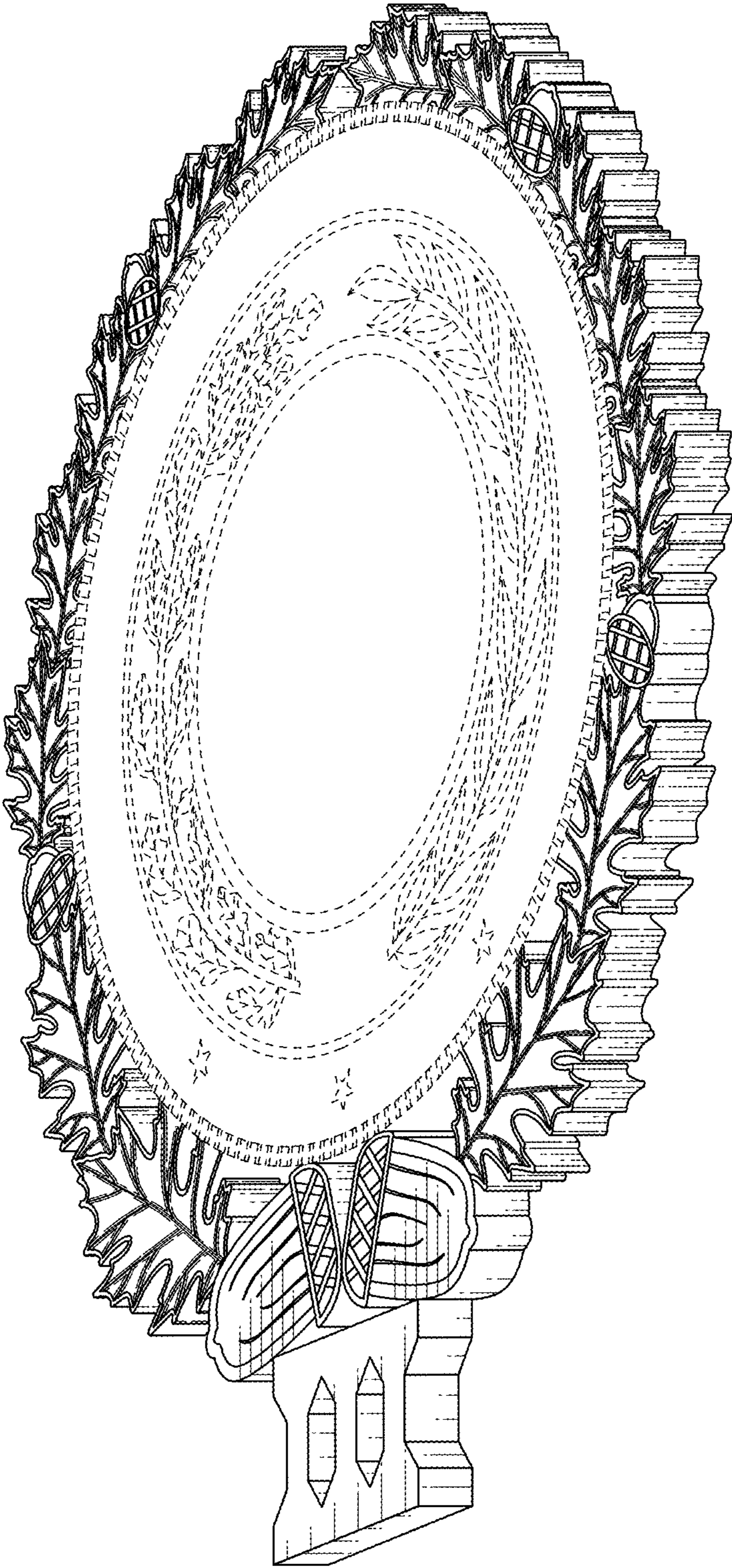

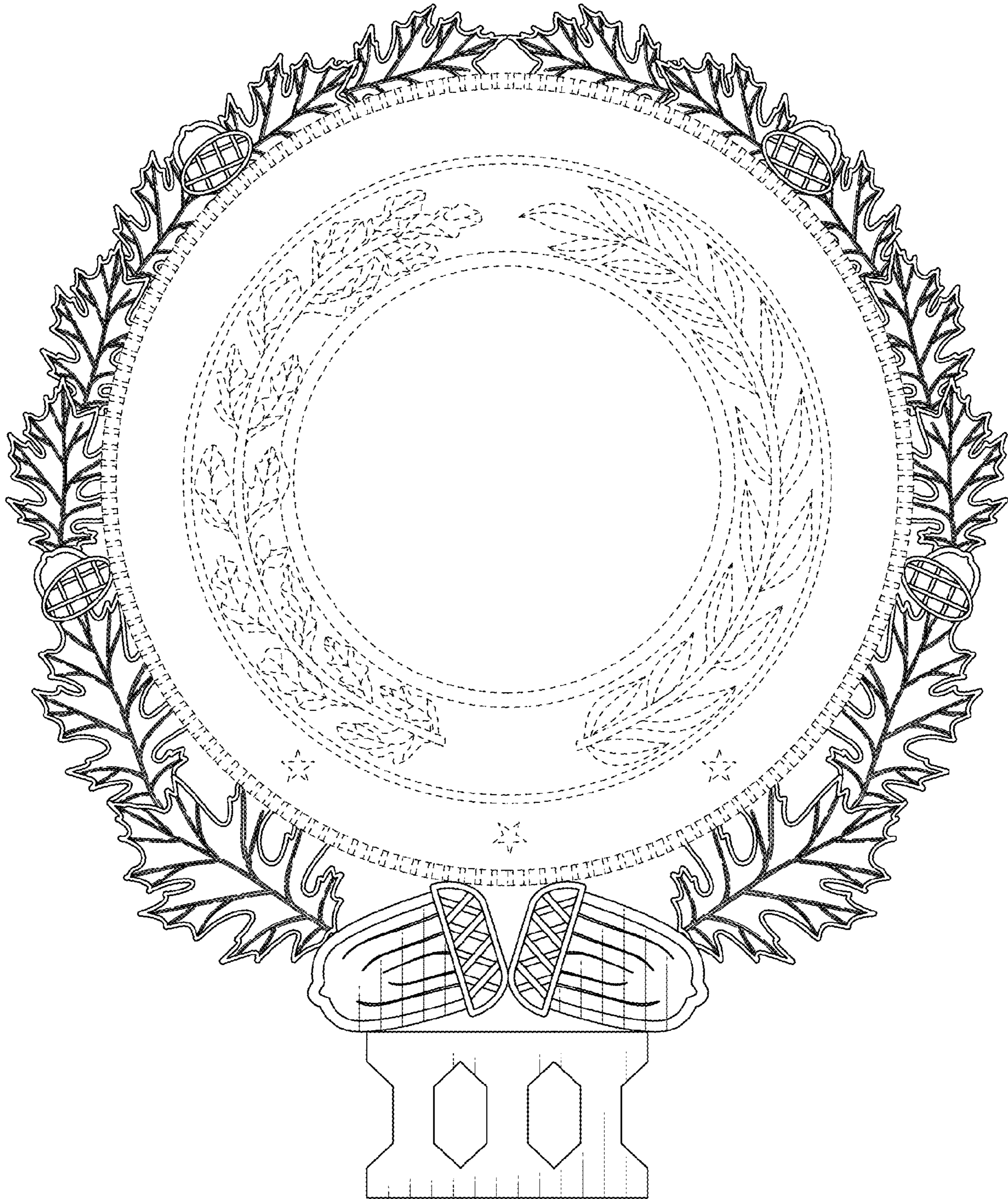

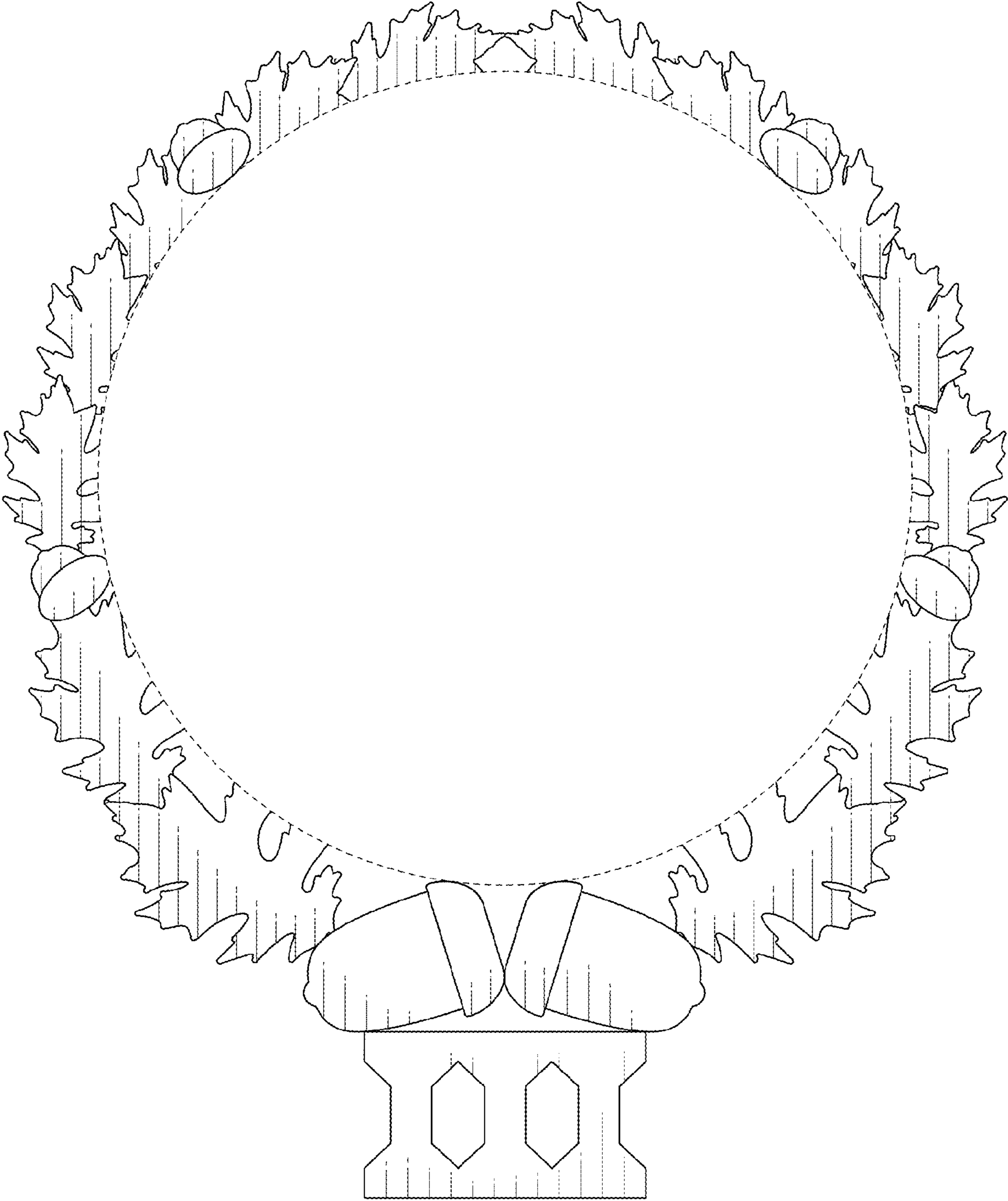

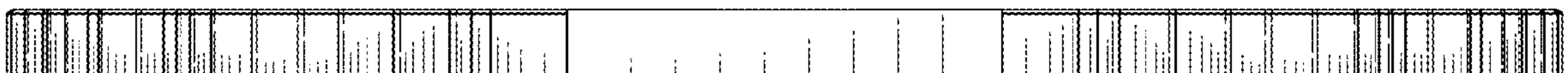
