**DESCRIPTION**

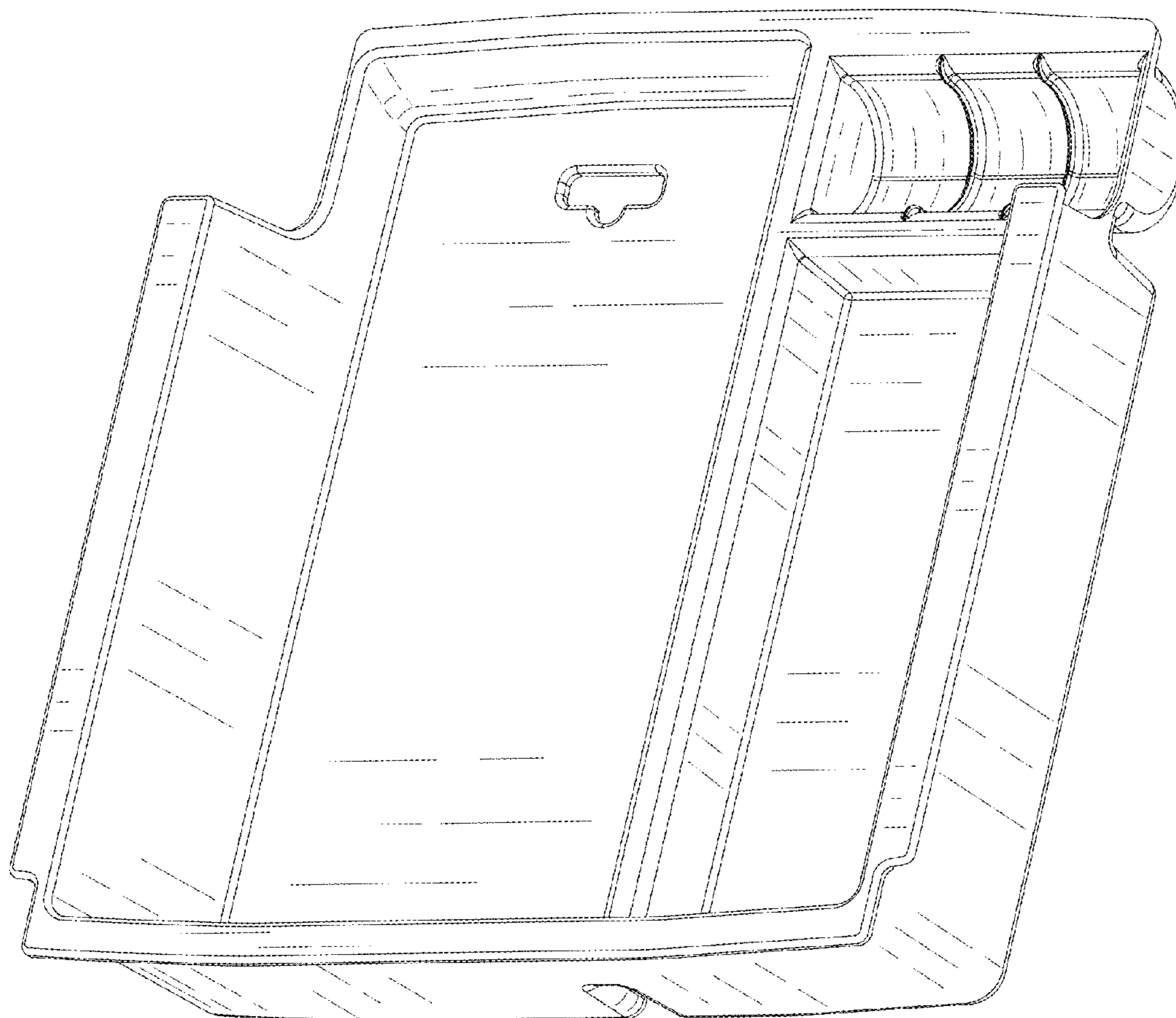
FIG. 1 is a perspective view of an in-car storage box, showing my new design;

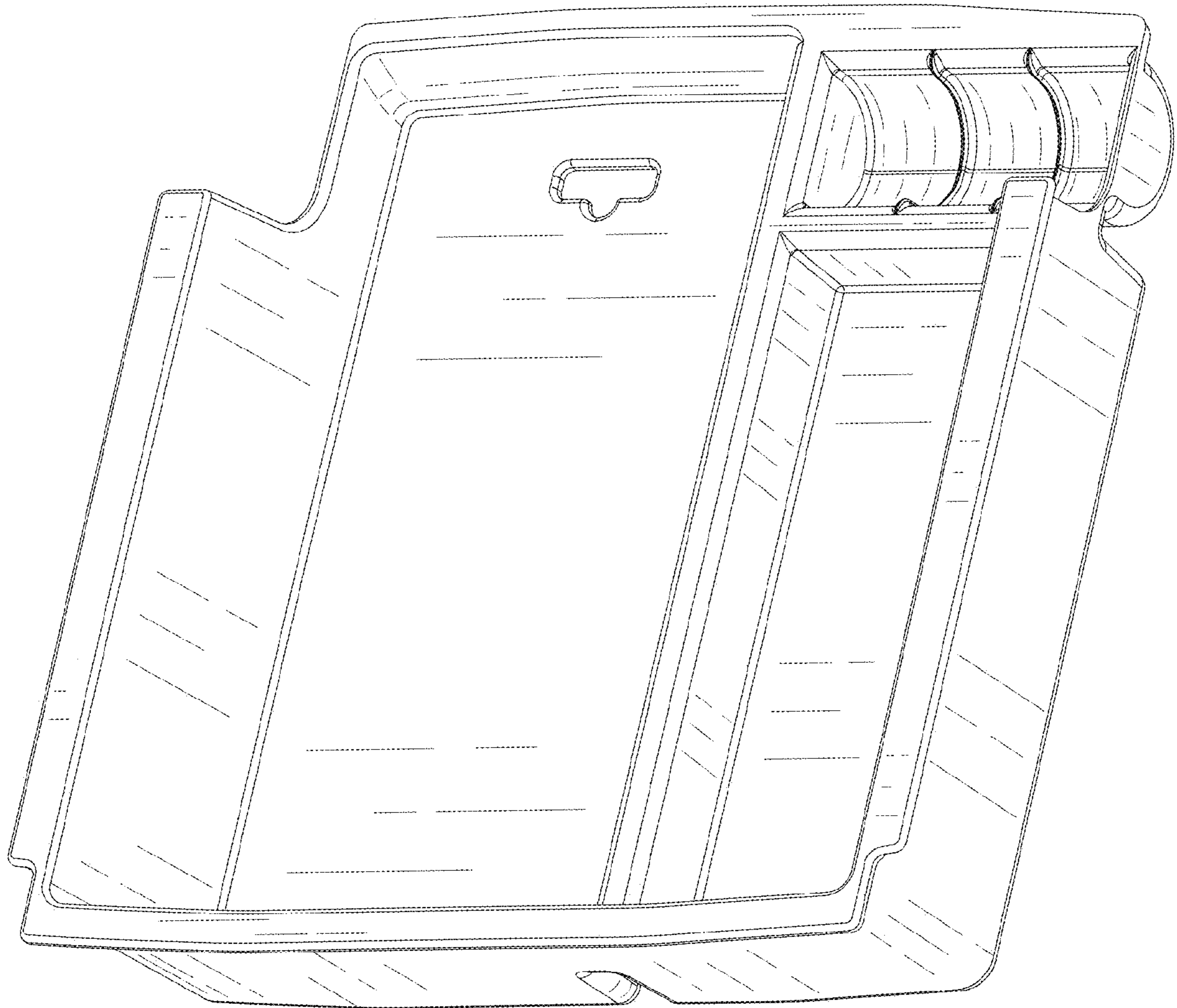

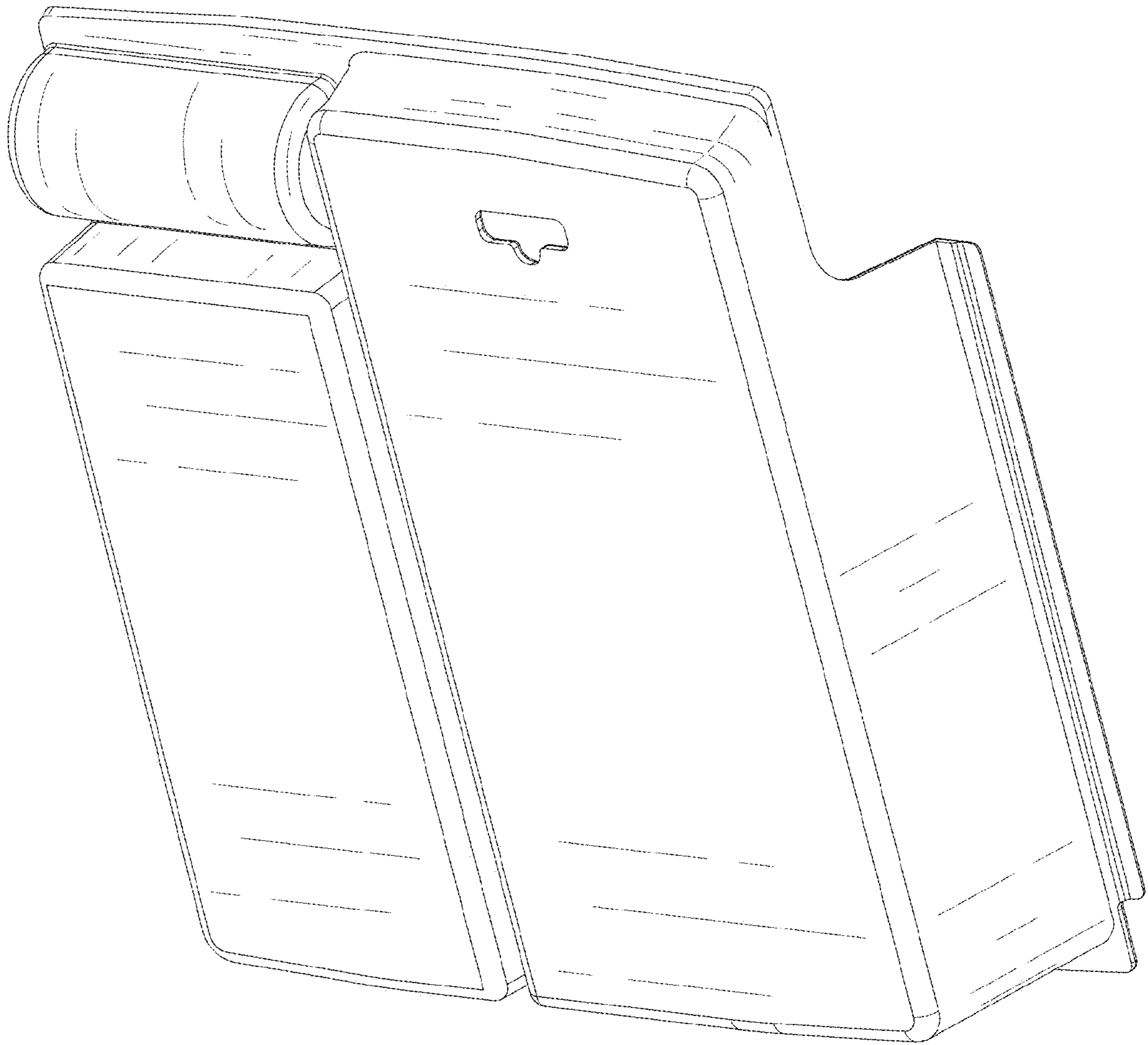

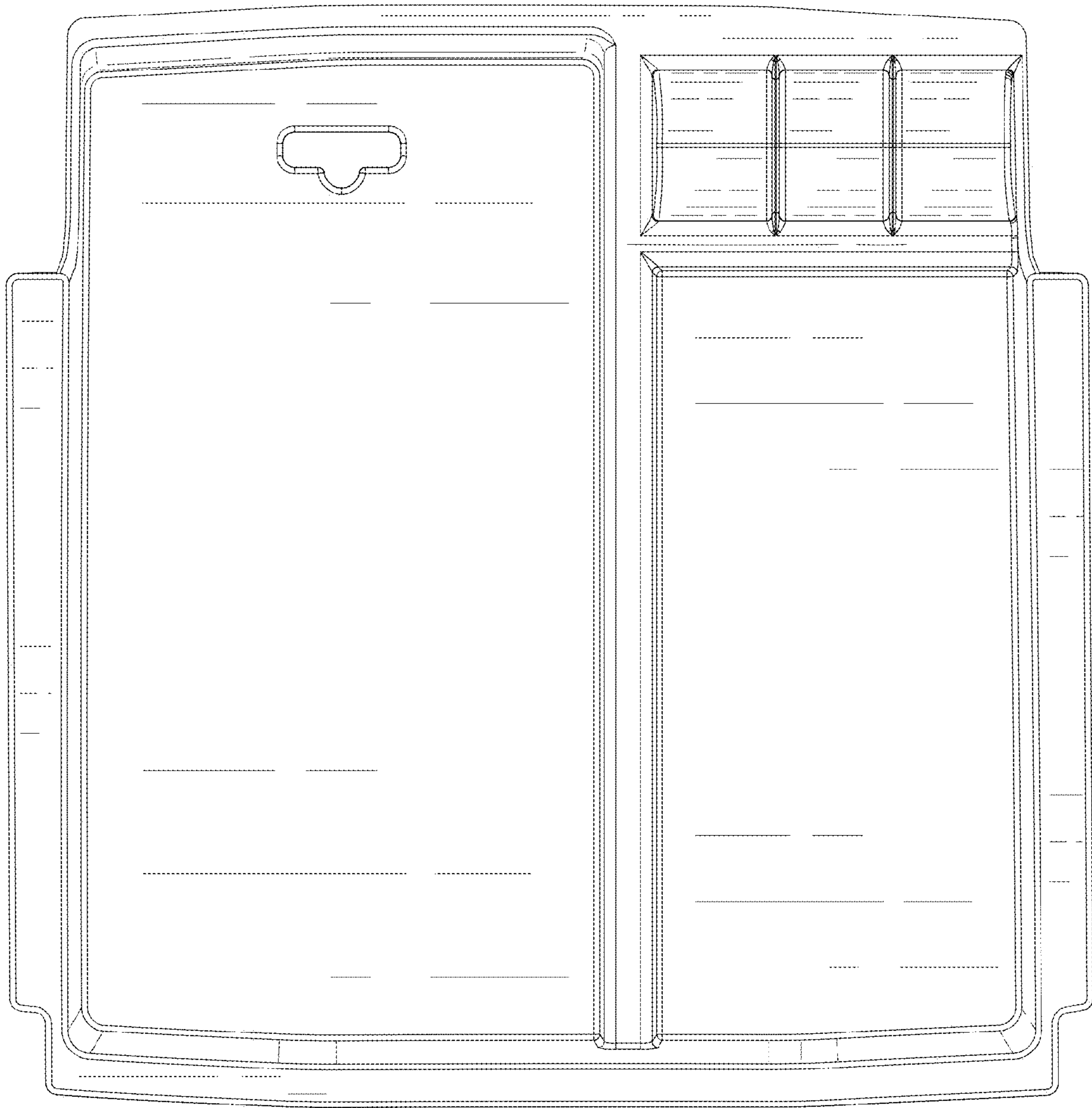

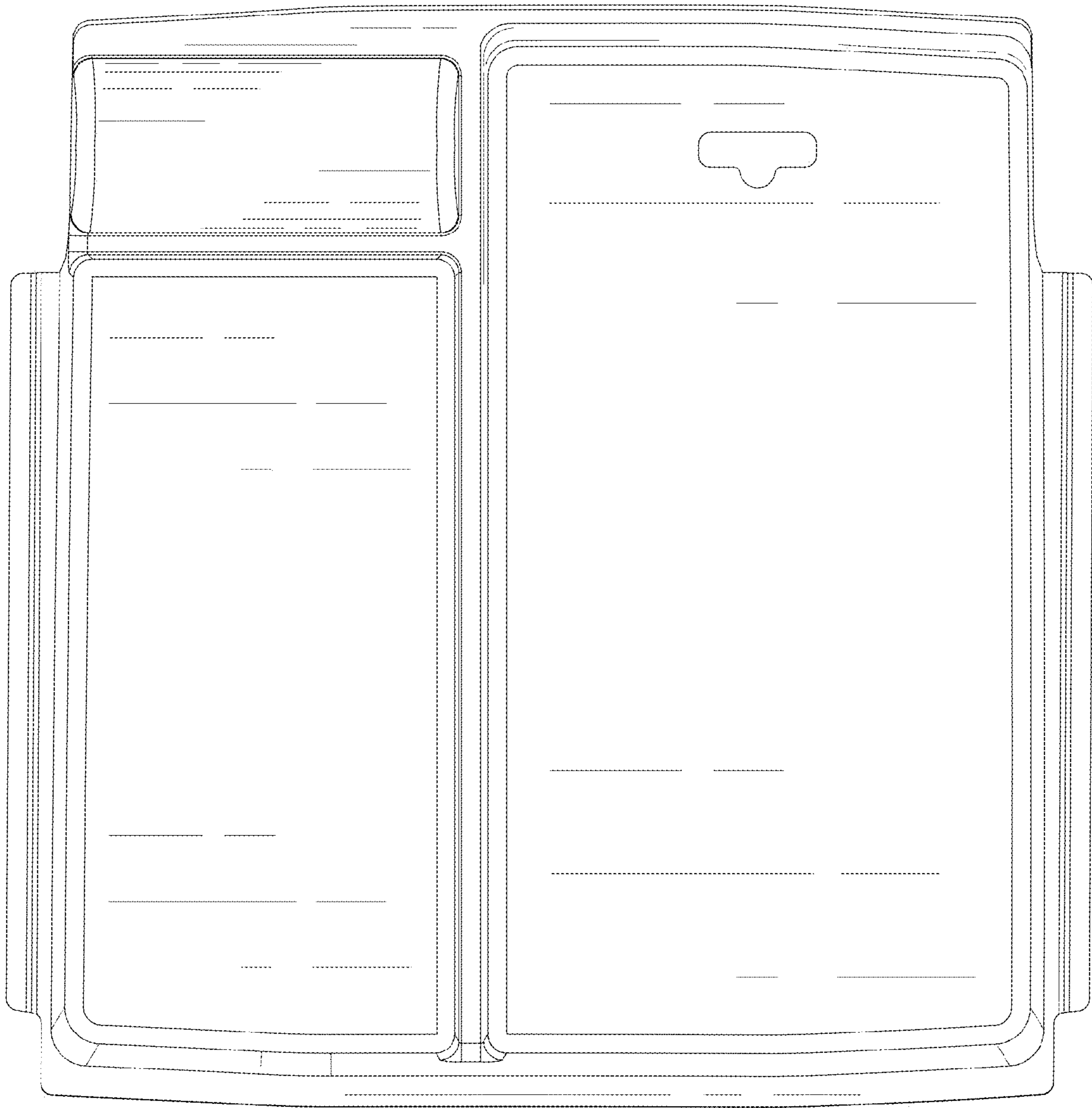

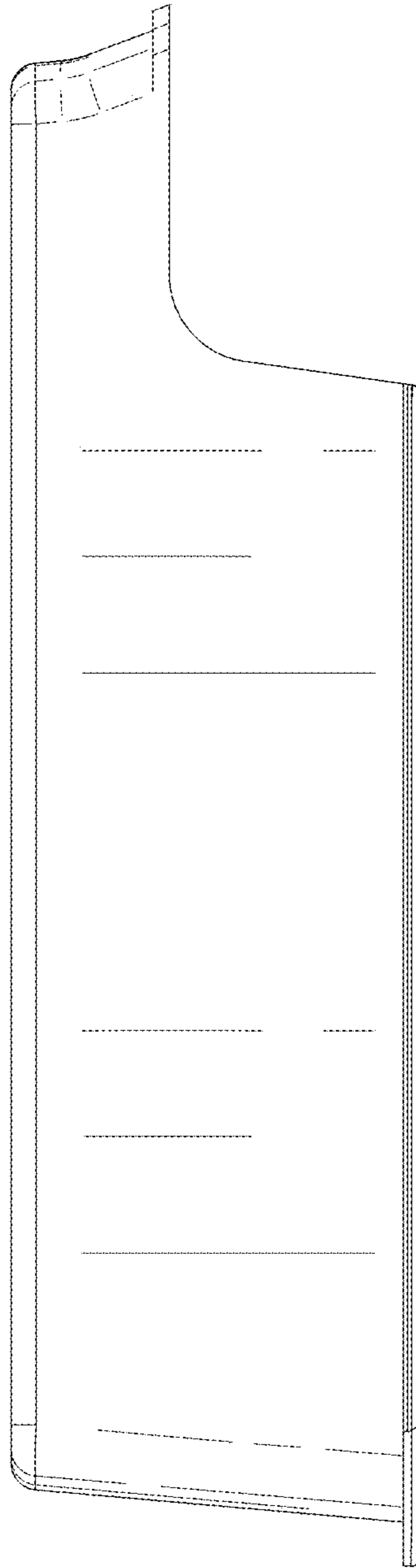

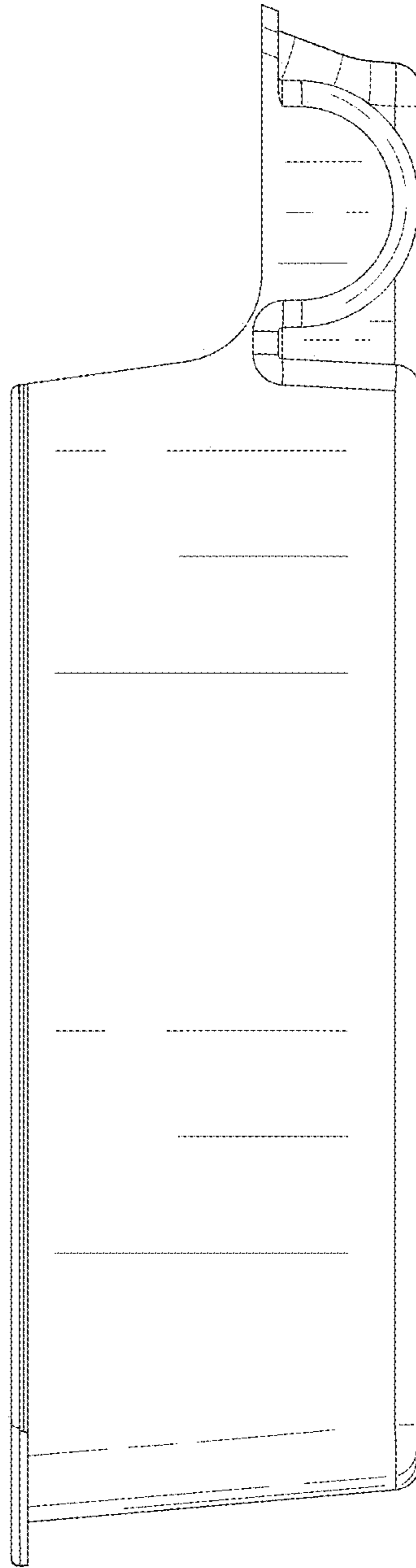

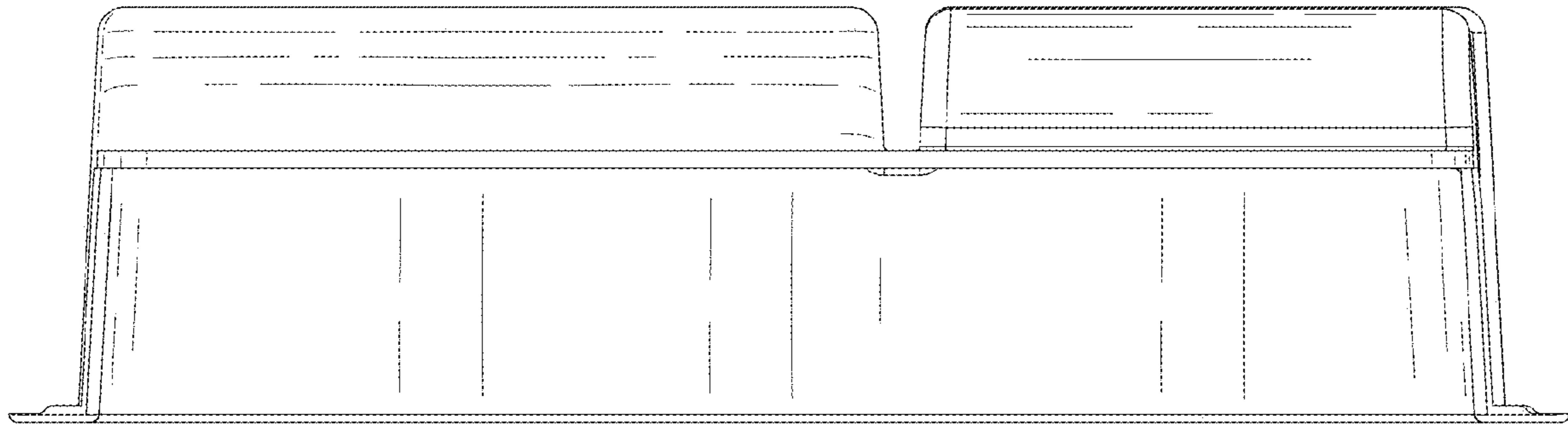

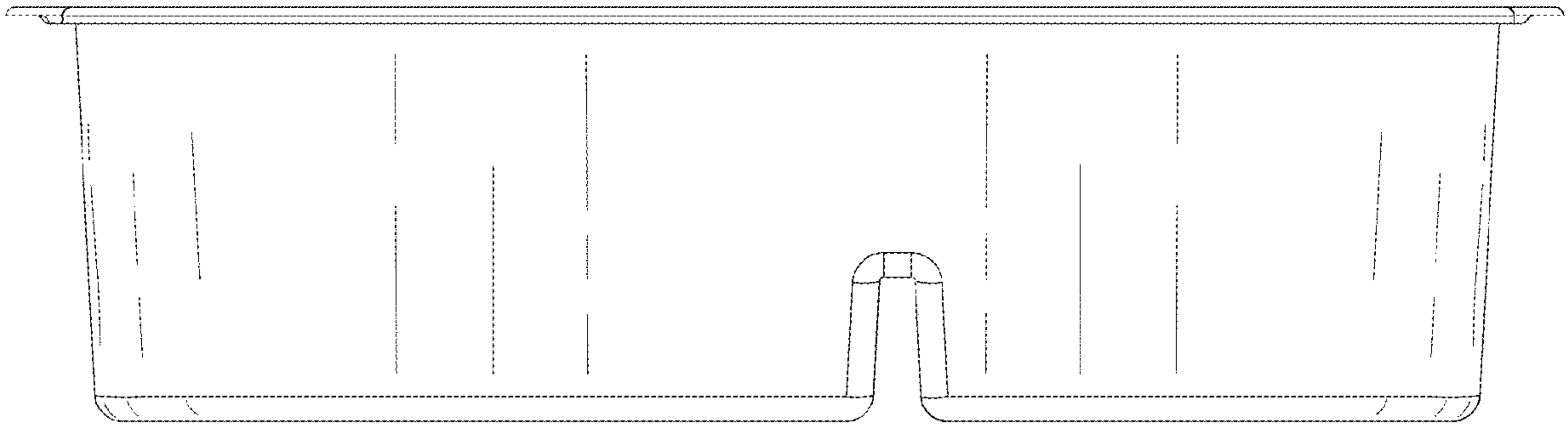
