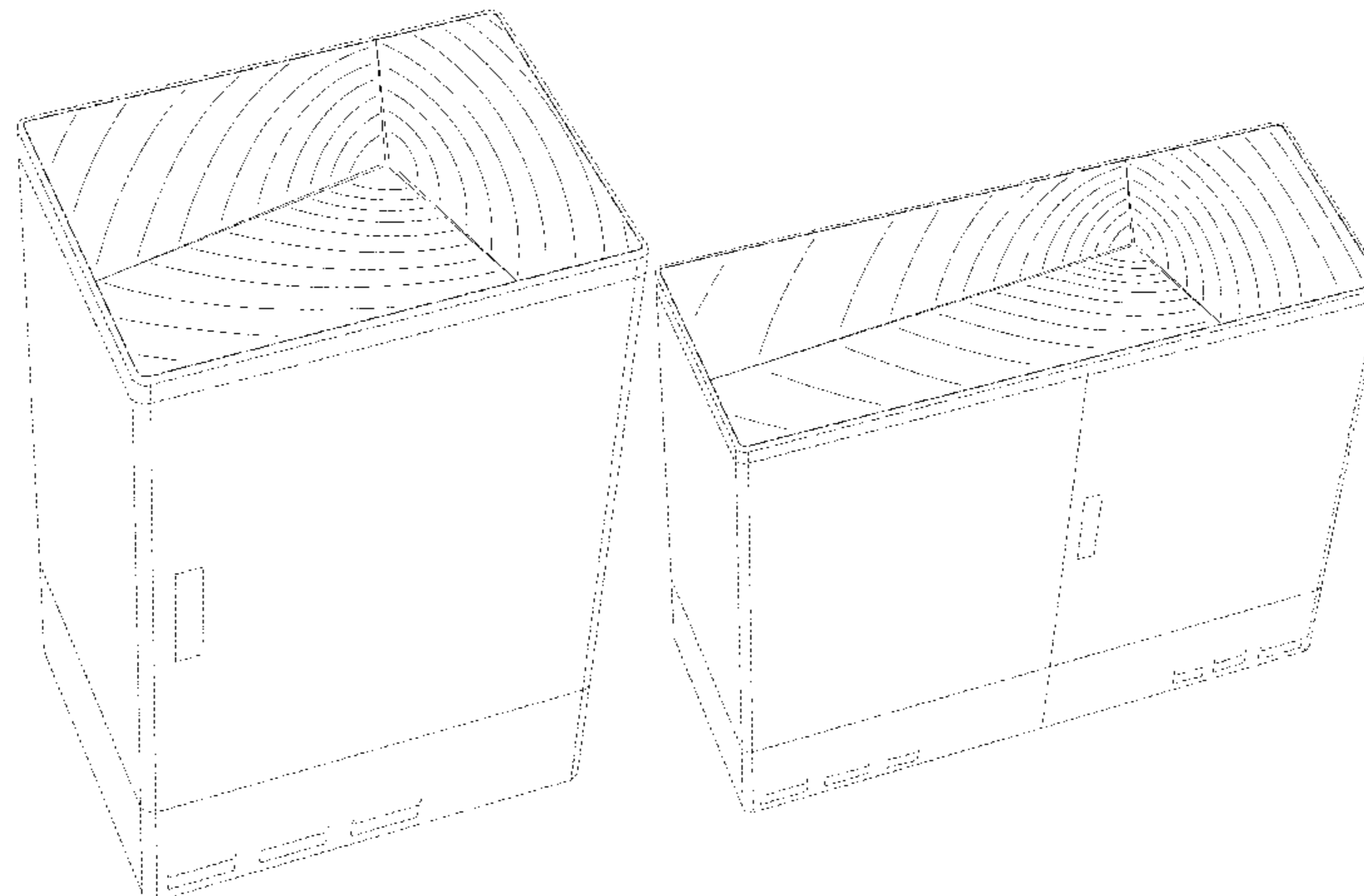


FIG. 22 is a front perspective view of an outdoor cabinet with surface ornamentation illustrating another embodiment of our new design;

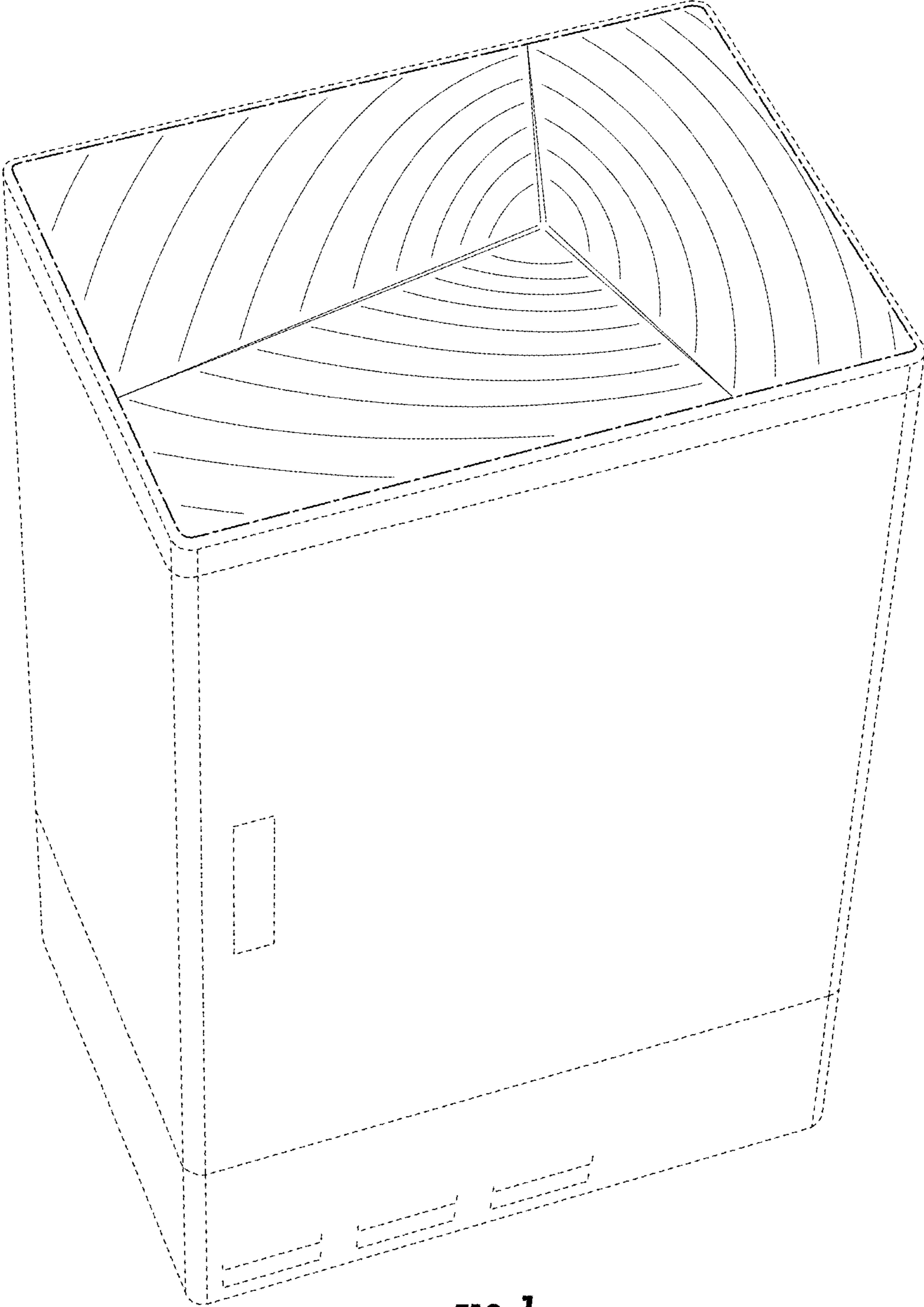

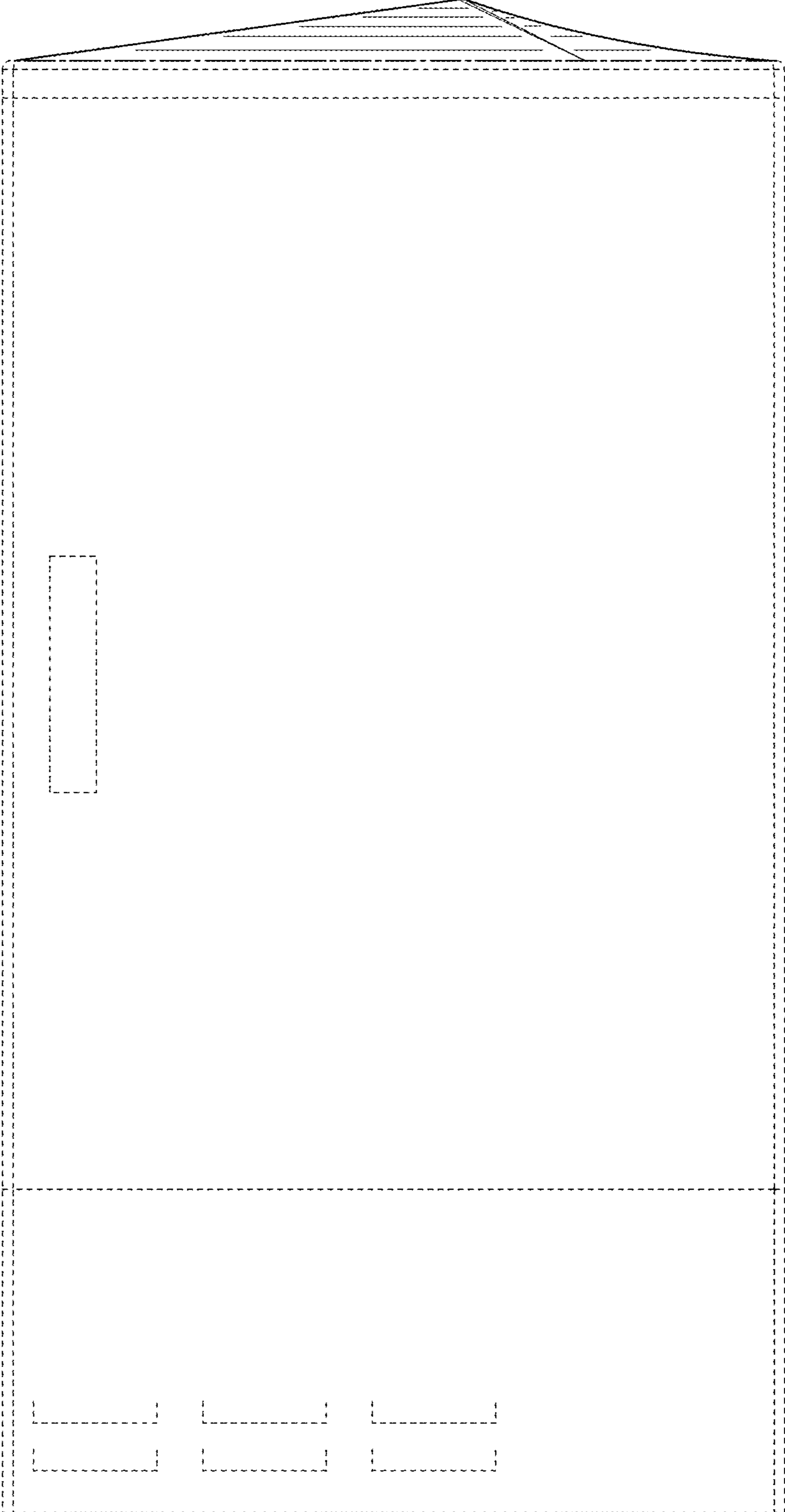

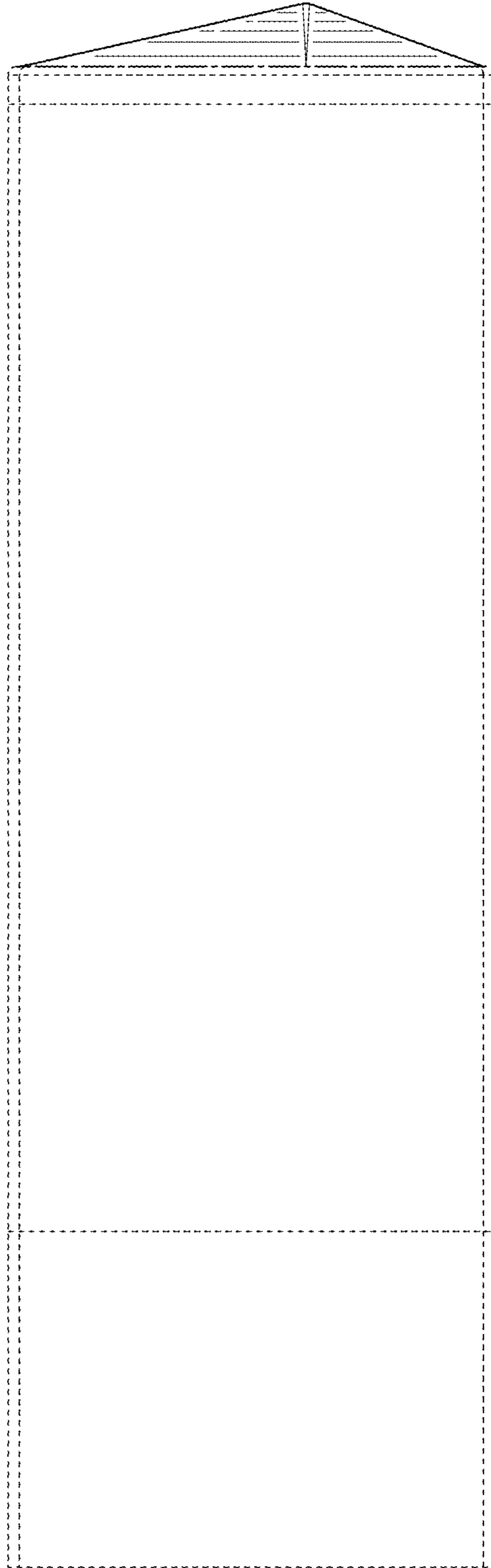

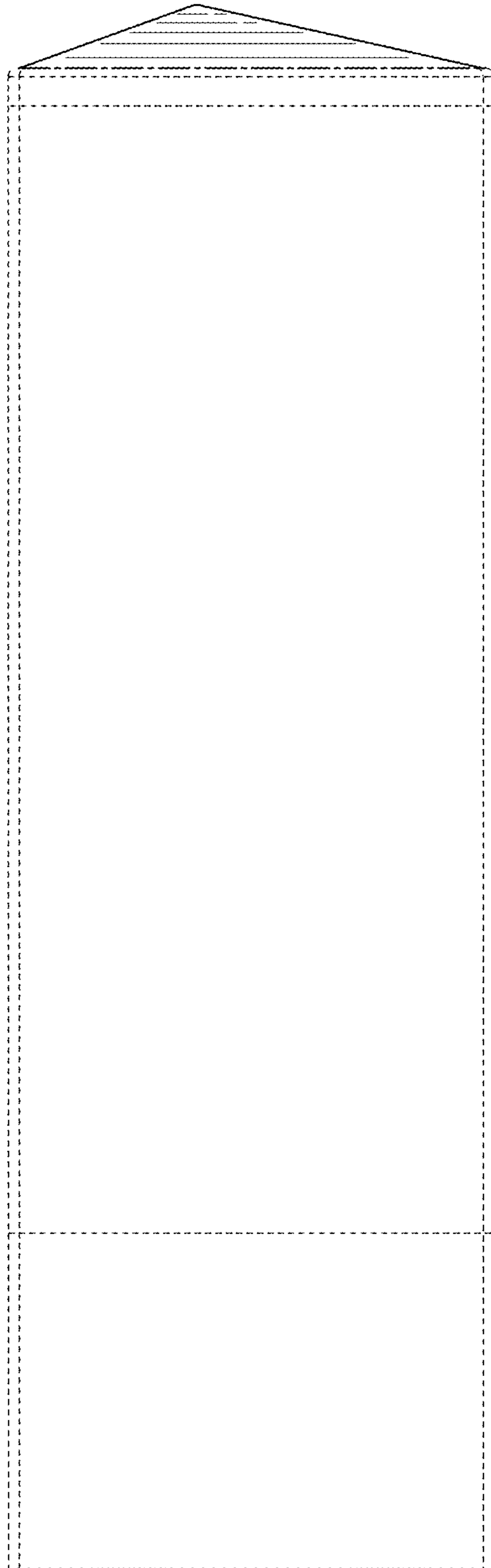

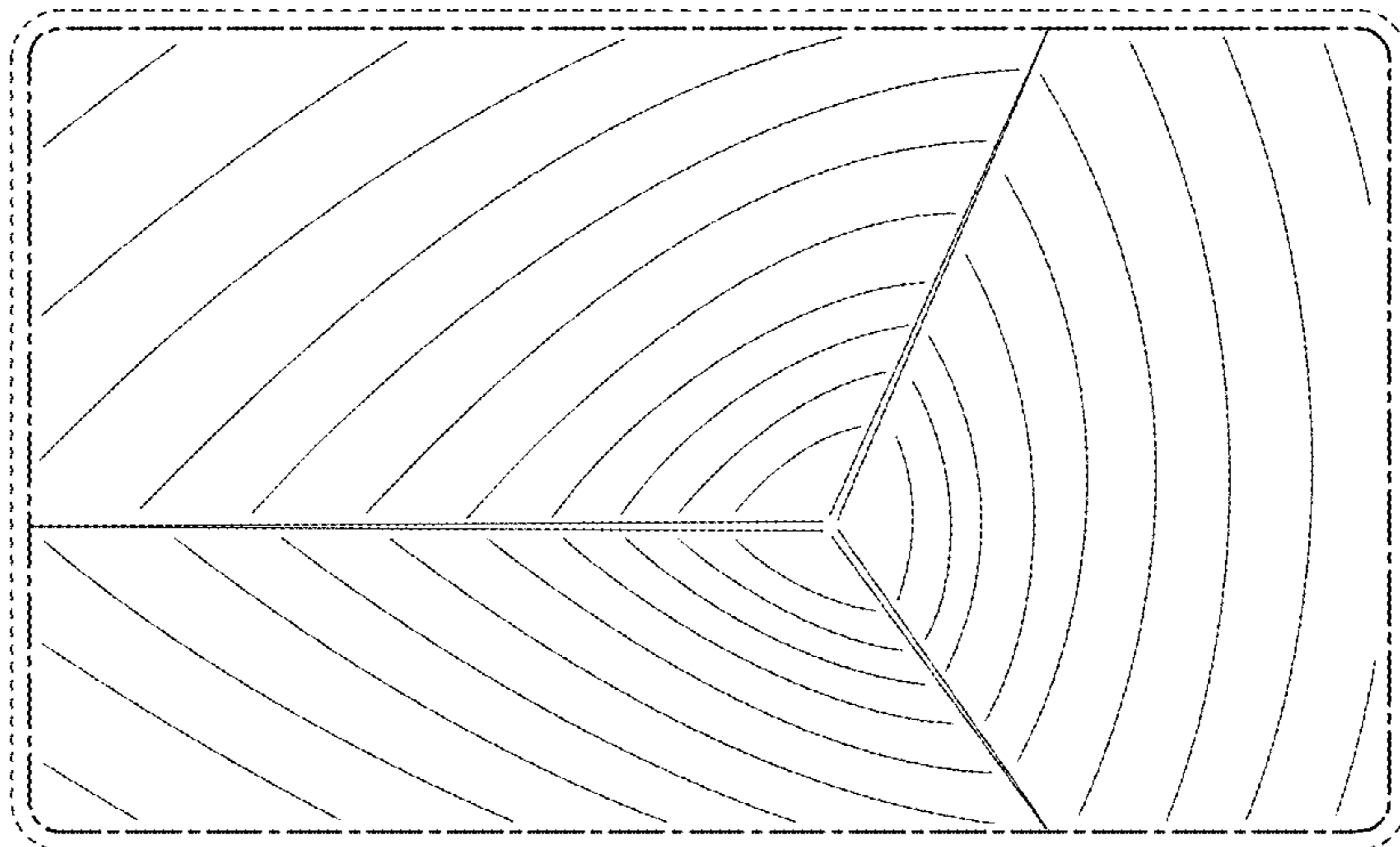

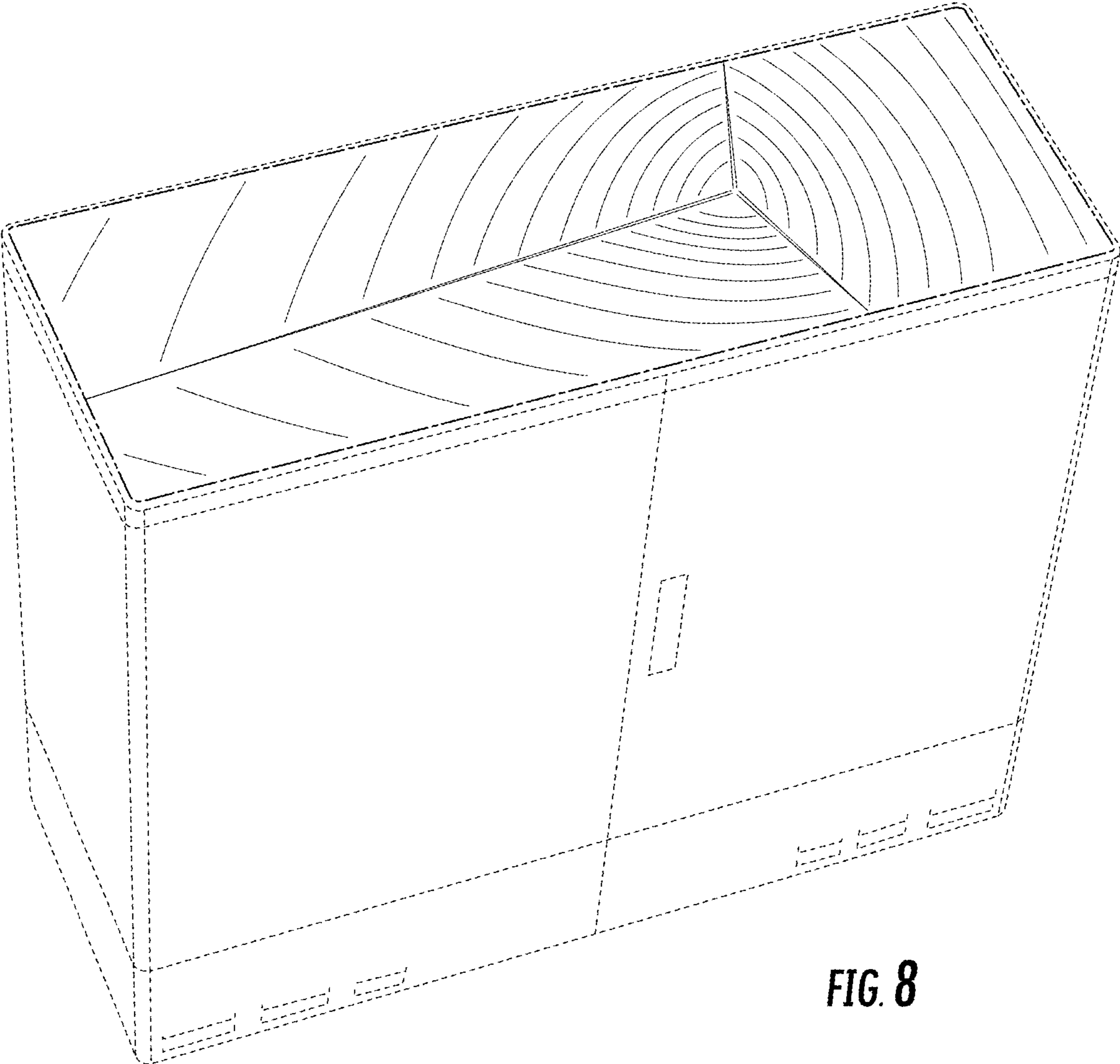

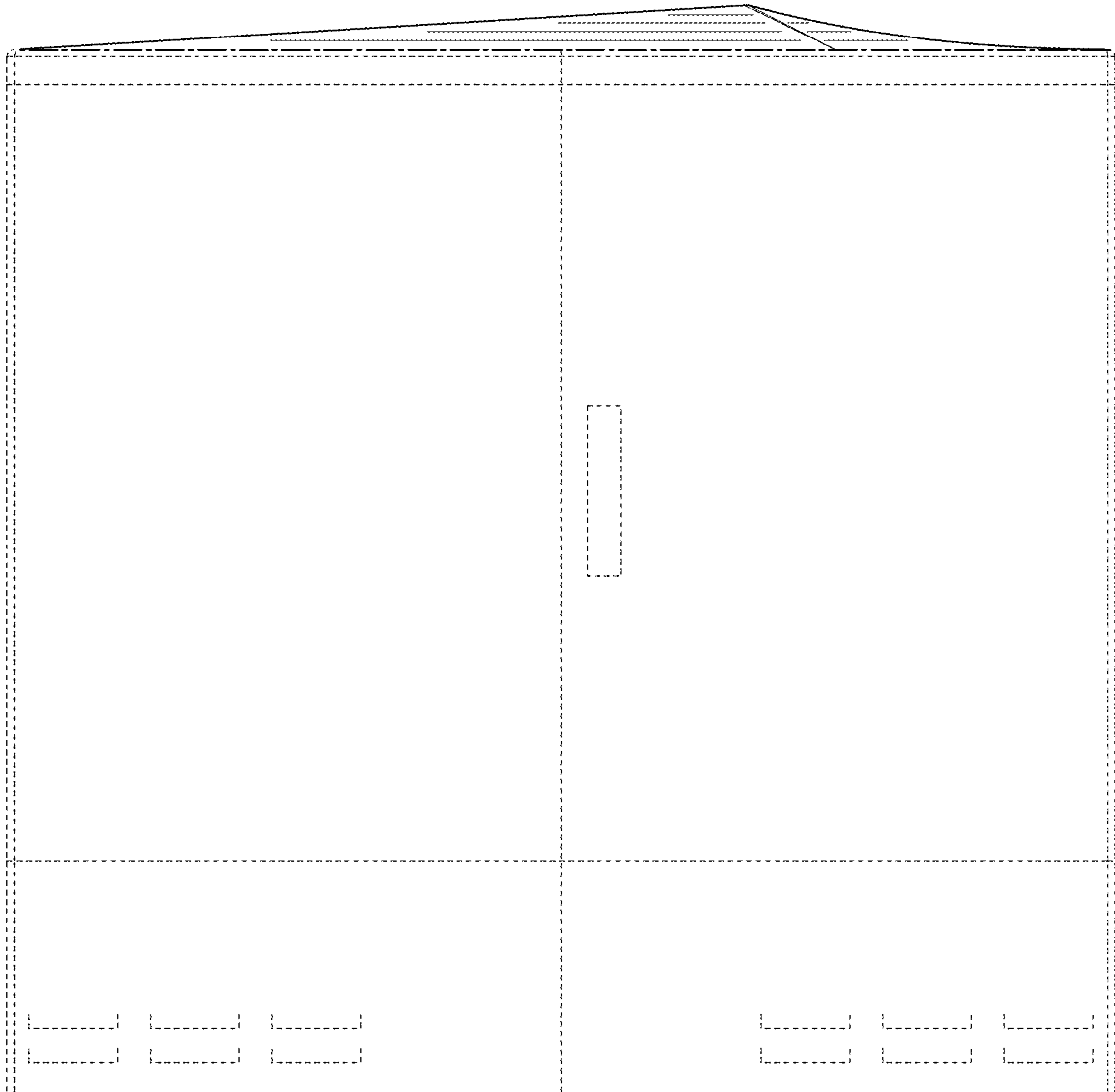

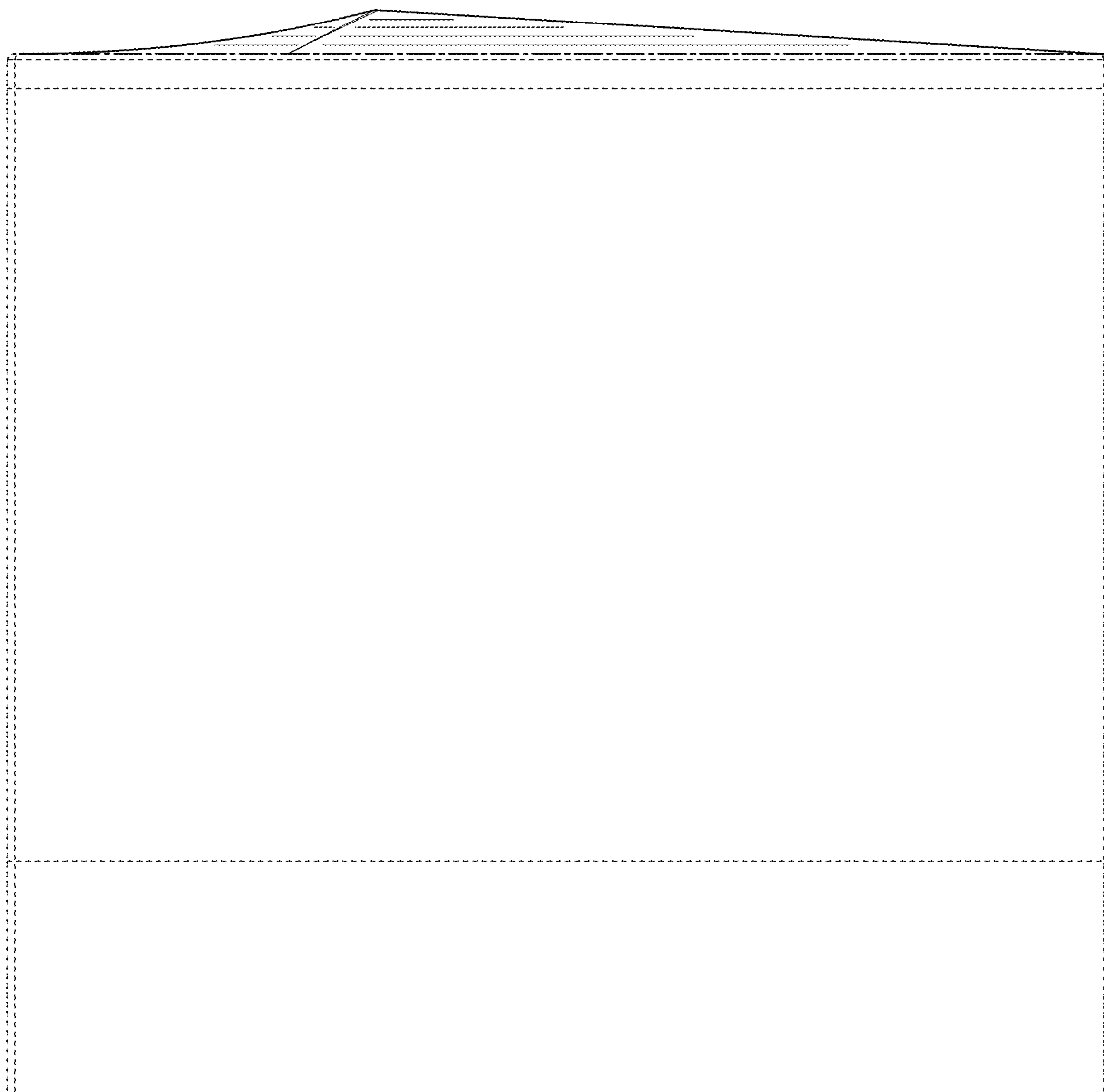

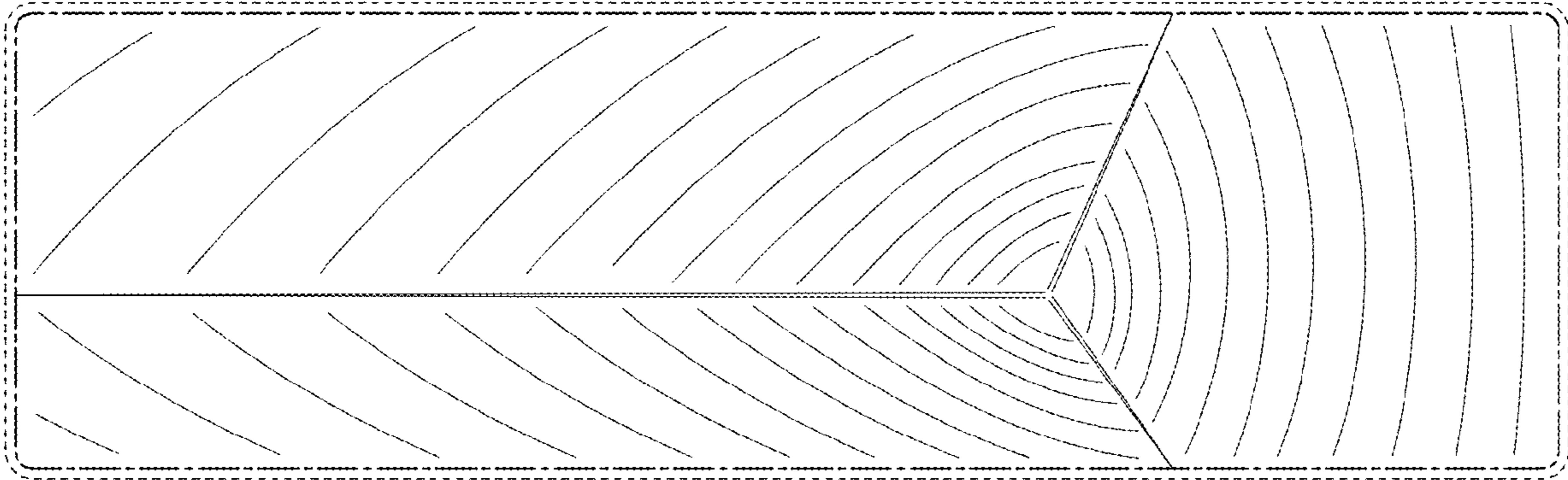

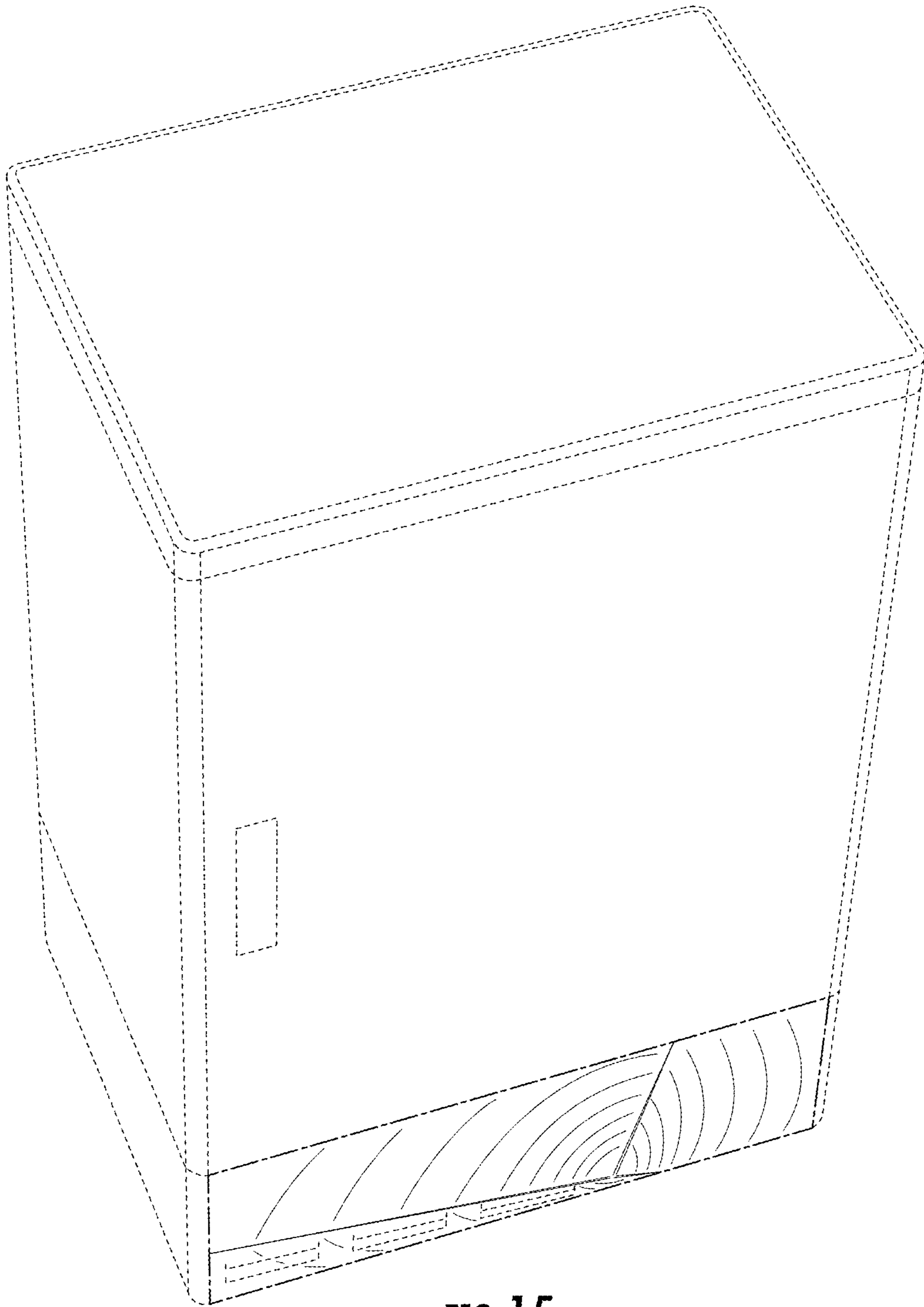

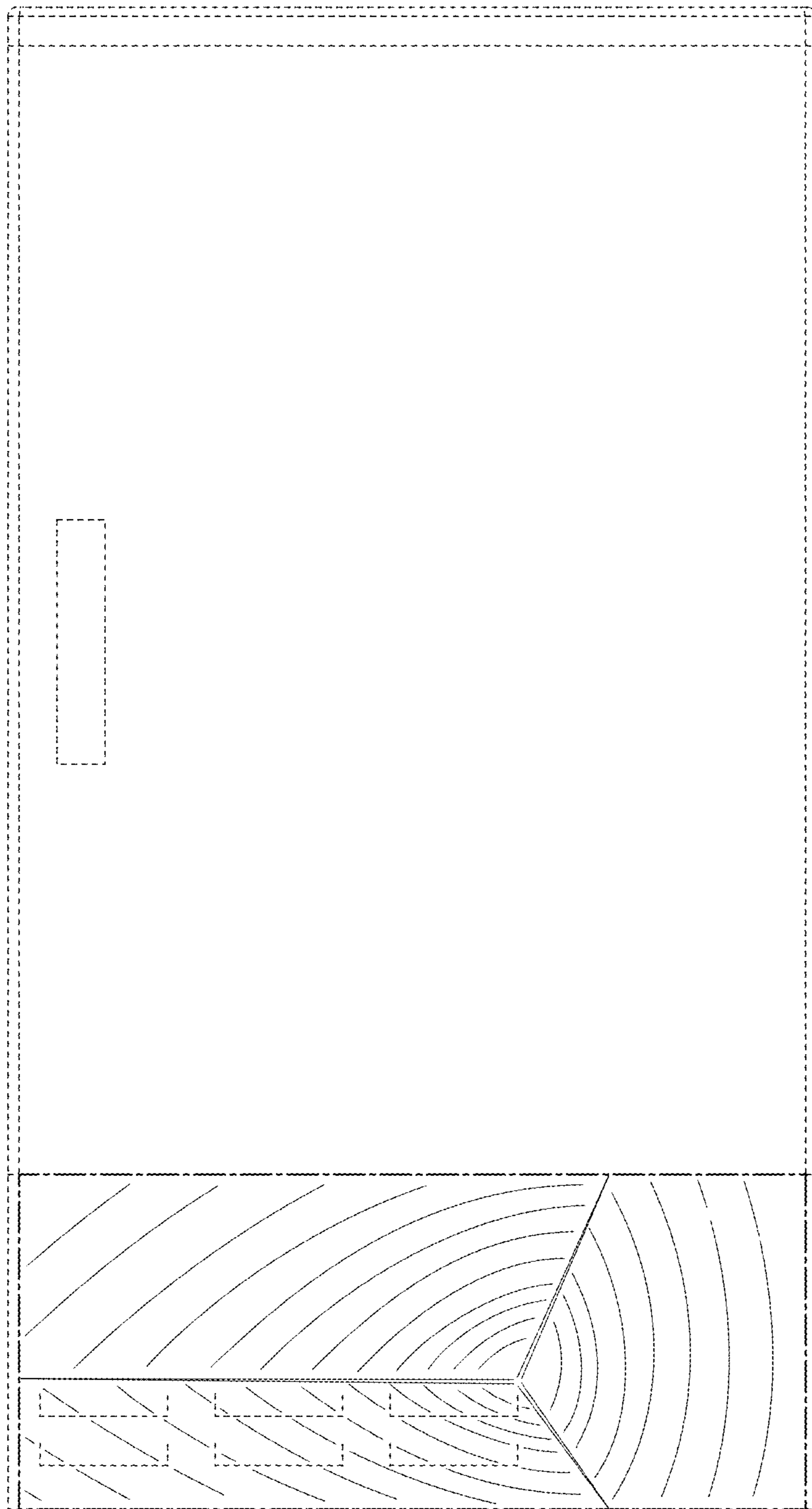

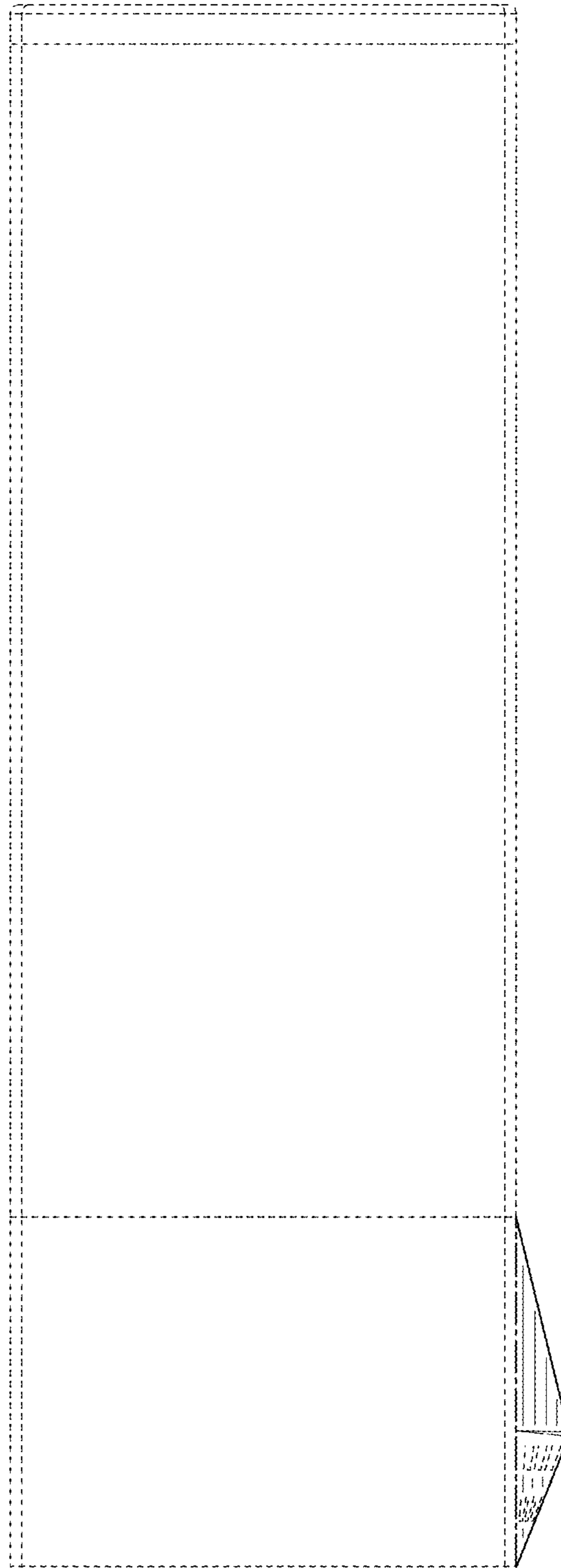

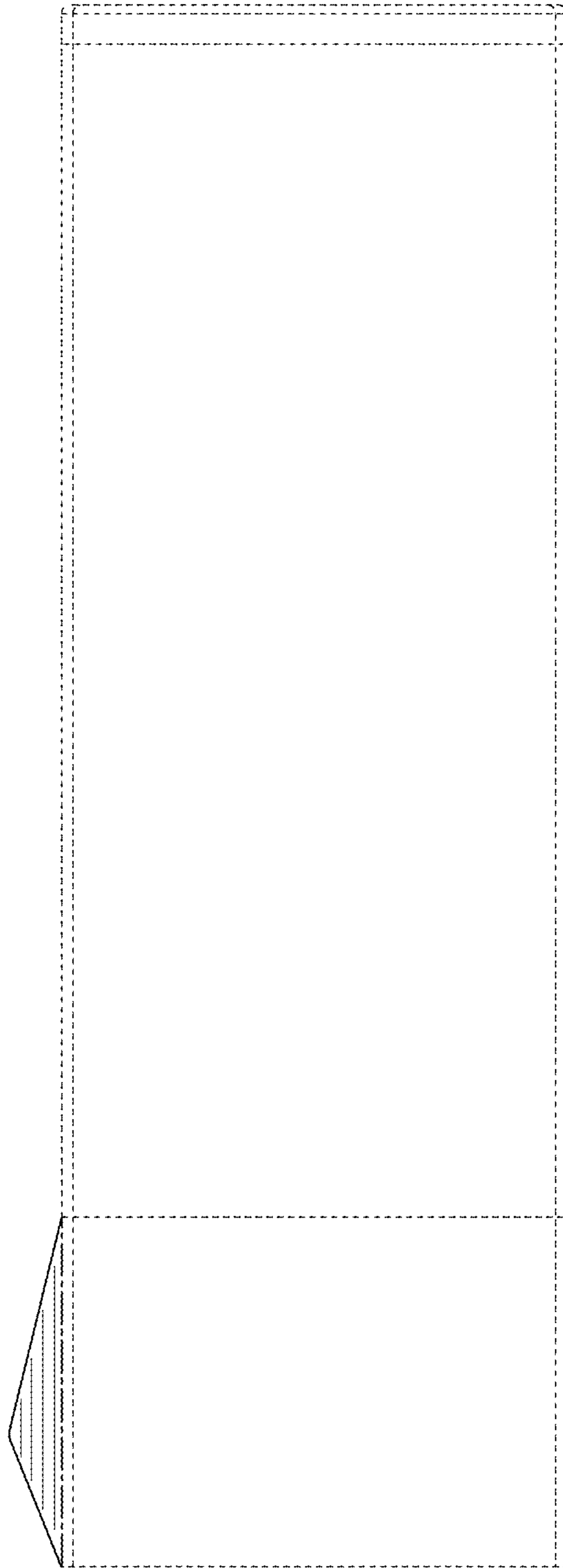

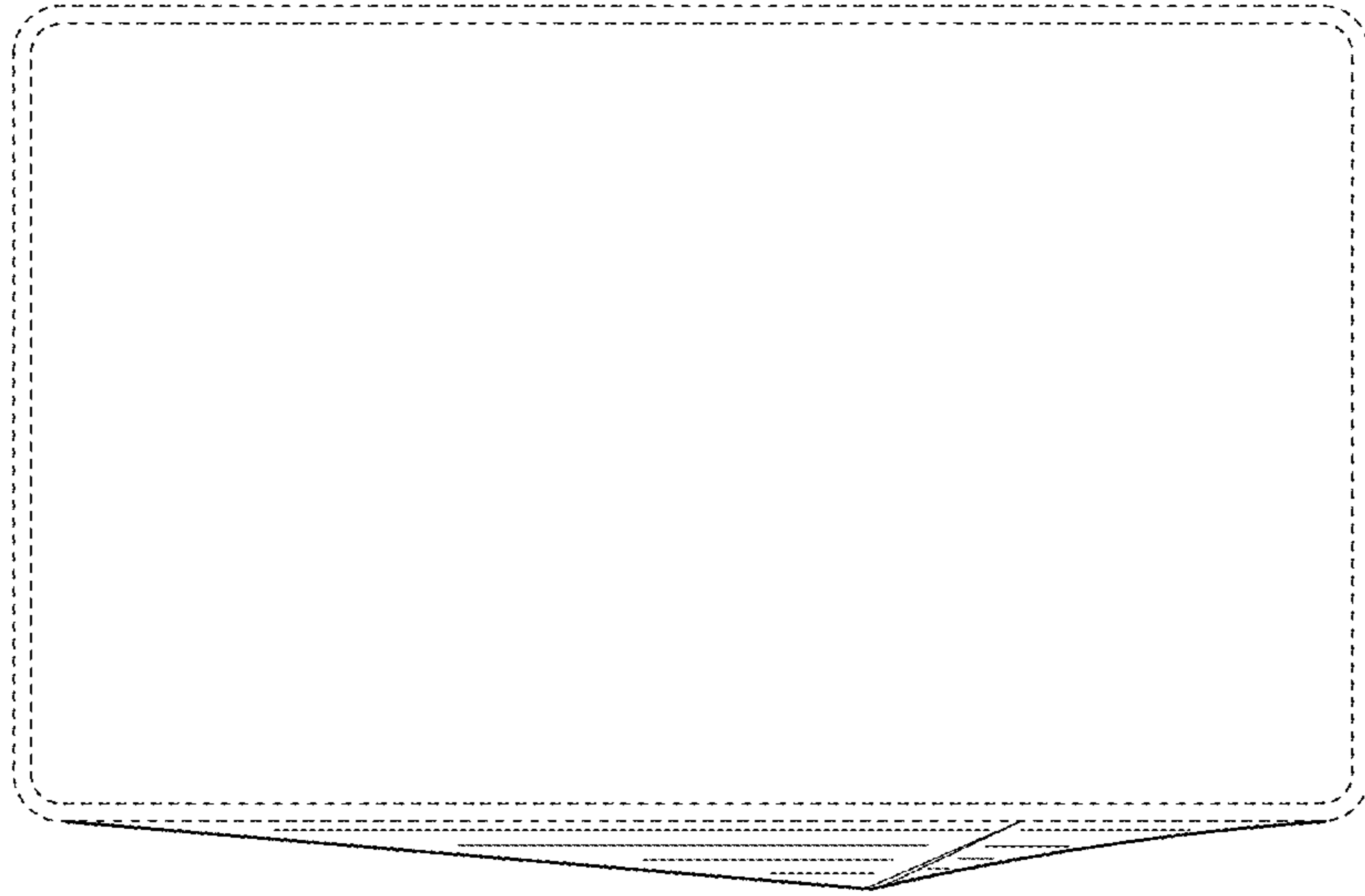

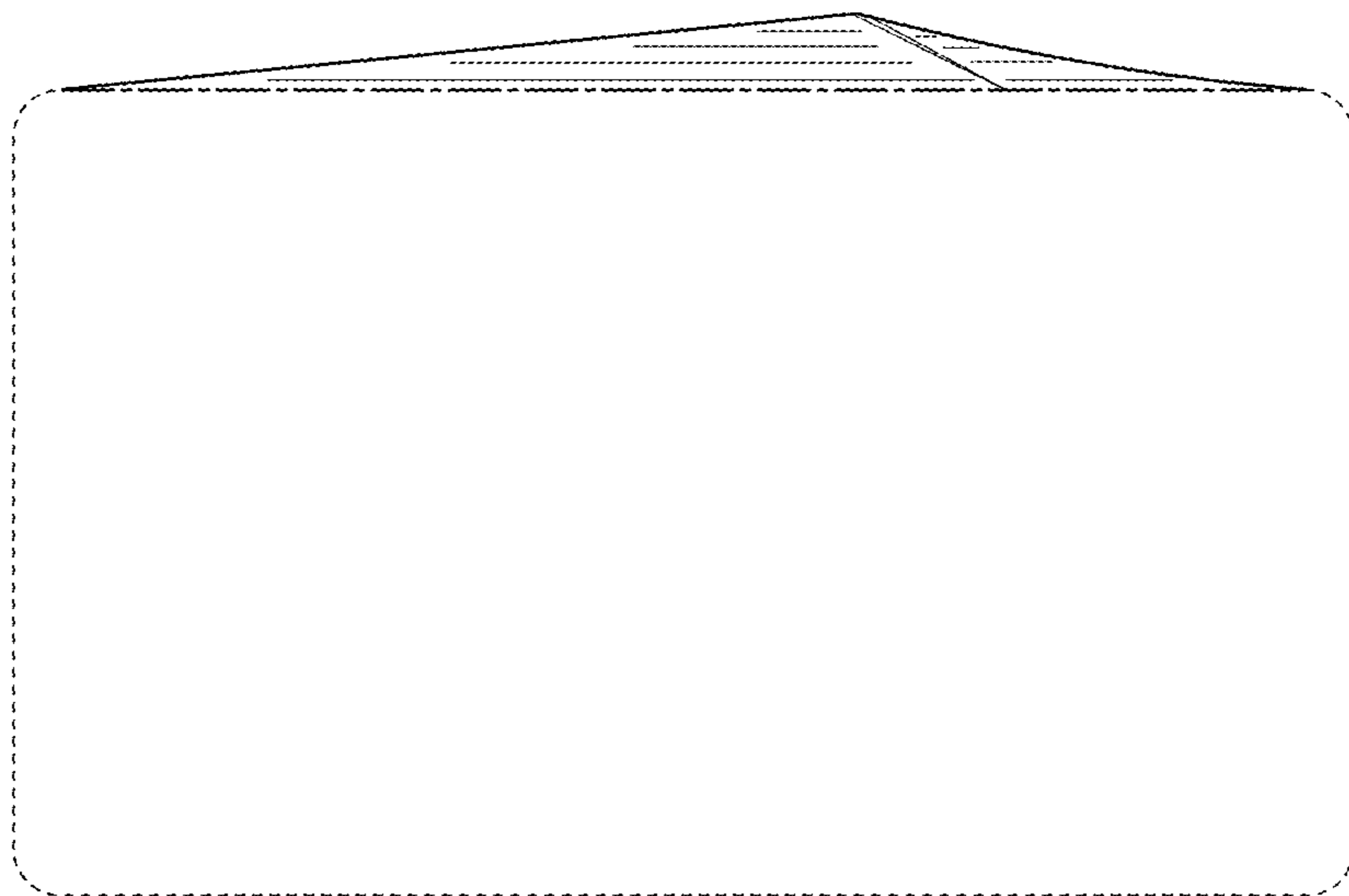

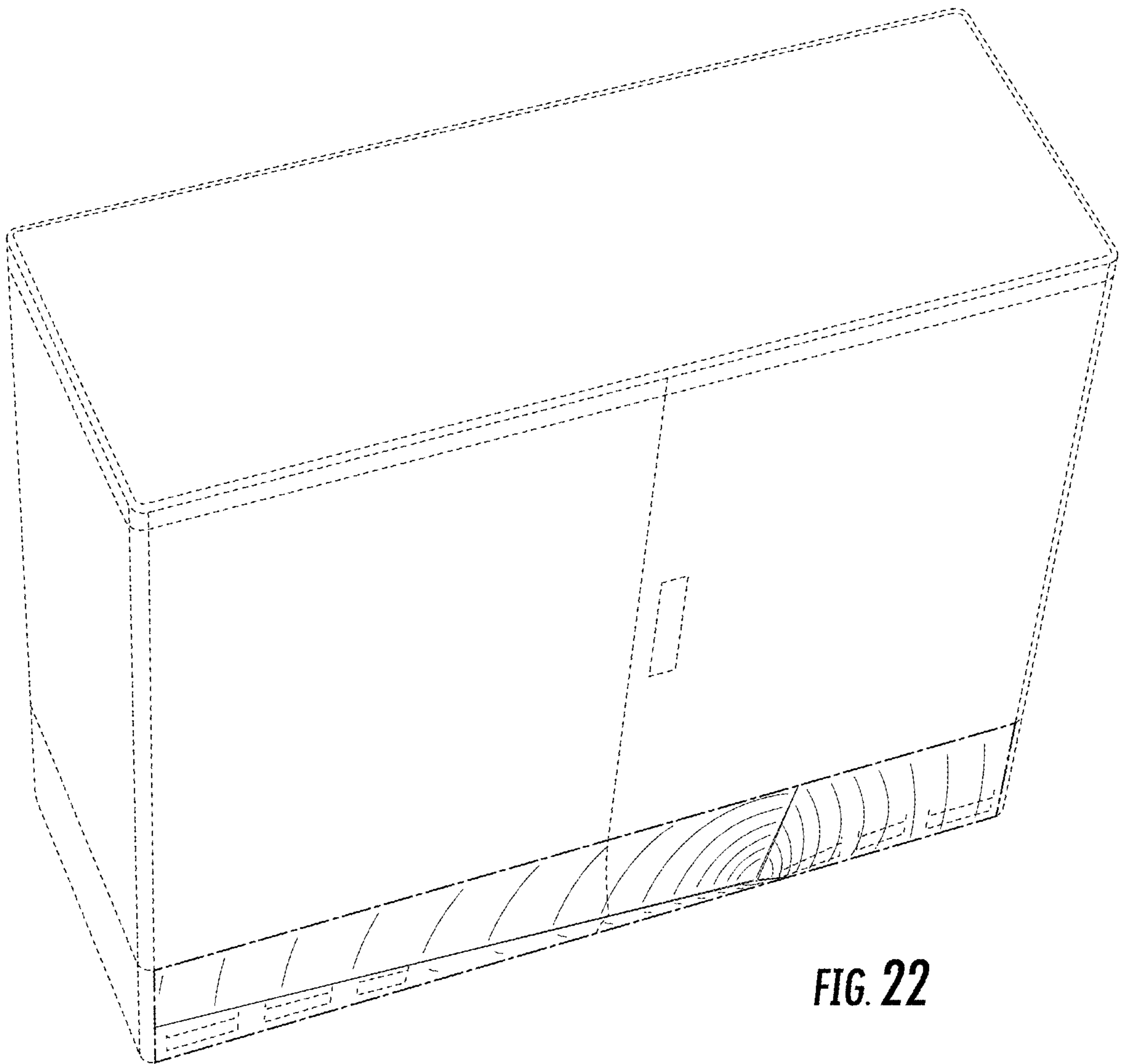

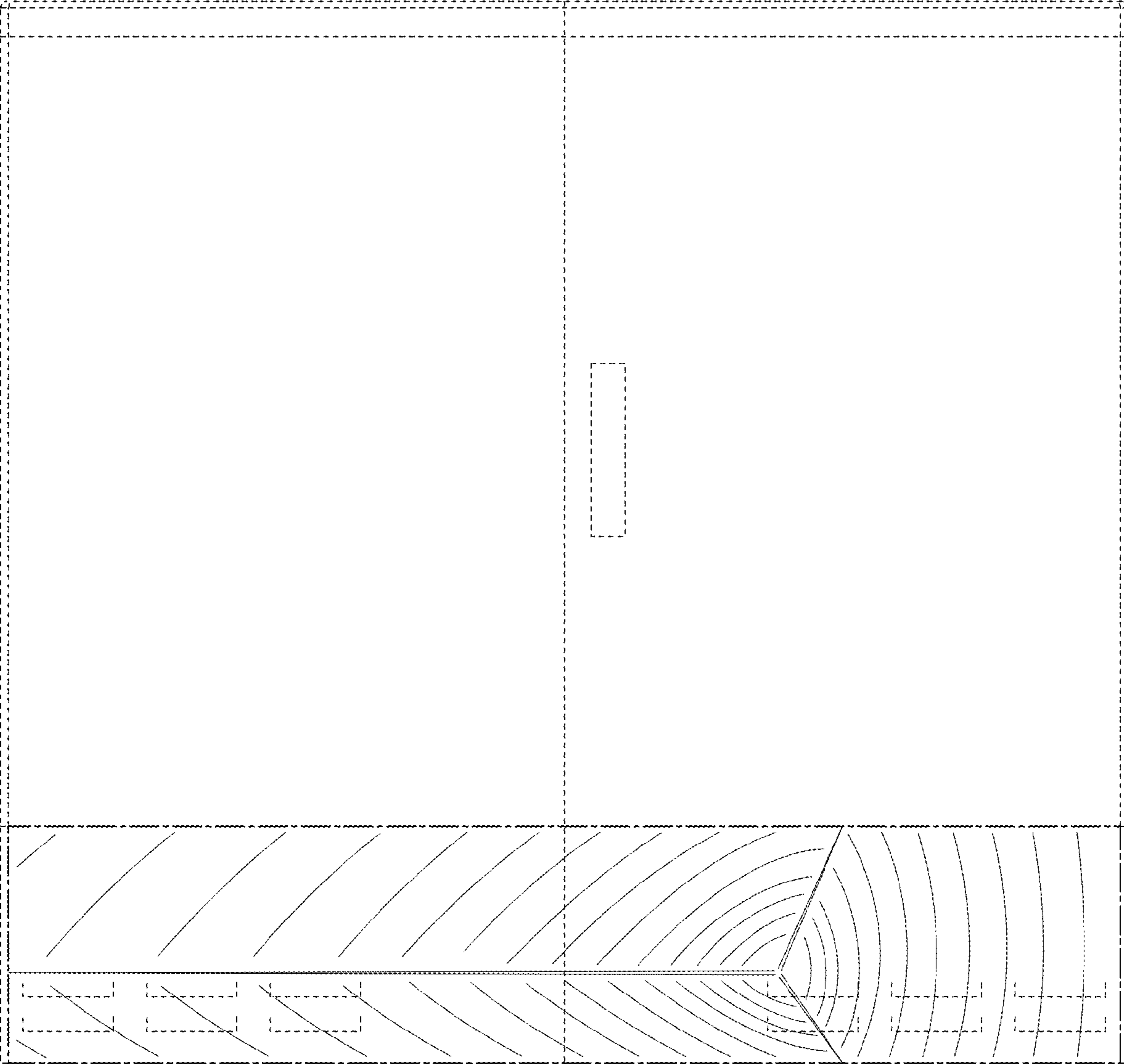

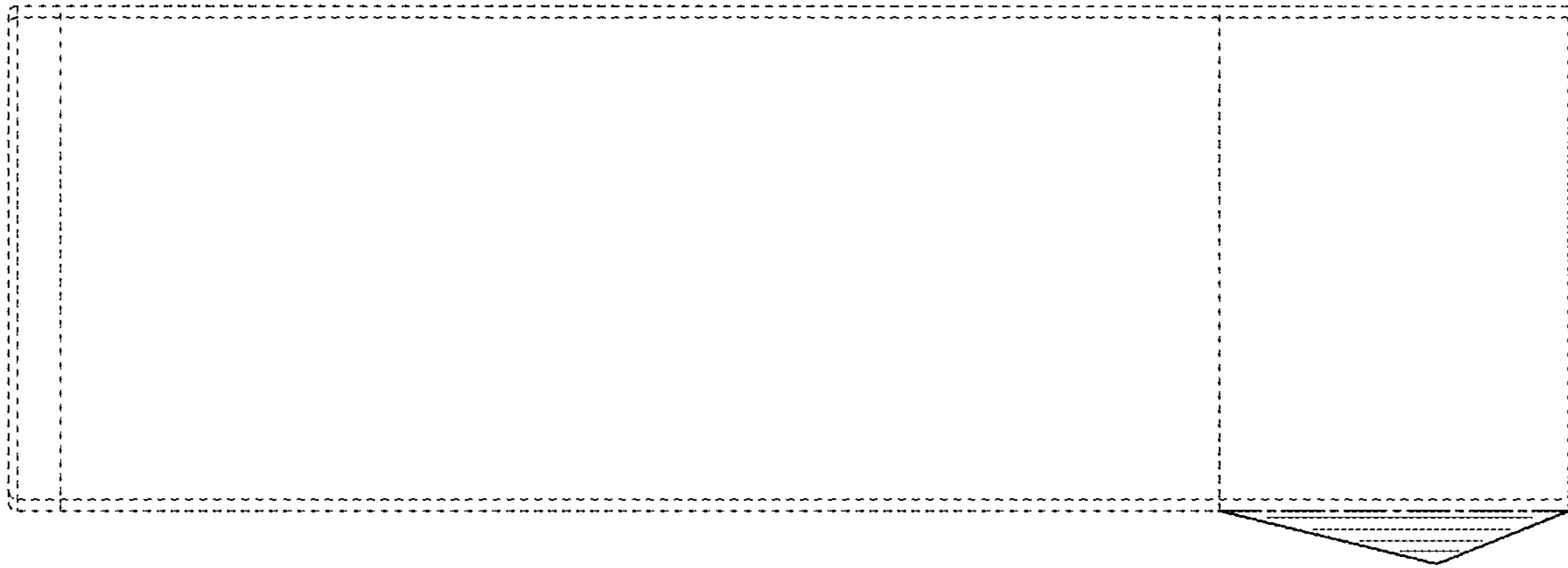

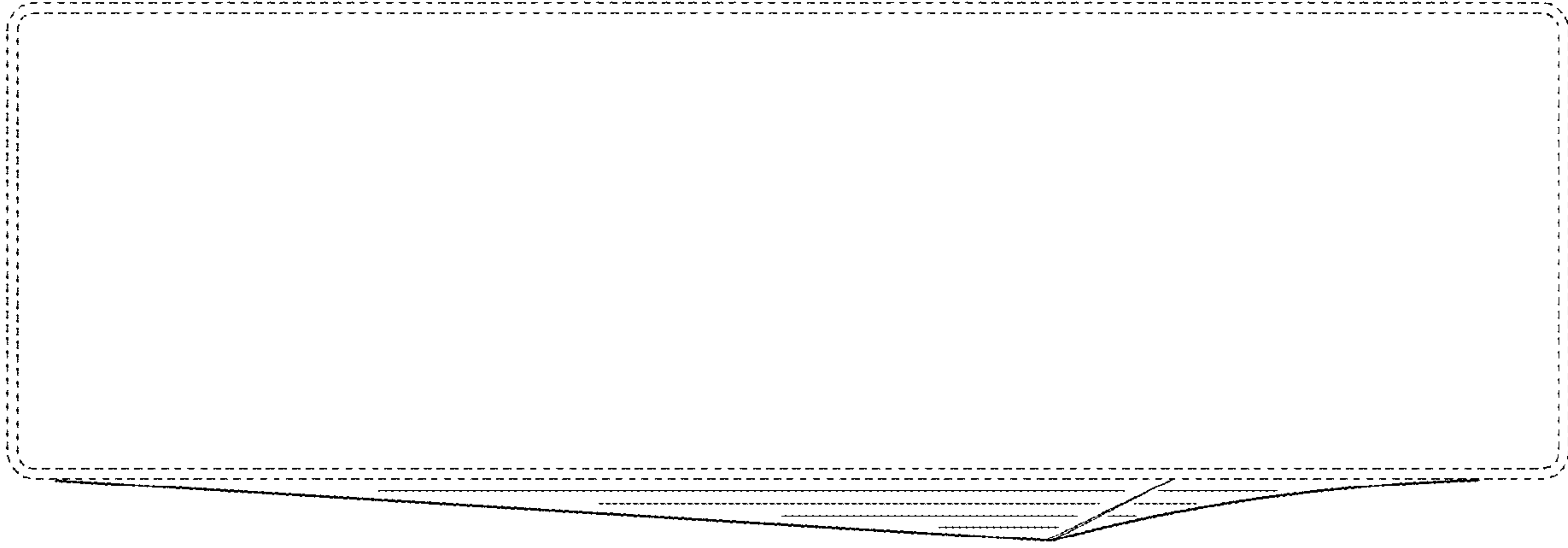

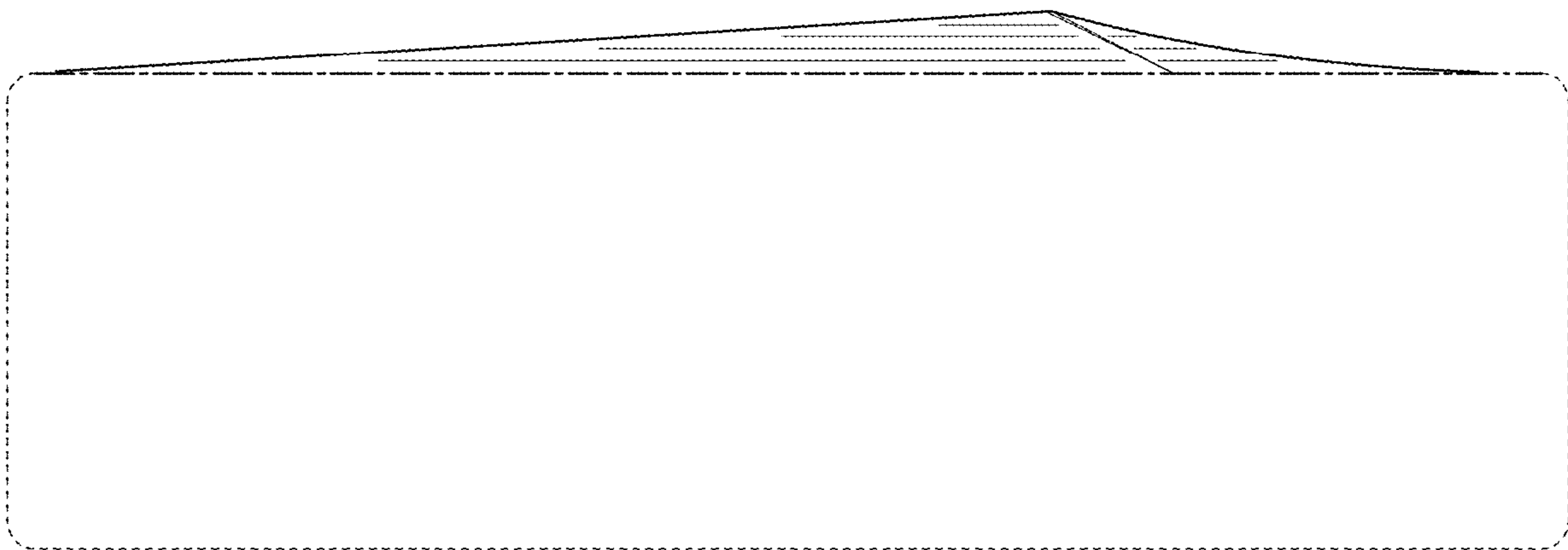
