DESCRIPTION

FIG. 1 is a front perspective view of a terminal for networks, showing our new design;

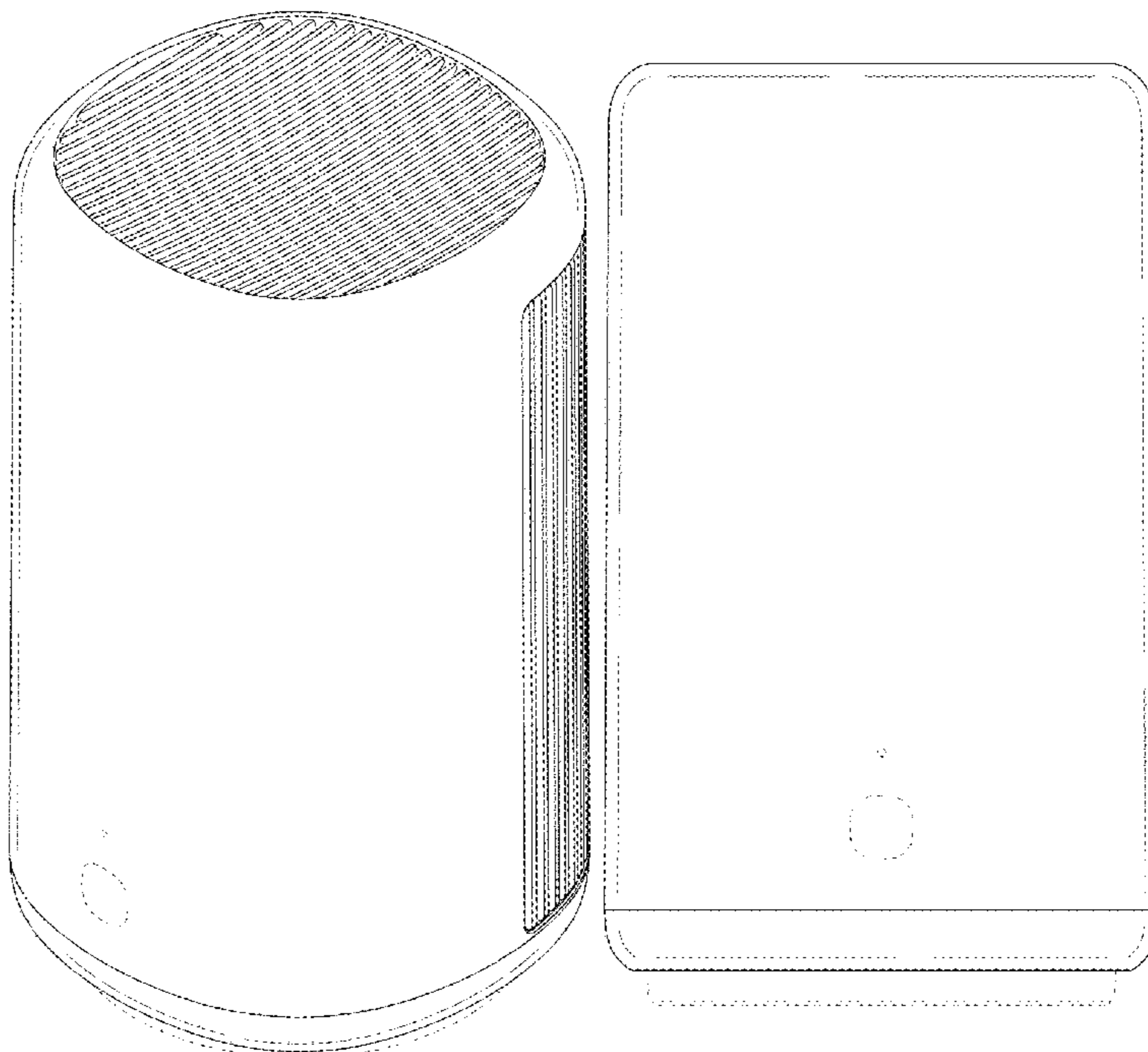

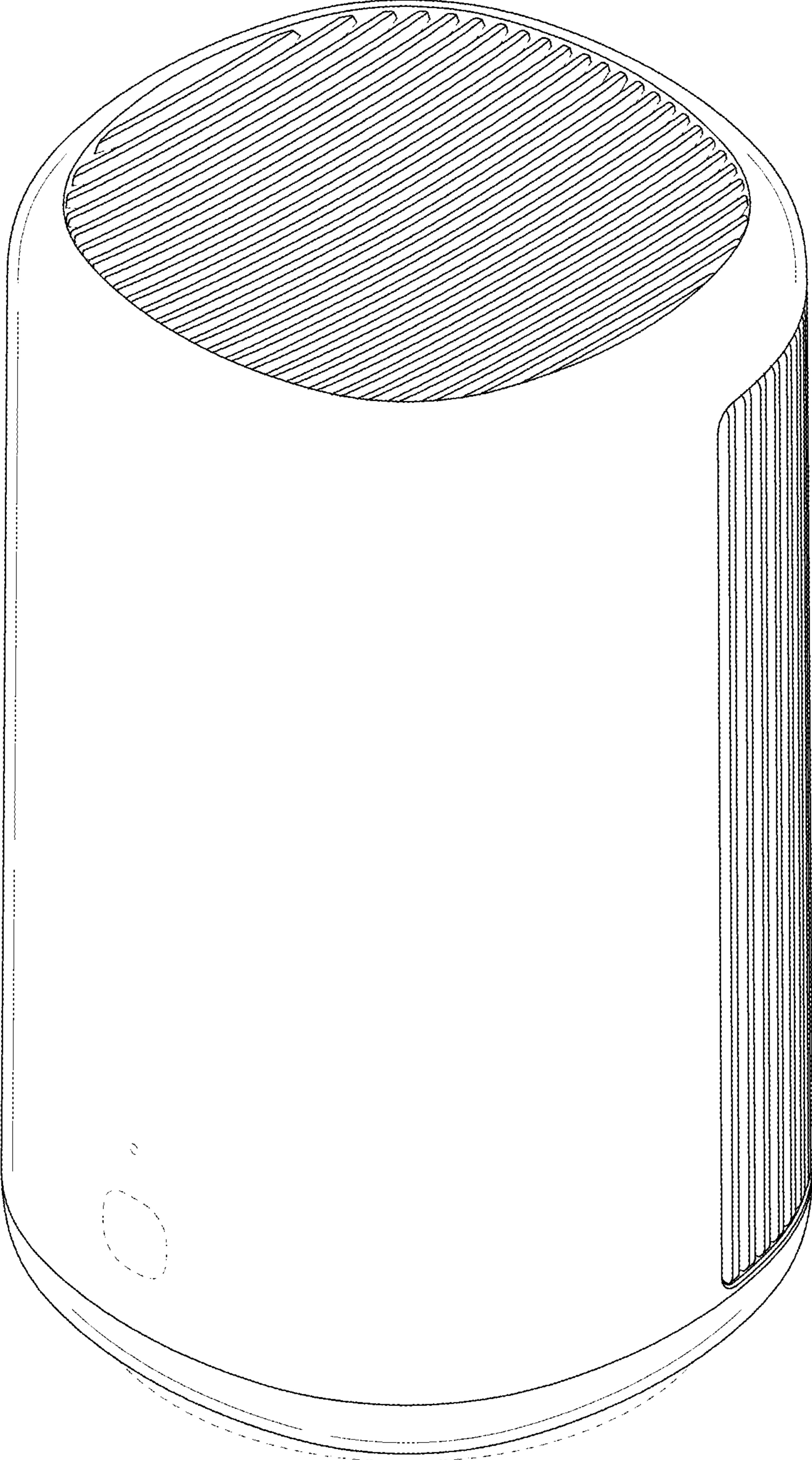

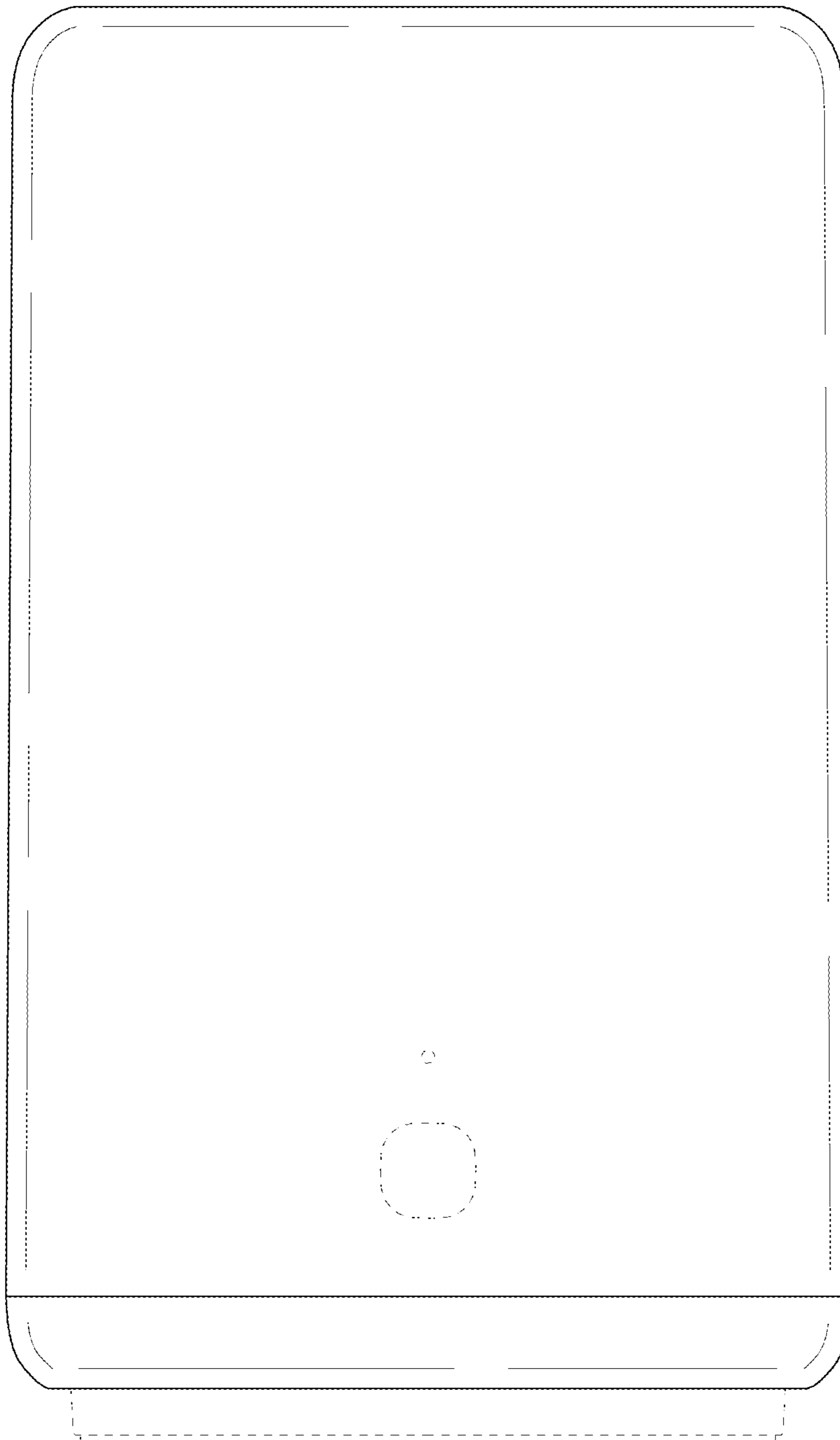

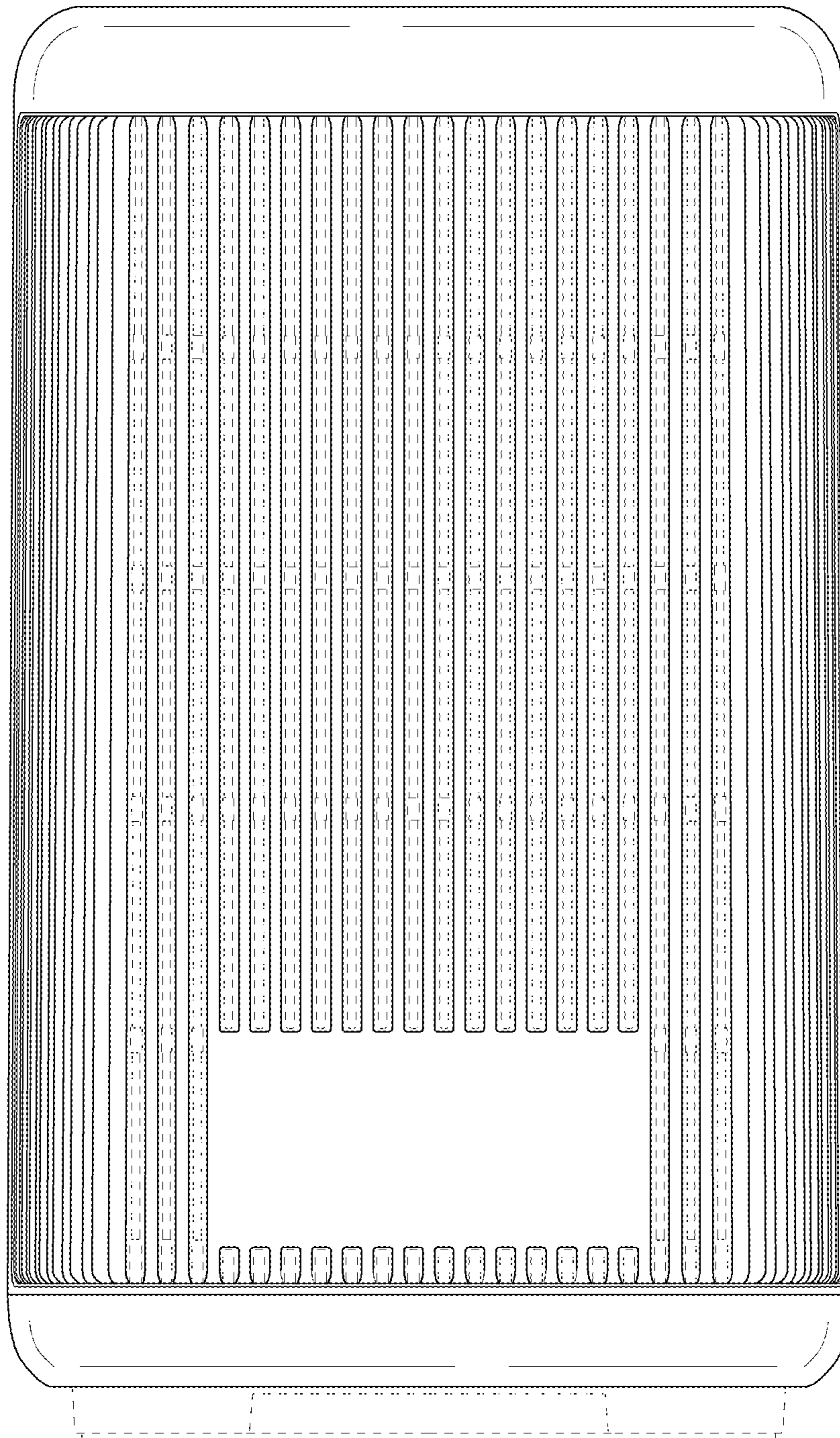

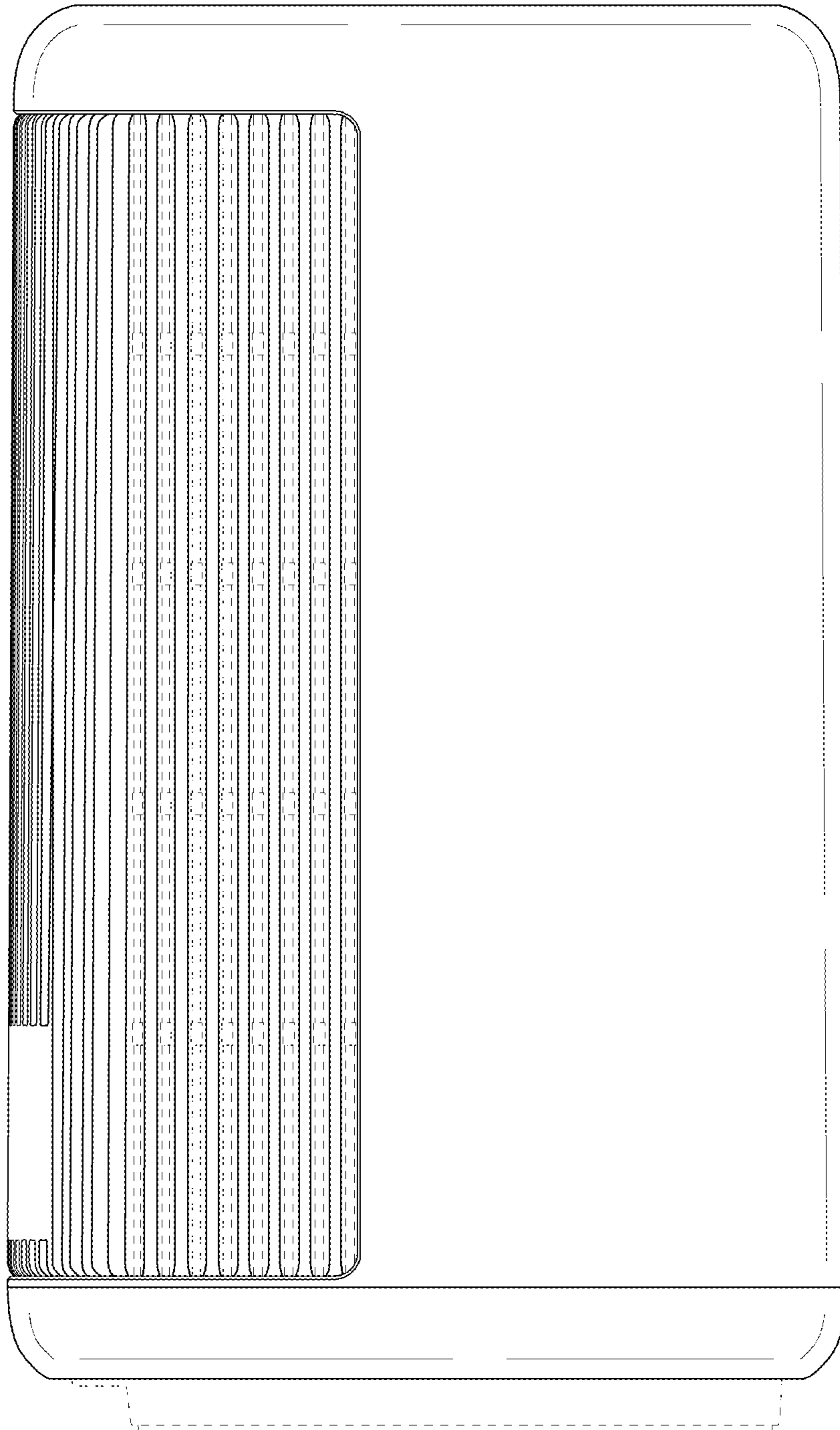

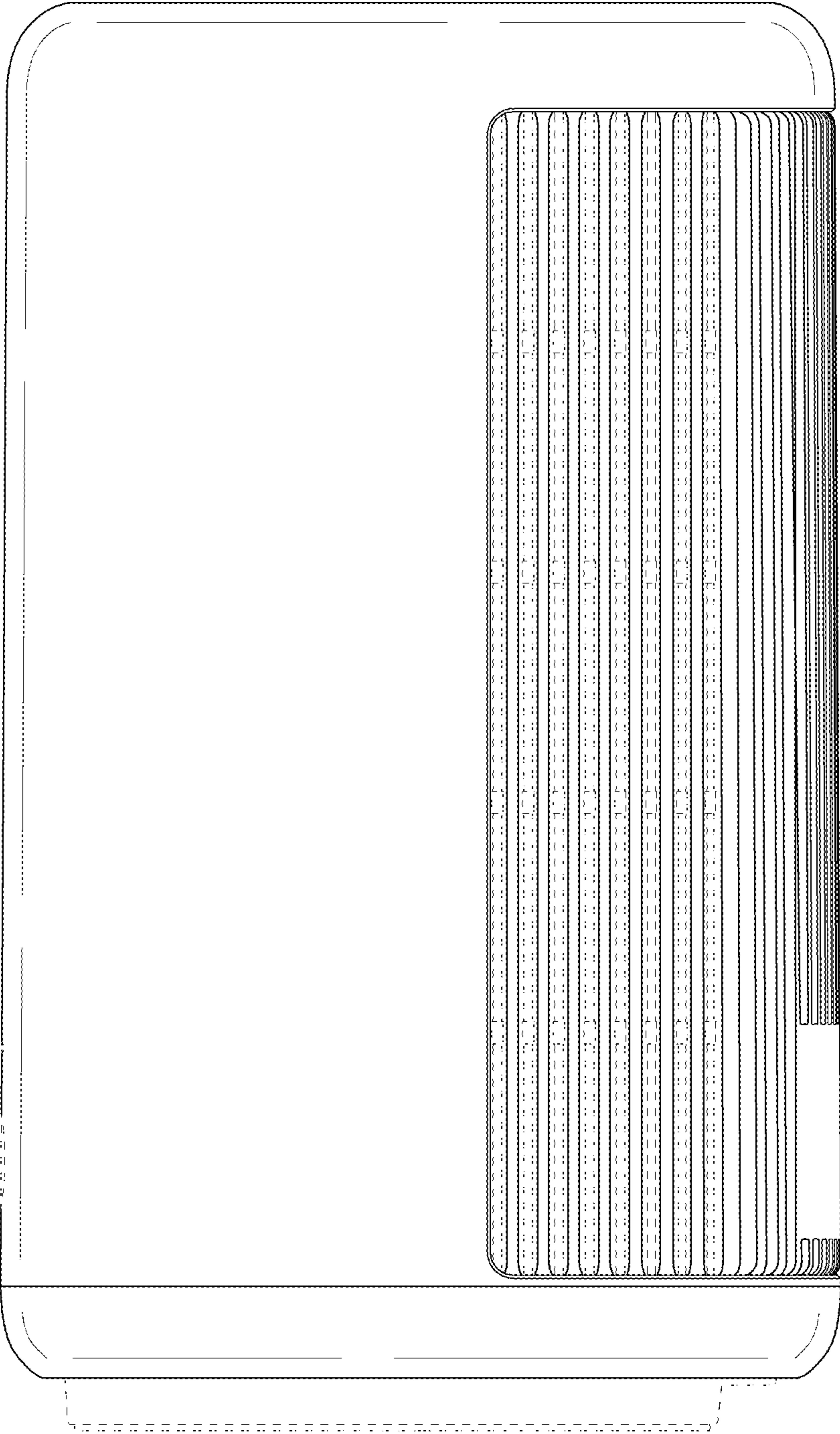

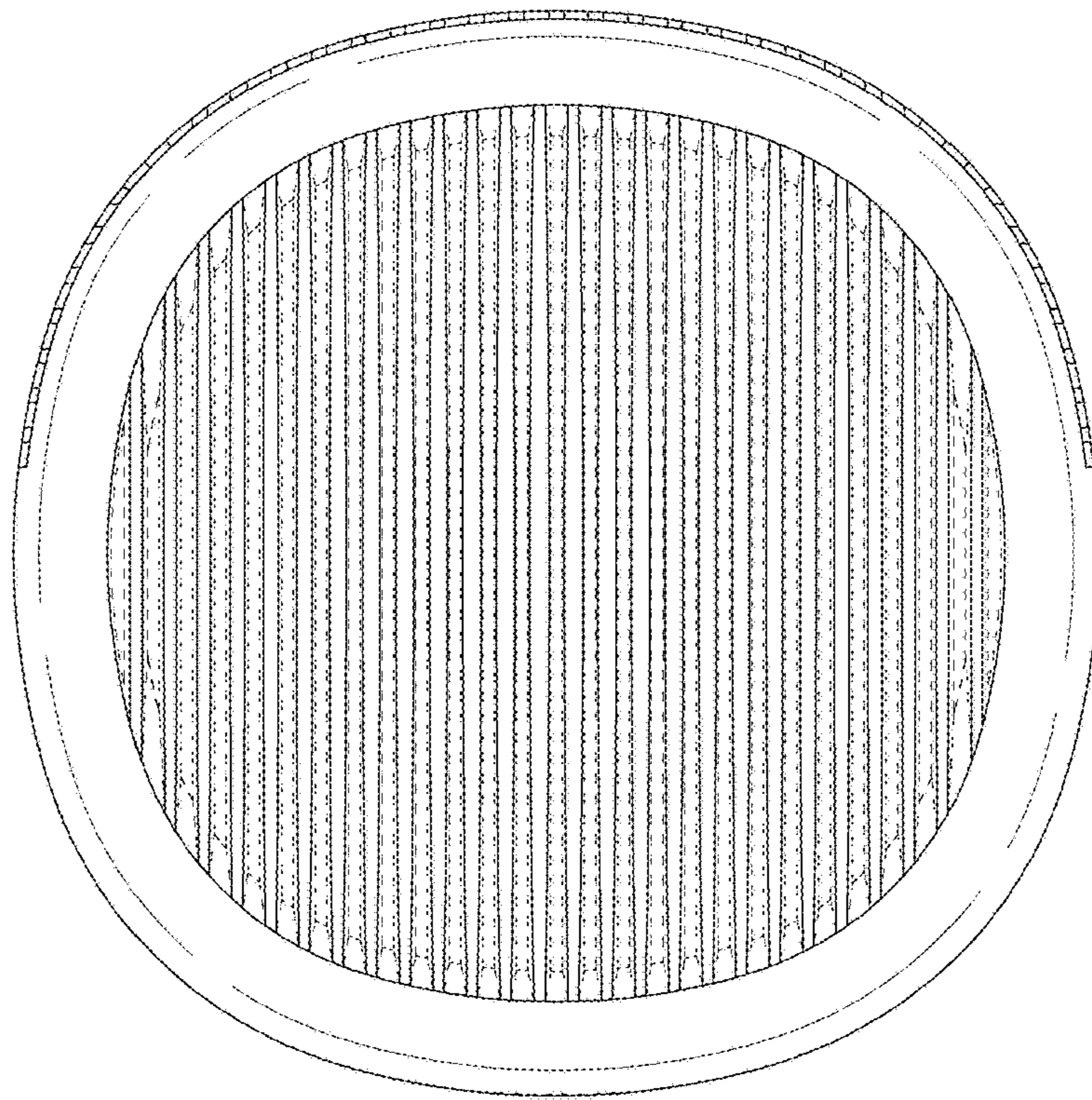
