DESCRIPTION

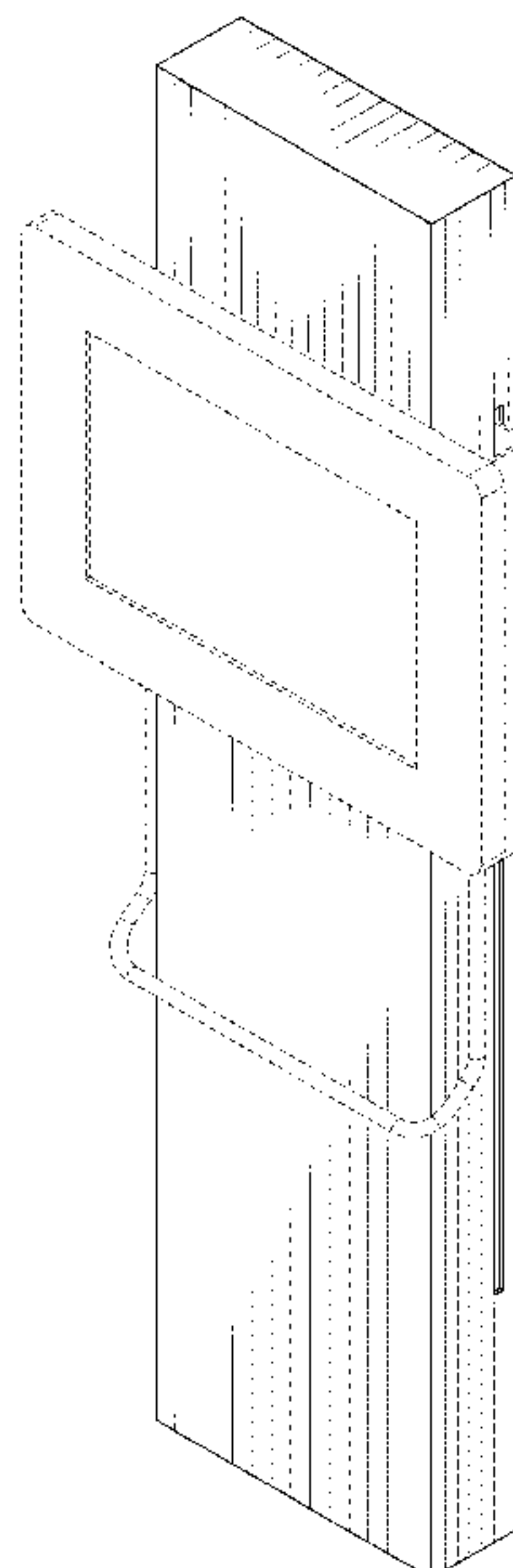
FIG. 1 is a partial front perspective view of a design for a kiosk display apparatus;

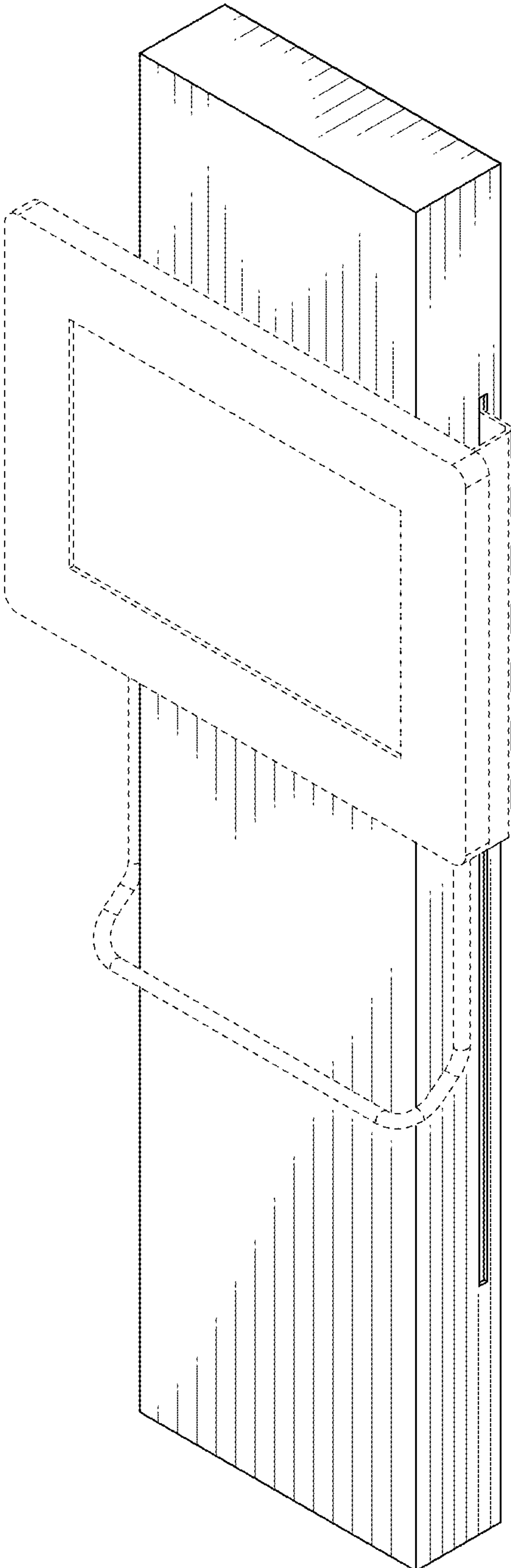

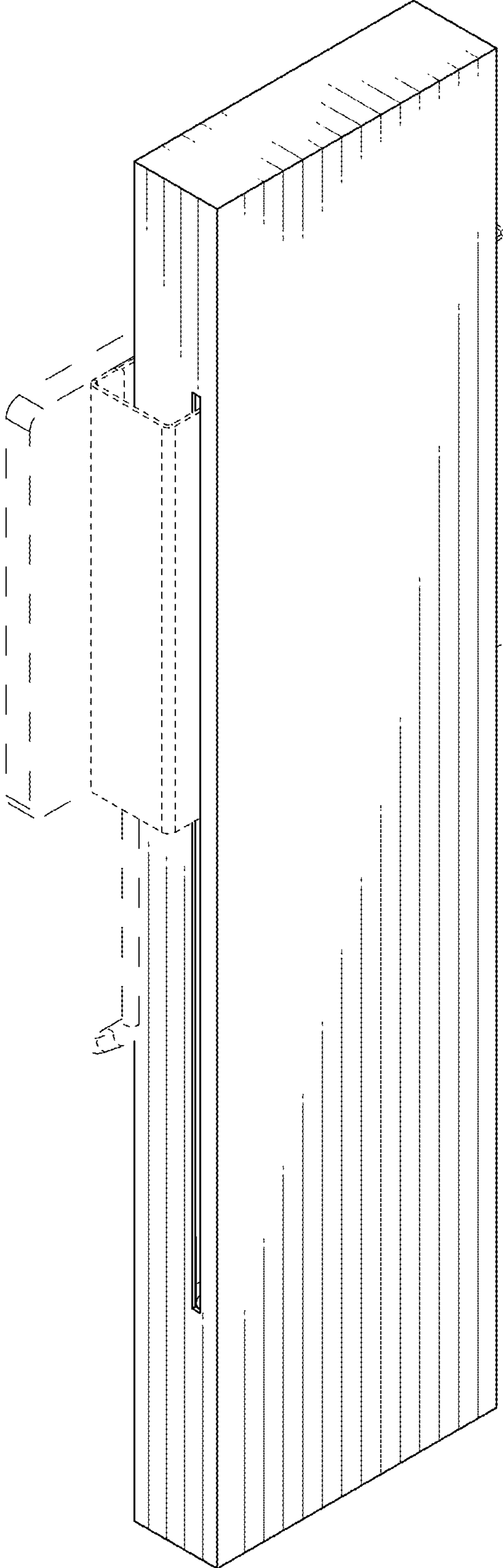

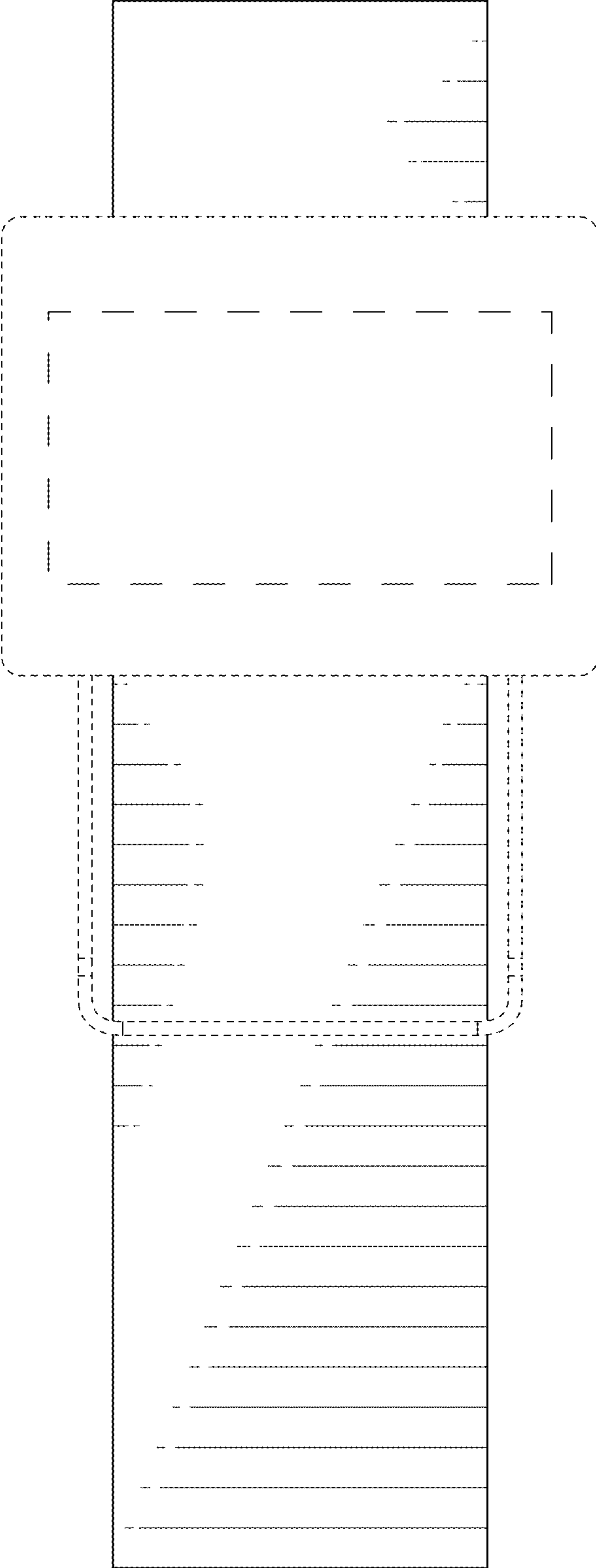

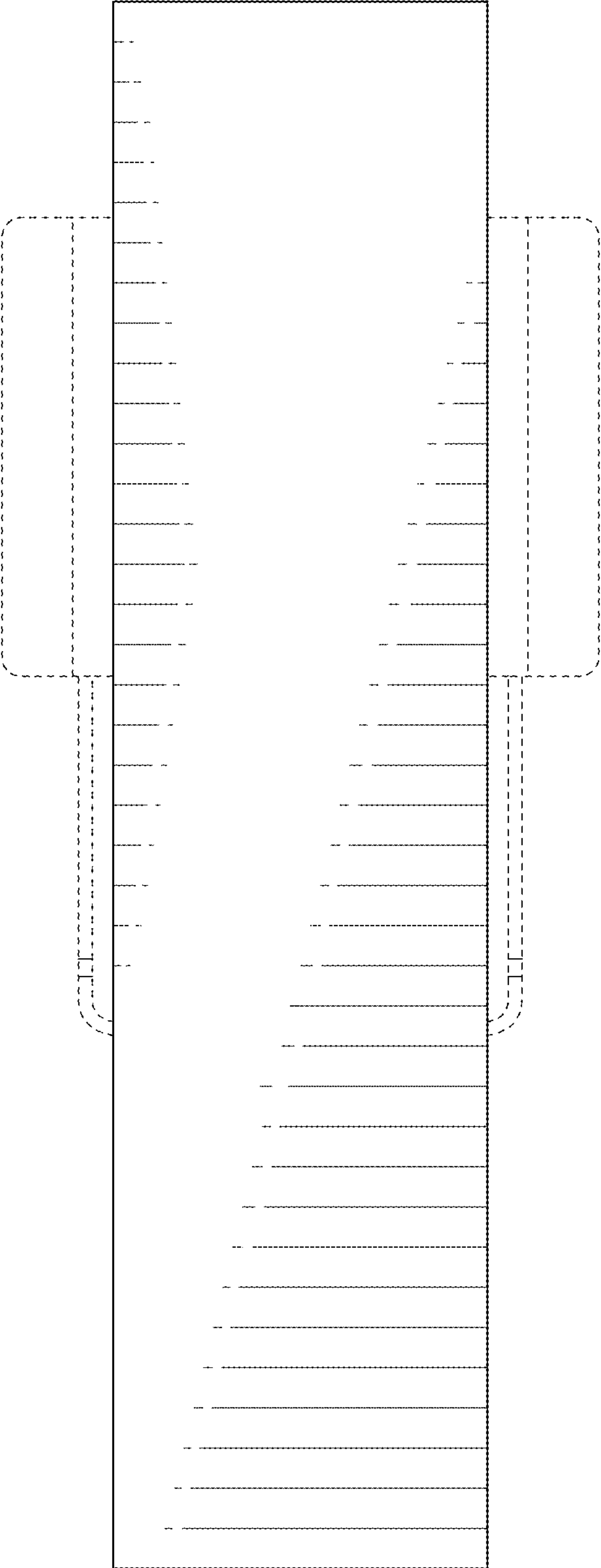

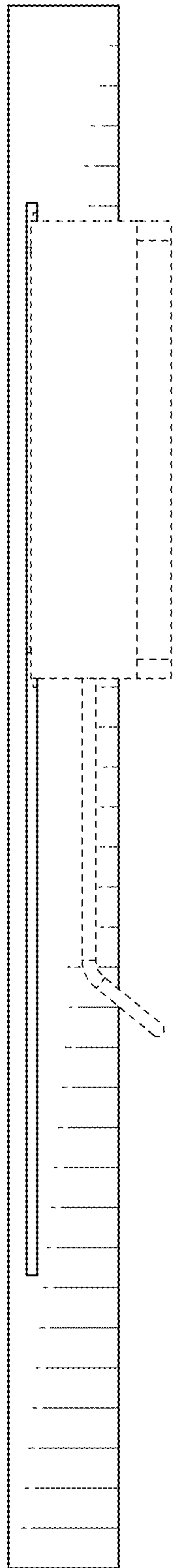

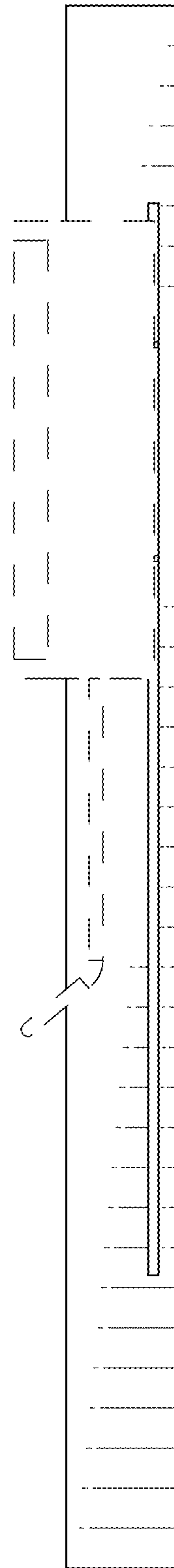

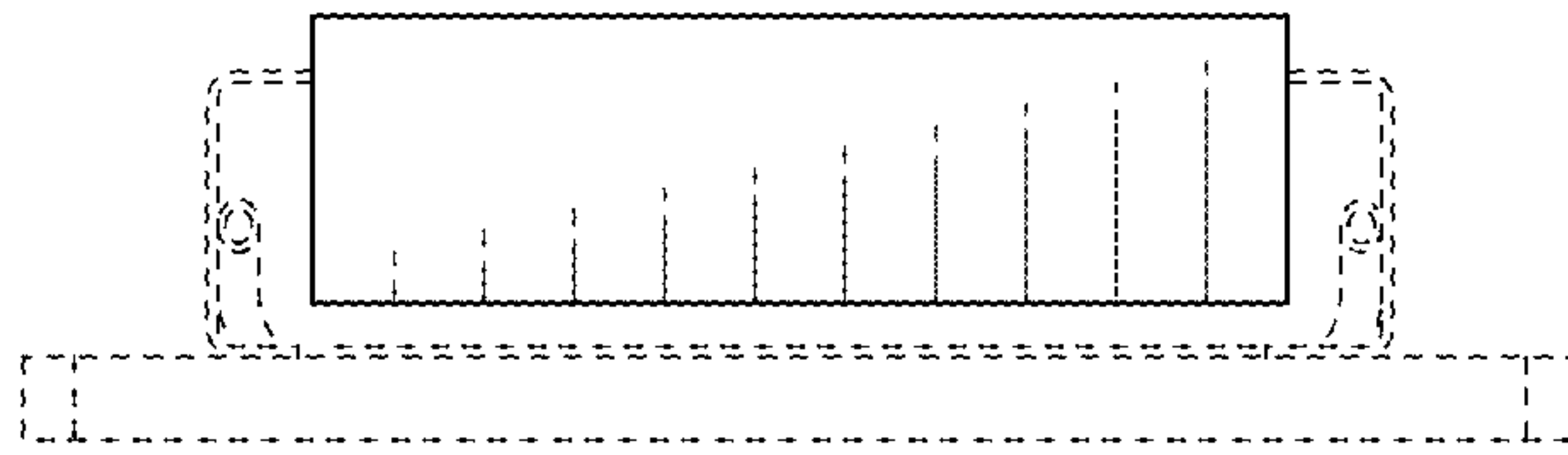

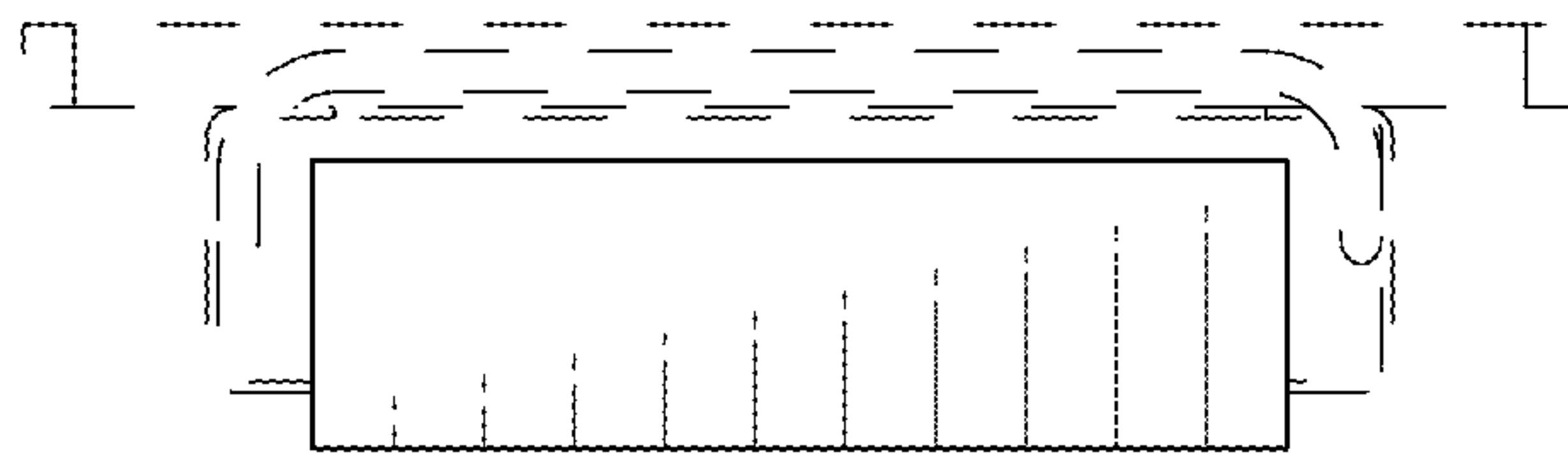
