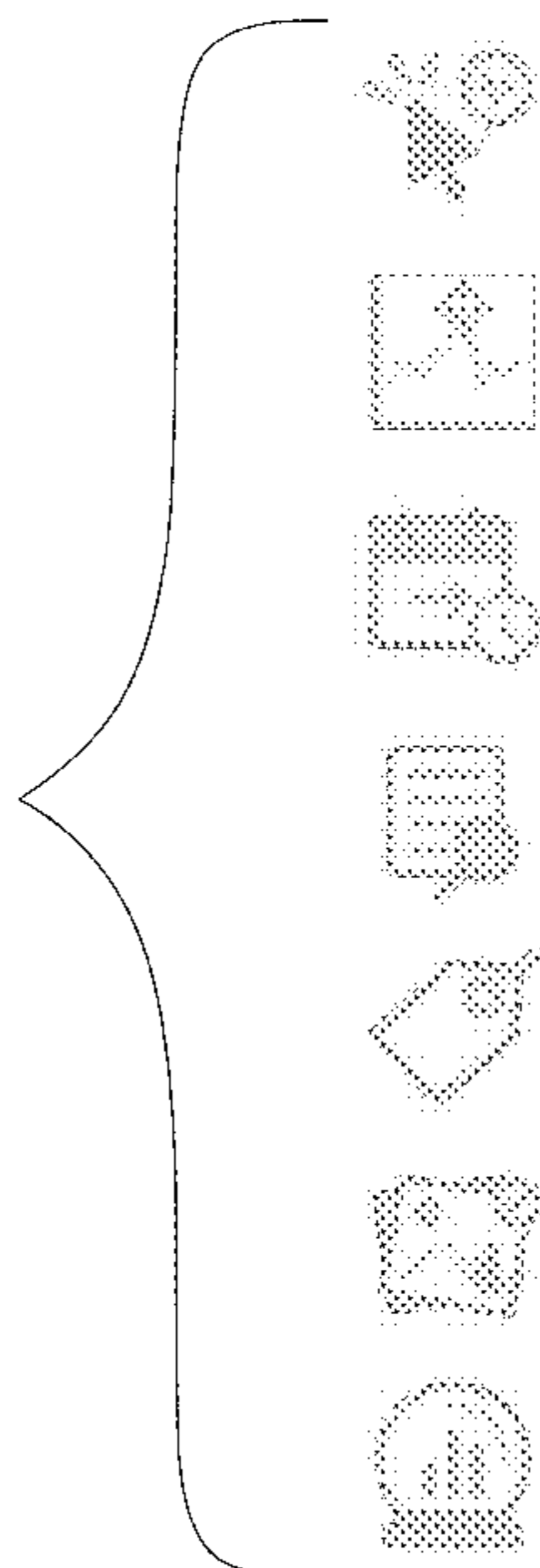
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with group of icons, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of a display screen or portion thereof with group of icons showing the claimed design. The broken lines in the FIGURE show a display screen or portion thereof, and form no part of the claimed design. The bracket shown in the FIGURE indicates a group.
