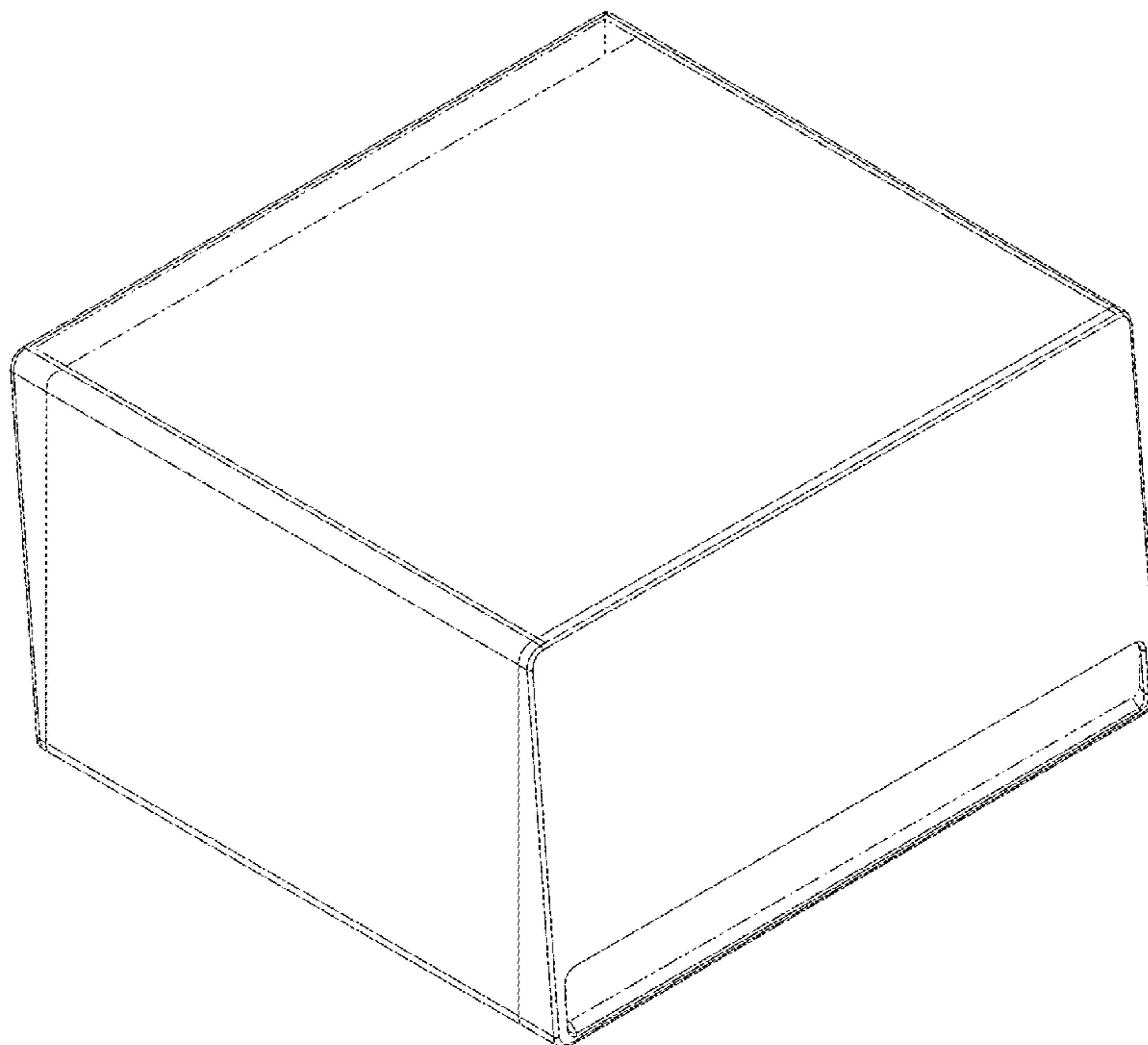
(57) **CLAIM**

The ornamental design for an apparatus for providing broadband light, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front left perspective view of an apparatus for providing broadband light showing my new design.  
FIG. 2 is a top rear left perspective view thereof.  
FIG. 3 is a front side elevational view thereof.  
FIG. 4 is a rear side elevational view thereof.  
FIG. 5 is a left side elevational view thereof.  
FIG. 6 is a right side elevational view thereof; and,  
FIG. 7 is a top plan view thereof.

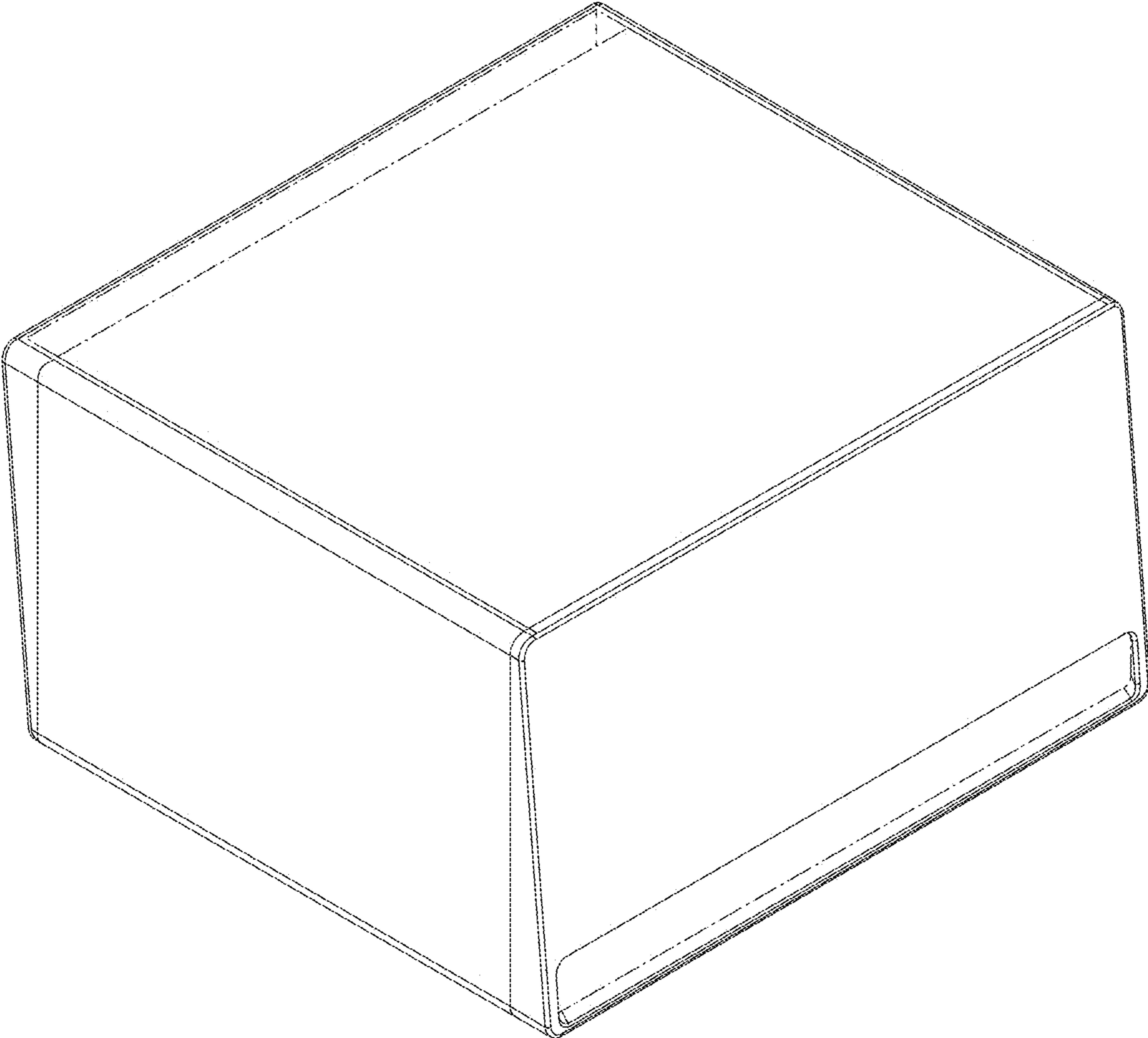

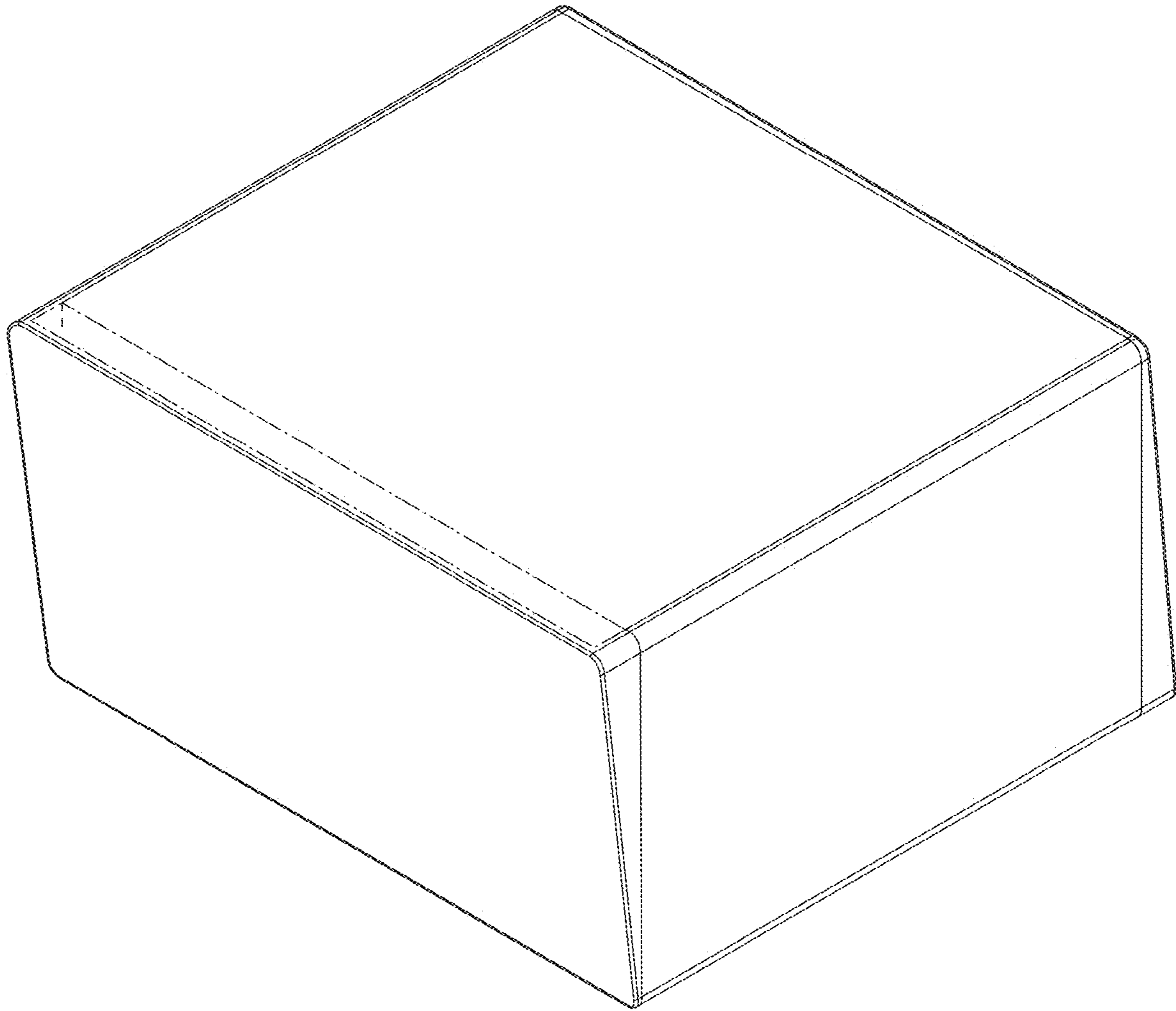

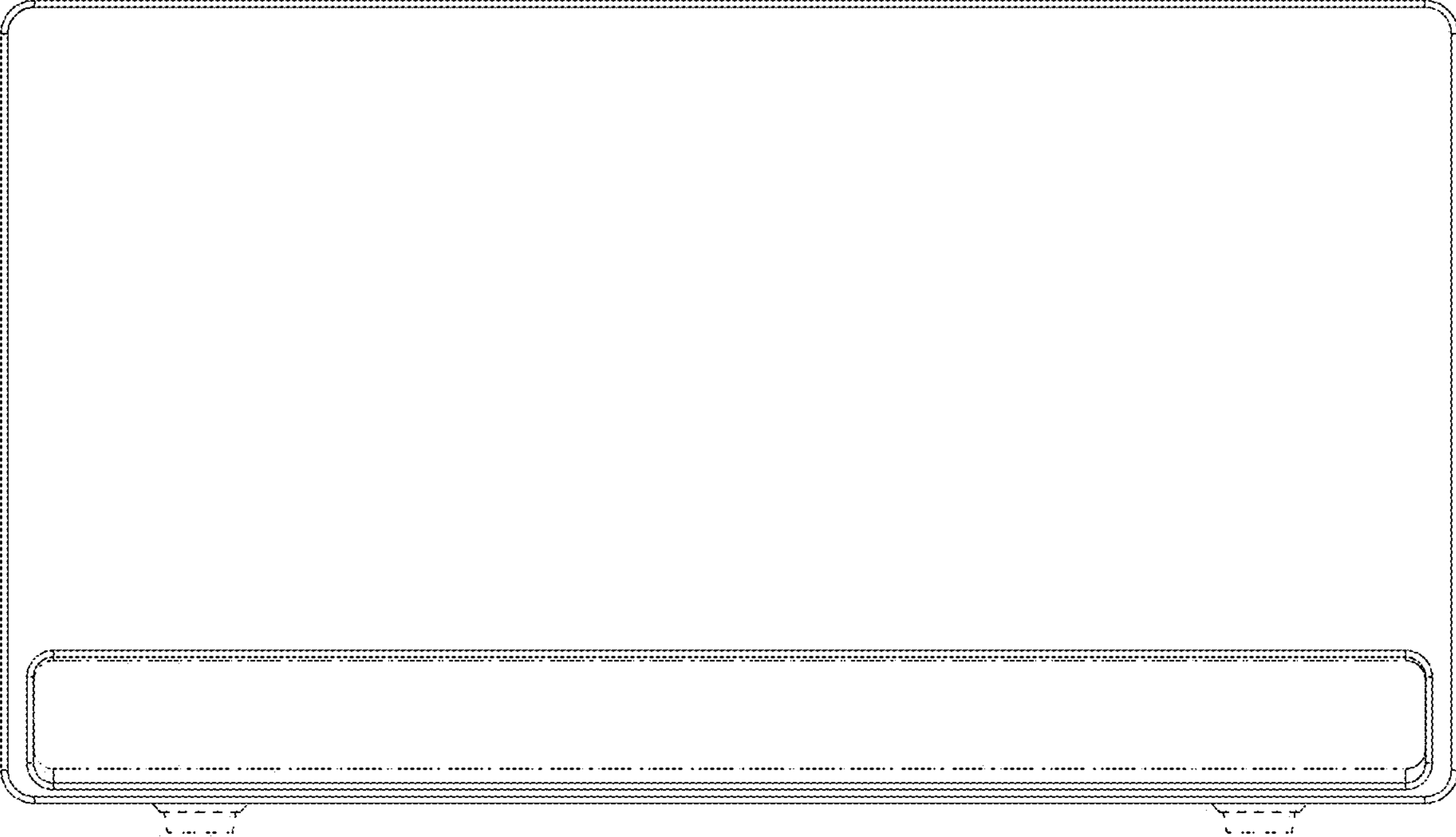

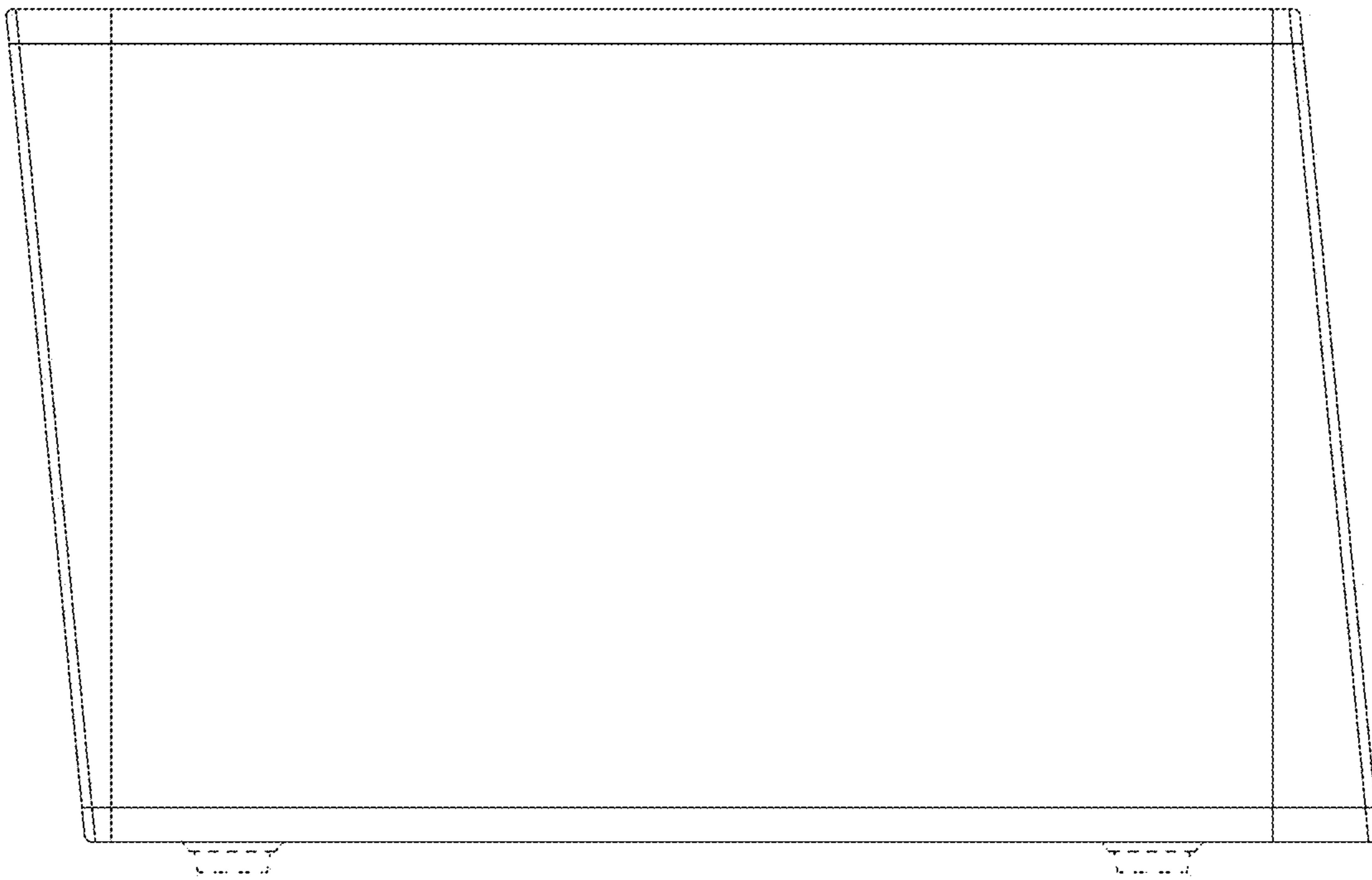

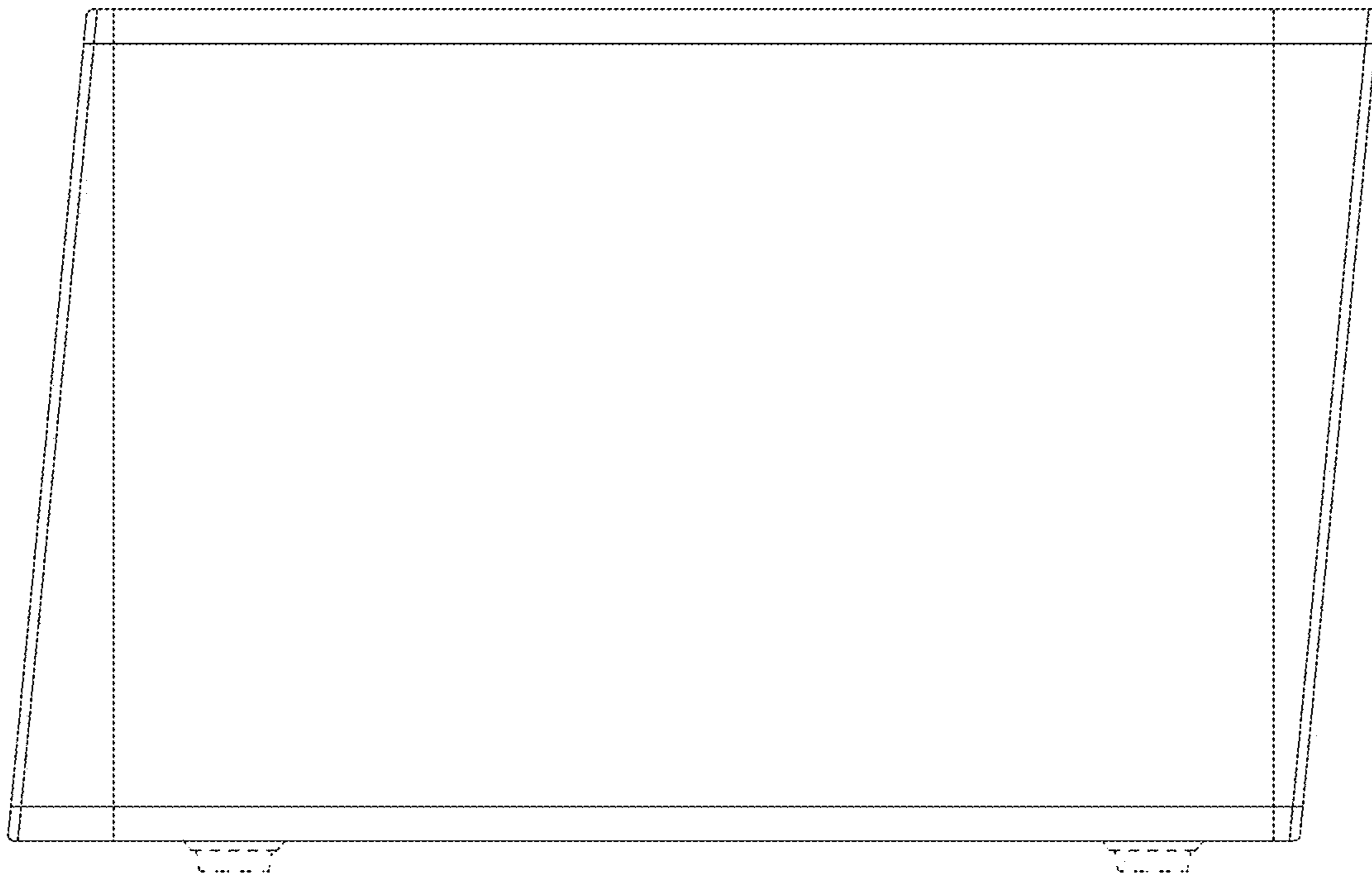
