The ornamental design for a game board and game board cover set, as shown and described.

**DESCRIPTION**

FIG. 11 is a bottom plan view thereof;

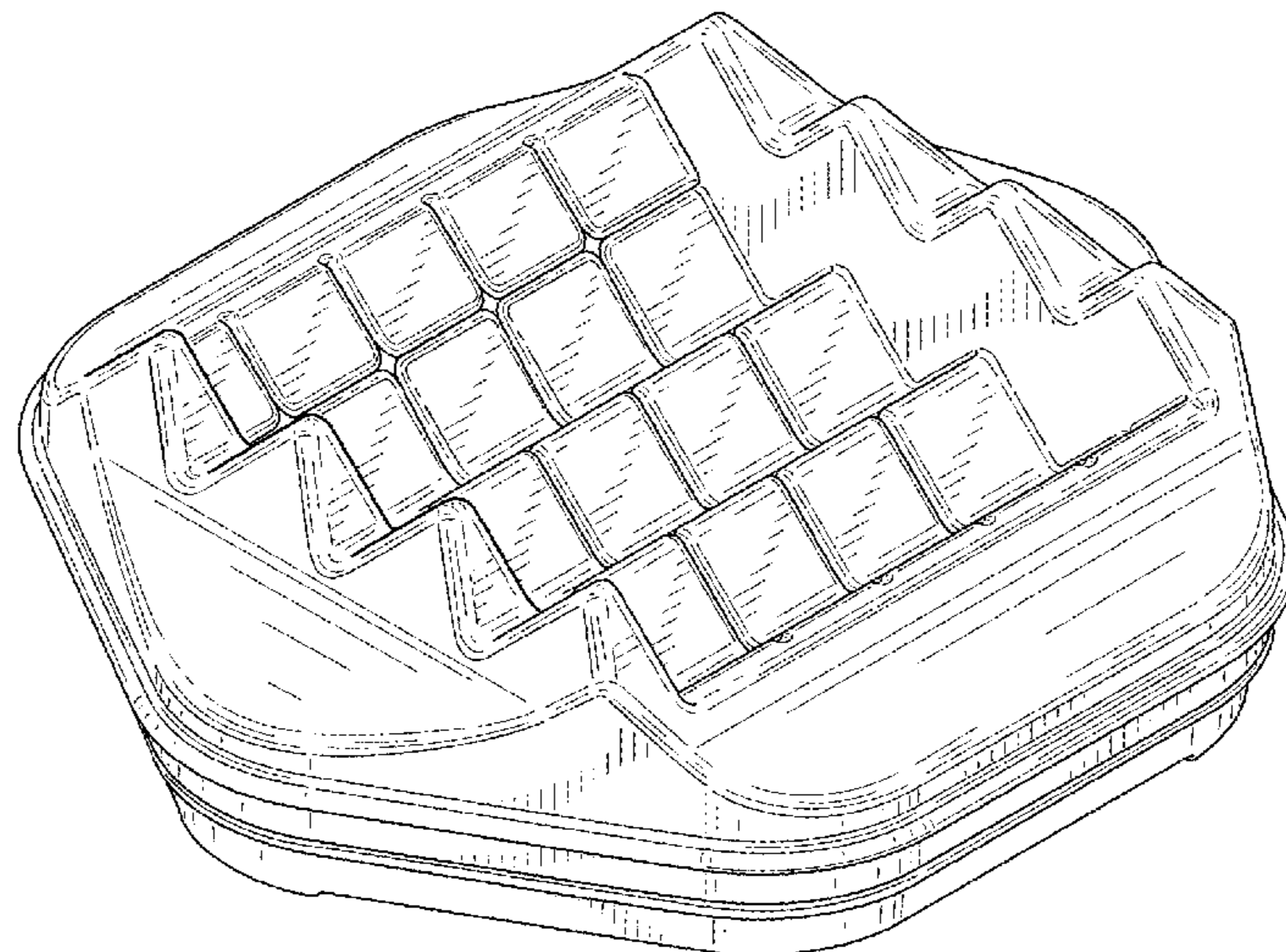
FIG. 12 is a front elevation view thereof;

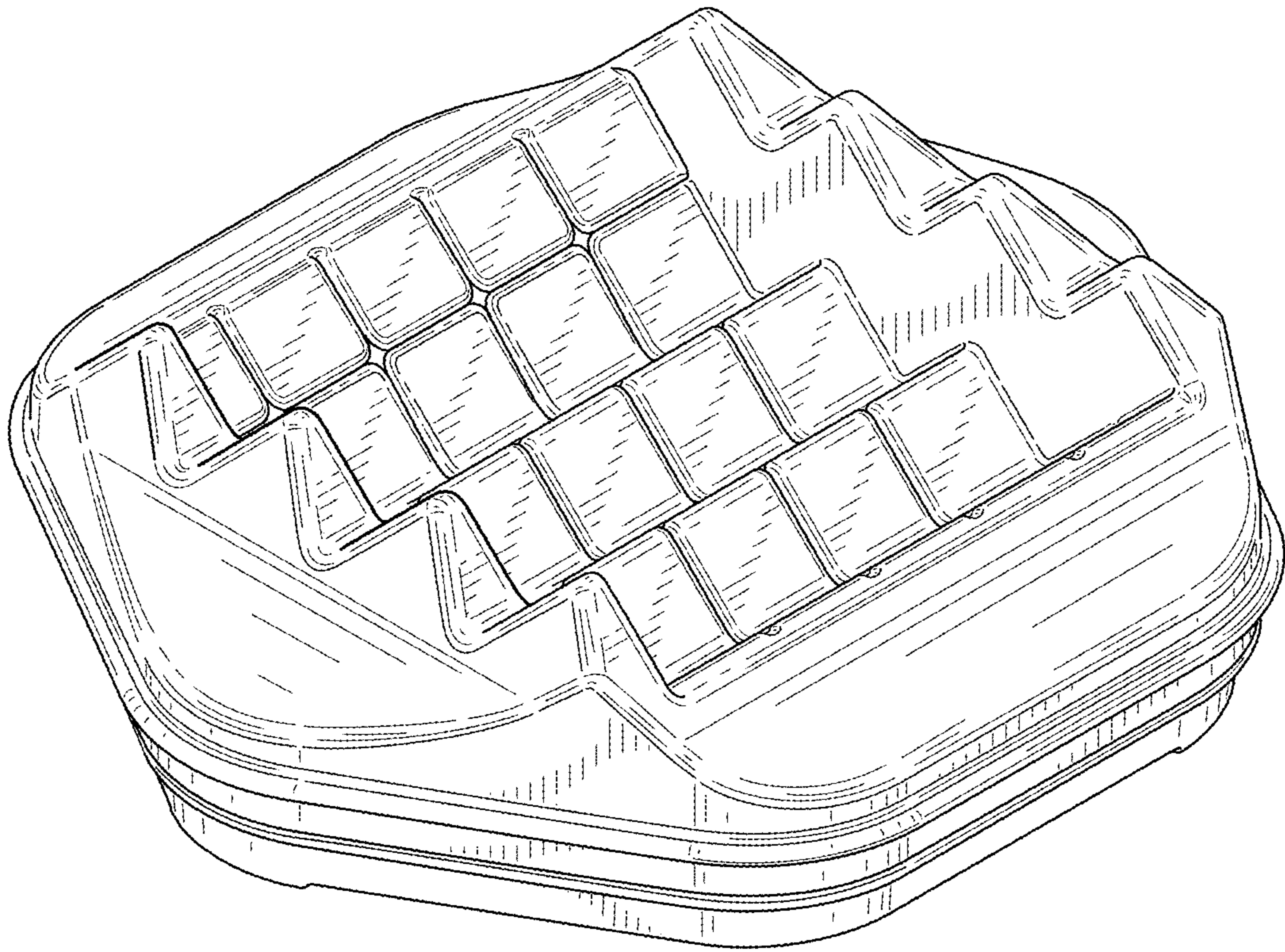

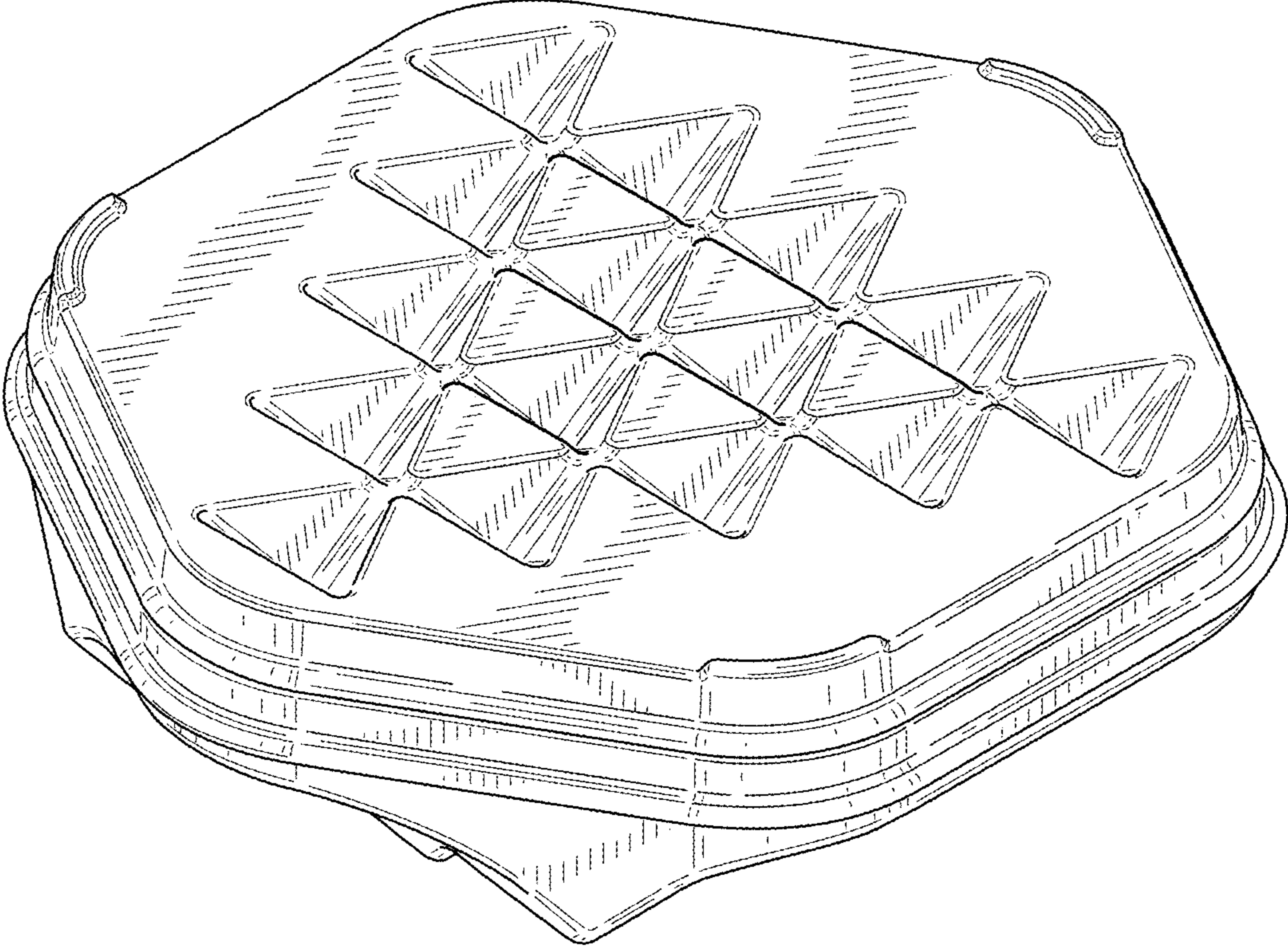

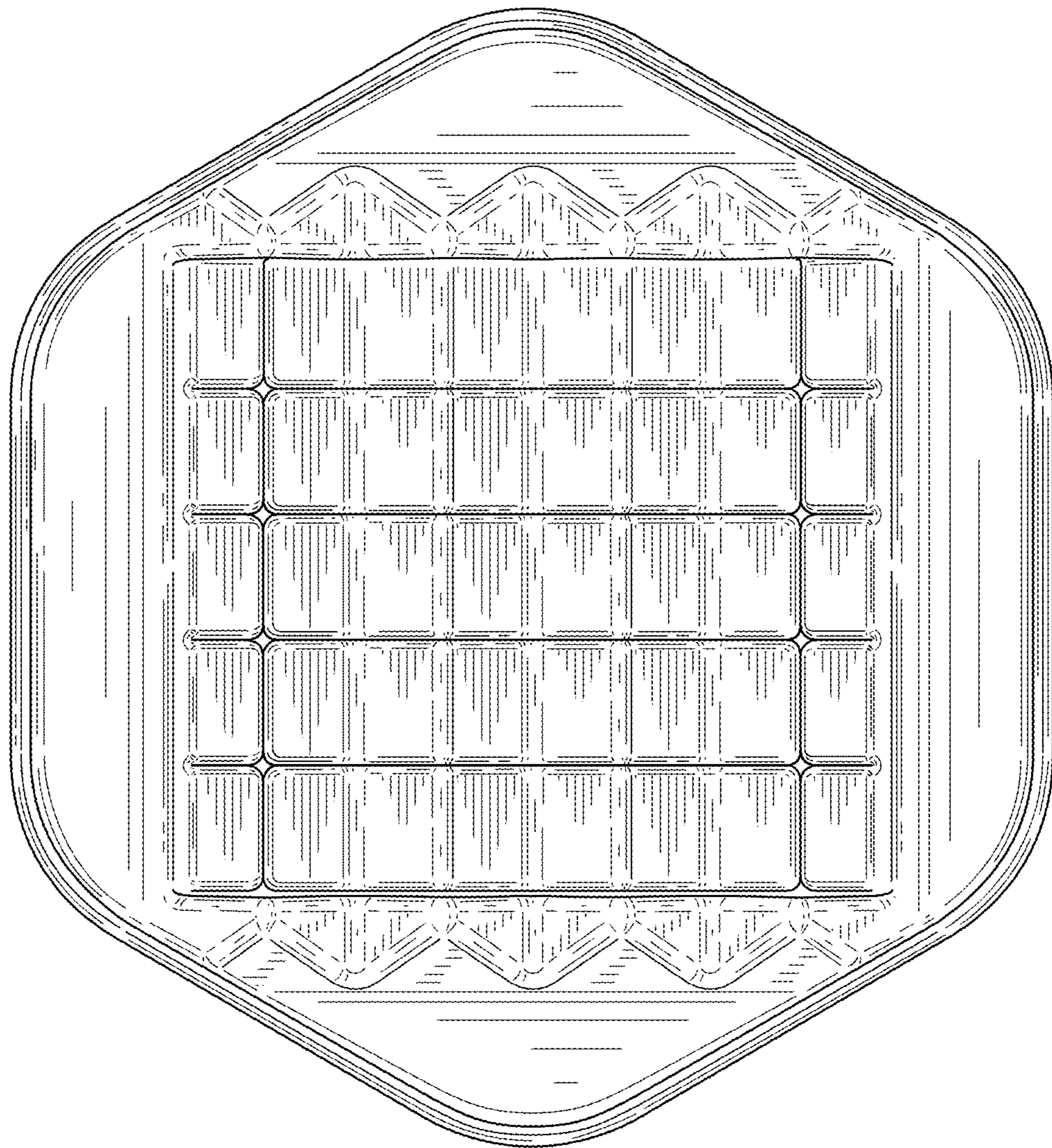

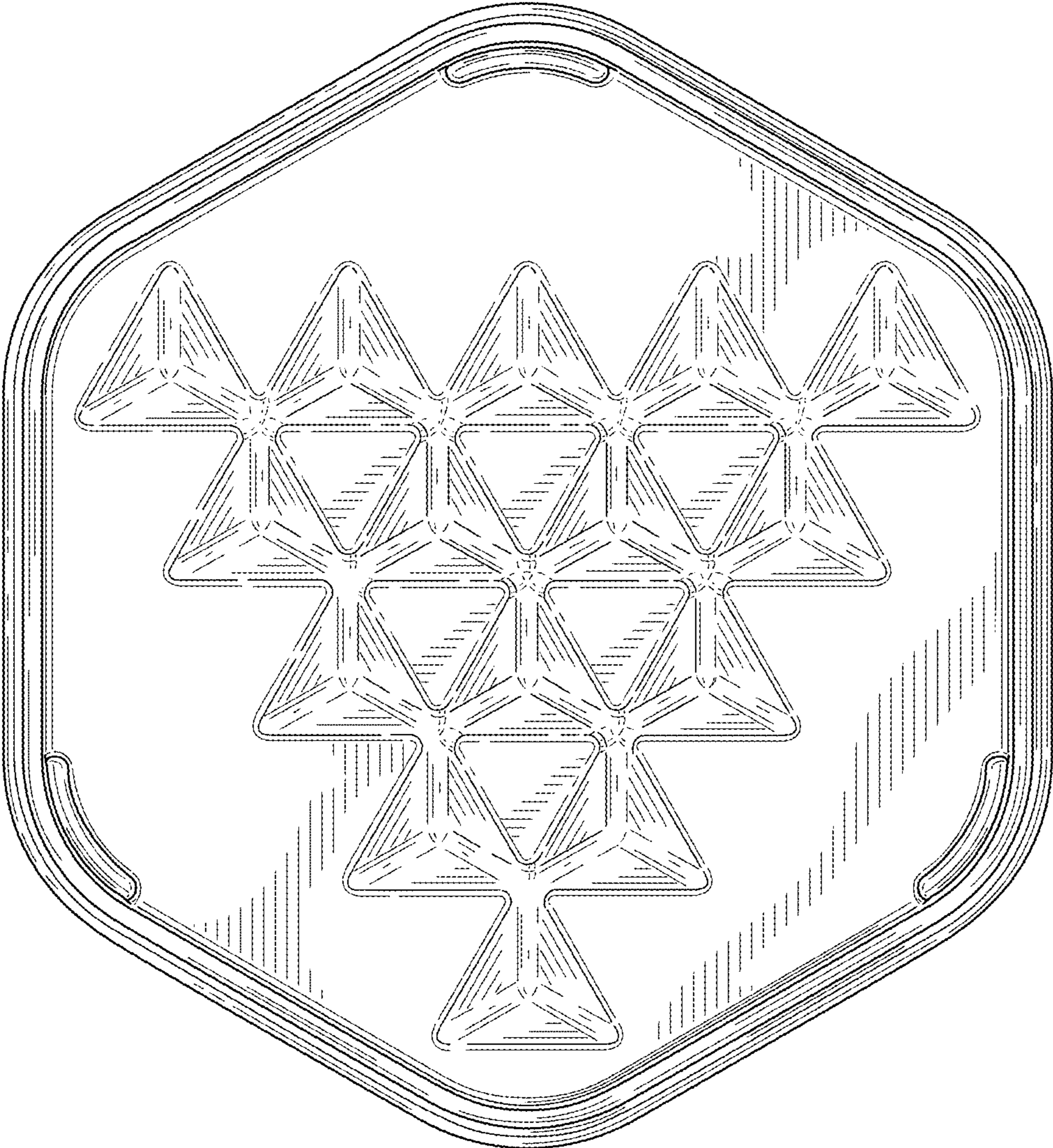

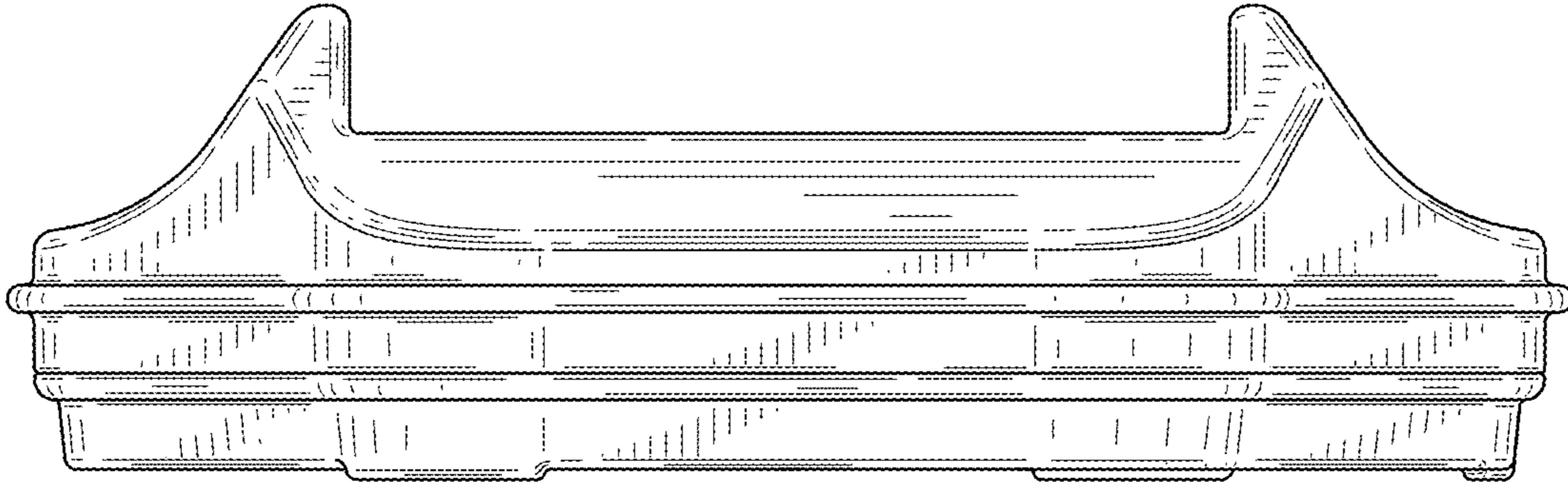

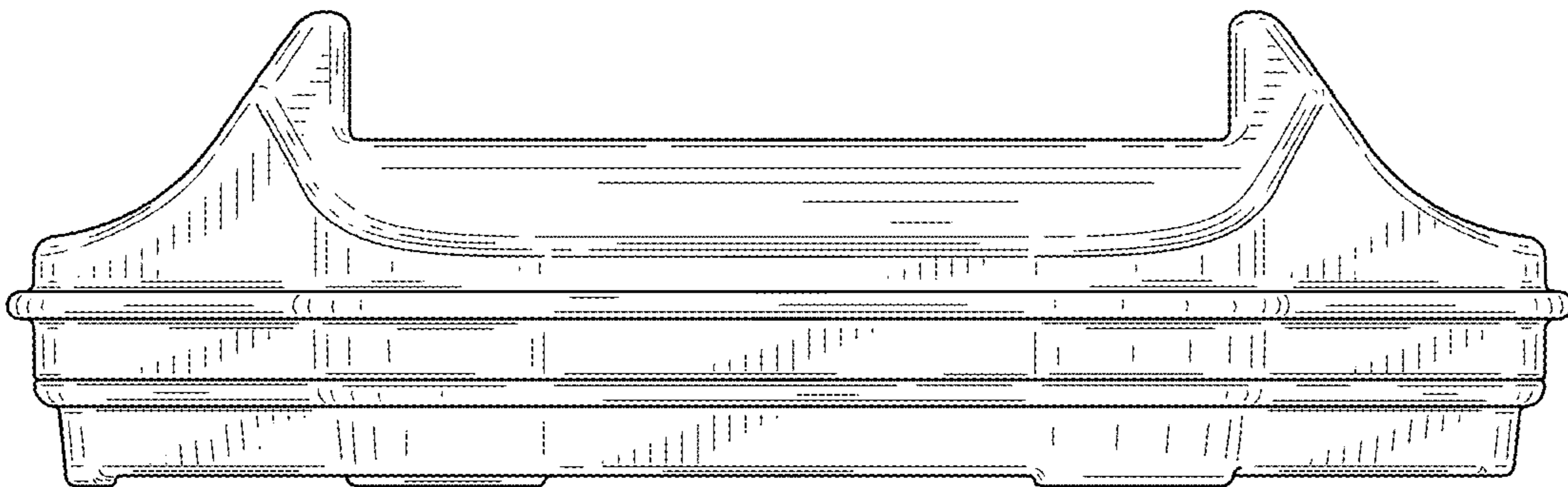

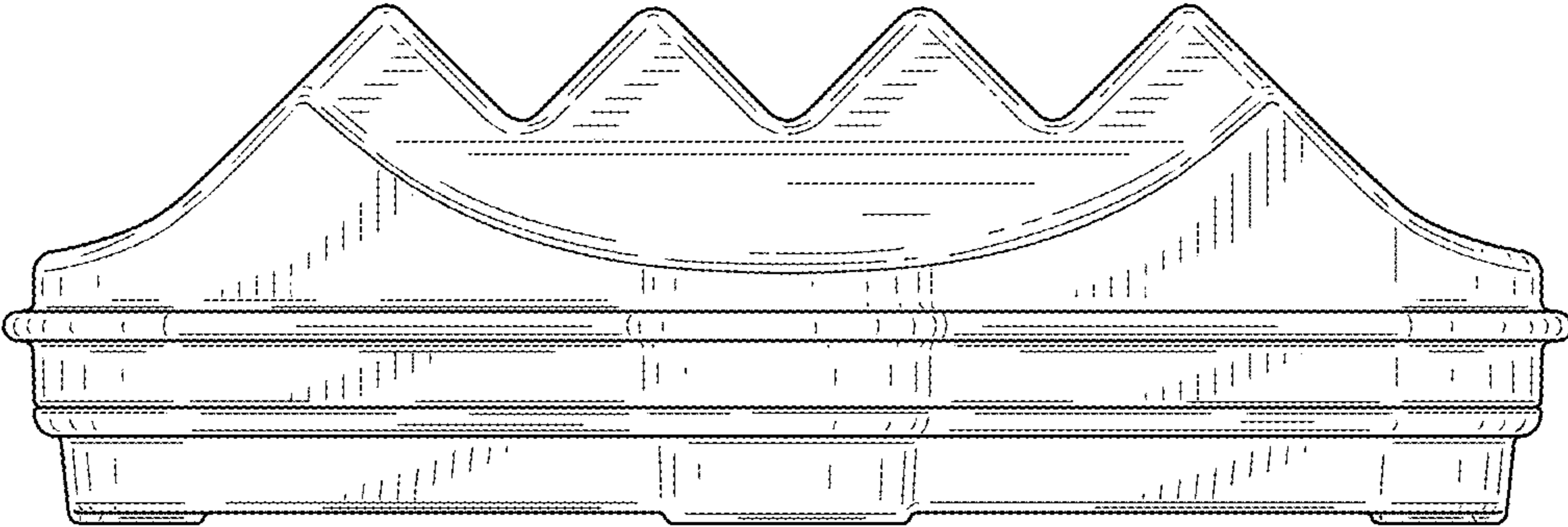

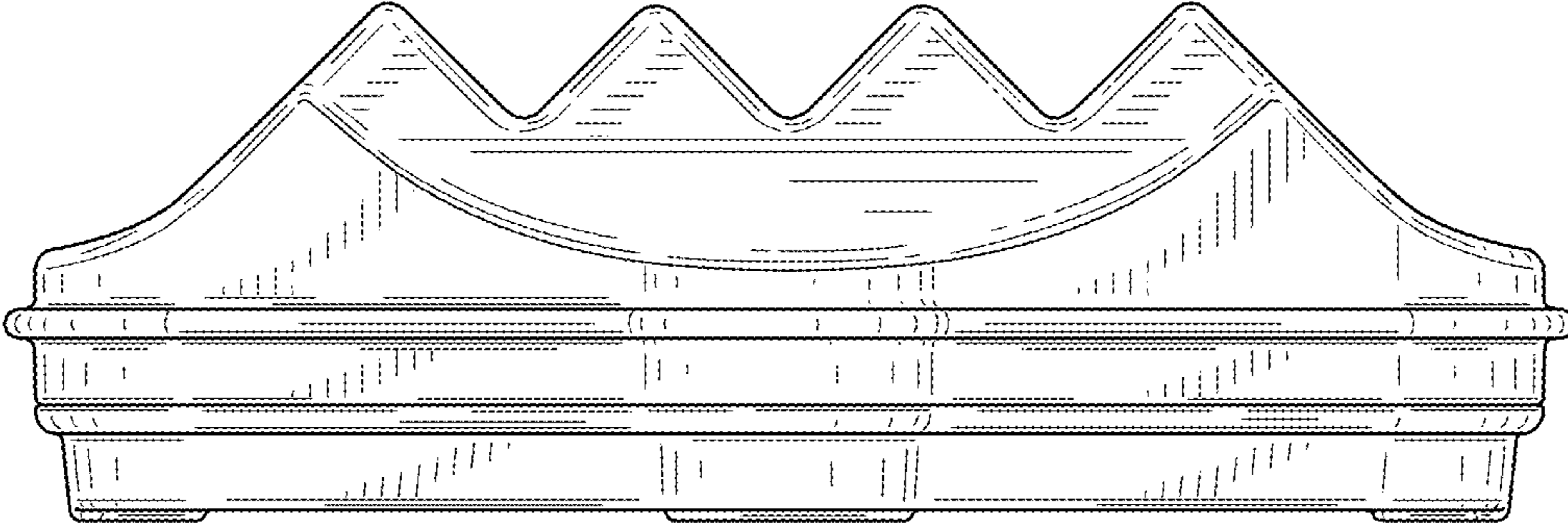

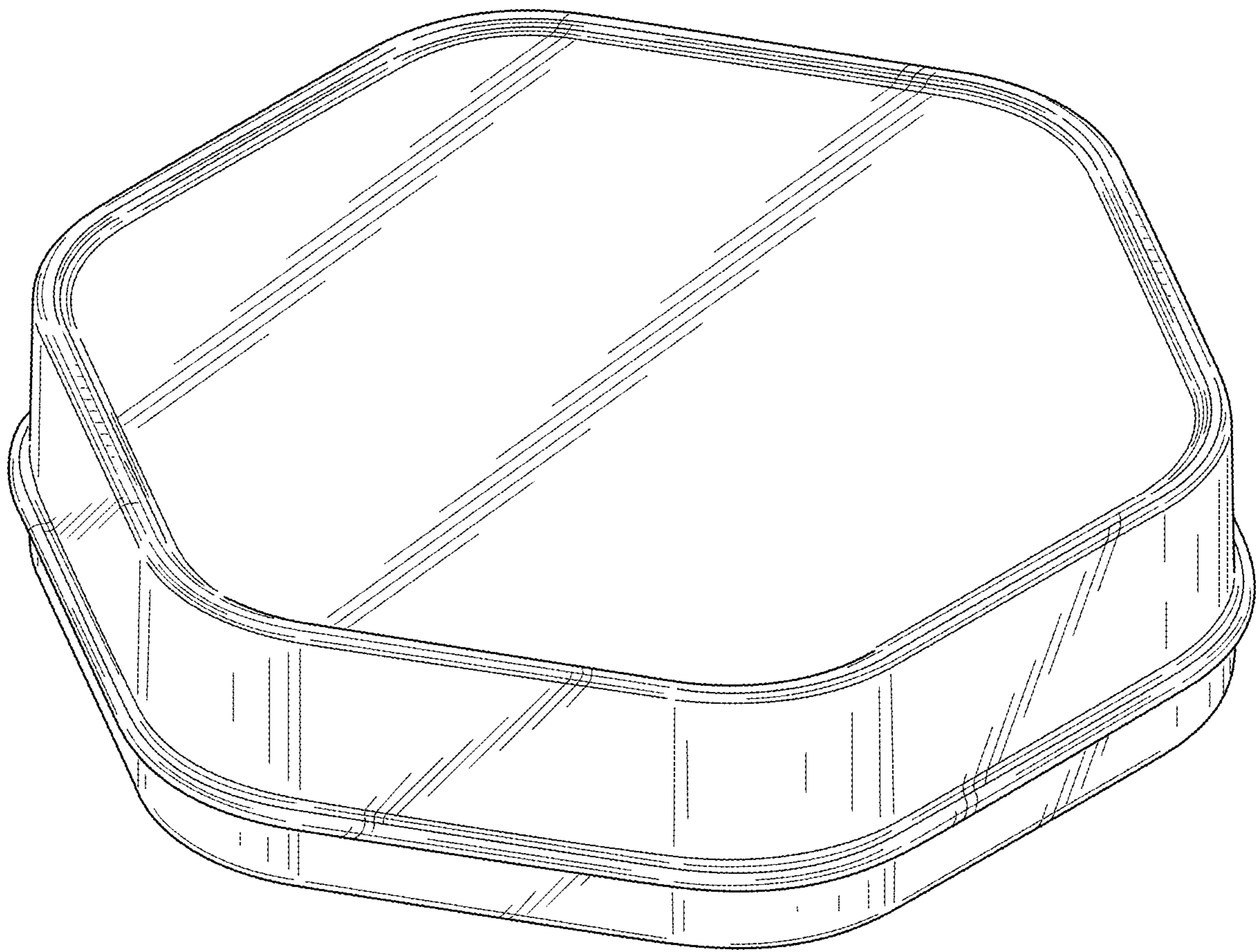

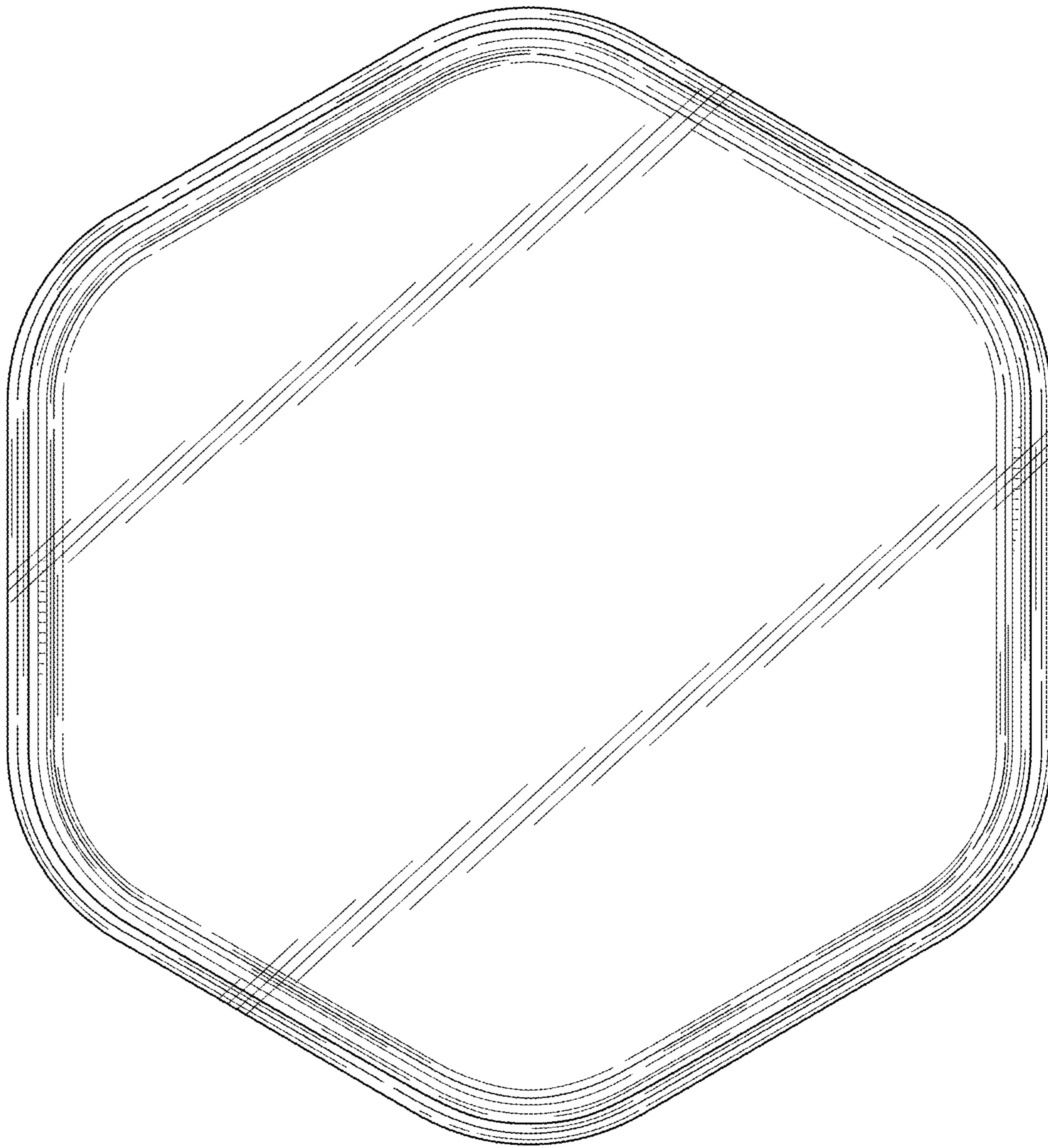

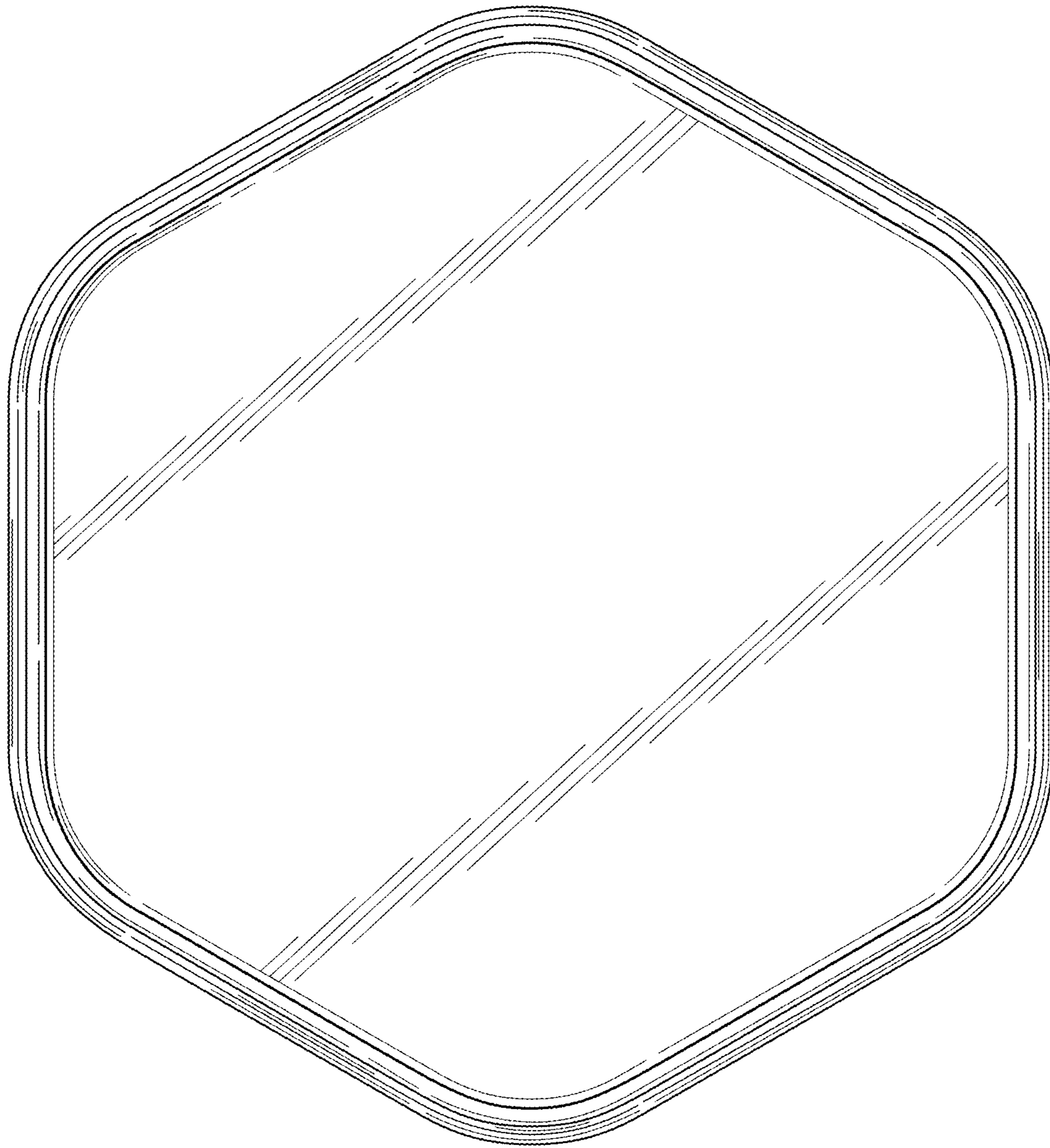

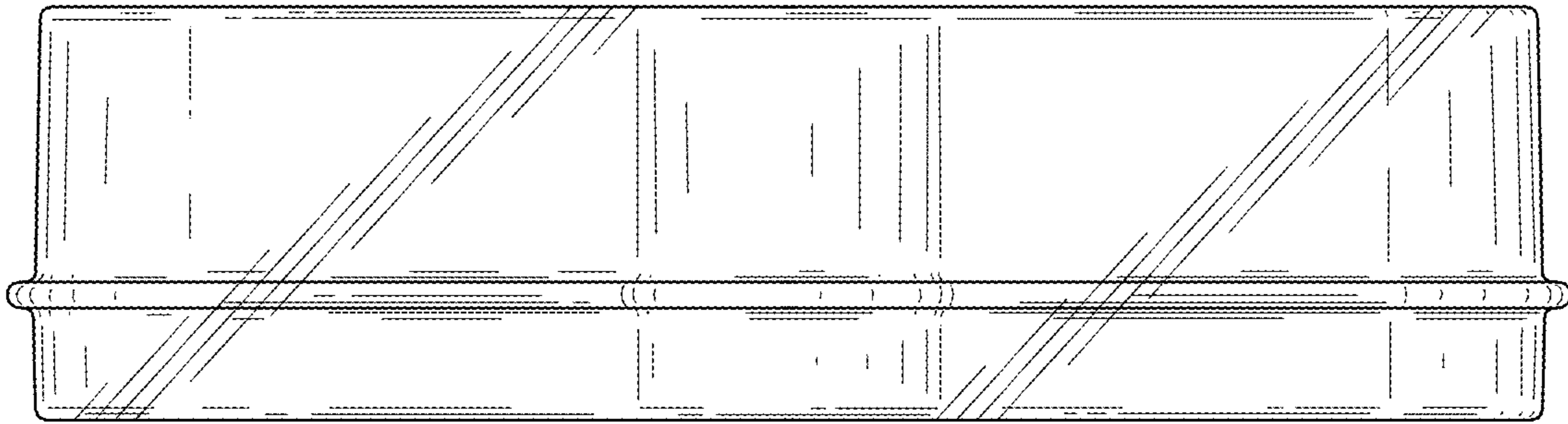

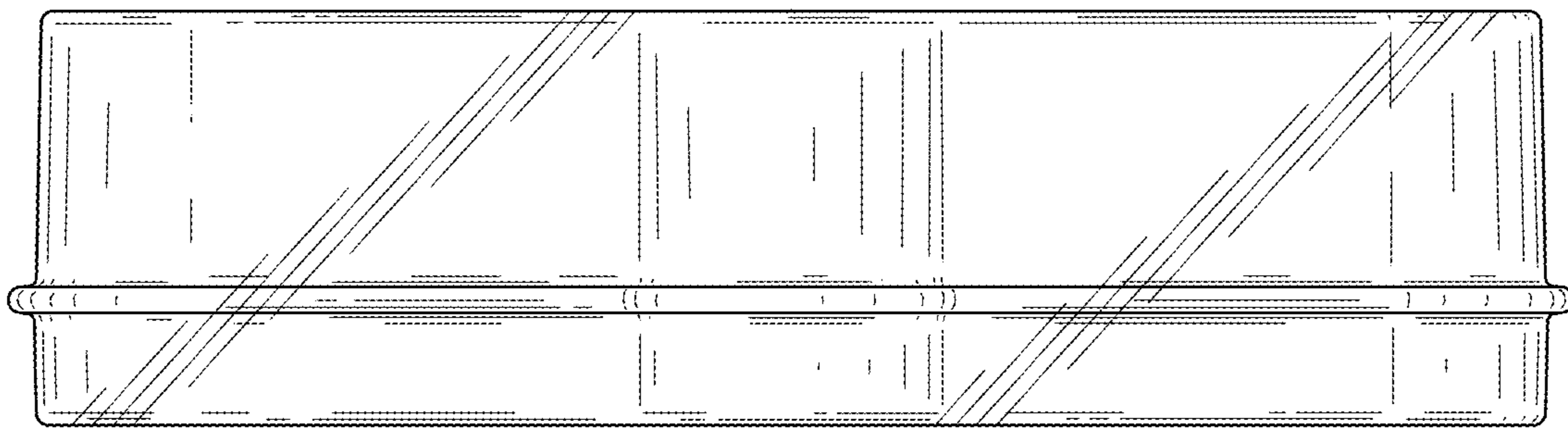

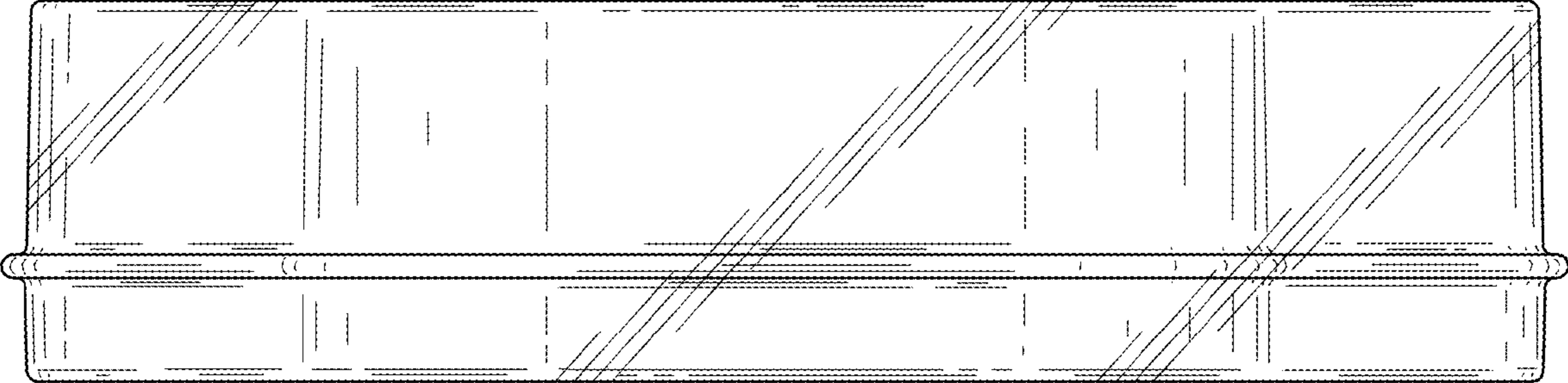

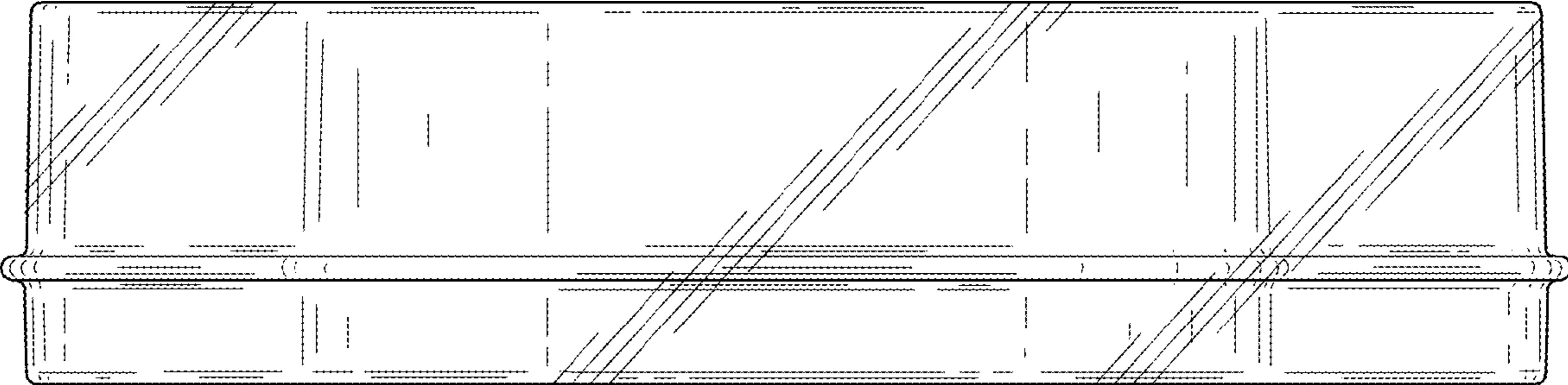
