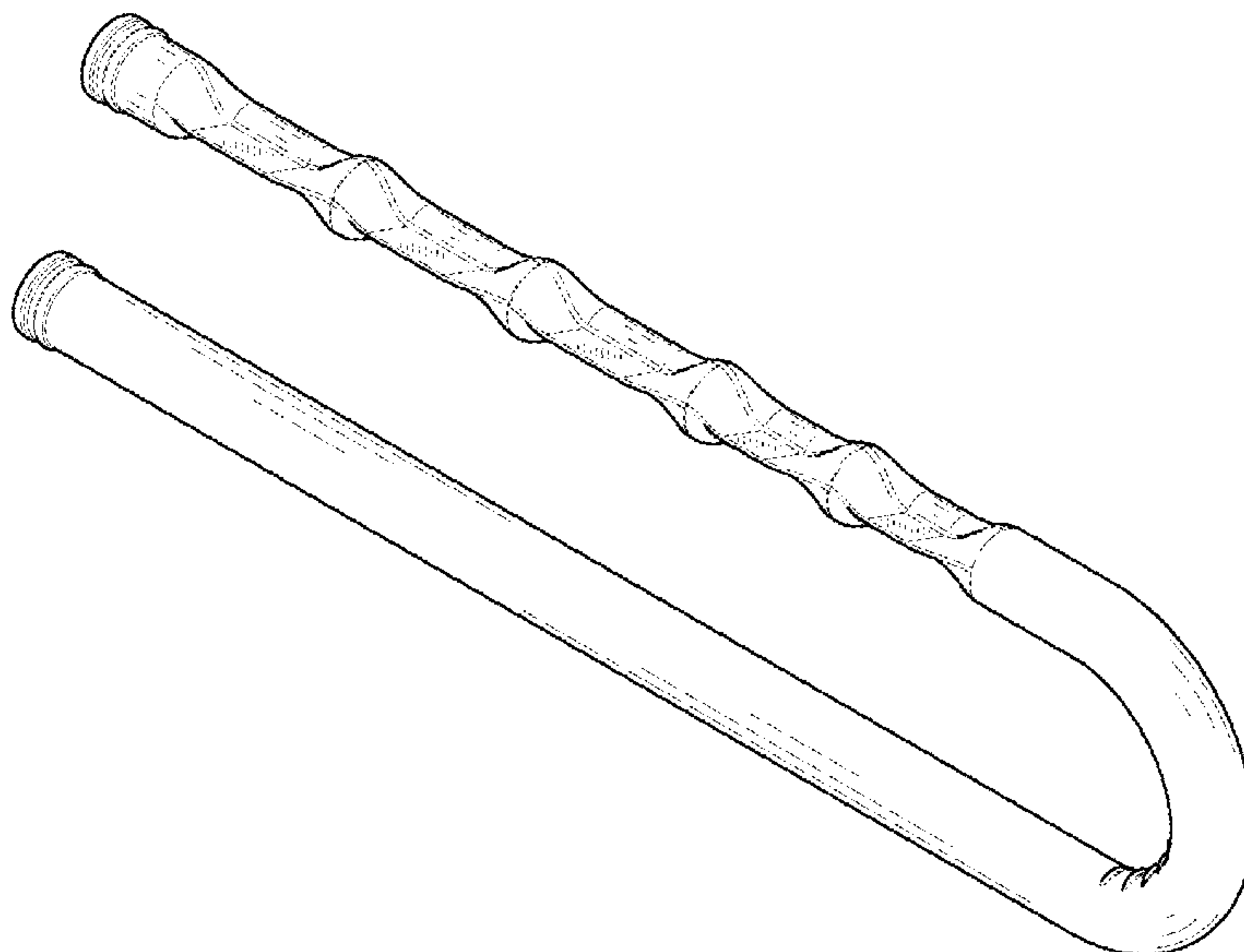
(57) **CLAIM**

The ornamental design for a heat exchanger tube with fins,
as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a heat exchanger tube
with fins showing our new design.
FIG. 2 is a bottom perspective view thereof.
FIG. 3 is a bottom plan view thereof.
FIG. 4 is a top plan view thereof.
FIG. 5 is a back elevation view thereof.
FIG. 6 is a front elevation view thereof.
FIG. 7 is a right side elevation view thereof.
FIG. 8 is a left side elevation view thereof; and,
FIG. 9 is a perspective view showing the heat exchanger
tube with fins installed in a heat exchanger.
The broken lines shown represent the surrounding environ-
ment of the heat exchanger tube with fins that forms no part
of the claimed design.

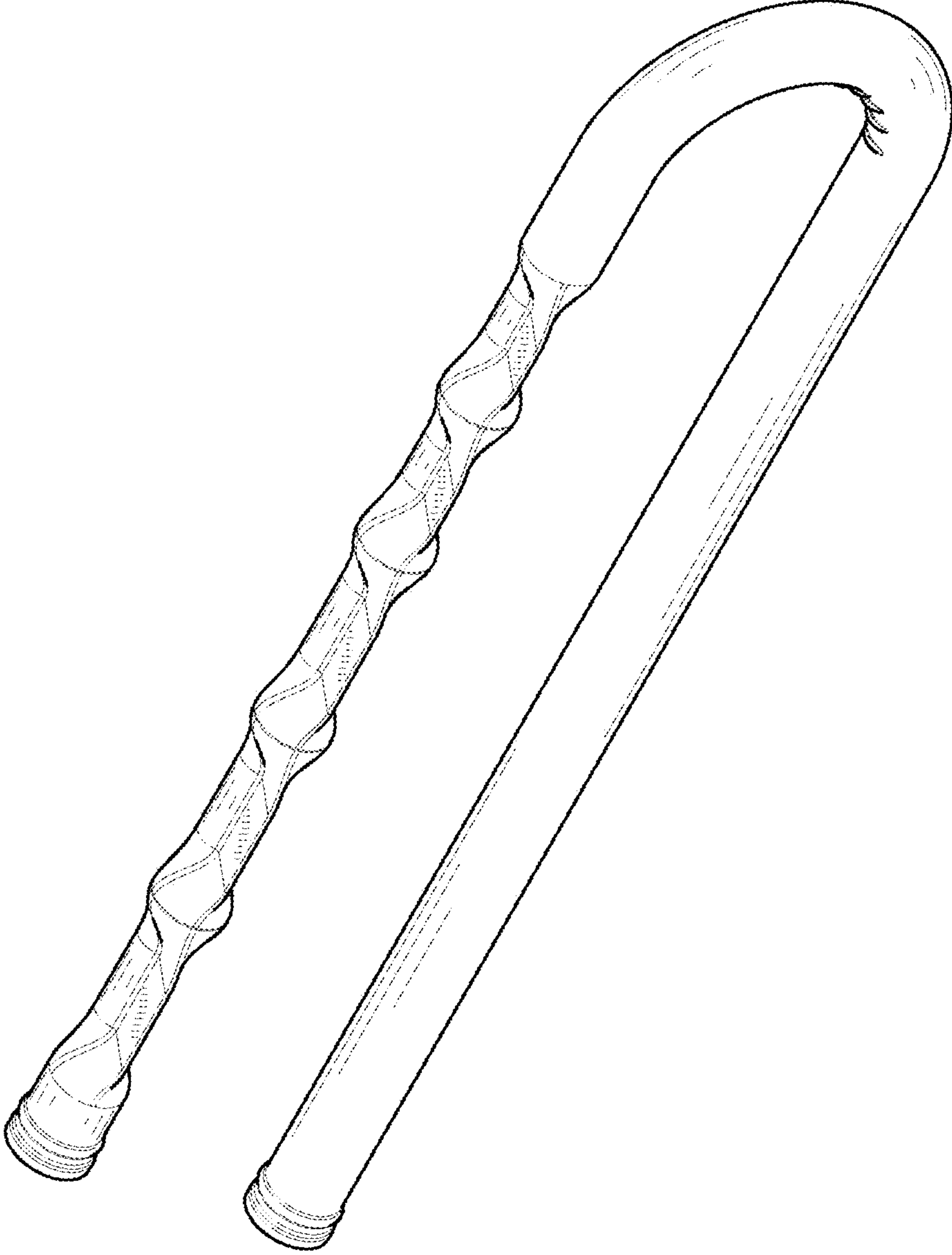

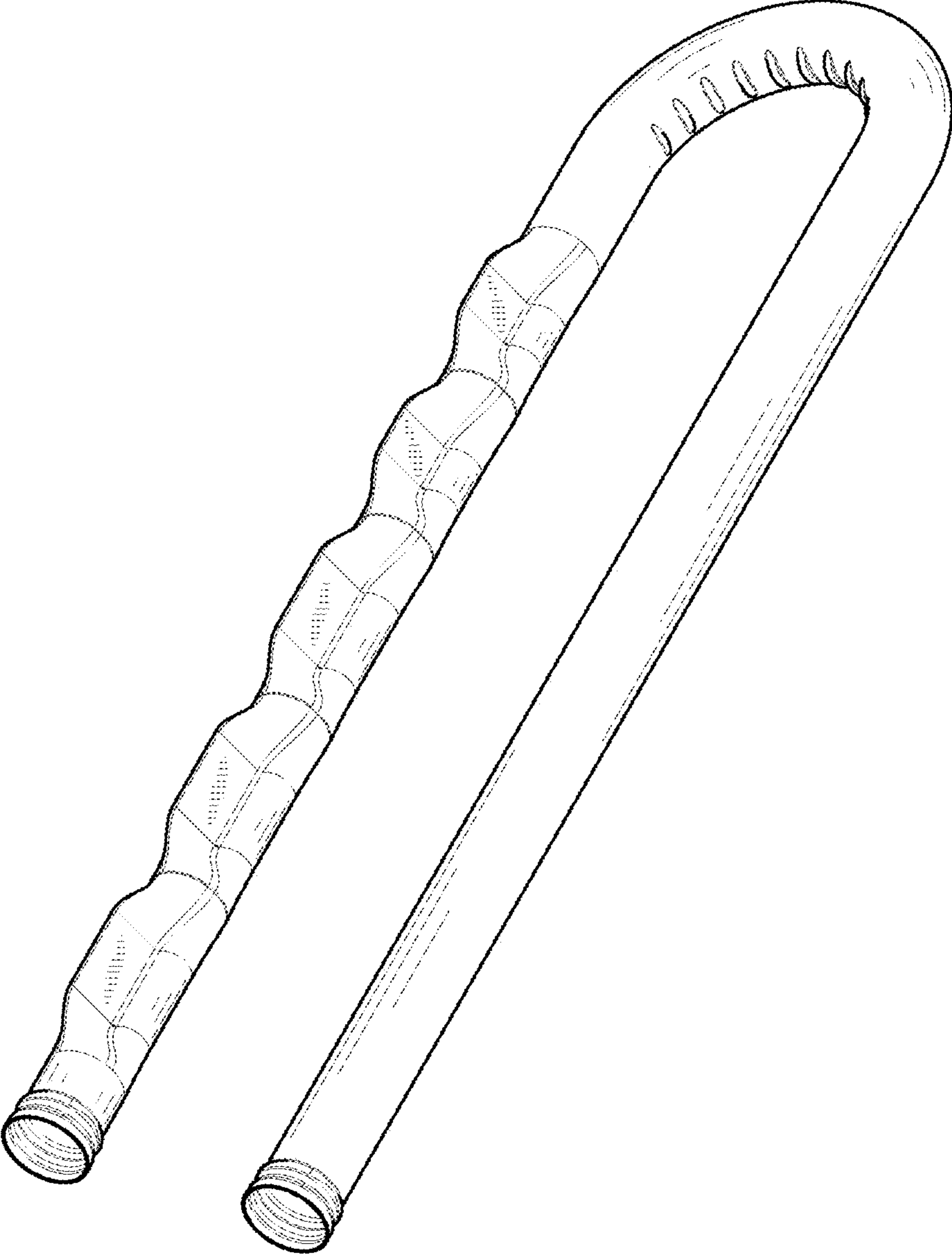

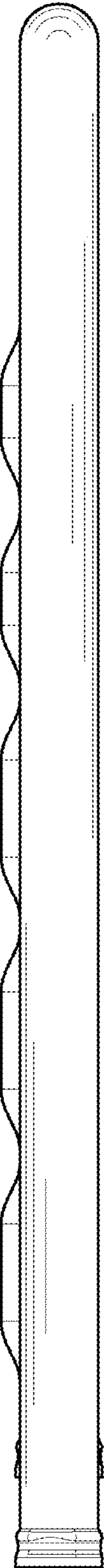

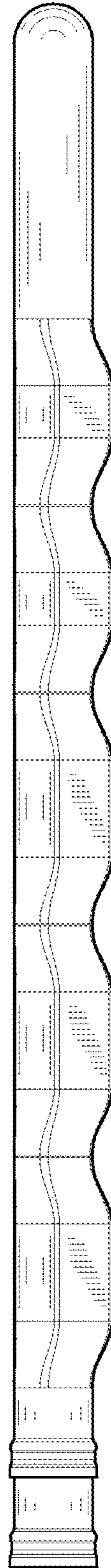

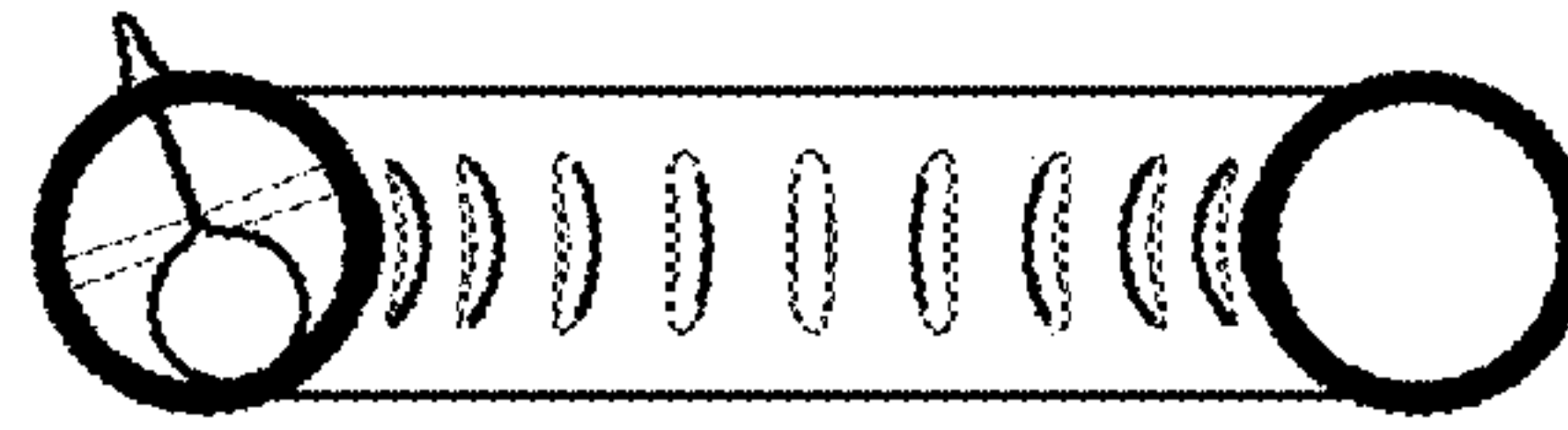

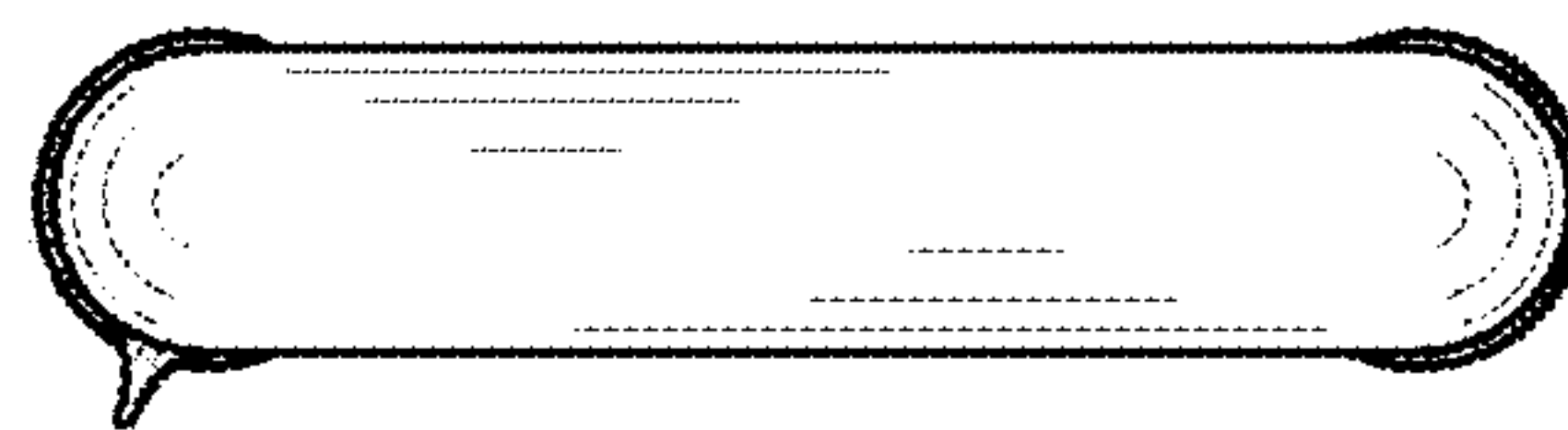

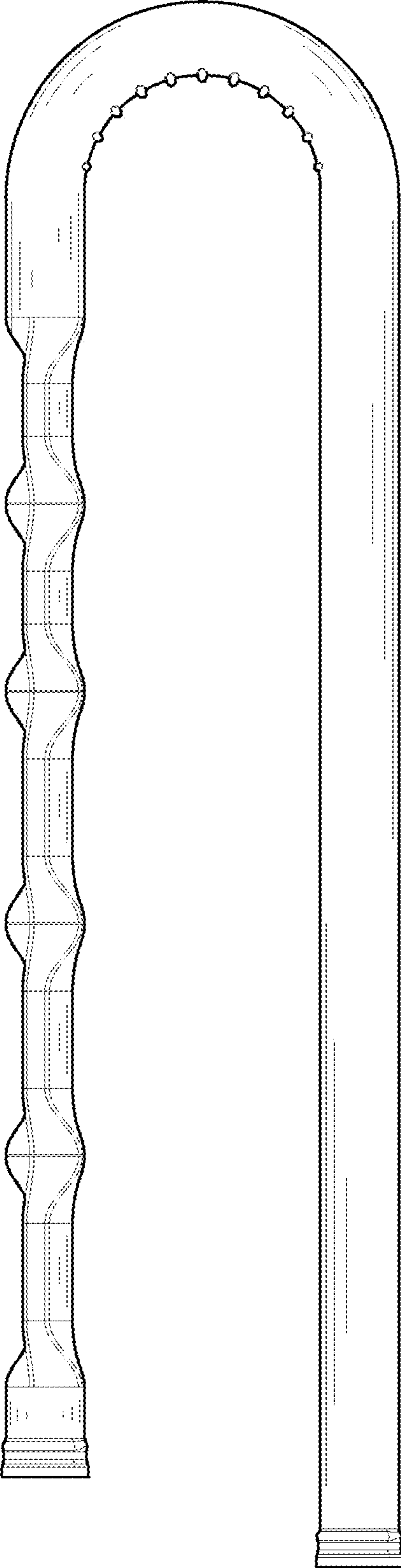

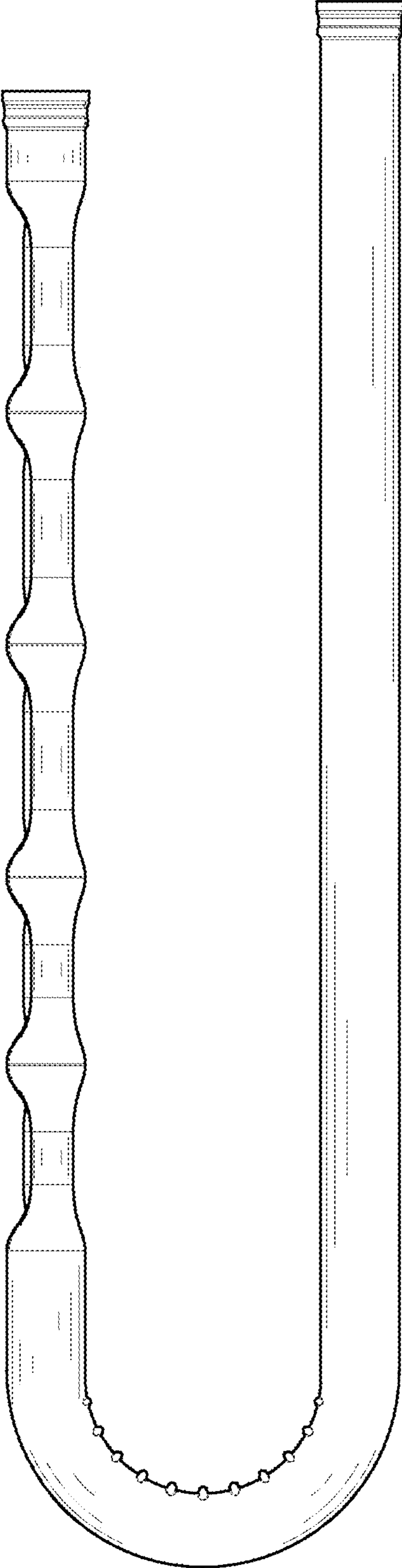
