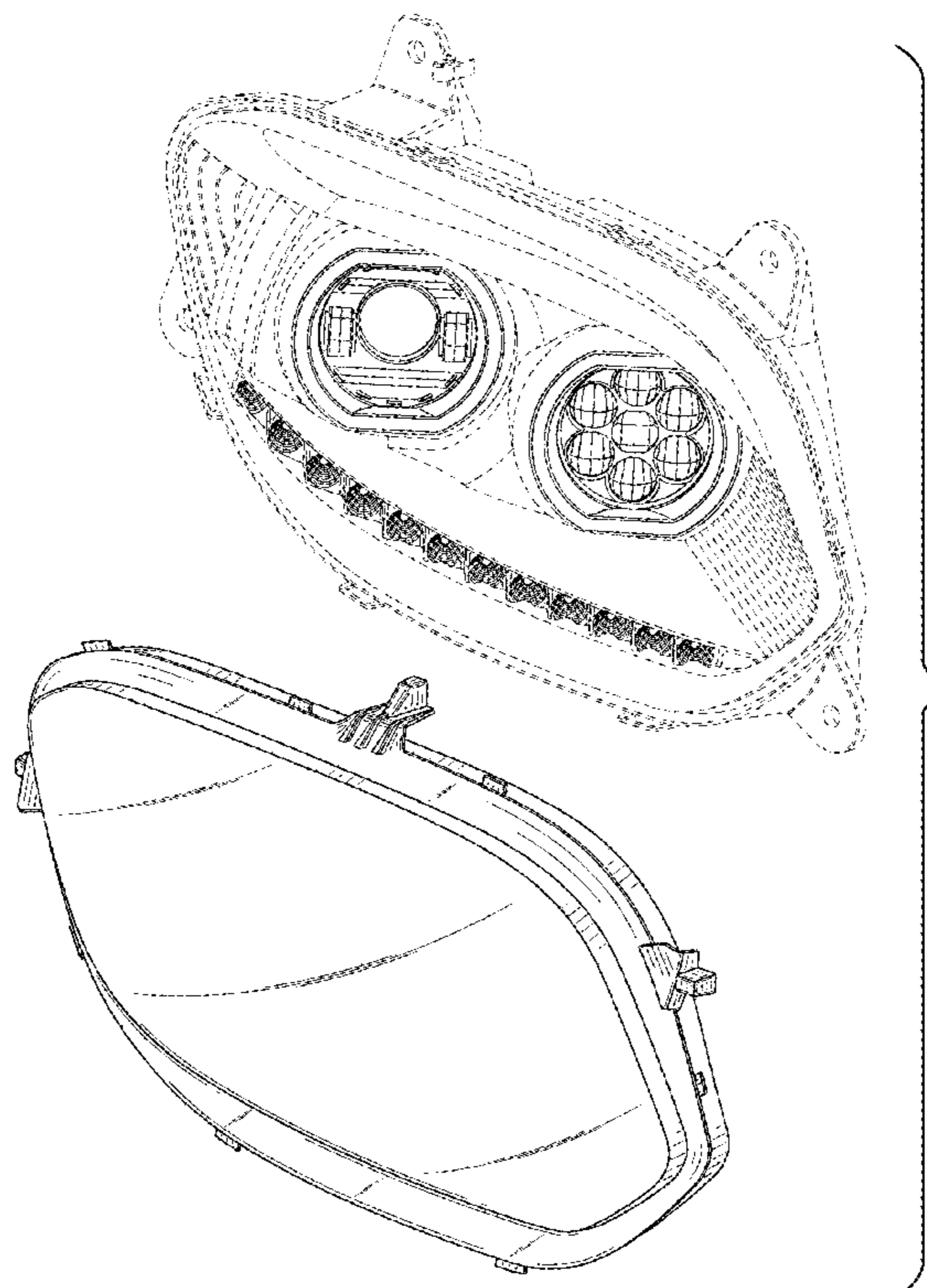
(57) **CLAIM**

The ornamental design for a truck lamp, as shown and described.

DESCRIPTION

FIG. 1 is an exploded perspective view of a truck lamp, showing my new design.
FIG. 2 is a perspective view thereof, with the lens removed;

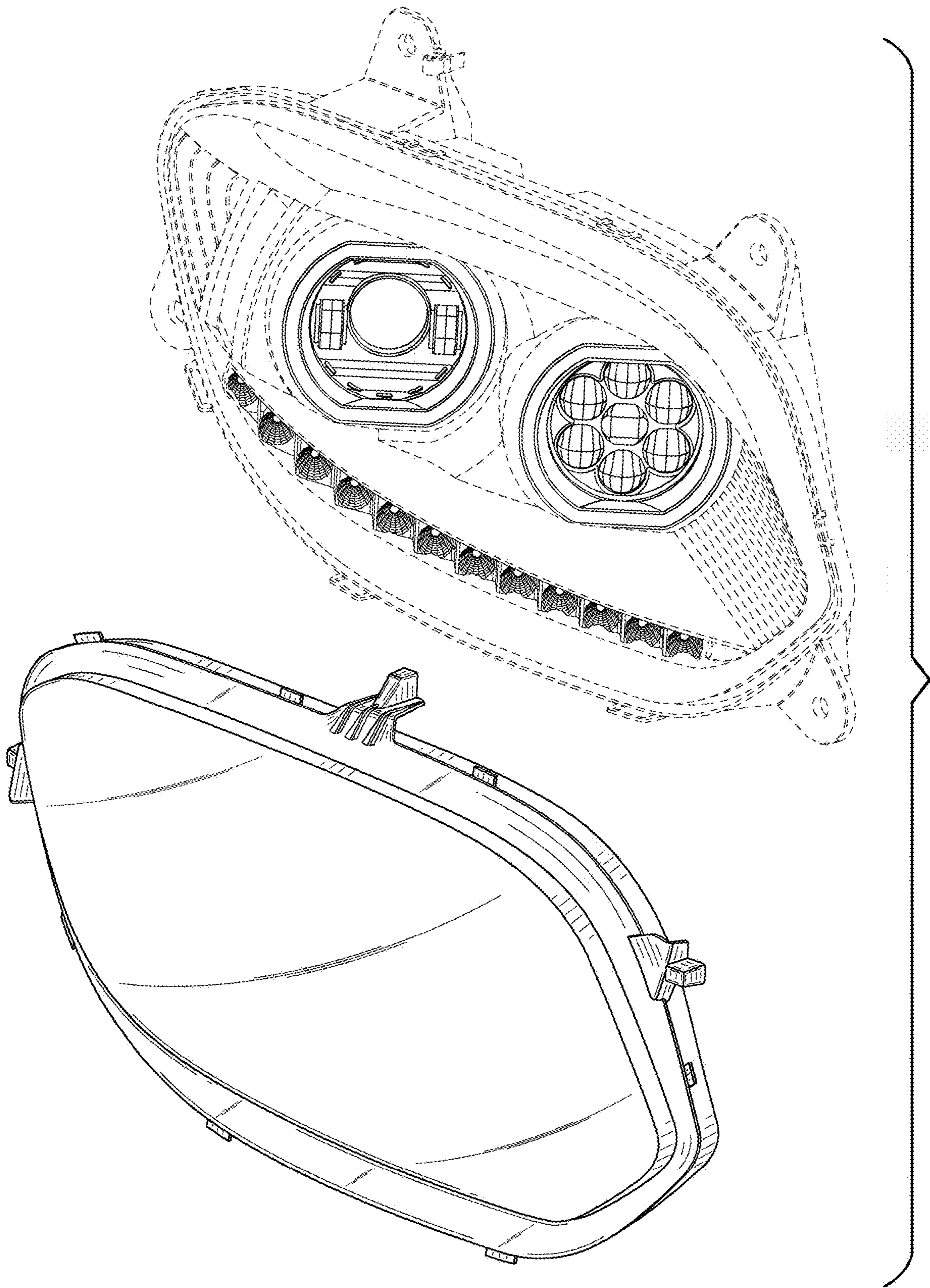

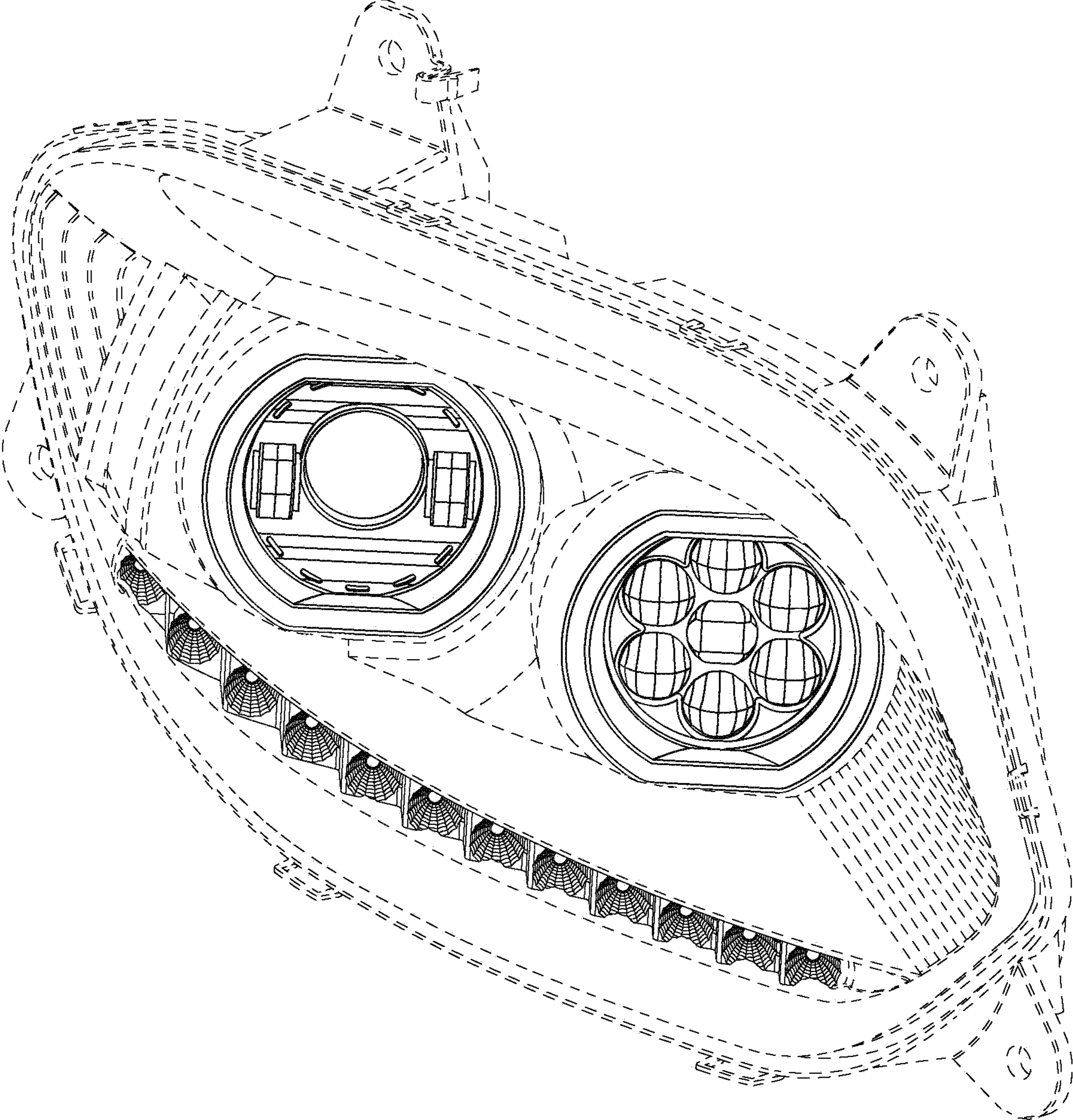

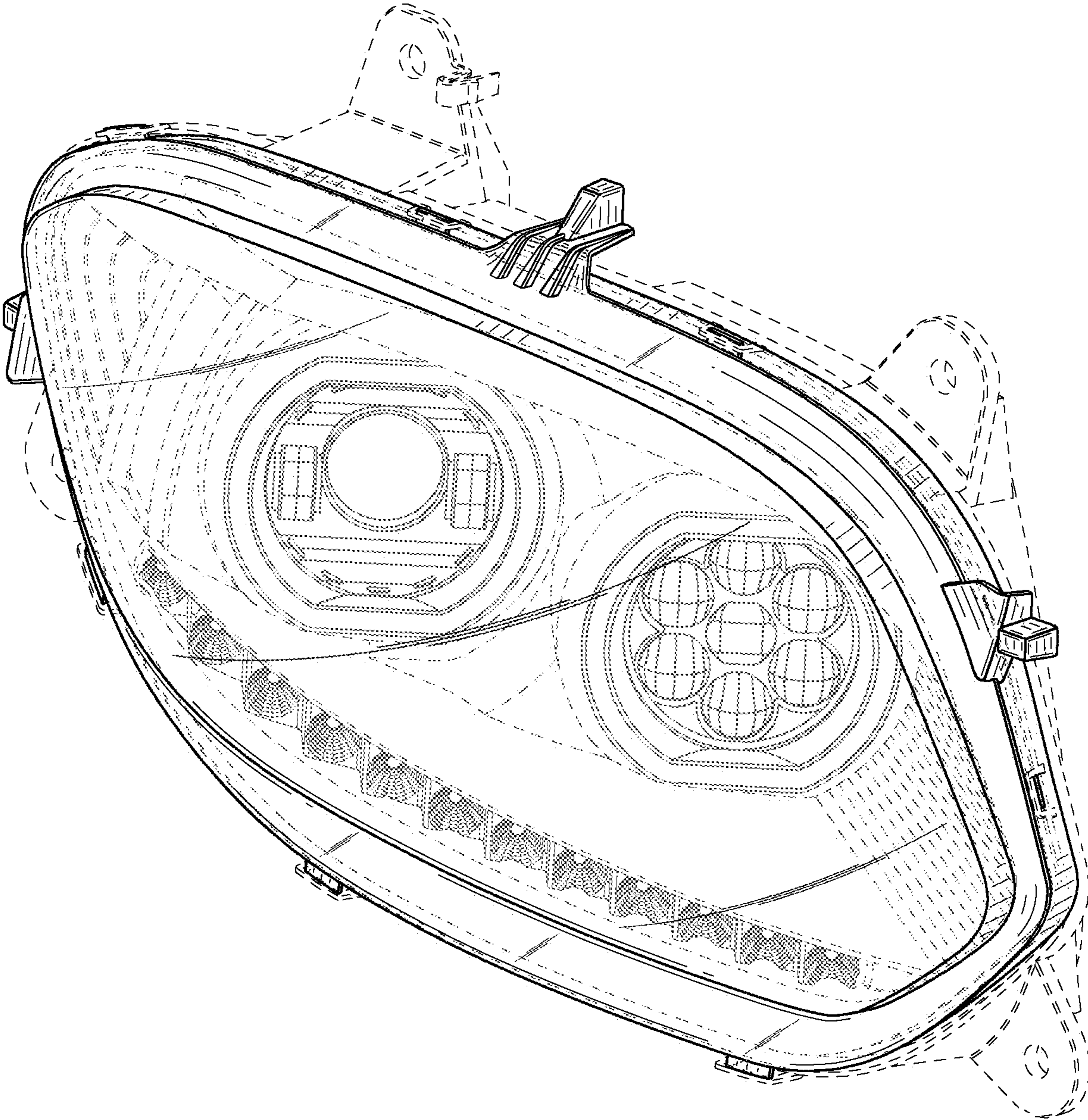

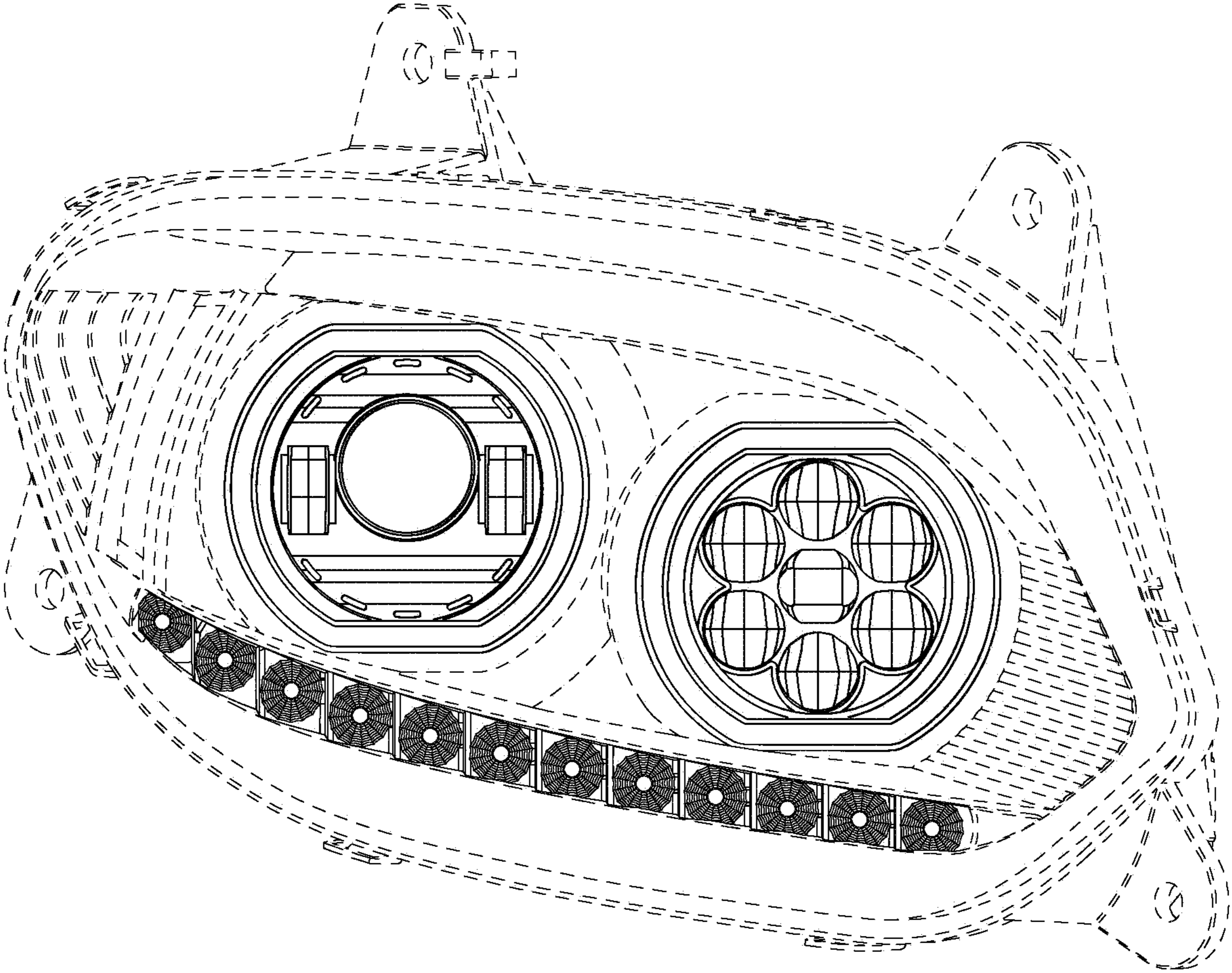

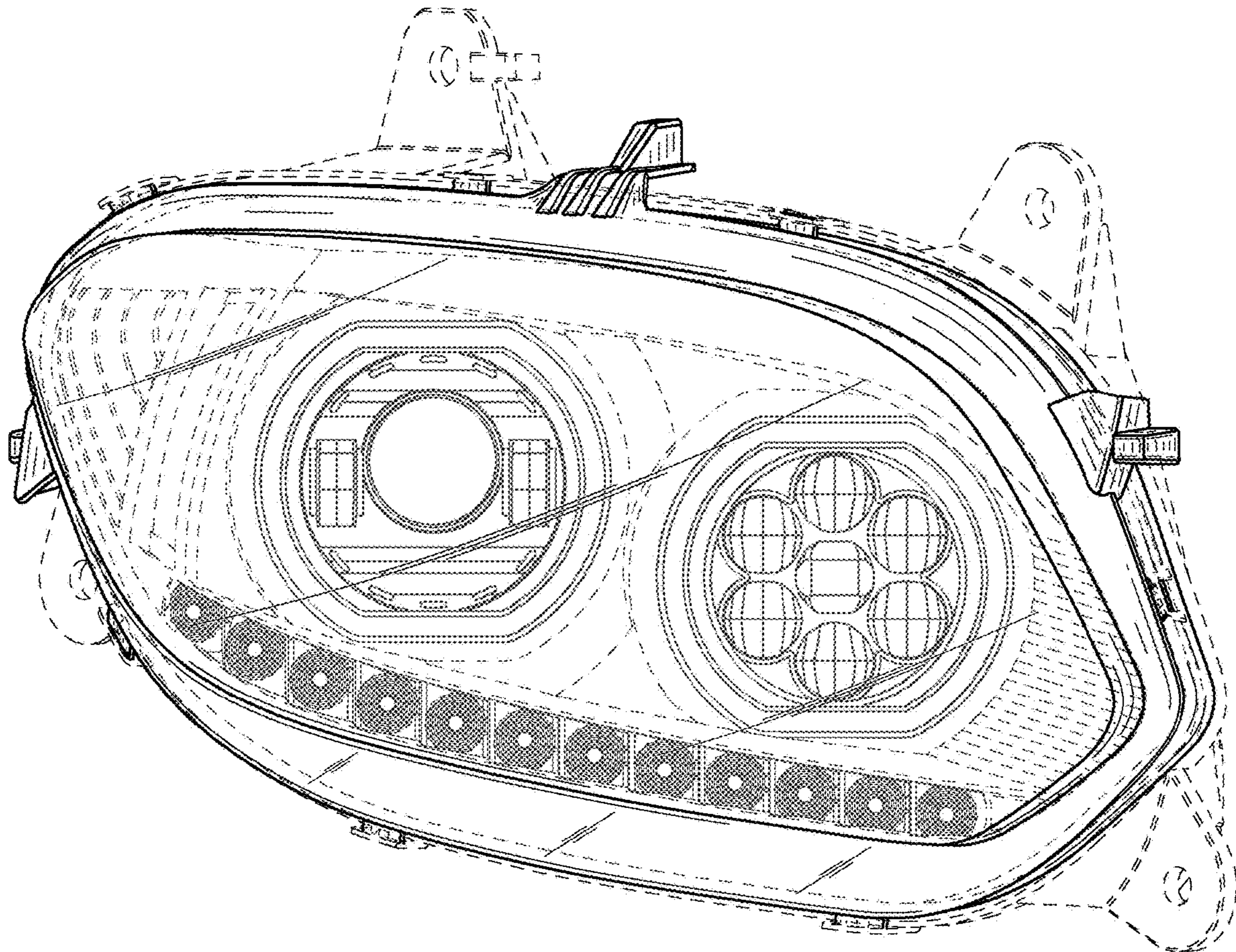

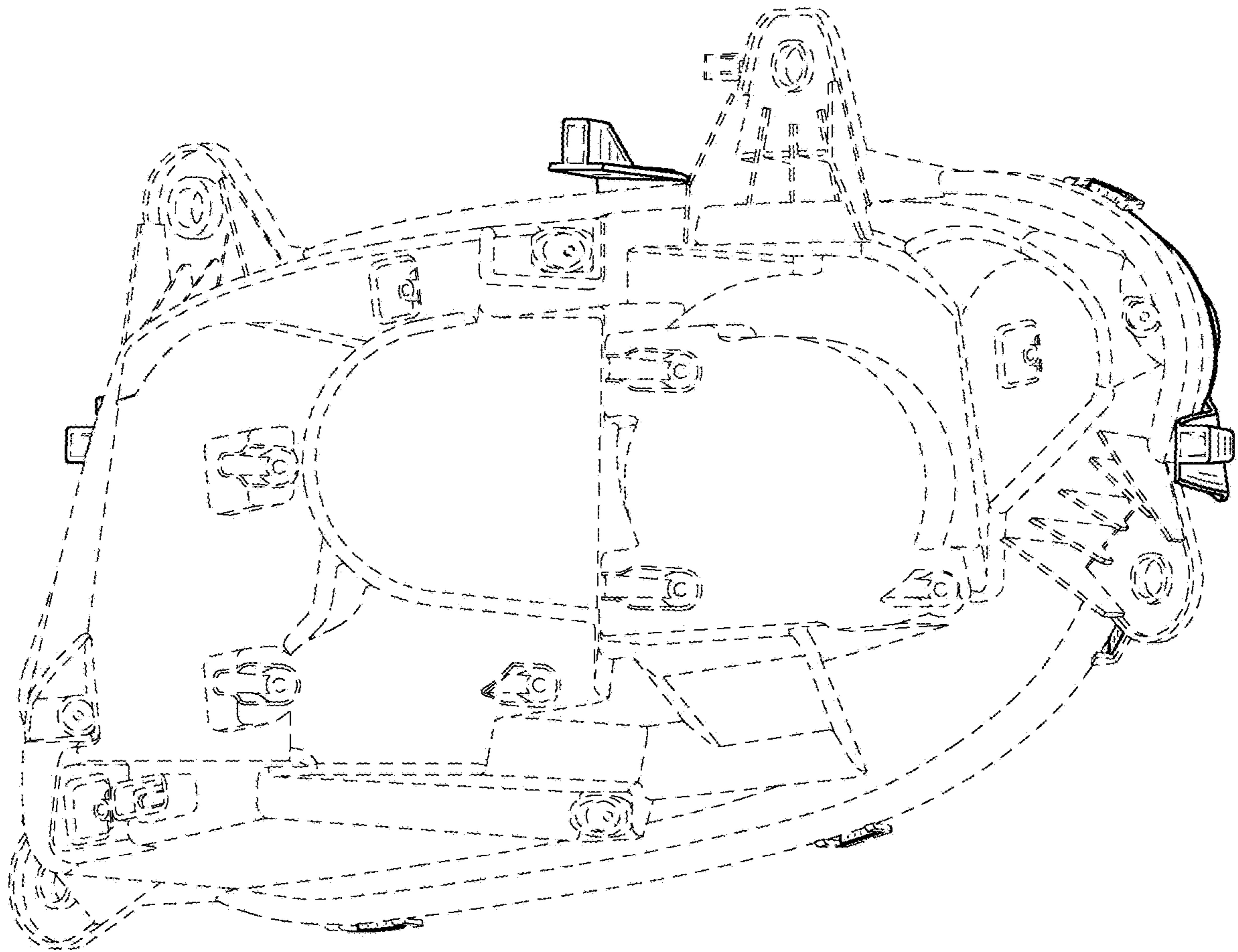

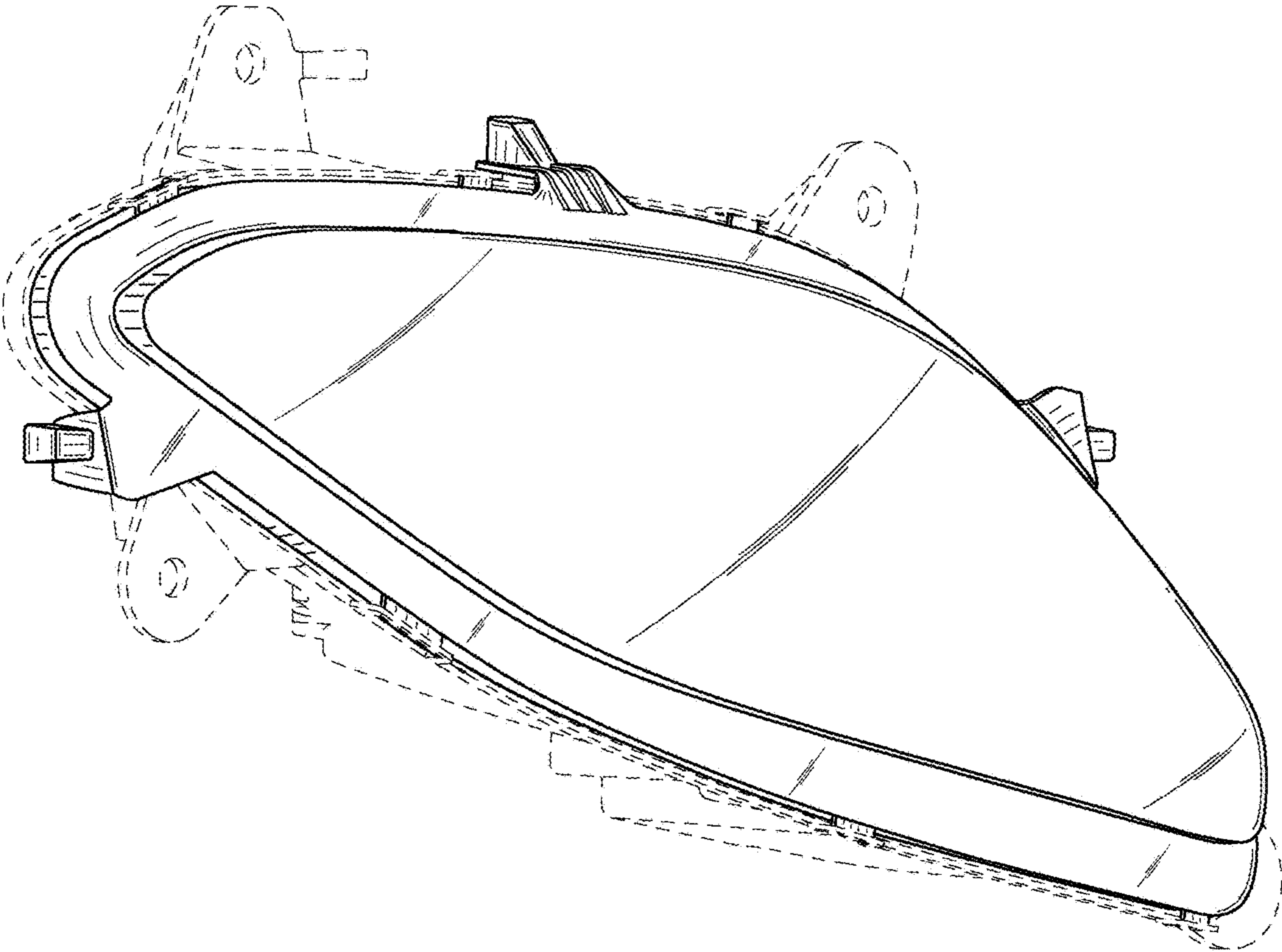

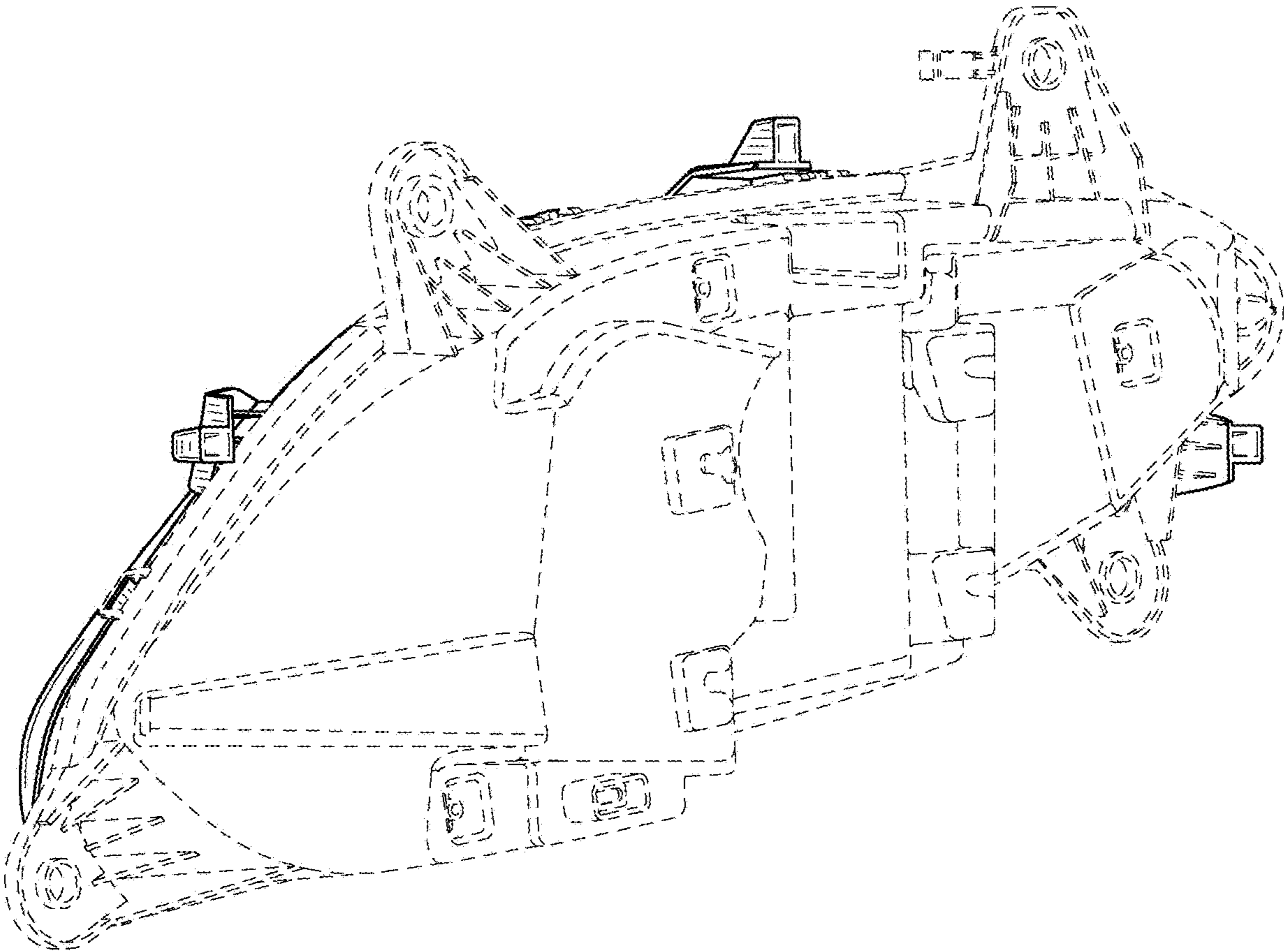

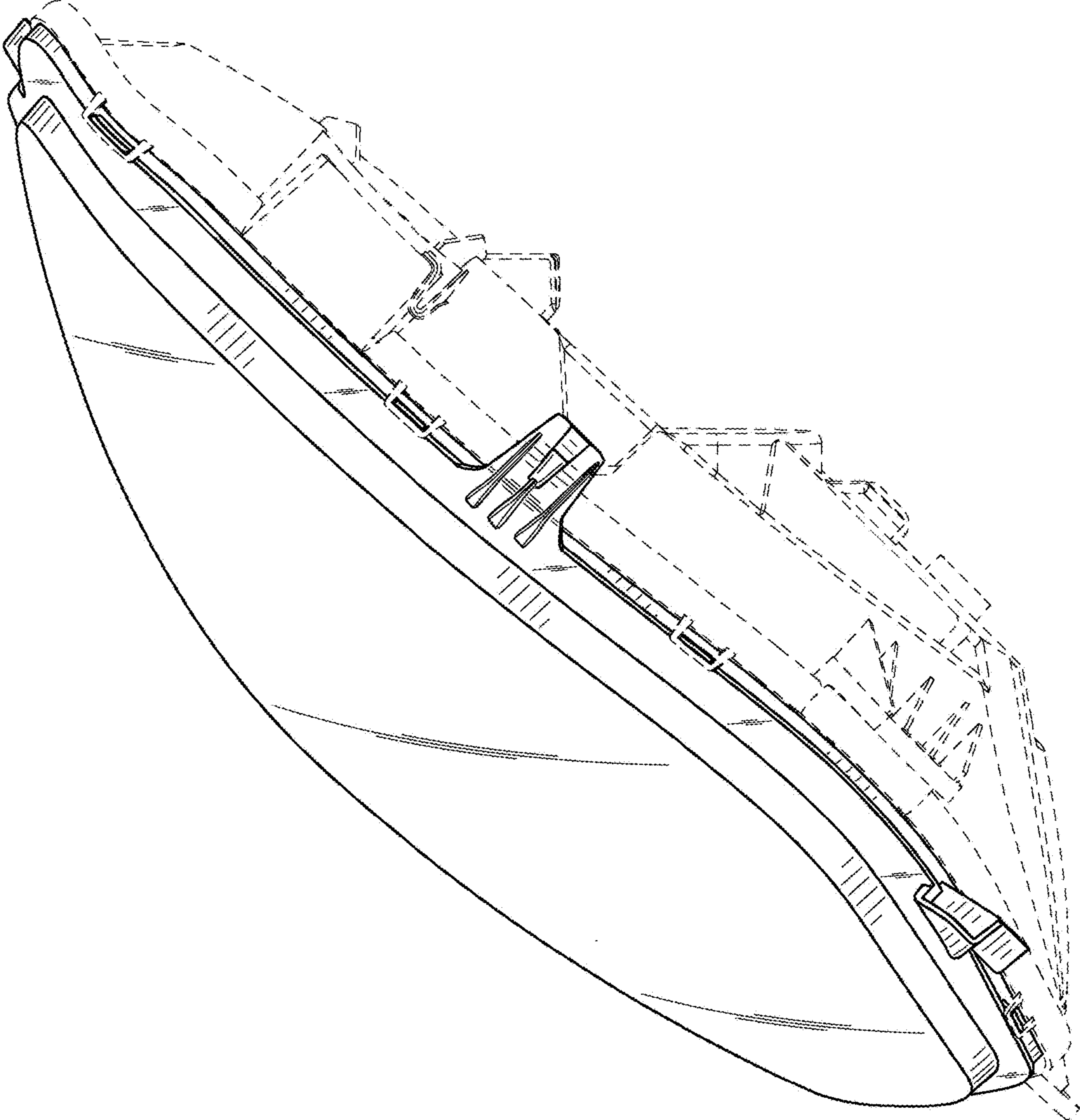

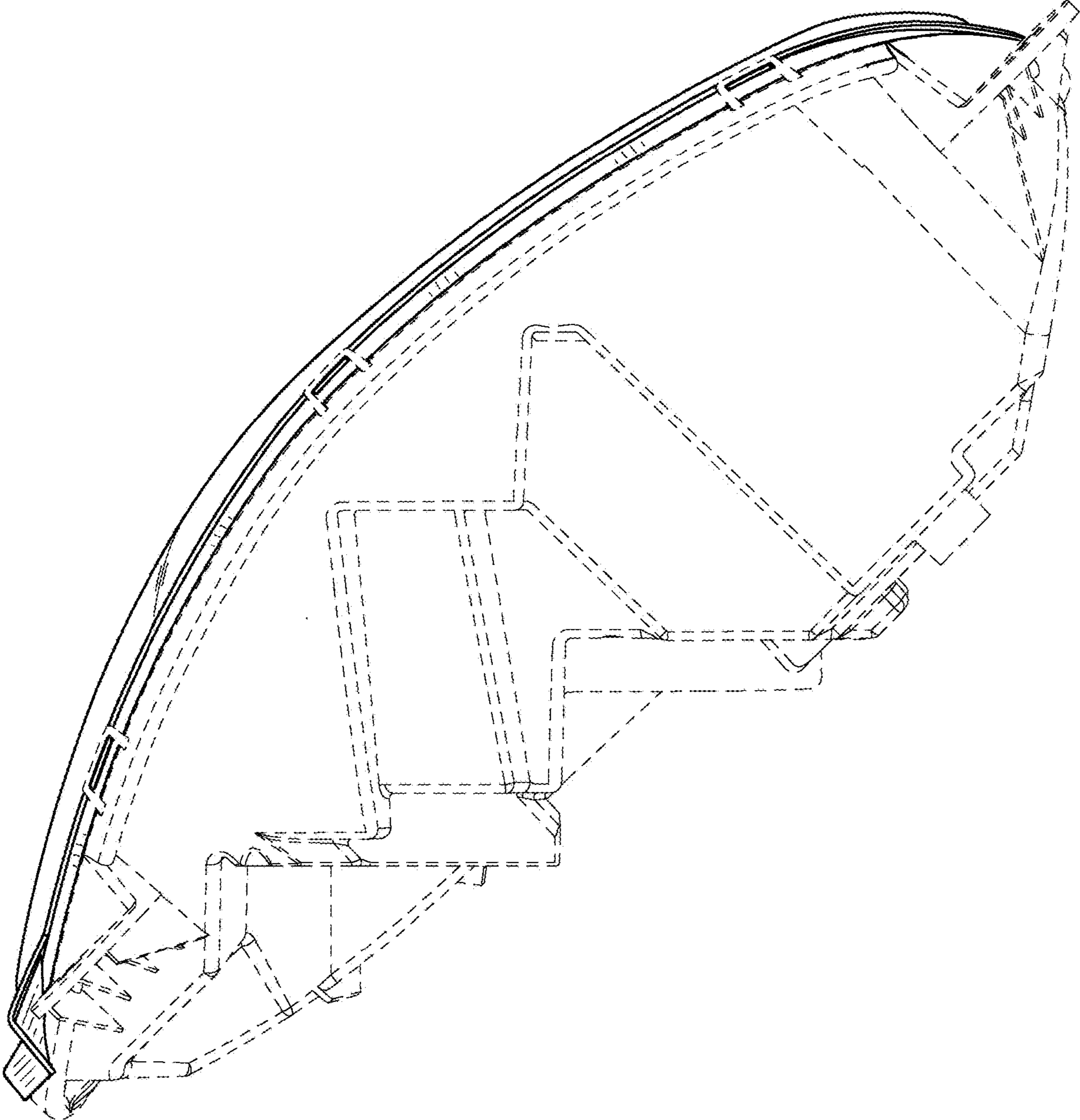
