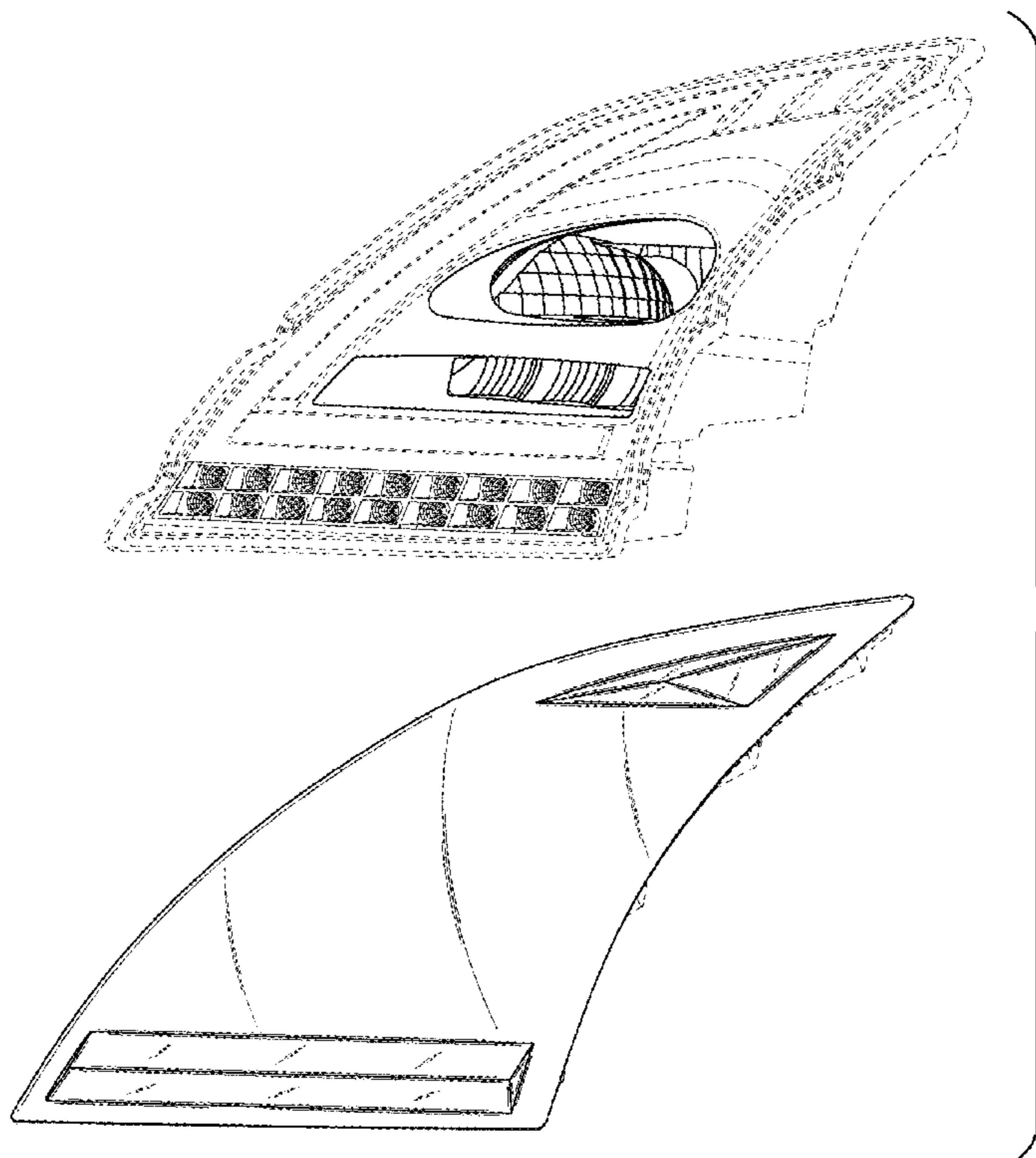
(57) **CLAIM**

The ornamental design for a truck headlight, as shown and described.

DESCRIPTION

FIG. 1 is an exploded perspective view of a truck headlight, showing my new design;

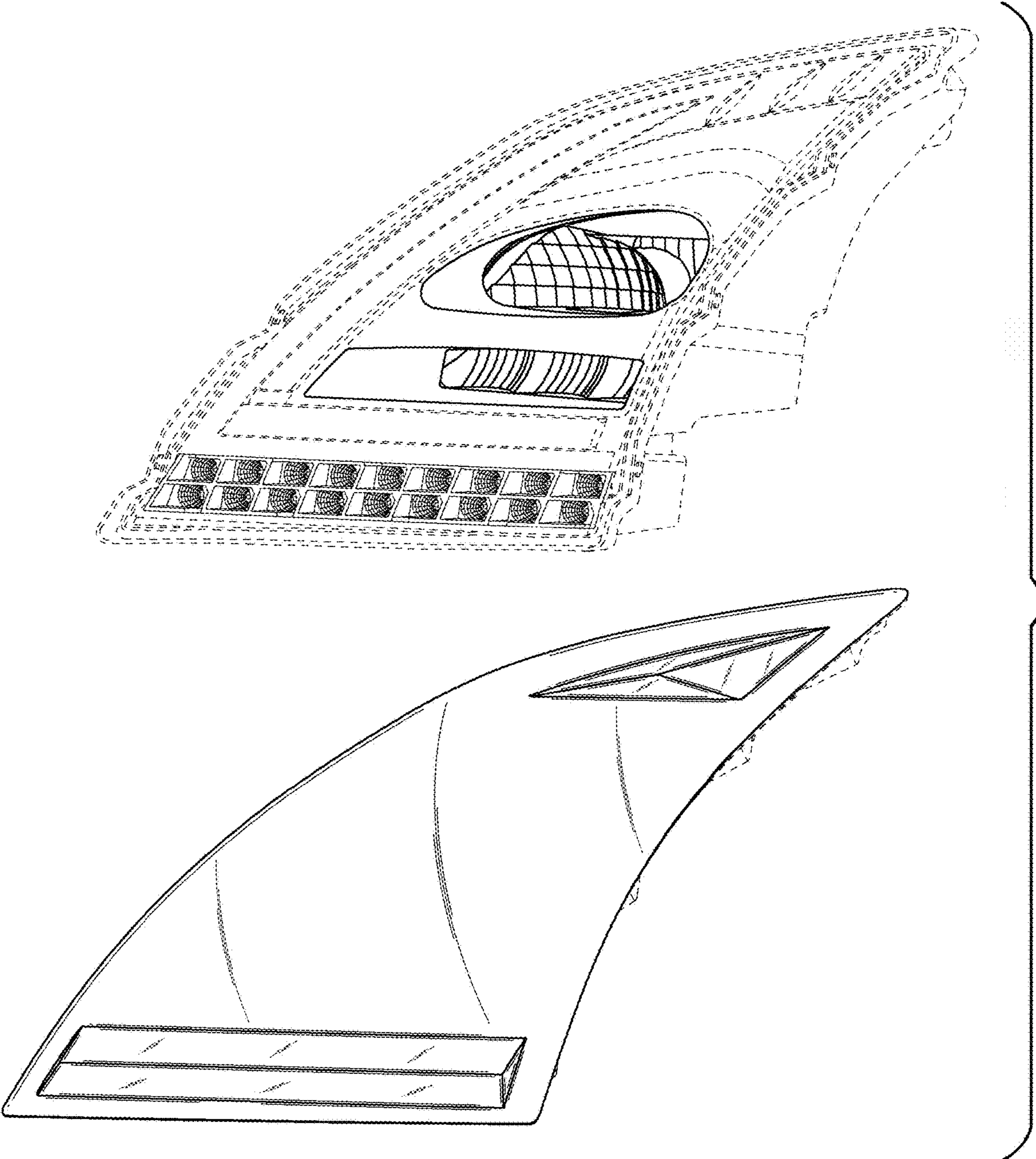

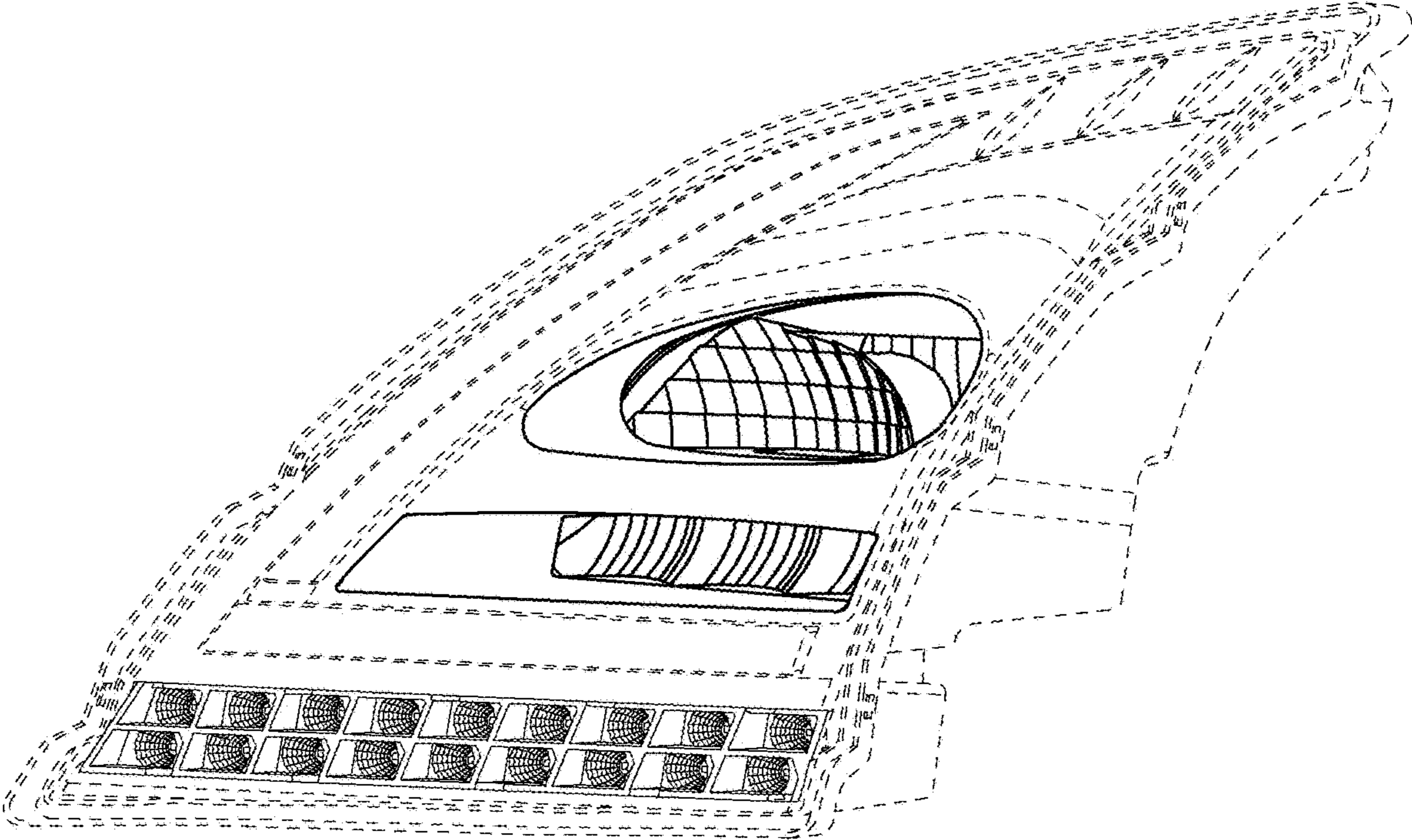

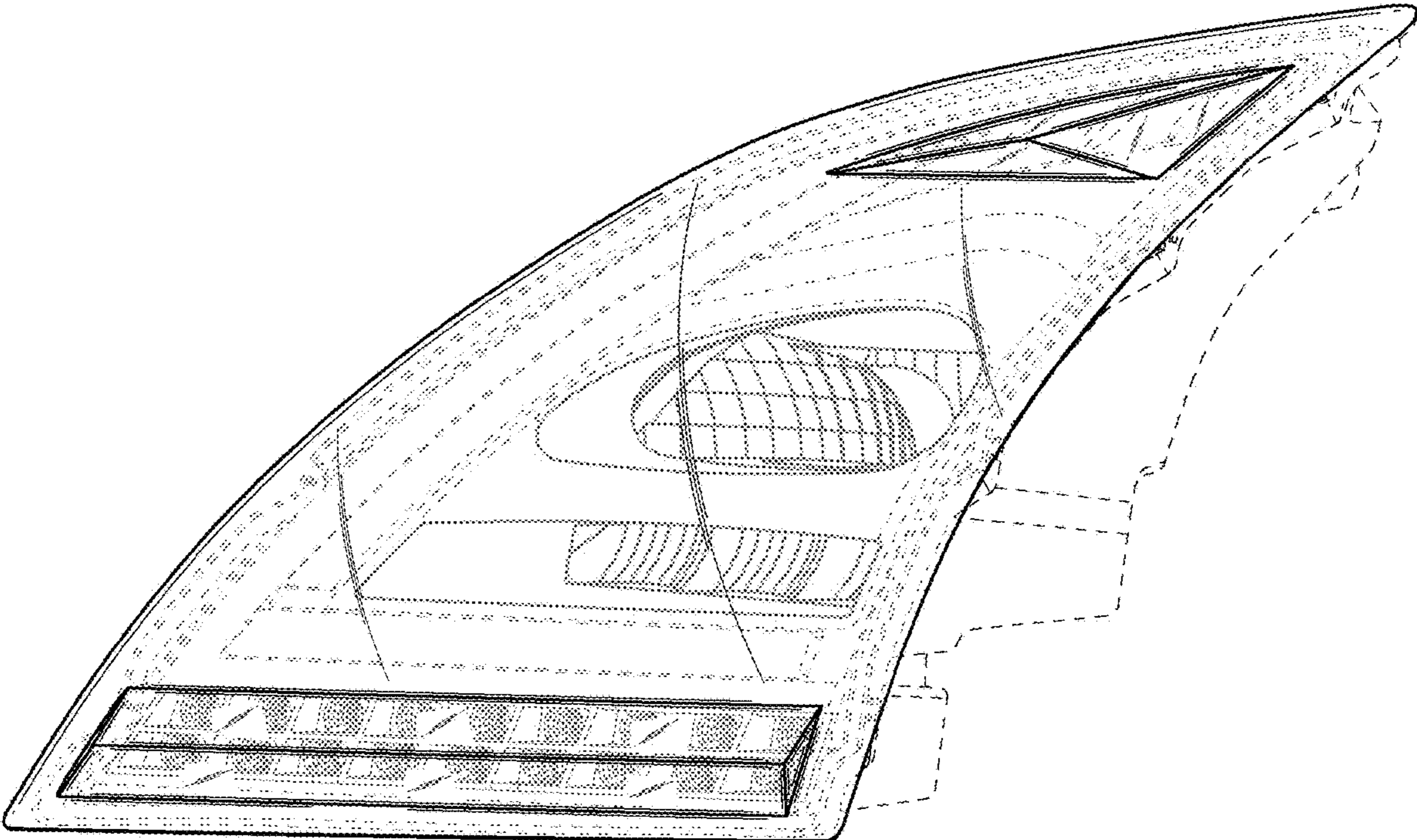

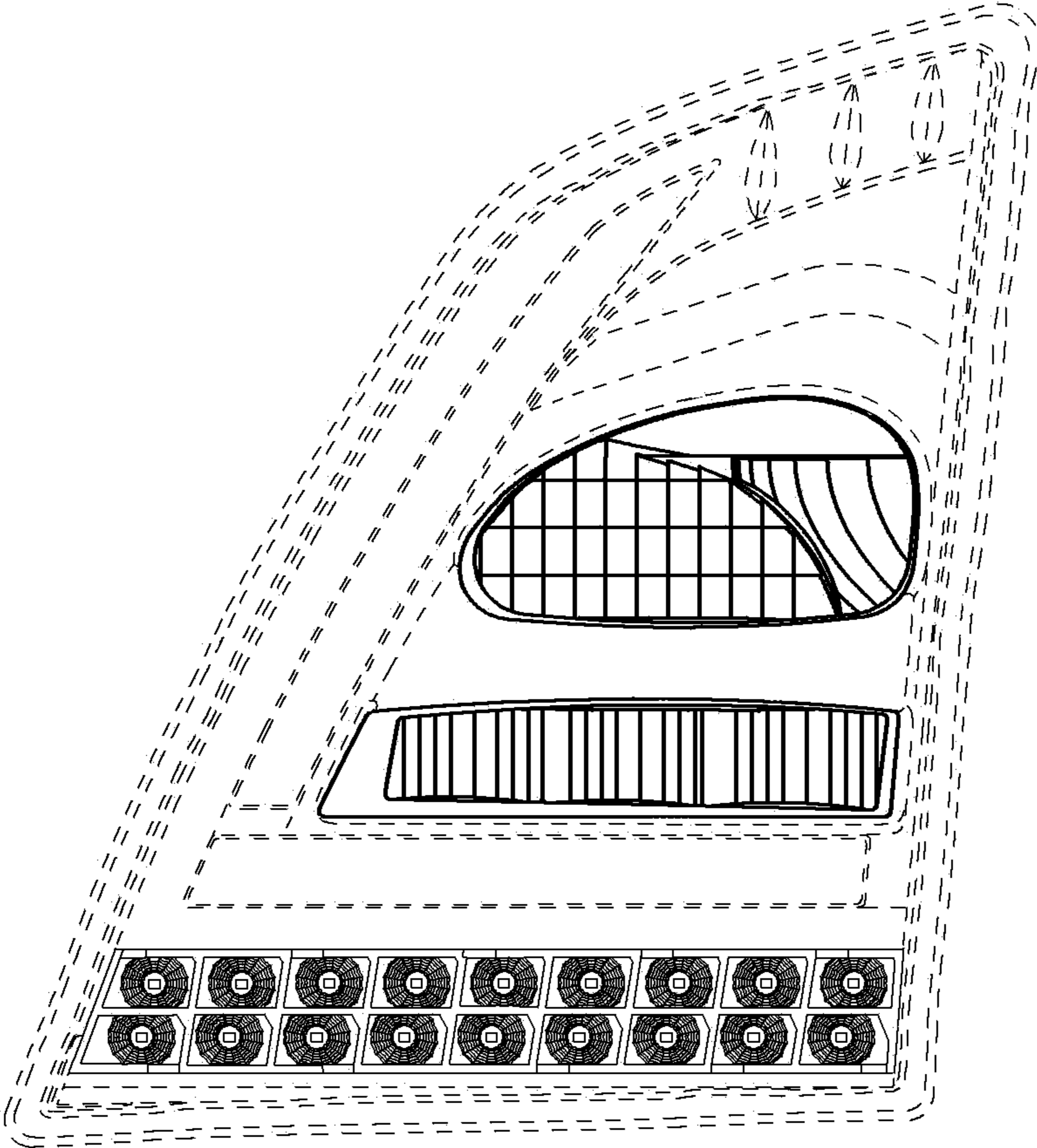

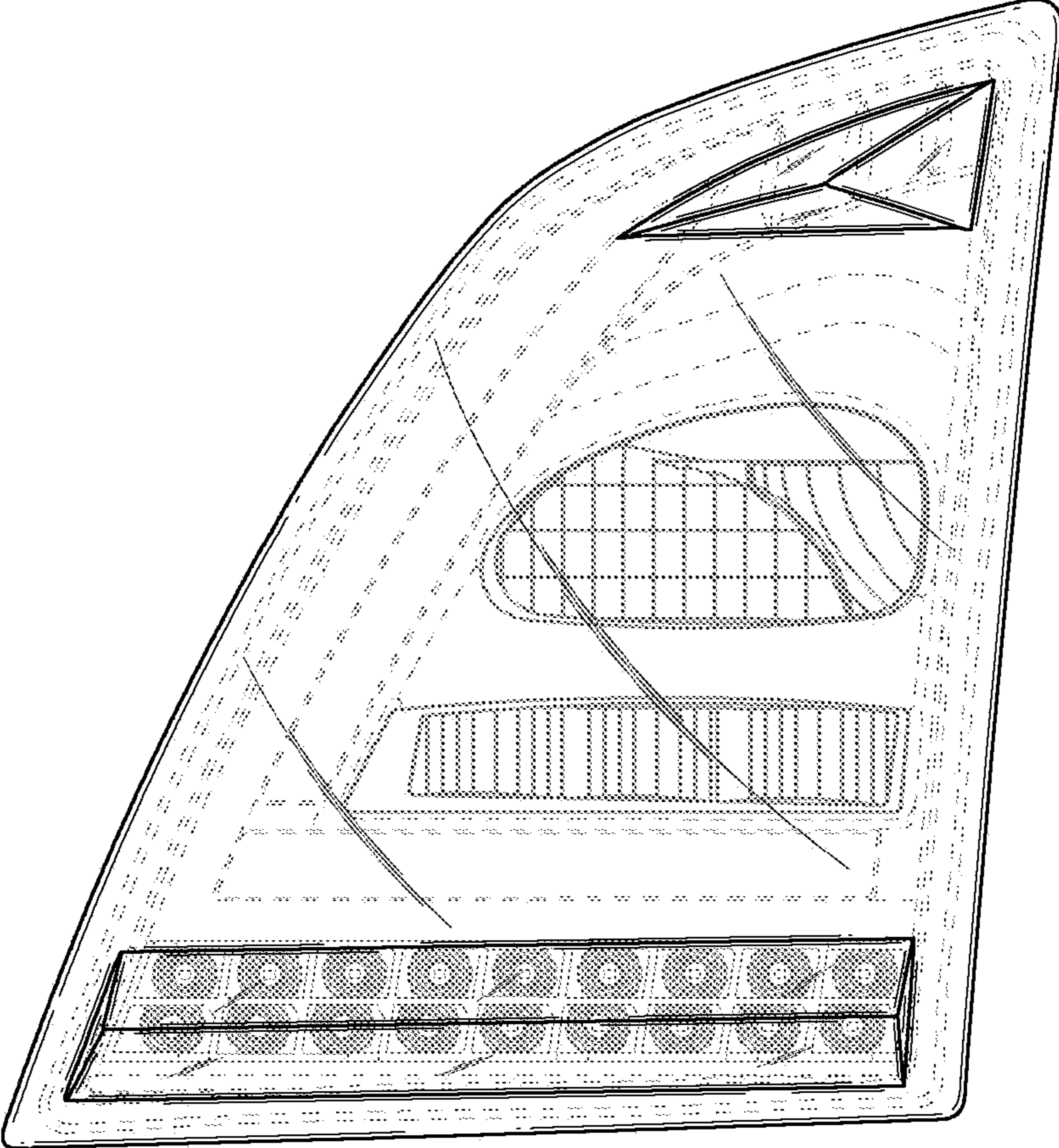

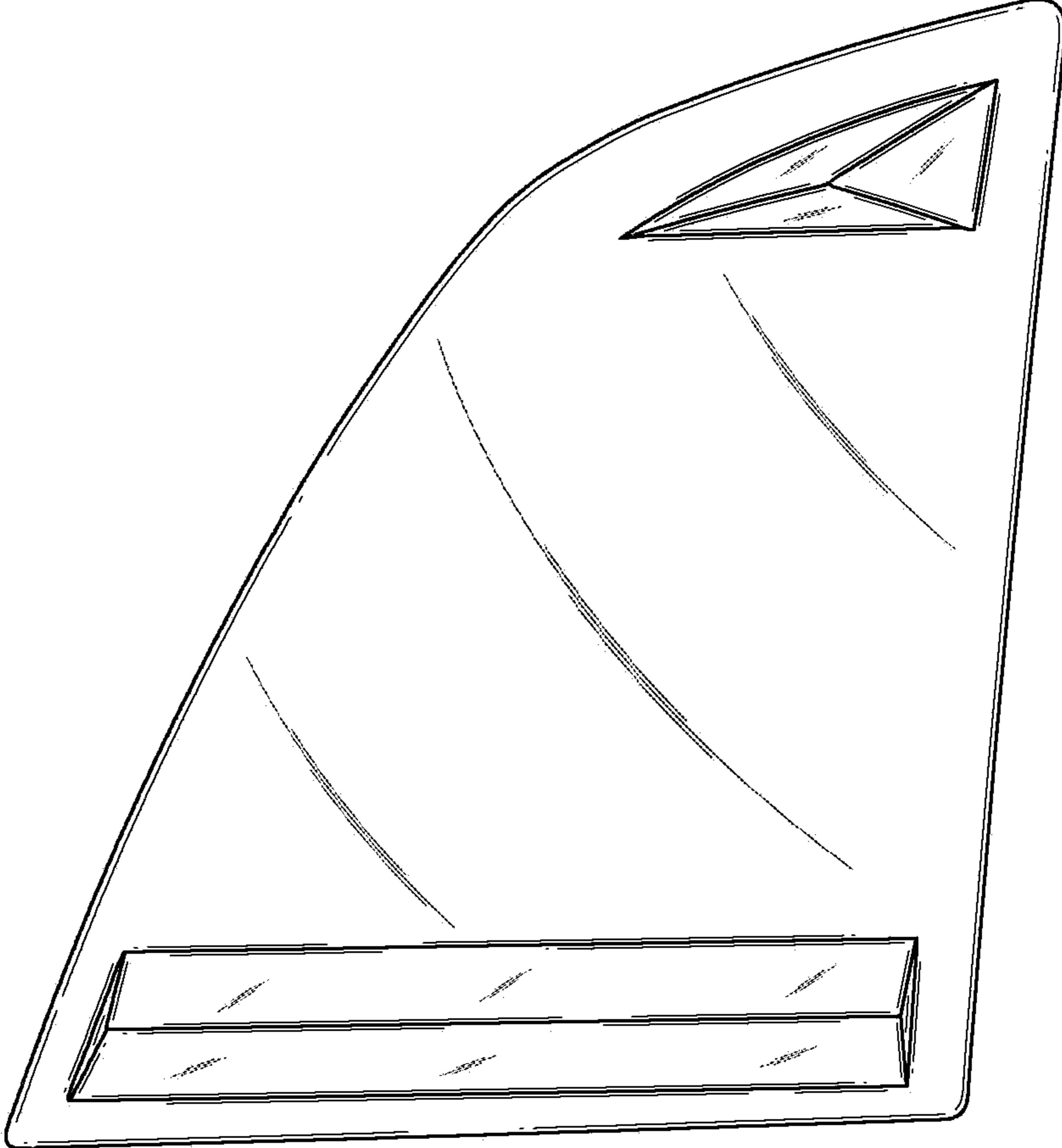

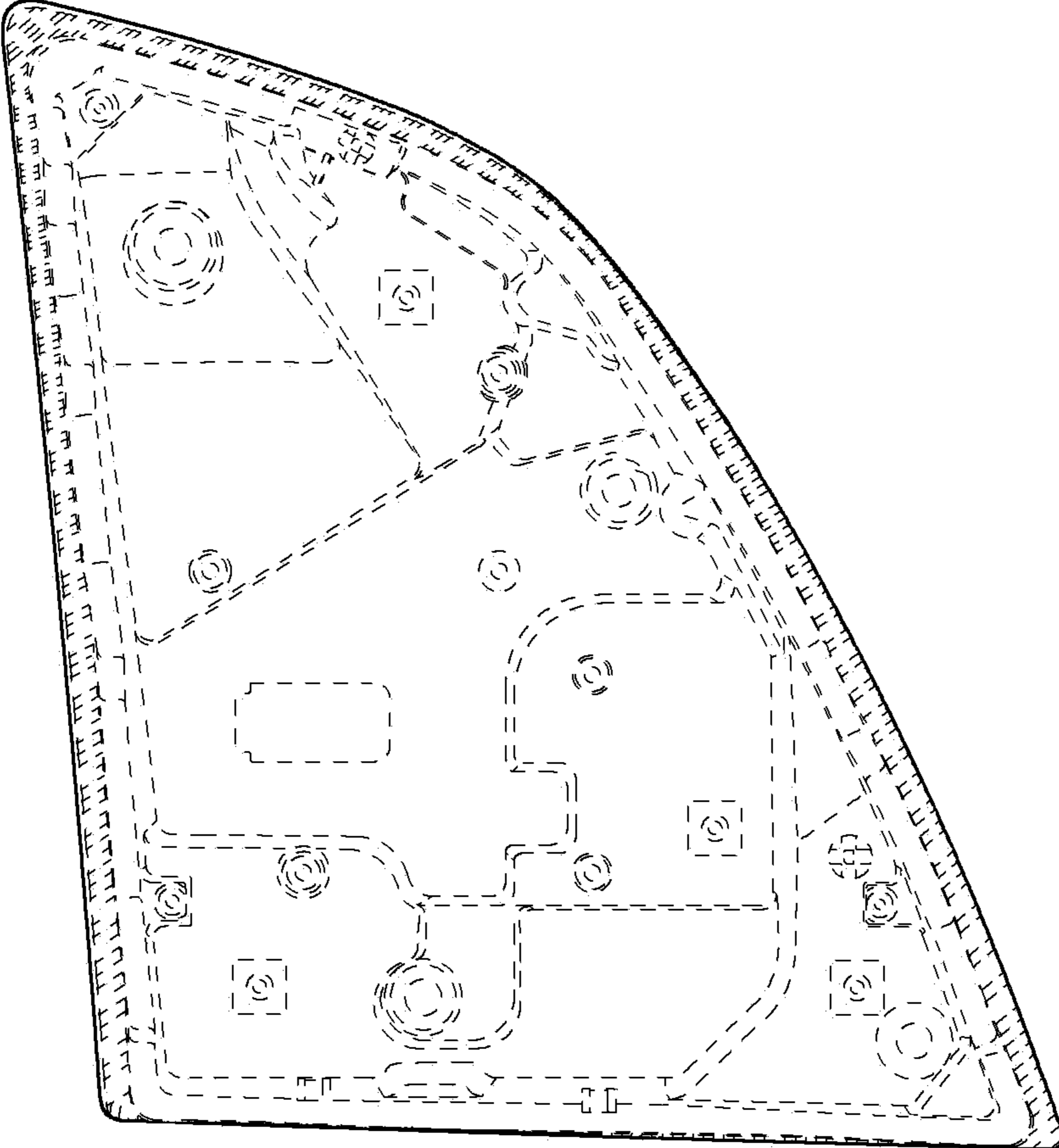

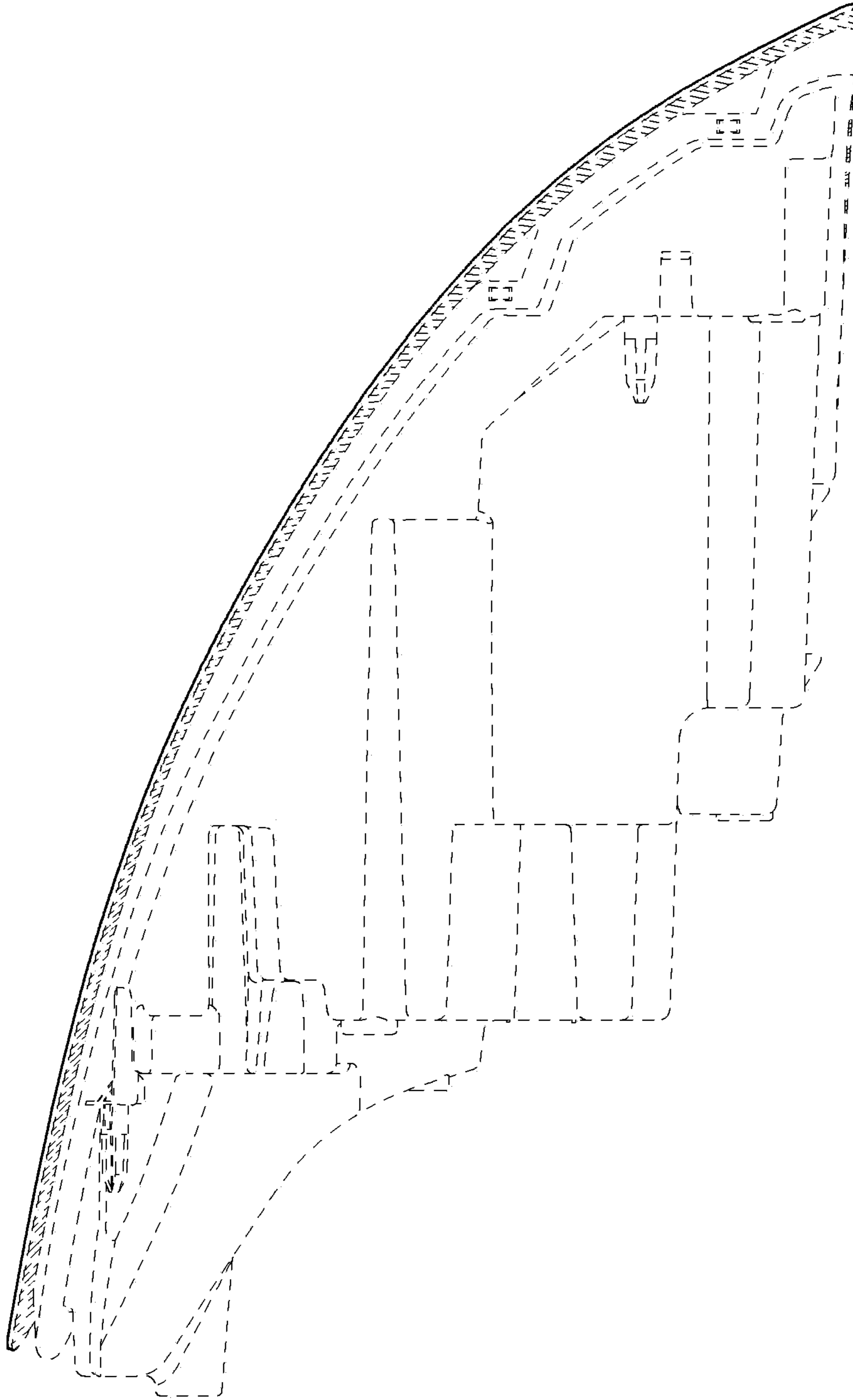

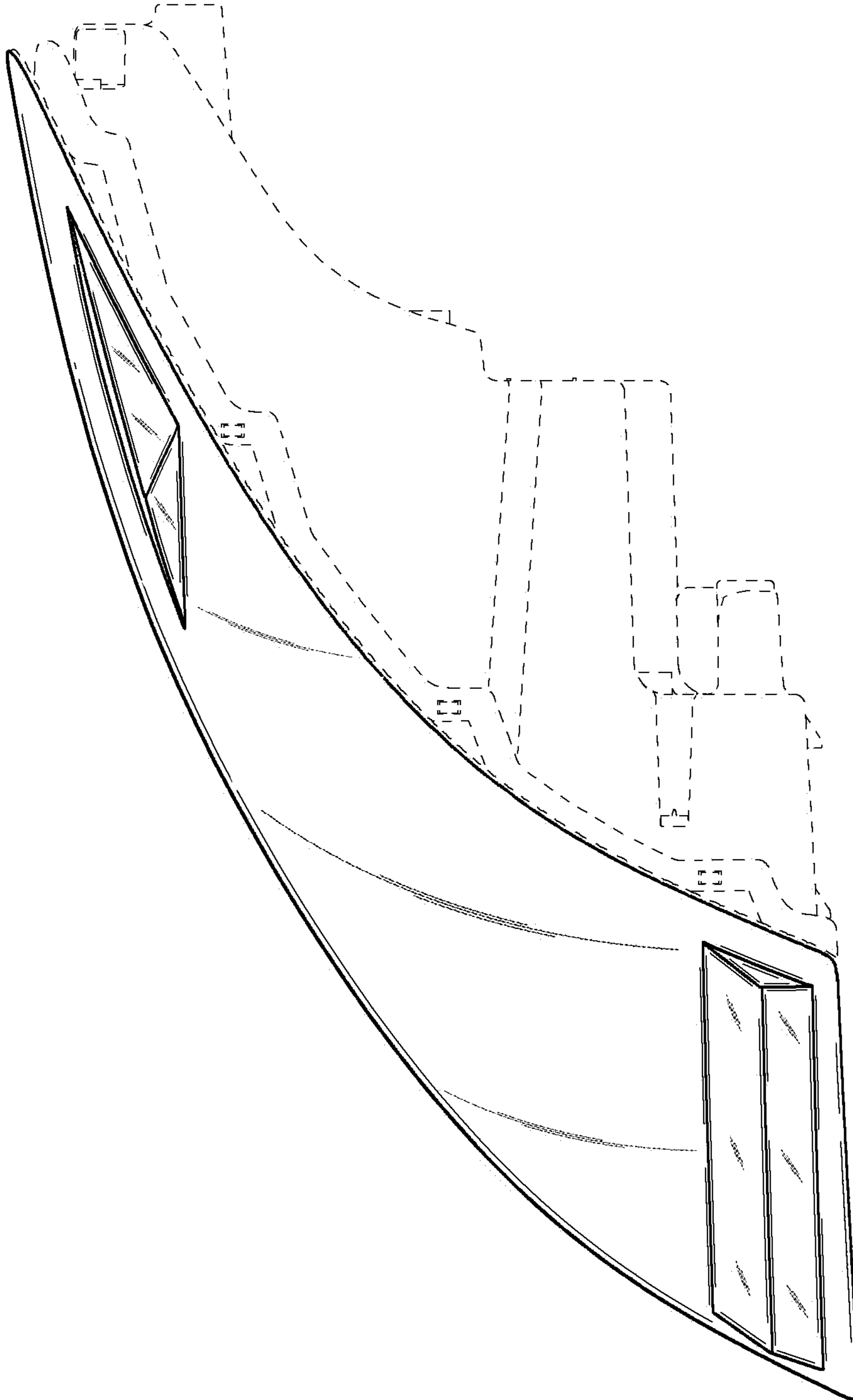

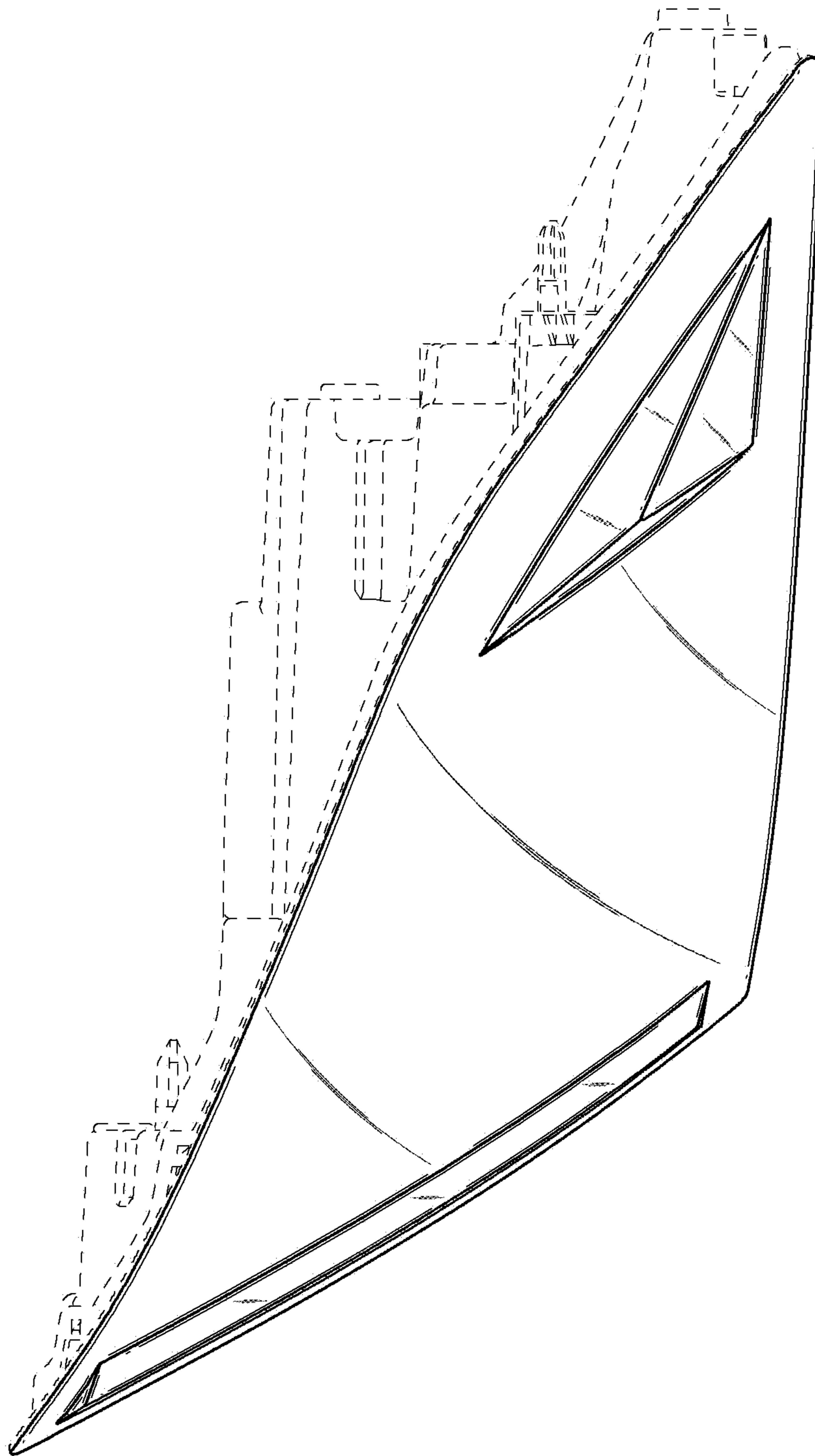

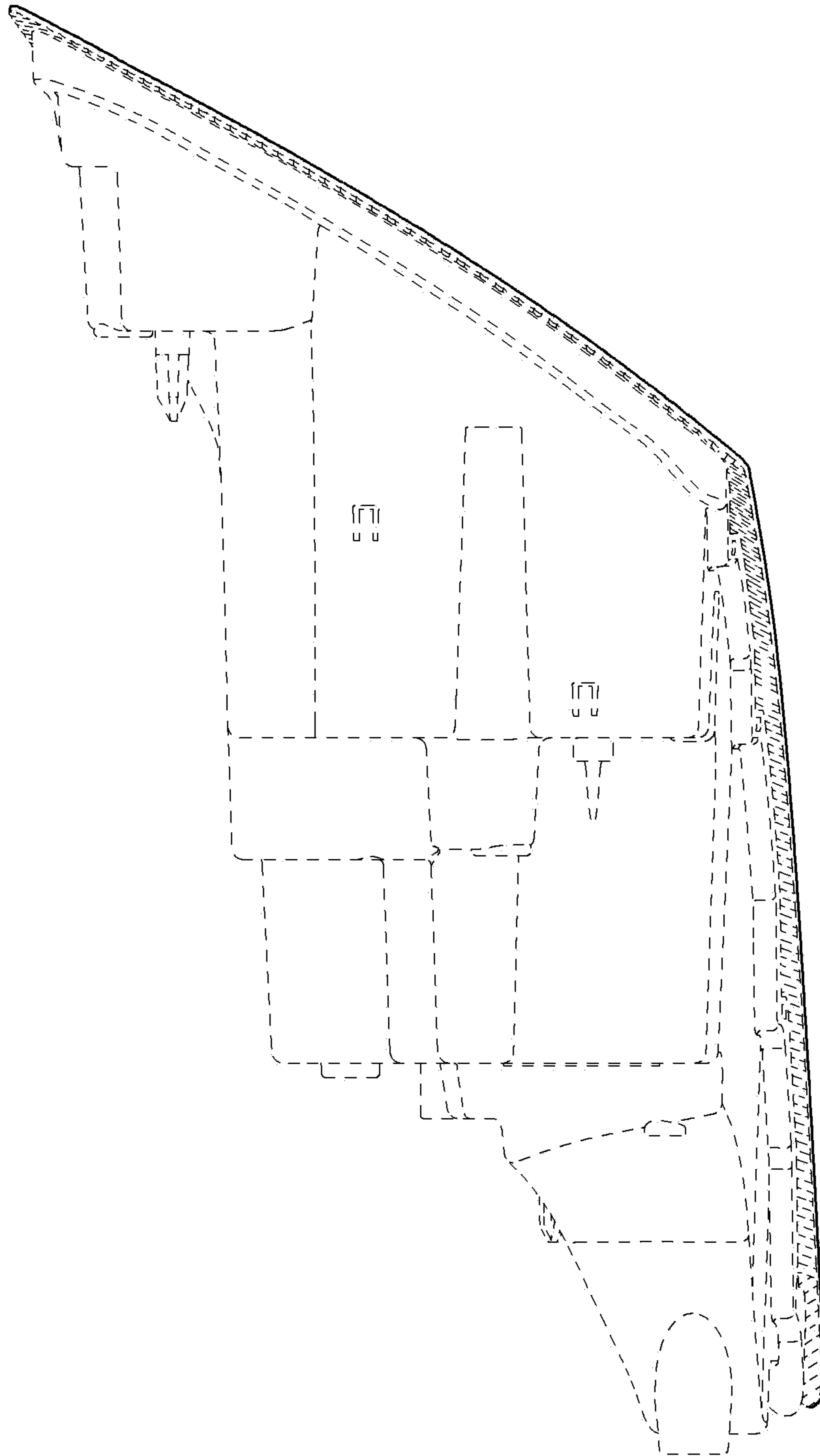
