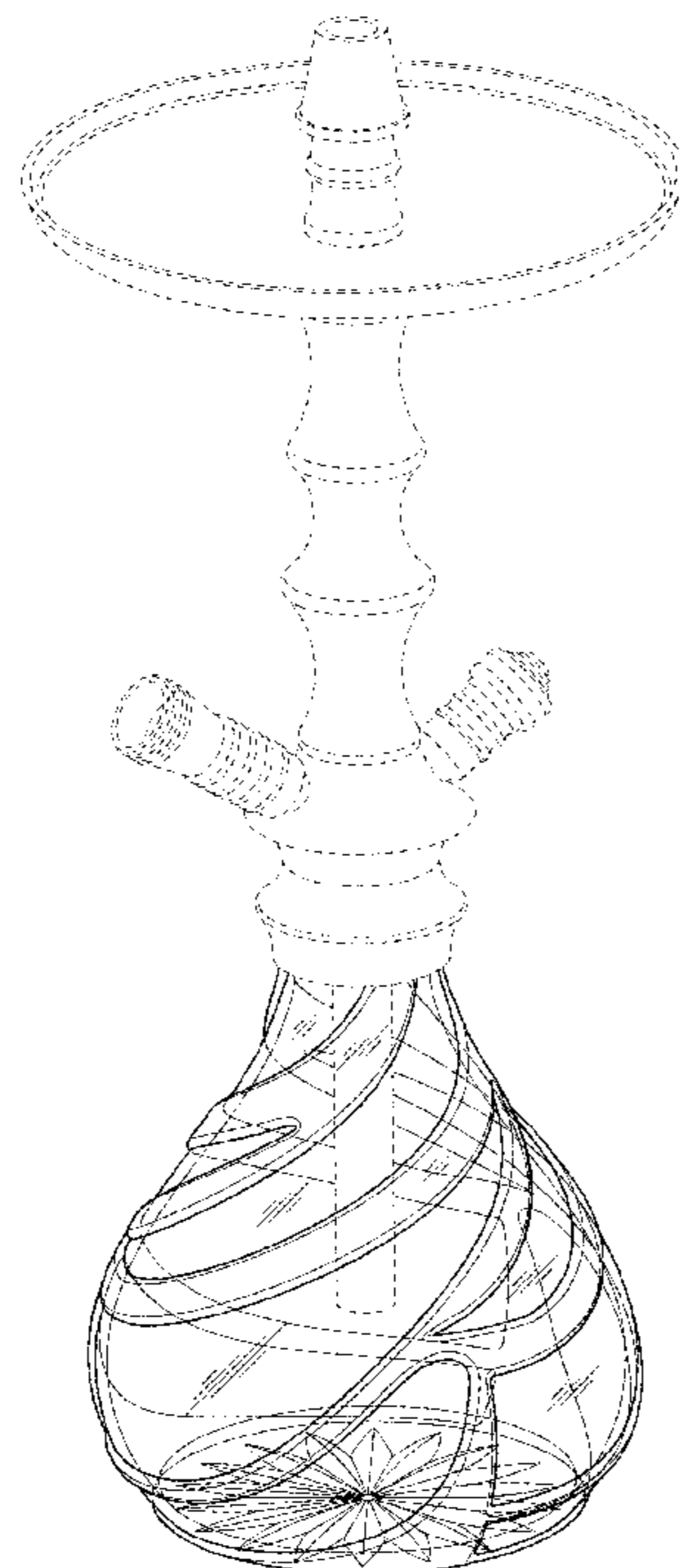

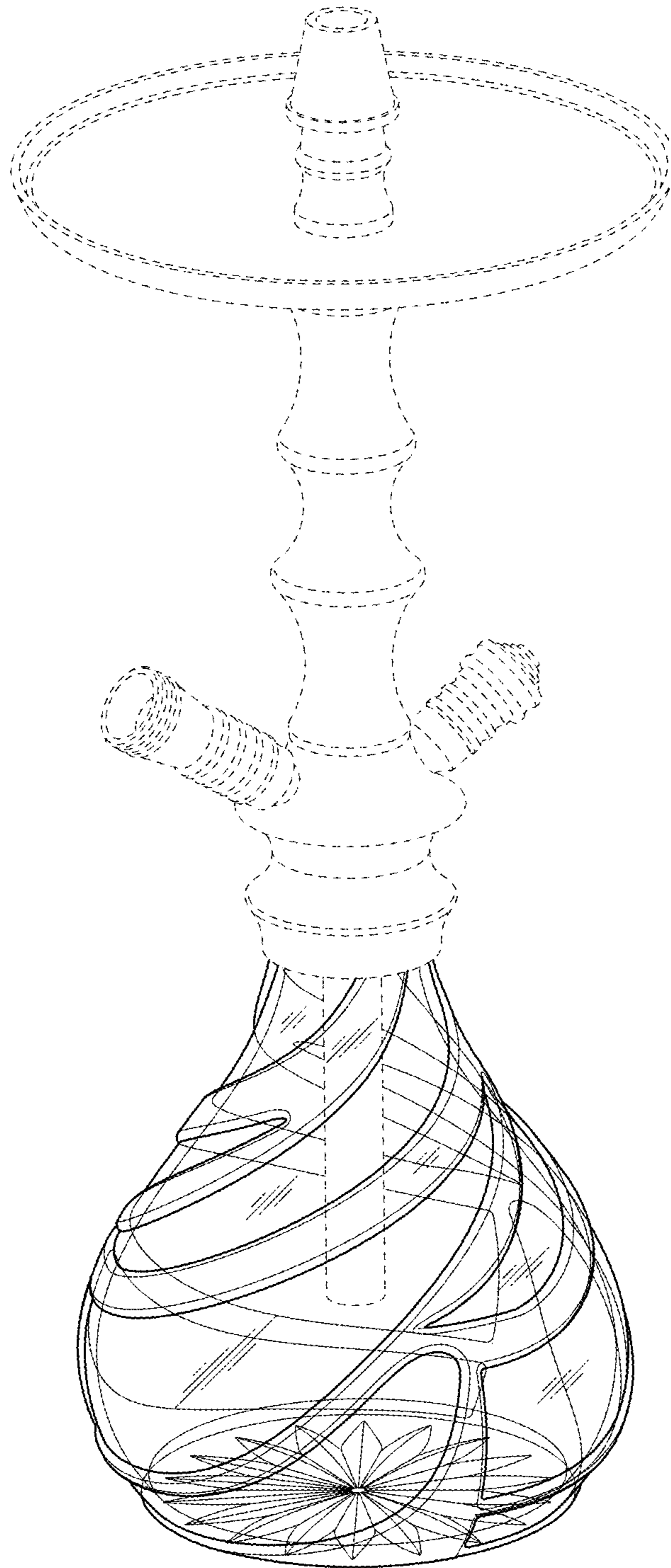
The ornamental design for a hookah, as shown and described.

**DESCRIPTION**

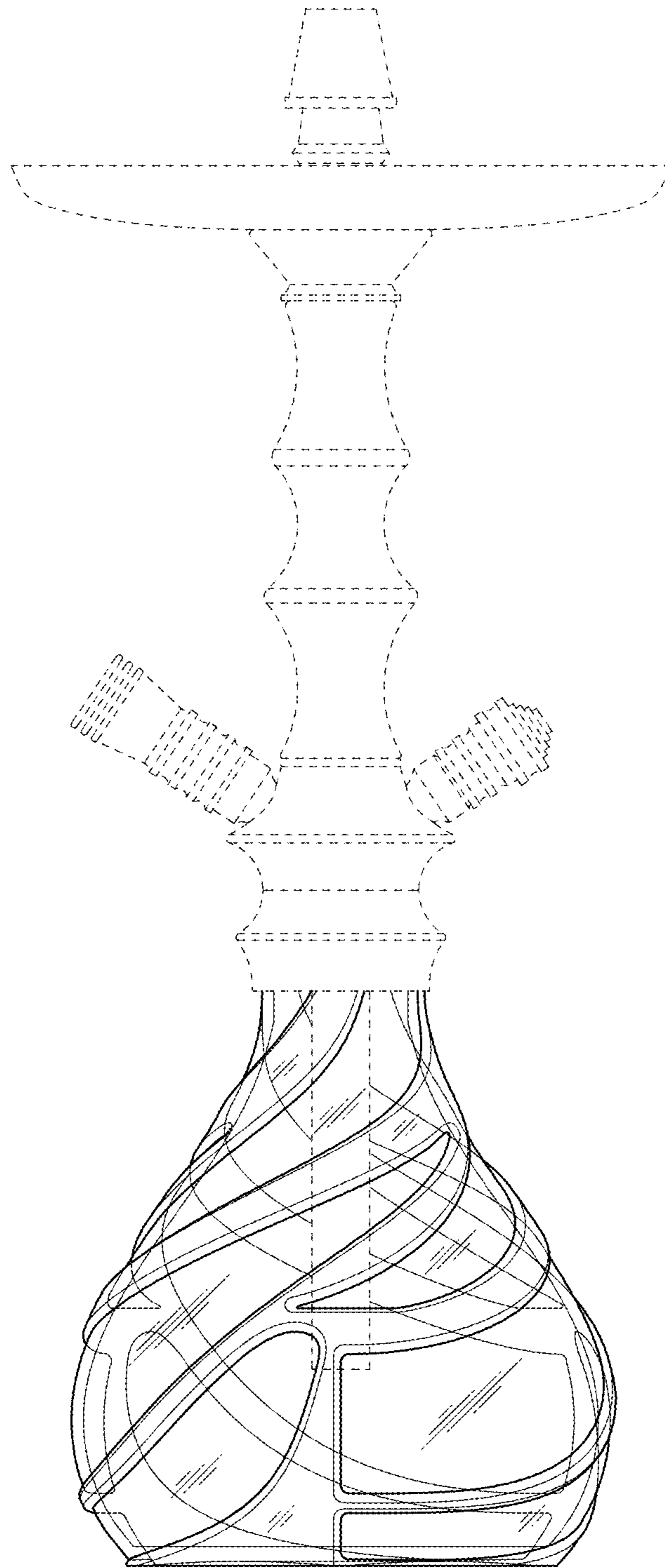
FIG. 1 is a front left perspective view of a hookah in accordance with my new design;

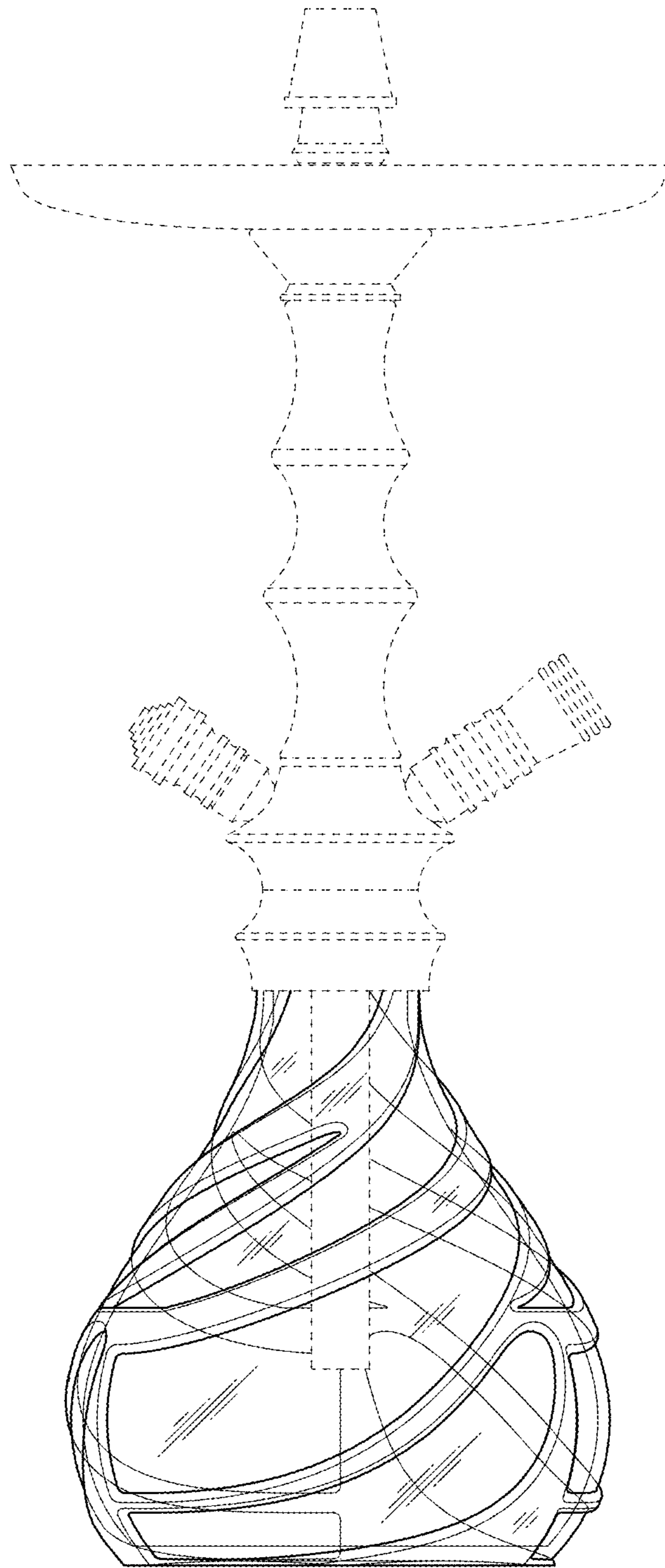




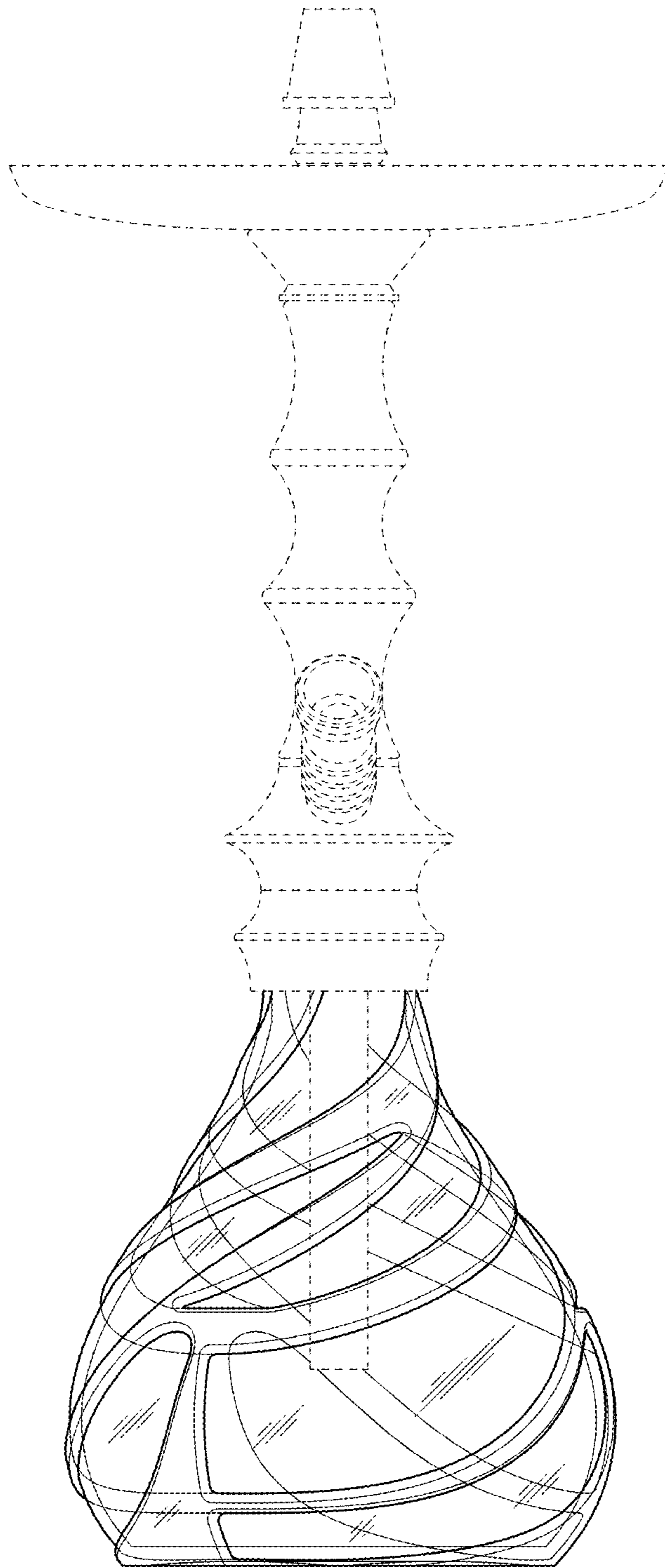

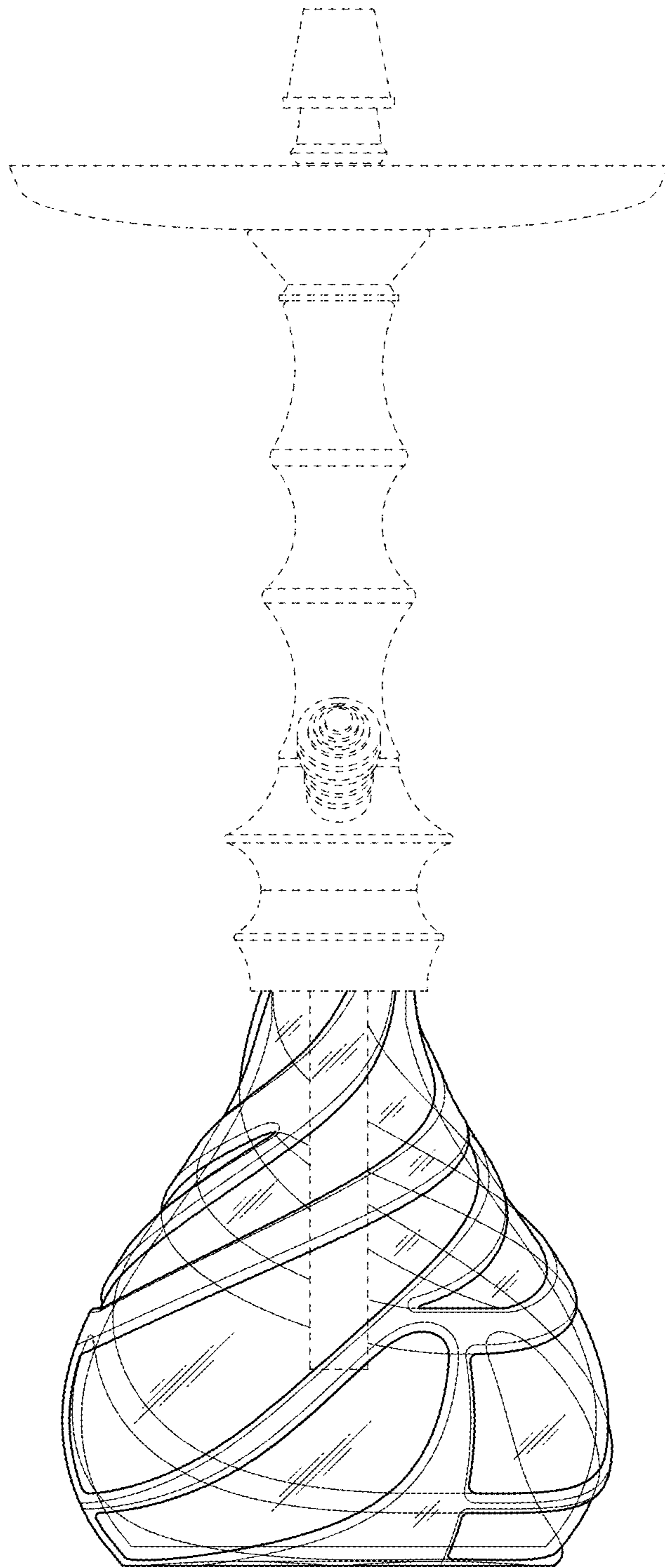

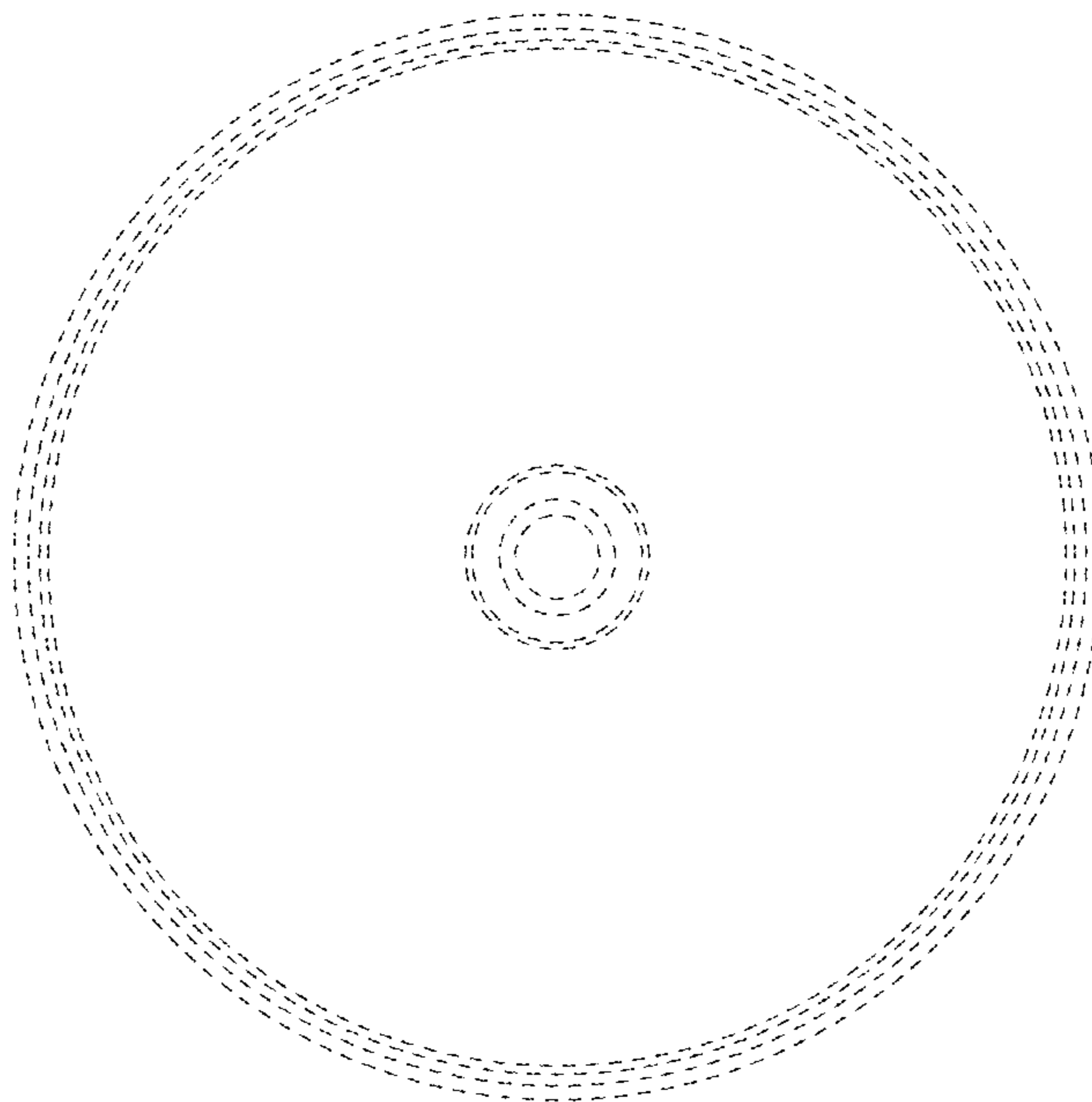

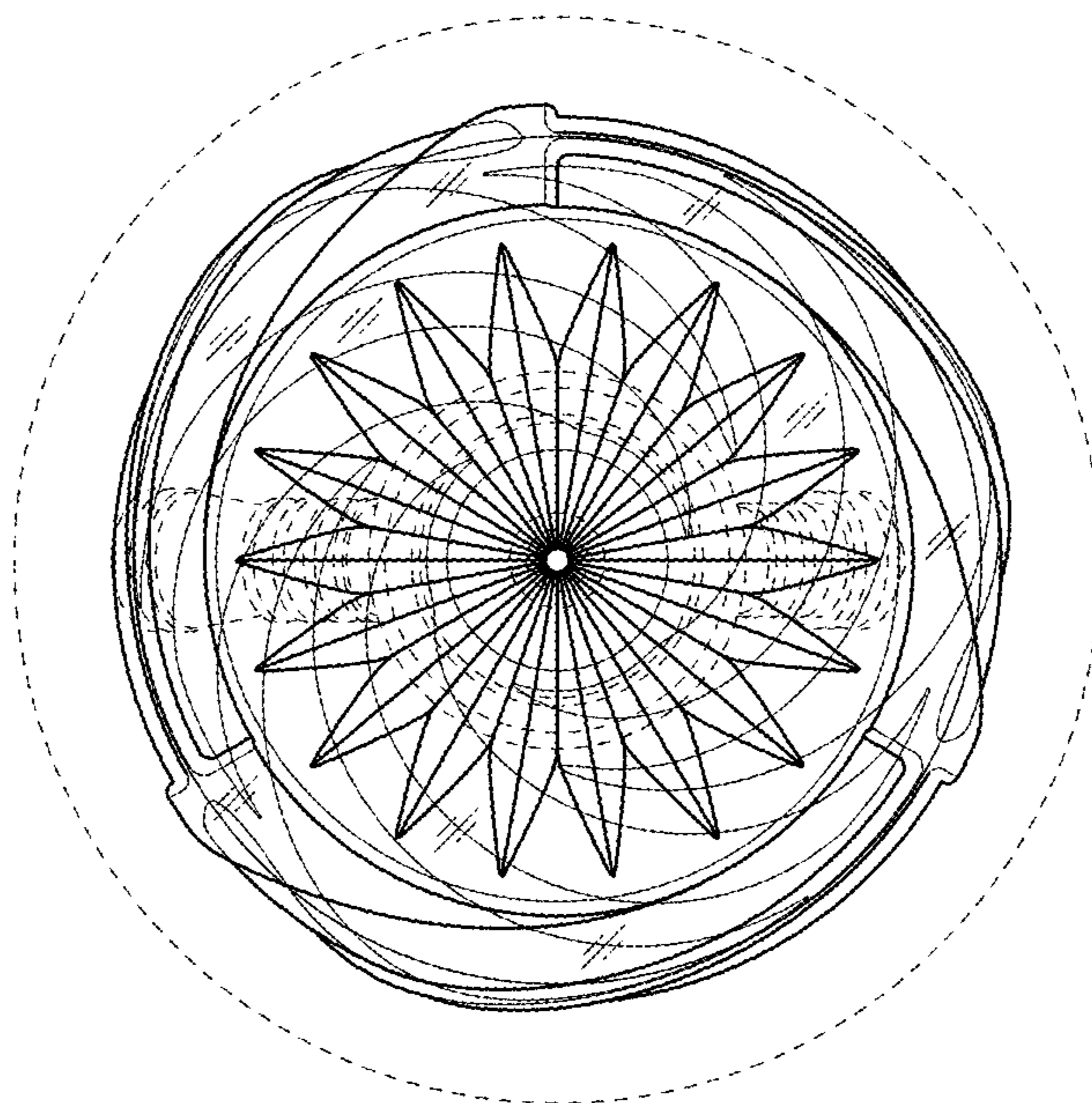
