FIG. 1 is a top, front and left side perspective view of an electric hair styling brush showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and FIG. 7 is a bottom plan view thereof. FIG. 8 is an enlarged view of the partial portion of FIG. 1; and, FIG. 9 is an enlarged view of the partial portion of FIG. 1. The dashed broken lines shown in the drawings depict portions of the electric hair styling brush in which the design is embodied that form no part of the claimed design. The long-short-long broken lines illustrate the portions of FIG. 1 extracted for the enlarged views of FIGS. 8-9, as well as the bounds of the enlarged views themselves. The long-short long broken lines form no part of the claimed design.

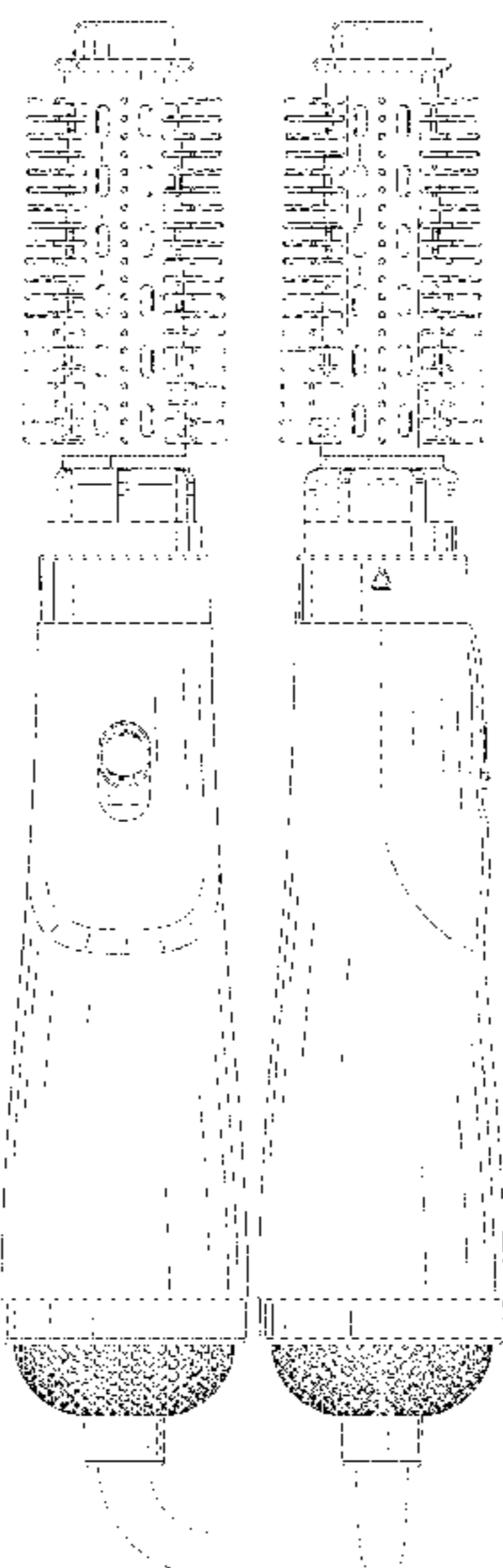

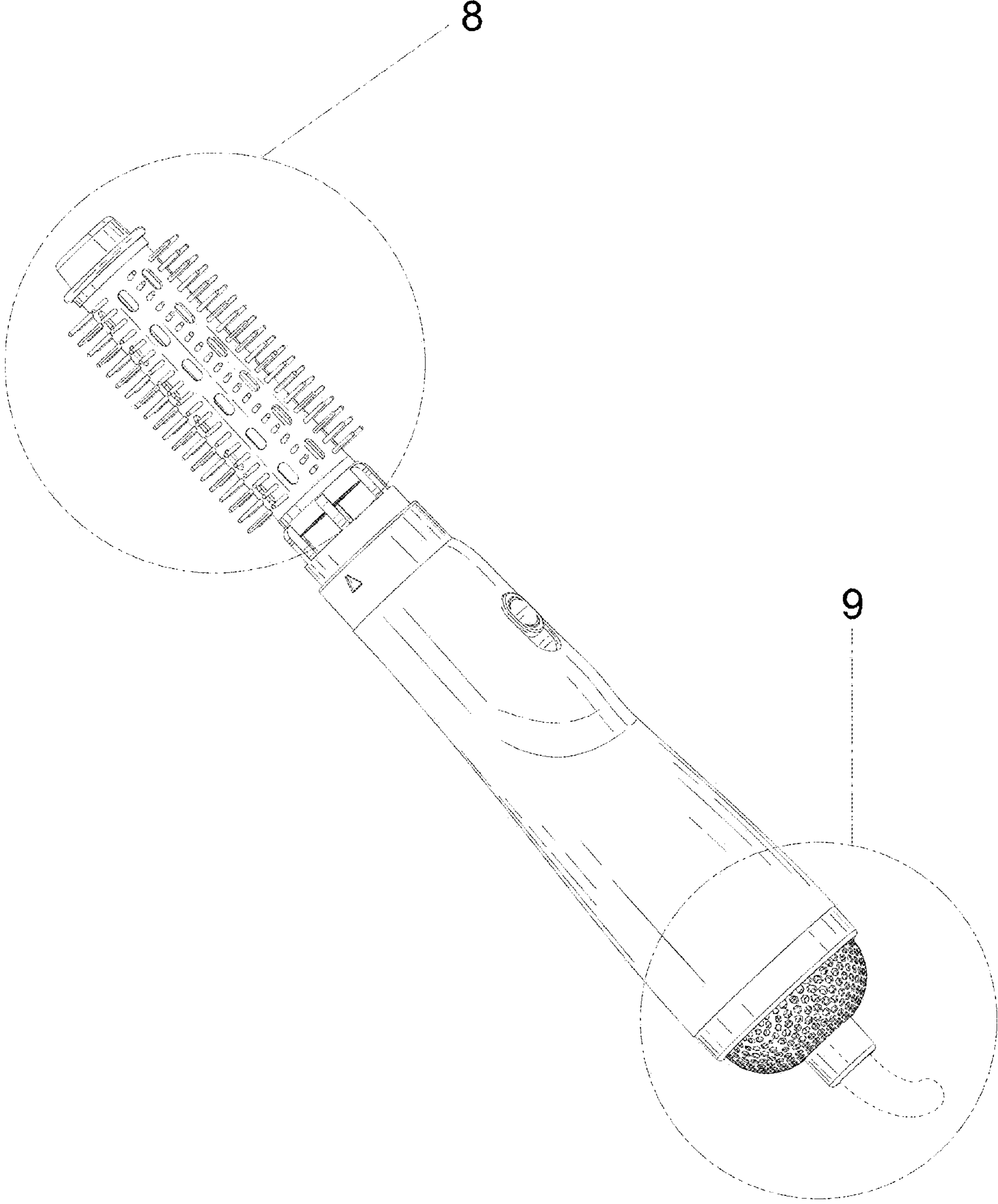

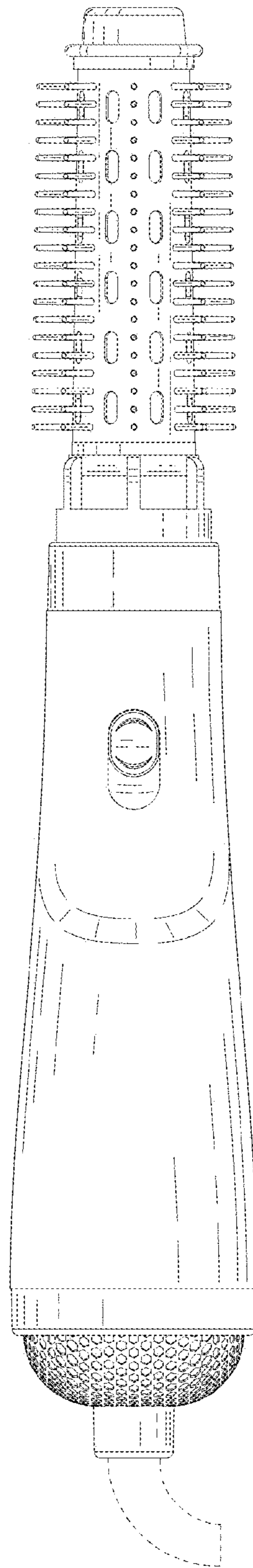

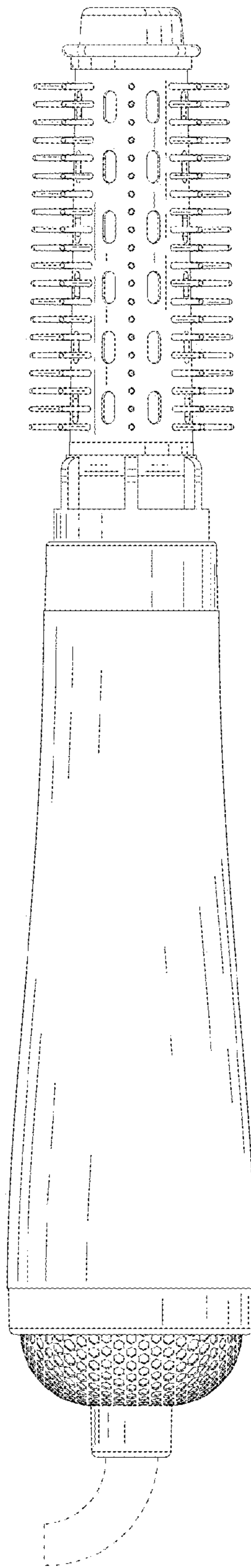

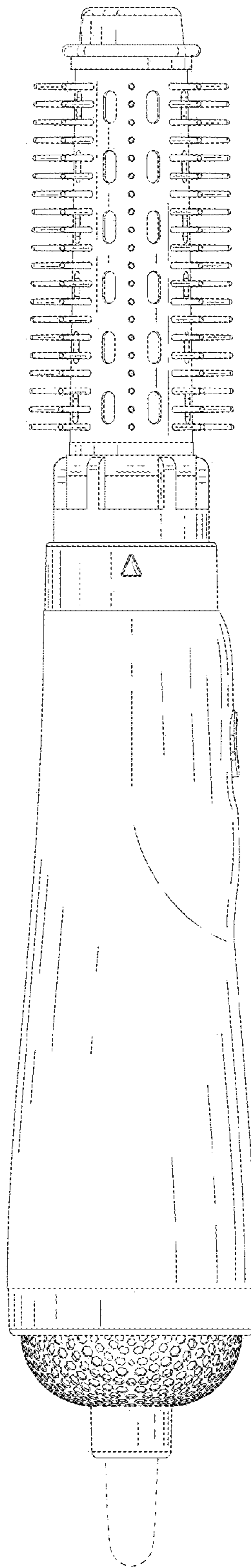

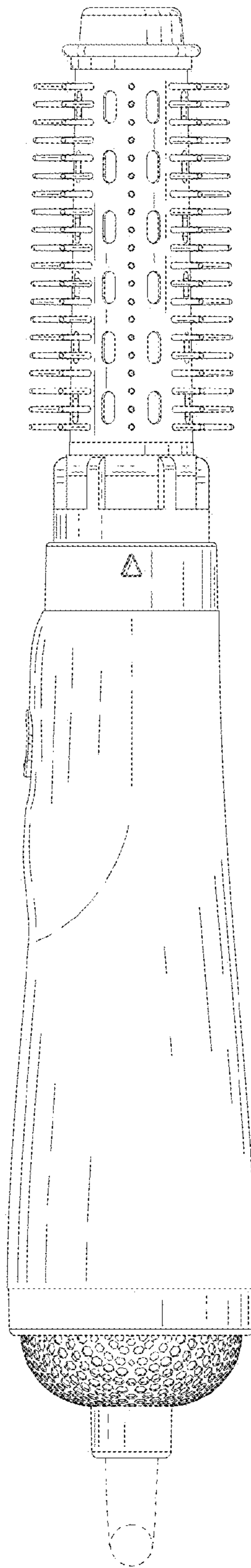

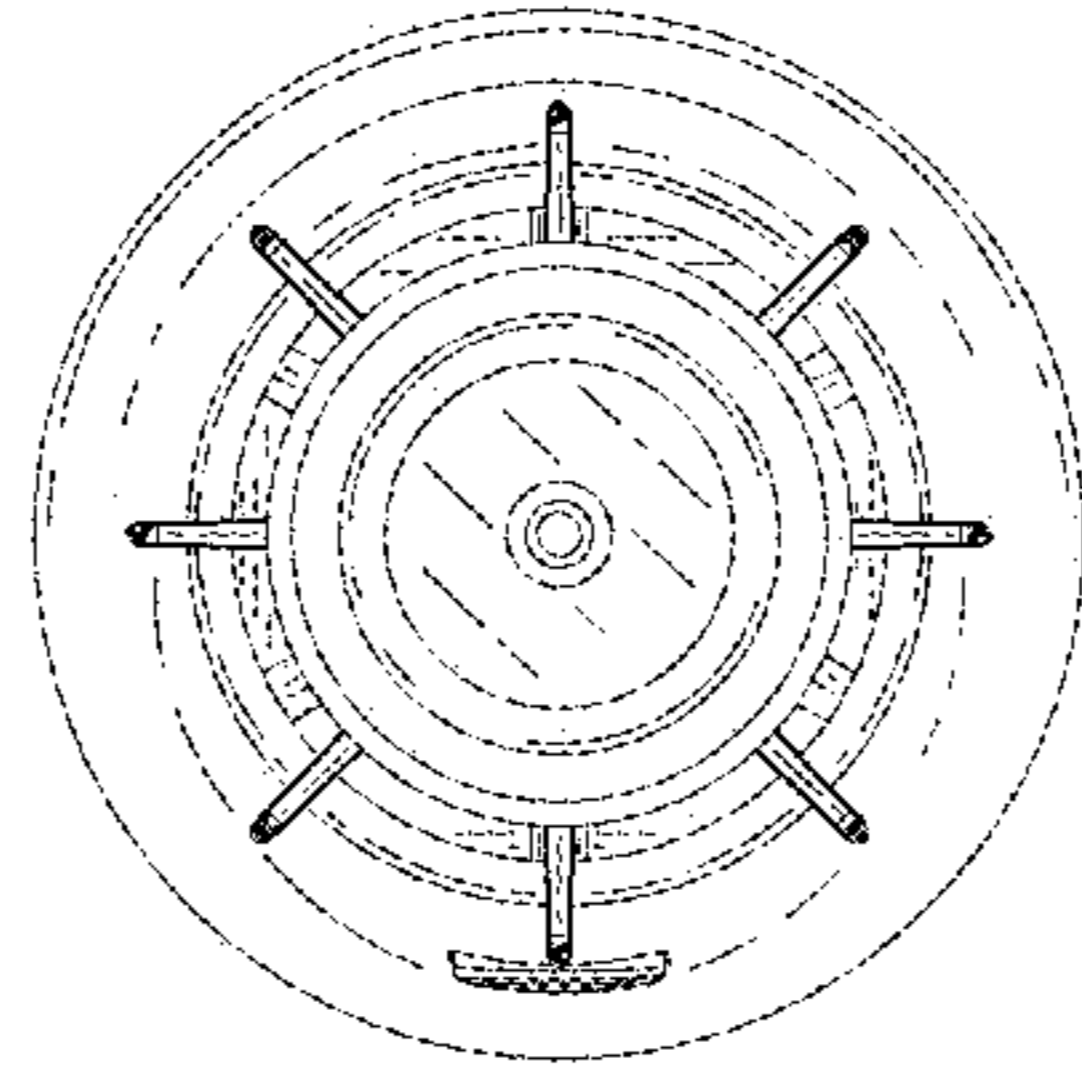

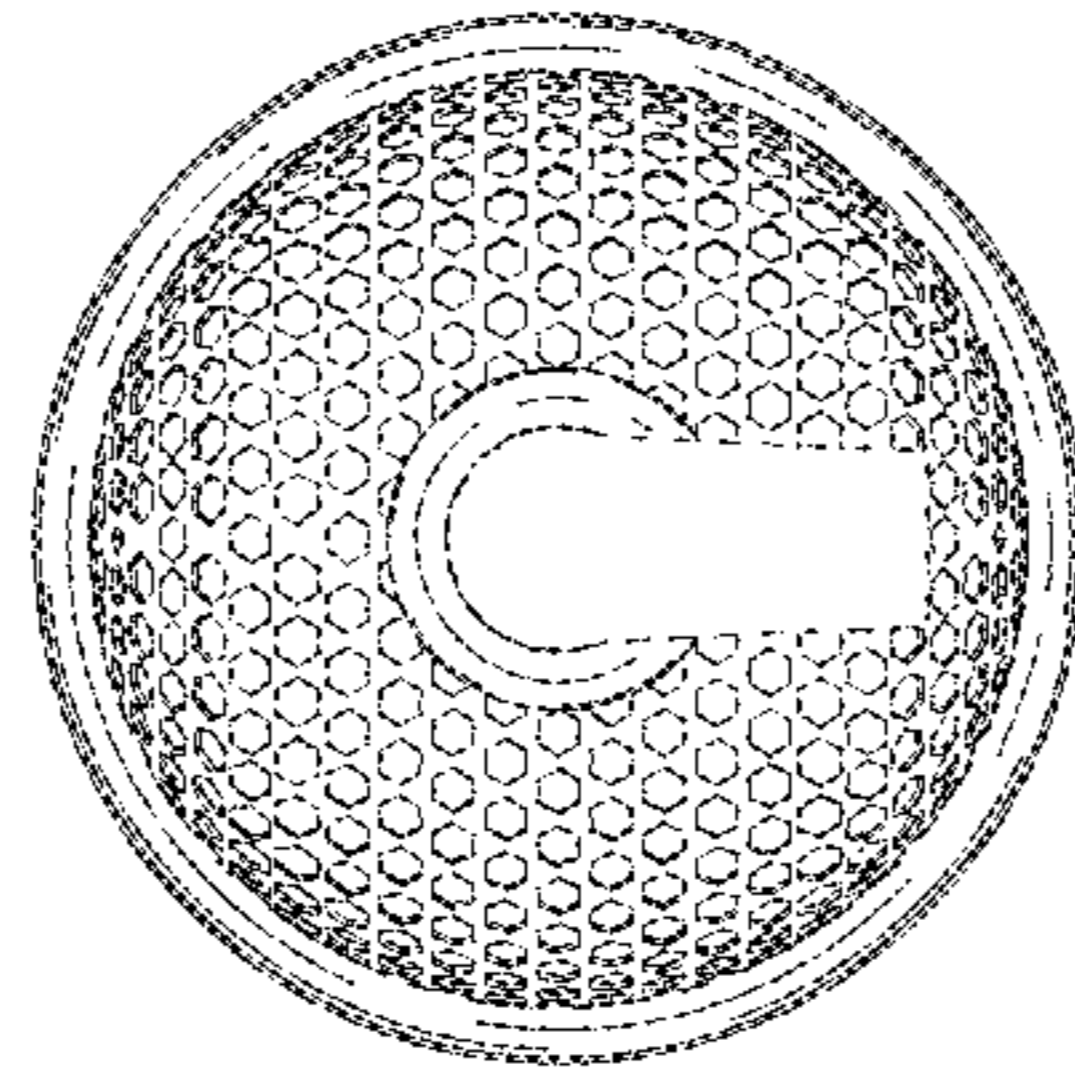

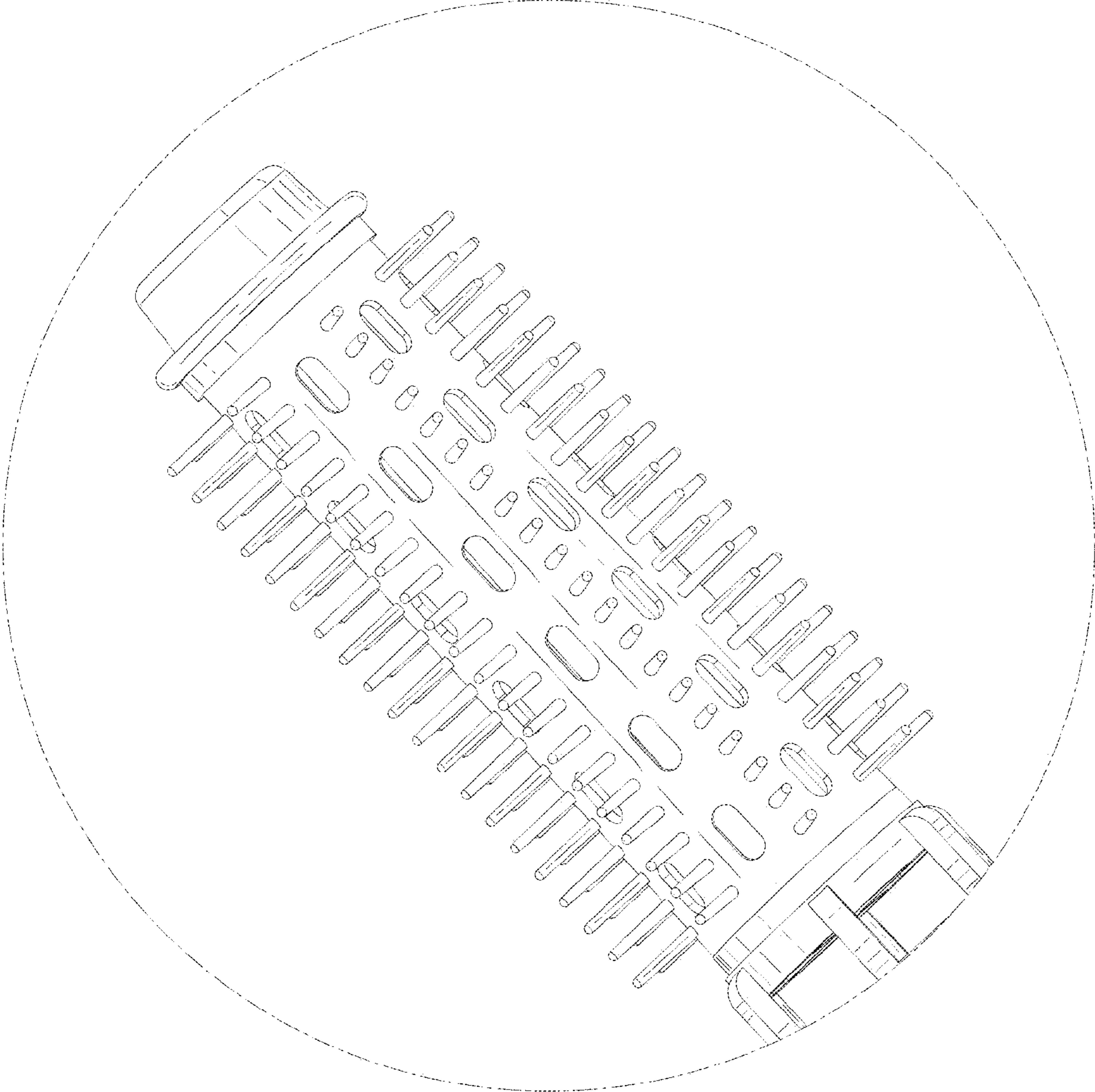

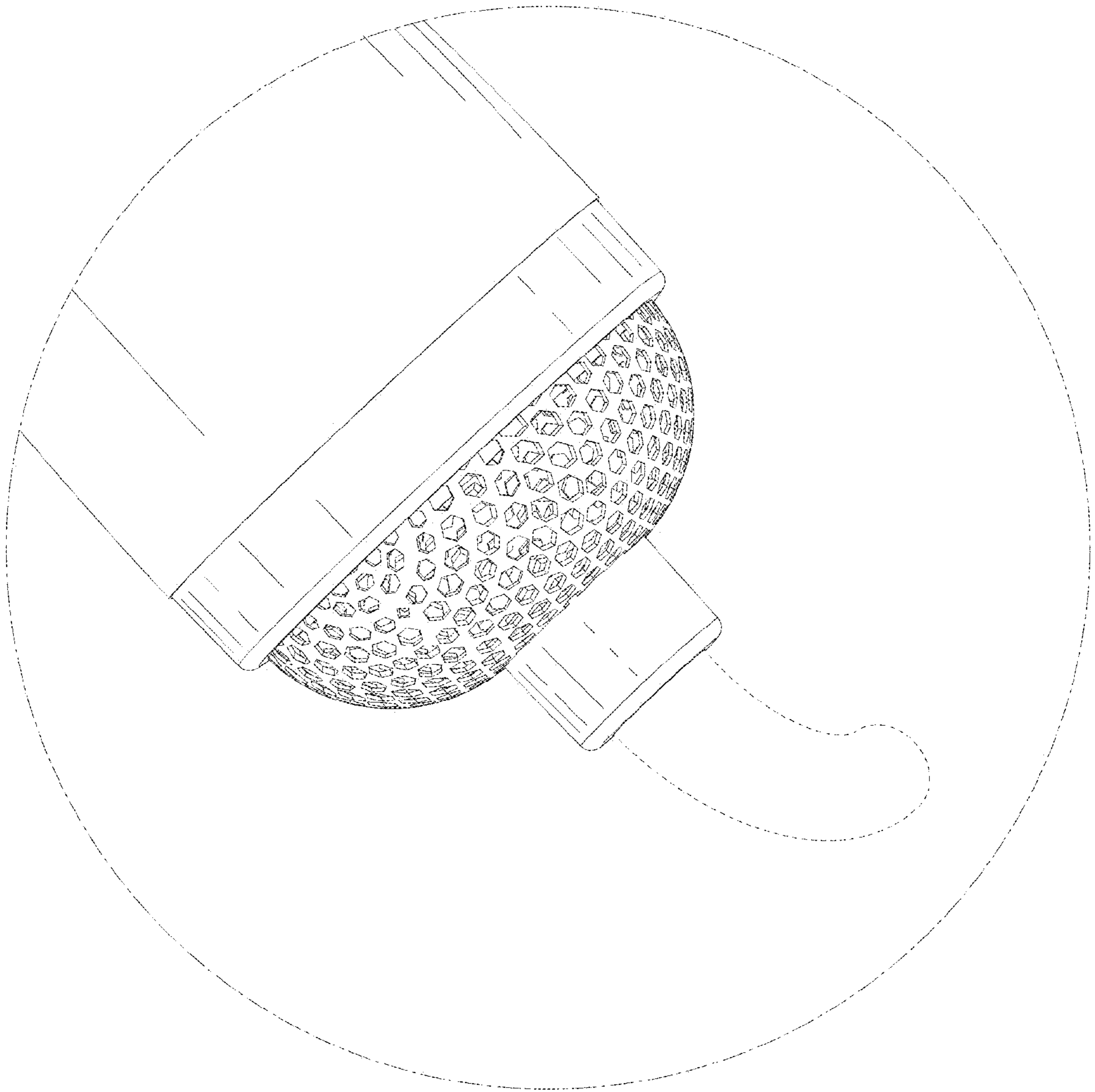
