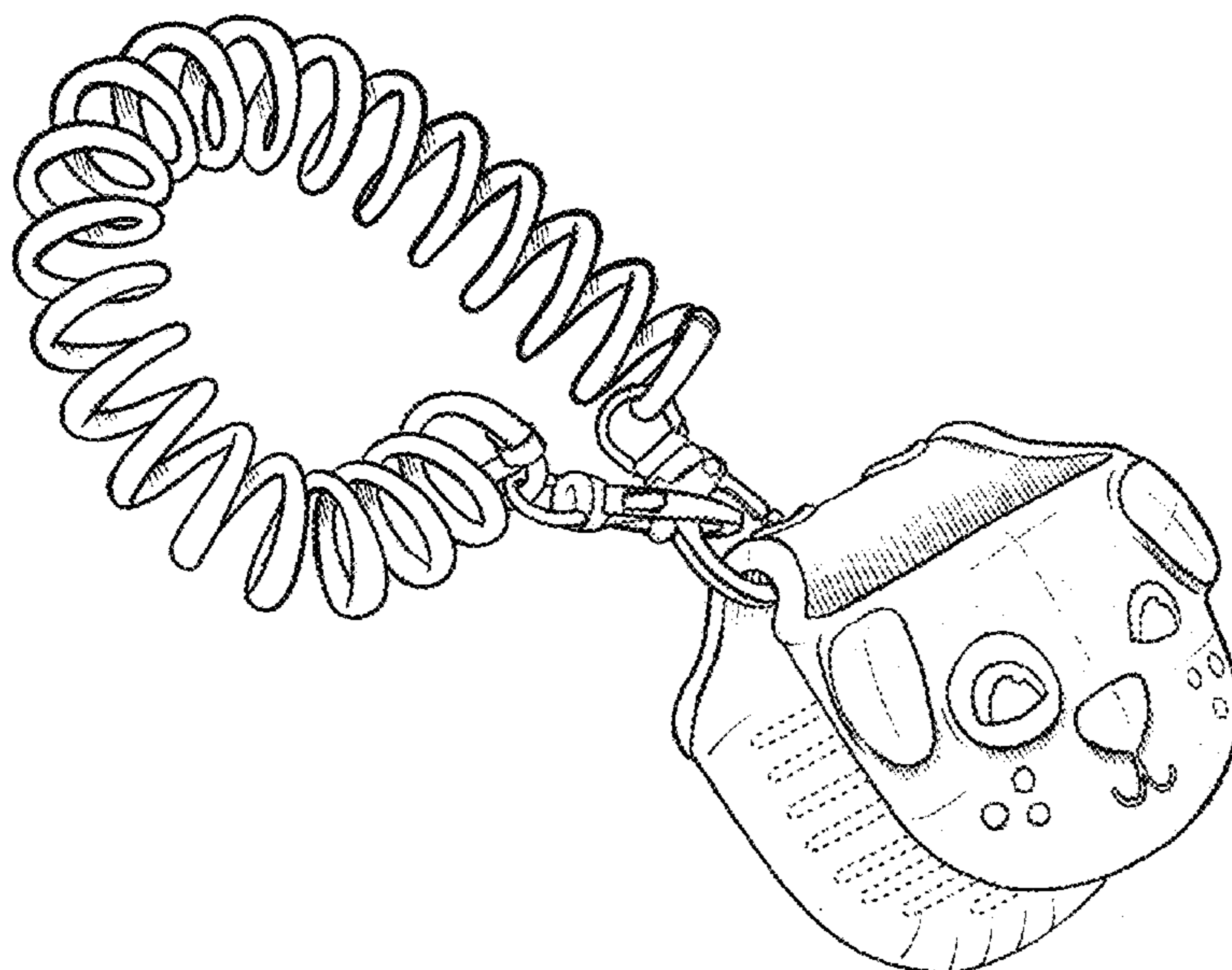
The ornamental design for a finger mitt, as shown and described.

DESCRIPTION

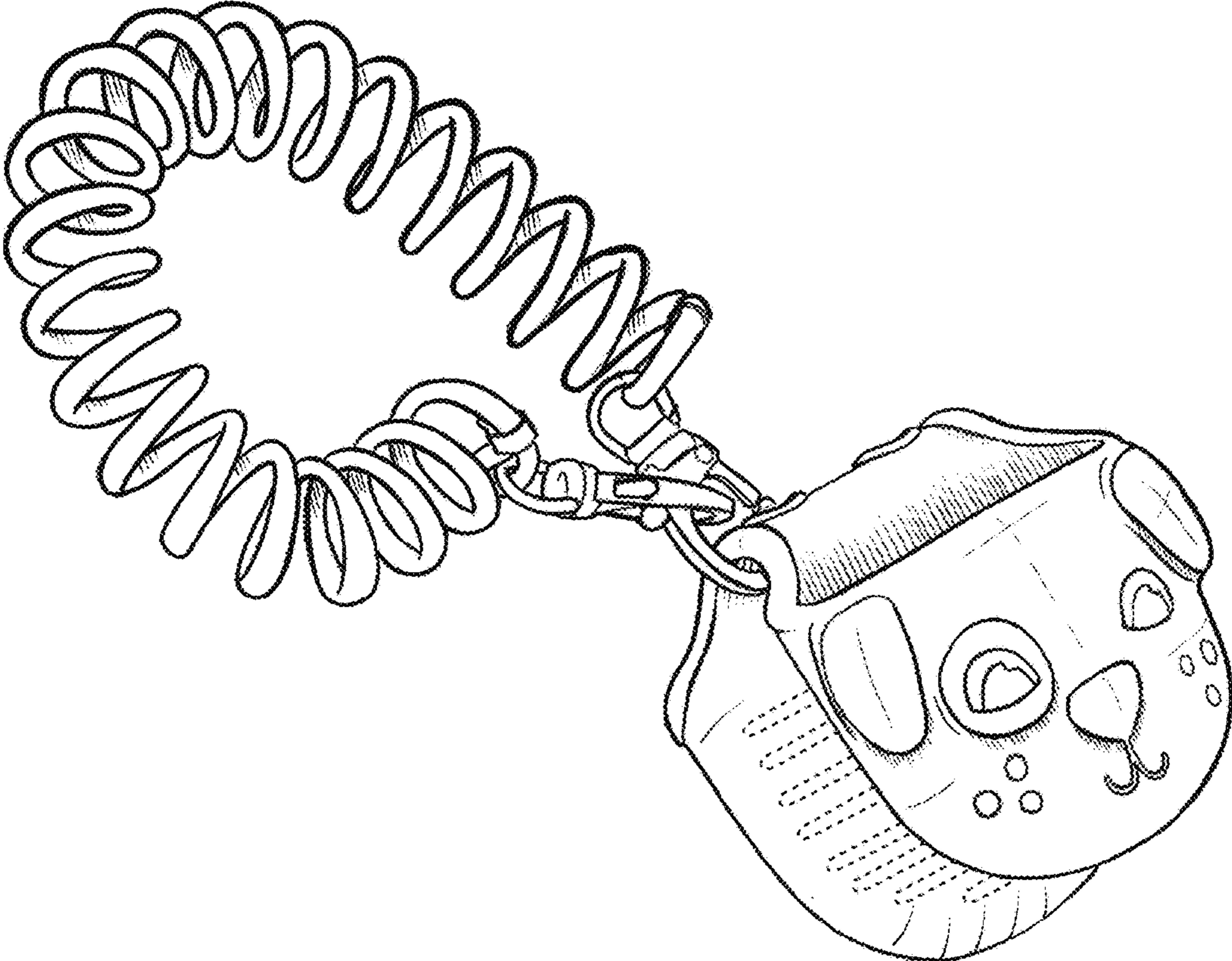

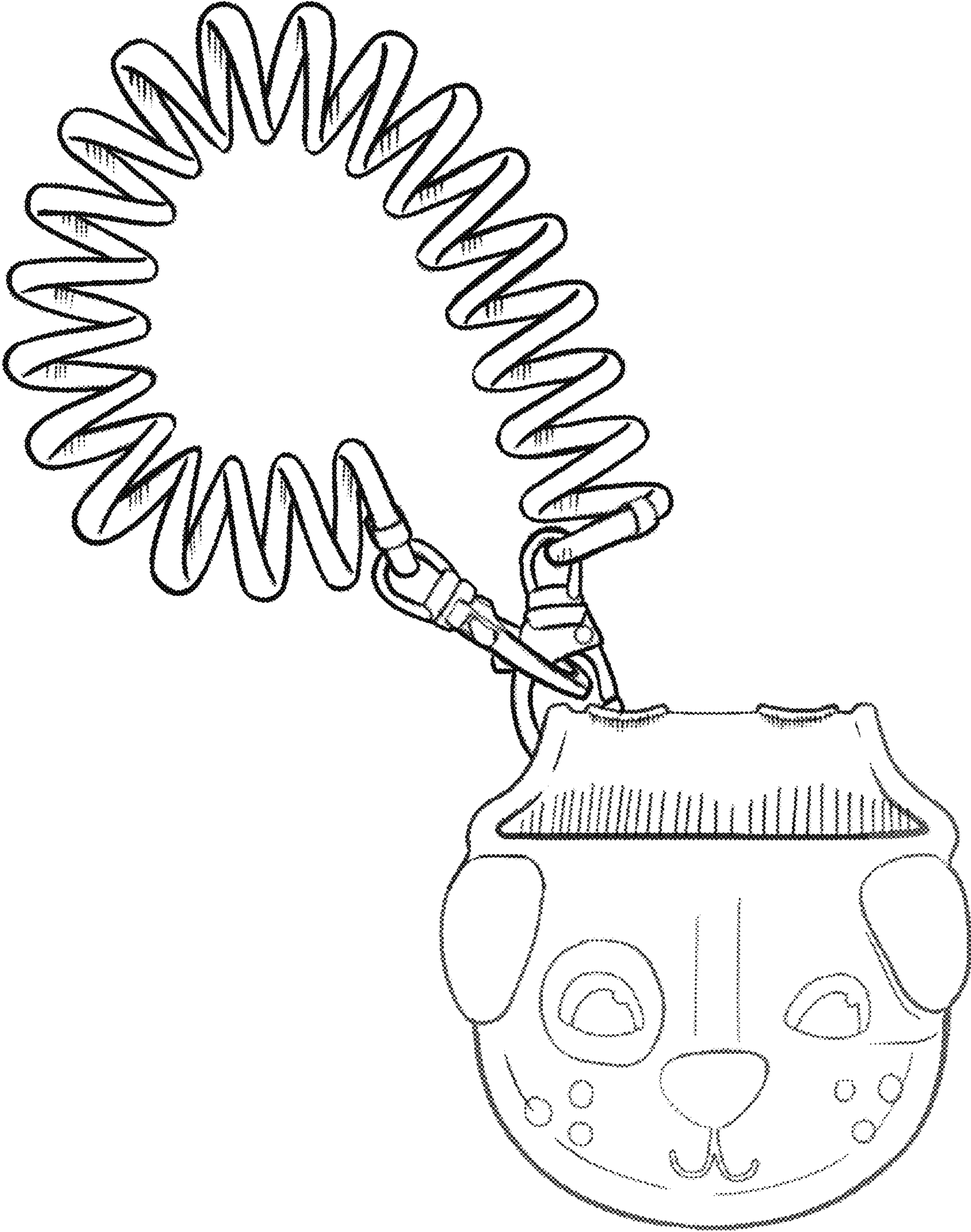

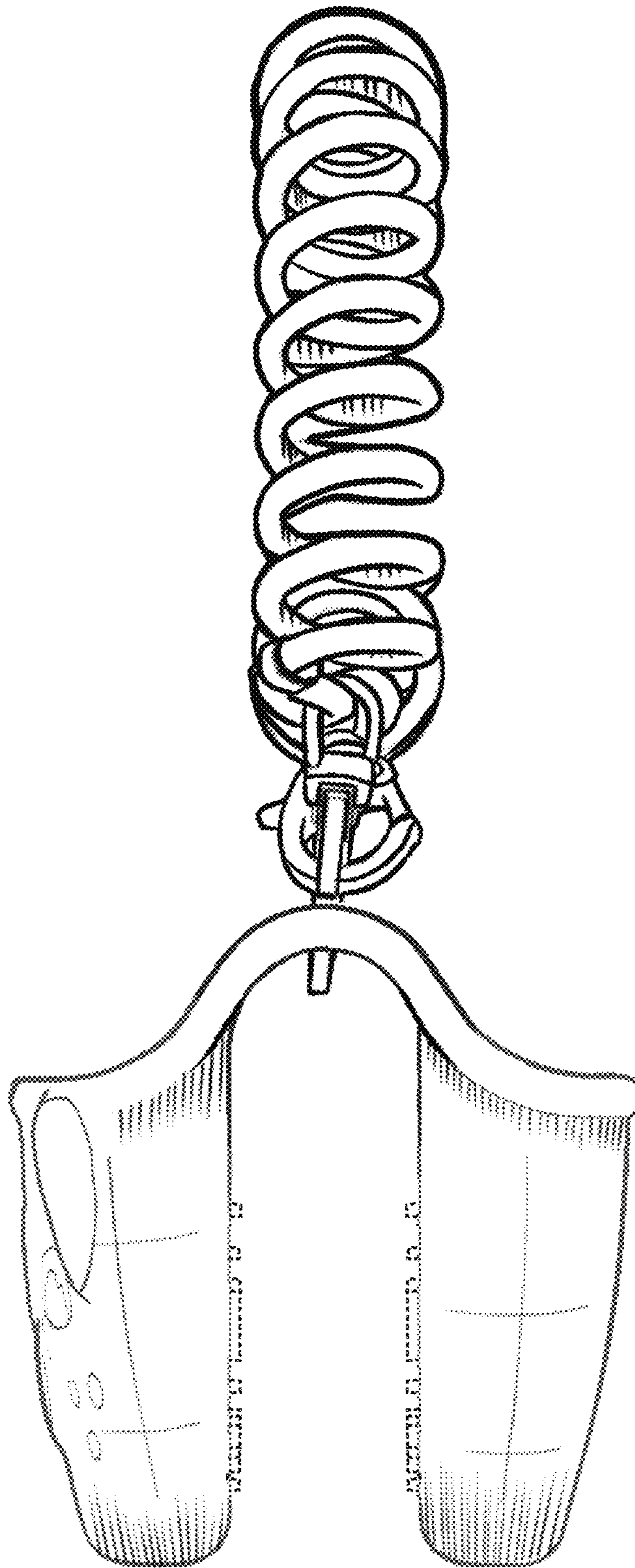

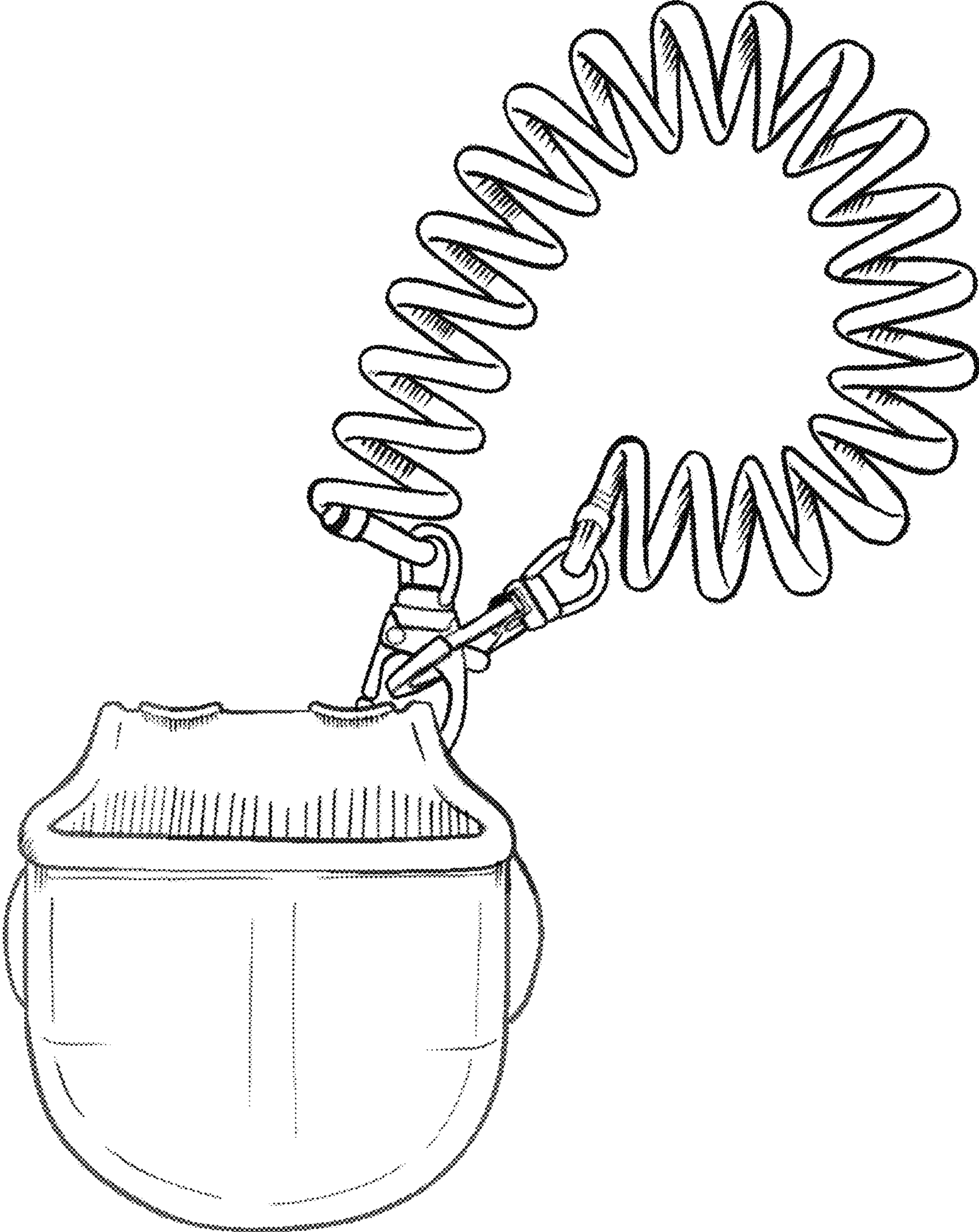

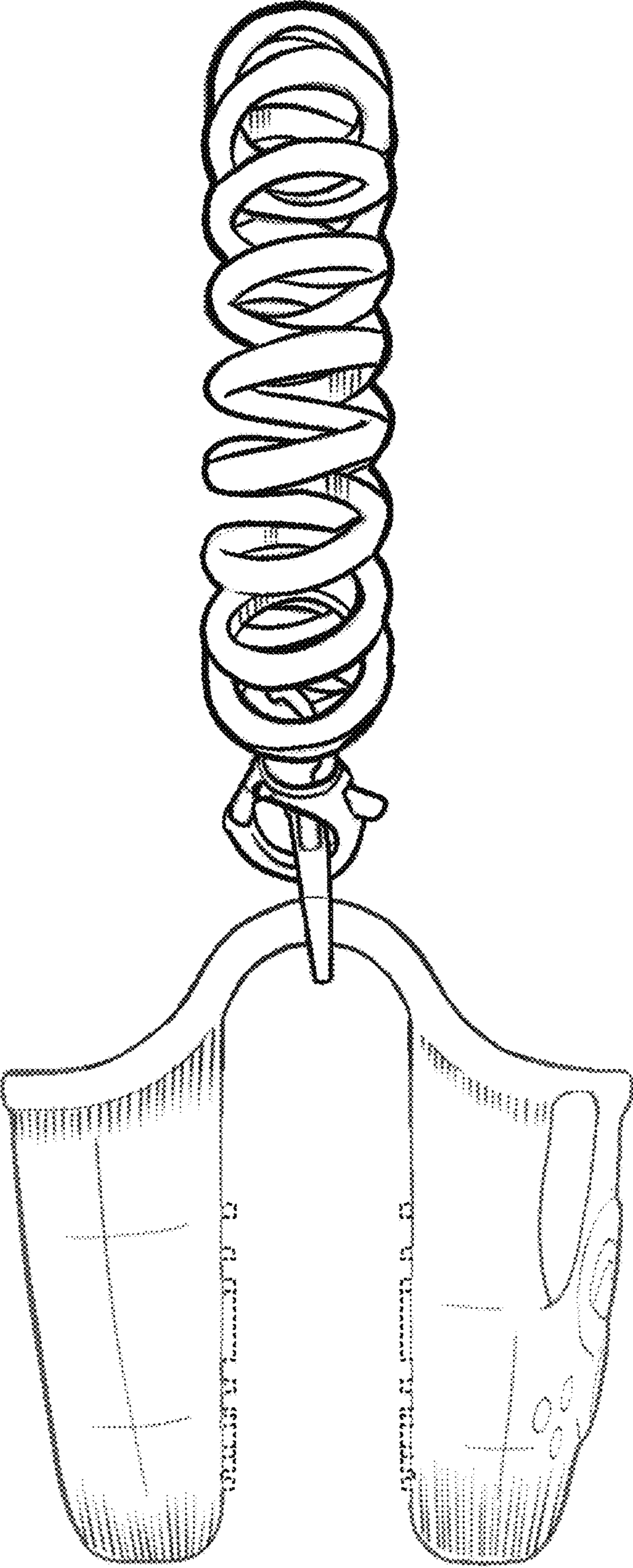

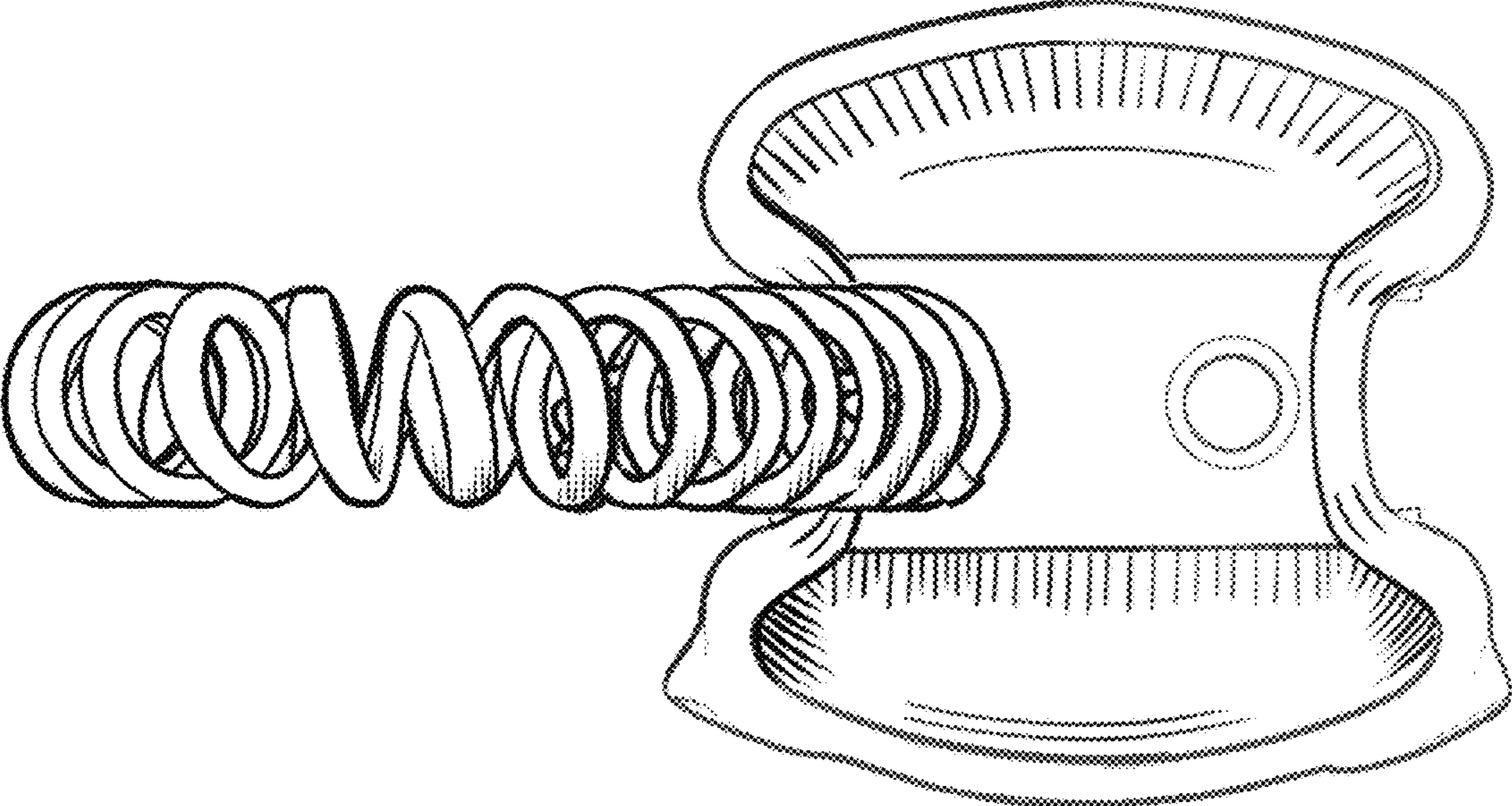
