FIG. 13 is a front exterior view of underwear in accordance with the present invention shown in a fourth embodiment.

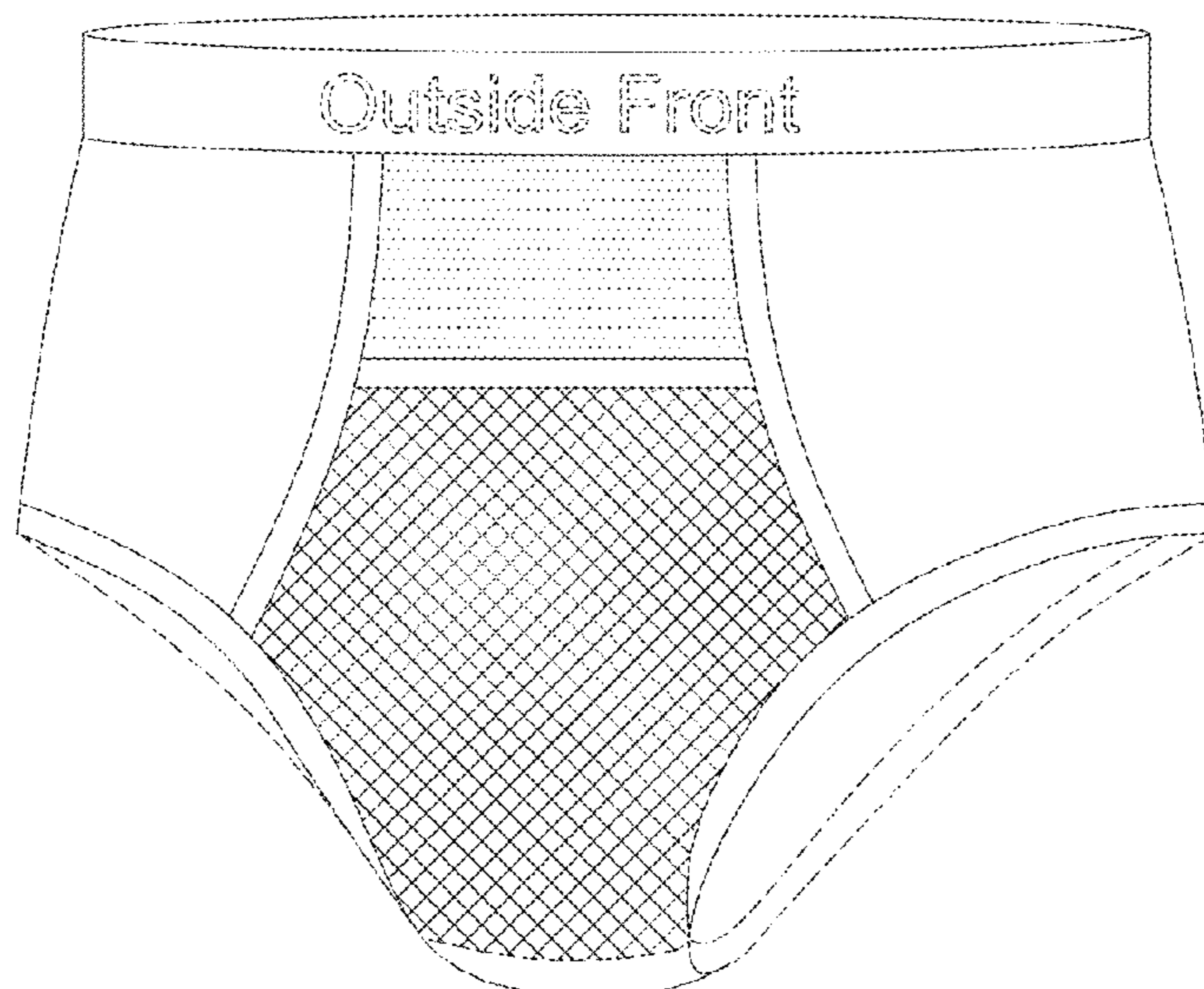
FIG. 14 is a front interior view thereof.

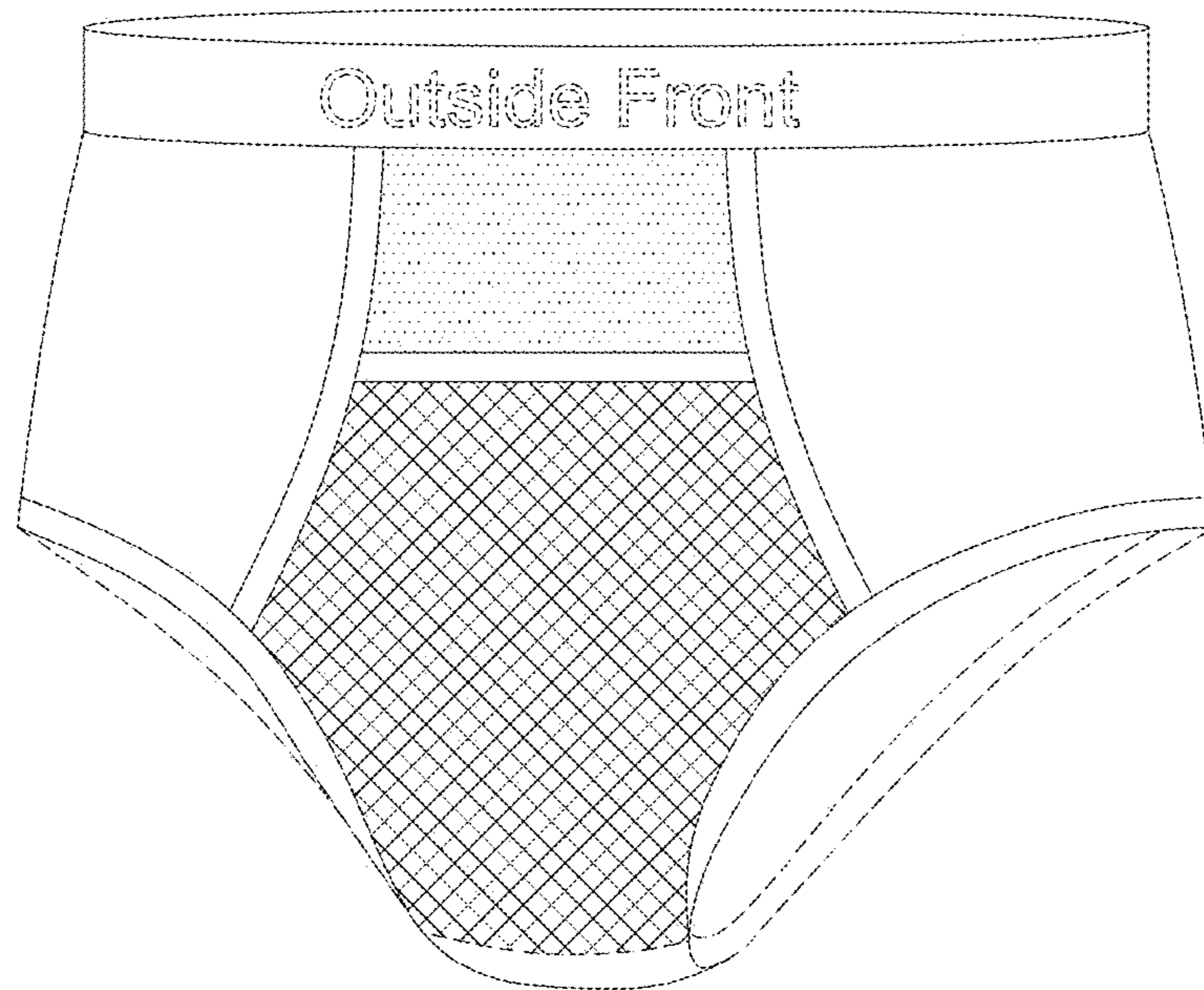

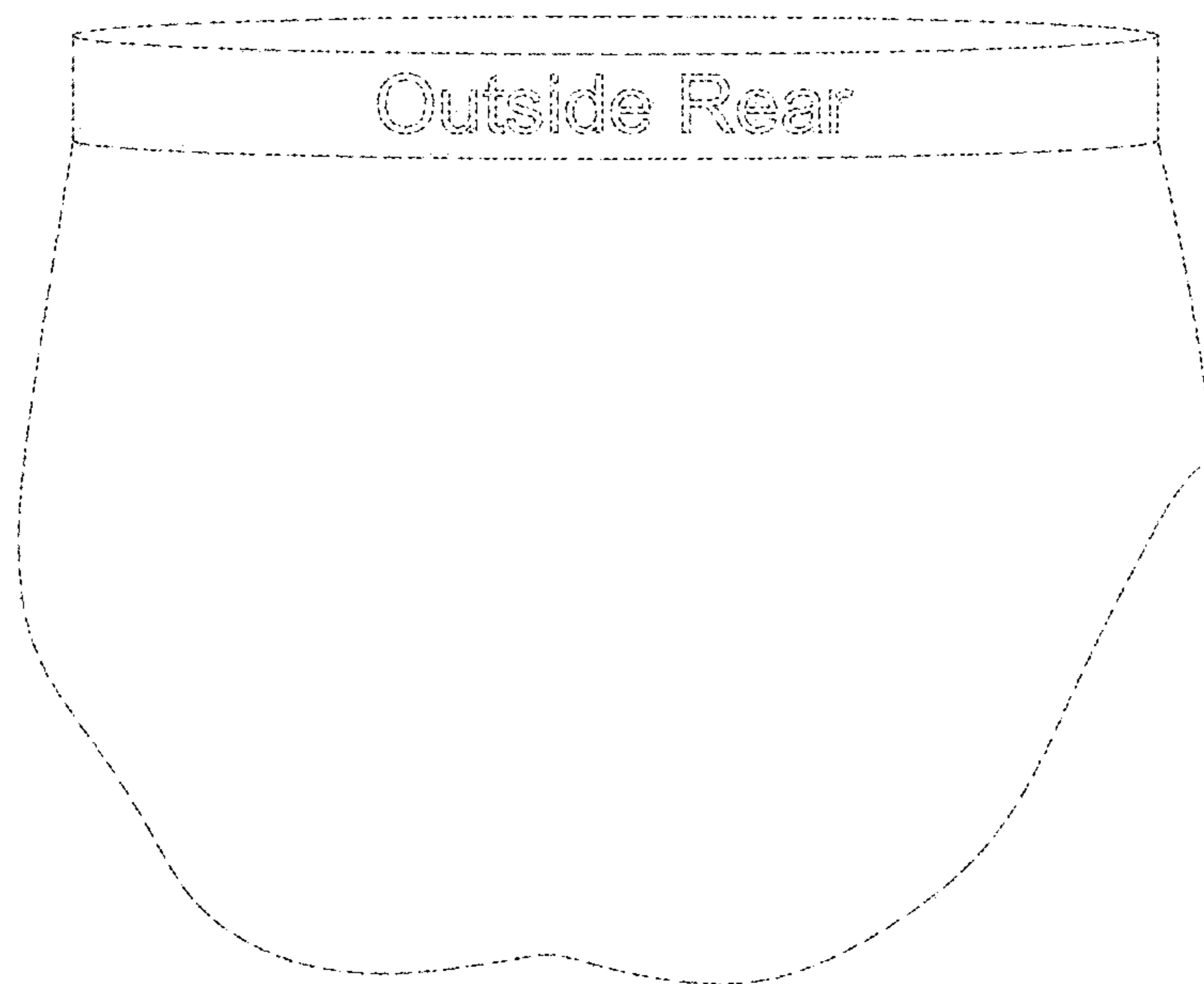

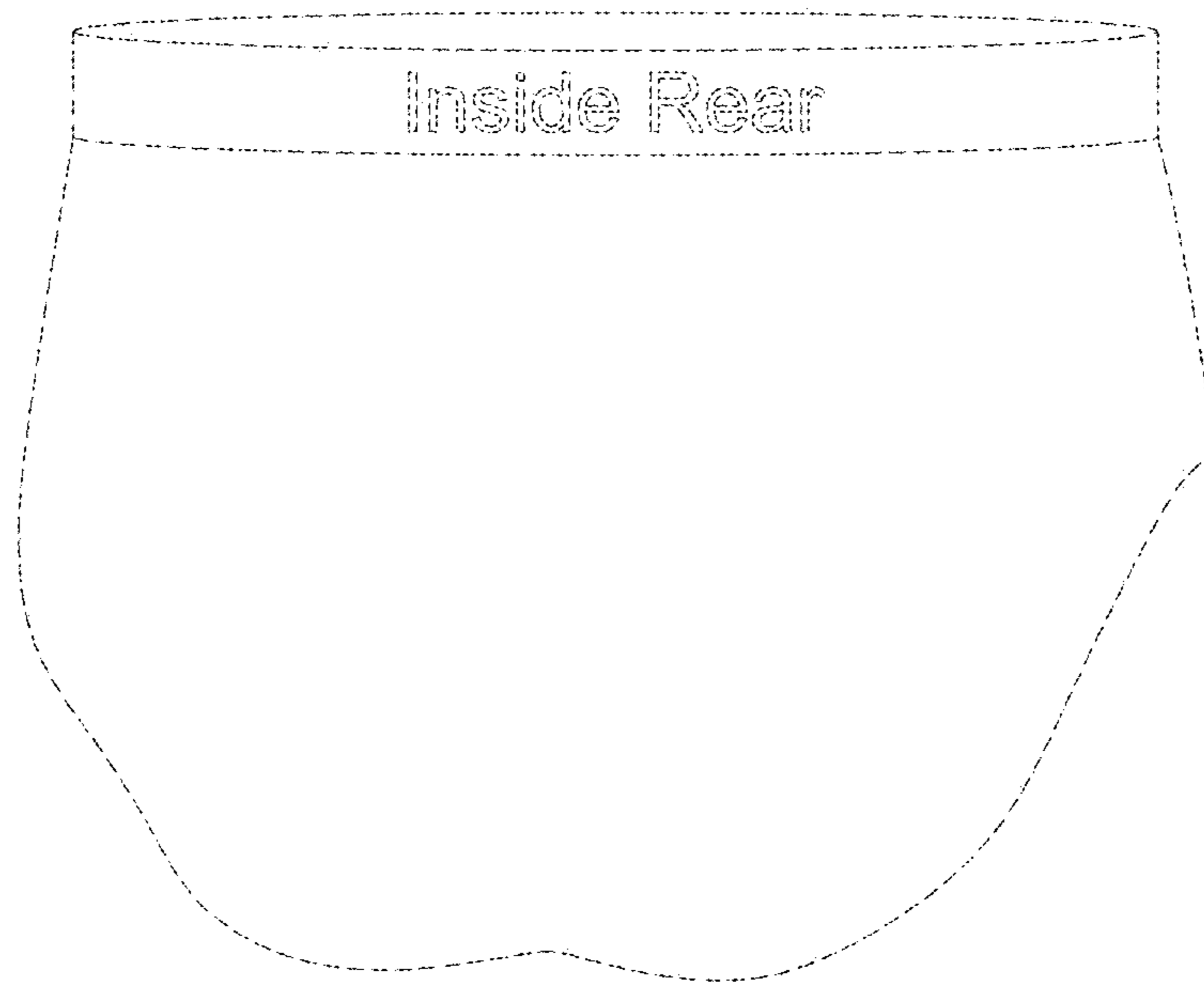

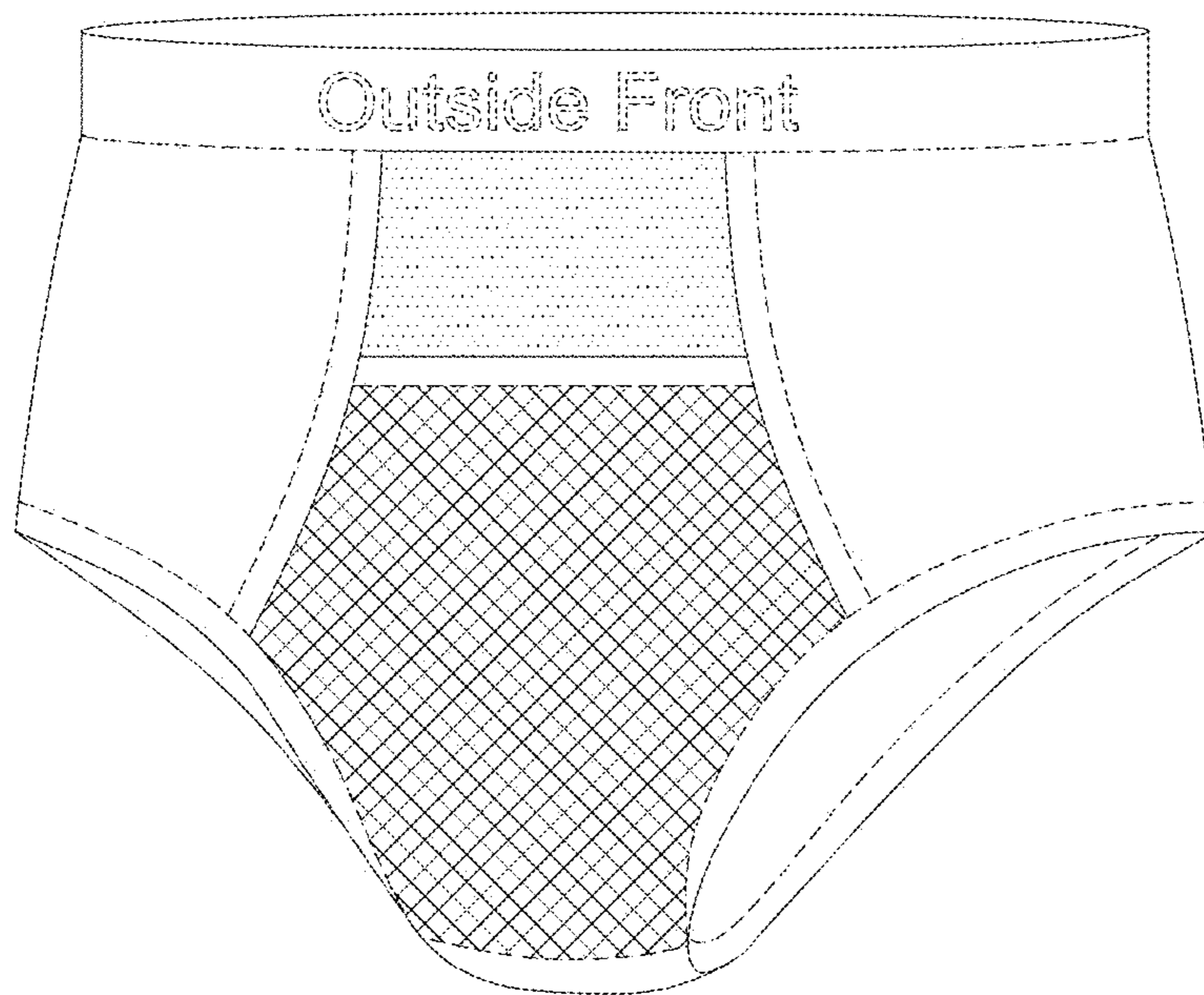

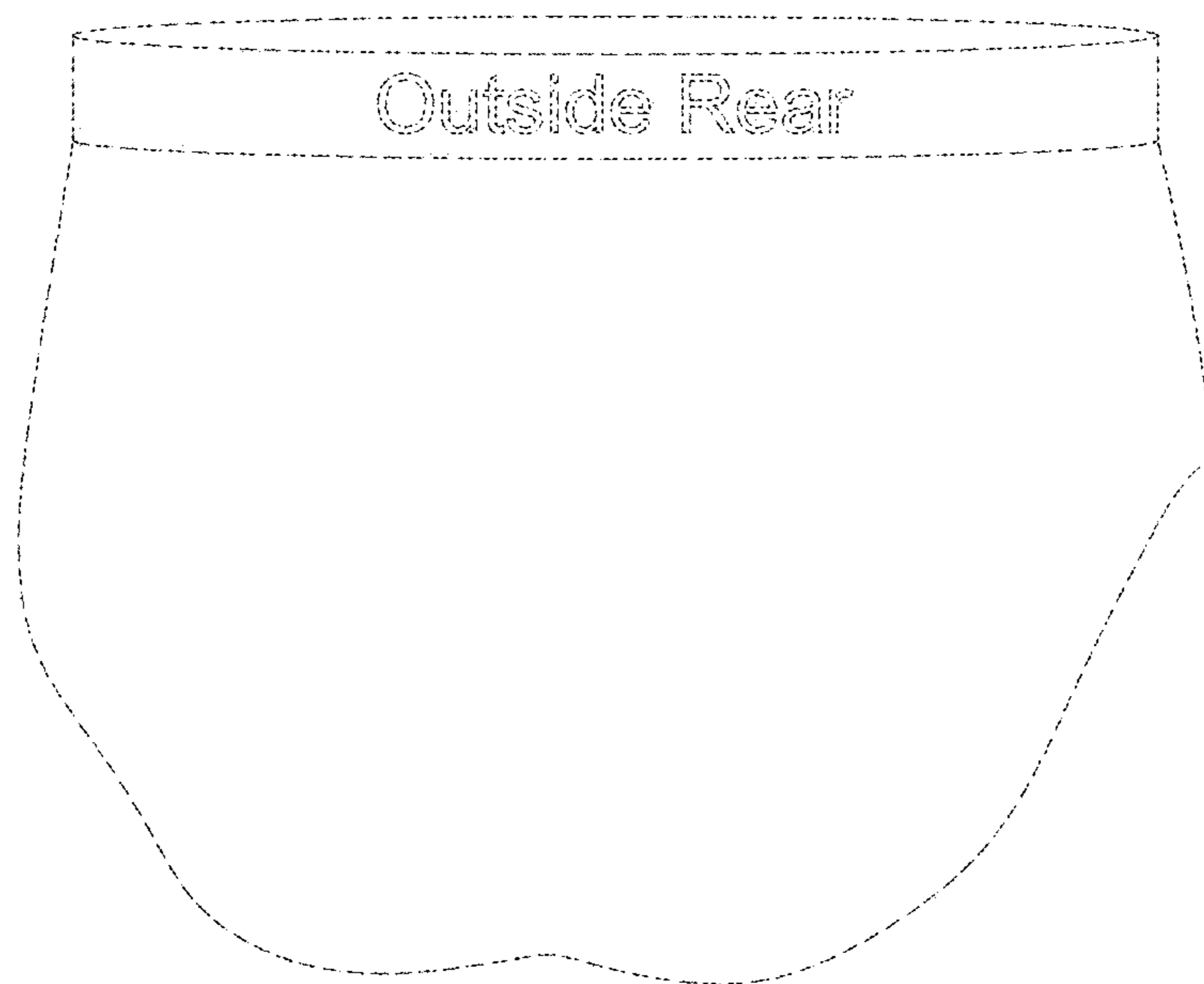

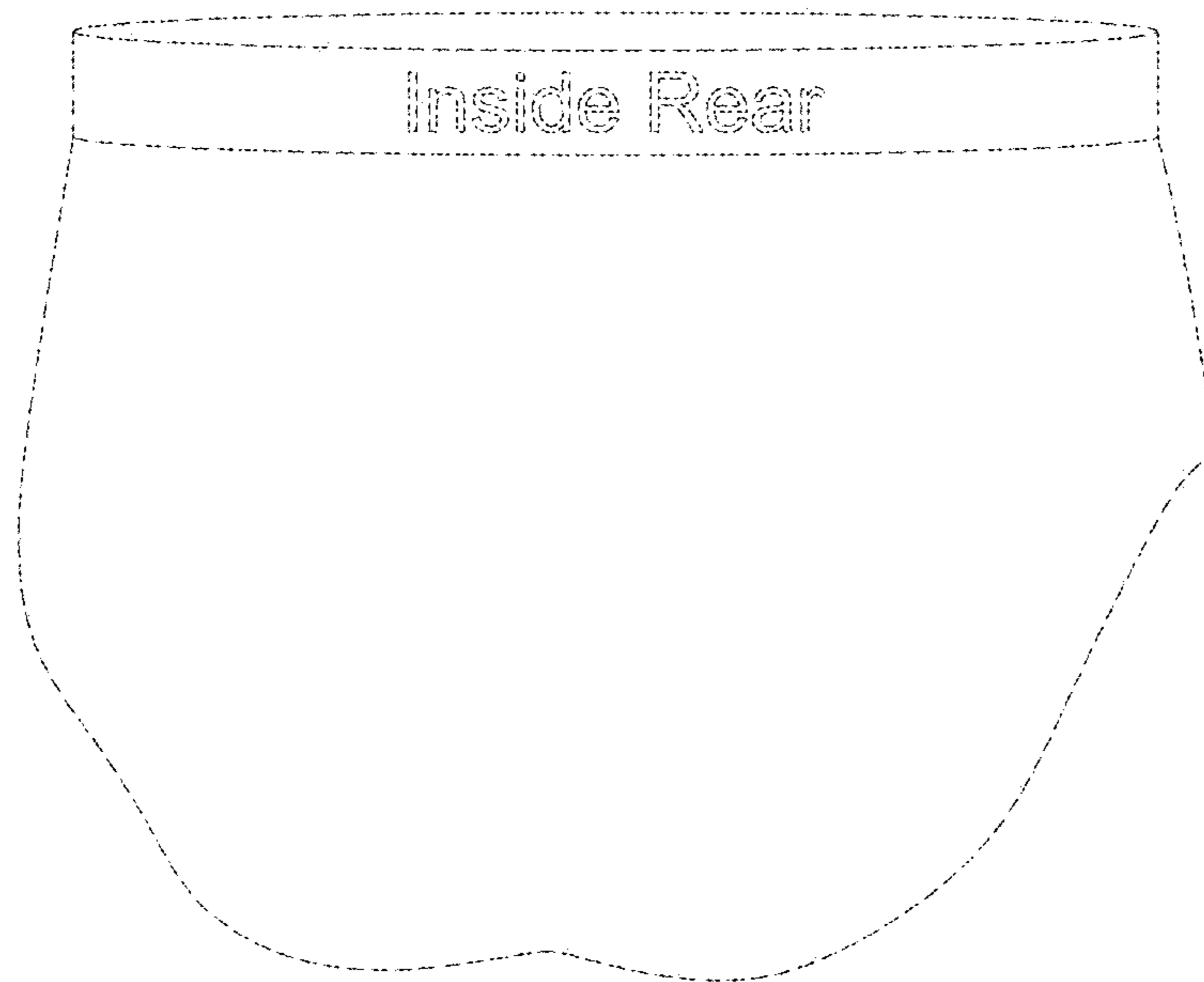

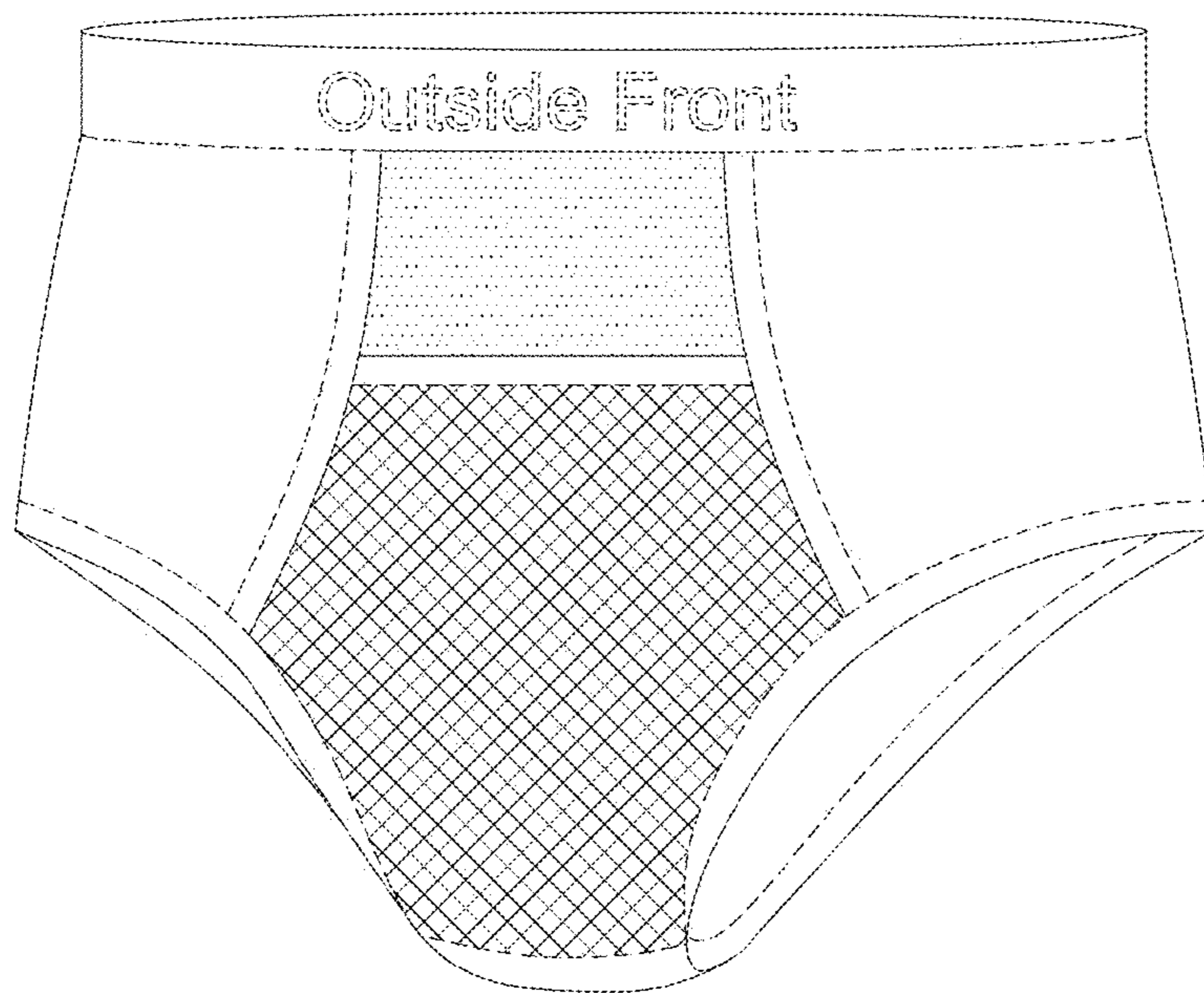

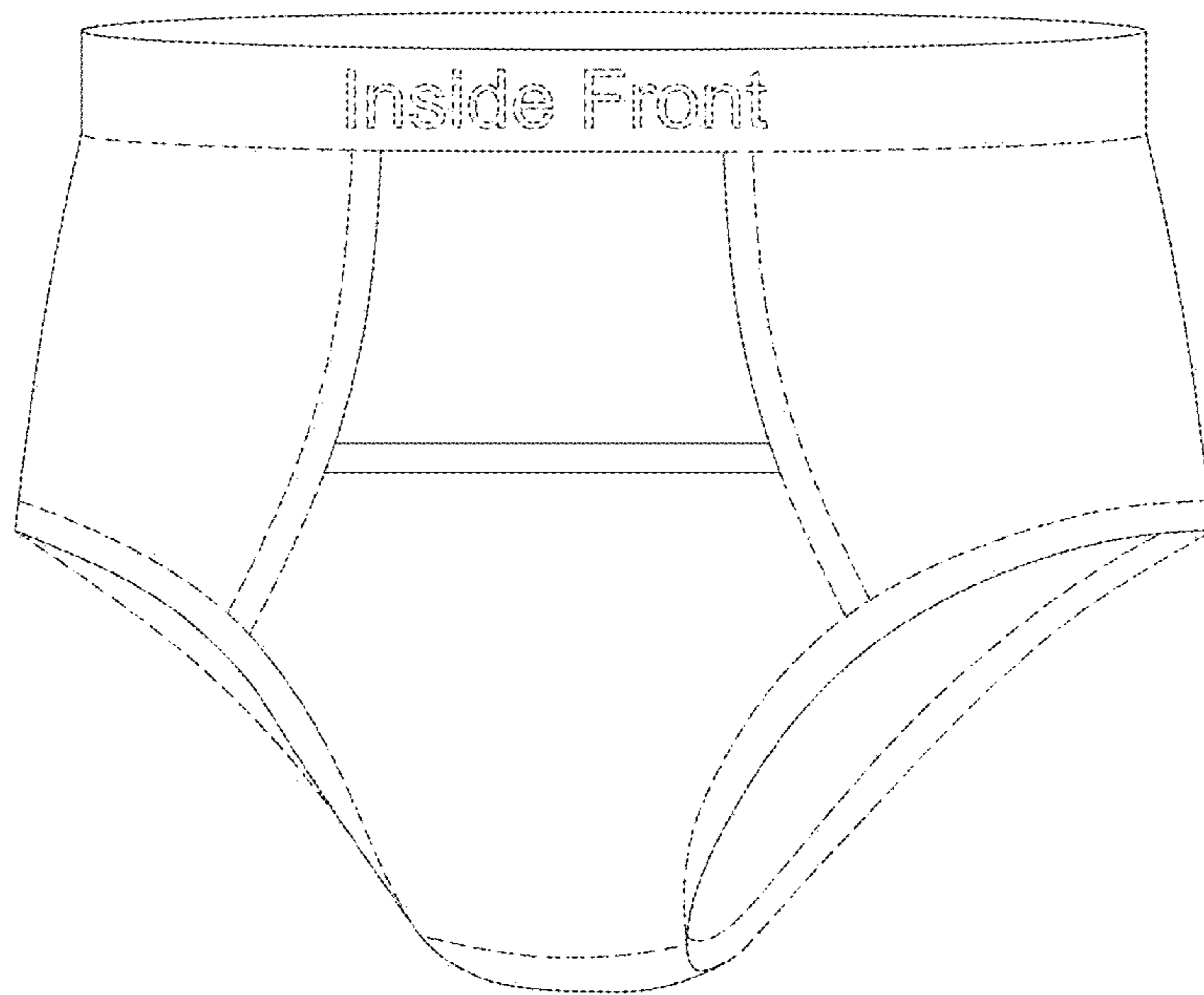

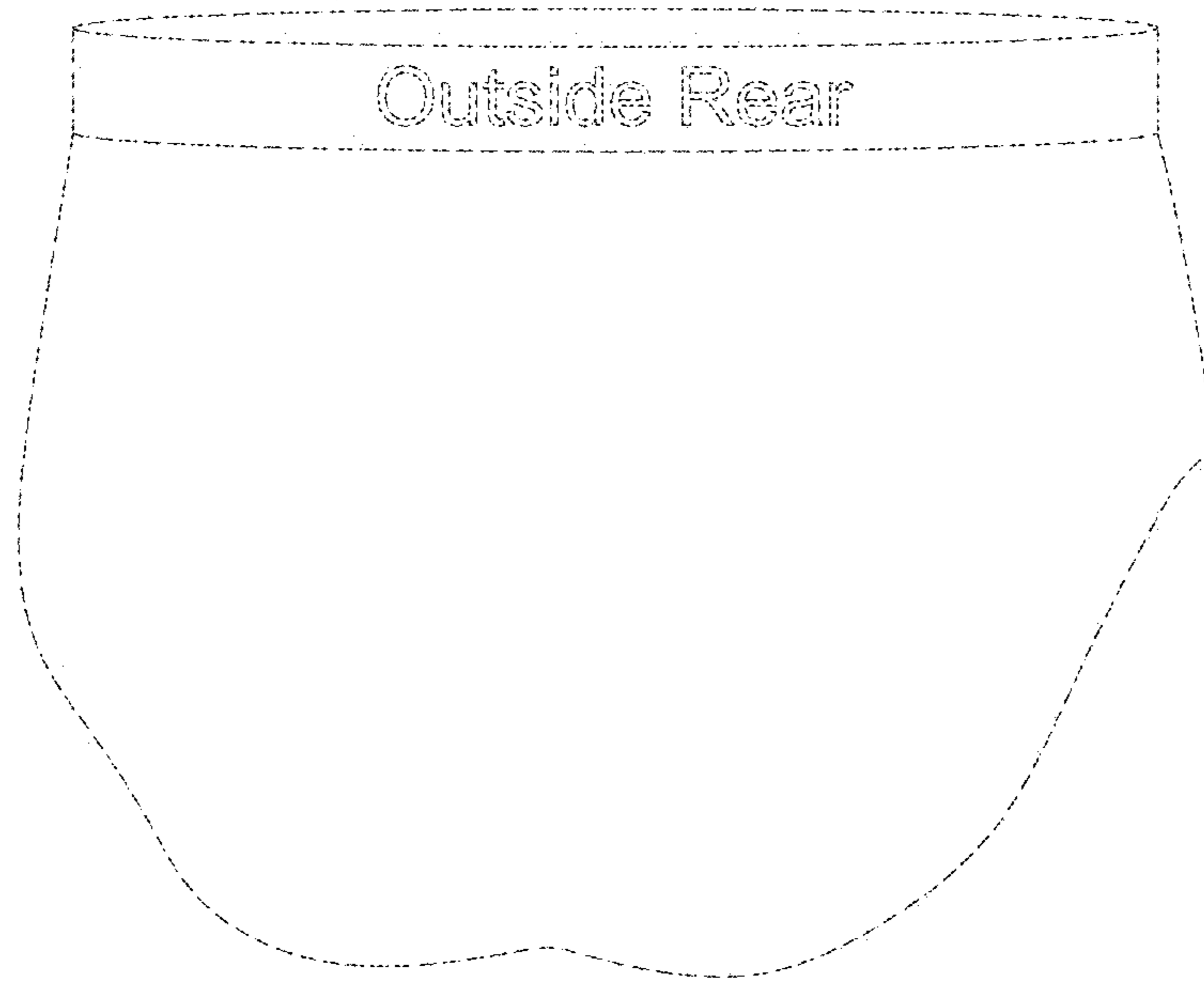

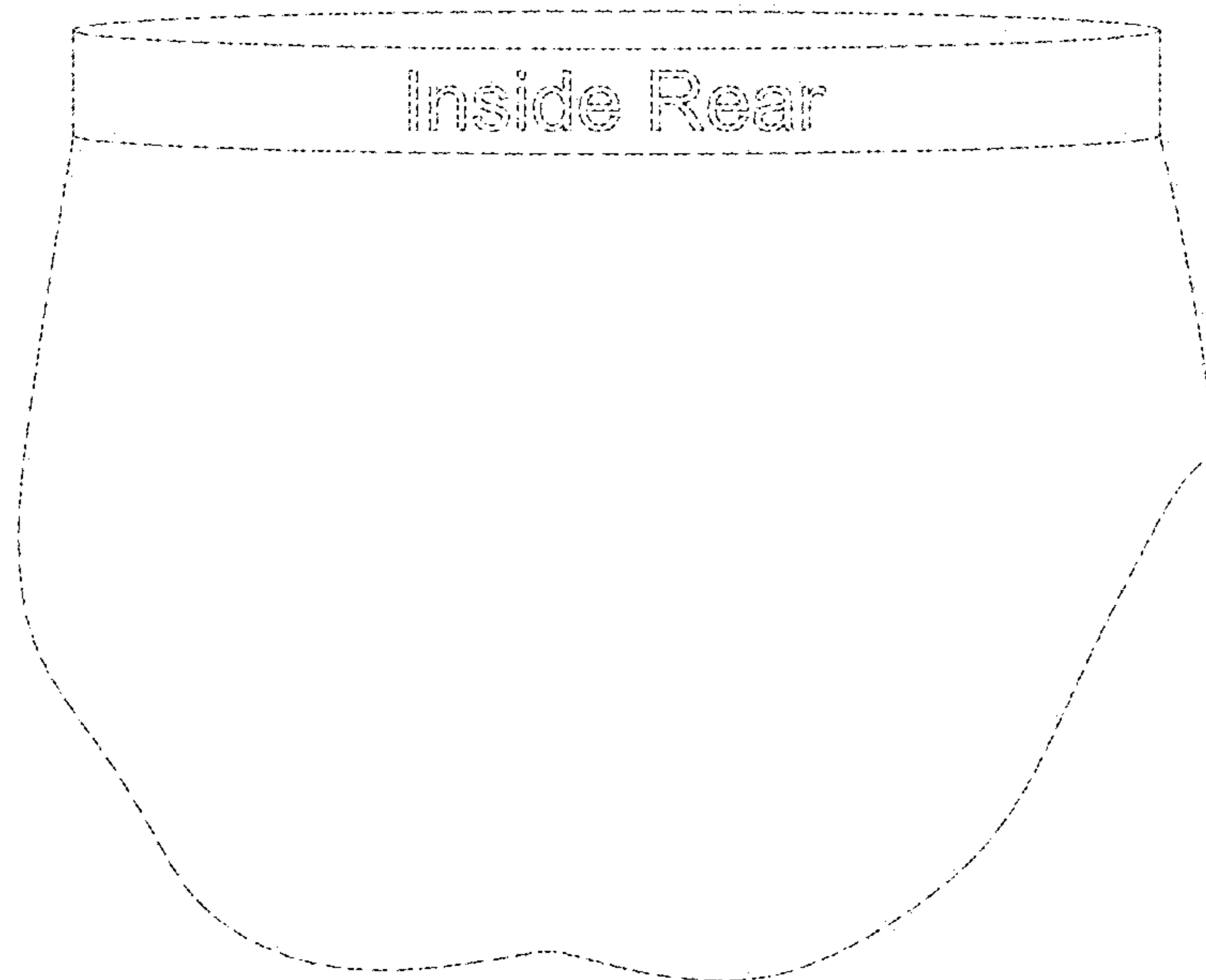

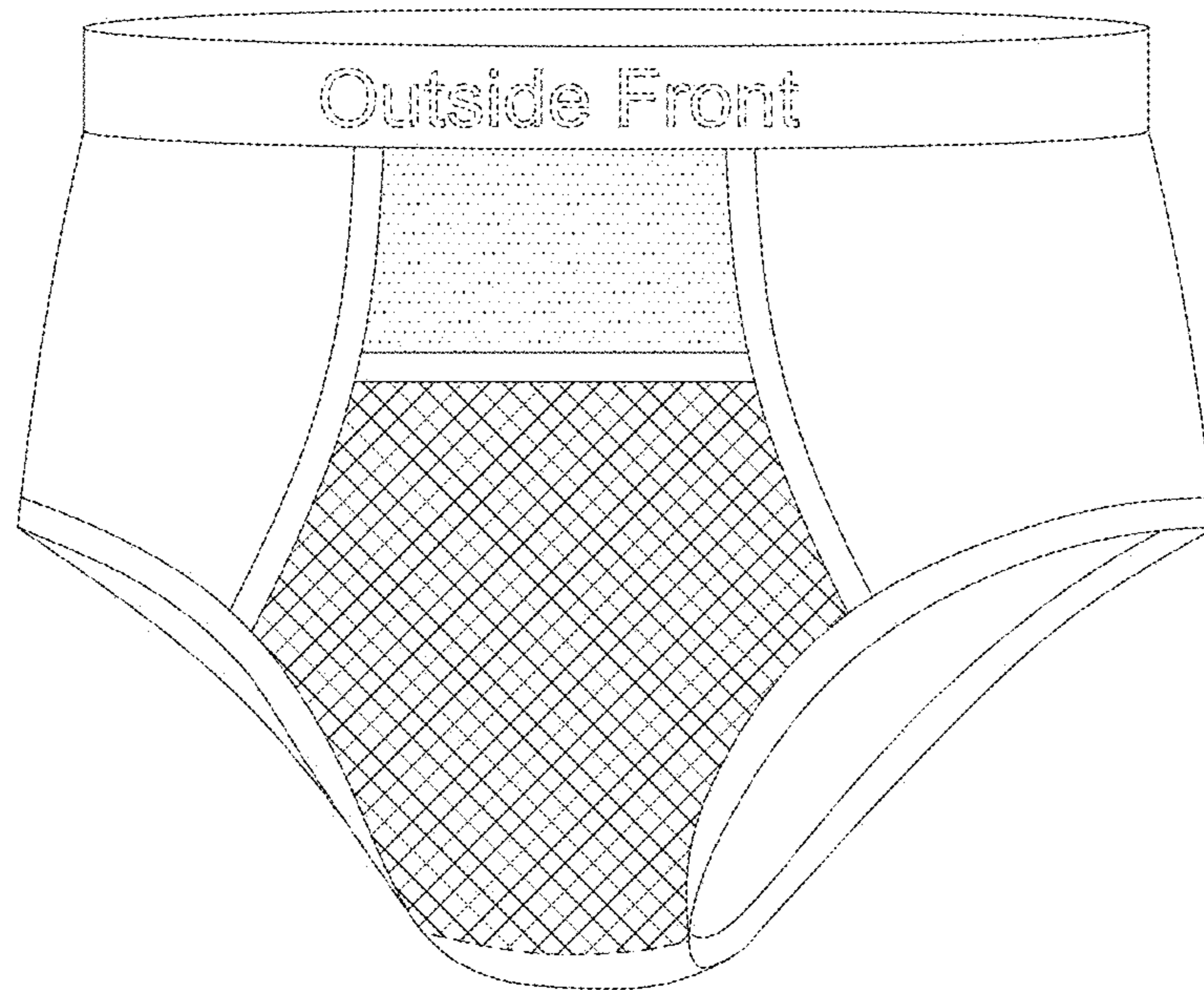

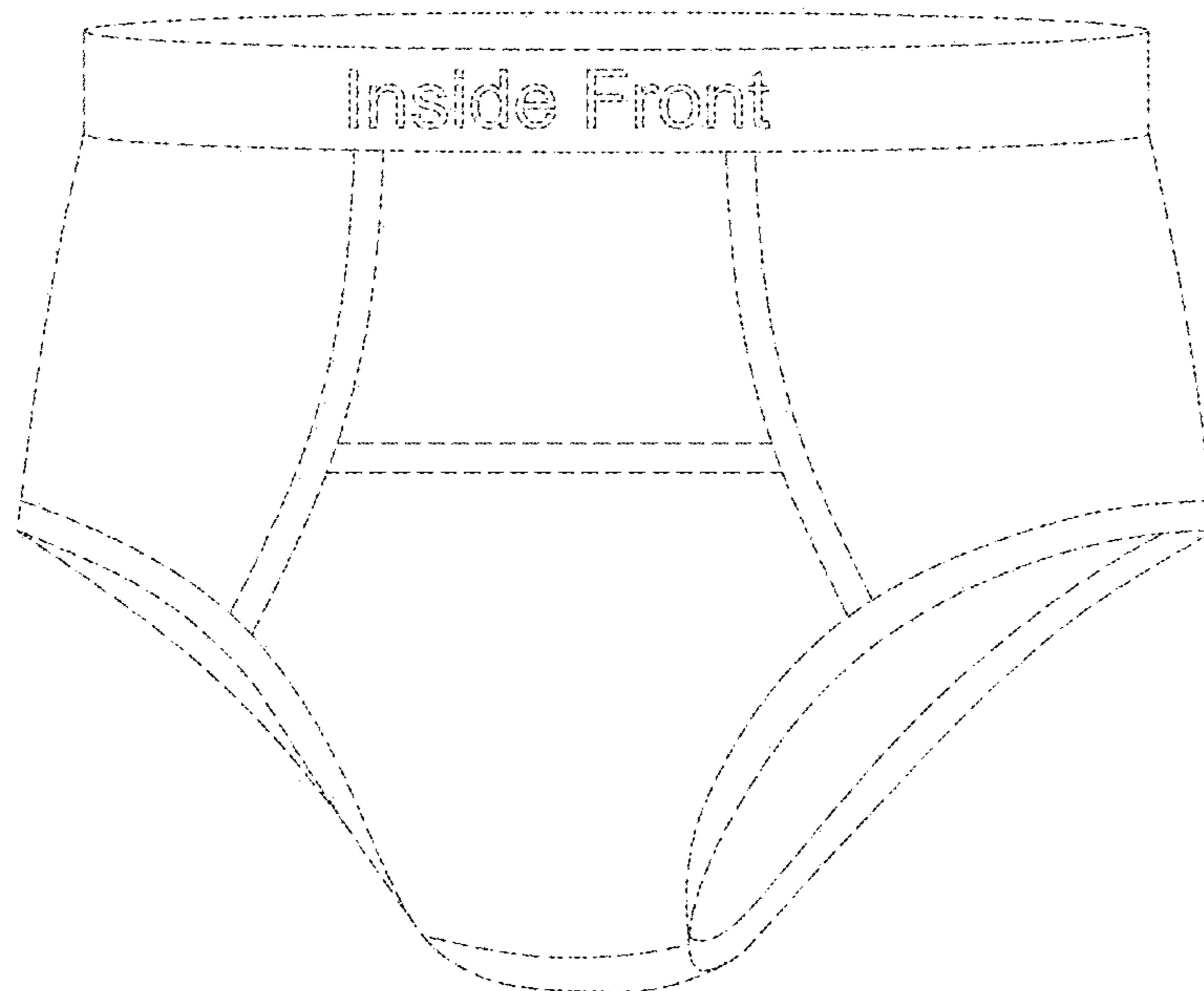

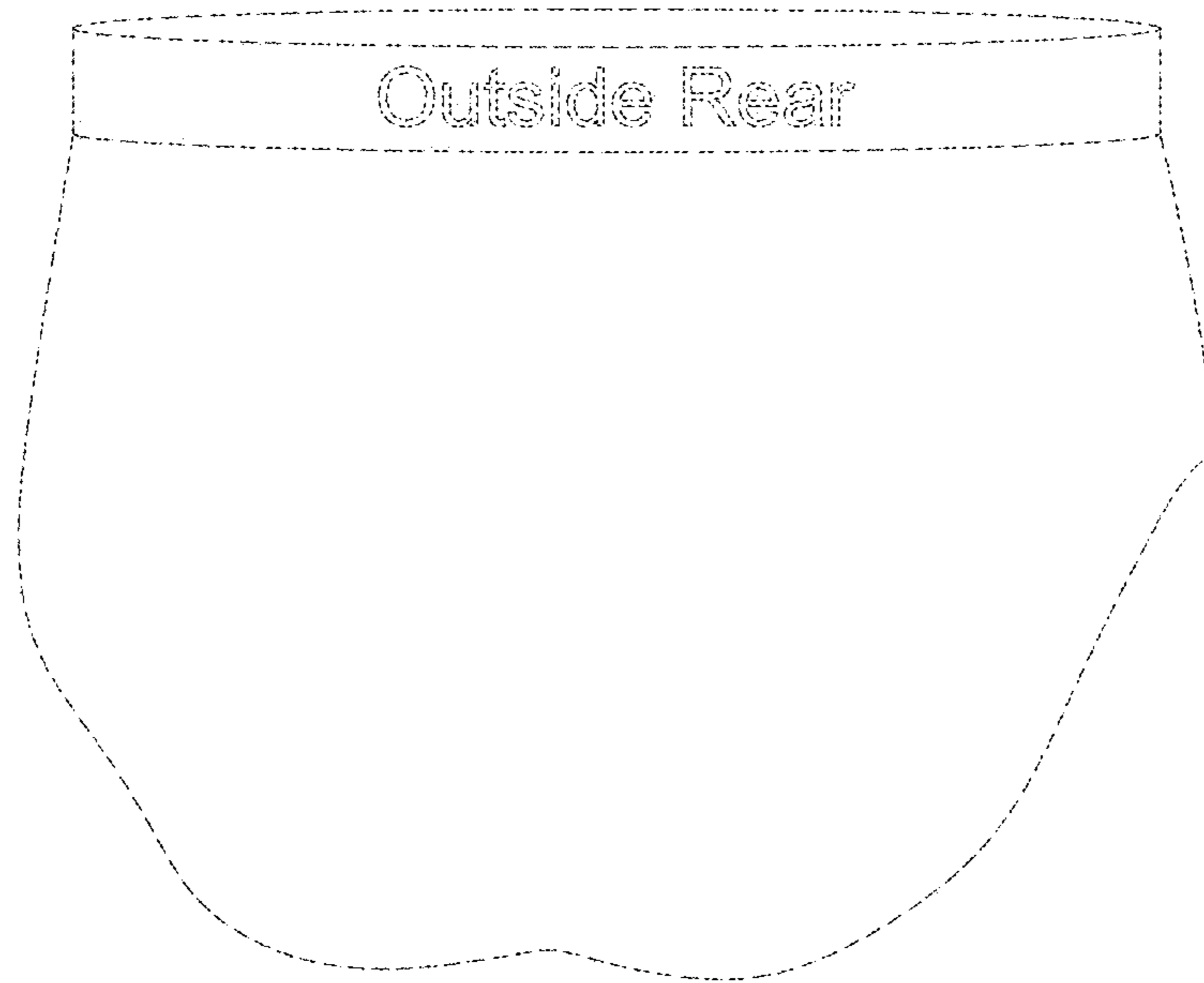

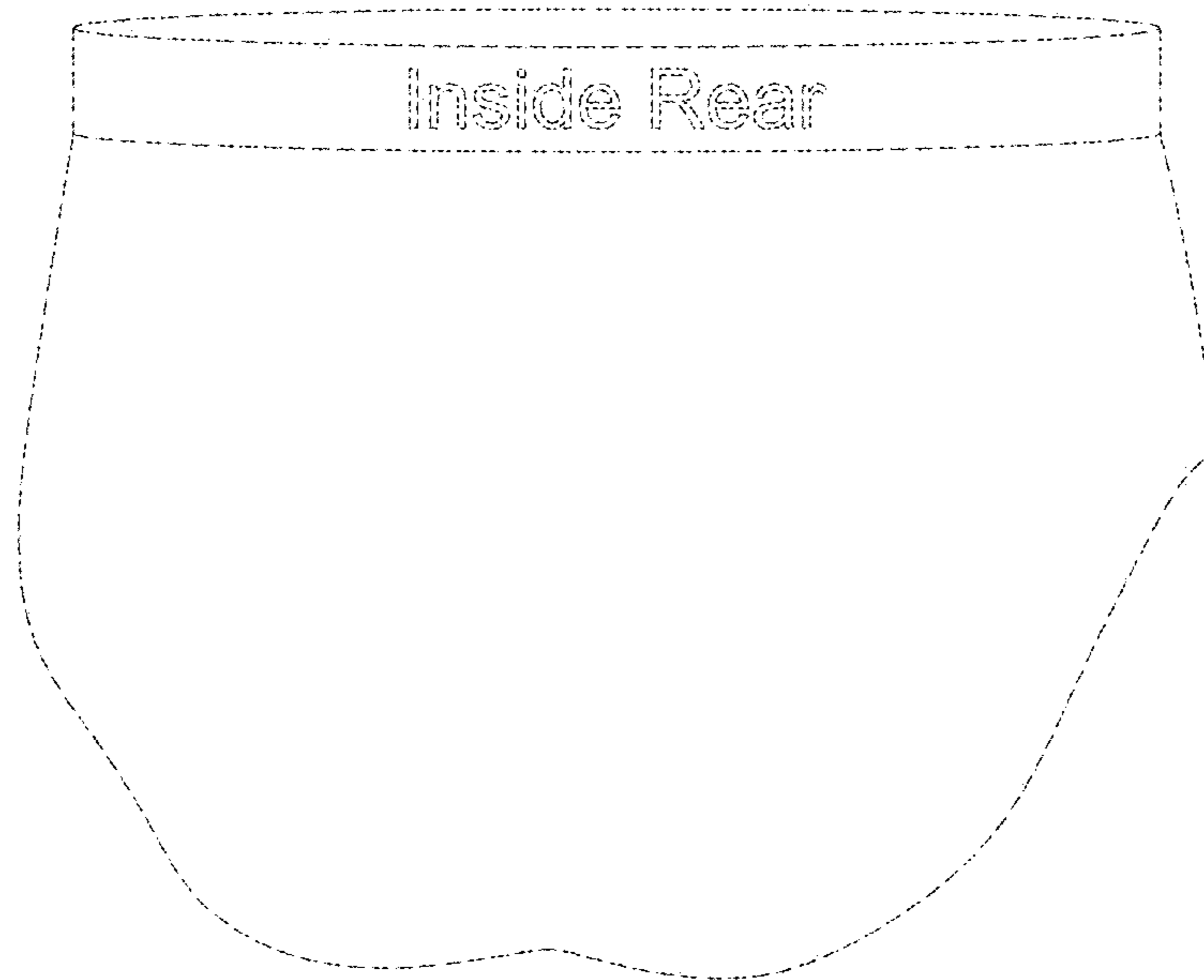
