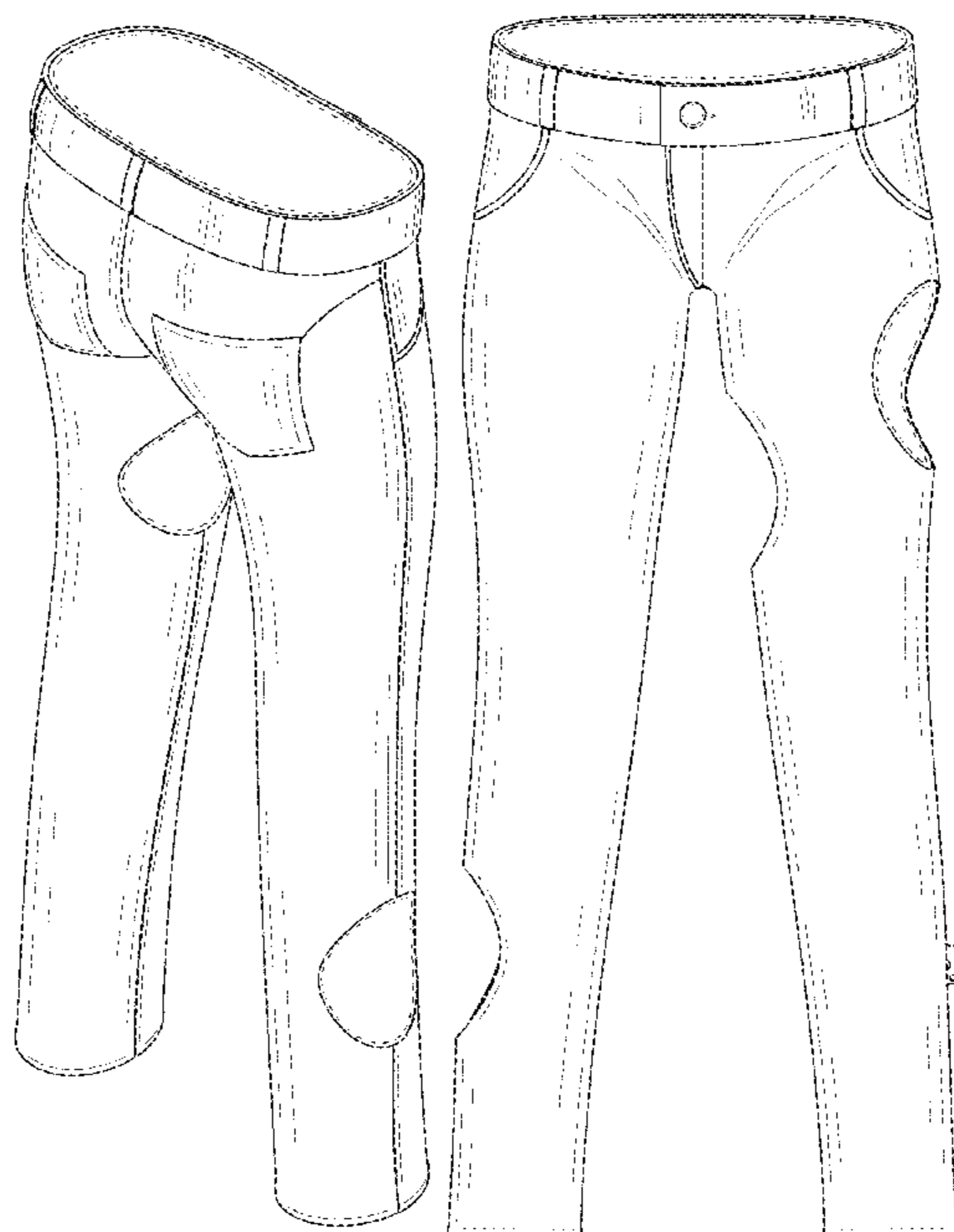
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of the jeans showing the top, front and right side thereof;
FIG. 2 is a isometric view of the jeans showing the top, rear and left side thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is an elevation view of the left side thereof;
FIG. 6 is an elevation view of the right side thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

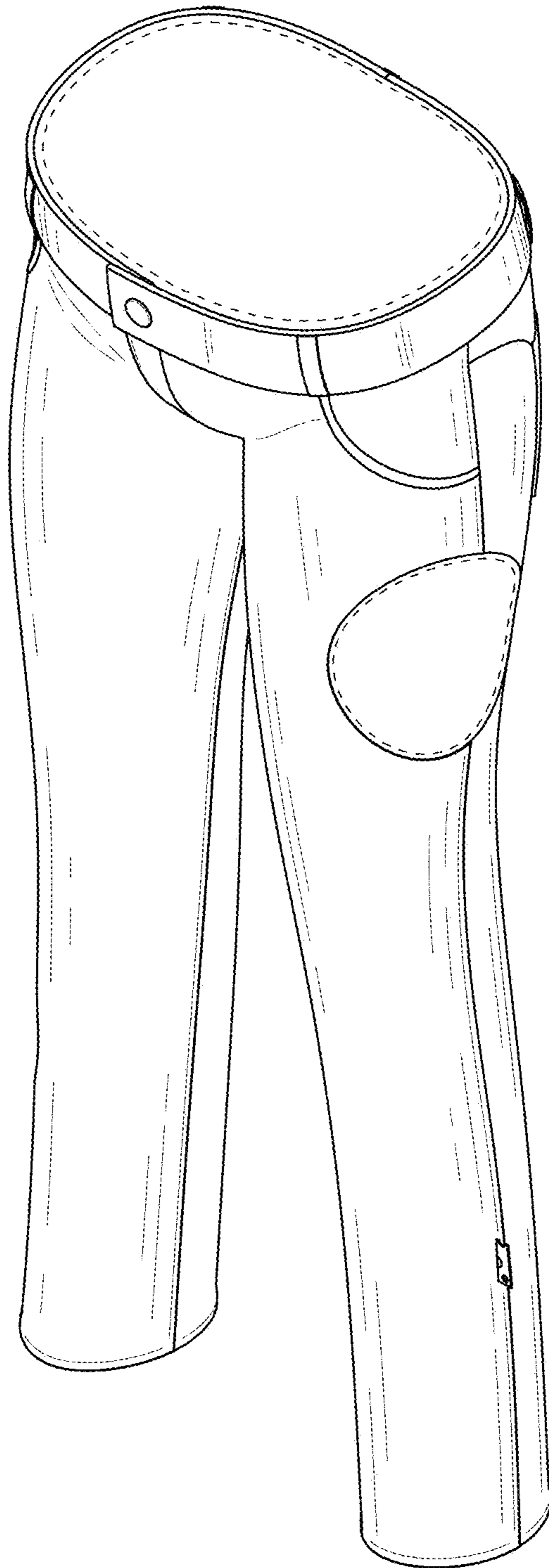

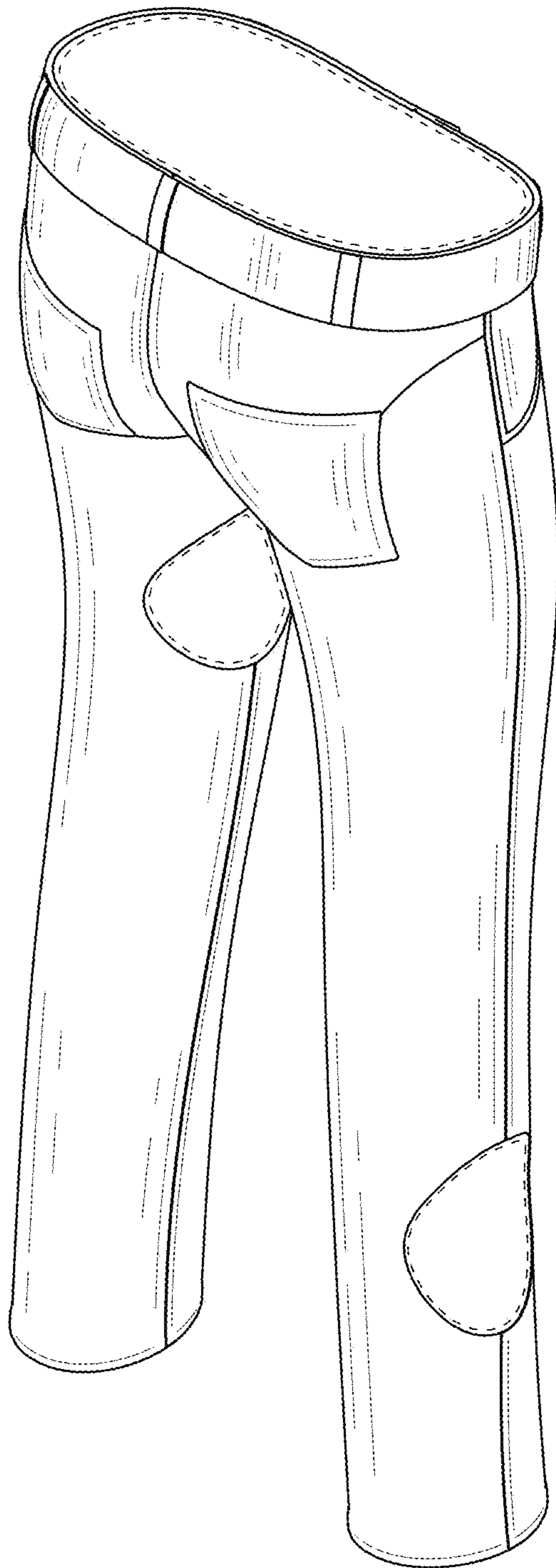

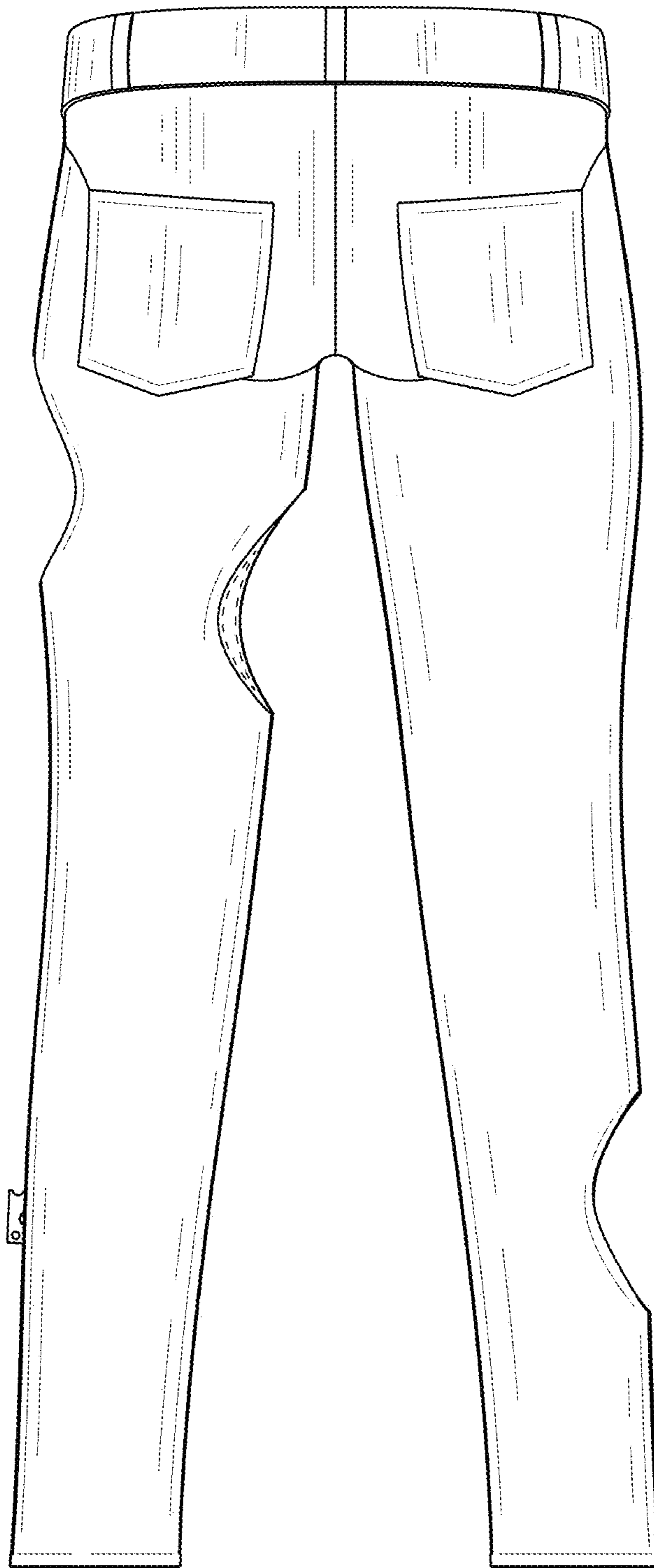

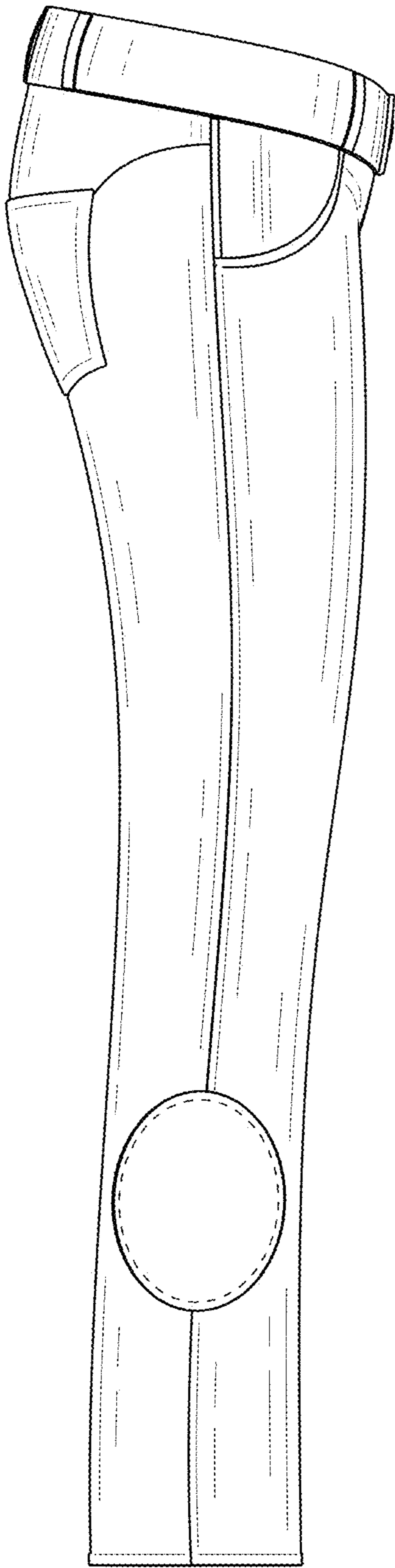

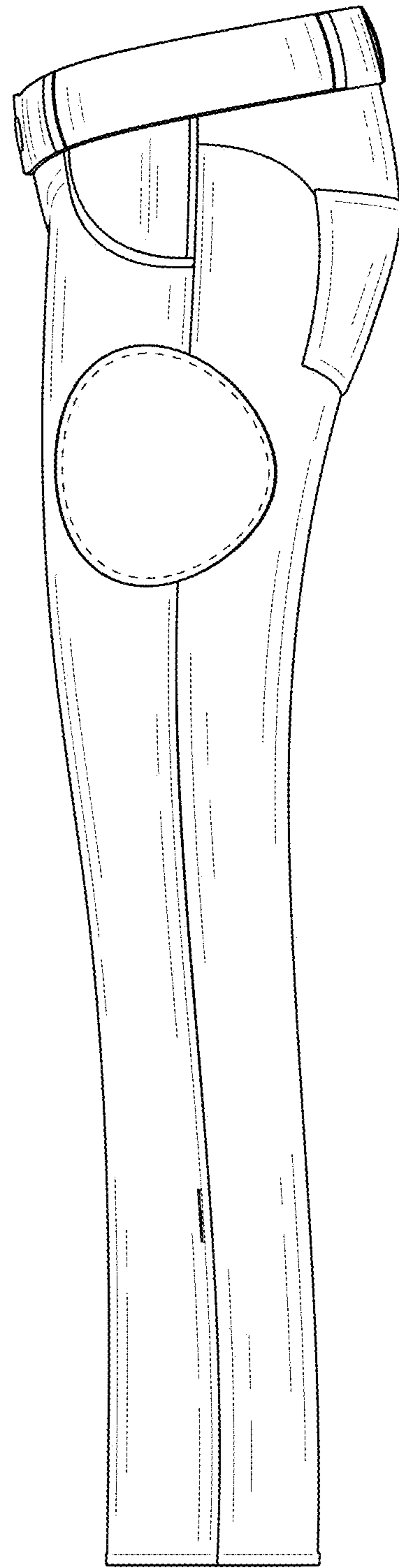

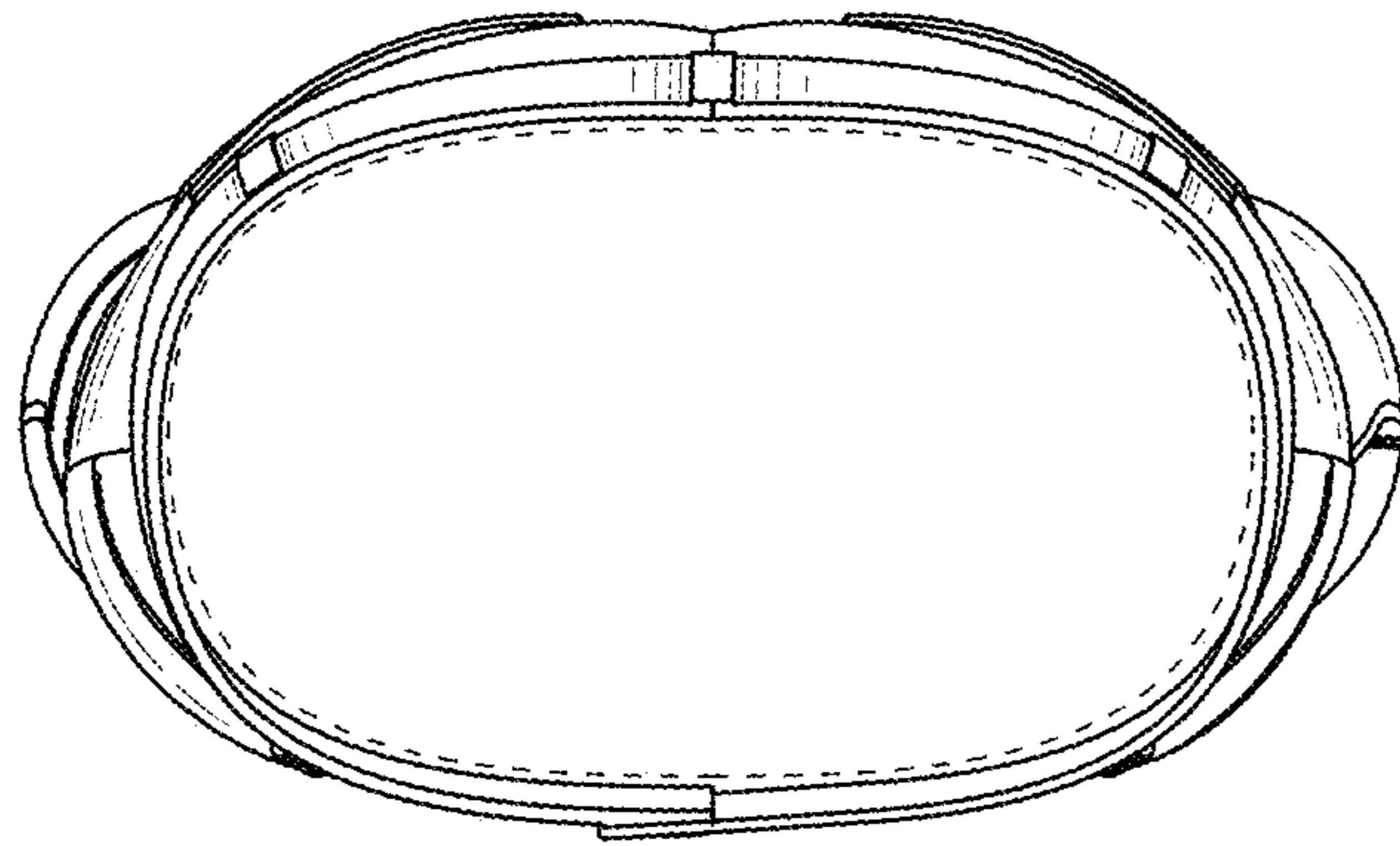

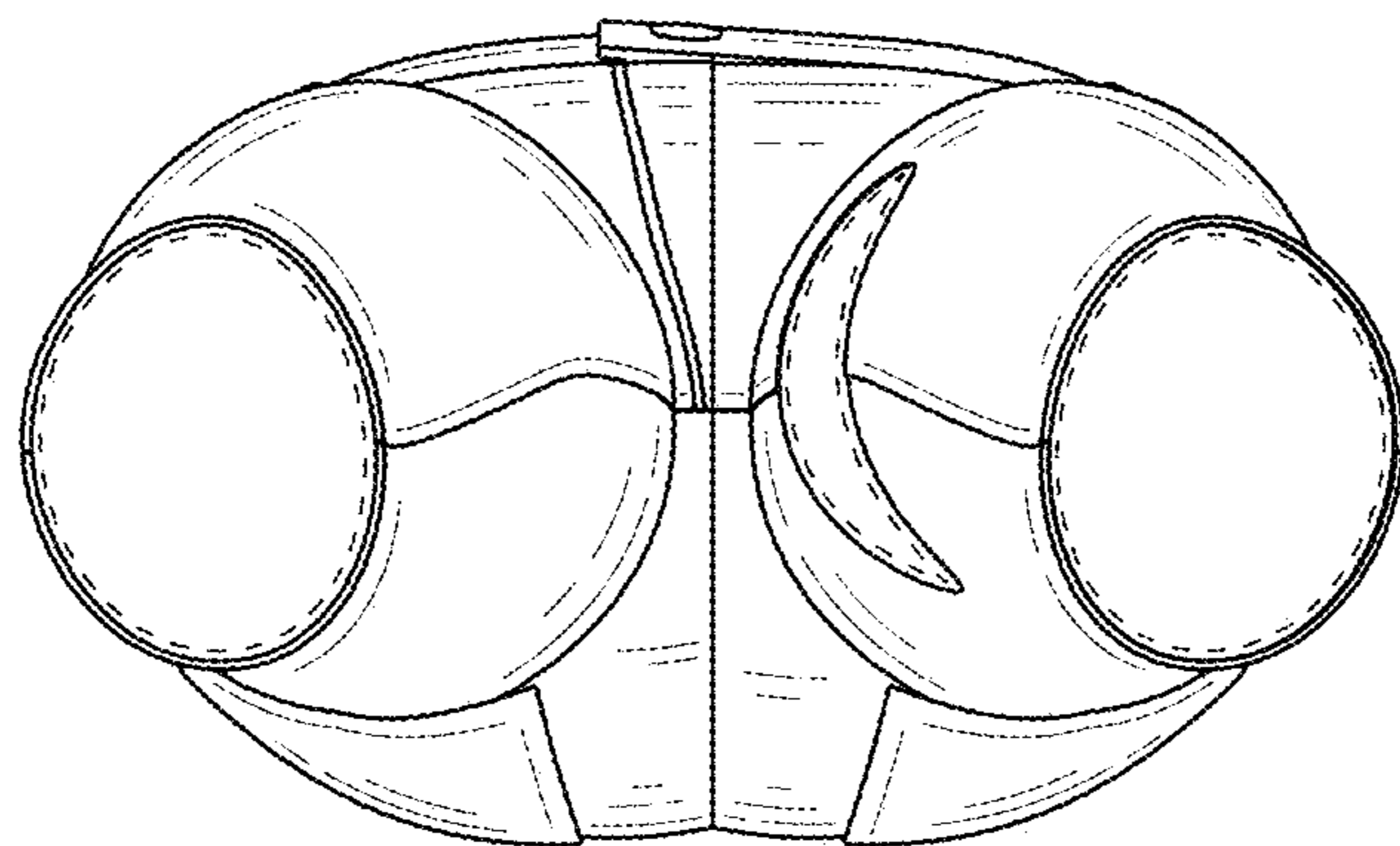
