FIG. 1 is a front view of the trousers according to the present design;

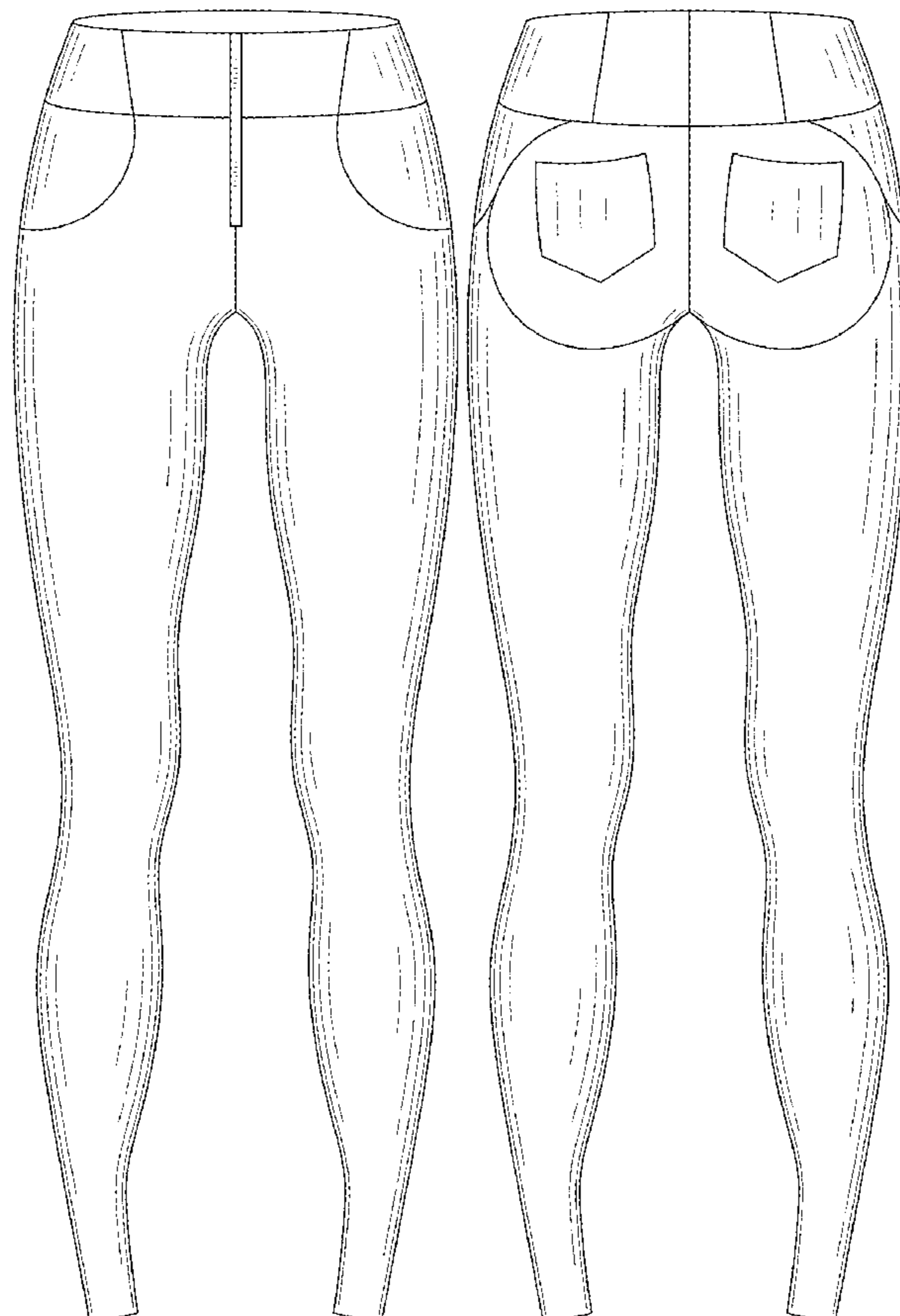
FIG. 2 is a rear view of the trousers of FIG. 1;

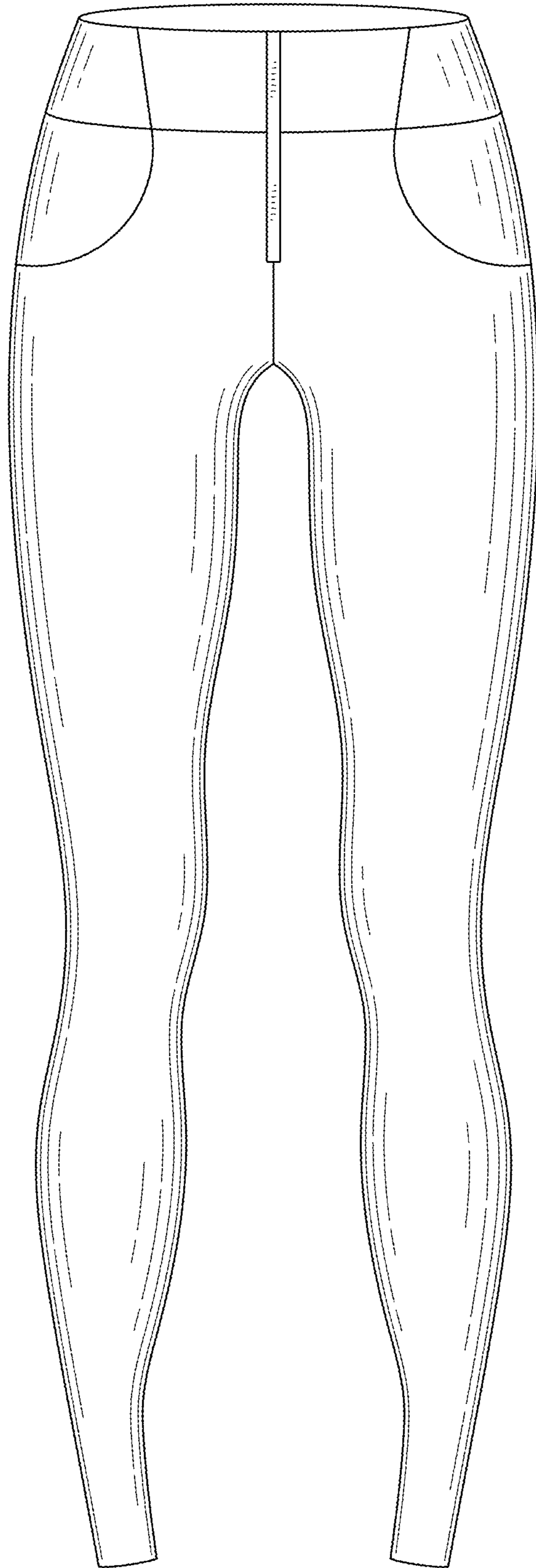

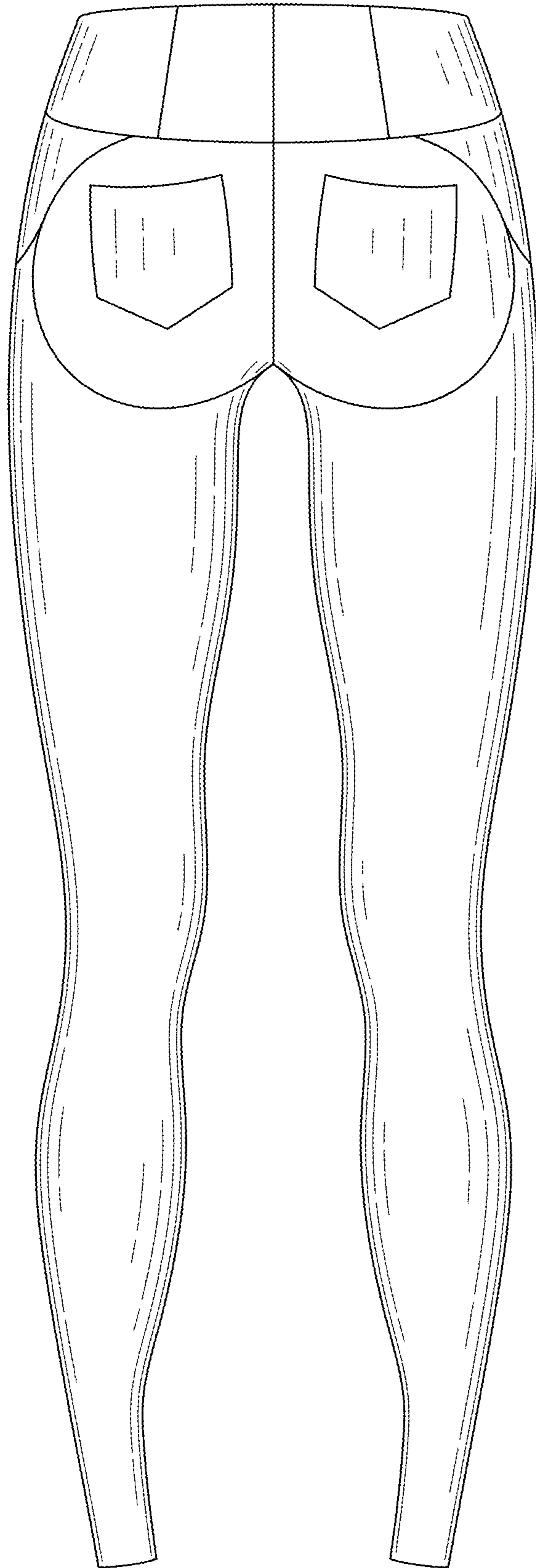

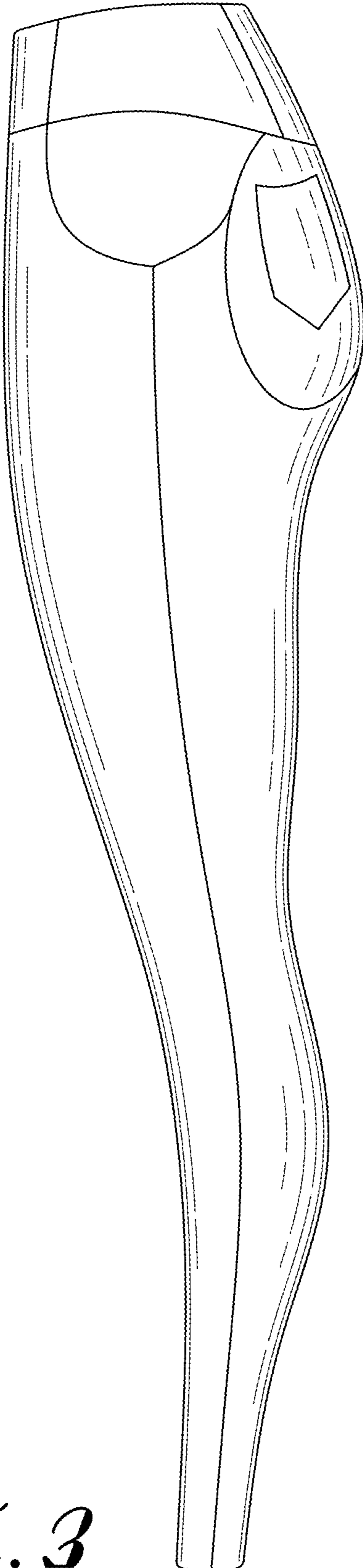

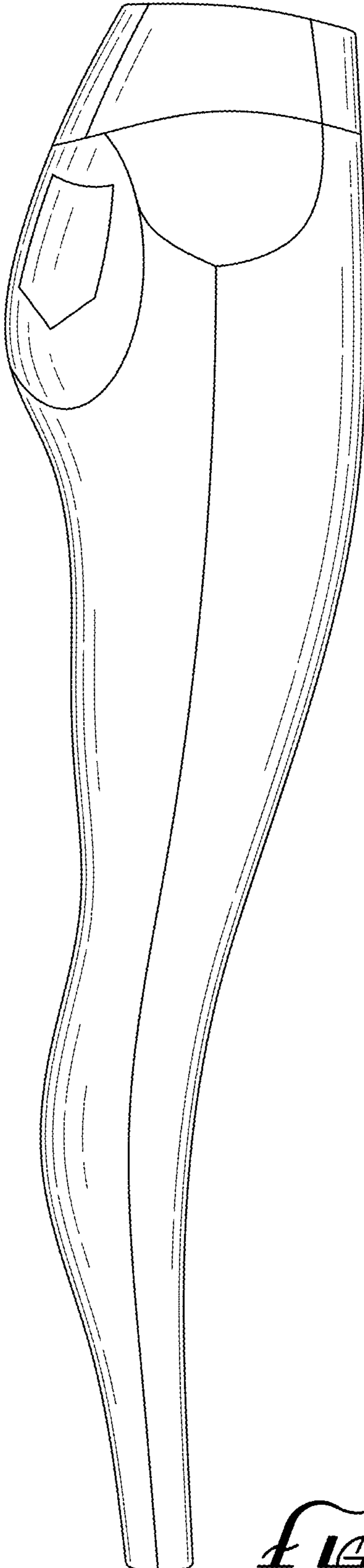

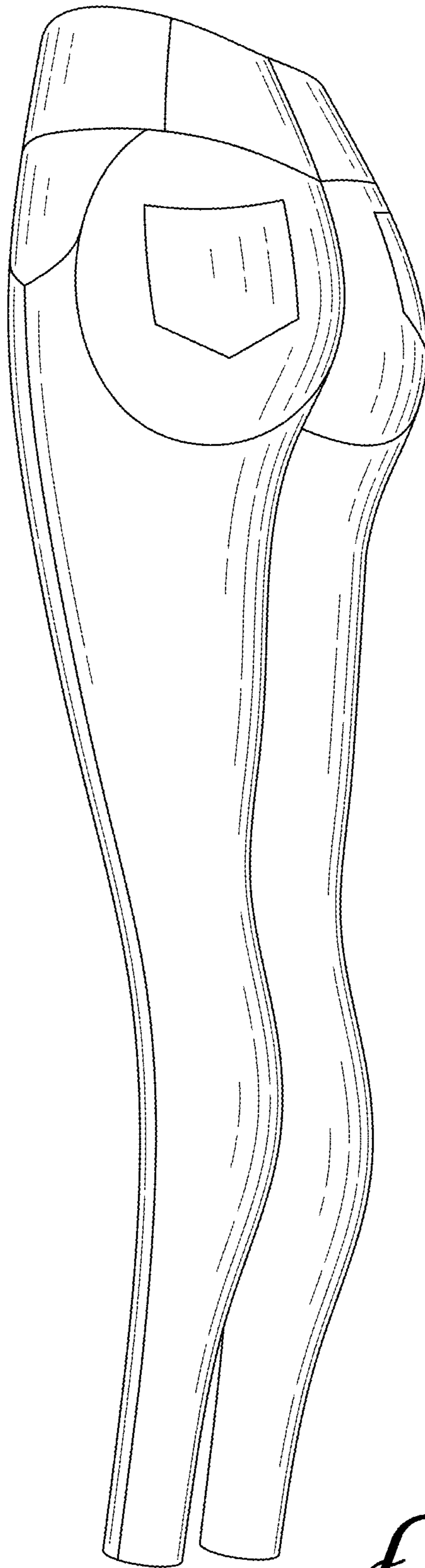
