FIG. 1 is a front view of an integrated illumination apparel showing my new design;

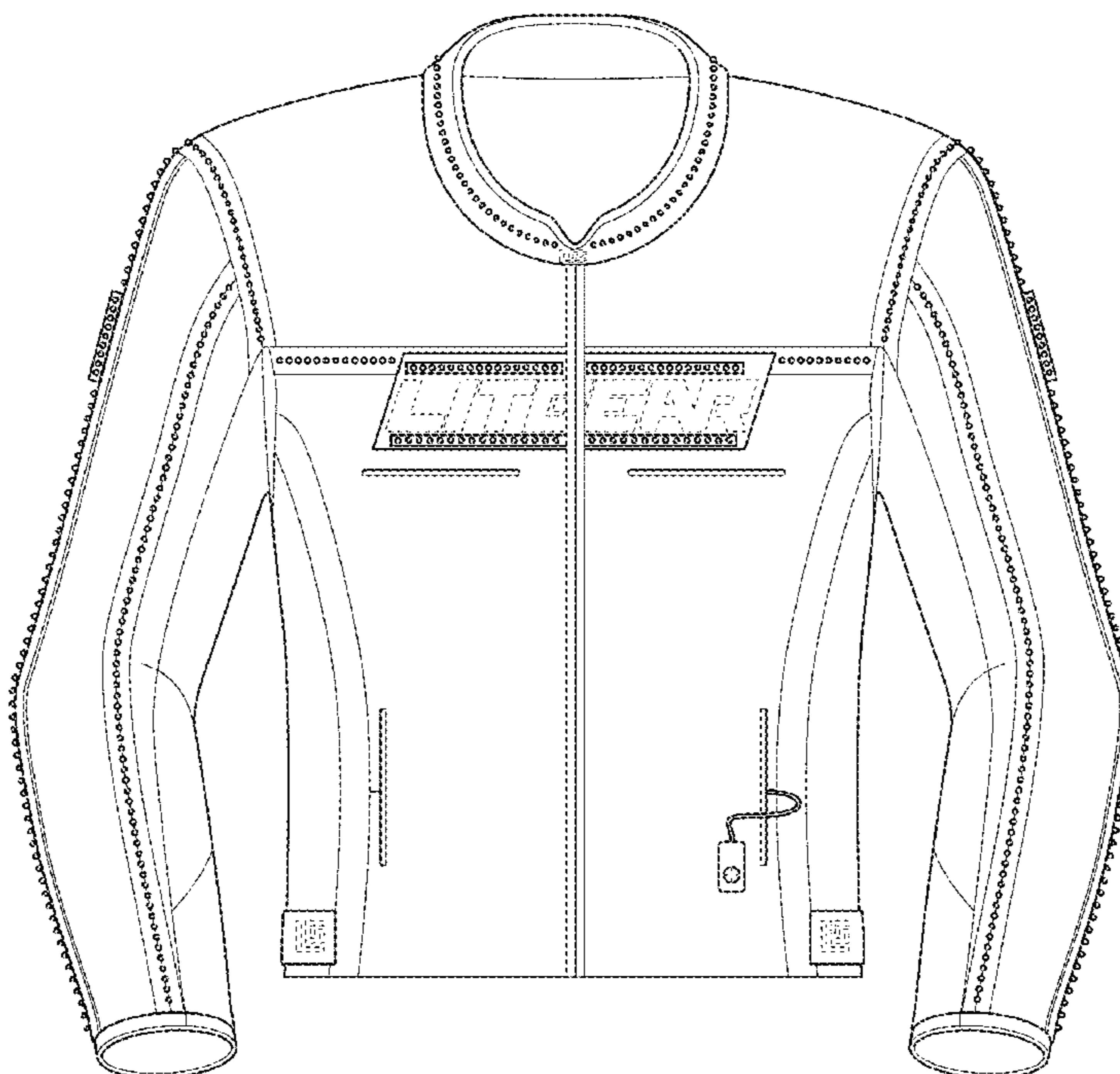
FIG. 2 is a rear view thereof;

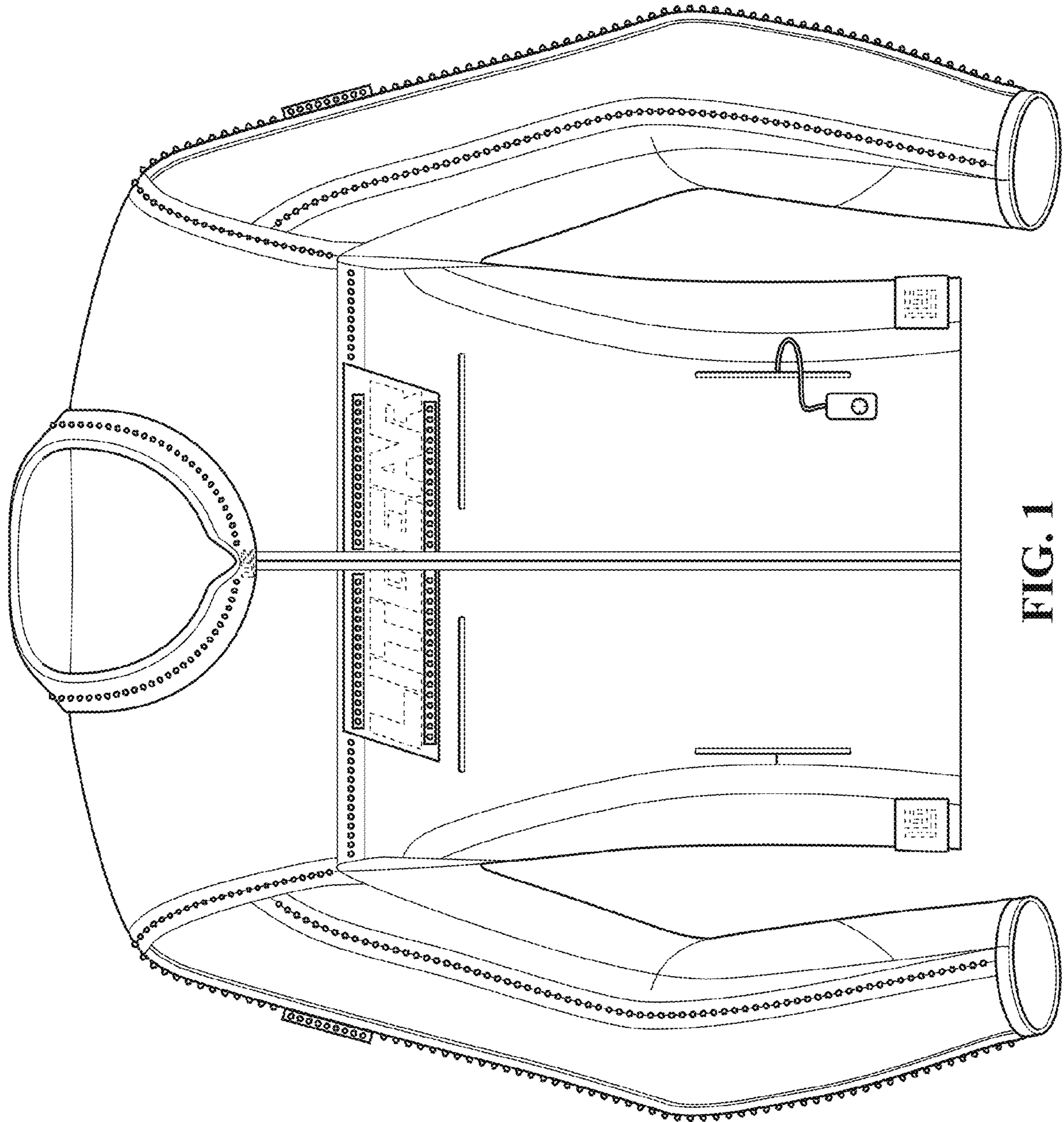
FIG. 3 is a left side view thereof; and,

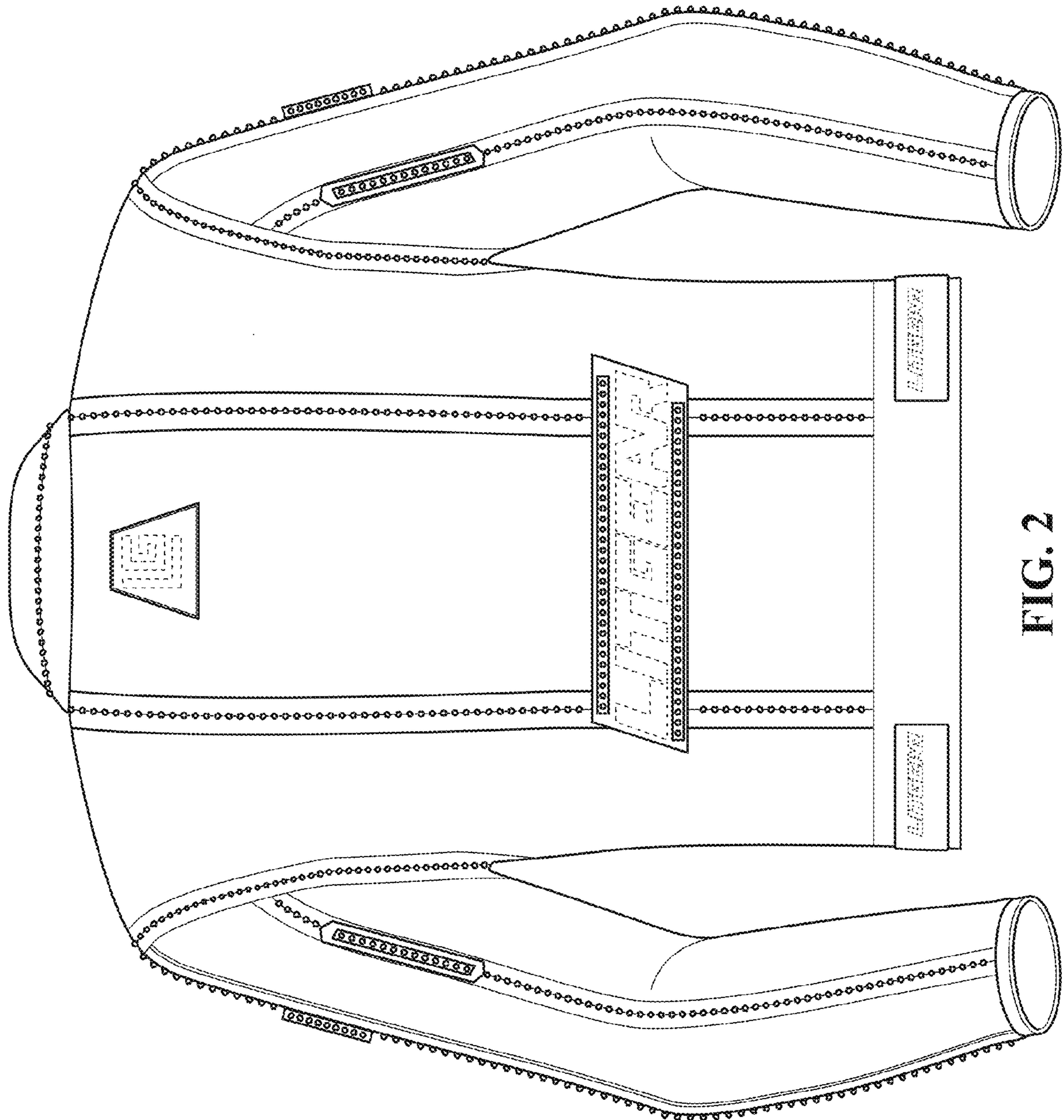

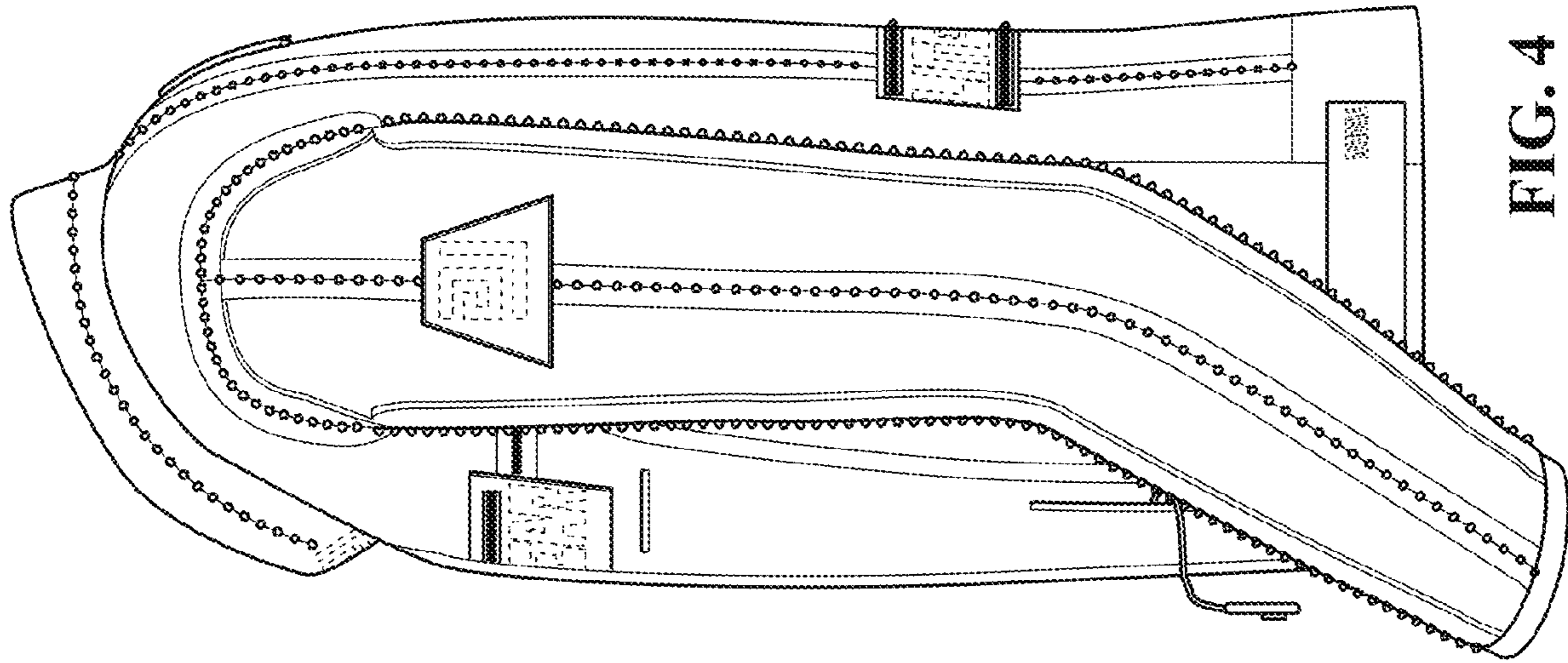

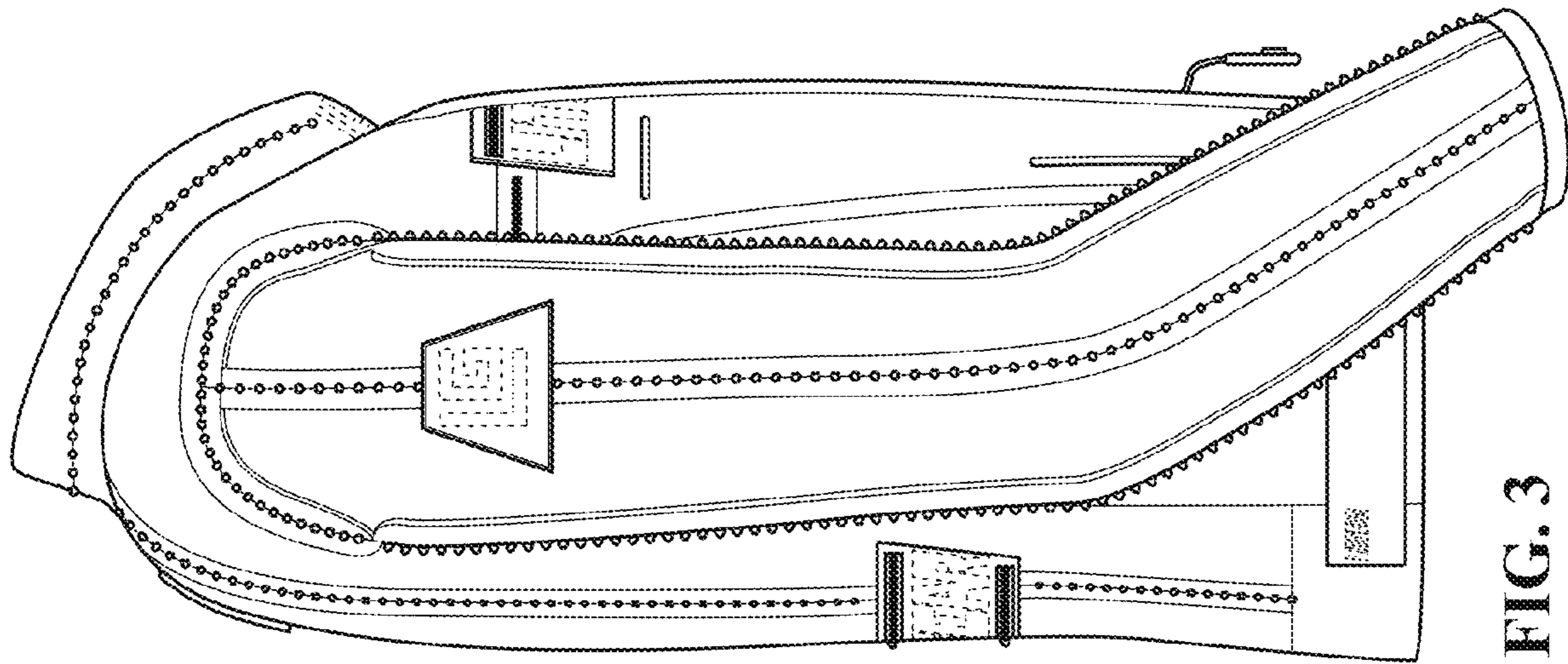
